Notice of Available Grant Funding

Grant funds are available from the Federal Governor's Discretionary Portion of the Safe and Drug-Free Schools and Communities Act for federal fiscal year October 1, 1998 through September 30, 1999. The purpose of this grant program is to fund units of state or local government, schools and private not-for-profit organizations that provide drug and violence prevention programs and activities and law enforcement education partnerships.

Priority will be given to programs and activities that serve children and youth who are not normally served by state or local educational agencies or populations that need special services or additional resources, such as preschoolers, youth in juvenile detention facilities, runaway or homeless children and youth, pregnant and parenting teenagers, and school dropouts. A minimum of 10 percent of each federal fiscal year grant will be allocated to law enforcement agencies.

Heartland Works, Inc. is in the process of submitting a consolidated local Job Training Plan for Service Delivery Area II to carry out programs authorized under the Job Training Partnership Act. The plan covers Titles IIA (Adult Program), IIB (Summer Youth), IIC (Youth Program) and III (Dislocated Worker Program) for program years 1998 and 1999. The plan also includes Wagner-Peyser Funding (Job Service) for program year 1998. Program year 1998 allocations are as follows: Title IIA, \$699,317; Title IIB, \$864,476; Title IIC, \$104,202; Title III, \$780,930; and Wagner-Peyser, \$800,810.

It is the purpose of the JTPA to establish programs to prepare youth and unskilled adults for entry into the labor force and to afford job training to those economically disadvantaged individuals with barriers to employment in need of training. 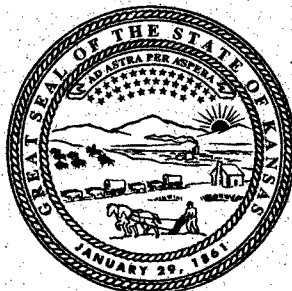

**Notice of Hearing on Proposed
Administrative Regulations**

A public hearing will be conducted at 10:30 a.m. Tuesday, May 26, in Room 108, Landon State Office Building, 900 S.W. Jackson, Topeka, to consider the adoption of proposed rules and regulations of the Department of Administration, Division of Accounts and Reports, on a permanent basis.

This 60-day notice of public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the Secretary of Administration, Room 263-E, State Capitol, 300 S.W. 10th Ave., Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Faith Loretto, (785) 296-6000 or (785) 296-4798 (TTY). Handicapped parking is located at the south end of the Landon State Office Building, and the north entrance to the building is accessible.

Summaries of the proposed regulations and their economic impact follow.

K.A.R. 1-16-18, Subsistence allowance, rates, prescribes the amounts and method for computing reimbursement for meal expenses and reimbursement or direct payment of lodging expenses incurred by state employees while traveling on official state business. The regulation sets forth maximum allowable costs for meals and lodging for travel in-state, out-of-state, to identified high-cost geographic areas and to international locations. The regulation also sets forth the required reduction amounts for meals provided to the traveler at no cost to the traveler. The proposed amendments to K.A.R. 1-16-18 increase the reimbursement limitation for meals allowances and lodging expenses in most categories of travel and adjust the required reductions for meals provided accordingly. These proposed increases are based on consideration of actual costs incurred in travel, the rate(s) allowed by the Internal Revenue Service and other pertinent matters at the discretion of the Secretary of Administration, as required by K.S.A. 75-3207a(b).

The amendments to the regulation also authorize payment of actual expenses for conference lodging as qualified within the provisions of K.A.R. 1-16-18a(e). Beginning April 1, 1996, the Secretary of Administration could temporarily designate a conference site as a designated high-cost geographic area. The temporary des-

ignation is effective only for the interval specified for the conference and only for those employees authorized to attend the conference. The provision was designed to provide flexibility to agency managers to allow employees to attend conferences when lodging rates exceed: (1) the lodging expense limitation authorized by K.A.R. 1-16-18; and (2) the allowance to exceed such rates by up to 150% as authorized by K.S.A. 75-3207a(e). Proposed amendments to K.A.R. 1-16-18 and K.A.R. 1-16-18a provide for payment of actual lodging expenses at conference sites, rather than making conference sites a temporary designated high-cost area.

K.A.R. 1-16-18 is further amended to allow the application of the lodging limits to the lodging rate *before* taxes. Thus, the amount reimbursed or paid for lodging expenses may exceed the established lodging limitation by as much as the amount of associated taxes. The amendment is simply designed to prevent situations in which a traveling site officer or employee must pay expenses out-of-pocket when the total lodging cost exceeds the allowable rates due to the addition of applicable taxes.

An additional amendment to K.A.R. 1-16-18 incorporates two existing special areas, Washington, D.C. and Manhattan, into a broadened category of travel labeled "out-of-state, special designated high-cost geographic area." This category includes the areas listed in 1-16-18a.

Effective July 1, 1998, the amended regulation would increase the reimbursement rates for meals and lodging while on official state business as follows:

State agencies will bear the cost of the increases to subsistence rates, and state employees traveling on official state business will benefit from establishment of rates which more closely reflect the actual cost of travel. Estimated expenditures due to rate increases assume all lodg-

ing expenses will increase to the new limitation levels, but this will likely not occur, and therefore, the fiscal impact will be less. The proposed subsistence rates could increase annual subsistence allowances and reimbursements for in-state and out-of-state travel by approximately 4.4 percent if the present rate of travel continues. This represents an estimated statewide increase in expenditures of \$540,500. The increase includes \$190,400 from the state general fund and \$350,100 from other funds, including special revenue and federal funds. These expenditure increases would be incurred in FY 1999 and fiscal years thereafter.

K.A.R. 1-16-18a, Designated high-cost geographic areas, identifies "high-cost geographic areas," which qualify for higher subsistence reimbursement rates pursuant to K.A.R. 1-16-18. Amendments to K.A.R. 1-16-18a(d) add 15 new high-cost geographic areas. The amendment also reflects the broadened definition of travel to Washington, D.C., and New York, New York, as "out-of-state special designated high-cost geographic areas." Because travel allowances for Washington, D.C., and Manhattan are currently higher than other designated high-cost geographic areas, the redefined category does not alter the reimbursement policies for travel to these two cities. Additionally, the regulation is amended to provide for reimbursement of actual lodging expenses for conferences, subject to review and approval requirements set out in subsection (e). Currently, subsection (e) allows conference sites to be temporarily designated as high-cost geographic areas under similar review and approval requirements.

State agencies will bear the cost of any increase in travel expense reimbursements, and state employees traveling on official state business will benefit from reimbursement rates or allowances that more closely reflect the actual cost of travel. The volume of travel to the cities added as high-cost geographic areas cannot be predicted. However, the increase per day in allowable meals and lodging expenses for areas proposed to be designated as high-cost areas is a maximum of \$55 in lodging reimbursement and \$1 in meal reimbursement, with lodging reimbursement further limited to actual expenses. Any increase in cost to agencies must be managed within existing available resources. Some local units of government may use the state's subsistence rates as the basis for reimbursing their own employees for travel expenses. However, this amendment is not expected to have a significant impact on local units' travel costs. No economic impact on private citizens and consumers is expected.

K.A.R. 1-18-1a, Maximum allowance for mileage for use of a privately-owned conveyance for public purposes, prescribes reimbursement rates in four categories for employees' use of privately-owned conveyances on official business. Effective July 1, 1998, the amended regulation would increase the reimbursement rate for the use of privately-owned conveyances as follows:

The proposed amendment will affect state agencies and their employees who travel on official state business in privately-owned conveyances. However, K.A.R. 1-18-1a currently provides that those employees who choose to use a privately-owned vehicle when a state-owned or leased vehicle is available are to be reimbursed at the Central Motor Pool rate for compact cars. Therefore, the privately-owned conveyance reimbursement rate may be paid only under the following circumstances: (1) if a state-owned or leased vehicle is not available; (2) if the use of a state vehicle is determined to be more expensive than the use of an employee's privately-owned vehicle; or (3) if the employee has a disability which requires use of a specially-equipped privately-owned vehicle.

An estimate of increased expenditures resulting from an increase in the privately-owned conveyance mileage rate cannot be accurately predicted. If it is assumed that all FY 1998 expenditures for mileage reimbursement for privately-owned conveyances were paid at the Central Motor Pool rate and will continue to be, then the impact of an increase in the privately-owned conveyance reimbursement rate is zero. If it is assumed all FY 1998 expenditures for mileage reimbursement for privately-owned conveyances were paid at the rate of \$.31, the following table shows a "worst case" estimate of statewide increased expenditures if the rate is raised to \$.32 in FY 1999:

These expenditure increases would be incurred by state agencies for each year after implementation. The proposed increase in privately-owned conveyance rates also would have an indeterminable economic impact on any governmental units within the State of Kansas that do not elect to establish their own mileage rates and alternatively use the state rates. No impact on the general public is anticipated.

Legislative Bills and Resolutions Introduced

HB 3009, An act relating to the pooled money investment board; concerning audits and comparative investment reviews; amending K.S.A. 75-4222 and 75-4234 and repealing the existing sections; also repealing K.S.A. 75-627, by Committee on Appropriations.

HB 3010, An act concerning construction management services for public works projects of state agencies and local governments; prescribing certain procurement procedures; amending K.S.A. 75-1265 and repealing the existing section, by Committee on Appropriations.

HB 3011, An act concerning natural gas; declaring certain sales and acquisitions relating thereto not to be prudent, in the public interest or just and reasonable, by Committee on Appropriations.

HB 3012, An act concerning the department of social and rehabilitation services; relating to foster care services and contracts with service providers, by Committee on Appropriations.

HB 3013, An act concerning the council on travel and tourism; transferring the powers and duties of the division of travel and tourism development to the council on travel and tourism; establishing the council on travel and tourism as a separate state agency; abolishing the division of travel and tourism development of the department of commerce and housing; amending K.S.A. 73-2103, 74-5090 and 74-9202 and K.S.A. 1997 Supp. 74-5089, 74-5091, 74-9001, 74-9002 and 74-9003 and repealing the existing sections; also repealing K.S.A. 74-5032 and 74-5032a, by Committee on Appropriations.

HB 3014, An act concerning the transportation of hazardous materials; authorizing certain federal exemptions, by Committee on Appropriations.

House Concurrent Resolutions

HCR 5050, A proposition to amend article 11 of the constitution of the state of Kansas by adding a new section thereto, prohibiting the increase of the rate of certain taxes.

House Resolutions

HR 6016, A resolution urging the State Corporation Commission to postpone certain proceedings and conduct an investigation relating to a natural gas contract (P-0802 contract).

HR 6017, A resolution in memory of Garner Shriver.

HR 6018, A resolution in memory of Edward F. Arn.

Facility Closure

The Kansas Department of Health and Environment has received investigation and remediation documents from the Kansas Army Ammunition Plant (KSAAP) for closure of the 700 Area at the army installation at Parsons, Kansas. The 700 Area at KSAAP is located in the north-central part of the installation and covers approximately 38 acres. In accordance with K.S.A. 65-3453, KDHE issued a Consent Order (Case No. 89-E-20) in March 1989 to KSAAP requiring further investigation, remediation and closure of the 700 Area as a Resource Conservation and Recovery Act (RCRA) regulated disposal unit. The Army installation operates under a RCRA permit with an EPA identification number KS0213820467 for other regulated units.

Several documents have been submitted to KDHE in response to the requirements of the Consent Order. RCRA mandates that the public be given the opportunity to review and comment on these documents, which include the results of the site investigations and assessments of cleanup actions for the 700 Area. The 700 Area was put into service in 1942. This production area was used for loading, assembling and packing the M-55 detonator, the M-210 lead cup, boosters and expulsion charges. Between 1942 and the present, the 700 Area was periodically deactivated and reactivated. The 700 Area production-line generated wastewater was contaminated with explosives and metal compounds. Explosives such as lead azide and RDX were used in this production area for the manufacture of munitions. Before 1970, wastewater that was generated from washing down the interior of buildings where explosives were handled flowed into concrete sumps via trough systems. The trough systems were located just outside of each of the buildings. Sodium hydroxide was added to the wastewater in the sumps as a final step in the kill procedure of any residual reactivity of explosives. The kill solution was then allowed to overflow the sumps into drainage ditches, which eventually lead to two ponds south and southwest of the 700 Area. These ponds drain to intermittent streams leading to Labette Creek approximately 2 miles downstream of each pond. During the time this procedure was followed, the wastewater contaminated the soil, sediment, surface water and groundwater of the area of the sumps, ditches and ponds. To provide for early remediation of sources of contaminated soil containing high concentrations of metals and explosives, an interim soil removal action is being planned for the late spring or early summer of 1998.

Public involvement is an important part of RCRA. The public must be notified of significant actions related to the Consent Order for the 700 Area at KSAAP. The following documents have been placed in the KSAAP repository at the Parsons Library and are available for public review and comment:

Temporary Administrative Regulations

Article 1.—GENERAL OPERATIONS

III-1-3. Information required from vendors. (a)

For each vendor being considered for the award of a major procurement contract as defined in the Kansas Lottery Act, the executive director may require the information listed in subsection (b) for each of the following persons associated with such vendor, each subsidiary or other business in which the vendor owns a controlling interest, and each subcontractor which the vendor is using or intends to use in performance of such contract.

(1) All officers and directors.

(2) All persons who own a 5% or more interest.

(3) All persons who own a controlling interest.

(4) All employees who are or will be in a position where they could have an opportunity to compromise the random selection of lottery game winners, including all employees of the on-line vendor(s) who are located in Kansas.

(b) The executive director may require the following information with regard to each person listed in subsection (a):

(1) Biographical data, including three sets of fingerprints, as needed to do a criminal background investigation.

(2) History of past residences, schooling and employment.

(3) Financial and credit data, character references and civil litigation history which relates to the person's honesty, integrity and financial stability, including copies of federal income tax returns for the past five years.

(c) For each vendor being considered for the award of a major procurement contract as defined in the Kansas

Lottery Act, the executive director may request the vendor to supply the following additional information:

(1) A list of the names and addresses of all businesses which currently supply goods or services to the vendor.

(2) A list of each agency or business to which the vendor has, within the previous five years, submitted a bid for goods or services, whether or not the vendor was awarded the contract with such agency or business. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-88-25, July 31, 1987; amended, T-111-3-4-98, March 4, 1998.)

Article 2.—LOTTERY RETAILERS

111-2-1. Application to become a lottery retailer.

(a) Persons or businesses wanting to sell lottery tickets or shares shall apply to the Kansas lottery on forms available through the lottery headquarters in Topeka or through any lottery regional office.

(b) Each application to become an all games lottery retailer shall be accompanied by a fee of \$150.00. All fees shall be non-refundable once a contract is fully executed and a lottery retailer certificate issued. Prior to contract execution and the issuance of a certificate, should the lottery reject or the applicant withdraw an application, the lottery shall refund all but \$50.00 of the application fee. Any applicant receiving a certificate is authorized to sell all Kansas lottery games.

(c) Lottery retailers other than pull-tab only retailers shall be subject to the following:

(1) They are required to have dedicated telephone lines for which they will be charged \$10.00 per week.

(2) Certain retailers whose businesses are seasonal, or are based at events in which Kansas lottery staff is participating, and regularly occur four or fewer days a week during the season, may qualify for cellular telephone services rather than dedicated telephone lines. There shall be no service charges for those on-line retailers selected to receive cellular telephone services available from the lottery.

(d) An applicant to become an all games lottery retailer shall actively offer for sale current instant games offered by the lottery, unless approved by the executive director as a "social environment establishment" defined at K.A.R. 111-6-1, and all on-line games offered by the lottery.

(e) Each application to become a pull-tab only retailer shall be accompanied by a fee of \$25.00, unless the applicant has applied to become an instant and on-line retailer and paid the appropriate fee. All pull-tab application fees shall be non-refundable.

(f) An applicant receiving a lottery retailer certificate pursuant to K.S.A. 74-8708, as amended, may apply for a temporary lottery retailer certificate, good for no more than fourteen days, at a specific location, for special lottery events and other events approved by the executive director. An application for a temporary lottery retailer certificate shall designate the event and the specific location where tickets will be sold.

(g) No sale shall be made at any location outside the state of Kansas or any location not authorized by the executive director or his designee.

(h) No natural person shall be selected as a lottery retailer who is the executive director, a member of the commission or an employee of the Kansas lottery; an officer or employee of a vendor contracting with the Kansas lot-

tery to supply gaming equipment or tickets to the Kansas lottery for use in the operation of any lottery conducted pursuant to this act; a spouse, or a person who resides in the same household as any person described in this subsection. 111-2-2. Qualifications of lottery retailers. (a) In addition to the qualifications and restrictions set forth in K.S.A. 74-8708 and amendments thereto, the executive director shall also consider the following factors in selecting lottery retailers:

(1) The sufficiency of existing retailers to serve the public interest.

(2) The current and potential sales volume of the applicant.

(3) The types of products, services, or entertainment offered at the applicant's place of business and their effect upon the credibility, integrity and reputation of the Kansas lottery.

(4) That all locations from which Kansas lottery products will be sold or purchased are within the state of Kansas.

(b) To sell instant or on-line lottery tickets, a retailer must have a current retailer certificate and must be actively engaged in the sale of current instant games offered by the lottery unless approved by the executive director as a social environment establishment as defined in K.A.R. 111-6-1(1).

(c) Retailers whose business is seasonal may request that lottery ticket sales be suspended and their accounts placed on hold during the time the business is closed subject to approval by the executive director. During the seasonal period those businesses placed on hold will not be required to sell lottery tickets pursuant to subsection (b) above.

(d) In addition to the qualifying standards to be selected as a lottery retailer provided by K.S.A. 74-8708, and amendments thereto, the same qualifying standards may be required for employees of the applicant for a retailer certificate as deemed necessary by the executive director. (a) During the period beginning February 1, 1998, and ending February 28, 1998, in addition to compensation provided for in K.A.R. 111-2-4, the Kansas lottery also offers all Dara's Fast Lane stores located in Kansas an opportunity to participate in a bonus retailer "ask for the sale" incentive promotion of lottery tickets.

(b) On each Wednesday in February 1998, including February 4, 11, 18, and 25, all Dara's Fast Lane stores' personnel selling Kansas lottery tickets will ask every adult customer making a purchase if the customer would like to purchase a lottery ticket. If the employee fails to ask adult customers for the purchase of a lottery ticket and the customer brings it to the clerk's attention before leaving the premises, the retailer shall give the adult customer one \$1.00 instant lottery ticket at no charge.

(c) All retailer employees at each location shall wear promotional buttons and display special point-of-sale materials provided by the lottery each Wednesday from 7:00 a.m. to 7:00 p.m. during the promotion announcing the promotion to its customers. These promotional materials consist of:

(1) A tent card to be displayed at the point where tickets are sold.

(2) A window/monitor banner to be displayed at the front entrance of the business and/or below the lottery information display system monitor.

These materials must be on display during all hours of the promotion at the times and dates established in subsections (b) and (c) for a store to be eligible for a prize.

(d) The Kansas lottery will provide each location with a credit of \$35. This will be credited to each store's account at the beginning of the promotion.

(e) Any tickets given away above the \$35 allowance representing 35 tickets per location will be the responsibility of Dara's, Inc.

(f) Each retail location shall maintain a ticket log form to be completed every time a lottery ticket is given away. The log will be picked up by the Kansas lottery district manager servicing the retailer location at the end of the promotion.

(g) At the end of the promotion, one store will win a \$300.00 pack of instant tickets selected by the lottery. The pack will be awarded with the winner being determined by a drawing. With each five percent increase in total sales during the sales period over the base period, the store will receive an entry into the drawing. Promotional items will also be awarded to the first, second, and third place stores based on the percentage increase in total lottery sales over the predetermined base. The base sales period for Dara's Fast Lane stores will be the 28 day average sales based upon total lottery sales from February 1, 1998, through February 28, 1998, compared to total sales from February 1, 1997, through February 28, 1997. (b) On each day, February 2, 1998, through February 8, 1998, from 6:00 a.m. to 1:00 a.m., all Total store personnel selling Kansas lottery tickets will ask every adult customer making a purchase if the customer would like to purchase an instant ticket. If the employee fails to ask adult customers making a purchase whether they want to purchase an instant ticket before leaving the premises, and the customer brings it to the clerk's attention, the retailer shall give that adult customer one \$1.00 instant ticket at no charge.

(c) The retailer at each location shall display special point-of-sale materials provided by the lottery during the promotion announcing the promotion to its customers. These materials consist of:

(1) A tent card to be displayed at the point where tickets are sold.

(2) A window/monitor banner to be displayed at the front entrance of the business and/or below the lottery information display system monitor.

(3) Promotion specific buttons. These materials must be on display during all hours of the promotion on the times and dates established in subsection (b) for a store to be eligible for a prize.

(d) The Kansas lottery will provide each location with a credit of \$35.00. This will be credited to each store's account at the beginning of the promotion.

(e) Any tickets given away above the \$35.00 allowance representing 35 tickets per location will be Total Petroleum's responsibility.

(f) Each retail location shall maintain a ticket log form to be completed every time an instant ticket is given away because an employee forgot to ask for the sale. The log will be picked up by the Kansas lottery district manager servicing the retailer location at the end of the promotion.

(g) At the end of the promotion, the Total store with the greatest percentage increase in instant ticket sales for the period from February 1, 1998, through February 28, 1998, over the period from February 1, 1997, through February 28, 1997, will win a \$300.00 pack of instant tickets selected by the lottery. The second place store will receive \$100.00 worth of instant tickets selected by the lottery. The third place store will receive promotional items. Article 3.—INSTANT GENERIC GAME RULES

111-3-1. Definitions. The following definitions apply to all instant ticket games: (a) "Bare arm technique" means a type of drawing in which the person drawing the winning ticket from the receptacle or drum wears a short-sleeved (sleeve not extending past the elbow) or a no-sleeve shirt which exposes the drawer's bare arm.

(b) "Book" means a pack of fanfolded instant game tickets which are attached to each other by perforations, which perforations the retailer tears when selling a ticket from the book.

(continued)

(c) "Book-ticket number" means the unique number appearing on each ticket which includes the number of the book from which it was removed and the serially assigned number of the ticket within that book. The book-ticket number is a number followed by a dash and then a 3-digit ticket number. The ticket numbers in each book start with 000. The book-ticket number is printed in black ink on the ticket below the bar code and above the space for the player's name and address.

(d) "Claimant" means a holder of a ticket who presents it for payment of a prize.

(e) "Co-sponsor drawings" are the acts of drawing for prizes which may be held subsequent to the lottery drawings.

(f) "Co-sponsor(s)" means the person, retailer or organization designated by the executive director to assist in organizing and participating in the lottery drawings.

(g) "Drawings" are the acts of drawing prizes conducted by the Kansas lottery.

(h) "Drum" means a container which can be sealed and rotated for the purpose of mixing, and into which instant tickets are placed for the purpose of drawing preliminary and/or final drawing winners.

(i) "Executive director" means the executive director of the Kansas lottery, or the person designated by the executive director.

(j) "Instant game" means a lottery game in which a ticket is purchased by a player and the player can immediately determine whether he or she has won a prize by removing the removable covering on the ticket and comparing the exposed play numbers or symbols with those specified as winners in the published game rules for that instant game.

(k) "Lottery retailer" or "retailer" means a person or business authorized by the lottery to sell lottery tickets.

(l) "Lottery security" means the lottery security officer or a certified law enforcement officer(s) designated by the executive director or the person designated by the executive director.

(m) "Non-winning ticket" means any valid Kansas instant game lottery ticket not eligible to win a prize under any instant game rules.

(n) "Participant" means any person, player, or contestant participating in a lottery game and anyone designated by a prize winner to appear on his or her behalf for any lottery game including any lottery drawing or televised draw show. In the event the prize winner or his or her designee fails to appear for a drawing or televised draw show, the executive director may designate an adult who may be a member of his staff to participate on behalf of the non-appearing prize winner. Any prize won by a participant appearing through a designee shall be payable to and delivered to the prize winner as provided by these rules and regulations.

(o) "Play area" is the portion of the front of each instant game ticket where the play or game symbols appear. It is covered by a removable layer of material which is intended to be removed ("scratched off") by the player to reveal the play or game symbols.

(p) "Play symbols" or "game symbols" are the numbers, letters, symbols, or pictures printed in the play area

of each instant game ticket and which determine if the ticket holder is entitled to a prize.

(q) "Play symbol captions" or "game symbol captions" are the words or portions of words printed beneath each play or game symbol in the play area and are used to repeat or explain the play or game symbol. The play or game symbol caption associated with each play or game symbol is designated by the rules of the game.

(r) Prize tiers:

(1) "Low-tier prize" means a lottery instant game prize not exceeding \$599.00.

(2) "High-tier prize" means a lottery instant game prize in excess of \$599.00.

(s) "Receptacle" means a container in which non-winning Kansas instant game lottery tickets are placed and from which the drawings are made. Receptacles shall be sealable and capable of being mixed.

(t) "Retailer validation code" means the small letters found under removable covering in the play area of each instant game ticket. The retailer uses this code to verify and validate winners which are to be paid by the retailer.

(u) "Special event" means a drawing or other method of awarding an additional prize or prizes within a group of lottery instant game winners as defined by the rules for a particular instant game.

(v) "Ticket holder" or "holder" means the person who has possession of an unsigned ticket or the person whose signature appears in the area upon a ticket designated for signature.

(w) "Ticket validation number" means a unique number appearing on each ticket which is used to validate winning tickets. The ticket validation number appears under the removable covering on the front of each instant ticket.

(x) "Activated book" means book or pack of instant tickets activated on the lottery's computer system, which is available for sale to the public by a lottery retailer.

(y) "Consigned book" means a full book or pack of instant tickets sealed in shrink wrap and delivered to a certified Kansas lottery retailer, which is designated on the lottery's computer system as consigned and has not been made available to the public. 111-3-13. Ticket validation requirements. (a) Each instant game ticket shall be validated prior to payment of a prize. Submission of a valid winning ticket to and receipt of the ticket by the lottery or one of its authorized retailers shall be the sole method of claiming a prize or prizes.

(b) Besides meeting all other requirements in these rules and those printed on the back of each instant ticket, the following validation requirements shall apply to all tickets for instant games:

(1) The ticket must have been issued by the Kansas lottery in an authorized manner and must not be counterfeit in whole or in part.

(2) The ticket shall be intact to the extent that the lottery can determine whether the ticket is a winning ticket.

(3) The ticket must not be altered or tampered with in any manner.

(4) The ticket must not be blank or partially blank, mis-cut, misregistered, defective, or printed or produced in error.

(5) The display printing on the ticket must be regular in every respect and correspond precisely with the artwork on file at the Kansas lottery.

(6) The ticket must not be stolen nor appear on any list of omitted tickets on file at the Kansas lottery.

(7) Play symbols must appear in the play area. Each play symbol must be exactly as described in specific game rules.

(8) Each play symbol must have a play symbol caption underneath, and each play symbol caption must agree with its play symbol. Each play symbol caption must be exactly as described in specific game rules.

(9) Each of the play symbols and play symbol captions must be present in its entirety, fully legible, right side up, not reversed in any manner, and correspond precisely to the artwork on file at the Kansas lottery.

(10) The ticket must have exactly one ticket validation number, one book-ticket number and one retailer validation code, each of which must be present to the extent that the lottery can determine whether the ticket is a winning ticket, and correspond precisely to the artwork on file at the Kansas lottery. The ticket validation number shall correspond, using the Kansas lottery codes, to the play symbols on the ticket.

(11) The ticket validation number of an apparent winning ticket shall appear on the Kansas lottery's official list of ticket validation numbers of winning tickets and a ticket with that ticket validation number shall not have been paid previously.

(12) The ticket must pass all additional confidential validation tests of the Kansas lottery.

(c) Any ticket not passing all of the validation checks stated in this section is void and ineligible for any prize. However, the executive director may, solely at his or her option, reimburse the player for the cost of an invalid ticket. In the event that a defective ticket is purchased, the only responsibility or liability of the Kansas lottery shall be for reimbursement of the cost of the defective ticket.

(d) A valid instant ticket which is validated and determined to contain a winning combination of numbers by the lottery's computer validation system shall be eligible for payment, provided it has not previously been paid and it meets the requirements of subsection (b)(6), even though it does not meet the remaining validation requirements of subsection (b). 111-3-14. Payment of prizes. The procedures for payment of instant monetary prizes to the winners of the instant games are as follows:

(a) The executive director or his designee shall award the designated prize to the appropriate person as soon as

it is determined that all laws, regulations, and rules have been adhered to.

(b) Low-tier instant game prizes shall be paid as follows:

(1) Present the ticket to any retailer. Upon receipt and computer validation of the ticket, the retailer shall immediately make payment for the prize to the claimant. A retailer choosing not to make the payment shall not computer validate the ticket, and the claimant may claim the prize at another retailer location or may claim the prize in another manner prescribed in these rules. If the retailer cannot validate the claim, the claimant shall fill out a claim form provided by the retailer and personally present or mail the completed form together with the ticket to Kansas lottery headquarters. If the claim is received and validated at lottery headquarters, then payment shall be made to the claimant by mail.

(2) Bring the ticket to any regional office of the Kansas lottery during the hours that such office is open to the public for business. Upon receipt and verification of the claim, payment for such claim shall be made to the winner in the following manner:

(A) The prize for a validated free ticket winner redeemed in this manner shall be \$1.00 to be paid by the Kansas lottery.

(B) The prize for other validated low-tier winners redeemed in this manner shall be paid by the lottery.

(3) Mail the ticket with a completed claim form in any envelope to Kansas lottery headquarters. Claim forms can be obtained from any lottery instant game retailer or any office of the Kansas lottery. Upon receipt and verification of the claim, the payment for such claim shall be made to the winner in the following manner:

(A) The prize for a validated free ticket winner redeemed in this manner shall be \$1.00 which shall be paid by the lottery.

(B) The prizes for other validated low-tier winners redeemed in this manner shall be paid by the lottery.

(c) High tier instant game prizes in excess of \$599.00 shall be paid by any one of the following methods:

(1) Bring the ticket to any office of the Kansas lottery during the hours that such office is open to the public for business. Upon receipt and validation of the ticket, the payment shall be made to the claimant by the executive director by any means deemed appropriate. On all high-tier claims, the winning ticket should be validated by requesting any Kansas lottery retailer to validate the ticket through the lottery's on-line central computer system. Although the ticket is validated, no authorization numbers will be provided the retailer since retailer cannot pay a high-tier claim.

(2) Mail the ticket with a completed claim form in any envelope to Kansas lottery headquarters. Claim forms may be obtained from any lottery instant game retailer or any office of the Kansas lottery. Upon receipt and validation of the ticket, the payment shall be made to the claimant by the executive director by any means deemed appropriate.

(d) Tickets submitted for payment of a prize shall become property of the lottery and shall not be returned to claimant. (Authorized by K.S.A. 1997 Supp. 74-8710(c);

111-3-25. Winner validation. The following validation requirements shall apply to all drawings conducted pursuant to K.A.R. 111-3-1 *et seq.* unless otherwise specified by individual game rules:

(a) Each ticket entered must be a valid non-winning Kansas instant game lottery ticket from any game specified by the rules and regulations of the drawing;

(b) The information form on the back of each ticket must be filled out in a legible manner;

(c) Each ticket must have been issued by the Kansas lottery in an authorized manner and must not be counterfeit in whole or in part;

(d) Each ticket shall be intact to the extent that the lottery can determine whether the ticket is a winning ticket;

(e) Each ticket must not be altered or tampered with in any way;

(f) Each ticket must not be blank or partially blank, misregistered, defective, or printed or produced in error;

(g) The display printing on each ticket must be regular in every respect and correspond precisely with the artwork on file at the Kansas lottery;

(h) Each ticket must not be stolen nor appear on any list of omitted tickets on file at the Kansas lottery;

(i) Each ticket must have exactly one ticket validation number, one book-ticket number, and a two-letter retailer validation code for non-barcoded tickets and a three-letter retailer validation code for barcoded tickets, each of which must be present in its entirety, be fully legible, be exactly as described in paragraph (d) above, and correspond precisely to the artwork on file at the Kansas lottery. Each ticket validation number shall correspond to the play symbols on the ticket;

(j) The ticket validation number of the tickets shall not appear on the Kansas lottery's official list of ticket validation numbers of winning tickets.

(k) Any ticket not passing all the validation checks in this section is void and is not eligible for drawings conducted pursuant to K.A.R. 111-3-1 *et seq.* (Authorized by and implementing K.S.A. 1997 Supp. 74-8710(b); effective, T-111-7-7-88, July 7, 1988; amended, T-111-5-28-91, May 24, 1991; amended, T-111-7-1-92, June 26, 1992; amended, T-111-11-8-94, Oct. 20, 1994; amended, T-111-3-4-98, March 4, 1998.)

Article 4.—INSTANT GAMES

**RULES FOR INSTANT GAME NO. 49
"BLACKJACK"**

111-4-1181. Name of game. The Kansas lottery shall conduct an instant winner lottery game entitled "Blackjack" commencing on or after January 19, 1998. The specific rules for the "Blackjack" game are contained in K.A.R. 111-3-1 *et seq.* and 111-4-1181 through 111-4-1184.

(Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-3-4-98, March 4, 1998.)

111-4-1182. Definitions. The following definitions shall apply to the "Blackjack" instant lottery game:

(a) "Game symbols" are the numbers, letters, symbols, or pictures printed in the play area of each instant game ticket and which determine if the ticket bearer is entitled to a prize. In this instant game, the game symbols are printed in black ink in 10 point WGI font with matching captions in WGI Cap font. A game symbol appears in each of 11 play spots within the play area. Each game symbol for this instant game is one of the following: \$1.⁰⁰ - \$2.⁰⁰ - \$3.⁰⁰ - \$4.⁰⁰ - \$6.⁰⁰ - \$8.⁰⁰ - \$12.⁰⁰ - 24.⁰⁰ - 50.⁰⁰ - 70.⁰⁰ - \$210\$ - \$700\$ - \$2100 - 2 - 3 - 4 - 5 - 6 - 7 - 8 - 9 - 10 - J - Q - K - A - BUST.

(b) "Game symbol captions" are the words or portions of words, letters or numbers printed beneath each game symbol in the play area and are used to repeat or explain the game symbol. The game symbol caption associated with each game symbol is as follows:

(c) "Ticket validation number" means a unique number appearing on each ticket which is used to validate winning tickets. For this instant game, the ticket validation number is an 11-digit number which appears on the front of each instant ticket and will be covered by latex.

(d) "Book-ticket number" means the unique number appearing on each ticket which includes the number of the book from which it was removed and the serially assigned number of the ticket within that book. For this instant game, the book-ticket number is an 8-digit book number followed by a dash and then a 3-digit ticket number. The ticket numbers in each book start with 000 and

end with 299. The book-ticket number is printed in black ink on the back of each instant game ticket both above the information form and below the bar code.

(e) "Retailer validation code" means the small letters found under removable covering in the play area of each instant game ticket. The retailer uses this code to verify and validate winners which are to be paid by the retailer. In this instant game, the retailer validation code is a three-letter code printed and appearing in three of six varying locations among the game symbols. The codes and their meanings are as follows: ONE = \$1.00; TWO = \$2.00; FOR = \$4.00; SIX = \$6.00; TWL = \$12.00; TFO = \$24.00; FTY = \$50.00; THT = \$210.00

(f) "Bar code" means the 16-digit bar-coded number appearing on the back of each ticket. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-3-4-98, March 4, 1998.)

111-4-1183. Determination of instant prize winners. An instant prize winner is determined for this instant game when the player removes or "scratches off" the removable layer of material covering the table play area to reveal three hands, "HAND 1," "HAND 2," and "HAND 3," as well as three prize amounts and one "DEALER'S HAND." If the total value of a "HAND" is higher than the value of the "DEALER'S HAND," the player wins the prize directly below that "HAND." If the player gets Blackjack (21) in any "HAND," the player wins double the prize for that "HAND." If the dealer "BUSTS," the player wins all three prizes. Each ticket can win up to three times. (Authorized by K.S.A. 1997 Supp. 74-8710(b), (c) and (i); implementing K.S.A. 1997 Supp. 74-8710(b), (c) and (i), and K.S.A. 74-8720(b) and (d); effective, T-111-3-4-98, March 4, 1998.)

111-4-1184. Number and value of instant prizes.

(a) There will be approximately 1,800,000 tickets ordered for this instant game. The expected number and value of the instant prizes are as follows:

(b) The executive director may terminate the sale of

tickets prior to the complete sale of all tickets. In this event, the number and value of prizes will be approximately proportional to the number of tickets actually sold. The odds of winning a prize in this game are one in 5.10.

Article 6.—ON-LINE GENERIC GAME RULES

111-6-1. Definitions. (a) All definitions contained in the Kansas lottery act (K.S.A. 74-8701 *et seq.*) and amendments thereto, and lottery regulations adopted pursuant to the Kansas lottery act are hereby incorporated by reference.

(b) "On-line Game" or "game" means a lottery game in which a player selects a combination of numbers or symbols, the type of game and amount of play, and the drawing date(s) by use of a computer. In return for paying the appropriate fee, the player receives a computer-generated ticket with the player's selection printed on it. The Kansas lottery will conduct a drawing to determine the winning combination in accordance with the rules of the specific game being played. Each ticket holder whose valid ticket includes a winning combination, shall be entitled to a prize if the ticket and a valid claim form are submitted within the specified time period.

(c) "On-line Retailer" or "retailer" means a person or business authorized by the Lottery to sell on-line tickets.

(d) "On-line Terminal (OLT)" or "terminal" means the computer hardware by which an on-line retailer or player enters the combination selected by the player and by which on-line tickets are generated and claims are validated.

(e) "On-line Ticket" or "ticket" means a computer-generated ticket issued by an on-line terminal to a player as a receipt for the combination a player had selected. That ticket shall be the only acceptable evidence of the combination of numbers or symbols selected.

(f) "Drawing" includes the procedure determined by the executive director by which the lottery selects the winning combination in accordance with the rules of the game or the procedure of removing non-winning tickets or other types of entry forms from a receptacle or drum in a drawing event conducted by the lottery. Various types of drawings and procedures involve the following:

(1) Those utilizing ball sets are open to the public, and are required to be witnessed by a lottery security officer and a drawing manager. Furthermore, the equipment used in any drawing must be inspected by the lottery security official present before the drawing.

(2) Winning number combinations may be generated through the use of a computer-driven random number generator located at lottery headquarters as provided by specific game rules. The generator shall be statistically analyzed, tested, and certified by an independent qualified statistician for integrity. Periodic checks shall be made to ensure the security and integrity of the system at least quarterly.

(continued)

(3) Drawing events requiring non-winning tickets or entry forms from a receptacle or drum shall be conducted in accordance with specific game rules and K.A.R. 111-6-6.

(4) All drawings and inspections are required to be recorded on both video and audio tape.

(g) "Quick pick" or "computer pick" means the random selection of numbers or symbols which appear on a ticket and are played by a player in a game.

(h) "Winning combination" means one or more numbers or symbols randomly selected at each on-line game drawing which shall be used to determine winning plays contained on a game ticket.

(i) "Validation" means the process of determining whether an on-line ticket presented for payment is a winning ticket.

(j) "Ticket holder" or "holder" means the person who has possession of an unsigned ticket or the person whose signature appears in the area upon a ticket designated for signature.

(k) "Executive director" means the executive director of the Kansas lottery or the person designated by the executive director.

(l) "Social environment establishment" means a retailer licensed to serve cereal malt beverage and/or alcohol for consumption on premises.

(m) "Attempt(s) to cancel" means that a retailer enters cancellation data into an on-line terminal or is informed by a player, prior to the first drawing for which the ticket was eligible, that the ticket was produced in error either because of a terminal malfunction or by miscommunication between a player and a retailer.

(n) "Problem ticket" means any on-line ticket erroneously produced either by terminal malfunction or by miscommunication between a player and a retailer.

(o) "Receptacle" or "drum" means a container in which non-winning tickets or entry forms are placed and from which the drawings are made. Receptacles or drums shall be sealable and drums shall be capable of being mixed or rotated for the purpose of ensuring random distribution.

(p) "Day," "business day" or "operations day," when referring to an on-line game, means the 19-hour period starting at 6:00 a.m. and ending at 1:00 a.m., the following day, unless specified otherwise in individual game rules. Article 9.—INDIVIDUAL PULL-TAB GAME RULES
RULES FOR PULL-TAB GAME NO. 12
"MAX 7"

111-9-79. Name of game. The Kansas lottery shall conduct a pull-tab game entitled "Max 7" starting on or

after January 19, 1998. The specific rules for the "Max 7" game are contained in K.A.R. 111-9-79 through 111-9-84. Other applicable rules for the game may be found in K.A.R. 111-8-1 *et seq.* (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-3-4-98, March 4, 1998.)

111-9-80. Definitions. The following definitions shall apply to the "Max 7" pull-tab lottery game.

(a) "Ticket" or "card" means a Kansas lottery pull-tab game "Max 7" ticket.

(b) "Play symbols" are the numbers, letters, symbols or pictures printed on the front and under each tab on the back of each pull-tab ticket which determine if the ticket bearer is entitled to a prize. In this pull-tab game, the play symbols consist of images of diamonds, oranges, strawberries, lemons, pears, green 7's, and a purple Max 7. Green 7's, the purple Max 7, diamonds, oranges, and strawberries appear on the front of each ticket. Various combinations of these play symbols appear under each of the five tabs on the back of each ticket.

(c) "Carton" means a box of pull-tab tickets containing 2,688 tickets.

(d) "Carton serial number" is the 9-digit number appearing on the front of the ticket.

(e) "Quarter carton" means one-fourth of a carton containing 672 pull-tab tickets. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-3-4-98, March 4, 1998.)

111-9-81. Determination of instant prize winners. Each tab on the back of the ticket is to be pulled open. If four symbols and one purple Max 7, or three, four or five symbols identified below appear horizontally, vertically or diagonally with a blue arrow running through all symbols, the player wins the prize which corresponds to the symbols appearing on the front of the ticket. On winning combinations, the total amount won will appear under a tab. The prize amounts are as follows:

4 - green 7's and a purple Max 7	\$75.00
4 - diamonds and a purple Max 7	\$25.00
4 - oranges and a purple Max 7	\$15.00
4 - strawberries and a purple Max 7	\$10.00

(e) "Quarter carton" means one-fourth of a carton containing 624 pull-tab tickets. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-3-4-98, March 4, 1998.)

111-9-87. Determination of instant prize winners. Each tab on the back of the ticket is to be pulled open. If three of the symbols shown below appear horizontally with the word "WIN" running through the first two symbols under any one tab, the player wins the prize which corresponds to the symbols appearing on the front of the ticket.
