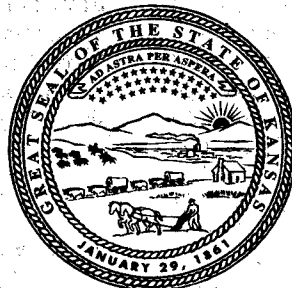

Wildlife and Parks Commission**Notice of Hearing on Proposed
Administrative Regulations**

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Thursday, August 20, at the Great Plains Nature Center, 6232 E. 29th, Wichita, to consider the approval and adoption of proposed regulations of the Department of Wildlife and Parks.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 1:30 p.m. August 20 at the location listed above. The meeting will recess at 5 p.m., then resume at 7 p.m. at the same location for the regulatory hearing. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. August 21 at the same location.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Cindy Baugh, commission secretary, at (316) 672-5911. Persons with a hearing impairment may call the TDD service at (800) 766-3777 to request special accommodations.

This 60-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on the proposed administrative regulations.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, Suite 502, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The regulations that will be heard during the regulatory hearing portion of the meeting are as follows:

K.A.R. 115-18-13. This regulation establishes dark goose hunting units, defines dark geese and establishes a permit requirement for the hunting of dark geese in the units. The proposed amendment to the regulation would eliminate the permit requirement in the Flint Hills unit.

Economic Impact Summary: The proposed amendment may result in a loss of revenue to the department of approximately \$6,800. This loss of revenue would equate to savings realized by individual hunters. In addition, elimination of the permit requirement in the area may lead to increased hunter activity, creating an economic benefit for businesses providing goods and services to hunters in the area.

K.A.R. 115-18-14. This regulation establishes legal types of shot for hunting migratory waterfowl and other

migratory wetland birds. The U.S. Fish and Wildlife Service may be proposing the addition of tungsten-tin shot as a non-toxic shot for the 1998-1999 hunting season. This amendment would add tungsten-tin to the list of approved non-toxic shot materials within the state, and would be acted on if the USFWS proceeds with the proposed addition.

Economic Impact Summary: To the extent the new shot is purchased and used by hunters, the amendment would provide an economic benefit to resident businesses. No other economic impacts are anticipated.

Negotiations for Architectural Services**

Notice is hereby given of the commencement of negotiations for architectural services for a new Reception and Diagnostic Unit for the Kansas Department of Corrections. The site of this facility has not yet been determined, but the location appears to be either the Topeka Correctional Facility or the El Dorado Correctional Facility. It is the department's intent to select a project architect at this time; however, fee negotiations with the selected firm will be delayed until a final site is selected. Presently, the project is funded for design only, and construction funds are expected to be requested in fiscal year 2000. The estimated construction cost for the project varies from \$16 to \$21 million, depending on the site selected.

The Kansas Department of Health and Environment is providing public notice that on March 13, 1998, Plastic Packaging Corporation (PPC), 750 S. 65th, Kansas City, Kansas, submitted a request for a variance from specific hazardous waste regulations. The request for a variance was submitted in accordance with K.A.R. 28-31-13(a).

The variance is requested from K.A.R. 28-31-4(g)(1) and 40 CFR 264.176, which require a generator to store ignitable or reactive wastes to be stored more than 50 feet from the property line. The PPC variance request would allow storage of ignitable wastes within 50 feet of the property line.

The Kansas Department of Health and Environment is providing public notice that on May 21, 1998, the School Service Center-U.S.D. 259, 3850 N. Hydraulic, Wichita, submitted a request for a variance from specific hazardous waste regulations. The request for a variance was submitted in accordance with K.A.R. 28-31-13(a).

The variance is requested from K.A.R. 28-31-4(j)(1), which limits the accumulation of not more than 55 gallons of each type of hazardous waste in not more than one satellite container at or near each point of generation where waste initially accumulates, and which is under the control of the operator of the process generating the waste. The U.S.D. 259 variance request would allow two containers to collect waste at the sand blasting station. Since the station is equipped with a double hopper collection system, the integrity of the collection process will be preserved with the use of two collection containers.

KDHE has reviewed the variance request and concluded that the variance is justified. The proposed general permit does not allow discharges to surface waters of the state and is based upon standard lagoon/retention structure requirements including restoration of the wastewater retention site after project completion.

A general permit applies to a group or class of applicants conducting similar activities. Since the requirements of each permit are identical for all members of the group or class, the general permit is placed on public notice one time and can be issued thereafter for the life of the general permit without further public notice. The use of general permits reduces the cost and time to obtain a permit for the permittee and to provide a permit for KDHE while assuring adequate protection of the health of the people of Kansas and the environment.

Applicants seeking a general permit are required to submit a notice of intent (NOI) and a \$60 annual permit fee to KDHE. If the project meets the requirements of the general permit, KDHE will provide the applicant a general permit pursuant to K.A.R. 28-65-164 *et seq.* If the project does not meet the requirements of the general permit, the applicant will be required to obtain an individual wastewater treatment permit for the project.

**Notice Concerning Variance Request
from Hazardous Waste Regulations**

The Kansas Department of Health and Environment is providing public notice that on September 2, 1997, Burlington Northern Santa Fe Railway (BNSF), 1001 N.E. Atchison, Topeka, submitted a request for a variance from specific hazardous waste regulations. The request for a variance was submitted in accordance with K.A.R. 28-31-13(a).

The variance is requested from K.A.R. 28-31-4(l), which allows a generator to accumulate as much as 55 gallons of each type of hazardous waste in not more than one container at or near the point of generation where waste initially accumulates, and which is under the control of the operator of the process generating the waste. The BNSF variance request would allow a specific satellite storage area to serve several generation points that create the same waste. The request indicates that by granting this variance, both the number of satellite storage sites as well as the number of hazardous waste storage drums at the facility will be reduced. In addition, BNSF estimates that the number of drums used to store hazardous waste each year at the facility will be reduced from thirty-six to six. Instead of using additional drums, BNSF employees would move the accumulation drum from point to point. The variance request indicates that the risk associated with moving these drums is minimal as the waste is fiberglass batting used as paint filters and contains no free liquid. The variance would allow a single satellite drum to be moved to a paint booth, then to a compactor, and then back to the satellite storage area.

KDHE has reviewed the variance request and concluded that the variance is justified. In accordance with K.A.R. 28-31-13(b), public notice is being provided of the tentative decision to grant the variance. Copies of the variance request are available for public review until July 17 from 8 a.m. to 4:30 p.m. weekdays at the KDHE, Building 740, Forbes Field, Topeka, and at the KDHE northeast district office, 800 W. 24th, Lawrence.

Comments concerning this variance request may be directed to David E. Branscum, Policy, Planning and Outreach Section, Bureau of Waste Management, KDHE, Building 740, Topeka, 66620. Comments must be submitted in writing prior to July 17. Requests for additional information may be made by contacting David Branscum at (785) 296-6898.

Upon the written request of any interested person, a public meeting may be held to consider comments on this tentative decision. The person requesting a meeting shall state the issues to be raised and shall explain why written comments would not suffice to communicate the person's views. If a decision is made to conduct a public meeting, a separate public notice detailing the date and place will be issued.

After evaluating all public comments, a final decision shall be made by the KDHE secretary and a notice of the final decision shall be published in the Kansas Register.

If approved, any conditions or time limitations needed to comply with all applicable state or federal laws or to protect human health or safety or the environment shall be specified by the secretary. A date upon which the variance will no longer be valid shall be prescribed in the final decision.

Redemption of Bonds

Copies of the final official statement in excess of a reasonable number may be ordered by the successful bidder at its expense.

Continuing Disclosure

The city will adopt a resolution establishing an undertaking to provide ongoing disclosure concerning the city in connection with and for the benefit of owners of the bonds, pursuant to Section (b)(5)(i) of Securities and Exchange Commission Rule 15c2-12. Article 2.—LOTTERY RETAILERS

111-2-30. Retailer bonus; on-line games. (a) On all Powerball, Cash 4 Life, and Kansas Cash drawings in which the prize claimed and awarded is the "jackpot prize" offered in the game it represents, the Kansas lottery retailer(s) selling the ticket(s) shall receive \$10,000 for Powerball, \$2,500 for Cash 4 Life and \$1,000 for Kansas Cash, or share equally in a bonus if there are multiple winners and the prize is paid on a parimutuel basis. The bonus shall be in addition to compensation specified in K.A.R. 111-2-4.

(b) A "jackpot prize" is the highest prize awarded in the prize structure of the Powerball, Cash 4 Life, or Kansas Cash game it represents.

(c) On all Powerball and Cash 4 Life drawings where the prize claimed and awarded is less than the jackpot prize and is not less than \$100,000, the Kansas lottery retailer selling the ticket shall receive \$1,000.

(d) On all Keno drawings where the prize claimed and awarded is not less than \$100,000, the Kansas lottery retailer selling the ticket shall receive \$1,000. (d) The Kansas lottery will provide each location with a \$25 credit to its account at the beginning of the promotion.

(e) Any tickets given away above the \$25 allowance representing 25 tickets per location will be the responsibility of the regional Love's stores.

(f) Each retail location shall maintain a ticket log form to be completed every time a lottery ticket is given away because an employee forgot to ask for the sale. The log will be picked up by the Kansas lottery district manager servicing the retailer location at the end of the promotion.

111-4-1251. Cost of ticket. The price of "Casino Royale" instant tickets sold by a retailer shall be \$5.00 each. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-5-28-98, May 15, 1998.)

111-4-1252. Determination of instant prize winners. Casino Royale is a ticket with five different games featuring six distinct play areas. An instant prize winner is determined for this instant game when the player removes or "scratches off" the removable layer of material covering the play area to reveal the 43 game symbols and captions.

(a) Game one is "Blackjack." "Blackjack is a beat the dealer game. A player will remove the scratch-off covering over the table area to reveal three hands ("Hand 1," "Hand 2," and "Hand 3"), and one "Dealer's Hand." Article 6.—ON-LINE GENERIC GAME RULES

111-6-20. Cancellation of tickets. (a) On all on-line games other than those games conducted by the "Multi-State Lottery Association" a single game or consecutive game ticket may be cancelled provided it is cancelled prior to the drawing at the same terminal from which it was purchased and on the same day the ticket was produced. Neither exchange tickets nor tickets originating or resulting from an on-line game or retailer promotion can be cancelled. The cancelled ticket, along with the terminal issued cancellation slip, must be remitted by the retailer to the lottery.

(b) If a single game or consecutive game ticket is not cancelled before the first game, credit may still be given to a retailer provided the following steps are taken:

(1) The retailer attempts to cancel the ticket within 30 seconds from the time of the first draw for which the ticket was eligible, as reflected by the time of the transaction recorded in the computer record of the attempt to cancel;

(2) The retailer calls the on-line vendor's "hotline" number, gives the ticket number to the operator and completely fills out a problem ticket report;

(3) A lottery representative mutilates the on-line ticket by tearing in half vertically and retaining the right half to prevent the possibility of the ticket being eligible for validation pursuant to K.A.R. 111-6-7; and

(4) The retailer does not cash, or attempt to cash the ticket.

(c) An exchange ticket cannot be cancelled and is not eligible for problem ticket credit.

(d) The final decision on whether a ticket has satisfied the requirements for cancellation or abuses cancellation privileges will be made by the executive director. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-3-3-94, Feb. 25, 1994; amended, T-111-10-21-96, Oct. 18, 1996; amended, T-111-5-28-98, May 15, 1998.)

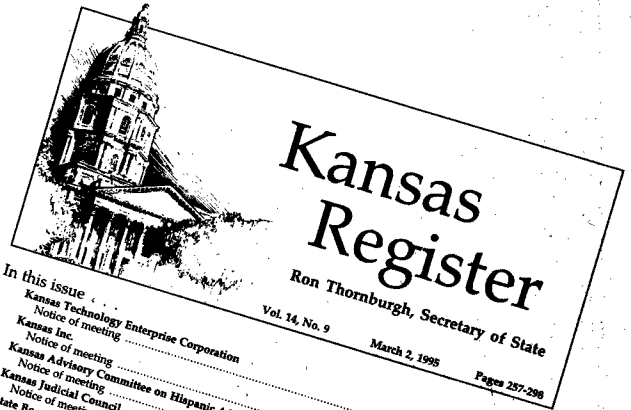
