117-8-1. Uniform standards of professional appraisal practice. The 1998 edition of the uniform standards of professional appraisal practice, as promulgated by the appraisal standards board of the appraisal foundation, copyrighted and in effect on January 1, 1998, is hereby adopted by reference. Article 2.—DRUGSTORES

68-2-20. Pharmacist's function in filling a prescription. (a) Those judgmental functions that constitute the filling or refilling of a prescription shall be performed by a licensed pharmacist only and shall consist of the following steps:

(1) read and interpret the prescription of a licensed practitioner, as defined by K.S.A. 1997 Supp. 65-1637(b), and amendments thereto;

(2) limit any filling or refilling of a prescription to one year from the date of origin, except as provided by K.S.A. 1997 Supp. 65-1637, and amendments thereto;

(3) verify the compounding, counting, and measuring of ingredients and document the accuracy of the prescription;

(4) identify, in the pharmacy record, the pharmacist who verifies the accuracy of the completed prescription;

(5) personally offer to counsel each patient or the patient's agent with each new prescription dispensed, once yearly on maintenance medications and, if the pharmacist deems appropriate, with prescription refills in accordance with subsection (b);

(6) ensure the proper selection of the prescription drug product or products, devices, or suppliers as authorized by law;

(7) when supervising a pharmacy technician, delegate only nonjudgmental duties associated with the preparation of medications and conduct in-process and final checks;

(8) prohibit all other pharmacy personnel from performing those judgmental functions restricted to the pharmacist; and

(9) interpret and verify patient medication records and perform drug regimen reviews.

(b) In order to comply with paragraph (a)(5), the pharmacist or pharmacy student under the pharmacist's supervision shall perform the following:

(1) personally offer to counsel each patient or the patient's agent with each new prescription dispensed, once yearly on maintenance medications and, if the pharmacist deems appropriate, with prescription refills;

(2) provide the verbal counseling required by this subsection in person, whenever practical, or by the utilization of a telephone service available to the patient or patient's agent. Any pharmacist may authorize an exception to the verbal counseling requirement on a case-by-case basis for refills, maintenance medications, or continuous medications for the same patient;

(3) when appropriate, provide alternative forms of patient information to supplement verbal patient counseling. These supplemental forms of patient information may include written information, leaflets, pictogram labels, video programs, and auxiliary labels on the prescription vials. However, the supplemental forms of patient information shall not be used as a substitute for the verbal counseling required by this subsection;

(4) encourage proper patient drug utilization and medication administration. The pharmacist shall counsel the patient or patient's agent on those elements that, in the pharmacist's professional judgment, are significant for the patient. These elements may include the following:

(A) the name and a description of the prescribed medication;

(B) the dosage form, dosage, route of administration, and duration of therapy;

(C) special directions and precautions for preparation, administration, and use by the patient;

(D) common side effects, adverse effects or interactions, or therapeutic contraindications that may be encountered; the action required if such effects, interactions, or contraindications occur; and any activities or substances to be avoided while using the medication;

(E) techniques for self-monitoring drug therapy;

(F) proper storage requirements; and

(G) action to be taken in the event of a missed dose; and

(5) expressly notify the patient or the patient's agent if a brand exchange has been exercised.

(c) Nothing in this subsection shall be construed to require a pharmacist to provide the required patient counseling when either of the following occurs.

(1) The patient or the patient's agent refuses counseling.

(2) The pharmacist, based upon professional judgment, determines that the counseling may be detrimental to the patient's care or to the relationship between the patient and the patient's practitioner. Article 10.—ADULT CARE HOME PROGRAM

30-10-14. Prospective reimbursement. Providers participating in the medicaid/medikan program shall be reimbursed for nursing facility services or nursing facility for mental health services through rates that are reasonable and adequate to meet the resident-related costs which must be incurred by efficiently and economically operated facilities in order to provide care and services in conformity with applicable state and federal laws, regulations, and quality and safety standards. Because even efficiently and economically operated facilities may incur some excess or inefficient costs, in this prospective payment system the identification of efficiently and economically operated facilities by the procedures and limitations of this article shall be an aggregate determination. 30-10-209. ICF-MR prospective reimbursement. Providers participating in the medicaid/medikan program shall be reimbursed for ICF-MR services through rates that are reasonable and adequate to meet the client-related costs which must be incurred by efficiently and economically operated facilities in order to provide care and services in conformity with applicable state and federal laws, regulations, and quality and safety standards. Because even efficiently and economically operated facilities may incur some excess or inefficient costs, in this prospective payment system the identification of efficiently and economically operated facilities by the procedures and limitations of this article shall be an aggregate determination. (a) The Pick 3 sales promotion will commence at 6:00 a.m. on Wednesday, July 1, 1998, and end at the end of the business day as defined at K.A.R. 111-6-1 on Friday, July 31, 1998.

(b) The base period used for the contest shall be derived from the 31-day average Pick 3 ticket sales over a three-month period from March 1, 1998, through the end of the business day on June 1, 1998. A minimum base of \$20 will be established for participating retailers.

(c) At the end of the Pick 3 sales promotion, the grand prize will be awarded to the retailer with the greatest percentage increase of Pick 3 sales over the base period. The grand prize will be a \$300 credit to the winning retailer's account and promotional items. One secondary prize of \$50 credit and promotional items will be awarded in each of the remaining seven district manager routes. The secondary prizes will be awarded to the retailer in each district manager route with the greatest percentage of Pick 3 sales increase over its sales base. The district manager route winning the grand prize shall not be eligible for any secondary prize. Grand prize and secondary prize winners shall not exceed eight. Article 4.—INSTANT GAME RULES

RULES FOR INSTANT GAME NO. 57

"SUNNY MONEY"

111-4-1266. Name of game. The Kansas lottery shall conduct an instant winner lottery game entitled "Sunny Money" commencing on or after June 22, 1998. The specific rules for the "Sunny Money" game are contained in K.A.R. 111-3-1 *et seq.* and 111-4-1266 through 111-4-1269. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-7-20-98, June 19, 1998.)

111-4-1267. Definitions. The following definitions shall apply to the "Sunny Money" instant lottery game:

(a) "Game symbols" are the numbers, letters, symbols, or pictures printed in the play area of each instant game ticket and which determine if the ticket bearer is entitled to a prize. In this instant game, the game symbols are printed in black ink with matching captions. A game symbol appears in each of six play spots within the play area. Each game symbol for this instant game is one of the following: \$1.⁰⁰ - \$2.⁰⁰ - \$4.⁰⁰ - \$5.⁰⁰ - 10.⁰⁰ - 20.⁰⁰ - 25.⁰⁰ - 50.⁰⁰ - \$2000 - \$4000 - sun symbol.

(b) "Game symbol captions" are the words or portions of words, letters or numbers printed beneath each game symbol in the play area and are used to repeat or explain the game symbol. The game symbol caption associated with each game symbol is as follows:

(c) "Ticket validation number" means a unique number appearing on each ticket which is used to validate winning tickets. For this instant game, the ticket validation number is an 11-digit number which appears on the front of each instant ticket and will be covered by latex.

(d) "Book-ticket number" means the unique number appearing on each ticket which includes the number of the book from which it was removed and the serially assigned number of the ticket within that book. For this instant game, the book-ticket number is an 8-digit book number followed by a dash and then a 3-digit ticket number. The ticket numbers in each book start with 000 and end with 299. The book-ticket number is printed in black ink on the back of each instant game ticket both above the information form and below the bar code.

(e) "Retailer validation code" means the small letters found under removable covering in the play area of each instant game ticket. The retailer uses this code to verify and validate winners which are to be paid by the retailer. In this instant game, the retailer validation code is a three-

letter code printed and appearing in three of six varying locations among the game symbols. The codes and their meanings are as follows: ONE = \$1.00; TWO = \$2.00; FOR = \$4.00; FIV = \$5.00; TEN = \$10.00; TWY = \$20.00; FTY = \$50.00.

(f) "Bar code" means the 16-digit bar-coded number appearing on the back of each ticket. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-7-20-98, June 19, 1998.)

111-4-1268. Determination of instant prize winners. An instant prize winner is determined for this instant game when a player removes or "scratches off" the removable layer of material covering the play area to reveal six prize amounts or five prize amounts and a "sun symbol." This is a match three of six dollar amounts or a match two dollar amounts plus a "sun symbol" to win double the dollar amount. If a player matches three like prize amounts, the player wins that amount. If a player matches two like prize amounts plus a "sun symbol," the player wins double the prize amount. No ticket will be eligible to win more than one prize. (Authorized by K.S.A. 1997 Supp. 74-8710(b), (c) and (i); implementing K.S.A. 1997 Supp. 74-8710(b), (c) and (i), and K.S.A. 74-8720(b) and (d); effective, T-111-7-20-98, June 19, 1998.)

111-4-1269. Number and value of instant prizes.

(a) There will be approximately 1,800,000 tickets ordered initially for this instant game. The expected number and value of the instant prizes are as follows:

(c) All prizes are subject to deductions provided by law.

(d) Additional ticket orders shall have the same prize structure, the same number of prizes per prize pool of 300,000 tickets and the same odds as were contained in the initial ticket order. 111-4-1270. Name of game. The Kansas lottery shall conduct an instant winner lottery game entitled

"Triple Cash In A Flash" commencing on or after June 22, 1998. The specific rules for the "Triple Cash In A Flash" game are contained in K.A.R. 111-3-1 *et seq.* and 111-4-1270 through 111-4-1273. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-7-20-98, June 19, 1998.)

111-4-1271. Definitions. The following definitions shall apply to the "Triple Cash In A Flash" instant lottery game:

(a) "Game symbols" are the numbers, letters, symbols, or pictures printed in the play area of each instant game ticket and which determine if the ticket bearer is entitled to a prize. In this instant game, the game symbols are printed in black ink with matching captions. A game symbol appears in each of six play spots within the play area. Each game symbol for this instant game is one of the following: FREE - \$1.00 - \$2.00 - \$5.00 - 10.00 - 20.00 - 50.00 - \$100 - \$250 - \$500 - \$1500 - \$\$ - \$\$\$.

111-4-1276. Cost of ticket. The price of "Fall Fest" instant tickets sold by a retailer shall be \$2.00 each. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-7-20-98, June 19, 1998.)

111-4-1277. Determination of instant prize winners. An instant prize winner is determined for this instant game when a player removes or "scratches off" the removable layer of material covering the three play areas to reveal the 12 game symbols and captions. This is a ticket with three distinct games featuring three separate play areas.

Game 1 is a "key number match" game. A player will remove the scratch-off material to reveal two "winning numbers" and six "your numbers." If any of the "your numbers" match either "winning number," the player wins the prize below that number. A player can win up to six times in this game.

(b) The executive director may terminate the sale of tickets prior to the complete sale of all tickets. In this event, the number and value of prizes will be approximately proportional to the number of tickets actually sold. The odds of winning a prize in this game are one in 4.89.

(c) All prizes are subject to deductions provided by law.

(d) Additional ticket orders shall have the same prize structure, the same number of prizes per prize pool of 300,000 tickets and the same odds as were contained in the initial ticket order. (Authorized by K.S.A. 1997 Supp. 74-8710(b), (c) and (f); implementing K.S.A. 1997 Supp. 74-8710(b); (c) and (f), and K.S.A. 74-8720; effective, T-111-7-20-98, June 19, 1998.)

Article 6.—ON-LINE GENERIC GAME RULES

111-6-7. Validation requirements. (a) To be a valid winning on-line ticket, all of the following conditions must be met:

(1) The ticket data must have been recorded in the central computer system prior to the drawing and the information appearing on the ticket must correspond with the computer record to the extent necessary to determine whether the ticket is a winning ticket.

(2) The ticket shall be intact to the extent that all information appearing on the ticket corresponds with the lottery's computer records.

(3) The ticket shall not be mutilated to the extent that the lottery is unable to determine whether the ticket is a winning ticket.

(4) The ticket shall not be altered or tampered with in any manner.

(5) The ticket shall not be counterfeit or a duplicate of another winning ticket.

(6) The ticket must have been issued by an authorized on-line retailer in an authorized manner.

(7) The ticket must not have been stolen or cancelled.

(8) The ticket must not have been previously paid.

(9) The ticket must contain numbers which make it eligible to win a prize pursuant to specific game rules as determined by the lottery.

(10) The ticket shall pass all other confidential security checks of the lottery.

(11) The ticket must be validated through the lottery's computer system.

(12) The ticket shall be the only valid evidence for claiming a prize. A play slip or a copy of the ticket has no monetary or prize value and shall not constitute evidence of a ticket purchase or of numbers selected.

(b) Any ticket failing any of the validation requirements listed above is invalid and ineligible for a prize. The final decision on whether a prize is paid will be made by the executive director.

(c) In the event of a dispute between the executive director and a claimant as to whether a ticket is a valid winning ticket, and if the executive director determines that the ticket is not a valid winning ticket and a prize is not paid, the executive director may replace the disputed ticket with a ticket of equivalent sales price for a future drawing of the current game or refund the cost of the ticket. These shall be the sole and exclusive remedies of the claimant.

(d) In the event a defective on-line ticket is purchased or is damaged as it is issued from an authorized terminal to the extent that it does not contain all validation and the lottery's security requirements, the only responsibility or liability of the lottery or the on-line retailer shall be the replacement of the defective on-line ticket with another on-line ticket for a future drawing of the same game.

(e) In the event an incorrect number is entered into the lottery's on-line computer system terminals following a drawing described in specific game rules and the incorrect number is reflected in reports generated by the computer system, the lottery shall not be responsible for the payment of claims presented as a result of the entry of an incorrect number in a computer system terminal which may have been used in the validation process.

(f) Subject to certain conditions, prize payment may be made for an on-line ticket or share over \$600 in value that is not received or not recorded by the lottery by applicable deadlines. The following conditions may constitute exceptions to the validation requirements previously identified in subsections (a), (b), (c), (d) and (e):

(1) Consideration will only be given to claimants with on-line tickets or shares that have been destroyed or lost during a validation attempt at an authorized retail location.

(2) A record of the event must be contained within the database of the lottery's central computer system accu-

rately identifying the retailer, the validation attempt, the date, ticket serial number, the time of the event, the terminal number, and the prize amount.

(3) The claimant must present the claim to lottery headquarters office in Topeka, be authorized to purchase an on-line ticket or share, be eligible to claim a prize, and be the rightful recipient of the prize claimed as determined by the lottery.

(4) The claimant will complete and sign both a Kansas lottery winner claim form and an affidavit providing the following information: the prize amount claimed, the retailer name, address, and city where the ticket was purchased, the game played, the date of purchase, the time of purchase, the type of wager (quick pick or personal selection), the numbers wagered if personal selection, the dollar value wagered, the retailer name, address, and city where the validation attempt occurred, the date and time the validation attempt occurred, the manner or means by which the ticket or share was destroyed or lost, a description of the clerk or retailer who performed the validation attempt and destroyed or lost the ticket, and any other information that will establish the validity of the claim.

(5) The lottery will enter information from the winner claim form and the affidavit into a database contained within the lottery's central computer system.

(6) Lottery security will conduct an investigation to determine if the claim is or is not supported by the investigation and will submit a report with a recommendation to that effect to the executive director of the lottery.

(7) If the executive director determines that the claim is otherwise supported by the investigation, and if no other claimant has presented the ticket in question, the prize will be validated through the lottery's central computer system on the last day of the expiration period. If the validation period expires on a weekend or on a holiday when the lottery is closed, the validation will be conducted on the next working day.

(8) Following expiration of the validation period, a valid claim will be paid. Such payment will be restricted to the original prize amount only. No interest will be paid.

(9) The final decision on whether a prize will be paid shall be made by the executive director. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-89-4, Jan. 22, 1988; amended, T-111-9-1-92, Aug. 28, 1992; amended, T-111-12-2-97, Nov. 21, 1997; amended, T-111-7-20-98, June 19, 1998.)

Payment of Principal and Interest

The Treasurer of the State of Kansas shall serve as the bond registrar and paying agent for the bonds, and the principal of the bonds shall be payable upon surrender at the paying agent's principal offices in the city of Topeka, Kansas. Interest shall be paid by the mailing of a check or draft of the paying agent to the registered owners of the bonds.

Security for the Bonds

The bonds and the interest thereon shall constitute general obligations of the city, and the full faith, credit and resources of the city shall be pledged to the payment thereof. A public hearing will be conducted at 1 p.m. Thursday, October 8, in the auditorium of the Kansas Bureau of Investigation, 1620 S.W. Tyler, Topeka, to consider adoption of proposed changes in existing rules and regulations of the Kansas Attorney General.

This 30-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the Office of the Attorney General, c/o Assistant Attorney General Camille Nohe, 2nd Floor, Kansas Judicial Center, 301 S.W. 10th Ave., Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to 10 minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Pat Pound at (785) 296-8242 or (800) 766-3777 (TDD). Handicapped parking is located at the south end of the parking area in front of the Kansas Bureau of Investigation building and also on the upper parking area south of the KBI building. The entrance near the upper parking area south of the building is accessible to individuals with disabilities.

These regulations are proposed for adoption on a permanent basis. A summary of the proposed regulations and their economic impact follows.

K.A.R. 16-1-7. Fees. Pursuant to 1998 Senate Bill 234, the Attorney General is authorized to adopt regulations to establish private detective and private detective agency license fees, firearm permit fees, firearm trainer certificate fees, application packet fees and duplicate license fees within statutory maximums. These fees are established in this regulation.

Both initial and renewal applicants for a private detective license, private detective agency license, firearm permit or firearm trainer certificate will be affected in some manner through an adjustment, a raising or a lowering of current fees:

(a) The license application fee for a private detective agency is currently a maximum of \$120 (prorated at the rate of \$10 per month) for a license which expires December 31 of the year issued. This fee will be adjusted to a maximum of \$240 (prorated at the rate of \$10 per month) for a license which expires December 31 of the year following the year in which it is issued.

(b) The renewal fee for a private detective agency is currently \$120 annually. In its effect, the regulation will lower this fee to \$175 biennially (\$87.50 per year).

(c) The license application fee for an independent private detective (not an employee of a private detective

agency) is currently a maximum of \$120 (prorated at the rate of \$10 per month) for a license which expires December 31 of the year issued. This fee will be adjusted to a maximum of \$240 (prorated at the rate of \$10 per month) for a license which will expire December 31 of the year following the year in which it is issued.

(d) The renewal fee for an independent private detective is currently \$120 annually. In its effect, the regulation will lower this fee to \$175 biennially (\$87.50 per year).

(e) The license application fee for an employee, officer, director, partner or associate of a private detective agency who engages in detective business is currently \$18 for a license which expires December 31 of the year issued.

For an employee of a private detective agency, this fee will be adjusted to a maximum of \$240 (prorated at the rate of \$10 per month) for a license which will expire December 31 of the year following the year in which it is issued.

For an officer, director, partner or associate of a private detective agency who engages in detective business, this fee will be raised to a maximum of \$96 (prorated at the rate of \$4 per month) for a license which will expire December 31 of the year following the year in which it is issued.

(f) The renewal fee for an employee, officer, director, partner or associate of a private detective agency who engages in detective business is currently \$18 annually.

The renewal fee for an employee of a private detective agency will be raised to \$175 biennially (\$87.50 per year).

The renewal fee for an officer, director, partner or associate of a private detective agency who engages in detective business will be raised to \$50 biennially (\$25 per year).

(g) The firearm permit application fee and renewal fee are currently \$10 annually; each will be raised to \$50 biennially (\$25 per year).

(h) The firearm trainer application fee and renewal fee are currently \$25 annually; each will be adjusted to \$50 biennially (\$25 per year).

(i) A \$15 application packet fee will initially be charged, but will be credited against the application fee of any person who subsequently submits an application.

(j) A duplicate license fee of \$5 is established.

1998 Senate Bill 234 establishes a private detective fee fund. License, permit, certificate and other fees received pursuant to this regulation will be deposited in this fund and used by the Attorney General to administer the private detective licensure program. Prior to the enactment of 1998 Senate Bill 234, license, permit and certificate fees were deposited in the general fund and were not available to the Attorney General to administer the program.

Other governmental units, private citizens and consumers will be minimally affected by these changes.

K.A.R. 16-2-1. Definitions. The proposed amendment adds a definition of "independent private detective," a term which is necessary in the fee regulation, K.A.R. 16-1-7, to clarify the appropriate amount of the initial and renewal license fees for an applicant or a licensed private detective who is not an employee, officer, director or associate of a licensed private detective agency and who

(continued)

does not employ any other person to engage in detective business.

There is no economic effect on the Attorney General, other governmental agencies, private citizens or consumers of private detective services.

K.A.R. 16-3-1. Procedure. The proposed amendment reiterates the statutory requirement that an applicant submit two classifiable sets of fingerprints and adds the historical requirement that the fingerprints be taken by an officer or employee of a law enforcement agency on a form approved by the Attorney General.

Effect: Historically, the Attorney General through the Kansas Bureau of Investigation has required applicants for a private detective license to obtain fingerprints from a law enforcement agency. This historical requirement is codified in the regulation. Many law enforcement agencies will continue to charge \$5-\$6 to provide this service to such applicants.

K.A.R. 16-5-1. Individuals deemed personally qualified and knowledgeable. The proposed amendment brings the regulation into conformity with 1998 Senate Bill 234, § 13 by requiring two (instead of one) classifiable sets of fingerprints for an applicant for a firearm instructor certificate who is not a licensed private detective. It also adds the requirement that the fingerprints be taken by an officer or employee of a law enforcement agency on a form approved by the Attorney General.

Effect: Historically, the Attorney General through the Kansas Bureau of Investigation has required applicants for a firearm trainer permit to obtain fingerprints from a law enforcement agency. This historical requirement is codified in the regulation. Many law enforcement agencies will continue to charge \$5-\$6 to provide this service to such applicants.

K.A.R. 16-6-1. Training in the handling of firearms. The proposed amendment clarifies that a certified firearms trainer may not certify himself in relation to satisfactory completion of training in the handling of firearms and the lawful use of force in order to be granted a firearm permit or have a firearm permit renewed. It also corrects a cited reference to another regulation.

A certified firearm instructor who is also a licensed private detective will need to pay or trade for services with another certified firearm instructor to obtain the applicable training in order to obtain and review his or her firearm permit. The cost of a 16-hour initial training program is approximately \$300 to \$500 plus any associated costs for travel, meals, lodging and ammunition. The cost of a nine-hour renewal training program in the handling of firearms and the lawful use of force is approximately \$200 to \$300 plus any associated costs for travel, meals, lodging and ammunition.

There is no economic effect on the Attorney General, other governmental agencies, private citizens or consumers of private detective services.

K.A.R. 16-6-3. Firearm permit badge. Pursuant to 1998 Senate Bill 234, a licensed private detective who holds a firearm permit to carry a concealed weapon is authorized to carry a firearm permit badge designed by the Attorney General. The bill specifies that the cost of the badge shall be borne by the private detective. This regulation explains that such a private detective may obtain a firearm permit

badge and a badge holder upon written request to the Attorney General through the Kansas Bureau of Investigation and upon payment for reimbursement for the cost of the badge and badge holder. The cost to a licensed private detective who chooses to obtain the authorized firearm permit badge and badge holder is approximately \$50.

The Kansas Department of Health and Environment has received and reviewed a new municipal solid waste landfill permit application from Browning Ferris Industries of Western Kansas, Inc. (BFI) to develop a Subtitle "D" landfill adjacent to the existing landfill. KDHE is providing public notice of its intent to issue a municipal solid waste permit for a new landfill, which will encompass the new area and the existing Finney County landfill - Permit #504. The new landfill (Permit #768) is approximately 220 acres, including the existing county landfill. The landfill is located in the northwest quarter and the west ½ of the northeast quarter of Section 30, Township 24 South, Range 31 West. The site is approximately 3½ miles east of Garden City and 1½ miles south of U.S. Highway 50.

BFI was retained by Finney County in 1994 to operate the existing county landfill. With the issuance of a new landfill permit, BFI will become owner and operator of

the new landfill. As a condition of the new permit, BFI will purchase the existing landfill area within 180 days of the new permit being issued. Originally contracted by Finney County, SCS Engineers, Inc. was retained by BFI to continue to modify and develop design plans, complete location restriction demonstrations, perform engineering analysis, and develop a groundwater monitoring system for the landfill. A composite liner consisting of soil and a geomembrane along with a leachate collection system were included in the design of all future landfill cells. BFI's landfill application and subsequent documentation developed by SCS Engineers, Inc. fulfill the requirements of Kansas administrative regulations.

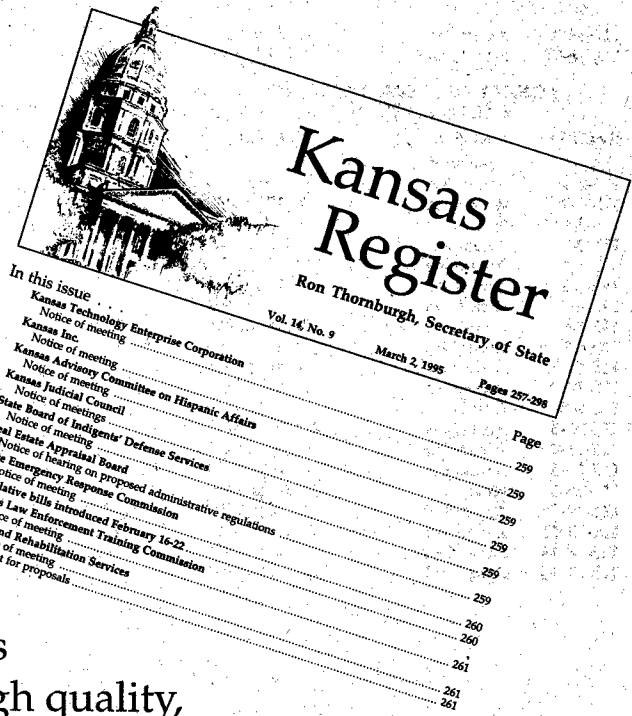
