Notice of Hearing on Proposed
Administrative Regulations

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Thursday, March 18, at the Holiday Inn Holidome, 530 Richards Drive, Manhattan, to consider the approval and adoption of a proposed regulation of the Kansas Department of Wildlife and Parks.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 1:30 p.m. March 18 at the location. The meeting will recess at 5 p.m., then resume at 7 p.m. at the same location for the regulatory hearing. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. March 19 at the same location.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulation and economic impact statement in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Cindy Baugh, commission secretary, at (316) 672-5911. Persons with a hearing impairment may call the TDD service at (800) 766-3777 to request special accommodations.

This 60-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on the proposed administrative regulation.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, Suite 502, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulation. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulation.

The regulation that will be heard during the regulatory hearing portion of the meeting is as follows:

K.A.R. 115-11-2. This regulation establishes operation procedures for controlled shooting areas. The primary changes proposed would establish minimum total release numbers for game birds, restrict the number of birds harvested to the number of birds that had been released within the previous seven days, and require a department form for transport of birds taken on a controlled shooting area.

Economic Impact Summary: The majority of the proposed changes require procedural adjustments, creating no economic impact to the department, the public or other state agencies. Minimum release requirements could create added expense for some smaller controlled shooting areas. However, department records indicate most areas already meet or exceed these release requirements.

Opinion 98-58

Schools—Federal Funds; Right of Privacy—Federal Laws and Regulations; Right of Privacy Policies. Warren D. Andreas, Legal Counsel, Unified School District No. 465, Winfield, December 17, 1998.

State educational authorities are among the entities listed under 20 U.S.C.A. § 1232g(b)(1)(C) that may receive records containing personally identifiable information contained in educational records subject to the Family Educational Rights and Privacy Act. Likewise, the receipt of personally identifiable information is permissible under the Individuals With Disabilities Education Act when the information is used to examine the rate of long-term suspensions and expulsions of children with disabilities, or to provide data to the Secretary of Education regarding the number of children with disabilities, by race, ethnicity and disability category, who are removed to an interim alternative education setting. The information must be maintained by the state educational officials in a manner that will not permit the personal identification of pupils and their parents by persons other than those officials. Opinion 98-59

Schools—School Safety and Security Act—Safe and Secure Schools; Reports of Criminal Acts to Law Enforcement Agencies and State Board of Education. Paul J. Morrison, Johnson County District Attorney, Olathe, December 21, 1998.

Unified school districts are required by subsection (b) of K.S.A. 1997 Supp. 72-89b03, as amended by L. 1998, Ch. 171, § 4, to adopt a policy establishing a procedure for reporting to the police, county attorney, Attorney General, Kansas Highway Patrol, or other similar law enforcement agency, as appropriate, acts which have been committed at school, on school property, or at a school supervised activity when the acts involve conduct which constitutes the commission of a felony or misdemeanor or the possession, use or disposal of explosives, firearms, or other weapons. A unified school district may adopt a policy whereby all reports of incidents are made to an employee designated by the board of education of a unified school district. The designated employee may then

review the reports. If it is determined that the incident involved conduct which constitutes the commission of a felony or a misdemeanor, or which involves the possession, use or disposal of explosives, firearms, or other weapons, the law requires the designated employee to forward the report to the appropriate law enforcement agency. A school policy providing for the reporting of an incident to a school resource officer who is employed by the police department or other law enforcement agency as a law enforcement officer may fulfill the requirements of K.S.A. 1997 Supp. 72-89b03 if such manner of reporting is acceptable to the law enforcement agency. Executive Order 99-1

WHEREAS, on September 27, 1997, at approximately 3:16 a.m., the Dodge City Police Department was dispatched to 2906 Dora Lane, Apartment D, Dodge City, Kansas, to investigate the death of Shelly Ann Gehlen.

WHEREAS, Shelly Ann Gehlen left work at the Pizza Hut Delivery at approximately 1:30 a.m. on September 27, 1997. After numerous attempts to contact Gehlen, a co-worker went to Gehlen's apartment. Gehlen was found lying in her bed. An autopsy revealed Gehlen died as a result of strangulation.

WHEREAS, law enforcement officers and technicians from the Dodge City Police Department, Kansas Bureau of Investigation, Ford County Sheriff's Department and Sedgwick Forensic Labs have been involved in Gehlen's investigation. Officers have interviewed over 111 individuals, and 185 pieces of evidence have been collected and processed.

WHEREAS, a reward would enhance the investigative efforts of the agencies and officers involved in this heinous crime.

NOW THEREFORE, by virtue of authority vested in me by K.S.A. 75-113, I, Bill Graves, Governor of the State of Kansas, do hereby offer a reward of five thousand dollars (\$5,000.00) for information leading to the arrest and conviction of the murderer or murderers of Shelly Ann Gehlen.

This document shall be filed with the Secretary of State as Executive Order 99-1, and shall become effective immediately.

Article 19.—AMBIENT AIR QUALITY STANDARDS AND AIR POLLUTION CONTROL

28-19-50. (Authorized by K.S.A. 65-3005, 65-3010; effective Jan. 1, 1971; amended, E-73-8, Dec. 27, 1972; amended Jan. 1, 1974; revoked Jan. 29, 1999.)

28-19-650. Emissions opacity limits. (a) Except as otherwise provided in K.A.R. 28-19-9, K.A.R. 28-19-11, or K.A.R. 28-19-31, in subsections (b) and (c) of this regulation, or in other applicable air quality regulations, opacity of visible air emissions from any emission unit shall not exceed the following limits:

(1) 40 percent opacity for any portable source existing on or before January 1, 1971;

(2) 40 percent opacity for any emission unit, other than a portable source, that existed on or before January 1, 1971 and that has not been relocated after January 1, 1971; and

(3) 20 percent opacity for any other emission unit.

(b) Special opacity limits, Wyandotte county. Air emissions within Wyandotte county from any processing of materials or other uses of the premises within the county shall not exceed 20 percent opacity.

(c) Exceptions. Air emissions opacity levels that exceed the specified limits in subsections (a) and (b) of this regulation shall not be considered a violation of this regulation if the owner or operator of the emission unit demonstrates to the satisfaction of the department that the opacity exceedance is due solely to the presence of uncombined water in the plume.

(d) Method. The determination of opacity of air emissions shall be made either by 40 C.F.R. Part 60, appendix A, method 9, as adopted in K.A.R. 28-19-720, or by another method approved in advance by the department. (Authorized by K.S.A. 1997 Supp. 65-3005 and K.S.A. 1997 Supp. 65-3007; implementing K.S.A. 1997 Supp. 65-3005, K.S.A. 65-3006, and 65-3010; effective Jan. 29, 1999.)

AND STANDARDS OF PRACTICE**60-3-101. Licensure.** (a) Licensure by examination.

(1) Not later than 30 days before the examination date, each applicant for licensure by examination shall file with the board a completed application and tender the fee prescribed by K.A.R. 60-4-101.

(2) The application shall be filed on a form adopted by the board.

(3) Each applicant for nursing licensure shall take and pass the examination prepared by the national council of state boards of nursing.

(b) Licensure by endorsement.

(1) Each applicant for licensure by endorsement shall file with the board a completed application and tender the fee prescribed by K.A.R. 60-4-101. The application shall be filed on a form adopted by the board.

(2) Verification of a current Kansas license shall be provided to other state boards upon request and upon payment of the prescribed fee.

(c) Information regarding examinations.

(1) The examination for licensure shall be administered at designated sites.

(2) Each candidate shall present a validated admission card in order to be admitted to the examination center.

(3) Any applicant cheating or attempting to cheat during the examination shall be deemed not to have passed the examination.

(4) If the answer key is lost or destroyed through circumstances beyond the control of the board, the candidate shall be required to retake the examination in order to meet requirements for licensure, except that there shall be no examination fee charged to the applicant.

(5) Individual examination results shall be released to the school from which the examinee graduated.

(6) Any candidate requesting modifications to the examination procedures or materials because of a learning disability shall provide written documentation from the appropriate medical professional confirming the learning disability, an evaluation completed within the last five years by a learning disabilities evaluation team, and a letter from the nursing program confirming learning and testing modifications made during the course of study.

(d) Application for reexamination. Any applicant who fails to make a passing score on the licensure examination may retake the examination and shall pay an examination fee for each retest as established by K.A.R. 60-4-101. 60-3-106. Licensure qualifications. (a) As part of the application process, each individual applying for licensure in Kansas who is a graduate of a foreign nursing school shall submit that individual's education and licensure credentials for evaluation to the commission on graduates of foreign nursing schools (CGFNS) or some other credentialing agency approved by the board.

(b) Any individual applying for licensure in Kansas who is a graduate of a foreign nursing school in which instruction was not in English may be granted a license if that individual meets all other requirements for licensure in effect at the time of application and shows proof of proficiency in English by passing any of the following:

(1) The commission on graduates of foreign nursing school's examination of English;

(2) the test of English as a foreign language and the test of spoken English; or

(3) similar examinations, as approved by the board.

- (2) a specific content outline for all of the areas of low performance on the diagnostic profile;
- (3) methods of study, including the following:
 - (A) Self-study;
 - (B) study groups;
 - (C) tutors; or
 - (D) any other methods as approved by the board;
- (4) a schedule for study that meets the following requirements:
 - (A) 30 hours per each low performance area;
 - (B) a start date; and
 - (C) completion in six months or the petition shall be considered abandoned;
- (5) learning resources identified to be used in the study that meet these requirements:
 - (A) a written bibliography in a standard documentation format, with resources no more than five years old; and
 - (B) four types for each low performance area selected from the list as follows:
 - (i) Textbooks;
 - (ii) journals;
 - (iii) review books;
 - (iv) audiovisuals;
 - (v) computer-assisted instruction; or
 - (vi) computer review programs.
 - (f) A registered professional nurse shall provide written verification that the individual has completed the study plan.

(g) Academic nursing courses, clinical observations, or other learning activities to meet study requirements may also be prescribed by the board. (6) Any candidate requesting modifications to the examination procedures or materials because of a learning disability shall provide written documentation from the appropriate medical professional confirming the learning disability, an evaluation completed within the last five years by a learning disabilities evaluation team, and a letter from the mental health technician program confirming the learning and testing modifications made during the course of study.

(d) Application for retest. An applicant who fails to make a passing score on the licensure examination may retake the examination and shall pay an examination fee for each retest as established by K.A.R. 60-8-101.

(e) If an individual fails to pass the licensure examination within 24 months from graduation, the individual shall petition the board in writing before being allowed to retake the licensure examination. The petition shall be on a form provided by the board and shall contain the following:

- (1) The name of the school of graduation;
- (2) the date of graduation;
- (3) the number of months or years since graduation;
- (4) the number of times taking the licensure examination;
- (5) the dates of the licensure examinations;

Article 5.—TRANSFER OF GRAIN BETWEEN PUBLIC WAREHOUSES

25-5-1. Transfer of grain between public warehouses. (a) A public warehouseman, as defined by K.S.A. 34-223(l) and amendments thereto, who lacks sufficient space and desires to transfer grain for which valid receipts have been issued may do so either by physical movement of the grain or by other methods accepted by the secretary as standard industry practice, subject to the following terms and conditions:

(1) The shipping public warehouse shall immediately notify the secretary before the transfer of receipted grain. Notice to the secretary shall include the location where the grain will be transferred for storage. The shipping public warehouseman shall also provide written notice to all depositors who hold receipts for grain that the shipping public warehouseman may forward grain deposited on a commingled basis.

(2) For purposes of this regulation, a licensed public warehouse means a warehouse operated by a public warehouseman who holds an unsuspended, unrevoked license under the U.S. warehouse act for grain, or a public warehouse operated by a public warehouseman who holds an effective warehouse license for the public storage of grain, rice, or both issued by a state that has financial, bonding, and examination requirements for the benefit of all depositors.

(3) The shipping public warehouseman shall promptly obtain nonnegotiable warehouse receipts from the receiving public warehouseman for all transferred grain. The receipts shall be on forms furnished by the secretary pursuant to K.S.A. 34-238(c) and amendments thereto. Receipts shall not be used in any other manner except as expressly provided by Kansas statutes. The receipts shall be retained by the shipping public warehouseman to be presented to and used by department examiners in lieu of an on-site inventory. The grain covered by these receipts shall not be the property of either the receiving or shipping public warehouseman but shall be held in trust by both parties solely for the benefit of the depositors whose bailed grain was transferred individually or collectively, and the depositor or the depositor's transferee shall retain title to it.

(4) The shipping public warehouseman's bond shall be increased to consider the addition of the transferred grain to the licensed capacity of the public warehouse with the net worth requirements based on the total of the licensed capacity and the forwarded grain. The bond amount shall not be required to be more than \$500,000 unless necessary to cover a deficiency in net worth to meet the requirements of K.S.A. 34-228(c) and amendments thereto.

(5) The shipping public warehouseman shall continue to retain that individual's obligations to the owners for all grain deposited in the public warehouse for storage, whether forwarded or retained, and shall redeliver the

(continued)

grain upon demand to the depositor or the depositor's transferee at the public warehouse where the grain was first deposited for storage.

(6) Nothing in this regulation shall in any way diminish the right of the owner of the grain to receive on delivery, or the obligation of the public warehouseman of a licensed public warehouse from which the product is transferred to deliver, to the owner, grain in the amount and of the kind, quality, and grade called for by the warehouse receipts or other evidence of storage.

(7) If it is the shipping public warehouseman's obligation by terms of the warehouse receipt or otherwise to insure the grain subject to the transfer, that individual shall in accordance with K.S.A. 34-236, and amendments thereto, keep this grain insured in that individual's own name or transfer the grain only to a public warehouse where the grain is fully insured.

(b) A shipping public warehouseman may transfer stored grain, as defined by K.S.A. 34-227 and amendments thereto, by complying with the provisions of paragraphs (a)(2), (5), (6), and (7) of this regulation. Article 1.—GENERAL OPERATIONS

111-1-5. Restrictions on who may participate. (a) In addition to persons prohibited from playing Kansas lottery games pursuant to K.S.A. 74-8719, and amendments thereto, any person, officer or employee of a vendor contracting for the production of a televised drawing or the auditing of lottery games, is prohibited from purchasing lottery tickets and from winning prizes in any game in which they perform services pursuant to contract.

(b) A spouse, child, stepchild, brother, stepbrother, sister, stepsister, parent or stepparent of a person described by subsection (a), or a person who resides in the same household as any person described by subsection (a), is also prohibited from purchasing lottery tickets and from winning prizes in any game in which any person described in subsection (a) performs services pursuant to contract.

(c) In the event of a dispute concerning this requirement, the executive director has the authority to determine the facts underlying the dispute and make a decision as to the participation of such a person in purchasing lottery tickets and winning prizes. Article 2.—LOTTERY RETAILERS

111-2-80. "Ask for the sale" promotion. (a) During the period beginning January 1, 1999, and ending January 31, 1999, in addition to compensation provided for in K.A.R. 111-2-4, the Kansas lottery also offers all Pete's Corporation stores located in Kansas an opportunity to participate in a bonus retailer "ask for the sale" incentive promotion of lottery tickets.

(b) On each Wednesday in January 1999, including January 6, 13, 20 and 27, all Pete's Corporation stores' personnel selling Kansas lottery tickets will ask every adult customer making a purchase if the customer would like to purchase a lottery ticket. If the employee fails to ask adult customers for the purchase of a lottery ticket and the customer brings it to the clerk's attention before leaving the premises, the retailer shall give the adult customer one \$1.00 instant lottery ticket at no charge.

(c) All retailer employees at each location shall wear promotional buttons and display special point-of-sale materials provided by the lottery each Wednesday from 7:00 a.m. to 10:00 p.m. during the promotion announcing the promotion to its customers. These promotional materials consist of:

(1) A tent card to be displayed at the point where tickets are sold.

(2) A window/monitor banner to be displayed at the front entrance of the business and/or below the lottery information display system monitor. These materials must be on display during all hours of the promotion at the times and dates established in subsections (b) and (c) for a store to be eligible for a prize.

(d) The Kansas lottery will provide each location with a credit of \$35. This will be credited to each store's account at the beginning of the promotion.

(e) Any tickets given away above the \$35 allowance representing 35 tickets per location will be the responsibility of Pete's Corporation.

(f) Each retail location shall maintain a ticket log form to be completed every time a lottery ticket is given away. The log will be picked up by the Kansas lottery district manager servicing the retailer location at the end of the promotion.

(g) At the end of the promotion, one store will win one pack of instant tickets selected by the lottery. The pack will be awarded with the winner being determined by a drawing. With each five percent increase in total lottery sales during the sales period over the base period, the store will receive an entry into the drawing. Promotional items will also be awarded to the first, second, and third place stores based on the percentage increase in total lottery sales over the predetermined base. The base sales period for each store shall be the 31-day average sales based upon total lottery sales from January 1, 1998, through January 31, 1998, compared to total sales from January 1, 1999, to January 31, 1999. The drawing will be conducted at lottery headquarters as soon as possible after sales increases are determined following the promotion. (Authorized by K.S.A. 1997 Supp. 74-8710; implementing K.S.A. 1997 Supp. 74-8710 and K.S.A. 74-8708; effective, T-111-12-21-98, Dec. 10, 1998.)

111-2-82. "Ask for the sale" promotion. (a) During the period beginning January 1, 1999, and ending January 31, 1999, in addition to compensation provided for in K.A.R. 111-2-4, the Kansas lottery also offers the following Love's stores, numbers 11, 24, 25, 32, 39, 43, 44, 58, 59, 60, 61, 62, 63 and 97, an opportunity to participate in a bonus retailer "ask for the sale" incentive promotion of lottery tickets.

(b) On each Wednesday in January 1999, including January 6, 13, 20 and 27, the above-mentioned Love's stores' personnel selling Kansas lottery tickets will ask every adult customer making a purchase if the customer would like to purchase a lottery ticket. If the employee fails to ask adult customers for the purchase of a lottery ticket and the customer brings it to the clerk's attention before leaving the premises, the retailer shall give the adult customer one \$1.00 instant lottery ticket at no charge.

(c) All retailer employees at each location shall wear promotional buttons and display special point-of-sale materials provided by the lottery each Wednesday from 6:00 a.m. to 6:00 p.m. during the promotion announcing the promotion to its customers. These promotional materials consist of:

(b) On each Friday in January 1999, including January 1, 8, 15, 22 and 29, the above-mentioned Pump Mart

stores' personnel selling Kansas lottery tickets will ask every adult customer making a purchase if the customer would like to purchase a lottery ticket. If the employee fails to ask adult customers for the purchase of a lottery ticket and the customer brings it to the clerk's attention before leaving the premises, the retailer shall give the adult customer one \$1.00 instant lottery ticket at no charge.

(e) Any tickets given away above the \$25 allowance representing 25 tickets per location will be the responsibility of the regional Pump Mart stores.

(f) Each retail location shall maintain a ticket log form to be completed every time a lottery ticket is given away. The log will be picked up by the Kansas lottery district manager servicing the retailer location at the end of the promotion.

(g) At the end of the promotion, the Pump Mart store with the greatest percentage increase in total sales for the period from January 1, 1999, to January 31, 1999, over the period from January 1, 1998, to January 31, 1998, will win a pack of instant tickets and promotional items. The second and third place stores will receive promotional items provided by the lottery. 111-2-84. Pull-tab retailer sales incentive. In addition to the compensation specified in K.A.R. 111-2-4 and K.A.R. 111-2-6, for the period from January 11, 1999, through February 26, 1999, all Kansas lottery retailers certified to sell Kansas lottery pull-tabs, who purchase and have delivered a carton of any four current 50 cent pull-tab games, shall receive a carton of a \$1.00 pull-tab game selected by the lottery at no additional charge. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-12-21-98, Dec. 10, 1998.)

Article 4.—INSTANT GAME RULES

RULES FOR INSTANT GAME NO. 29

"WIZARD OF OZ"

111-4-1381. Name game. The Kansas lottery shall conduct an instant winner lottery game entitled

"Wizard of Oz" commencing on or after December 11, 1998. The specific rules for the "Wizard of Oz" game are contained in K.A.R. 111-3-1 *et seq.* and 111-4-1381 through 111-4-1385. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-12-21-98, Dec. 10, 1998.)

111-4-1382. Definitions. The following definitions shall apply to the "Wizard of Oz" instant lottery game:

(a) "Game symbols" are the numbers, letters, symbols, or pictures printed in the play area of each instant game ticket and which determine if the ticket bearer is entitled to a prize. In this instant game, there will be no prize symbols imaged in the game play area. Each game symbol for this instant game is one of the following: symbol of arrow facing left; symbol of arrow facing right; symbol of arrow facing up; symbol of arrow facing down; symbol of arrow facing both left and right; and symbol of arrow facing both up and down.

(b) "Ticket validation number" means a unique number appearing on each ticket which is used to validate winning tickets. For this instant game, the ticket validation number is an 11-digit number which appears below the game symbols under the latex covering in the play area on the front of each instant ticket.

(c) "Book-ticket number" means the unique number appearing on each ticket which includes the number of the book from which it was removed and the serially assigned number of the ticket within that book. For this instant game, the book-ticket number is an 8-digit book number followed by a dash and then a 3-digit ticket number. The ticket numbers in each book start with 000 and end with 099. The book-ticket number is printed in black ink on the back of each instant game ticket both below the information form and below the bar code.

(d) "Retailer validation code" means the small letters found under removable covering in the play area of each instant game ticket. The retailer uses this code to verify and validate winners which are to be paid by the retailer. In this instant game, the retailer validation code is a three-letter code printed and appearing in three of eight varying locations among the game symbols in the play area. (e) "Bar code" means the 16-digit bar-coded number appearing on the back of each ticket. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-12-21-98, Dec. 10, 1998.)

111-4-1383. Cost of ticket. The price of "Wizard of Oz" instant tickets sold by a retailer shall be \$3.00 each. (Authorized by and implementing K.S.A. 1997 Supp. 74-8710; effective, T-111-12-21-98, Dec. 10, 1998.)

111-4-1384. Determination of instant prize winners. "Wizard of Oz" is a maze game. An instant prize winner is determined for this instant game when the player removes or "scratches off" the removable layer of material covering the square marked "ENTER." The arrow revealed will indicate which square is to be scratched next. A player shall continue to scratch, following the arrows, until exiting the maze at either one or two locations.

If a player exits the maze directly on a prize amount, the player wins that prize. A player can win up to two times on a single ticket. 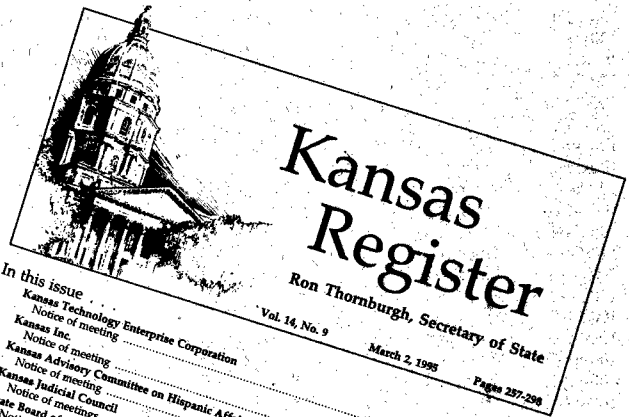
