Proposed Traffic Regulations

A public hearing will be conducted from 3 to 5 p.m. Thursday, April 22, in the Little Theater, Student Union, Kansas State University, Manhattan, concerning the adoption of regulations governing traffic and parking on the roads, streets, driveways and parking facilities at the Kansas State University Manhattan campus. The following is a summary of the substance of the rules and proposed changes:

- A new permit, to be used by students at the Chester Peters Recreation Complex, was designated to cost \$30 a year or \$20 a semester.
- Temporary medical permits will now be purchased at the Riley County Courthouse.
- The cost of a lost or stolen permit will be the prorated cost of that type of permit.
- The fine for a forged, altered or stolen permit will be increased from \$60 to \$85. The additional money will be refunded to those that report a lost permit, once the permit is recovered.
- Skateboard rules and fines have been added.

Executive Order 99-2

**Requiring Executive Branch Agencies to
Provide the State's Chief Information
Technology Officer Year 2000 Reports Pursuant
to CITO Reporting Standards**

WHEREAS, information is an asset and resource for delivery of services to Kansas citizens. The State of Kansas relies upon its computer systems to manage information and accomplish its business functions with accuracy and speed. The State's information technology resources are critical to the State's ability to provide services to its citizens.

WHEREAS, many of the State's systems rely upon accurate date calculations to perform required functions. Kansas, along with the rest of the world, faces a significant problem with computer system software that will not function properly after December 31, 1999, because the technology will not recognize the century change.

WHEREAS, without a way to recognize the century change, information in the State's computer, telecommunications, and embedded chip systems will be interpreted inconsistently and date calculations will be performed incorrectly, presenting a threat to the State's ability to conduct business and serve citizens.

WHEREAS, the Kansas Information Technology Executive Council has established a goal that state agencies will have identified and corrected all computer programs that will not function properly when the Year 2000 is reached.

WHEREAS, time is of the essence if the State is to take advantage of this opportunity to both prepare for the century change and update essential state information systems.

NOW THEREFORE, pursuant to the authority vested in me as Governor and chief executive of the State of Kansas by Article 1, Section 4 of the Constitution of the State of Kansas, I hereby order that each executive branch agency repair their information technology systems for Year 2000 compliance and provide Year 2000 reports to the Executive Branch Chief Information Technology Officer (CITO). Repairs shall be done in accord with schedules developed by the Chief Information Technology Officer (CITO) to insure all executive branch systems properly function in the year 2000 and beyond. Reports shall contain information required by the CITO reporting standards as set forth in the Year 2000 Web Database Asset Tracking and Readiness System, available through the Department of Administration, Division of Information Systems and Communications or at the web site, <http://y2k.state.ks.us>.

This document shall be filed with the Secretary of State as Executive Order No. 99-2, and shall become effective immediately.

Wildlife and Parks Commission**Notice of Hearing on Proposed
Administrative Regulations**

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Tuesday, April 27, at the Country Kitchen Convention Center, 3203 N. Vine, Hays, to consider the approval and adoption of proposed regulations of the Kansas Department of Wildlife and Parks.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 1:30 p.m. April 27 at the location listed above. The meeting will recess at 5 p.m., then resume at 7 p.m. at the same location for the regulatory hearing. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. April 28 at the same location.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Cindy Baugh, commission secretary, at (316) 672-5911. Persons with a hearing impairment may call the TDD service at (800) 766-3777 to request special accommodations.

This 60-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on the proposed regulations.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, Suite 502, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The administrative regulations that will be heard during the regulatory hearing portion of the meeting are as follows:

K.A.R. 115-16-4. This regulation provides methods for the issuance of big game control permits. One proposed amendment would allow the use of taking methods other than firearms in order to allow the use of control permits in areas where firearm use is prohibited or otherwise inappropriate. A second amendment would revise the conditions for receiving a control permit to remove requirements that the applicant make efforts to alleviate the problem through other nonhunting means or methods.

Economic Impact Summary: The proposed amendments may have indirect positive economic impact by providing more flexibility to control big game populations where necessary. Otherwise, no significant economic impact is anticipated.

K.A.R. 115-17-21. This proposed regulation would allow feral pigeons to be commercially harvested by any person with a valid hunting license, without regard to number or season. It is otherwise illegal to commercially harvest any wildlife without authorization through law or regulation.

Economic Impact Summary: The proposed regulation would provide some economic benefit to persons who decide to harvest feral pigeons for commercial use, although the department is unable to estimate that impact.

K.A.R. 115-30-10. This regulation establishes provisions and restrictions concerning the operation of personal watercraft. Under current law, no person under the age of 16 may operate a personal watercraft unless accompanied by someone over the age of 17, or unless the person is over the age of 12 and has completed boater safety education. The proposed amendment would state that no person in possession of a personal watercraft shall permit its operation by anyone under the age of 16, unless the same conditions are met.

Economic Impact Summary: The proposed regulation is not anticipated to have a significant economic impact.

Form of Bonds

The bonds will be issued in book-entry-only form.

Paying Agent and Bond Registrar; Payment of Principal and Interest

The Kansas State Treasurer shall serve as the bond registrar and paying agent for the bonds. The principal amount of and the interest on the bonds shall be paid by the paying agent from funds made available by the county by wire transfer of same day funds to Cede & Co., nominee for the Depository Trust Company, New York, New York (DTC). Article 2.—MAXIMUM LIGHTING STANDARDS

27-2-1. (Authorized by K.S.A. 1979 Supp. 58-1313; effective, E-80-24, Dec. 12, 1979; effective May 1, 1980; revoked March 12, 1999.)

Article 1.—RULES OF PRACTICE AND PROCEDURE

82-1-221a. Confidentiality. (a) Any document, data, customer-specific contract, proprietary information, trade secret, or other commercial information filed with or furnished to the Kansas corporation commission (commission) as confidential shall, in addition to the requirements set forth in the Kansas statutes annotated and the Kansas administrative regulations, comply with the following requirements:

(1) The term "document" or "documents," as used in this regulation, means any original, copy, or draft of any handwritten, typewritten, printed, graphic, or electronically recorded material, and shall include the following:

- (A) Correspondence;
- (B) notes;
- (C) memoranda;
- (D) studies;
- (E) reports;
- (F) records;
- (G) charts;
- (H) invoices;
- (I) bills;
- (J) diaries;
- (K) calendars;
- (L) books;
- (M) statements;
- (N) appointment books;
- (O) tape recordings;
- (P) videos;
- (Q) faxes;
- (R) computer printouts and software;
- (S) electronically recorded media; and
- (T) any other writing or tangible record of any kind, type, or nature, and however produced.

(2) The party seeking to classify documents as confidential shall file with or furnish to the executive director of the commission each document clearly marked "CONFIDENTIAL," accompanied by a cover letter requesting confidential status.

(3) Confidential information contained on a floppy disk or other electronic device shall be filed or furnished separately from other devices containing nonconfidential information. The electronic device containing the confidential material shall be clearly marked "CONFIDENTIAL."

(4) The information contained on floppy disks or other electronic devices shall also contain the "CONFIDENTIAL" designation on each page or other subdivision of information when printed.

(continued)

(5) A written explanation of the confidential nature of each document shall accompany each page for which confidential status is sought. One written explanation may apply to more than one page of confidential information, if the identity and confidential nature of each individual page is clearly stated in the explanation. The explanation shall be specific to the document in question and shall state whether the information constitutes a trade secret or confidential commercial information. The explanation shall further specify the harm or potential harm that disclosure would cause to the entity seeking nondisclosure.

(b) Requests for information classified as confidential shall be made by filing a written request with the executive director of the commission and using a form provided by the commission for this purpose, or by motion from a party to the docket in which the information is sought.

(1) If a request for information classified as confidential is not filed as a motion in an active KCC docket, the entity seeking to maintain the confidential status of the information shall be notified by the commission of the request. The entity seeking to maintain the confidential status shall have five working days after service, plus three days if service is by mail, to respond to this request. Any response filed with the commission in opposition to a request shall substantiate the basis for nondisclosure and shall be served upon the commission and the entity requesting disclosure. The entity requesting disclosure may reply to the response within five working days after service, plus three days if service is by mail, by serving a reply upon the entity seeking to maintain nondisclosure and upon the commission.

(2) A request made by a party to a docket for disclosure of confidential documents or information contained within the docket shall be made by motion. No party shall request disclosure from the commission of information classified as confidential until the party has requested the information in writing from the party seeking to maintain its confidential nature and this request has been denied. The motion shall proceed in accordance with the Kansas corporation commission's rules of practice and procedure, K.A.R. 82-1-201 *et seq.*

(3) A determination of the confidential nature of the information and whether or not to require the disclosure of the confidential information requested under paragraphs (b)(1) and (b)(2) above shall be issued by the commission in accordance with K.S.A. 66-1220a and amendments thereto.

(c) Each person making a request pursuant to K.S.A. 45-215 *et seq.*, and amendments thereto, for nonconfidential information shall submit the request in writing and shall include the requester's name, address, telephone number, and the name of the business or entity represented.

(d) Confidential documents submitted to the corporation commission before the adoption of this regulation, including information required by statute, regulation, or order of the commission, shall be handled in accordance with statutes, regulations, and orders applicable at the time the document was submitted. Requests for access to any of this information shall be handled in accordance with the provisions of this regulation.

(e) Documents filed pursuant to K.A.R. 82-3-107 shall be exempt from the requirements of this regulation. (Authorized by and implementing K.S.A. 66-1220a; implementing K.S.A. 1997 Supp. 66-101c, K.S.A. 1997 Supp. 66-117, K.S.A. 1997 Supp. 66-151, K.S.A. 1997 Supp. 66-2010, K.S.A. 1997 Supp. 66-1,190, K.S.A. 1997 Supp. 66-1,203 and K.S.A. 55-704; effective March 12, 1999.)

82-1-221b. Protective orders. A party before the commission seeking issuance of a protective order to protect confidential material shall do so by motion. (Authorized by and implementing K.S.A. 66-1220a; implementing K.S.A. 1997 Supp. 66-101c, K.S.A. 1997 Supp. 66-117, K.S.A. 1997 Supp. 66-151, K.S.A. 1997 Supp. 66-2010, K.S.A. 1997 Supp. 66-1,190, and K.S.A. 1997 Supp. 66-1,203; effective March 12, 1999.)

82-1-228. Hearings. (a) General provisions. Public hearings shall be held in the hearing rooms of the commission, in any district courtroom, at any other place in Kansas that the commission may deem appropriate or at any place required by statute. All hearings before the commission shall be conducted by the commission or by a presiding officer who may be a commissioner, a hearing examiner, or any other person duly authorized by the commission to conduct the hearing. The provisions of these regulations governing hearings before the commission shall be applicable to hearings conducted by the presiding officer.

(b) Convening of hearings. On the date and at the place and time stated in the notice of the hearing, the presiding officer conducting the hearing shall call the docket by announcing the docket number and by reading the caption of the case into the record. Commission hearings shall be opened in a formal way on each day upon which commission business is transacted.

(c) Scope of hearing. The presiding officer may make a concise statement of the scope and the purpose of the hearing and the issues involved therein at the beginning of the hearing.

(d) Appearances. Each attorney for a party, and any other representative authorized by the commission pursuant to paragraph (3) of this subsection, shall enter an appearance by giving the attorney or representative's name and address for the record.

(1) Except as otherwise provided in paragraph (2) of this subsection, any party may perform any of the following:

(A) Appear before the commission and be heard in person and on that party's own behalf;

(B) appear and be represented by an attorney who is regularly admitted to practice in the courts of record of the state of Kansas; or

(C) appear and be represented by any regularly admitted practicing attorney in the courts of record of another state of the United States, if the nonresident attorney complies with the requirements set forth in K.S.A. 7-104, and amendments thereto. The local counsel shall first enter the local counsel's own appearance and shall then orally move for the admission of the nonresident attorney with whom local counsel is associated.

(2) Except as otherwise provided in paragraph (3) of this subsection, a corporation shall not be permitted to enter an appearance, except by its attorney.

(3) In any intrastate railroad proceeding brought pursuant to the Staggers Rail Act of 1980 that comes before the commission, a resident of the state of Kansas who is not an attorney-at-law may represent a party before the commission if both of these conditions are met:

(A) The person is a duly registered interstate commerce commission class B practitioner who is representing the person's permanent employer or is a duly elected officer of a union representing a group of employees of a railroad.

(B) The person has obtained approval of the commission to appear as a representative upon a motion. The motion shall include the individual's qualifications, the name of the party and the proceeding in which the individual wishes to appear.

(e) Preliminary matters. After the calling of the docket, the statement of the scope and purpose of the hearing, and the entries of the appearances of attorneys or other representatives for the parties, the oath required by K.S.A. 7-104, and amendments thereto, shall be administered to the nonresident attorneys by the presiding officer. Thereafter, an oral order admitting them as attorneys or representatives in the proceeding then pending shall be made by the presiding officer, and they shall enter their appearances on the record. Thereafter, the following matters shall be disposed of in the following order:

(1) Petitions for intervention;

(2) any other pending petitions or motions;

(3) stipulations of the parties whereby parties may make written or oral stipulations in conformance with these regulations, and stipulations of facts shall be regarded as evidence at the hearing. Stipulations shall not be binding upon the commission; and

(4) opening statements of attorneys or other representatives for the parties. Opening statements, if any, shall be made immediately before the introduction of testimony.

(f) Hearing room conduct.

(1) The conduct of attorneys and other representatives during a hearing shall be the same as the conduct required of attorneys in the district courts of Kansas, so as to reflect respect for the dignity and authority of the applicable facts and the correct principles of law. Attorneys and other representatives shall examine witnesses from a position at the counsel table, except when handling exhibits. Anyone whose conduct before the commission is deemed inappropriate may be refused permission to appear by the commission.

(2) Smoking shall not be permitted on commission premises.

(3) The use of photographic equipment or recording devices shall not be prohibited during hearings, except that the presiding officer may regulate the use of this equipment or these devices so as to insure the orderly conduct of the proceedings. (Authorized by and implementing K.S.A. 1997 Supp. 55-604, K.S.A. 55-704, K.S.A. 66-103, K.S.A. 1997 Supp. 66-106, K.S.A. 66-165; effective Jan. 1, 1966; amended Feb. 15, 1977; amended, T-83-12, June 9, 1982; amended May 1, 1983; amended July 23, 1990; amended March 22, 1993; amended March 12, 1999.)

82-1-235. Petitions for reconsideration; compliance with orders. Any party being aggrieved by any order or decision of the commission may file a petition for reconsideration before the commission. All petitions for reconsideration shall be filed pursuant to the appropriate statutory provisions relating to them.

(a) If the petitioner relies on the ground that the commission, in making its determination, did not consider any of the evidence presented in the proceeding, the petition for reconsideration shall cite that portion of the transcript where the testimony appears, if the transcript is available on the date of the commission's order, and the application shall specify by number the exhibits and the pertinent portion thereof that is alleged not to have been considered by the commission.

(b) Service. A party filing a petition for reconsideration shall serve a copy upon all parties to the proceeding in the manner prescribed by these regulations for the filing and service of pleadings.

(c) Types of hearings for reconsideration. A petition for reconsideration shall specify the type of reconsideration requested, which shall be one of the following:

(1) General reconsideration of all issues of fact or law involved in the initial hearing and the commission's order;

(2) specific reconsideration of issues of fact or law, limited to those issues of fact or law specified in the petition for reconsideration;

(3) reconsideration for oral argument or legal authorities relating to legal issues and the commission's conclusions of law; or

(4) reconsideration for submission of additional evidence that was either not available or not known to exist at the time of the hearing.

(d) Nature of additional evidence. If the petition is to reopen the case for further evidence, the nature and purpose of the evidence shall be briefly stated, and the same shall not be merely cumulative.

(e) Order of procedure. The burden of going forward with the evidence shall rest upon the applicant or applicants who procured the reconsideration, and the applicant or applicants shall open and close.

(f) Evidence in original hearing. All the evidence, rules and regulations, instruments, and other documents admitted or received in the original hearing or subsequent hearings shall, by operation of this regulation, become a part of the record in the reconsideration, unless otherwise directed by the commission.

(g) Multiple petitions for reconsideration. Each party desiring reconsideration shall file a petition for reconsideration. Any party that files a petition for reconsideration shall rely solely upon its own application. An applicant may dismiss its petition for reconsideration at any time. All parties are entitled to cross-examine witnesses and be heard at the hearing where facts or issues are given reconsideration. Direct testimony may be introduced only by applicants. Rebuttal testimony may be introduced by any party. When two or more petitions for reconsideration are granted, they shall be consolidated for hearing and shall be heard on a common record. There shall be only one hearing for reconsideration, regardless of how

Article 11.—NATURAL GAS PIPELINE SAFETY

82-11-3. Transportation of natural and other gas by pipeline; annual reports and incident reports. The federal rules and regulations entitled "transportation of natural and other gas by pipeline; annual reports and incident reports," title 49 CFR, part 191, as in effect on October 1, 1997, are adopted by reference with the following exceptions, deletions, additions, and modifications:

(a) The following sentence shall be deleted from 49 CFR 191.3: "'Secretary' means the Secretary of Transportation or any person to whom he has delegated authority in the matter concerned."

(b) 49 CFR 191.5(b) shall be deleted and replaced by the following: "(b) Each notice required by paragraph (a) of this section shall be made by telephone to the gas pipeline safety section and to the U.S. department of transportation. Both notices shall include the following information:

- (1) The names of the operator and the person making the report and their telephone numbers;
- (2) the location of the incident;
- (3) the time of the incident;
- (4) the number of fatalities and personal injuries, if any; and
- (5) all other significant facts known by the operator that are relevant to the cause of the incident or extent of the damages."

(c) 49 CFR 191.7 shall be deleted.

(d) The term "Department of Transportation Form RSPA F 7100.1," as used in 49 CFR 191.9(a), means Kansas corporation commission form KCC 192.004-1 (gas distribution system).

(e) 49 CFR 191.9(a) shall be deleted and replaced by the following: "(a) Except as provided in paragraph (c) of this section, each operator of a distribution pipeline system shall submit U.S. department of transportation form RSPA F 7100.1 as soon as practicable but not more than 30 calendar days after detection of an incident required to be reported under 49 CFR 191.5."

(f) 49 CFR 191.9(b) shall be deleted and replaced by the following: "(b) If additional relevant information is required after the report is submitted under paragraph (a), each operator shall submit to the commission a written report providing the additional information pertaining to the incident within 15 calendar days of the commission's request."

(g) 49 CFR 191.11(a) shall be deleted and replaced by the following: "(a) Except as provided in paragraph (b) of this section, each operator of a distribution pipeline system shall submit an annual report in duplicate for that system on department of transportation form RSPA F 7100.1-1. This report shall be submitted to the gas pipeline safety section not later than March 1 of each year, for the preceding calendar year."

(h) The term "Department of Transportation Form RSPA F 7100.1-1," as used in 49 CFR 191.11(a), means U.S. department of transportation form RSPA F 7100.1-1.

(i) The term "Department of Transportation Form RSPA F 7100.2," as used in 49 CFR 191.15(a), means Kansas corporation commission form 192.004-1 (gas transmission and gathering systems).

(j) 49 CFR 191.15(a) shall be deleted and replaced by the following: "(a) Except as provided in paragraph (c) of this section, each operation of a transmission or a gathering pipeline system shall submit U.S. department of transportation form RSPA F 7100.2 as soon as practicable but not more than 30 calendar days after detection of an incident required to be reported under 49 CFR 191.5."

(k) 49 CFR 191.15(b) shall be deleted and replaced by the following: "(b) If additional relevant information is required by the commission after the report is submitted under paragraph (a), each operator shall submit to the commission a written report providing the additional information pertaining to the incident within 15 calendar days of the commission's request."

(l) The term "Department of Transportation Form RSPA F 7100.2-1," as used in 49 CFR 191.17(a), means U.S. department of transportation form RSPA F 7100.2-1.

(m) 49 CFR 191.17(a) shall be deleted and replaced by the following: "(a) Except as provided in paragraph (b) of this section, each operator of a transmission or gathering pipeline system shall submit an annual report in duplicate for that system on department of transportation form RSPA F 7100.2-1. This report shall be submitted to the gas pipeline safety section not later than March 1 of each year, for the preceding calendar year."

(n) 49 CFR 191.19 shall be deleted and replaced by the following: "Report Forms. The prescribed report forms are available without charge upon request from the commission, gas pipeline safety section, Topeka, Kansas. Reproduced copies of the forms may be used if in the same size and kind of paper."

(o) 49 CFR 191.21 shall be deleted.

(p) The term "Secretary," as used in 49 CFR 191.25, means commission. (Authorized by and implementing K.S.A. 66-1,150; effective, T-82-10-28-88, Oct. 28, 1988; effective, T-82-2-25-89, Feb. 25, 1989; revoked, T-82-3-31-89, April 30, 1989; effective May 1, 1989; amended April 16, 1990; amended March 12, 1999.)

82-11-4. Transportation of natural and other gas by pipeline; minimum safety standards. The federal rules and regulations entitled "transportation of natural and other gas by pipeline; minimum federal safety standards," title 49 CFR, part 192, including appendices A, B, C, and D, as in effect on October 1, 1997, are adopted by reference with the following exceptions, deletions, additions, and modifications:

(a) 49 CFR 192.7(b) shall be deleted and replaced by the following: "(b) Any incorporated document shall be available for inspection at the commission, gas pipeline safety section, Topeka, Kansas. In addition, each document shall be available at the addresses provided in appendix A to this part."

(b) 49 CFR 192.181(a) shall be deleted and replaced by the following: "(a) Each high-pressure distribution sys-

tem shall have valves spaced to reduce the time to shut down a section of main in an emergency. Each operator shall specify in its operation and maintenance manual the criteria as to how valve locations are determined using, as a minimum, the considerations of operating pressure, the size of the mains, and the local physical conditions. The emergency manual shall include instructions on where operating personnel can find maps and other means of locating emergency valves during an emergency. Each area of residential development constructed after May 1, 1989 shall be provided with at least one valve to isolate it from other areas."

(c) 49 CFR 192.199(e) shall be deleted and replaced by the following: "(e) Have discharge stacks, vents, or outlet ports designed to prevent accumulation of water, ice, or snow, located where gas can be discharged into the atmosphere without undue hazard; provided that, at town border stations and district regulator settings, the gas shall be discharged upward at a minimum height of six feet from the ground or past the overhang of any adjacent building, whichever is greater."

(d) 49 CFR 192.199(h) shall be deleted and replaced by the following: "(h) Except for a valve that will isolate the system under protection from its source of pressure, shall be designed to prevent unauthorized access to or operation of any stop valve that will make the pressure relief valve or pressure limiting device inoperative including,

(1) valves that would bypass the regular or relief devices, and

(2) shut-off valves in regulator control lines that, if operated, would cause the regulator to be inoperative."

(e) The following shall be added to 49 CFR 192.199(i): "At town border stations and district regulator settings, this section shall require pressure relief or pressure limiting devices regardless of installation date."

(f) 49 CFR 192.307 shall be deleted and replaced by the following: "Inspection of materials. Each length of pipe and each other component shall be visually inspected at the site of installation to ensure that it has not sustained any visually determinable damage that could impair its serviceability. Each coated length of pipe shall be instrumentally checked for defects in the coating prior to lowering into the ditch."

(g) 49 CFR 192.311 shall be deleted and replaced by the following: "Repair of plastic pipe. Each imperfection or damage that would impair the serviceability of plastic pipe shall be removed."

(h) 49 CFR 192.317(b) shall be deleted and replaced by the following: "(b) Each aboveground transmission line or main, not located offshore or in inland navigable water areas, shall be protected from accidental damage by vehicular traffic or other similar causes, by being placed at a safe distance from the traffic or by installing barricades, and complying with 49 CFR 192.707(c)."

(i) The following subsection shall be added to 49 CFR 192.317: "(d) Each aboveground pipeline shall be placed underground by December 31, 1995, with the following exceptions:

- (1) Regulator station piping;
- (2) bridge crossings;
- (3) aerial crossings or spans;

(4) short segments of piping for valves intentionally brought above ground, including but not limited to risers, piping at compressor, processing or treating facilities, block gate settings, sectionalizing valves and district regulator sites;

(5) distribution mains specifically designed to be above ground and have the approval of the landowner to provide service to commercial customers from the above ground main and associated service line(s); or

(6) Pipelines in class 1 locations."

(j) The following shall be added to 49 CFR 192.317: "(e) Each pipeline constructed after May 1, 1989, shall be placed under ground, with the following exceptions:

(1) Regulator station piping;

(2) bridge crossings;

(3) aerial crossings or spans;

(4) short segments of piping for valves intentionally brought above ground, including but not limited to, risers, piping at compressor, processing or treating facilities, block gate settings, sectionalizing valves and district regulator sites; or

(5) distribution mains specifically designed to be above ground and have the approval of the landowner to provide service to commercial customers from the above ground main and associated service line(s)."

(k) 49 CFR 192.453 is adopted by reference, and the following additional provisions shall be adopted:

"An initial electrical survey shall be conducted by May 1, 1991, on all unprotected bare steel service lines whether company-owned or customer-owned. If active corrosion is found, the piping shall be either provided with cathodic protection and monitored annually as required by K.A.R. 82-11-4(q) or replaced. In areas where there is no active corrosion, each operator shall, at intervals not exceeding three years, reevaluate these pipelines. In lieu of conducting electrical surveys on service lines, each operator shall notify the commission by June 1, 1989, which of the following options it will implement:

(a) Conduct annual flame ionization leak surveys on all unprotected bare steel service lines and implement a replacement program whereby all bare steel service lines will be removed by December 31, 1993;

(b) conduct annual flame ionization leak surveys on all unprotected bare steel service lines and initiate a program to place anodes on all bare steel service lines by December 31, 1991; or

(c) conduct annual flame ionization surveys on all unprotected bare steel service lines. A preventative maintenance program shall be used in conjunction with the annual leak survey of unprotected bare steel to determine when these service lines will be replaced. After the annual leak survey of all unprotected bare steel service lines is completed, the operator shall prepare a summary listing of the leak survey results. The summary listing shall include the number of leaks found and the lines replaced in a defined area. Based upon the results of the summary listing, an operator's replacement program shall be initiated when the number of service lines with existing leaks, repaired leaks or already replaced due to corrosion, in a defined area equals 25% or more of the bare steel lines installed within that defined area. The replacement pro-

(continued)

gram, once initiated for a defined area, shall be completed by an operator within 18 months."

(l) 49 CFR 192.455(a) shall be deleted and replaced by the following: "(a) Except as provided in paragraphs (c) and (f) of this section, each buried, submerged pipeline, or exposed pipeline, installed after July 31, 1971, shall be protected against external corrosion, including the following:"

(m) 49 CFR 192.455(b) shall be deleted.

(n) 49 CFR 192.457(b) and (c) shall be deleted and replaced by the following: "(b) Except for cast iron or ductile iron pipelines, each of the following buried, exposed or submerged pipelines installed before August 1, 1971, shall be cathodically protected in accordance with this subpart in areas in which active corrosion is found:

- (1) Bare or ineffectively coated transmission lines;
- (2) bare or coated pipes at compressor, regulator, and measuring stations; and
- (3) bare or coated distribution lines.

(c) The operator shall determine the areas of active corrosion by electrical survey. In areas where electrical survey is impractical, the operator shall conduct flame ionization leak surveys at least once every three years at intervals not exceeding 42 months. A repair/replacement program for unprotected bare steel transmission lines and mains shall be established based upon the number of leaks in a defined area. It shall be considered practical to conduct electrical surveys in all areas, except the following:

- (1) Where the pipe lies under wall-to-wall pavement;
- (2) where the pipe is in a common trench with other utilities;
- (3) in areas with stray current; or
- (4) in areas where the pipeline is under pavement, regardless of depth, and more than two feet away from an unpaved area.

(d) For the purposes of this subpart, active corrosion means continuing corrosion which, unless controlled, could result in a condition that is detrimental to public safety."

(o) 49 CFR 192.465(a) shall be deleted and replaced by the following: "Each pipeline that is under cathodic protection shall be tested at least once each calendar year, but with intervals not exceeding 15 months, to determine whether the cathodic protection meets the requirements of 192.463. However, if tests at those intervals are impractical for separately protected short sections of mains or transmission lines not in excess of 100 feet, or separately protected service lines, these pipelines may be surveyed on a sampling basis. At least one-third of these protected structures, distributed over the entire system, shall be surveyed each calendar year, with a different one-third checked each subsequent year, so that the entire system is tested in each three-year period."

(p) 49 CFR 192.465(d) shall be deleted and replaced by the following: "(d) Each operator shall begin corrective measures within 30 days, or more promptly if necessary, on any deficiencies indicated by the monitoring."

(q) 49 CFR 192.465(e) shall be deleted and replaced by the following: "(e) After the initial evaluation required by paragraphs (b) and (c) of 192.455 and paragraph (b) of 192.457, each operator shall, at intervals not exceeding

three years, reevaluate its unprotected pipelines and cathodically protect them in accordance with this subpart in areas in which active corrosion is found. The operator shall determine the areas of active corrosion by electrical survey, or where electrical survey is impractical, by the completion of flame ionization leak surveys at intervals at least once every three years at intervals not exceeding 42 months. A repair/replacement program for bare steel transmission lines and mains shall be established based upon the number of leaks in a defined area."

(r) The following sentence shall be added to 49 CFR 192.465: "(f) It shall be considered practical to conduct electrical surveys in all areas, except the following:

- (1) Where the pipe lies under wall-to-wall pavement;
- (2) where the pipe is in a common trench with other utilities;
- (3) in areas with stray current; or
- (4) in areas where the pipeline is under pavement, regardless of depth, and more than two feet away from an unpaved area."

(s) 49 CFR 192.491(a) shall be deleted and replaced by the following: "(a) Each operator shall maintain records and maps to show the location of all cathodically protected piping, cathodic protection facilities other than unrecorded galvanic anodes installed before August 1, 1971, and neighboring structures bonded to the cathodic protection system."

(t) 49 CFR 192.491(b)(1) shall be deleted and replaced by the following: "(b) Each record and map required by paragraph (a) of this section."

(u) 49 CFR 192.509(b) shall be deleted and replaced by the following: "(b) Each main that is to be operated at less than 1 p.s.i.g. shall be tested to at least 10 p.s.i.g. and each main to be operated at or above 1 p.s.i.g. shall be tested to at least 100 p.s.i.g."

(v) The first sentence of 49 CFR 192.517 shall be deleted and replaced by the following: "Each operator shall make, and retain for the useful life of the pipeline, a record of each test performed after May 1, 1989. The record shall contain at least the following information:"

(w) The following shall be added to 49 CFR 192.517: "(h) Test date."

(x) The following shall be added to 49 CFR 192.517: "(i) Description of facilities being tested."

(y) 49 CFR 192.553(a)(1) shall be deleted and replaced by the following: "(1) At the end of each incremental increase, the pressure shall be held constant while the entire segment of pipeline that is affected is checked for leaks. This leak survey by flame ionization shall be conducted within eight hours after the stabilization of each incremental pressure increase provided in the uprating procedure. If the operator elects to not conduct the leak survey within the specified time frame because of nightfall or other circumstance, the pressure increment in the line shall be reduced that day with repetition of that particular increment during the next day that the uprating procedure is continued."

(z) 49 CFR 192.603(b) shall be deleted and replaced by the following: "(b) Each operator shall establish a written operating and maintenance plan meeting the requirements of this part and keep records necessary to admin-

ister the plan. This plan and future revisions shall be submitted to the gas pipeline safety section."

(aa) The following shall be added to 49 CFR 192.603: "(d) Each operator shall have regulator and relief valve test, maintenance and capacity calculation records in its possession whether the town border station is owned by the operator or by a wholesale supplier, if the supplier's relief valve capacity is utilized to provide protection for the operator's system.

(e) Each operator shall be responsible for ensuring that all work completed by its consultants and contractors complies with this part."

(bb) 49 CFR 192.617 shall be deleted and replaced by the following: "Investigation of failures. (a) Each operator shall establish procedures for analyzing accidents and failures, including the selection of samples of the failed facility or equipment for laboratory examination, where appropriate, for the purpose of determining the causes of the failure and minimizing the possibility of a recurrence.

(b) Each operator shall investigate each accident and failure."

(cc) 49 CFR 192.625(f) shall be deleted and replaced by the following: "Each operator shall assure the proper concentration of odorant in accordance with this section by the following:

(1) Conduct monthly odorometer sampling of combustible gases at selected points in the system; and

(2) conduct sniff tests during each service call involving entry into a structure or dwelling. Each operator shall establish in its operations and maintenance manual a procedure for selecting a minimum number of locations to be sampled for odorant if no service calls are made by the operator in any month. The operator shall then initiate contacts and sampling at those locations in the next month. Records of such sampling shall be kept for at least two years."

(dd) 49 CFR 192.703 shall be deleted and replaced by the following: "General. (a) No person shall operate a segment of pipeline, unless it is maintained in accordance with this subpart.

(b) Each segment of pipeline that becomes unsafe shall be replaced, repaired or removed from service within five days of the operator being notified of the existence of the unsafe condition.

(c) Each operator shall inspect and classify all reports of gas leaks within two hours of notification.

(d) Leaks shall be classified by use of a combustible gas indicator instrument and shall be determined as follows:

(1) A class 1 leak means a leak that represents an existing or probable hazard to persons or property, and requires immediate repair or continuous action until the conditions are no longer hazardous. This class of leak may include but not be limited to the following conditions:

(A) Any leak which, in the judgment of operating personnel at the scene, is regarded as an immediate hazard;

(B) any leak in which escaping gas has ignited;

(C) any indication that gas has migrated into or under a building, or into a tunnel;

(D) any LEL % reading at the outside wall of a building, or where gas would likely migrate to an outside wall of a building;

(E) any reading of 80% LEL, or greater, in a confined space;

(F) any reading of 80% LEL, or greater, in a small substructure from which gas would likely migrate to the outside wall of a building; or

(G) any leak that can be seen, heard, or felt, and which is in a location that may endanger the general public or property.

(2) A class 2 leak means a leak that is non-hazardous at the time of detection, but justifies scheduled repair based on probable future hazard. Class 2 leaks shall be repaired within six months after detection, but any such leak discovered after June 30 of any calendar year shall be repaired no later than December 31 of the same year, or ground freezing, whichever occurs first. This class of leak may include but not be limited to the following conditions:

(A) Any leak which, under frozen or other adverse soil conditions, would be likely to migrate to the outside wall of a building;

(B) Any reading of 40% LEL, or greater, under a sidewalk in a wall-to-wall paved area that does not qualify as a class 1 leak;

(C) Any reading of 100% LEL, or greater, under a street in a wall-to-wall paved area that has significant gas migration and does not qualify as a class 1 leak;

(D) Any reading less than 80% LEL in a small substructure from which gas would likely migrate creating a probable future hazard;

(E) Any reading between 20% LEL and 80% LEL in a confined space;

(F) Any reading on a pipeline operating at 30% SMYS, or greater, in a class 3 or 4 location, which does not qualify as a class 1 leak;

(G) Any reading of 80% LEL, or greater, in a gas associated substructure; or

(H) Any leak which, in the judgment of operating personnel at the scene, is of significant magnitude to justify scheduled repair.

(3) A class 3 leak means a leak that is non-hazardous at the time of detection and can reasonably be expected to remain non-hazardous. These leaks shall be rechecked at least every six months and repaired or replaced within 30 months. This class of leak may include but not be limited to the following conditions:

(A) Any reading of less than 80% LEL in a small gas associated substructure;

(B) Any reading under a street in areas without wall-to-wall paving where it is unlikely the gas could migrate to the outside wall of a building; or

(C) Any reading of less than 20% LEL in a confined space."

(ee) 49 CFR 192.721(a) shall be deleted and replaced by the following: "(a) The frequency with which mains are patrolled shall be determined by the severity of the conditions which could cause failure or leakage, and the consequent hazards to public safety. Intervals between patrols shall not be longer than those prescribed in the following table:

(ff) 49 CFR 192.723 shall be deleted and replaced by the following: "Distribution systems: leak surveys and procedures. (a) Each operator of a distribution system shall provide for periodic leakage surveys in its operating and maintenance plan.

(b) The type and scope of the leakage control program shall be determined by the nature of the operations and the local conditions, but it shall meet the following minimum requirements:

(1) A flame ionization leakage survey shall be conducted in business districts, including tests of the atmosphere in gas, electric, telephone, sewer and water system manholes, at cracks in pavement and sidewalks, and at other locations providing an opportunity for finding gas leaks. This survey shall be conducted at intervals not exceeding 15 months, but at least once each calendar year.

(2) A flame ionization leakage survey of the distribution system shall be conducted outside the principal business areas. The survey shall be made as frequently as necessary, but at least once every three calendar years at intervals not exceeding 42 months. Each operator's O & M Manual shall state that company designated employees are to be trained in and conduct vegetation leak surveys where vegetation is suitable to such analysis. Each leakage survey record shall be kept for at least two years.

(3)(a) A flame ionization survey must be conducted for all service lines and yard lines at least once every three years at intervals not exceeding 42 months. Unprotected bare steel service lines and yard lines must be inspected annually at intervals not exceeding 15 months utilizing flame ionization methods. Operators must have a program to replace unprotected steel service lines and yard lines when 25% in a defined area have experienced leaks. The replacements must occur within 18 months of the triggering of the replacement program. Operators (at their option) may have separate programs for service lines and yard lines, but must consistently follow their selection.

(b) For service lines/yard lines more than 220 yards in length only the portion within 220 yards of a habitable dwelling must be leak surveyed in accordance with these regulations."

(gg) Cast iron evaluation and replacement. Effective January 1, 1990, each operator with cast iron piping shall institute all of the following:

(1) Collect a coupon each time cast iron piping is uncovered. If long stretches of pipe are uncovered or if a series of short sections of pipe are uncovered, it is not necessary to take coupons at less than 200-foot intervals.

(2) Take additional coupons, if necessary, to obtain a random sample of the entire system. The minimum annual rate of such sampling shall be one coupon for each

two miles of cast iron pipe installed. The maximum required annual rate is one coupon for each one mile of cast iron pipe installed.

(3) Conduct laboratory analysis on all coupons to determine the percentage of graphitization. Coupons shall be submitted for analysis within 30 days of collection.

$$\text{Percent of graphitization} = \frac{(\text{Maximum Depth of Graphitization}) \times 100}{(\text{wall thickness})}$$

(4) Replace at least one city block (approximately 500 feet) within 120 days of the operator's knowledge of the laboratory test results, each time the results show graphitization equal to or greater than the following in a coupon:

2.0 inch	25%
3.0 inch and 4.0 inch	60%
6.0 inch and 8.0 inch	75%
10.0 inch or greater	90%

(5) Retain all sampling records for the life of the facility, but not less than five years. (Authorized by and implementing K.S.A. 66-1,150; effective, T-82-10-28-88, Oct. 28, 1988; effective, T-82-2-25-89, Feb. 25, 1989; revoked, T-82-3-31-89, April 30, 1989; effective May 1, 1989; amended April 16, 1990; amended March 12, 1999.)

82-11-9. Waiver provisions. (a) Upon application by any person engaged in the transportation of gas or the operation of pipeline facilities, compliance with any regulation of this article that is not incorporated by reference from 49 CFR 191-192 may be waived, in whole or in part, by the commission if the commission determines that the waiver is consistent with pipeline safety. The provision of notice of the proposed waiver and an opportunity for hearing on the application for waiver may be required by the commission. In addition, the waiver shall be granted only under these circumstances:

(1) By order of the commission; and

(2) after notice and opportunity for hearing, if ordered by the commission. The waiver shall be subject to any terms, conditions, and limitations deemed appropriate by the commission.

(b) Upon application by any person engaged in the transportation of gas or the operation of pipeline facilities, compliance with any regulation of this article that is incorporated by reference from 49 CFR 191-192 may be waived, in whole or in part, by the commission if the commission determines that the waiver is consistent with pipeline safety. The provision of notice of the proposed waiver and an opportunity for hearing on the application for waiver may be required by the commission. In addition, the waiver shall be granted only under these circumstances:

(1) By order of the commission;

(2) after notice and opportunity for hearing, if ordered by the commission; and

(3) upon approval of the US department of transportation under 49 USC 1671 et seq. The waiver shall be subject to any terms, conditions, and limitations deemed appropriate by the commission. (Authorized by and implementing K.S.A. 66-1,150; effective, T-82-10-28-88,

Oct. 28, 1988; effective, T-82-2-25-89, Feb. 25, 1989; revoked, T-82-3-31-89, April 30, 1989; effective May 1, 1989; amended March 12, 1999.)

82-11-10. Drug testing. The federal rules and regulations entitled "drug testing," title 49 CFR, part 199 as in effect October 1, 1997, are adopted by reference only as they apply to operators of pipeline facilities that deal in transportation of natural gas by pipeline. (Authorized by and implementing K.S.A. 66-1,150; effective April 16, 1990; amended March 12, 1999.)

82-11-11. (a) The fee for each public utility covered under K.S.A. 66-1,153 and K.S.A. 66-1,154, and amendments thereto, shall be as follows:

(1) For assessments made during calendar year 1998, the fee shall be \$0.50 per meter.

(2) For assessments made during calendar year 1999, the fee shall be \$0.75 per meter.

(3) For assessments made during calendar year 2000 and succeeding years, the fee shall be \$1.00 per meter.

(b) Subsection (a) above notwithstanding, the minimum annual assessment shall not be less than \$50.00 during calendar year 1998, \$75.00 during calendar year 1999, and \$100.00 during calendar year 2000 and succeeding

years. (Authorized by and implementing K.S.A. 66-1,153 and K.S.A. 66-1,154; effective March 12, 1999.)

Article 12.—WIRE-STRINGING RULES

82-12-2. Adoption by reference of the National Electrical Safety Code, or NESC, 1997 edition. The standard entitled the "National Electrical Safety Code," or NESC, of the American National Standards Institute, 1997 edition, ANSI C2-1997, approved June 6, 1996, and published by the Institute of Electrical and Electronic Engineers, or IEEE, is adopted by reference. However, the standard for minimum vertical clearance of wires, conductors, and cables over railroad tracks shall be the greatest of the applicable values specified in the NESC Table 232-1, K.S.A. 66-183, and K.S.A. 66-320, and amendments thereto. Copies of the NESC are available from the IEEE. A reference copy of the NESC shall also be available at the commission. (Authorized by and implementing K.S.A. 66-183; effective Aug. 11, 1995; amended March 12, 1999.)

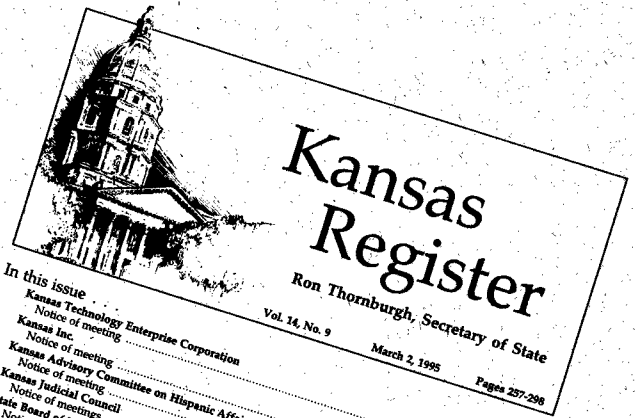
