Notice of Designation of Local Workforce  
Investment Areas

In compliance with the Workforce Investment Act of 1998, Public Law 105-220, August 7, 1998, the governor shall designate local workforce investment areas within the state. Beginning July 1, 2001, these areas will receive funds for adult and youth employment and training activities under the Workforce Investment Act.

Governor Bill Graves has proposed that through December 31, 2000, the configuration of the local workforce investment areas will be the same as the areas currently designated under the Job Training Partnership Act. In the future, the local workforce investment areas will be encouraged to seek bi-state compacts in natural labor areas that cross state borders.

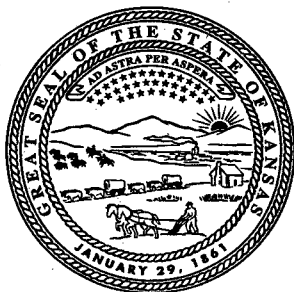

Notice of Hearing on Proposed  
Administrative Regulations

A public hearing will be conducted at 9 a.m. Wednesday, December 22, in Room 401 of the Kansas Department of Agriculture, 109 S.W. 9th, Topeka, to consider the adoption of proposed rules and regulations of the Dairy Program.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the Secretary of Agriculture, 109 S.W. 9th, 4th Floor, Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Leslie Garner at (785) 296-4623 or fax (785) 368-6668. Handicapped parking is located on the southwest corner of 9th and Jackson Streets, and the north entrance to the building is accessible to individuals with disabilities.

These regulations are proposed for adoption on a permanent basis. A summary of the proposed regulations and their economic impact follows.

Proposed amendments to K.A.R. 4-7-213 adopt by reference pertinent provisions of the 1996 provisions of the "milk for manufacturing purposes and its production and processing." Copies of the publication can be obtained from the Kansas Department of Agriculture. Currently, the regulations refer to the 1972 requirements.

Proposed amendments to K.A.R. 4-7-214 revise definitions for consistency with the 1996 federal standards.

The proposal also repeals K.A.R. 4-7-215 because the language in the current regulation is made obsolete by the adoption of the 1996 requirements.

New proposal K.A.R. 4-7-216 provides for enforcement of the 1996 requirements consistent with Kansas statutes and the practice of using the "stop-sale" mechanism to regulate the safe transfer of manufacturing grade milk.

The inspection of manufacturing grade farms and processing plants would remain the same, therefore there will be no additional costs. Each manufacturing grade farm will still be inspected an average of four and one-half times per year. Sampling frequency also will remain the same. There will be no additional cost to the dairy industry.

Copies of the regulations and their economic impact statements may be obtained from the Department of Agriculture.

Proposals will be issued upon request to all prospective bidders who have been prequalified by the Kansas Department of Transportation on the basis of financial condition, available construction equipment and experience. Also, a statement of unearned contracts (Form No. 284) must be filed. There will be no discrimination against anyone because of race, age, religion, color, sex, handicap or national origin in the award of contracts.

Each bidder shall file a sworn statement executed by or on behalf of the person, firm, association or corporation submitting the bid, certifying that such person, firm, association or corporation has not, either directly or indirectly, entered into any agreement, participated in any collusion, or otherwise taken any action in restraint of free competitive bidding in connection with the submitted bid. This sworn statement shall be in the form of an affidavit executed and sworn to by the bidder before a person who is authorized by the laws of the state to administer oaths. The required form of the affidavit will be provided by the state to each prospective bidder. Failure to submit the sworn statement as part of the bid approval package will make the bid nonresponsive and not eligible for award consideration.

Plans and specifications for the projects may be examined at the office of the respective county clerk or at the KDOT district office responsible for the work.

A public hearing will be conducted at 10 a.m. Tuesday, December 7, in Room 108, Landon State Office Building, 900 S.W. Jackson, Topeka, to consider the adoption of proposed rules and regulations of the Department of Administration, Division of Personnel Services, on a permanent basis.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the Secretary of Administration, Room 263-E, State Capitol, 300 S.W. 10th Ave., Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Faith Loretto at (785) 296-6000 or (785) 296-4798 (TTY). Handicapped parking is located at the south end of the Landon State Office Building, and the north entrance is accessible.

Summaries of the proposed regulations and their economic impact follow.

**K.A.R. 1-9-4. Vacations.** There are a number of proposed amendments to this regulation, including a number of technical amendments that have little significant impact. However, one proposed amendment adds an additional rate of vacation leave accrual for employees with 20 or more years of service (equivalent to an additional .9 hours of leave per biweekly payroll period), while another increases the maximum vacation leave accumulation by 40 hours for all length of service levels. Another proposed amendment abolishes the requirement that employees use all vacation leave over the maximum accumulation before the end of the fiscal year or forfeit the excess. Instead, employees would be paid for all vacation

leave over the maximum accumulation at the end of the fiscal year. The final proposed amendment to this regulation provides for the payout of all vacation leave, including any vacation leave in excess of the maximum accumulation, to employees upon separation from state service. Agencies will be responsible for the annual payout of leave in excess of the maximum as well as the payout of vacation leave upon separation. However, the initial impact will be lessened by the increase to the maximum accumulation. Employees will see an economic benefit from all amendments to this regulation be it in the form of payout, or in the form of more leave being available for use. Estimates indicate that the economic impact of these amendments will be under \$450,000 for all agencies.

**K.A.R. 1-9-5, Sick leave; K.A.R. 1-9-14, Transfer of leave credits.** The proposed amendments to these regulations are being proposed to permanently adopt the temporary amendments made to the regulation on September 13, 1999. The temporary amendments to K.A.R. 1-9-14 allowed for rehires who were separated from state service for more than a year to request reinstatement of sick leave balances forfeited at the time of their separation, if they provide documentation of their sick leave balance in one of three prescribed ways. Documentation may consist of the amount shown in the SHARP system, or if the employee's separation occurred before the implementation of the SHARP system, state agency leave ledgers or a copy of the pay stub from the employee's final payroll check or advice at the time of separation from the service.

K.A.R. 1-9-5 is being amended to remove language providing for the reinstatement of sick leave only to those employees who return to state service within one year. All employees who are rehired will be eligible to request reinstatement of their sick leave upon return to state service, pursuant to K.A.R. 1-9-14. New language was added stating that those employees who were compensated for unused sick leave pursuant to K.S.A. 75-5517 will not be eligible to have their sick leave reinstated.

The proposed amendments to these regulations will have a substantial economic impact on state employees and state agencies. State employees who are rehired will be able to have the sick leave balances that they had upon separation reinstated, thereby increasing the potential use of sick leave and reducing the instances in which these employees use leave without pay or request shared leave. Upon their retirement, the additional sick leave could result in higher sick leave payouts under K.S.A. 75-5517. For employees rehired prior to July 1993, the increased sick leave payout could result in retirement benefits since the sick leave pay out for these employees is included in their final average salary. Based on historical data for FY 99, it is estimated that 338 employees who are rehired to regular positions by the state would be eligible to request reinstatement of sick leave under the proposed amendments each fiscal year. Although there is no way to accurately determine the economic impact of the above-mentioned factors, it is estimated that it would be quite substantial.

**K.A.R. 1-9-27. Family and medical leave act of 1993 (FMLA).** The proposed amendment to this regulation re-

moves the requirement that employees who meet FMLA leave criteria must exhaust all of their accrued sick leave and vacation leave prior to the use of leave without pay. The effect of this amendment will be that employees must only exhaust their accrued sick leave before the use of leave without pay.

The fiscal impact of this amendment would stem mostly from the fact that employees would have their vacation leave available to use upon returning from FMLA leave. This could prolong employees' time away from work and would result in agencies having to compensate for their absence. Agencies may see a savings due to the fact that employees would go on leave without pay sooner than they currently do. However, the department is not able to accurately estimate the actual fiscal impact of this amendment, but anticipates that it will be minimal. This amendment is anticipated to have no economic impact on the general public.

Notice of Medicaid State Plan Amendment

An amendment to the State Medicaid Plan attachment 4.19D is being submitted to the federal Department of Health and Human Services Health Care Financing Administration, changing the cost center limits for intermediate care facilities for persons who are mentally retarded (ICFs/MR). Social and Rehabilitation Services, through the Commission of Substance Abuse, Mental Health and Developmental Disabilities (SAMHDD), proposes to increase selected cost center limitations for ICFs/MR effective October 1, 1999. The approved State Medicaid Plan requires that ICFs/MR cost center limitations be reviewed before October 1 of each year and, if less than 75 percent of all ICFs/MR are reimbursed less than 95 percent of their reported allowable Medicaid costs, cost center limits must be adjusted.

SRS/SAMHDD staff compared the reported allowable costs of all ICFs/MR with the current cost center limits for habilitation and administration, the two cost centers with caps, and determined adjustments in certain cost center limits were justified. The cost center limit adjustments and justifications are as follows:

Habilitation Cost Center Limits

Large facilities with more than 16 beds—

No large facility has reported allowable costs exceeding the current habilitation cost center limits. Therefore, no changes in these cost center limits will be made.

Medium facilities with 9 to 16 beds—

Level 1: One level 1 medium-sized facility reported an allowable cost that exceeded the habilitation cost cen-

ter limit, but did not meet the 95 percent threshold. Therefore, no changes in this cost center limit will be made.

Level 2: No level 2 medium-sized facility reported allowable costs that exceed the current habilitation cost center limit. Therefore, no changes in this cost center limit will be made.

Level 3: One level 3 medium-sized facility reported an allowable cost that exceeded the habilitation cost center limit, falling below the 95 percent threshold. Therefore, the cost center limit will be increased from \$120 to \$123.

Level 4: Two level 4 medium-sized facilities reported allowable costs that exceed the habilitation cost center limit, falling below the 95 percent threshold. Therefore, the cost center limit will be increased from \$106 to \$109.

Small ICFs/MR with 4 to 8 beds—

Level 1: Five level 1 small-sized facilities reported allowable costs that exceeded the habilitation cost center limit but did not meet the 95 percent threshold. Therefore, no changes in the cost center limit will be made.

Level 2: One level 2 small-sized facility reported allowable costs that exceeded the habilitation cost center limit but did not meet the 95 percent threshold. Therefore, no changes in the cost center limit will be made.

Level 3: One level 3 small-sized facility reported allowable costs that exceeded the habilitation cost center limit but did not meet the 95 percent threshold. Therefore, no changes in the cost center limit will be made.

Administrative Cost Center Limits

The reported allowable administrative costs for large-sized facilities did not meet the 95 percent threshold, therefore, no changes in the cost center limit will be made. The medium- and small-sized facilities reported a significant difference between actual costs and the cost center limits. Therefore, the following cost center limit changes will be made:

Small Facility	from \$25 to \$25.50
Medium Facility	from \$17.50 to \$18

Inflation Factor

The annual percentage rate for estimated inflation is computed using a projection based on economic forecasts and predictions of reputable and prominent national publications. The projected inflation percentage that will be used to recalculate ICF/MR rates for October 1, 1999, is 3 percent.

Financial Impact

It is estimated that the change in ICF/MR cost center limits will result in an increase in budget expenditures of \$720,000. The state general fund portion of this increase is \$288,000.

A public hearing will be conducted at 1:30 p.m. Wednesday, December 8, in the MTA conference room in the Air Terminal at Forbes Field, 6700 S. Topeka Blvd., Topeka, to consider the adoption of new regulations related to financial assurance for solid waste facilities.

The proposed new regulations will replace all previously adopted regulations and policies with respect to the allowable methods of providing closure and post-closure cost financial assurance for solid waste disposal areas and processing facilities (the current financial assurance regulations do not recognize or explain the use of all the methods of financial assurance allowed by law). The new regulations also add rules for providing financial assurance for corrective action.

The proposed new regulations will promote uniformity of understanding by providers and users of financial assurance methods and instruments, and will protect the

state from incurring costs for closure, post-closure and corrective action when owners or operators fail to complete the required actions themselves.

The regulations are proposed for adoption on a permanent basis. A summary of the proposed regulations follows.

**K.A.R. 28-29-17a. Financial assurances for closure and post-closure care.**

**K.A.R. 28-29-17b. Post-closure operations and maintenance fund.**

**K.A.R. 28-29-98. Financial assurance criteria for municipal solid waste landfills.** These solid waste management regulations are proposed to be revoked because the proposed new regulations, K.A.R. 28-29-2101 through 28-29-2113, will contain all of the financial assurance requirements for solid waste management.

**K.A.R. 28-29-2101. Financial assurance for closure and post-closure.** This regulation sets forth the general rule requiring financial assurance for closure and post-closure, lists the methods available and the times a demonstration of assurance must be made to the department, and provides rules for calculating costs to be assured.

**K.A.R. 28-29-2102. Financial assurance for corrective action.** This regulation sets forth the general rule requiring financial assurance for corrective action required by provisions of K.A.R. 28-29-114, lists the methods available and the times a demonstration of assurance must be made to the department, and provides rules for calculating costs to be assured.

**Financial Assurance Methods**

The following regulations provide the basic rules necessary to implement each method of financial assurance in addition to the specific items mentioned below.

**K.A.R. 28-29-2103. Financial assurance provided by a funded trust fund.** This regulation details the methods for determining the amounts of annual payments into the fund and the number of years during which the fund may be accumulated.

**K.A.R. 28-29-2104. Financial assurance provided by a surety bond guaranteeing payment.** This regulation requires a standby trust fund and sets out the conditions under which a surety will become liable under terms of the bond.

**K.A.R. 28-29-2105. Financial assurance provided by a surety bond guaranteeing performance.** This regulation requires a standby trust fund and sets out the conditions under which a surety will become liable under terms of the bond.

**K.A.R. 28-29-2106. Financial assurance provided by a letter of credit.** This regulation requires a standby trust fund and sets out the conditions under which the department may draft the amount of the letter of credit.

**K.A.R. 28-29-2107. Financial assurance provided by insurance.** This regulation sets out the conditions under which the insurer will become liable to pay the amount of the insurance.

**K.A.R. 28-29-2108. Financial assurance provided by a corporate financial test.** This regulation lists the financial quality indicators used in the test.

**K.A.R. 28-29-2109. Financial assurance provided by a corporate guarantee.** This regulation lists the financial quality indicators to be satisfied by a guarantor and lists the types of entities that may provide guarantees.

**K.A.R. 28-29-2110. Financial assurance provided by a local government financial test.** This lists financial quality indicators used in the test and provides for public notice that the method is in use.

**K.A.R. 28-29-2111. Financial assurance provided by a local government guarantee.** This regulation lists the financial quality indicators to be satisfied by a guarantor.

**K.A.R. 28-29-2112. Financial assurance provided by use of ad valorem taxing authority.** This regulation contains information concerning the ad valorem taxing authority method and provides for department oversight of the procedure.

**K.A.R. 28-29-2113. Financial assurance provided by a simplified financial instrument.** This regulation contains rules for use of a simplified surety bond and letter of credit that do not require a standby trust fund, and for small environmental liabilities, use of an escrow account or a pledged certificate of deposit. Available only for closure costs estimated at \$100,000 or less, the method contained in this regulation defines the permit bond rule for construction and demolition and special use landfills.

These proposed financial assurance regulations will not impose requirements on any new regulated constituency. Two of the 54 municipal solid waste landfills in Kansas are projected to have increased annual costs as a result of these regulations with a combined total of \$34,277 per year. Seventy-one other solid waste facilities are projected to have increased annual costs with a combined total of \$4,586 per year.

The time period between publication of this notice and the scheduled hearing serves as the required public comment period of at least 60 days for the purpose of receiving written public comments on the proposed regulation. #### Notice of Hearing on Proposed Administrative Regulations

A public hearing will be conducted at 9 a.m. Friday, December 10, in the third floor conference room, Kansas Insurance Department, 420 S.W. 9th, Topeka, to consider the adoption of proposed regulations.

The 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to Rebecca Sanders, Kansas Insurance Department, 420 S.W. 9th, Topeka, 66612-1678. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Rebecca Sanders at (785) 296-7811.

Copies of the full text of the regulations and the economic impact statement may be obtained by contacting Rebecca Sanders. A summary of the proposed regulations and the economic impact follows.

**K.A.R. 40-4-42. Definitions; external review.** This regulation defines terms that require definition in implementing the external review legislation passed by the 1999 Legislature.

**K.A.R. 40-4-42a. Notice requirements of adverse decisions.** The purpose of this regulation is to set out the requirements the insurance companies must meet when sending out notice of adverse decisions that insureds or providers may request review of by the external review organization.

**K.A.R. 40-4-42b. Preliminary determination by commissioner.** The purpose of this regulation is to set out procedures that the Commissioner of Insurance must fol-

low in processing requests for external review and assigning requests to the external review organization.

**K.A.R. 40-4-42c. Standard external review procedures.** The purpose of this regulation is to set out the procedure that should be followed by the external review organization and insurer in conducting a standard external review.

**K.A.R. 40-4-42d. Expedited external review.** The purpose of this regulation is to set out the procedures that should be followed in conducting the expedited external review.

**K.A.R. 40-4-42e. Minimum qualifications for external review organizations.** The purpose of this regulation is to set out the minimum qualifications an entity shall have to be qualified to conduct external reviews in Kansas.

**K.A.R. 40-4-42f. External review reporting requirements.** The purpose of this regulation is to set out the reports and records that the external review organizations, which are assigned to conduct external reviews, shall maintain.

**K.A.R. 40-4-42g. Exhaustion of internal review process.** The purpose of this regulation is to describe and define what circumstances constitute exhaustion of the internal review process. Exhaustion of the internal review process is required before the external review can be conducted.

The Kansas Insurance Department can implement the external review program by using current staff as far as budget concerns for fiscal year 2000. This program will be re-evaluated for budget and staff needs as the program is implemented. There will be an economic impact on the companies in drafting adverse decisions, providing information to the external review organization that justifies or defends their decision. The economic impact is based on the number of adverse decisions issued by the company where external review is requested.

These proposed regulations were not mandated by federal law. The external review requirements and procedures require the force and effect of law to be effective.

RegulationsArticle 5.—REGISTERED MARRIAGE AND  
FAMILY THERAPISTS

**102-5-7a. Professional postgraduate supervised experience requirement.** (a) The administrative supervisor of a person attaining the 4,000 hours of professional experience required for licensure as a marriage and family therapist shall satisfy either of these requirements.

(1) If available at the supervisee's place of employment, the administrative supervisor shall be the individual who has management authority and responsibility for the supervisee's general administrative functioning in the practice of marriage and family therapy.

(2) If not available at the supervisee's place of employment, the administrative supervisor shall meet either of these requirements:

(A) Be a marriage and family therapist who has been registered or is licensed in Kansas or another jurisdiction and who, beginning July 1, 2003, has practiced as a marriage and family therapist for two years beyond the supervisor's registration or licensure date; or

(B) if a registered or licensed marriage and family therapist is not available, be a person who is otherwise legally authorized at the graduate level to practice marriage and family therapy, or another mental health profession and, beginning July 1, 2003, has not less than two years of postgraduate professional experience.

(b) The clinical supervisor of a person attaining the 4,000 hours of professional experience required for licensure as a marriage and family therapist shall satisfy the requirements in paragraphs (b)(1) and (b)(2).

(1) At the time of providing supervision, the clinical supervisor had met one of the following qualifying provisions.

(A) The clinical supervisor shall be a marriage and family therapist who has been registered or is licensed in Kansas or another jurisdiction and, beginning July 1, 2003, has practiced as a marriage and family therapist for two years beyond the supervisor's registration or licensure date.

(B) If a registered or licensed marriage and family therapist is not available, the clinical supervisor shall be a person who is qualified by educational coursework and degree for licensure as a marriage and family therapist in Kansas and who, beginning July 1, 2003, has not less than five years of postgraduate professional experience.

(C) Before July 1, 2003, if a registered or licensed marriage and family therapist is not available, the clinical supervisor may be a person who has been registered or is licensed at the graduate level to practice in one of behavioral sciences, and whose authorized scope of practice permits the practice of counseling, therapy, or psychotherapy. The qualifying individual shall not have had less than two years of postgraduate professional experience at the time the individual provided the clinical supervision.

(2) The clinical supervisor shall have professional authority over and responsibility for the supervisee's clinical functioning in the practice of marriage and family therapy.

(c) The administrative supervisor may be the same person as the clinical supervisor.

(d) To further qualify as an administrative or a clinical supervisor, an individual shall meet these requirements:

(1) Not have a dual relationship with the supervisee;

(2) not be under any sanction from a disciplinary proceeding, unless the board waives this prohibition for good cause shown by the proposed supervisor;

(3) have knowledge of and experience with the supervisee's client population;

(4) have knowledge of and experience with the methods of practice that the supervisee employs;

(5) have an understanding of the organization and the administrative policies and procedures of the practice setting; and

(6) if available, be a member of the practice setting staff.

(e) When a qualified administrative or clinical supervisor is not available for staff in the practice setting, the supervisee may secure an otherwise qualified administrative or clinical supervisor outside the practice setting if all of the following conditions are met.

(1) The supervisor has a solid understanding of the practice setting's mission, policies, and procedures.

(2) The extent of the supervisor's responsibility for the supervisee is clearly defined in terms of client cases to be supervised for a clinical supervisor or organizational concerns for an administrative supervisor, role in personnel evaluation within the practice setting, and other aspects of the training plan.

(3) The responsibility for payment for supervision is clearly defined.

(4) If the supervisee pays the supervisor directly for the supervision, the supervisor maintains responsibility to the client and to the practice setting.

(f) A marriage and family therapy administrative supervisor shall meet in person with the supervisee, for purposes of administrative supervision, and shall provide at least one hour of supervision for every 40 hours of general professional functioning. These meetings may include persons other than the marriage and family therapy supervisee or supervisees.

(g) A marriage and family therapy clinical supervisor shall meet in person with the supervisee for purposes of clinical supervision and shall provide at least one hour of supervision for every 40 hours of general professional functioning, which includes any direct, face-to-face client contact.

(h) When meeting in person for administrative or clinical supervision is not practical due to an emergency, geographic distance, or other exigent circumstances, the supervisor may meet with the supervisee by interactive video or other telephonic means of communication, but in no event shall an administrative supervisor or clinical supervisor meet fewer than two times per month in person with a supervisee.

(i) A marriage and family therapy administrative or clinical supervisor shall perform the following:



(1) Provide oversight, guidance, and direction of the supervisee's administrative or clinical practice of marriage and family therapy by assessing and evaluating the supervisee's performance;

(2) conduct supervision as a process distinct from personal therapy, didactic instruction, or marriage and family therapy consultation;

(3) provide documentation of supervisory qualifications to the supervisee;

(4) periodically evaluate the supervisee's role;

(5) provide supervision in accordance with the written training plan;

(6) maintain documentation of supervision in accordance with the written training plan;

(7) provide documentation required by the board when a supervisee completes the supervision. The supervisor shall submit this documentation on board-approved forms and in a manner that will enable the board to evaluate the extent and quality of the supervisee's professional experience and assign credit for that experience;

(8) provide a level of supervision that is commensurate with the education, training, experience, and ability of both the supervisor and the supervisee; and

(9) ensure that each client knows that the supervisee is practicing marriage and family therapy under supervision.

(j) The supervisor and supervisee shall develop and co-sign a written training plan at the beginning of the supervisory relationship. This agreement shall clearly define and delineate the following items:

(1) The supervisory context;

(2) a summary of the anticipated types of clients and the services to be provided;

(3) a plan that describes the supervision goals and objectives, the means to attain and evaluate progress toward the goals, and the manner in which the goals relate to the overall objective of supervision;

(4) the format and schedule of supervision;

(5) the supervisor's responsibilities;

(6) the supervisee's responsibilities;

(7) a plan for documenting the following:

(A) The date of each supervisory meeting;

(B) the length of each supervisory meeting;

(C) the content of each supervisory meeting;

(D) a designation of each supervisory meeting as an individual or group meeting;

(E) a designation of each supervisory meeting as conducted in person or otherwise; and

(F) the supervisee's progress toward the established goals and objectives;

(8) a plan to notify clients of the following:

(A) The fact that the supervisee is practicing marriage and family therapy under supervision;

(B) the limits of client confidentiality within the supervisory process; and

(C) the name, address, and telephone number of the supervisor;

(9) a plan to address and remedy circumstances in which there is a conflict between the supervisor and the supervisee;

(10) the date that the training plan was entered, the time frame that it is intended to encompass, and the pro-

cess that either party shall follow to terminate the supervisory relationship;

(11) a plan to amend or renegotiate the terms of the training plan, if warranted;

(12) the supervisee's informed consent for the supervisor to discuss supervision or performance issues with the supervisee's clients, the supervisee's other marriage and family therapy or employment supervisors, the board, or any other individual or entity to which either the supervisee or the supervisor is professionally accountable;

(13) a statement signed by each supervisor and supervisee that acknowledges that each person has read and agrees to the postgraduate supervised experience requirements set forth in this regulation; and

(14) if there is compensation for supervisory services, a statement that specifies the party responsible for payment, the terms of payment, and the mutual obligations and rights of each party.

(k) An applicant with a doctor's degree in marriage and family therapy or a related field as defined in K.A.R. 102-5-1(o) may submit a written request to the board for a waiver of up to a maximum of one-half of the professional postgraduate supervised experience requirements. In order to qualify for this waiver, the applicant shall meet these requirements:

(1) Complete the educational requirements provided in K.A.R. 102-5-3; and

(2) complete no fewer than 100 hours of qualifying supervision that is acceptable to the board and that includes the following required components:

(A) A minimum of 50 hours of administrative supervision regarding general professional function; and

(B) a minimum of 50 hours of clinical supervision regarding delivery of direct client contact services with no more than 25 hours conducted as group supervision, no fewer than 25 hours conducted as individual supervision, and no fewer than four hours of clinical supervision contact monthly.

(l) "Place of employment" means a public or private practice setting, which may include self-employment. (Authorized by K.S.A. 1997 Supp. 74-7507; implementing K.S.A. 1997 Supp. 65-6404 and 65-6405; effective April 17, 1998; amended Oct. 22, 1999.)

## Kansas Lottery

### Temporary Administrative Regulations

#### Article 3.—INSTANT GENERIC GAME RULES

##### 111-3-12. Determination of instant prize winners.

The following subparagraphs specify how an instant prize winner is determined for instant games:

(a) The player must remove or "scratch off" the removable layer of material covering the play area to reveal

(continued)

the play symbols and captions. If the play symbols meet the requirements of the rules of the game, the player wins the prize designated by the rules of the game.

(b) In any event, only the highest instant prize shall be paid on a given ticket unless it is a multiple game ticket.

(c) Once a player has collected a prize from a retailer, the player shall not be entitled to any other prize from the lottery whether or not the prize paid by the retailer was less than the prize to which the player was entitled.

(d) Only play symbols and validation numbers are used for determination of entitlement to instant prizes. Play symbol captions, agent validation codes, book-ticket numbers, any portion of the display printing and any extraneous materials are not play symbols or validation numbers, and shall not be usable or playable to win instant prizes.

(e) In all events, the determination of instant prize winners shall be subject to the general ticket validation requirements set forth in K.A.R. 111-3-13 and the requirements set forth on the back of each instant game ticket.

(f) An instant ticket is a bearer instrument. The prize payable for an instant ticket shall be paid to the bearer or holder thereof unless the ticket has been signed on the back. Once a ticket has been signed on the back, any prize payable for such ticket shall be paid to the apparent owner of the ticket as evidenced by such signature. The holder of a winning ticket shall sign his or her name on the back of the ticket.

(g) No particular prize may be paid more than once.

(h) All instant prizes must be claimed within 180 days following the termination of the game announced by the executive director, or in drawings involving non-winning instant tickets entered in a drawing, within 180 days of the drawing in which the prize was won. To claim a prize, the holder of the winning ticket must present or mail the winning ticket and claim form to the Kansas lottery, and the lottery must receive it within the above time period. Any instant prize not claimed by such date and in the manner specified on the back of each ticket shall be forfeited.

(i) The right of any person to a prize shall not be assignable, except that payment of any prize may be paid to the estate of a deceased prize winner or to a person designated pursuant to an appropriate judicial order. **111-4-607.** Name of drawings. The Kansas lottery shall conduct a series of drawings, entitled the "Heartland Park Parts America Drawings." The "Heartland Park Parts America Drawings" shall take place on Sunday, October 3, 1999, at Heartland Park, 7530 Southwest

Topeka Boulevard, Topeka, Kansas 66619. Rules applicable are contained in K.A.R. 111-3-1 *et seq.* and 111-4-607 through 111-4-615. (Authorized by and implementing K.S.A. 1998 Supp. 74-8710; effective, T-111-8-26-94, Aug. 19, 1994; amended, T-111-10-12-95, Aug. 18, 1995; amended, T-111-8-25-97, Aug. 15, 1997; amended, T-111-9-21-98, Aug. 21, 1998; amended, T-111-10-30-98, Oct. 16, 1998; amended, T-111-9-14-99, Aug. 20, 1999.)

**111-4-610.** Entry into drawings. Entry into the "Heartland Park Parts America Drawings" is accomplished by the process detailed in the following subparagraphs:

(a) Obtain a valid Kansas instant lottery ticket from the lottery's selling location at Heartland Park Topeka;

(b) Determine if the ticket is a winning ticket in accordance with any instant game rules. If the ticket is a winning ticket, it is not eligible for the "Heartland Park Parts America Drawings," and shall be redeemed in accordance with the instant game rules;

(c) If the ticket is a valid non-winning ticket purchased at the Heartland Park selling location, the ticket is eligible for winning a drawing and the holder of the ticket may enter the "Heartland Park Parts America Drawings."

(d) The holder of the non-winning ticket must complete the information form on the back of the ticket in a legible manner and sign it.

(e) The holder of the ticket need not be present to win at the time of the "Heartland Park Parts America Drawings."

(f) There is no limit to the number of entries a participant may make.

(g) For the racing events occurring on September 30, October 1, 2 and 3, 1999, the receptacle(s) or drum(s) shall be open during lottery selling hours. Should the racing events be postponed for any reason, prizes for events which were postponed will be the maximum amounts specified in K.A.R. 111-4-609.

(h) The holder of a non-winning ticket must take each non-winning ticket with the information form on the back completed, to the location of the receptacle(s) or drum(s) at the "Heartland Park Parts America Drawings" and place it in the receptacle(s) or drum(s) provided by the lottery.

(i) On Sunday, October 3, 1999, the Kansas lottery will sponsor its "Heartland Park Parts America Drawings." Players enter the drawings by placing non-winning tickets purchased at Heartland Park Topeka into the receptacle(s) or drum(s) located near the lottery's selling location in the pit area next to the souvenir shop. Twelve tickets will be drawn from the contents of the receptacle(s) or drum(s). Following validation by lottery security personnel, the winners' names shall be announced.

(j) Drawings shall be held by the lottery selling location on the east side of the track in the pit area next to the souvenir shop.

(a) "Play symbols" are the numbers, letters, symbols, or pictures printed in the play area of each instant game ticket and which determine if the ticket bearer is entitled to a prize. In this instant game, the play symbols are printed in black ink with matching captions. A play symbol appears in each of seven play spots within the play area. Each play symbol for this instant game is one of the following: FREE - \$2<sup>00</sup> - \$4<sup>00</sup> - \$10<sup>00</sup> - \$20<sup>00</sup> - \$40<sup>00</sup> - \$500 - symbol of a penny - symbol of a nickel - symbol of a dime - symbol of a quarter - symbol of half a dollar.

(b) "Play symbol captions" are the words or portions of words, letters or numbers printed beneath each play symbol in the play area and are used to repeat or explain the play symbol. The play symbol caption associated with each play symbol is as follows:

The book-ticket number is printed in black ink on the back of each instant game ticket both above the information form and below the bar code.

(e) "Retailer validation code" means the small letters found under removable covering in the play area of each instant game ticket. The retailer uses this code to verify and validate winners which are to be paid by the retailer. In this instant game, the retailer validation code is a three-letter code printed and appearing in three of six varying locations among the play symbols. The codes and their meanings are as follows: FRE = Free Ticket; TWO = \$2.00; FOR = \$4.00; TEN = \$10.00; TWY = \$20.00; FRY = \$40.00; FHN = \$500.00.

(f) "Bar code" means the 16-digit bar-coded number appearing on the back of each ticket. (Authorized by and implementing K.S.A. 1998 Supp. 74-8710; effective, T-111-9-14-99, Aug. 20, 1999.)

**111-4-1532. Determination of instant prize winners.** An instant prize winner is determined for this instant game when the player removes or "scratches off" the removable layer of material covering the play area to reveal the seven play symbols and captions. This is an add up game. If the coins add to over \$1.00, the player wins the prize in the prize box. No ticket is eligible to win more than one prize. (Authorized by K.S.A. 1998 Supp. 74-8710(b), (c) and (i); implementing K.S.A. 1998 Supp. 74-8710(b), (c) and (i), and K.S.A. 74-8720(b) and (d); effective, T-111-9-14-99, Aug. 20, 1999.)

**Article 6.—ON-LINE GENERIC GAME RULES**

**111-6-5. Payment of prizes.** (a) Following the drawing for which an on-line ticket was purchased, and prior to the payment of any prize, the claimant shall present the winning on-line ticket to any on-line retailer, or any Kansas lottery office for validation.

(b) The procedure for payment of a single game prize of \$599, or less, except for a jackpot prize, is as follows:

(1) The holder of the ticket may present it to any on-line retailer. If the on-line retailer cannot validate the claim, or if the amount of the claim exceeds \$599, the claimant may obtain and complete a claim form and submit it with the ticket to the lottery by mail or in person. Upon validation of the ticket, the retailer shall immediately pay the holder of the ticket.

(2) Prizes payable by on-line retailers shall be paid during all normal business hours of the retailer, provided the on-line system is operational and claims can be validated.

(3) An on-line retailer may pay prizes in cash or by business check, certified check, or money order, or any combination thereof. An on-line retailer who pays a prize with a check which is dishonored may be subject to suspension or termination of its contract.

(4) A winning on-line ticket offering a free ticket or tickets may be claimed at any on-line retailer location or at any Kansas lottery office. If a winning on-line ticket offers the player 15 or more free tickets, the prize must be claimed at lottery headquarters. A player claiming a free ticket prize at the lottery may be issued either a free ticket or a \$1.00 prize payment at the discretion of the executive director.

(c) To claim an on-line prize of more than \$599, the claimant shall obtain and complete a claim form and submit it with the winning ticket to the lottery's headquarters in Topeka by mail or in person. Prizes greater than \$599 can only be paid from the lottery's headquarters in Topeka. Upon determination that the ticket is a winning ticket, the lottery shall process for payment the amount due, less any withholding required by state and federal laws. The amount due shall be calculated according to the rules adopted for the particular on-line game. If the ticket is determined to be a non-winning ticket, the claim shall be denied and the claimant shall be promptly notified.

(d) If the claim is presented to a lottery regional office or to lottery headquarters, the claimant may complete a claim form regardless of the prize amount and submit it with the winning ticket, either by mail or in person. Upon determination that the ticket is a winning ticket, the lottery shall present or mail a check to the claimant in payment of the amount due, less any withholding required by state and federal laws.

(e) All on-line prizes must be claimed within 365 days including the first day of the game or the drawing in which the prize was won. In the event the final day of the 365 day period falls on a day lottery headquarters is not open for business between 8:00 a.m. and 5:00 p.m. or a federal holiday, the claim period will be extended to 5:00 p.m. on the next business day. To claim a prize, the holder of the winning ticket must present or mail the winning ticket and claim form to the Kansas lottery, and the lottery must receive it within the above time period. Any on-line prizes not claimed within the specified period shall be added to the prize pools of subsequent Kansas lottery games.

(f) If the ticket is determined to be a non-winning ticket, the claim shall be denied and the claimant shall be promptly notified. Non-winning tickets will not be returned to the claimant.

(g) A validated ticket shall be the only proof of a game play or plays, and the submission of a winning ticket to and receipt of the ticket by the lottery or its authorized retailer shall be the sole method of claiming a prize.

(h) Claims in excess of \$599 shall not be paid by lottery retailers. The lottery has no obligation to reimburse retailers paying claims in excess of \$599. (b) The maximum prize awarded per game per ticket shall be \$100,000 regardless of the amount wagered per game, except as provided by the bull's-eye option as specified in K.A.R. 111-7-80a.

(c) A player is eligible to receive only the highest prize per game played on a ticket, except as increased by the progressive jackpot bonus and the bull's-eye option.

(d) The progressive jackpot bonus applies only to a player choosing either the 6 spot or 7 spot game with starting 6 spot prizes for matching six of six numbers selected being \$50 higher than the Keno prize of \$1,000, and starting 7 spot prizes for matching seven of seven numbers selected being \$100 higher than the Keno prize of \$2,000. The progressive jackpot bonus shall be funded as follows:

(1) A total of .70 percent of Keno sales from the previous Keno game shall be applied to the bonus jackpot for the 6 spot game for each drawing after the starting progressive jackpot until the jackpot is won. The first drawing after a jackpot is won starts with a minimum progressive jackpot bonus minimum of \$50.

(2) A total of .35 percent of Keno sales from the previous Keno games shall be applied to the bonus jackpot for the 7 spot game for each drawing after the starting progressive jackpot until the jackpot is won. The first drawing after a jackpot is won starts with a minimum progressive jackpot bonus minimum of \$100.

(3) If the progressive jackpot bonus is not won, it will continue to grow as stated in subsection (d)(1) and (d)(2) above.

(4) The prize money allocated to the progressive jackpot prize bonus shall be distributed on a parimutuel basis by dividing the bonus prize equally by the number of dollars wagered for each winning combination of numbers for the same game.

(5) All progressive jackpot bonus prizes shall be paid in whole dollar amounts which will be rounded down for payment, except that no progressive jackpot bonus prize paid shall be less than \$1. (Authorized by and implementing 1998 Supp. K.S.A. 74-8710; effective, T-111-9-1-92, Aug. 28, 1992; amended, T-7-19-99, June 17, 1999; amended, T-111-9-14-99, Aug. 20, 1999.)
