Notice to Private Activity Bond Applicants

Applications for allocation of 2000 Private Activity Bond (PAB) authority are now being accepted for qualified uses, as defined by the Internal Revenue Code of 1986, and amendments thereto.

The State of Kansas currently receives \$150 million of federal authority for the issuance of PABs on an annual basis. Historically, the primary uses of this federal authority have included "qualified small issue bonds" used for construction and equipping of manufacturing facilities and beginning farmer programs; "exempt facility bonds" used by for-profit entities providing a public benefit, i.e., certain waste treatment facilities, qualified residential rental facilities, etc.; and "qualified mortgage bonds" issued to benefit first-time homebuyers. Allocations awarded by the Secretary of Commerce and Housing are subject to the provisions of K.S.A. 74-5060 *et seq.* and the limitations of the state volume cap.

Fees associated with PAB application and issuance are as follows:

(1) **Application fee**—A nonrefundable fee must accompany the application before the request can be processed. The application fee is determined as follows:

- \$250 for allocation requests up to \$5,000,000
- \$500 for allocation requests from \$5,000,001 to \$10,000,000
- \$1,000 for allocation requests \$10,000,001 and above

(2) **Issuance Fee**—An issuance fee for allocation amounts utilized, other than "Qualified Mortgage Bonds" issued, shall be due and payable to the Kansas Department of Commerce and Housing at bond closing. Issuance fees shall be determined as follows:

Allocation Used	Fee
• To \$2,000,000	5 basis points (.05%)
• \$2,000,001 and above	10 basis points (.10%)

** "Qualified Mortgage Bond" programs will be assessed a fee equal to .5% of equal mortgage loan amount upon issuance of each mortgage loan assisted through the program.

Issuance fees shall be remitted within 30 days of bond closing.

Checks for both the application and issuance fees should be payable to the Kansas Department of Commerce and Housing Bond Fee Fund.

The PAB application has been updated for the 2000 application year and a new attachment has been added to the materials. The Department of Commerce and Housing asks that all applicants utilize the 2000 documents.

Notice of Hearing on Proposed
Administrative Regulations

A public hearing will be conducted at 3:30 p.m. Tuesday, March 21, at 216 E. 1st, Wichita, to consider the adoption of proposed changes in existing rules and regulations of the Kansas Board of Hearing Aid Examiners.

This 60-day notice of public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the Board of Hearing Aid Examiners, P.O. Box 252, Wichita, KS 67201. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic im-

pact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Lee Payne at (316) 263-0774.

These regulations are proposed for adoption on a permanent basis. A summary of proposed regulations and their economic impact follows.

K.A.R. 67-2-4. Examinations. Changes to this regulation allow the board to set a reasonable cut-off date for applications for examination. Applications received after the date specified will be processed in a normal manner, and applicants may be placed on the exam roster, if time allows.

K.A.R. 67-3-2. Responsibilities and termination of responsibilities. The amendment to the regulation provides that the sponsor of an applicant will be responsible for ensuring that the applicant meets all requirements that are set forth in statute or regulation.

K.A.R. 67-4-7. Educational requirements; duties of executive officer; national organizations; acceptance. The amendments in this regulation change language to conform with policies that have been practiced regarding documentation of continuing educational credits. Changes also broaden the allowable sponsors for continuing educational credits to be more representative of current educational offerings.

K.A.R. 67-4-10. Same; local organizations; notice of credit hours. The amendment in this regulation allows for pre- or post-course approval of continuing educational units as opposed to the previously required 60-day pre-approval. Changes also allow the board 60 days to approve or deny the request as opposed to the previous 30-day requirement.

K.A.R. 67-4-13. Same; temporary applicants. This regulation requires that an applicant for temporary license present documentation that educational training covering basic areas set forth by the board has been met. Requirements shall not exceed 200 clock hours.

K.A.R. 67-6-4. Office conditions; license identification. Changes to this regulation update wording referring to the professional and hygienic condition of an office and change identification card information to note expiration date in lieu of applicant's office address.

K.A.R. 67-7-4. Calibration of audiometric equipment. The changes update language, and reflect current date and grandfathering information. Language is changed to allow violation of the regulation to be treated as unethical conduct.

There is no economic impact for any of the amended regulations to state agencies, employees or the general public. Other governmental units, private citizens and consumers will not be affected by this change.

Sealed bids for 127th Street (Quivira to Switzer) will be received by the City of Overland Park, Kansas, at the office of the city clerk, City Hall, 8500 Santa Fe Drive, Overland Park, until 2 p.m. local time Tuesday, February 8. At that time all sealed bids will be transferred to the City Council Chamber, City Hall, where they will be publicly opened and read aloud. Any bid received after the designated closing time will be returned unopened. All bids shall be submitted in sealed envelopes addressed to the city clerk of Overland Park, Kansas, and marked "Bid for: 127th Street (Quivira to Switzer)."

Copies of plans, specifications, bid documents and other contract documents are on file at the office of HNTB Corporation, 7450 W. 130th St., Suite 400, Overland Park, 66213. Contractors desiring the contract documents for use in preparing bids may obtain a set of such documents from HNTB Corporation, (913) 491-9333, upon payment of \$150, which amount is not refundable.

Contractors should read and be fully familiar with all contract documents before submitting a bid. In submitting a bid, the bidder warrants that it has read the contract documents and is fully familiar therewith, that it has visited the site of the work to fully inform itself as to all existing conditions and limitations, and shall include in its bid a sum to cover the cost of all items of the work.

Should a bidder find "defects" as defined in paragraph GC-2 of the General Conditions, it shall follow the procedures outlined in paragraph GC-3 to bring the same to the attention of the city. Changes necessitated thereby shall be in the form of addenda issued by the consulting engineer. All bidders shall verify that they have considered all written addenda. Neither the city nor the consulting engineer shall be responsible for oral instructions. Any written addenda issued during the time of bidding shall be covered and included in the bid. There will be

no clarifications or exceptions allowed on the bid. Bids are for a total bid package, total contract price.

Bids shall be made upon the form provided, in ink or typewritten. Numbers shall be stated both in writing and in figures; the signature shall be long hand; and the complete form shall be without alteration or erasure. On alternate items for which a bid is not submitted, a written indication of "no bid" on the bid form is required.

No oral, telegraphic, facsimile or telephonic bids or alterations will be considered. The following items must be included in the sealed envelope with the bid:

- a. Bid
- b. 5% Bid Security—Bid Bond, Cashier's Check or Certified Check (see below)
- c. Signed Documents (KDOT Certifications)
 - Certification—Noncollusion and History of Debarment
 - Certification—Federal Funds for Lobbying
 - Required Contract Provisions—Certification—Contractual Services with Current Legislator or Legislator's Firm
 - Required Contract Provision—DBE Contract Goals

Each bidder shall file with its bid a bid bond, a cashier's check or a certified check drawn on any acceptable bank, made payable to the City of Overland Park, Kansas, in an amount of not less than 5 percent of the total bid, which shall be retained by the City of Overland Park until a contract for the project has been executed. Bid bonds will be returned to the unsuccessful bidders, with the exception of the second qualifying bidder, at such time as their bids are rejected. The bid deposit of the successful bidder and the second qualifying bidder will be returned when satisfactory bonds in an amount equal to 100 percent of the contract amount, required insurance certificates and other required documents shall have been furnished and the contract documents have been executed.

In the event the successful bidder is unable to execute the contract, for whatever reason, the city may exercise its legal prerogatives, including, but not limited to, enforcement of its rights as to the bid security.

The city reserves the right to accept or reject any and all bids and to waive any technicalities or irregularities therein. Bids may be modified or withdrawn by written request of the bidder received in the office of the city clerk, prior to the time and date for bid opening, provided, however, that no bidder may withdraw its bid for a period of 30 days from the date set for the opening thereof. All bidders agree that rejection shall create no liability on the part of the city because of such rejection, and the filing of any bid in response to this invitation shall constitute an agreement of the bidder to these conditions.

In the Personal Responsibility and Work Opportunity Reconciliation Act of 1996 (PRWORA), Congress established work participation rates that states must meet for adults receiving Temporary Assistance for Needy Families (TANF). Separate work participation rates were established for two-parent families and for all families.

PRWORA allows states to reduce their work participation rate targets if their TANF caseloads have declined for reasons other than requirements of federal law or a change in eligibility rules from those in effect in FY 1995. This reduction is known as the caseload reduction credit.

To claim a caseload reduction credit, a state must submit a Caseload Reduction Report to the U.S. Department of Health and Human Services each year that includes:

- A listing of, and implementation dates for, all state and federal eligibility changes made by the state since the beginning of FY 1995.
- A numerical estimate of the positive or negative impact on the TANF caseload of each eligibility change (based, as appropriate, on application denials, case closures and other analyses). (Application denials and case closures resulting from full family sanctions do not count toward the caseload reduction credit per federal regulations.)
- An overall estimate of the total net positive or negative impact on the caseload as a result of all such eligibility changes.
- An estimate of the state's caseload reduction credit.
- The number of application denials and case closures for FY 1995 and the prior fiscal year.
- The distribution of such denials and closures, by reason, for fiscal year 1995 and the prior fiscal year.
- A description of the methodology and the supporting data that was used to calculate the caseload reduction estimates.
- A certification that the state has provided the public an appropriate opportunity to comment on the estimates and methodology, considered their comments, and incorporated all net reductions resulting from federal and state eligibility changes.
- A summary of all public comments.

(g) At the end of the promotion, the Triplett store with the greatest percentage increase in total sales for the period from February 1, 2000, to February 28, 2000, over the period from February 1, 1999, to February 28, 1999, will win a credit for a pack of instant tickets valued at \$285.00 and promotional items. All other Triplett stores showing an increase from February 1, 2000, to February 28, 2000, over the base period will receive promotional items provided by the lottery. (Authorized by K.S.A. 1998 Supp. 74-8710; implementing K.S.A. 1998 Supp. 74-8710 and K.S.A. 74-8708; effective, T-111-12-27-99, Dec. 17, 1999.)

Article 3.—INSTANT GENERIC GAME RULES

111-3-12. Determination of instant prize winners. The following subparagraphs specify how an instant prize winner is determined for instant games except where otherwise specified by individual game rules:

(a) The player must remove or "scratch off" the removable layer of material covering the play area to reveal the play symbols and captions. If the play symbols meet the

requirements of the rules of the game, the player wins the prize designated by the rules of the game.

(b) In any event, only the highest instant prize shall be paid on a given ticket unless it is a multiple game ticket.

(c) Once a player has collected a prize from a retailer, the player shall not be entitled to any other prize from the lottery whether or not the prize paid by the retailer was less than the prize to which the player was entitled.

(d) Only play symbols and validation numbers are used for determination of entitlement to instant prizes. Play symbol captions, agent validation codes, book-ticket numbers, any portion of the display printing and any extraneous materials are not play symbols or validation numbers, and shall not be usable or playable to win instant prizes.

(e) In all events, the determination of instant prize winners shall be subject to the general ticket validation requirements set forth in K.A.R. 111-3-13 and the requirements set forth on the back of each instant game ticket.

(f) An instant ticket is a bearer instrument. The prize payable for an instant ticket shall be paid to the bearer or holder thereof unless the ticket has been signed on the back. Once a ticket has been signed on the back, any prize payable for such ticket shall be paid to the apparent owner of the ticket as evidenced by such signature. The holder of a winning ticket shall sign his or her name on the back of the ticket.

(g) No particular prize may be paid more than once.

(h) All instant prizes must be claimed within 180 days following the termination of the game announced by the executive director, or in drawings involving non-winning instant tickets entered in a drawing, within 180 days of the drawing in which the prize was won. To claim a prize, the holder of the winning ticket must present or mail the winning ticket and claim form as set forth in K.A.R. 111-3-14, and the retailer or the lottery must receive it within the above time period. Any instant prize not claimed by such date and in the manner specified on the back of each ticket shall be forfeited.

(i) The right of any person to a prize shall not be assignable, except that payment of any prize may be paid to the estate of a deceased prize winner or to a person designated pursuant to an appropriate judicial order. 111-3-20. Method of entry. Entry into lottery drawings is accomplished by the following steps except where otherwise specified by individual game rules:

(a) Obtain a valid Kansas instant game lottery ticket;

(b) Determine if the ticket is a winning ticket in accordance with any instant game rules. If the ticket is a winning ticket, it is not eligible for the drawings and shall be redeemed in accordance with the appropriate game rules;

(c) If the ticket is a non-winning ticket, it is eligible for winning the drawing, and the holder of the ticket may enter

the drawing by placing it in the receptacle or drum provided by the lottery;

(d) The holder of a non-winning ticket must complete the information form on the back of the ticket in a legible manner;

(e) There is no limit on the number of entries a person may make, but a person may only win one time.

(f) All entrants in a Kansas lottery drawing must be at least 18 years of age to constitute a valid entry or win a prize. Article 4.—INSTANT GAME RULES

111-4-1594. Determination of instant prize winners. An instant prize winner is determined for this instant game when the player removes or "scratches off" the removable layer of material covering the four separate play areas entitled "GAME 1," "GAME 2," "GAME 3" and "GAME 4" to reveal the game symbols and captions in each play area.

(2) Determine if the ticket is a winning ticket in accordance with "Wheel of Fortune" instant game rules. If the ticket is a winning ticket, it is not eligible for the "Wheel of Fortune Drawing" and shall be redeemed in accordance with the instant game rules;

(3) If the ticket is a valid non-winning ticket, the ticket is eligible for the drawing and the holder of the ticket may enter the "Wheel of Fortune Drawing."

111-4-1643. Cost of ticket. The price of "Bonus Crossword" instant tickets sold by a retailer shall be \$2.00 each. (Authorized by and implementing K.S.A. 1998 Supp. 74-8710; effective, T-111-12-27-99, Dec. 17, 1999.)

111-4-1644. Determination of instant prize winners. "Bonus Crossword" consists of three play areas. In the upper part of the ticket there is a crossword puzzle grid that contains 11 spaces (height) by 11 spaces (width) covered by transparent latex. In the "YOUR LETTERS" play area, located in the lower part of the ticket, there are 18 letters located under latex. Imaged around each of the 18 "YOUR LETTERS" there will be a four-sided box composed of solid lines. To the right of the "YOUR LETTERS" play area is the "BONUS" play area. (a) "Play symbols" are the numbers, letters, symbols, or pictures printed in the play area of each instant game ticket and which determine if the ticket bearer is entitled to a prize. In this instant game, the play symbols are printed in black ink with matching captions. A play symbol appears in each of the 11 play spots within the play area. (c) "Ticket validation number" means a unique number appearing on each ticket which is used to validate winning
