Notice of Hearing on Proposed  
Administrative Regulations

A public hearing will be conducted at 9 a.m. Wednesday, April 19, in the third floor conference room, Kansas Insurance Department, 420 S.W. 9th, Topeka, to consider the proposed revocation of an existing rule and regulation.

This 60-day notice of the public hearing shall constitute a public comment period for purpose of receiving written public comments on the proposed regulation. All interested parties may submit written comments prior to the hearing to Rebecca Sanders, Kansas Insurance Department, 420 S.W. 9th, Topeka, 66612-1678. All interested parties will be given a reasonable opportunity to present their views orally on the proposed revocation of the regulation during the hearing.

Copies of the full text of the regulation and the economic impact statement may be obtained by contacting Rebecca Sanders at the address above, (785) 296-7811. A summary of the proposed regulation and its economic impact follows.

**K.A.R. 40-3-27. Modification of rate filing requirements for individual risks; disapproval.** This regulation is being revoked because the 1999 Legislature amended K.S.A. 40-955, which exempted certain categories of commercial lines that are considered special risks from the rate filing requirements. This regulation set out the effective date of the disapproval of these rates and how the premiums should be adjusted when the rates are disapproved. Since the rates no longer are required to be filed, these guidelines are no longer necessary.

The revocation of this regulation will have a positive economic impact on the companies and the Insurance Department because the filing requirements have been removed, and also will eliminate the paperwork associated with rate filings. The revocation of this regulation is not required by federal law.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulation and economic impact statement in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Rebecca Sanders.

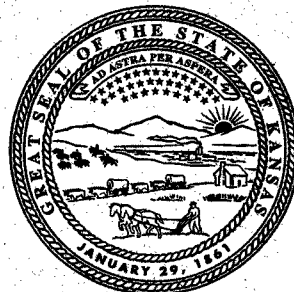

Grant funds are available from the State Crime Victims' Assistance Fund for fiscal year 2001. The purpose of the grant program is to provide services and assistance to victims of crime in order to speed their recovery from the financial loss, physical suffering and emotional trauma of victimization; and to assure proper and sensitive treatment of crime victims in the criminal justice process.

It is the intention of this grant program to provide as wide a range as possible of coverage to the citizens of the state. In distributing funds among urban and rural areas of the state, priority shall be given to those areas with the greatest need. Activities or services that can be funded include, but are not limited to: 24-hour crisis intervention, support or emergency services; counseling; assistance with compensation claims; community referrals; prosecutor/court-related services; shelter support; criminal justice advocacy, etc.

Available funds may be awarded to units of state or local government or private nonprofit organizations for defined program activities. Each applicant may receive up to \$25,000 in grant funds, but not more than 50 percent of the total applicant agency's budget prior to grant award.

Grant funds are available from the State Crime Victims' Assistance Fund Child Abuse and Neglect Grant Program for fiscal year 2001. The purpose of this grant program is to provide funds for ongoing operating expenses of programs (including court-appointed special advocate programs) providing: 1) temporary emergency shelter for victims of child abuse and neglect; 2) counseling and assistance to those victims; or 3) educational services directed at reducing the incidence of child abuse and neglect and diminishing its impact on the victim.

Available funds may be awarded to programs that meet the following requirements: are duly registered with the Kansas Secretary of State; meet the requirements of Section 501 (c) of the Internal Revenue Code of 1986; have trustees or board of directors who represent the racial, ethnic and socioeconomic diversity of the county or counties served; meet normally accepted standards for non-profit organizations; demonstrate ability to successfully administer programs; have obtained appropriate licensing or certification, or both; serve a significant number of residents of the county or counties served; and not unnecessarily duplicate services already adequately provided to county residents.

Each applicant must receive 50 percent or more of their funds from sources other than funds distributed through this fund; other sources may be public or private.

## Opinion 2000-1

**Schools—Organization, Powers and Finances of Boards of Education—Name and Style of Unified Districts; Deeds.** Joseph W. Zima, Legal Counsel, Unified School District No. 501, Topeka, January 20, 2000.

A deed for real estate owned by the school district should include the name of the school district in the form set forth in K.S.A. 72-8201. Cited herein: K.S.A. 19-1204; 19-1205; 58-2221; 72-8158; 72-8201. RDS

## Opinion 2000-2

**Wildlife, Parks and Recreation—Licenses, Permits, Stamps and Other Issues; Wildlife—Hunter Education; Certificate of Completion.** Senator Lana Oleen, 22nd District, Manhattan; Senator John Vratil, 11th District, Overland Park, January 31, 2000.

The plain and unambiguous meaning of the statutory requirement that an applicant for a hunting license "exhibit proof of completion of such to the person issuing the license at the time of purchasing the license" is that the applicant show or display proof of completion of an approved hunter education course. A regulation that allows proof to be made by an attestation, which is merely an act of witnessing a signature on a document, does not sufficiently comply with such statutory requirement. ## Opinion 2000-3

**State Departments; Public Officers and Employees—Kansas Tort Claims Act—Liability of Governmental Entities and Employees; Juvenile Corrections Advisory Boards and Employees of Juvenile Justice Administration.** Fred Lorentz, District Judge, 31st Judicial District, Chanute, February 3, 2000.

The 31st Judicial District Corrections Advisory Board is a governmental entity for purposes of the Kansas Tort Claims Act and, therefore, the Act applies to its members. Moreover, the Act also applies to those persons who are employed by a governmental entity to implement the plan for juvenile correctional services. ## Opinion 2000-4

**Cities and Municipalities—Public Recreation and Playgrounds—Recreation Systems; Establishment of System of Public Recreation; Joint Systems; Authority of Consolidated Unified School Districts.** Daniel D. Creitz, Counsel, Consolidated Unified School District No. 101, Erie, February 3, 2000.

A joint recreation system may not be established by a school district and more than one city. The electors of a city may compel the city to establish a recreation system, either independently or jointly with a school district. However, there is no mechanism through which a school district may force a city to participate in the establishment and operation of a recreation system. A school district

wishing to create a joint recreation system is not required to form such joint system with a city that already operates an independent recreation system. If a city that operates an independent recreation system chooses not to participate in the joint recreation system established by a school district, the city would have no right to representation on the recreation commission, would not be required to contribute facilities to the joint recreation system, and could continue to operate its own independent recreation system. The city, however, would be a part of the joint recreation commission taxing district, subject to the levy of a tax to provide funds for the operation of the joint recreation system. **Cities of the Third Class—Government by Mayor and Council and General Laws Applicable to Cities of the Third Class; Powers and Duties of Mayor—President of Council; Removal.** Frank H. Jenkins, Jr., Spring Hill City Attorney, Olathe, February 3, 2000.

No constitutional or statutory provision establishes a term of office for the president of a city council elected pursuant to K.S.A. 15-310. The person elected to such position, therefore, holds such position at the pleasure of the city council. Because there is no vested interest in serving as president of the council, the person serving as president is not entitled to a due process hearing prior to being removed as president. Cited herein: K.S.A. 15-204; 15-310; U.S. Const., Amend. XIV. RDS

## Opinion 2000-6

**Cities of the Third Class—Government by Mayor and Council and General Laws Applicable to Cities of the Third Class; Powers and Duties of Mayor—President of Council; Removal.** William E. Kennedy III, Riley County Attorney, Manhattan, February 3, 2000.

No constitutional or statutory provision establishes a term of office for the president of a city council elected pursuant to K.S.A. 15-310. The person elected to such position, therefore, holds such position at the pleasure of the city council. Because there is no vested interest in serving as president of the council, the person serving as president is not entitled to a due process hearing prior to being removed as president. ## Opinion 2000-7

**Public Health—Regulation of Dentists and Dental Hygienists—Definitions; Practice of Dentistry.** Senator John Vratil, 11th District, Overland Park, February 3, 2000.

Under the circumstances discussed herein, the sale of impression materials for teeth whitening does not consti-

tute the practice of dentistry as defined by K.S.A. 65-1422, nor does it violate K.S.A. 65-1438 because the legislative purpose is not served by a literal interpretation of these statutes. Cited herein: K.S.A. 65-1422; K.S.A. 1998 Supp. 65-1423; K.S.A. 65-1438. GE

Representative Douglas Johnston, 92nd District, Wichita; Karla Pierce, Secretary, Department of Revenue, Topeka, February 7, 2000.

The members of the Medical Advisory Board fall within the definition of "officers or employees" for purposes of K.S.A. 1998 Supp. 45-221(a)(4) of the Open Records Act. However, only names, positions, salaries and lengths of service of the members must be disclosed. Home addresses, telephone numbers, and recommendations and determinations of the board are not required to be disclosed. A public hearing will be conducted at 2:30 p.m. Wednesday, April 26, at the Capitol Plaza Hotel, Room 205, 1717 S.W. Topeka Blvd., Topeka, to consider the adoption of proposed changes in one existing rule and regulation of the Kansas Board of Examiners in Optometry.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rule and regulation. All parties may submit written comments prior to the hearing to the secretary-treasurer of the Kansas State Board of Examiners in Optometry, 3111 W. 6th, Suite A, Lawrence, 66049. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulation during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulation and economic impact statement in an accessible format. The amended regulation is proposed for adoption on a permanent basis. A summary of the regulation and its economic impact follows.

**K.A.R. 65-5-6. Continuing education.** This is an amendment to an existing regulation that changes the total number of hours from 20 to 24 that each licensed optometrist shall earn of documented and approved continuing education during each license renewal period.

The only economic impact will affect Kansas optometrists for the cost of the additional four hours of continuing education. No cost will be borne by the agency proposing the regulation, nor any other governmental agencies or units, nor any private citizens or consumers of the services that are the subject of this regulation. This is not an environmental regulation. The regulation is not mandated by federal law as a requirement for participating in or implementing a federally-subsidized or assisted program.

**Article 4.—MOTOR CARRIERS OF PERSONS  
AND PROPERTY**

**82-4-3. Motor carrier safety regulations.** (a) The following parts of the federal rules and regulations promulgated by the U.S. department of transportation, federal highway administration, and office of motor carriers are hereby adopted by reference. The adoption by reference shall cover the parts as in effect on October 1, 1998:

- (1) General: 49 C.F.R. Part 390, except for the following:
  - (A) 49 C.F.R. 390.3(b) and (f);
  - (B) the following terms as they appear in 49 C.F.R. 390.5: "motor vehicle," "person," and "private motor carrier of property"; "commercial motor vehicle," "motor carrier," and "driver"; and
  - (C) 49 C.F.R. 390.11;
- (2) qualifications of drivers: 49 C.F.R. Part 391, except 49 C.F.R. 391.11(b)(1), 391.67, and 391.69;
- (3) driving of motor vehicles: 49 C.F.R. Part 392;
- (4) parts and accessories necessary for safe operation: 49 C.F.R. Part 393, except 49 C.F.R. 393.81, 393.87, and 393.95(a);

(5) hours of service of drivers: 49 C.F.R. Part 395, except 49 C.F.R. 395.1(h)(i), and (k);

(6) hours of service of drivers engaged in transportation for agricultural operations: 49 C.F.R. 395.1(k), with the following provisions:

(A) "Agricultural commodities" means the unprocessed products of agriculture, horticulture, viticulture, and cultivation of the soil, including wheat, corn, hay, milo, sorghum, and soybeans. Agricultural commodities shall not include livestock and livestock products, milk, honey, poultry products, timber products, or nursery stock, nor shall the term include the transportation of hazardous materials of the type or quantity that requires the vehicle to be placarded;

(B) "farm supplies" means supplies or equipment for use in the planting or harvesting of agricultural commodities, but shall not include the transportation of hazardous materials of the type or quantity that requires the vehicle to be placarded; and

(C) "planting and harvesting season" means the time periods for planting and harvesting that occur between March 1 and November 30;

(7) inspection, repair, and maintenance: 49 C.F.R. Part 396;

(8) transportation of hazardous materials; driving and parking rules: 49 C.F.R. Part 397;

(9) transportation of migrant workers: 49 C.F.R. Part 398;

(10) employee safety and health standards: 49 C.F.R. Part 399;

(11) minimum levels of financial responsibility for motor carriers: 49 C.F.R. Part 387, except strictly intrastate nonhazardous motor carriers covered under K.S.A. 66-1,128 and amendments thereto;

(12) procedures for transportation workplace drug testing programs: 49 C.F.R. Part 40 and 49 C.F.R. Part 382; and

(13) rules of practice for motor carrier safety and hazardous materials proceedings: 49 C.F.R. 386.72.

(b) Whenever the incorporated federal regulations refer to portions of the federal regulations that are not included under subsection (a) of this regulation, those references shall not be applicable to this regulation.

(c) The following terms as used in this regulation and the identified sections of the regulations adopted by reference shall be defined as follows:

(1) "Authorized personnel," as used in 49 C.F.R. 396.9(c), means members of the Kansas highway patrol, any other law enforcement officer in the state, or authorized representatives of the commission who have been certified in the inspection of motor carriers based on the motor carrier safety assistance program standards.

(2) "Regional director of motor carriers," as used in 49 C.F.R. 391.51(b)(2), means the director of the transportation division of the commission.

(3) "Regional director of motor carriers," as used in 49 C.F.R. 391.51(g), means the superintendent of the Kansas highway patrol and the director of the transportation division of the commission.

(4) "Special agent of FHWA or special agent of the federal highway administration and authorized representatives of the federal highway administration," as used in

49 C.F.R. 395.13(a), 398.8(a), and appendix B to subchapter B, means authorized representatives of the commission, and members of the Kansas highway patrol or any other law enforcement officers in the state who have been certified in the inspection of motor carriers based on the motor carrier safety assistance program standards.

(d) Copies of the motor carrier safety regulations promulgated by the U.S. department of transportation may be obtained from the superintendent of documents, United States government printing office, Washington, D.C. 20402. Under the Medicaid program, 42 U.S.C. 1396 *et seq.*, the State of Kansas pays nursing facilities and nursing facilities for mental health a daily rate for care provided to residents who are eligible for Medicaid benefits. The Secretary of Aging administers the Medicaid nursing facility services payment program on behalf of the Secretary of Social and Rehabilitation Services. As required by 42 U.S.C. 1396a(a)(13), as amended by Section 4711 of the Balanced Budget Act of 1997, P.L. No. 105-33; 101 Stat. 251, 507-08 (August 5, 1997), the Secretary of Social and Rehabilitation Services (SRS) and the Secretary of Aging (KDOA) are publishing the proposed methodology for the Kansas Intergovernmental Transfer Program. SRS and KDOA also are providing notice of the state's intent to submit the proposed amendment to the Medicaid State Plan to the U.S. Department of Health and Human Services, Health Care Financing Administration (HCFA), on or before March 31, 2000.

**I. Kansas Intergovernmental Transfer Program  
Provisions for Governmental Facilities - Government-  
Owned and Operated Nursing Facility Proportionate  
Share Pool:**

(continued)

A proportionate share pool is created to increase reimbursement to Medicaid-certified, government-owned and operated nursing facilities. "Owned" refers to the common meaning of ownership of the physical structure(s). "Operated" refers to the government's direct and active involvement in a facility's day-to-day operations, as indicated in the provider agreement. "Government" means a unit of local government, such as a city, a county, a city hospital, a county hospital, a hospital district, or a health care facilities and services hospital district. The pool is created subject to availability of funds and subject to the payment limits of 42 CFR 447.272 (payments may not exceed the amount that can reasonably be estimated to be paid under Medicare payment principles).

The proportionate share pool is calculated by comparison of the Kansas Medicaid rates in all Medicaid-certified nursing facilities to the equivalent Medicare rates, whether or not each facility is Medicare certified. The equivalent Medicare rate is adjusted by the wage index published in the Federal Register. When the Case Mix Index utilized for computing the Medicaid rate does not have an equivalent Medicare classification, the Medicaid case mix index will be adjusted down to the next closest Medicare RUGs classification. The methodology shall adjust for pharmacy, laboratory, radiology, retroactive payment adjustments, and any other factors necessary to equate Medicaid to Medicare payment methodologies. The differences between the facility-specific Medicare rates and Medicaid rates are summed to determine the amount of the pool.

The Department of Social and Rehabilitation Services shall submit to HCFA quarterly reports that demonstrate the calculation of the proportionate share pool, and that calculations have not resulted in payments in excess of the amount which could reasonably be paid under Medicare payment principles.

The pool is calculated for each reporting period and distributed on or about 45 days after the end of the period. For example, a distribution would be made on or around May 15 for the quarter ending March 31. Each government-owned and operated facility's distribution amount is based on its estimated proportionate share of the pool (based on its share of Medicaid resident days).

## II. Proposed Medicaid Per Diem Rates for Kansas Nursing Facilities.

The Kansas Intergovernmental Transfer Program will not impact the Medicaid per diem rates for Kansas nursing facilities.

## III. Justifications for the Proposed Rates.

1. Federal Medicaid regulation 42 C.F.R. 447.272 imposes an aggregate upper payment limit that states may pay for Medicaid nursing facility services. The state's analysis indicates that the proposed Intergovernmental Transfer Program methodology would comply with federal regulation.

2. Estimated impact of the rate change due to the implementation of the Intergovernmental Transfer Program:

The above estimated average rates are in the aggregate. The Kansas Intergovernmental Transfer Program will not increase the rates paid to certified Medicaid nursing facilities.

3. The state estimates that the proposed rates would continue to make quality care and services available under the Medicaid State Plan at least to the extent that care and services are available to the general population. The state's studies indicate:

a. Service providers operating a total of 323 nursing facilities (representing 98 percent of all the licensed nursing facilities in Kansas) participate in the Medicaid program, while an additional 46 hospital-based long-term care units also are certified to participate in the Medicaid program;

b. There is at least one Medicaid-certified nursing facility, nursing facility mental health or Medicaid-certified hospital-based long-term care unit in each of the 105 counties in Kansas;

c. The statewide average occupancy rate for nursing facilities participating in Medicaid is 86.4 percent;

d. The statewide average Medicaid occupancy rate for participating facilities is 54.2 percent, which is a decrease from the prior year.

Accordingly, in the opinion of bond counsel, the offering and sale of the bonds described herein does not constitute an offering as defined by the rule, and the requirements of the rule do not apply to brokers, dealers and municipal securities dealers acting as underwriters in connection with the bonds described herein.

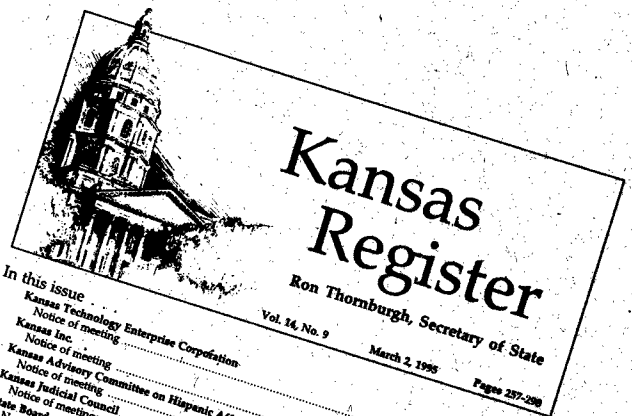
