The State of Kansas has been awarded \$402,301 in state fiscal year 2001 Local Law Enforcement Block Grant Program funding. Funding will be made available to state agencies, counties, cities and Indian Tribes. A 10 percent local match is required. Grants of up to \$9,000 in federal funding will be awarded. Entities that received a direct SFY 2001 Local Law Enforcement Block Grant from the federal government are not eligible to receive state funding under this grant program. Entities can submit only one application for funding. Grant applications must be postmarked not later than September 29, 2000.

Public Notice

Questions have arisen as to whether the sale of cigarettes and tobacco products to retailers and individuals on Indian reservations and lands are subject to Kansas cigarette and tobacco products tax.

K.S.A. 79-3310 provides as follows: "There is hereby imposed a tax upon all cigarettes sold, distributed or given away within the state of Kansas . . . Such tax shall be collected and paid only once and shall be paid by the wholesale dealer first receiving the cigarettes as herein provided..."

Under the Cigarette and Tobacco Products Tax Act, the legal incidence of cigarette and tobacco products tax, i.e. the responsibility for payment of the tax to the department, falls upon wholesalers first receiving the cigarettes and/or tobacco products. There is an exemption for cigarettes and tobacco products sold and shipped to another state (see K.S.A. 79-3311).

There is, however, an exception to the exemption at K.S.A. 79-3321(h)(2), which reads as follows: "It shall be unlawful for any person . . . To wholesale cigarettes to any person . . . who is . . . exempt from state licensing under applicable state or federal laws or court decisions including any such person operating as a retail dealer upon land allotted to or held in trust for an Indian tribe recognized by the United States Bureau of Indian Affairs."

Moreover, Indian reservations and lands are not "states," and any delivery to a retailer or individual located on Indian reservations or lands are not eligible for the export exemption.

As such, there is no exemption under Kansas law for sales of cigarettes and tobacco products to any retailer or individual on an Indian reservation or land. Likewise, there is no exemption from cigarette and tobacco products tax on sales of cigarettes and tobacco products to Indian tribes, their agents or tribal members who are retailers of cigarettes and tobacco products.

Therefore, beginning September 1, 2000, if you have not been remitting cigarette and/or tobacco products tax on sales and deliveries to retailers or individuals on Indian reservations or lands, you should begin immediately to remit said taxes on all sales from the date of this notice. If you agree to sell cigarette and/or tobacco products to retailers or individuals on Indian reservations or lands, you should remit cigarette and/or tobacco products tax on such sales and deliveries on all sales from the date of this notice.

To the extent that any prior notice, opinion or guide contradicts this notice, the same are hereby repealed and are of no effect.

Kansas Performance Review Board**Notice of Preliminary Recommendation**

The Kansas Performance Review Board recommends the retention of the current Kansas Department of Transportation inspection program. The board finds that this program is both economical and flexible in its approach to both public and private inspectors.

The Kansas Department of Transportation manages a complex engineering environment that requires frequent quality control and quality assurance inspections of pre-, during, and after-operations construction projects of state highways, roads, bridges and airfields. These construction projects are identified in multi-year programs, are bid competitively, and are inspected with a combination of state and private inspectors certified by KDOT. After a thorough review of all aspects of the state inspection program, the board concludes that the current management of the inspection program is the most advantageous method to ensure completion of construction projects in a timely and cost-effective manner.

The State Inspection Program allows KDOT to certify qualified state employees as construction inspectors for quality control and acceptance of projects upon completion. These inspections are interlaced with private inspectors from construction firms who have completed the inspector course of study and are certified by KDOT to provide quality assurance inspections during construction phases. The combined use of public and private inspectors allows for inspections to be performed in a timely manner across multiple projects in various locations throughout the state. The combined use of public and private inspectors during a construction project allows the program manager to maximize construction time during inclement weather, multiple projects, length and complexity of the projects, and other uncontrollable variables to include the recent increase in oil prices. By balancing need against time and date, KDOT is able to maintain in-house inspector strength at a level that maximizes the inspectors' "on-site" time while meeting inspection demands. It does this by using private inspectors to complement the main state inspector staff.

The 1999 KDOT workload expressed in total hours reveals a ratio of 70 percent in-house inspection to 30 percent from private inspectors as a benchmark for the 10-year construction program currently underway in fiscal year 2000. Although KDOT is approaching the most cost-effective balance of public/private inspector workload, it may need to adjust this ratio slightly to include efficiency as well.

KDOT contracts with Kansas State University to teach the course of instruction for the inspectors program. Both state and private inspectors must take and pass this course for certification by KDOT. In this manner, construction firms are able to meet their own staff needs for inspections as well. However, this demand for inspectors has increased the salary level for inspectors statewide. In order to keep an adequate pool of experienced inspectors, the department must maintain a constant balance of employees in the technical classification to achieve the desired number of inspectors in any given year.

Under the current management of the inspection program, KDOT will be able to meet any need for construction inspections as it implements the FY 2000 Comprehensive Transportation Program.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rule and regulation. All interested parties may submit written comments prior to the hearing to the Secretary of Administration, Room 263-E, State Capitol, 300 S.W. 10th Ave., Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulation during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulation and economic impact statement in an accessible format. Handicapped parking is located at the south end of Landon State Office Building, directly across the street from the building's north entrance, and on 9th Street. A summary of the proposed regulation and its economic impact follows.

Subsection (a) of K.A.R. 1-18-1a, mileage rates, prescribes reimbursement rates in four categories for employees' use of privately-owned conveyances on official business. The amended regulation would permanently implement the increases in reimbursement rates enacted by temporary regulation effective July 15, 2000. The in-

creases in reimbursement rates for the use of privately-owned conveyances are as follows:

Privately-Owned Conveyance	Current Mileage Rates	Proposed Mileage Rates
Motorcycle	\$.15	\$.16
Automobile	\$.31	\$.325
Airplane	\$.43	\$.44
Specially Equipped Vehicle for the Physically Disabled	\$.43	\$.44

The proposed amendments will affect state agencies and their employees who travel on official state business in privately-owned conveyances. However, K.A.R. 1-18-1a requires that, when a state-owned or leased vehicle is available, employees who choose to use a privately-owned vehicle are to be reimbursed at the Central Motor Pool rate for compact cars, which significantly reduces the economic impact of a change in the privately-owned conveyance reimbursement rate. The full privately-owned conveyance reimbursement rate may be paid only under the following circumstances: (1) if a state-owned or leased vehicle is not available; (2) if the use of a state vehicle is determined to be more expensive than the use of an employee's privately-owned vehicle; or (3) if the employee has a disability that requires use of a specially equipped private vehicle. Therefore, the reduced reimbursement rate would apply to most state employees who choose to use a privately-owned vehicle.

Statewide statistics are not maintained by the rate paid to reimburse mileage in privately-owned conveyances. Thus, an accurate estimate of increased expenditures resulting from the proposed increase in the privately-owned conveyance mileage rates cannot be provided.

If it is assumed that all FY 2000 expenditures for mileage reimbursement for privately-owned conveyances were paid at the Central Motor Pool rate and will continue to be, then the impact of an increase in the privately-owned conveyance reimbursement rate is zero. If it is assumed all FY 2000 expenditures for mileage reimbursement for privately-owned conveyances were paid at the rate of \$.31, the following table shows a "worst case" estimate of statewide increased expenditures with the rate raised to \$.325 in FY 2001:

The proposed increases in privately-owned conveyance rates also would have an indeterminable economic impact on any local governmental units within the State of Kansas that do not elect to establish their own mileage rates and alternatively use the state rates.

A public hearing will be conducted at 11 a.m. Tuesday, October 3, in Room 108, Landon State Office Building, 900 S.W. Jackson, Topeka, to consider the adoption of a proposed rule and regulation of the Kansas State Treasurer on a permanent basis.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rule and regulation. All interested parties may submit written comments prior to the hearing to Tim Shallenburger, Kansas State Treasurer, Room 201-N, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612-1235. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulation during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulation and economic impact statement in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Faith Loretto at (785) 296-6000 or (785) 296-4798 (TTY). The north entrance to the Landon State Office Building is accessible. Handicapped parking is located at the south end of the building, across the street from the north entrance to the building, and around the corner from the north entrance on 9th Street.

A summary of the proposed regulation and its economic impact follows.

During the 2000 legislative session, a new "linked deposit loan program" was authorized. L. 2000, Ch. 101 requires the State Treasurer to administer the "Kansas agricultural production loan deposit program" whereby state idle funds are made available to local banks as an incentive to the banks to provide low interest loans to agricultural borrowers. L. 2000, Ch. 101, Section 4 establishes a \$50 million limit on the amount of state idle funds that can be made available for agricultural production loans.

K.A.R. 3-3-1 provides that these funds are to be used only for agricultural production loans made to borrowers who are residents of Kansas and whose farms have the majority of their land located in Kansas. It further provides that limited liability agricultural companies, limited agricultural partnerships, and family farm corporations will be considered residents of Kansas if they meet the requirements of K.S.A. 17-5903. K.S.A. 17-5903 defines each of these entities in such a way that at least one of the partners, stockholders or members must be residing on the farm.

This regulation is not expected to have any economic impact on the Office of the State Treasurer or any other

governmental agencies or units. K.A.R. 3-3-1 does not increase or decrease the amount of state money made available for the agricultural production loan deposit program. The regulation does have an unknown adverse economic impact on borrowers who are not residents of Kansas or whose farm does not have the majority of its land located in Kansas, as those borrowers will not be eligible for these lower interest loans. However, it is not possible to provide an estimate of the number of potential borrowers who meet only one of these two requirements. Conversely, the regulation has a positive economic impact of an unknown magnitude on those borrowers who meet both the residency and site location requirements because it ensures that the limited funds provided for this program remain available for Kansans on farms with the majority of their land located in Kansas. There is no direct economic impact on private citizens of Kansas, except to the extent that focusing the low interest loans on Kansas residents and farms indirectly encourages increased business and income for Kansas communities, businesses and citizens.

The Kansas Board of Emergency Medical Services is conducting a public hearing at 1 p.m. Tuesday, October 3, in Centennial Room C, Pozez Education Center, 1505 S.W. 8th, Topeka, to consider amendments to permanent Kansas administrative regulations 109-2-2, 109-5-1, 109-5-4, 109-6-2, 109-7-1, 109-10-1, 109-11-6 and 109-13-1, and proposed new administrative regulation 109-6-3.

This notice constitutes the initiation of a 60-day public comment period for the purpose of receiving written public comments on the proposed rules and regulations. Written comments may be submitted to David Lake, Administrator, Kansas Board of Emergency Medical Services, 109 S.W. 6th Ave., Topeka, 66603-3826.

The adoption of these regulations is not required by federal law, nor is the board participating in or implementing a federally subsidized or assisted program relating to these proposed regulation changes.

Individuals will be given a reasonable opportunity to orally present their views at the public hearing. A written summary of testimony should be provided. Oral presentations may be limited to five minutes, depending on the number of individuals desiring to provide testimony.

A complete copy of the proposed rules and regulations and the economic impact statement may be obtained from the Kansas Board of Emergency Medical Services at the address above, (785) 296-7296 or TTY (785) 296-6237. Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statement in an accessible format. Requests for accommodation should be made at least five days in advance of the hearing by contacting David Lake at (785) 296-7296.

A summary of the proposed regulations and their economic impact follows.

**Article 2—Ambulance Services; Permits
and Regulations**

109-2-2. Application for ambulance service permit and permit renewal. The proposed changes to this regulation modify the date of expiration of service permits and vehicle licenses. This change is being recommended to disperse the workload of board staff. Currently, ambulance service permit and vehicle licensure renewal is at the end of the calendar year. Attendant, IC and training officer renewal also is at the end of the year. Processing these renewals can be accomplished more timely if the workload for this processing is at different times of the year.

There is no anticipated fiscal or economic impact on persons or licensed ambulance services subject to the proposed changes of this regulation. Ambulance services that hold a current permit and current vehicle licenses will receive an additional four months on their service permits and vehicle licenses. This will occur the first year only for implementation purposes. The renewal will then convert back to a 12-month basis as is the current situation, only at a different time of the year.

The fiscal impact to the board with the changes to this regulation is more efficient utilization of board staff time for timely processing the applications.

Article 5—Continuing Education

109-5-1. Continuing education. The proposed changes to this regulation modify the amount of continuing education hours that must be achieved for attendant certification renewal. The amount of required continuing education hours will double to take into account the two-year certification period mandated by HB 2696 adopted during the 2000 legislative session.

In order to maximize the benefit to the board, the registry will be split. This year's renewal will require approximately half of the individuals to renew for a one-year period and then convert to a two-year period after that. All current certifications are on a yearly basis and will expire December 31 of this year. No individual will have to obtain more continuing education hours this year than they currently are required to obtain, and will not have to until they are in a two-year certification cycle.

There is no estimated economic impact on persons subject to the proposed changes of this regulation since the total number of continuing education hours they will have to obtain over a two-year period will not change. There is no fiscal impact to individuals, local units of government, or the board because of the changes to this regulation.

109-5-4. Regaining expired certification. The proposed changes to this regulation implement a two-year certification period as required by the passage of HB 2696 during the 2000 legislative session. The revisions will basically double the amount of continuing education currently required to regain an attendant certification.

The economic impact of this regulation is primarily on individuals who allow their certification to expire and then desire to regain said certification. There also could be an impact to the local service provider who has an attendant on their roster that allows their certification to expire. This impact includes time to regain the certification as well as the amount of hours required to obtain. This may contribute to staffing problems for ambulance services that find themselves in this situation, as well as to the costs incurred by the individual to regain the certification. These costs may include travel, subsistence, registration fees and possibly loss of paid work time to obtain the necessary continuing education in order to regain the certification. There is no anticipated fiscal impact to the board by adopting this regulation.

Article 6—Temporary Certification

109-6-2. Renewal of attendant, training officer and instructor-coordinator certificate. The proposed changes to this regulation will eventually put all certified attendants, instructor-coordinators and training officers on a two-year renewal cycle. This regulation is necessary to implement statutory requirements of HB 2696 adopted during the 2000 legislative session.

There is no estimated economic impact on persons or local units of government subject to the proposed changes

(continued)

of this regulation. It will eventually put all individuals on a two-year certification cycle, thereby saving them the cost of a stamp every other year to apply for renewal. There are approximately 10,000 people in the board's registry who currently have to apply for certification renewal annually. At 33 cents per stamp, the total economic impact on individuals over a two-year period is a savings of \$3,300. There is a corresponding impact of a total loss of \$3,300 on mail services organizations.

The fiscal impact to the board with the changes to this regulation is to disperse staff time to timely process the certification renewal applications. The board also will receive a benefit of reduced mailing costs annually of approximately \$2,640.

109-6-3. Attendant certification expiration and renewal. This proposed new regulation describes how the registry will be split for implementation of a two-year certification period. Individuals who are provided the two-year certification period with this initial implementation year and individuals that will remain on a one-year certification period until their next renewal are defined. Additionally, this regulation, along with K.A.R. 109-6-2, explains what must be done to renew a certification.

There is no estimated economic impact on individuals or local units of government by the adoption of this regulation.

The fiscal impact to the board is dispersing board staff time for processing the applications for certification renewal.

Article 7—Fees

109-7-1. Schedule of fees. The proposed changes to this permanent regulation increase the renewal fee for MICTs by \$10 per year; raise the service permit fee for ambulance services by \$50 per service; raise the vehicle licensure fees for ambulances by \$5 per vehicle; and double all fees previously associated with a one-year attendant and I-C certification renewal to account for the new two-year renewal period. Additionally, the proposed changes to this regulation invoke fees for training officer certification and certification renewal. There currently is no fee for training officer certification and certification renewal.

The estimated economic impact on persons subject to the proposed changes of this regulation includes \$10 per year for each certified MICT, \$65 for initial certification as a training officer, and \$30 for biennial certification renewal as a training officer.

There currently are 1,478 certified MICTs in Kansas. Consequently, the total increase in costs incurred by all MICTs to renew their certification this implementation year is approximately \$14,780 and \$29,560 biennially.

There currently are 340 training officers certified in Kansas. Consequently, the total costs incurred by all certified training officers to renew their certification this implementation year is \$5,100 and \$10,200 biennially.

Some local services pay for their personnel's certification renewal. Therefore, a portion of the above-stated figure concerning certification renewal fees for MICTs and training officer fees will impact some local units of government. Additionally, there is an economic impact to each ambulance service provider to pay the increase in

the service permit fee and the vehicle licensure fee. There currently are 181 permitted ambulance services and 643 ambulances for a total increase to service providers of \$12,265.

The fiscal impact to the board with the changes to this regulation is an estimated average annual increase of revenue of approximately \$32,145. This increase will be realized during fiscal year 2001 but will be dispersed over a two-year period after that.

Article 10—Curricula

109-10-1. Curricula approval. Proposed changes to this permanent regulation adopt a new paramedic national standard curriculum. This change is necessary to continue training paramedics (MICTs) using current knowledge and therapeutic modalities. Additionally, the testing agent (NREMT) the board uses is rewriting all its exams to address the new national standard curriculum.

The estimated economic impact on persons subject to the proposed changes of this regulation may involve an increase in textbook fees and an increase in the number of credit hours of an MICT course, and possibly an increase in fees for clinical and field training costs. Additionally, one of the paramedic training programs has indicated that the adoption of this new curricula may cause it to hire an additional 1.5 full-time equivalents.

The estimated fiscal impact to the board primarily involves board certification testing. The board currently uses the National Registry of EMT's written and practical examinations for its certification exam for MICTs. The National Registry of EMTs will be modifying its examinations to coincide with the new national standard curriculum. If the board decides not to implement this new curriculum, it would have to find other arrangements for its certification exam. The board has recently purchased \$3,600 worth of testing supplies and equipment in preparation for the revised practical examinations for MICTs. There is no additional increase in direct costs to the board by adopting this new curriculum.

Article 11—Course Approval

109-11-6. Mobile intensive care technician course approval. Proposed changes to this permanent regulation will require that all MICT initial courses of instruction teach the latest version of the paramedic National Standard Curriculum (NSC).

The estimated economic impact is as stated under K.A.R. 109-10-1 above.

Article 13—Training Officers

109-13-1. Training officers. Proposed changes to this permanent regulation will clarify that training officers will continue to have to attend an annual meeting even though they are on a two-year certification cycle.

There is no economic impact imposed because of the proposed changes to this regulation since these training officers currently have to attend an annual meeting.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the Secretary of Agriculture, attention Derenda Mitchell, 109 S.W. 9th, 4th Floor, Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statement in an accessible format. These regulations are proposed for adoption on a permanent basis. A summary of the proposed regulations and their economic impact follows.

Proposed amendments to K.A.R. 4-8-14a revise definitions by adding the herbicide imazapic (Plateau). Imazapic is a relatively new herbicide that research has shown to be effective on musk thistle, johnsongrass, field bindweed, bur ragweed (bursage), bull thistle, and leafy spurge. Imazapic is being used to control musk thistle, johnsongrass, field bindweed, bur ragweed (bursage), bull thistle, and leafy spurge on public rights of way where cost share is not an issue.

Proposed amendments to K.A.R. 4-8-27, 4-8-28, 4-8-29, 4-8-32, 4-8-34 and 4-8-41 revise and adopt by reference the official control programs for musk thistle, johnsongrass, field bindweed, bur ragweed (bursage) and leafy spurge. This will allow county weed departments to sell imazapic at cost share for control of musk thistle, johnsongrass, field bindweed, bur ragweed (bursage) and leafy spurge for applications allowed on the product label. Some language relating to other herbicide controls was deleted to make the control programs conform to the current label language.

New proposal K.A.R. 4-8-42 would adopt by reference the official control programs for bull thistle. K.S.A. 2-1314b includes bull thistle (*Cirsium vulgare*) as a county-option noxious weed.

The anticipated economic impact upon the Kansas Department of Agriculture because of the proposed

amended and new regulations is \$1,000 for printing and distributing the amended control programs. The anticipated financial impact upon other governmental agencies and upon private business or individuals is likely to be minimal and may even be reduced because of improved efficacy.

Lower pesticide use rates contemplated by these proposals will reduce the environmental impact on desirable species.

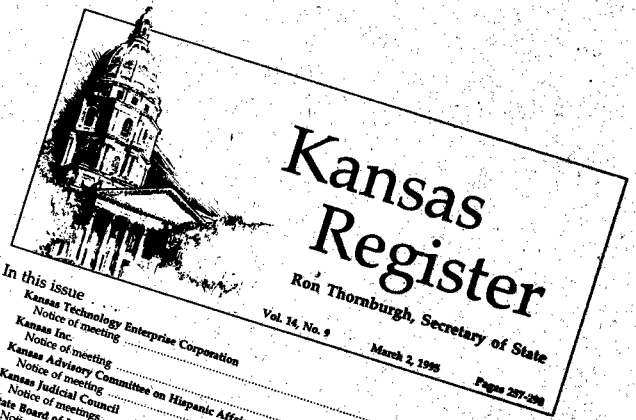
