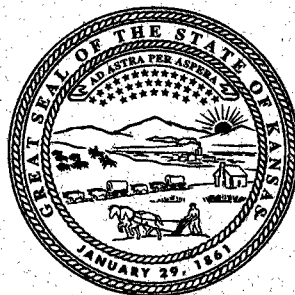

Notice of Hearing on Proposed  
Administrative Regulations

A public hearing will be conducted at 9:30 a.m. Friday, October 20, in Room 108 of the Landon State Office Building, 900 S.W. Jackson, Topeka, to consider the adoption of proposed new rules and regulations and amendments to existing rules and regulations of the Board of Accountancy.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the executive director of the Board of Accountancy, Suite 556, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Shelly Myers at (785) 296-2162. Handicapped parking is located at the south end of Landon State Office Building, and the north entrance to the building is accessible to individuals with disabilities.

These regulations are proposed for adoption on a permanent basis. A summary of proposed regulations and their economic impact follows.

**K.A.R. 74-1-2. Grading.** This regulation is being revised to set forth the board's policy on cheating and the consequences that may be incurred. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-1-7. Examination security.** This is a new regulation providing the flexibility of the board for scheduling and grading of the exams and the issuance of certificates. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-2-1. Filing date for applications.** This regulation is being revised to update existing language. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-2-3. Submission of college transcripts.** This regulation is being revised to update and clarify existing language. There is no economic impact to governmental agencies or to certified public accountants; however, there is a fee incurred by the CPA exam candidates for evaluation of a foreign transcript, which is paid to the service provider. The Board of Accountancy will not receive any receipts as a result of this change.

**K.A.R. 74-2-4. Conditionally qualified within ninety (90) days after examination.** This regulation is being re-

vised to update existing language. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-3-8. Ethics examination requirement for issuance of certificates.** This regulation is being revised to update existing language. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-4-1.** This regulation is being revoked.

**K.A.R. 74-4-1a. Experience requirements for attest services.** This is a new regulation to accommodate changes made to K.S.A. 1-302b requiring that a person supervising or performing attest services must meet certain requirements. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-4-2a. Evidence of experience.** This is a new regulation relating to the verification of a person's experience, outlining the board's authority to substantiate the experience. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-4-3a. Permit renewal.** This is a new regulation defining an "incomplete" application. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-4-4. Experience requirement for permits.** This regulation is being revised to accommodate changes made in the 2000 legislative session to K.S.A. 1-302b defining what qualifies as experience and the length of time required for said experience. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-4-7. Continuing education requirements.** This regulation is being revised to update existing language. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-4-10. Continuing education requirements for initial or reinstated permits.** This regulation is being revised to update existing language. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-5-2. Definitions.** This regulation is being revised to update existing language. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-5-202. Auditing standards.** This regulation is being revised to update existing language. There is no economic impact on governmental agencies, the general public or certified public accountants.

**K.A.R. 74-5-203. Accounting principles.** This language is being revised to update existing language. There is no economic impact on governmental agencies, the general public or certified public accountants.

**K.A.R. 74-5-205. Professional standards.** This is a new regulation that sets forth which professional standards apply to the type of service performed by a CPA. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-5-405. Form of practice.** This regulation is being revised to include a form of practice previously

omitted. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-6-1. Definitions of office and firm.** This regulation is being revised to update existing language. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-6-2. Management of an office.** This regulation is being revised to update existing language. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-7-2. Firms eligible for registration.** This regulation is being revised to further clarify changes made in the 2000 legislative session to K.S.A. 1-308 regarding firm registrations. There is no economic impact to governmental agencies or the general public; however, this change will result in a new fee paid by CPAs who are subject to firm registration, which will result in an increase in receipts to the Board of Accountancy.

**K.A.R. 74-11-6. Definitions.** This regulation is being revised to update existing language. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-12-1. Fees.** This regulation is being revised to set the fees for authority to practice by notification, renewal of the notification, and firm registration fees. There is no economic impact to governmental agencies or the general public. CPAs who qualify to practice by notification will incur a notification fee and a fee for renewal of the notification. These changes will result in a decrease of receipts paid to the Board of Accountancy. The implementation of the firm fee will result in a new fee paid by CPAs subject to firm registration, as well as renewal of the firm registration. This will result in an increase of receipts to the Board of Accountancy.

**K.A.R. 74-15-1. Adoption of the uniform accountancy act.** This is a new regulation to adopt specific sections of the uniform accountancy act. There is no economic impact to governmental agencies, the general public or certified public accountants.

**K.A.R. 74-15-2. Application of notification to practice; renewal.** This is a new regulation providing for authority to practice by notification. CPAs who qualify for this registration were previously required to obtain a CPA certificate and a permit to practice. There is no economic impact to governmental agencies or the general public. CPAs will incur a registration and biennial renewal fee in the amount of \$150, which is exactly equivalent to the permit fee previously required. This change will result in a decrease in receipts to the Board of Accountancy, as CPAs who qualify to practice under this provision will no longer be required to obtain a CPA certificate that bears a one-time fee of \$225.

**Notice of Proposed Nursing Facility Medicaid Rates  
for State Fiscal Year 2001 for the Nursing Facility  
Quality Enhancement Wage Pass-Through Program,  
Methodology for Calculating Proposed Rates, and Rate  
Justifications; Notice of Intent to Amend the Medicaid  
State Plan and Request for Written Comments**

Under the Medicaid Program, 42 U.S.C. 1396 *et seq.*, the State of Kansas pays nursing facilities, nursing facilities for mental health, and hospital-based long-term care units (hereafter collectively referred to as nursing facilities) a daily rate for care provided to residents who are eligible for Medicaid benefits. The Secretary of Aging administers the Medicaid nursing facility services payment program on behalf of the Secretary of Social and Rehabilitation Services. As required by 42 U.S.C. 1396a(a)(13), as amended by Section 4711 of the Balanced Budget Act of 1997, P.L. No. 105-33, 101 Stat. 251, 507-08 (August 5, 1997), the Secretary of Social and Rehabilitation Services (SRS) and the Secretary of Aging (KDOA) are publishing the proposed Medicaid per diem rates for Medicaid-certified nursing facilities for state fiscal year 2001, the methodology underlying the establishment of the proposed nursing facility rates, and the justifications for those proposed rates for the Nursing Facility Quality Enhancement Wage Pass-Through Program. SRS and KDOA also are providing notice of the state's intent to submit the proposed amendment to the Medicaid State Plan to the U.S. Department of Health and Human Services' Health Care Financing Administration (HCFA) on or before September 30, 2000.

**I. Methodology Used to Calculate Medicaid Per Diem Rates for the Continuation of the Nursing Facility Quality Enhancement Wage Pass-Through Program.**

The Kansas Legislature, during the 1999 session, adopted Senate Bill 126 (K.S.A. 1999 Supp. 39-971), an act to establish the Nursing Facility Quality Enhancement Wage Pass-Through Program. This program provided funding for nursing facilities to increase salaries or benefits for eligible positions providing direct care or support services to nursing facility residents. It also allowed facilities to hire additional staff in the eligible position categories. KDOA and SRS published the final methodology for calculating Medicaid per diem rates for the Nursing Facility Quality Enhancement Wage Pass-Through Program pursuant to Senate Bill 126 (K.S.A. 1999 Supp. 39-971) and House Bill 2489 (1999 Session Laws of Kansas, Chapter 160), in the August 5, 1999 Kansas Register. Readers should refer back to that issue for a description of the methodology.

During the 2000 legislative session, the Kansas Legislature adopted Senate Bill 248 (2000 Session Laws of Kansas, Chapter 105), creating the Kansas Intergovernmental Transfer Program. Of the funds generated from this program, 9.7 percent are to be transferred to the state Medicaid match fund-Department on Aging. House Bill 2513 (2000 Session Laws of Kansas, Chapter 183) included an appropriation of \$1,660,795 state general funds for the

Department on Aging from this fund for nursing facilities' (NF) quality enhancement wage pass-through pursuant to Senate Bill 126 (K.S.A. 1999 Supp. 39-971). A similar appropriation of \$39,205 state general funds was made to the Department of Social and Rehabilitation Services for nursing facilities for mental health (NF-MH).

House Bill 2513 contains the restriction that no funds be expended except upon the approval of the State Finance Council after it has received certification from the director of the budget that sufficient moneys are available. Therefore, the implementation of the quality enhancement wage pass-through program is contingent upon funding being secured for the program. The wage pass-through will be implemented retroactive to July 1, 2000, if and when funding is secured. The following is an addition to that methodology to provide for the continuation of the wage pass-through for state fiscal year 2001, limited by the contingency noted above.

**Eligibility**

Only those NF and NF-MHs that were active in the wage pass-through program as of June 30, 2000, will be eligible to participate in the program during FY 2001. These active participants will not be required to file a new application for the program.

**Funding for Individual Facilities**

Per diem funding for individual facilities for FY 2001 will be determined by two components. The first of these components will begin phase-out of the facility-specific per diems that each participant received during FY 2000. The second component will be a prorated portion of any remaining pass-through funds.

The first component of the FY 2001 per diems will be based on the FY 2000 per diems, and each facility's program effective date. It will be the amount of the facility's FY 2000 per diem that has not been built into its regular Medicaid rate or a prorated portion thereof if the program is not fully funded.

As an example, consider a facility that received a \$1.90 pass-through per diem during FY 2000 and that began the program on September 1, 1999. Of the \$1.90, \$0.63 would be built into the facility's regular Medicaid rate as of July 1, 2000. This amount is determined by multiplying the \$1.90 by the four months that the facility received the pass-through during calendar year 1999, and then dividing this product by the 12 months of the calendar year. In effect, this process averages the pass-through per diem out to a per resident day amount for calendar year 1999. Once this amount is determined, it is subtracted from the facility's FY 2000 pass-through per diem to arrive at its FY 2001 per diem. For the facility in this example, the FY 2001 per diem would be \$1.27 (\$1.90 - \$0.63). If full funding is not available, a prorated portion of this amount will be awarded.

The second component of the FY 2001 per diem will be determined by prorating any additional funds that remain after the first component has been determined for each participant. This prorated amount will be based upon each facility's FY 2000 per diem.

**Reporting and Documentation**

Providers will continue to be required to submit cost information within 45 days after the end of each quarter to document the use of the wage pass-through moneys. This documentation will be the Quality Enhancement Wage Pass-Through Quarterly Audit Report. Supporting documentation such as payroll registers and state unemployment tax reports will be required upon the request of KDOA audit staff.

**II: Proposed Medicaid Per Diem Rates for Kansas Nursing Facilities.**

The quality enhancement wage pass-through per-diem shall not exceed \$4 per Medicaid resident day. The per-diem increase for the participants will be added to the computed Medicaid rate in effect for the nursing facility but shall not exceed the comparable private pay rate.

**III. Justifications for the Proposed Rates.**

1. The proposed rates are calculated according to methodology published in the August 5, 1999 Kansas Register and satisfies the requirements of Senate Bill 126 (K.S.A. 1999 Supp. 39- 971), Senate Bill 248 and House Bill 2513.

2. Staff with the Kansas Departments on Aging and Social and Rehabilitation Services met with representatives from the Kansas Association of Homes and Services for the Aging, the Kansas Health Care Association and the Kansas Hospital Association to determine the most equitable method of distributing the available funding for the quality enhancement wage pass-through program. The proposed methodology represents a consensus of the attendees at the meetings.

3. a. Estimated impact of the rate change due to the implementation of the quality enhancement wage pass-through program:

Estimated Average Rate July 1, 2000 with Pass-Through .....	\$91.43
Estimated Average Rate July 1, 2000 without Pass-Through .....	\$90.43
Amount of Change .....	\$1.00
Percent of Change .....	1.10

b. The above estimated average rates are in the aggregate. Not all nursing facilities will receive a rate change, and some may receive an increase greater than \$1.00.

4. Estimated annual aggregate expenditures in the Medicaid nursing facility services payment program will increase by approximately \$4,500,000.

5. The state estimates that the proposed rates would continue to make quality care and services available under the Medicaid State Plan at least to the extent that care and services are available to the general population. The state's studies indicate:

a. Service providers operating a total of 323 nursing facilities (representing 98% of all the licensed nursing facilities in Kansas) participate in the Medicaid program, while an additional 46 hospital-based long-term care units also are certified to participate in the Medicaid program;

b. There is at least one Medicaid-certified nursing facility or Medicaid-certified hospital-based long-term care unit in each of the 105 counties in Kansas;

c. The statewide average occupancy rate for nursing facilities participating in Medicaid is 87.2%;

d. The statewide average Medicaid occupancy rate for participating facilities is 54.8%, which is an increase from the prior year; and

e. The proposed rates would enhance the coverage that is already at 99.19% of the estimated Medicaid health care costs incurred by participating nursing facilities statewide.

6. Federal Medicaid regulations at 42 C.F.R. 447.272 impose an aggregate upper payment limit that states may pay for Medicaid nursing facility services. The state's analysis indicates that the proposed methodology would result in compliance with the federal regulation.

**IV. Request for Comments; Request for Copies.**

The state requests providers, beneficiaries and their representatives, and other concerned Kansas residents to review and comment on the proposed rates, the methodology used to calculate the proposed rates and the justifications for the proposed rates. **State Bank Commissioner**

**Special Order 2000-3**

This order is hereby issued August 7, 2000, by the Kansas State Bank Commissioner pursuant to K.S.A. 9-1715, as amended.

WHEREAS, the Comptroller of the Currency, pursuant to 12 C.F.R. 5.36 and various Interpretive Letters, including but not limited to OCC Interpretive Letter Nos. 697, 732 and 889, has ruled that a national bank has authority to acquire a minority interest in a corporation engaged solely in activities which are permissible for the bank itself to engage in, provided certain requirements or standards are satisfied; and

WHEREAS, pursuant to 12 C.F.R. §7.1010, maintaining and operating a postal substation in accordance with rules and regulations of the United States Postal Service and advertising, developing and extending those services for the purpose of attracting customers to the bank is a permissible activity for a national banking association to engage in directly; and

WHEREAS, no provision of Kansas law presently allows a Kansas state bank to acquire a minority interest in a corporation engaged in activities that the bank itself could engage in; and

WHEREAS, The Peoples Bank, Pratt, Kansas, has requested authority to acquire a minority interest in a Kansas corporation which will engage in postal substation activities; and

WHEREAS, K.S.A. 9-1715, as amended, grants to the commissioner "... the power to authorize any ... state bank[s] to engage in any activity in which such banks could engage were they operating as national banks at the time such authority is granted ..."; and

WHEREAS, the Commissioner deems the issuance of this special order to be reasonably required to preserve the welfare of state banks and to promote competitive equality of state banks and national banking associations;

IT IS THEREFORE ORDERED, that The Peoples Bank, Pratt, Kansas, may acquire a minority interest in stock of a Kansas corporation that engages in postal substation activities, provided the following standards are met:

1. The services to be provided by the corporation are activities that a national bank could engage in directly through operation of a postal substation;
2. The corporation's articles of incorporation or bylaws specifically limit its activities to those activities a national bank could perform through a postal substation, and the bank has the ability to prevent the corporation from engaging in activities that do not meet the foregoing standard, or to withdraw its investment; and
3. The bank's potential loss exposure is limited to the amount of its investment in the corporation.

IT IS FURTHER ORDERED, that pursuant to K.S.A. 9-1715(b), as amended, the terms of this special order shall become effective August 7, 2000, and shall remain in full

force and effect until amended or revoked by the State Bank Commissioner.

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Thursday, October 19, at the Lee Richardson Zoo, 312 Finnup Drive, Garden City, to consider the approval and adoption of proposed regulations of the Kansas Department of Wildlife and Parks.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 1:30 p.m. October 19 at the same location. The meeting will recess at 5 p.m., then resume at 7 p.m. at the same location for the regulatory hearing. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. October 20 at the same location.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Sheila Kemmis, commission secretary, at (316) 672-5911. Persons with a hearing impairment may call the TDD service at 1-800-766-3777 to request special accommodations.

This 60-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on proposed administrative regulations.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, Suite 502, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The administrative regulations that will be heard during the regulatory hearing portion of the meeting are as follows:

**K.A.R. 115-2-2.** This regulation establishes fees for daily and annual motor vehicle permits for vehicles entering and using state parks. The proposed amendments would increase daily permit fees from \$3.50 to \$4.50 beginning January 1, 2001. Beginning April 1, 2001, annual permit fees would increase from \$29.50 to \$39.50 for the months of April through September. The fee would decrease to \$34.50 for October through March, and thereafter would continue this price difference between the summer season and the winter season.

**Economic Impact Summary:** The proposed amendments may increase FY 2001 revenues to the Park Fee Fund by an estimated \$280,000. The costs of the amendments would be borne by members of the public who use state parks. The amendments are not anticipated to have an impact on other agencies.

**K.A.R. 115-2-3.** This regulation establishes fees for camping permits and utilities at state parks. The primary impacts from the proposed amendments include an increase in the price of camping permits beginning on April 1, 2001, for the months of April through September, followed by a decrease in price October through March, and thereafter a continuing price difference between the summer season and the winter season. The proposed summer and winter fees for camping permits would be: Annual permit: \$130 - \$110; Overnight permit: \$6 - \$5; 14-night permit: \$70 - \$60. An additional \$2 fee would be required to camp at designated prime sites during the summer season. Increases in other related fees also are proposed, to be effective January 1, 2001. These include a fee increase for two-utility and three-utility hookups, from \$6 to \$6.50 and from \$7 to \$8, respectively.

**Economic Impact Summary:** The proposed amendments may increase FY 2001 revenues to the Park Fee Fund by an estimated \$25,000. The costs of the amendments would be borne by members of the public who camp overnight at state parks. The amendments are not anticipated to have an impact on other agencies.

**K.A.R. 115-7-1.** This regulation establishes legal fishing equipment and methods for sportfish and for nonsportfish. The proposed amendment would clarify that, if a minimum length limit for paddlefish is established in an area, paddlefish not meeting this limit must be released. Otherwise, according to the regulation, all paddlefish caught and landed must be retained and counted towards the creel and possession limits.

**Economic Impact Summary:** The proposed amendment is not anticipated to have an economic impact on the department, other state agencies or members of the public.

## Kansas Dental Board

### Permanent Administrative Regulations

#### Article 3.—DENTAL HYGIENISTS

**71-3-8. Refresher course.** (a) An eligible dental hygienist may, except as provided in subsection (e) below, return to the practice of dental hygiene without the requirement of a clinical examination, upon submitting an application on a form provided by the board and providing proof of having successfully completed a refresher course approved by the board.

(b) For purposes of this regulation, an eligible dental hygienist shall be an individual who meets the following requirements:

(1) Was previously licensed to practice dental hygiene;

(2) has not been disciplined by the licensing board in any state in which the individual has been licensed to practice dental hygiene;

(3) has practiced dental hygiene; and

(4) meets the other requirements for licensure set forth in K.S.A. 65-1455, and amendments thereto.

(c) For a refresher course to be approved by the board, it shall meet the following minimum criteria:

(1) Be taught at a dental hygiene school approved by the board;

(2) consist of a minimum of 48 clock hours, including a minimum of 32 clock hours of clinical instruction;

(3) include didactic coursework, which may be presented in a classroom or independent study setting, or both, and clinical coursework covering the following:

(i) Infection control and sterilization;

(ii) patient assessment, including the taking of health histories, an oral inspection and evaluation, and charting;

(iii) radiographic techniques;

(iv) instrumentation techniques, including periodontal procedures and instrument sharpening;

(v) current techniques in the polishing of teeth and the application of fluoride;

(vi) patient education;

(vii) emergency situations; and

(viii) the current Kansas dental laws; and

(4) include final written and clinical evaluations that require a minimum passing score of 75 percent.

(d) As a further condition of returning to the practice of dental hygiene, the dental hygienist may be required to appear before the board.

(e) A formerly retired or disabled dental hygienist who is returning to the practice of dental hygiene, without the requirement of a clinical examination, may not administer local anesthesia or nitrous oxide until having completed courses of instruction in local anesthesia and nitrous oxide approved by the board. Regulations****Article 5.—COMPENSATION**

**1-5-24. Overtime.** (a) Except as otherwise provided by the statutes or regulations, employees of the state who are eligible to receive overtime compensation under the fair labor standards act of 1938 (FLSA), as amended, shall be compensated for overtime as provided in that act. State employees in agricultural positions shall also be eligible for overtime compensation. The final determination as to eligibility to receive overtime as specified in this subsection shall be made by the director for all classified employees and all unclassified employees whose pay is subject to approval by the governor under K.S.A. 75-2935b and amendments thereto.

(b)(1) The rate at which any eligible employee is to be compensated for overtime worked shall be one and a half times the employee's regular rate of pay. This rate shall not include premium pay for holidays worked or any call-in and callback compensation paid for hours not actually worked.

(2) All employees who are eligible for overtime compensation and who were paid for overtime during the 12 months preceding the receipt of a longevity bonus payment or a quality award bonus payment shall receive an additional overtime payment to be calculated as follows:

(A) Divide the bonus pay by total hours worked in the preceding 12 months to obtain the increase in the regular rate; and

(B) multiply the increase in regular rate by the number of overtime hours paid in the preceding 12 months; then, multiply that product by one-half. The result shall be the employee's additional overtime pay.

No additional overtime pay shall be due for any overtime hours worked during the preceding 12 months for which compensatory time was given under subsection (e).

(c) Each appointing authority shall be responsible for control of overtime in the agency. Overtime, to the extent possible, shall be authorized in advance by the responsible supervisor.

(d)(1) Except as provided in paragraph (d)(3), in determining whether an employee in a position or class determined to be eligible for overtime pay has worked any overtime in a given workweek or work period, only time actually worked shall be considered.

(2) The number of hours of paid leave used in an employee's workweek or work period that, when added to the number of hours actually worked in that employee's workweek or work period, exceeds the applicable overtime threshold shall be compensated in the following manner:

(A) Given as equivalent time off as specified in subsection (f); or

(B) paid at the hourly rate of pay.

(3) Under the following conditions, an official state holiday may be counted as time worked for employees in positions that have been determined to be eligible for overtime compensation:

(A) The employee is asked to report to work in order to respond to a building, highway, or public safety emergency, as determined by the appointing authority;

(B) this work is performed outside the employee's normal work schedule for the workweek or work period that includes the official state holiday; and

(C) the appointing authority authorizes inclusion of that official state holiday in calculating time worked by the employee.

The appointing authority shall notify the director, in writing, of the nature of the emergency and the name and position number of each employee for whom the state holiday will be counted as time worked.

(e)(1)(A) In lieu of paying an eligible employee at the time-and-a-half rate for overtime worked, an agency may elect to compensate an employee for overtime worked by granting compensatory time off, at the rate of one and a half hours off for each hour of overtime worked, at some time after the workweek or work period in which the overtime was worked if the conditions of paragraph (e)(1)(B) are met.

(B) A state agency may elect to compensate an employee for overtime worked by granting compensatory time off only if an agreement or understanding has been reached before the performance of the work. Except as provided in 29 C.F.R. § 553.23(b), the agreement or understanding concerning compensatory time off shall be between the state agency and the individual employee, and a record of its existence shall be maintained for each employee. The agreement or understanding to provide compensatory time off may take the form of an express condition of employment if the employee knowingly and voluntarily agrees to it as a condition of employment and if the employee is informed that the compensatory time earned may be preserved, used, or cashed out in a manner consistent with the provisions of this regulation. Any state agency that had a regular practice of awarding compensatory time off in lieu of overtime pay before April 15, 1986 shall be deemed to have reached an agreement or understanding with any employee who has been continuously employed by that agency in one or more positions that are eligible for overtime from a date before April 15, 1986.

(continued)

(2)(A) An eligible employee shall not accrue more than 120 hours of compensatory time for overtime hours worked; except as provided in paragraph (e)(2)(B). Each eligible employee who has accrued 120 hours of compensatory time off shall, for any additional overtime hours of work, be compensated with overtime pay.

(B) Upon written request by an appointing authority, a higher maximum accumulation of compensatory time may be approved by the secretary of administration for a class or a group of eligible employees within that agency, but the maximum accumulation shall not exceed 240 hours.

(3) If an eligible employee is paid for accrued compensatory time off, this compensation shall be paid at the regular rate earned by the employee at the time the employee receives the payment.

(4)(A) Each eligible employee who has accrued compensatory time off authorized under this subsection shall, upon termination of employment or promotion, demotion, or transfer to another state agency, be paid for the unused compensatory time at a rate of compensation not less than the higher of either of the following rates:

(i) The average regular rate received by the eligible employee during the last three years of the employee's employment; or

(ii) the final regular rate received by the eligible employee.

(B) Any longevity or quality award bonus payments received during the last three years of employment shall be included in determining the average regular rate and the final regular rate specified in paragraph (4)(A).

(5)(A) Each eligible employee who has accrued compensatory time off authorized under this subsection and who has requested the use of compensatory time shall be permitted by the appointing authority to use this time within a reasonable period after making the request if the use of the compensatory time does not unduly disrupt the operations of the agency.

(B) Each employee who has accrued compensatory time and whose FLSA status is changed to exempt shall be granted the compensatory time off, paid for the entire amount, or provided a combination of both compensatory time off and pay, so that there is no remaining compensatory time balance before the employee's status changes to exempt.

(C) Each employee who has accrued compensatory time off under this subsection may be required by the appointing authority to use the compensatory time within a reasonable period after receiving notice of this requirement. The notice shall state the length of time in which a specified number of hours of compensatory time are to be used.

(f) When an employee who is eligible for overtime works additional time that could result in overtime hours, that employee's agency may give the employee equivalent time off, on an hour-for-hour basis, in the workweek or work period in which the additional time is worked if any of the following conditions is met:

(1) The agency notifies the employee of the change in the employee's normal work schedule for that workweek or work period at least five calendar days in advance of

the day in which the employee's normal work schedule is first changed.

(2) The agency has established a written policy stating that the employee may be required to take equivalent time off, on an hour-for-hour basis, in the workweek or work period in which additional time is worked.

(3) The employee requests or agrees to take equivalent time off during the workweek or work period in which additional time was worked, and the agency determines that this arrangement is not detrimental to the operations of the agency.

In any case, the equivalent time off shall be taken at a time agreeable to the agency during the workweek or work period in which the additional time is worked. **9-14-2. Registration; application; fee.** Each person operating as a livestock dealer in Kansas shall register with the Kansas animal health department on an application form approved by the commissioner. An annual fee of \$75.00 shall accompany each application for registration or renewal of registration. Upon receipt of a notice of renewal from the livestock commissioner, each person who wishes to renew the registration of a livestock brand shall submit to the livestock commissioner a renewal fee of \$45.00 before the registration period expires. ## Article 5.—CONTINUING EDUCATION

**109-5-1. Continuing education.** (a) Each applicant for certification renewal as a first responder whose certification expires on or before December 31, 2001 or whose certification expires in less than 24 months shall have earned at least eight clock hours of documented and approved continuing education during the period of certification.

(b) Each applicant for certification renewal as a first responder whose certification expires on a biennial basis shall have earned at least 16 hours of documented and approved continuing education during the biennial period.

(c) Each applicant for certification renewal as an EMT whose certification expires on or before December 31, 2001 or whose certification expires in less than 24 months shall have earned at least 14 clock hours of documented and approved continuing education during the period of certification.

(d) Each applicant for certification renewal as an EMT whose certification expires on a biennial basis shall have earned at least 28 hours of documented and approved continuing education during the biennial period.

(e) Each applicant for certification renewal as an EMT-I whose certification expires on or before December 31, 2001 or whose certification expires in less than 24 months shall have earned at least 18 clock hours of documented and approved continuing education during the period of certification.

(f) Each applicant for certification renewal as an EMT-I whose certification expires on a biennial basis shall have earned at least 36 clock hours of documented and approved continuing education during the biennial period.

(g) Each applicant for certification renewal as an EMT-D whose certification expires on or before December 31, 2001 or whose certification expires in less than 24 months shall have earned at least 18 clock hours of documented and approved continuing education during the period of certification.

(h) Each applicant for certification renewal as an EMT-D whose certification expires on a biennial basis shall have earned at least 36 clock hours of documented and approved continuing education during the biennial period.

(i) Each applicant for certification renewal as an EMT-I/EMT-D whose certification expires on or before December 31, 2001 or whose certification expires in less than 24 months shall have earned at least 22 clock hours of documented and approved continuing education during the period of certification.

(j) Each applicant for certification renewal as an EMT-I/EMT-D whose certification expires on a biennial basis shall have earned at least 44 clock hours of documented and approved continuing education during the biennial period.

(k) Each applicant for certification renewal as an MICT whose certification expires on or before December 31,

2001 or whose certification expires in less than 24 months shall have earned at least 30 clock hours of documented and approved continuing education during the period of certification.

(l) Each applicant for certification renewal as an MICT whose certification expires on a biennial basis shall have earned at least 60 clock hours of documented and approved continuing education during the biennial period.

(m) Each applicant for certification renewal as an I-C shall establish the following:

(1) That the applicant is certified as an attendant at or above the level at which the applicant is endorsed as an I-C or is a physician or professional nurse as defined by K.S.A. 65-6112 and amendments thereto;

(2) that the applicant has completed one of the following activities:

(A) Taught 45 contact hours for the calendar year that has elapsed since certification or the last renewal;

(B) obtained a minimum of three college semester hours of credit per year from an accredited college or university in a teaching degree program or in a health care specialty;

(C) attended a minimum of eight contact hours of education in adult teaching theory or methodology as approved by the board; or

(D) attended an I-C workshop approved by the board;

(3) that the applicant has current approval by the American heart association, the American red cross, or the national safety council as a CPR instructor at the professional rescuer level;

(4) that the applicant has taught a minimum of 60 hours of EMS training within the past three years; and

(5) that the applicant attended during each year of the biennial period an I-C meeting approved by the board.

(n) Each applicant for certification renewal as an I-C who is also endorsed to be the primary instructor of MICT initial courses of instruction shall verify, in addition to the items listed in subsection (m), that the applicant is currently approved by the American heart association as an instructor of advanced cardiac life support courses.

(o) Specific continuing education may be required by action of the board.

(p) One clock hour of continuing education credit shall mean a minimum of 50 minutes of classroom instruction between instructor and participant.

(q) One academic credit hour shall be equivalent to 15 clock hours for the purpose of continuing education credit. Credit for auditing an academic course shall be for actual clock hours attended during which instruction was given and shall not exceed the academic credit allowed.

(r) Acceptable forms of continuing education shall include the following:

(1) Academic medical courses, whether taken for credit or audited;

(2) seminars, workshops, or minicourses oriented to the enhancement of EMS practice, values, skills, and knowledge;

(3) programs presented by approved providers;

(4) programs presented by approved single-program providers;

(continued)

- (5) programs approved by the CECBEMS;
- (6) clinical training that meets the requirements of subsection (s); or
- (7) correspondence lessons that meet criteria established in paragraph (t)(2).

(s) All clinical training shall be in the form of pre-scheduled clinical training sessions. The training coordinator shall provide, to the student and the clinical training faculty, the clinical training objectives to be met during the training session. The clinical training faculty shall complete a clinical training evaluation form for each student.

(t)(1) Each student may be awarded one hour of continuing education credit for each correspondence lesson completed.

(2) Each correspondence training lesson shall include an examination over the material presented. The providers of the correspondence training lesson shall provide to each student the results of the examination and a certificate of completion.

(3) Each individual using one or more correspondence training lessons for the purpose of certification renewal shall keep a copy of the certificate of completion for a minimum of three years.

(4) Credit toward certification renewal requirements shall not be given for duplicate correspondence training lessons.

(u) Each attendant and I-C shall be responsible for maintaining personal records of attendance for a minimum of three years. The attendant or I-C may be requested by the board to submit these records as part of the verification process for certification renewal. Regaining expired certification.** If within two years of the date of expiration of an attendant's certification the person applies for certification pursuant to K.S.A. 65-6129 and amendments thereto, certification may be granted by the administrator or the administrator's designee to the applicant if the applicant has met the following requirements:

- (a) Made application to the board on forms provided by the administrator;
- (b) paid a fee as prescribed by K.A.R. 109-7-1; and
- (c) completed continuing education as follows:
  - (1) Each first responder shall complete at least 32 clock hours of documented and approved continuing education as described in K.A.R. 109-1-1.
  - (2) Each EMT shall complete at least 56 hours of documented and approved continuing education as described in K.A.R. 109-1-1.
  - (3) Each EMT-I shall complete at least 72 hours of documented and approved continuing education as described in K.A.R. 109-1-1.

(4) Each EMT-D shall complete at least 72 hours of documented and approved continuing education as described in K.A.R. 109-1-1.

(5) Each EMT-I who is also certified as an EMT-D shall complete at least 88 hours of documented and approved continuing education as described in K.A.R. 109-1-1.

(6) Each MICT shall complete at least 120 hours of documented and approved continuing education as described in K.A.R. 109-1-1.

(d) If the administrator or the administrator's designee grants certification before the effective date of this regulation, this certificate shall expire on December 31, 2000 and shall be automatically renewed for a period that expires on December 31, 2001. The person may apply to renew this certificate for each biennial period thereafter by paying the fee prescribed by K.A.R. 109-7-1 and by providing proof of successful completion of continuing education as prescribed by K.A.R. 109-5-1.

(e) If the administrator or the administrator's designee grants certification on or after the effective date of this regulation and before December 31, 2000, this certificate shall expire on December 31, 2000 and shall be automatically renewed for a period that expires on December 31 of the biennial period that commences on the date certification was granted. The person may apply to renew this certificate for each biennial period thereafter by paying the fee prescribed by K.A.R. 109-7-1 and by providing proof of successful completion of continuing education as prescribed by K.A.R. 109-5-1.

(f) If the administrator or the administrator's designee grants certification on or after January 1, 2001, this certificate shall expire on December 31 of the biennial period that commences on the date certification was granted. The person may apply to renew this certificate for each biennial period thereafter by paying the fee prescribed by K.A.R. 109-7-1 and by providing proof of successful completion of continuing education as prescribed by K.A.R. 109-5-1. #### Article 6.—TEMPORARY CERTIFICATION

**109-6-2. Renewal of attendant, training officer, and instructor-coordinator certificates.** (a) All applications for certification renewal shall be submitted on the original form provided by the administrator. Copies, facsimiles, electronic filings, and other reproductions shall not be accepted.

(b) If the board receives an application for renewal on or before December 31, the existing certificate shall not expire until the board has taken final action upon the renewal application or, if the board's action is unfavorable, until the last day for seeking judicial review of the board's action or a later date fixed by the reviewing court.

(c) If the board receives an insufficient renewal application, the applicant shall be notified by the board of any errors or omissions. If the applicant fails to correct the deficiencies and submit a sufficient application within 30 days of notification, the application may be considered by the board to be withdrawn.

(d) An application for renewal shall be deemed sufficient when the following conditions are met:

(1) The applicant provides in full the information requested on the form, and no additional information is required by the board to complete the processing of the application.

(2) The applicant submits a renewal fee in the correct amount. (Authorized by and implementing K.S.A. 1999 Supp. 65-6129, as amended by L. 2000, Ch. 117, § 2 and K.S.A. 65-6129b, as amended by L. 2000, Ch. 117, § 3; effective Nov. 1, 1996; amended Oct. 31, 1997; amended Nov. 12, 1999; amended, T-109-8-8-00, Aug. 8, 2000.)

**109-6-3. Attendant certification expiration and renewal.** (a) If a person received an initial attendant's certificate on or between January 1, 2000 and December 31, 2000 this certificate shall expire on December 31, 2000 and shall be automatically renewed for a period that expires on December 31, 2001. The person may apply to renew this certificate for each biennial period thereafter by paying the fee prescribed by K.A.R. 109-7-1 and by providing proof of successful completion of continuing education as prescribed by K.A.R. 109-5-1.

(b) If a person is currently certified and either received or renewed an attendant's certificate on or before December 31, 1999, one of the following requirements shall apply:

(1) The certificate shall expire on December 31, 2000 and may be renewed for a period that expires on December 31, 2001 and for each biennial period thereafter if the person meets the following conditions:

- (A) Has a residential zip code as reflected in board records with the first five numbers of 66619 or less;
- (B) pays the fee specified in K.A.R. 109-7-1; and
- (C) provides proof of successful completion of continuing education as prescribed in K.A.R. 109-5-1.

(2) The certificate shall expire on December 31, 2000 and may be renewed for a period that expires on December 31, 2002 and for each biennial period thereafter if the person meets the following conditions:

- (A) Has a residential zip code as reflected in board records with the first five numbers of 66620 or greater;
- (B) pay the fee specified in K.A.R. 109-7-1; and
- (C) provides proof of successful completion of continuing education prescribed in K.A.R. 109-5-1.

(c) If a person receives an initial attendant's certificate on or after January 1, 2001, this certificate shall expire on December 31 of the year following the date of its initial issuance and may be renewed for each biennial period thereafter if the person performs the following:

- (1) Pays the fee prescribed in K.A.R. 109-7-1; and
- (2) provides proof of successful completion of continuing education prescribed in K.A.R. 109-5-1. (Authorized by K.S.A. 1999 Supp. 65-6111; implementing K.S.A. 1999 Supp. 65-6129, as amended by L. 2000, Ch. 117, § 2; effective, T-109-8-8-00, Aug. 8, 2000.)
