**Social and Rehabilitation Services****Notice Concerning TANF Caseload  
Reduction Report**

In the Personal Responsibility and Work Opportunity Reconciliation Act of 1996 (PRWORA), Congress established work participation rates that states must meet for adults receiving Temporary Assistance for Needy Families (TANF). The PRWORA allows states to reduce their work participation rate targets if their TANF caseloads have declined for reasons other than requirements of federal law or a change in eligibility rules from those in effect in FY 1995. This reduction is known as the caseload reduction credit.

To claim a caseload reduction credit, a state must submit a Caseload Reduction Report to the U.S. Department of Health and Human Services each year that includes the following:

- A listing of, and implementation dates for, all state and federal eligibility changes made by the state since the beginning of FY 1995.
- A numerical estimate of the positive or negative impact on the TANF caseload of each eligibility change (based, as appropriate, on application denials, case closures and other analyses). (Application denials and case closures resulting from full family sanctions do not count toward the caseload reduction credit per federal regulations.)

- An overall estimate of the total net positive or negative impact on the caseload as a result of all such eligibility changes.
- An estimate of the state's caseload reduction credit.
- The number of application denials and case closures for FY 1995 and the prior fiscal year.
- The distribution of such denials and closures, by reason, for fiscal year 1995 and the prior fiscal year.
- A description of the methodology and the supporting data that was used to calculate the caseload reduction estimates.
- A certification that the state has provided the public an appropriate opportunity to comment on the estimates and methodology, considered their comments, and incorporated all net reductions resulting from federal and state eligibility changes.
- A summary of all public comments.

**Executive Order 00-09**

WHEREAS, the Kansas Bureau of Investigation and the Leavenworth County Sheriff's Department are investigating the deaths of Lawrence L. Daigle and his wife, Teresa C. Daigle; and

WHEREAS, on Sunday, August 9, 1998 at approximately 10:28 a.m., the Leavenworth County Sheriff's Department was notified of a body discovered along the north side of Dakota Drive, west of 171st Street in Leavenworth County, Kansas. A more thorough investigation of the crime scene determined a second body present, and autopsies determined that both victims had been shot numerous times; and

WHEREAS, the last known address of the victims was 1025 Wakefield, Houston, Texas, and the investigation determined the victims had extensive connections to the Wichita and Kansas City, Kansas areas. No connections have been found to the Leavenworth, Kansas area at this time; and

WHEREAS, the investigation of this double murder is continuing by the Leavenworth County Sheriff's Department and the Kansas Bureau of Investigation; and

WHEREAS, the offer of a reward will enhance the efforts of the Leavenworth County Sheriff's Department and the Kansas Bureau of Investigation in the investigation in this crime;

NOW, THEREFORE, by virtue of authority vested in me by K.S.A. 75-113, I, Bill Graves, Governor of the State of Kansas, do hereby offer a reward of five thousand dollars (\$5,000) for information leading to the arrest and conviction of the individual or individuals who committed the double murder of Lawrence L. Daigle and Teresa C. Daigle.

This document shall be filed with the Secretary of State as Executive Order 00-09, and shall become effective immediately.

## Article 10.—PUBLIC LIVESTOCK MARKETS

**9-10-33. Electronic auctions.** (a) As part of the application for an electronic auction license, each owner or operator of an electronic auction that is simulcast into the state of Kansas and at which livestock located in the state of Kansas are offered for sale shall pay a license application fee to the livestock commissioner in the amount of \$40.00. The owner or operator shall pay an annual license renewal fee of \$40.00 before June 30 of each year.

(b) The electronic auction operator shall collect from each consignor of livestock at the electronic auction a fee of \$.15 per head of livestock sold at the electronic auction if the livestock are located in the state of Kansas. The electronic auction operator shall remit these fees to the commissioner in accordance with K.S.A. 47-1011, and amendments thereto.

(c) The costs associated with issuance of the health certificate required under K.S.A. 47-1008, and amendments thereto, shall be paid by the consignor. Each of these health certificates shall meet the requirements of K.A.R. 9-10-3. (Authorized by and implementing K.S.A. 47-1001e, as amended by L. 2000, Ch. 111, §7, K.S.A. 47-1008, as amended by L. 2000, Ch. 111, §8, and K.S.A. 47-1011, as amended by L. 2000, Ch. 111, §9; effective, T-9-8-29-00, Aug. 29, 2000; effective Dec. 29, 2000.)

## Article 15.—LIVESTOCK BRANDS

**9-15-5. Brand inspection fees.** (a)(1) Each owner or seller of cattle or sheep that are in a brand inspection area shall pay a fee of \$.50 per head of cattle inspected by the livestock commissioner's brand inspectors and a fee of \$.05 per head of sheep inspected. The total minimum fee charged for each brand inspection area shall be the sum of \$20.00 plus a mileage charge per mile traveled by the brand inspector between the inspection site and the inspector's residence. The mileage charge shall be based on the schedule of charges for use of central motor pool vehicles established under K.S.A. 75-4607, and amendments thereto.

(2) If one or more of the livestock commissioner's brand inspectors provide on-site inspection of cattle or sheep that are not in a brand inspection area or a public livestock market, the owner or seller shall pay the fee established under paragraph (a)(1).

(b) The owner or seller shall pay the fee established under subsection (a) to the brand inspector at the conclusion of the inspection. (Authorized by K.S.A. 47-426, K.S.A. 47-436, and K.S.A. 47-437, as amended by L. 2000, Ch. 111, §5; implementing K.S.A. 47-417a and K.S.A. 47-437, as amended by L. 2000, Ch. 111, §5; effective, T-9-8-29-00, Aug. 29, 2000; effective Dec. 29, 2000.)

RegulationsArticle 2.—AMBULANCE SERVICES; PERMITS  
AND REGULATIONS

**109-2-2.** Application for ambulance service permit and ambulance vehicle license; permit renewal and license renewal. (a) (1) An applicant may apply for only one ambulance service permit for each ambulance service that the applicant seeks to operate. Each applicant shall indicate the class of service for the permit requested.

(2) An applicant may apply for only one ambulance vehicle license for each ambulance that the applicant seeks to operate. Each applicant shall indicate the type of ambulance for the license requested.

(b) All ambulance service permit and ambulance vehicle license application and renewal forms shall be submitted on the original forms provided by the administrator. Copies, facsimiles, electronic filings, and other reproductions shall not be accepted.

(c) (1) Except as provided in paragraph (c) (2), each ambulance service permit and ambulance vehicle license shall expire on April 30 of each year and may be renewed annually in accordance with this regulation.

(2) If the board receives an application for renewal of an ambulance service permit on or before April 30, the existing ambulance service permit shall not expire until the board has taken final action upon the renewal application or, if the board's action is unfavorable, until the last day for seeking judicial review of the board's action or a later date fixed by the reviewing court.

(d) Each application for renewal of an ambulance service permit and for renewal of an ambulance vehicle license shall be provided to the administrator no later than 30 days before expiration of the permit and license.

(e) If the board receives an insufficient application or renewal, the applicant or operator shall be notified by the board of any errors or omissions. If the applicant or operator fails to correct the deficiencies and submit a sufficient application within 30 days from the date of written notification, the application may be considered by the board as withdrawn.

(f) An application for ambulance service permit or permit renewal shall be deemed sufficient when both of the following conditions are met:

(1) The applicant or operator completes all forms provided with the application for ambulance service permit or permit renewal, and no additional information is required by the board to complete the processing of the application.

(2) The applicant or operator submits payment of the fee in the correct amount for the ambulance service permit or permit renewal.

(g) An application for ambulance vehicle license or license renewal shall be deemed sufficient when both of the following conditions are met:

(1) The applicant or operator completes all forms provided with the application for an ambulance vehicle license or license renewal, and no additional information is required by the board to complete the processing of the application.

(2) The applicant or operator submits payment of the fee in the correct amount for each ambulance vehicle. Jackson, Topeka, to consider the adoption of proposed changes in nine existing rules and regulations relating to duplicate licenses, inactive licenses, definitions for continuing nursing education, requirements for continuing nursing education for renewal, standards for intravenous fluid therapy course and fees collected by the board for licenses, certifications, and authorizations for renewals and initial applications.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed amended rules and regulations. All interested parties may submit written comments prior to the hearing to the executive administrator of the Board of Nursing at the address above. All interested parties will be given a reasonable opportunity to present their views, orally or in writing, concerning the adoption of the proposed amended regulations during the hearing. In order to give all persons an opportunity to present their views, it may be necessary to request each participant to limit any oral presentations to five minutes. A summary of the proposed regulations and the economic impact follows.

**K.A.R. 60-4-101. Payment of fees.** (Professional Nurses and Practical Nurses)

**K.A.R. 60-8-101. Payment of fees.** (Mental Health Technicians)

**K.A.R. 60-11-119. Payment of fees.** (Advance Registered Nurse Practitioners)

**K.A.R. 60-13-101. Payment of fees.** (Registered Nurse Anesthetists)

These four proposed amended rules and regulations deal entirely with fees associated with: (1) renewals, (2) application for initial license, (3) application for exempt license, (4) application for certifications, and (5) application for authorizations that are collected by the Board of Nursing in the professions of professional nurse, practical nurse, mental health technicians, advance registered nurse practitioner and registered nurse anesthetist.

**K.A.R. 60-7-102. Duplicate of license.** This regulation pertains to when a license has been lost or stolen. The board, upon payment of a fee, may issue a duplicate. This regulation, if adopted, will allow the board to waive the fee if the license was stolen.

**K.A.R. 60-7-108. Inactive license.** This regulation pertains to inactive licenses for licensed mental health technicians and clarifies the language used in the regulation. There is no change in the content of the regulation.

**K.A.R. 60-9-105. Definitions.** This regulation pertains to definitions for continuing education for nurses and clarifies the language used in the regulation. This regulation, if adopted, gives definition to distance learning and individual offering approval (IOA).

**K.A.R. 60-9-106. Continuing nursing education for license renewal.** This regulation pertains to continuing

nursing education for license renewal. This regulation, if adopted, will eliminate the maximum 15 contact hours of independent study in a renewal period, which will allow the nurse to have a total of 30 contact hours that are independent study.

**K.A.R. 60-16-104. Standards for course; competency examination.** This regulation pertains to requirements of the intravenous fluid therapy course for licensed practical nurses. This regulation, if adopted, will remove the one-year clinical experience requirement for the enrollment in an intravenous fluid therapy course. There is no economic impact anticipated by the State Board of Nursing, other governmental entities, private business or individuals.

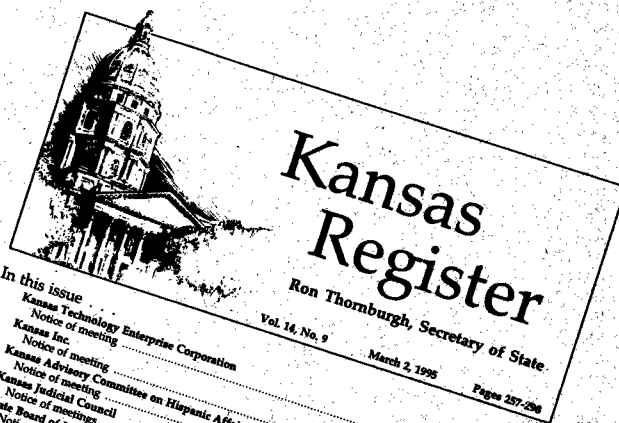
