## Wildlife and Parks Commission

Notice of Hearing on Proposed  
Administrative Regulations

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Thursday, April 19, at the Tonganoxie High School, 404 E. 24-40 Highway, Tonganoxie, to consider the approval and adoption of proposed exempt regulations of the Kansas Department of Wildlife and Parks.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 1:30 p.m. April 19 at the same location. The meeting will recess at 5 p.m., then resume at 7 p.m. at the same location for the regulatory hearing. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. April 20 at the same location.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Sheila Kemmis, commission secretary, at (620) 672-5911. Persons with a hearing impairment may call the TDD service at 1-800-766-3777 to request special accommodations.

This 30-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on proposed exempt regulations.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, Suite 502, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

In addition to the administrative regulations for which public notice has previously been published, the exempt regulations that will be heard during the regulatory hearing portion of the meeting are as follows:

**K.A.R. 115-25-5.** This proposed exempt regulation establishes hunting unit boundaries, bag limits, application periods and season dates for the 2001 fall turkey season. The proposed regulation combines archery and firearm seasons and would allow either type of equipment to be used. The regulation also would divide previous unit 2 into two units, creating a new unit 3 in southcentral Kansas, and it would authorize second turkey game tags in unit 2.

**Economic Impact Summary:** It is anticipated that a total of 5,200 fall turkey hunting permits of all types will be

issued, which would create \$86,000 in revenue. The department estimates over 20,000 days of hunting activity would occur, thus providing economic benefit to businesses providing goods and services.

**K.A.R. 115-25-7.** This proposed exempt regulation establishes hunting units, bag limits, application periods and season dates for the 2001 firearm, muzzleloader and archery antelope seasons. The hunting units have been increased in size, and a muzzleloader season has been added. Unlimited archery permits are proposed, and a total of 140 firearms permits and 38 muzzleloader permits are proposed.

**Economic Impact Summary:** It is anticipated that 328 antelope permits may be authorized, which would generate \$10,000 in revenue. Approximately 775 days of hunting activity may occur, thus providing economic benefit to businesses providing goods and services.

**K.A.R. 115-25-8.** This proposed exempt regulation establishes hunting units, bag limits, application periods and season dates for the 2001-2002 elk seasons. The regulation would allow elk permits to be used during muzzleloader, archery or firearm season. However, only eight antlerless-only elk permits would be valid for use at a single time on Fort Riley. In addition, unlimited hunt-on-your-own-land antlerless-only elk permits would be authorized off Fort Riley.

**Economic Impact Summary:** It is estimated that a total of 55 elk permits may be authorized. Estimated revenue if these permits are issued would be \$4,100. Approximately 500 days of hunting activity may occur, thus providing economic benefit to businesses providing goods and services.

**K.A.R. 115-25-9.** This proposed exempt regulation establishes hunting bag limits, application periods and season dates for the 2001 firearm and archery deer seasons. Among other proposed changes, the regulation would issue permits separately for white-tailed deer and mule deer; allow all white-tailed permit to be purchased "over-the-counter" rather than by application; provide up to four white-tailed antlerless-only game tags without first purchasing a regular permit; and allow individuals to obtain no more than one permit for an antlered white-tailed deer and one permit for an antlered mule deer.

**Economic Impact Summary:** Because white-tailed permits and game tags would be more available, it is impossible to accurately estimate total revenue. However, if antlerless-only permit sales decrease to 40 percent of previous sales, game tag sales increase by one-third, and other permit sales remain relatively stable, total revenue from deer permits may remain relatively constant at approximately \$3,100,000. Approximately 700,000 days of hunting activity by 100,000 hunters are anticipated, which, based on survey estimates, may generate \$51 million of economic benefit to businesses providing goods and services.

**Attorney General****Opinion 2001-4**

**Waters and Watercourses—Water Districts; Rural Water Districts; Board of Directors; Elections; Mail Ballot.** Gary H. Hanson, Counsel, Rural Water District No. 5, Topeka, February 6, 2001.

Members of a board of directors of a rural water district may be elected only at an annual meeting of landowners held upon a date between January 1 and April 1 of each year. The statutes do not authorize use of a mail ballot election. Cited herein: K.S.A. 82a-612; 82a-615; 82a-617; 82a-626. RDS

**Opinion 2001-5**

**Elections—Recall of Elected Officials—Recall of Local Officers; Petitions for Recall of Local Officers; Circulation; Signatures; Filing, When; When Improperly Filed.** Senator Greta H. Goodwin, Winfield, February 6, 2001.

K.S.A. 25-4323 precludes filing a recall petition during the first 120 days of a term of office of a county commissioner. A new term of office is deemed to begin on the second Monday of January following the reelection of a person serving as county commissioner. Only those persons who are registered electors of the election district served by the county commissioner sought to be recalled may be designated as sponsors of a petition seeking the commissioner's recall from office. It is not required that the sponsor have cast a ballot in the last preceding general election. **Notice of 2001 Kansas Mortgage Savers Program**

Sedgwick County, Kansas, in cooperation with the Kansas Department of Commerce and Housing and other political subdivisions of the State of Kansas, announces the 2001 Kansas Mortgage Savers Program, a Qualified Mortgage Credit Certificate Program. Section 25 of the Internal Revenue Code of 1986, as amended, authorizes issuers of qualified mortgage bonds, such as Sedgwick County, to elect to issue Mortgage Credit Certificates (MCCs) in lieu of qualified mortgage bonds. MCCs entitle qualifying individuals to a credit against the individual's federal income tax. The amount of the credit is determined by multiplying the certificate credit rate by the amount of interest paid or accrued during each taxpayer's taxable year on the mortgage loan for the taxpayer's "principal residence." In order for an individual to claim the credit provided by Section 25(a), the MCC must be a "qualified mortgage credit certificate" issued pursuant a "qualified mortgage credit certificate." The following criteria/requirements must be met:

**Principal Residence Requirement**

The homebuyer(s) must use the residence as his or her principal residence within a reasonable time (60 days) after the MCC is issued. The MCC holder must notify the issuer of the MCC if the residence ceases to be his or her principal residence.

**New Mortgage Requirements**

An MCC cannot be issued in conjunction with the acquisition, replacement or refinancing of an existing mortgage. However, a certificate can be used in conjunction with the replacement of construction period loans, bridge loans, or other temporary initial financing with a term of 24 months or less.

**Three-Year No Prior Homeownership Requirement**

The homebuyer(s) cannot have had any present ownership interest in a principal residence at any time during the preceding three years ending on the date the MCC is issued. This three-year, first-time homebuyer requirement does not have to be met if the residence for which a mortgage loan application is being made is located in a federally-designated targeted area. A targeted area is a particular area in the state determined or approved by the federal government that will receive special consideration to provide an added stimulus to housing in that area.

**Purchase Price Requirements**

There are maximum allowable purchase prices for residences assisted by MCCs that vary based upon location, whether the residence being purchased is new or existing and whether the home is in a targeted area. The maximum purchase prices at this time are:

Persons or families with family incomes not in excess of 75 percent of the above income limits will receive a higher certificate credit rate. Income limits and certificate credit rates are subject to change in accordance with federal guidelines.

**Methods by Which Certificates Are Issued**

Prior to the mortgage loan closing, an application and supporting affidavits and documents must be submitted to Ranson Housing Compliance, L.L.C., as compliance agent for the MCC Program. The compliance agent will review these documents and either reject or accept the application. At the mortgage loan closing a closing affidavit is prepared and sent with supporting documents to the compliance agent, and if all documents are acceptable a Mortgage Credit Certificate is issued by Sedgwick County that will allow homebuyers to claim the credit.

Sedgwick County will begin accepting applications for MCCs after April 1, 2001. In order to comply with federal requirements, Mortgage Credit Certificates may not be issued prior to the date that is at least 90 days after the date of publication of this notice (approximately June 5, 2001.)

HOUSE BILL No. 2056

AN ACT making and concerning appropriations for the fiscal years ending June 30, 2001, and June 30, 2002, for the legislative coordinating council; authorizing certain transfers, imposing certain restrictions and limitations, and directing or authorizing certain receipts, disbursements and acts incidental to the foregoing.

Be it enacted by the Legislature of the State of Kansas:

Section 1. (a) For the fiscal years ending June 30, 2001, and June 30, 2002, appropriations are hereby made, restrictions and limitations are

hereby imposed, and transfers, receipts, disbursements and acts incidental to the foregoing are hereby directed or authorized as provided in this act.

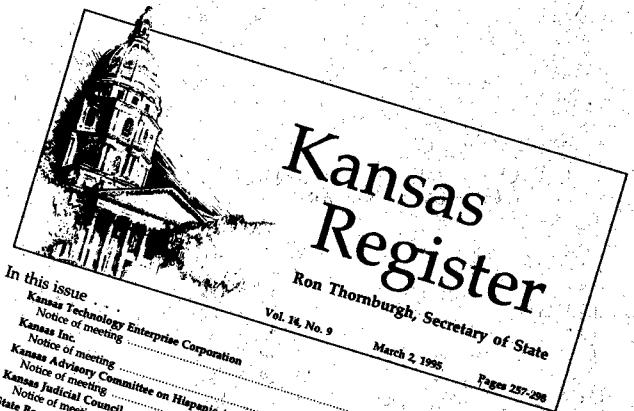
