Notice of Available Grant Funding

The Kansas Council on Developmental Disabilities (KCDD), in a joint project with the SRS Medicaid Buy-In Project, announces the availability of federal funds to be invested in state plan activities outlined below. Projects listed in the notice may be approved for grants for up to one year. Recipients are required to provide a 25 percent nonfederal match for this project. In-kind contributions may be included as part of the 25 percent match.

The KCDD is mandated by the Developmental Disabilities Assistance and Bill of Rights Act to “promote, through systematic change, capacity building and advocacy, a consumer and family-centered, comprehensive system and a coordinated array of services, supports and other assistance for individuals with developmental disabilities and their families.”

**Call For Investment #1—Waiver Review/
Employment Barriers**

Description: People with developmental disabilities have greater difficulty in finding employment compared to the general population. While a variety of employment options exist across the state for the persons with developmental disabilities, many leave much to be desired. The history of developing employment for people with developmental disabilities consists of predominately setting up programs and hoping for the best. Whether it is sheltered work, day activity or supported employment, the emphasis has been on getting someone into a program. Many people with developmental disabilities are still funneled automatically into segregated employment settings based solely upon their diagnosis or the service professional’s perception of capacity.

The specific objective is to research and identify the policy barriers, which under the existing Medicaid waivers and the Medicaid state plan keep people with developmental disabilities out of competitive, integrated employment? What Medicaid policy disincentives deter providers from helping people access integrated employment? What Medicaid policy disincentives deter providers from helping people access integrated employment opportunities? What practices of providers indicate the need for clarification of existing Medicaid policies that do encourage competitive, integrated employment? And, what conflicts between Medicaid policies and policies under the Rehabilitation Act-funded programs and the Workforce Investment Act-funded programs inhibit competitive, integrated employment for people with developmental disabilities?

A total of \$50,000 is available for one project. Proposals are due July 17.

The grant award is expected to be announced August 7. The project implementation period will be September 1, 2001 through August 31, 2002.

The bond will be payable solely from amounts received from the respective borrower, the obligation of which will be sufficient to pay the principal of, interest and redemption premium, if any, on the bond when it becomes due.

Administrative Regulations

A public hearing will be conducted at 9 a.m. Friday, August 17, in the third floor conference room, Kansas Insurance Department, 420 S.W. 9th, Topeka, to consider the adoption of proposed changes in an existing rule and regulation.

This 60-day notice of the public hearing shall constitute a public comment period for purpose of receiving written public comments on the proposed rule and regulation. All interested parties may submit written comments prior to the hearing to Rebecca Sanders, Kansas Insurance Department, 420 S.W. 9th, Topeka, 66612-1678. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulation during the hearing.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulation and economic impact statement in an accessible format. Copies of the regulation and the economic impact statement may be obtained by contacting Rebecca Sanders. A summary of proposed regulation and its economic impact follows.

K.A.R. 40-1-37. Insurance companies; audited financial reports; filing requirements. This regulation governs annual audited financial reports. This regulation adopted the National Association of Insurance Commissioners model regulation by reference with few exceptions. The National Association of Insurance Commissioners made significant changes to this model regulation in 1998, and the proposed changes reflect the changes made to the model regulation. The changes were made as result of an ongoing project by the National Association of Insurance Commissioners to standardize and modernize the NAIC Accounting Practices and Procedures Manual, which also is known in the industry as the Codification Project.

There are three primary changes to the model regulation to address technical issues. The first change eliminates the requirement that independent CPAs include in their statutory audit reports "any other notes required by Generally Accepted Accounting Principles" (GAAP) that may not be required to be disclosed in the notes to the annual statement. This disclosure is no longer required because the Codification Project has addressed all GAAP-like disclosures in the individual Statements of Statutory Accounting Principles (SSAPs) that comprise the Codification Project.

The second change was to add reference to the Accounting Practices and Procedures Manual to the model regulation. The purpose of the change was to ensure that all of the disclosures contained in the Codification Project, which will be renamed the Accounting Practices and Procedures Manual, are included in the auditor's reports. This change eliminates the need to constantly update the

model regulation for future changes to Codification disclosures and footnotes.

The third change dealt with a specific requirement contained in the current model to disclose "a summary of the ownership and relationships of the insurer and all affiliated companies." This requirement was removed from the model regulation because the disclosure is required in SSAP #1. If it were left in the model, then the reader might be confused as to why the many other Codification disclosures were not also referred to in the model regulation. Like the second change, this also eliminates the need to constantly update the model regulation for future changes to Codification disclosure and footnotes.

There is no fiscal impact as a result of these changes. The insurance industry commissioned a study of the significant elements of the Codification, which indicated the implementation of the new accounting and reporting requirements, was not significant in the aggregate.

The Kansas exceptions to the model regulation reflect specific reference to Kansas laws.

This facility is a mechanical treatment plant consisting of primary clarification, packed tower, activated sludge basin and final clarification. Sludge is digested in anaerobic digesters. The facility receives domestic wastewater from residential and commercial areas and industrial wastewater from local manufacturers.

The proposed action is to modify the current permit to update the current ammonia limits pursuant to a consent order 00-E-0160 and to add new limits and a schedule of compliance for a new outfall directly to the Missouri River. The proposed permit includes limits for biochemical oxygen demand, total suspended solids, ammonia and pH. Monitoring for fecal coliform, total phosphorus, total Kjeldahl nitrogen, nitrate, nitrite and effluent flow also will be required. The permittee is required to conduct chronic whole effluent toxicity and heavy metals testing annually, and a priority pollutant scan will be required once during the life of the permit.

The Kansas Department of Health and Environment has prepared a draft National Pollutant Discharge Elimination System permit for the Johnson County Nelson Complex Wastewater Treatment Facility to discharge treated domestic wastewater into the Kansas River via Turkey Creek.

The proposed permit is based upon an average discharge flow of 15.0 MGD into Turkey Creek. This wastewater treatment facility is a combination of two mechanical treatment plants: Mission Township M.S.D. #1 and Turkey Creek M.S.D. #1. These two facilities are now known as the Myron Nelson Complex.

The Mission Township M.S.D. #1 facility consists of bar screening and grit removal; primary, intermediate and final clarification; two-stage trickling filters; and sludge thickening and holding tanks. The collection system also contains three extraneous flow/holding basins with physical/chemical treatment. The Turkey Creek M.S.D. #1 facility consists of bar screening and grit removal, primary and final clarification, trickling filters, sludge thickening and holding tanks and one extraneous flow/holding basin with physical/chemical treatment located near the Turkey Creek plant. Sludge from the facility is hauled to a municipal solid waste landfill for disposal. An ultraviolet disinfection system has been installed on the combined outfall to replace the chlorination/dechlorination disinfection system previously used at the facility.

The facilities receive domestic wastewater from the residential and commercial areas and industrial wastewater from local manufacturers. The proposed permit includes limits for carbonaceous biochemical oxygen demand, total suspended solids, ammonia, fecal coliform, dissolved oxygen, chronic whole effluent toxicity and pH. Monitoring for total phosphorus, total Kjeldahl nitrogen, nitrate, nitrite, temperature, total residual chlorine, effluent flow and priority pollutants also will be required. In addition, the permittee is required to monitor the receiving stream above and below the plant discharge point and also discharges from the extraneous flow/holding basin.

Intoxicating Liquors and Beverages—Licensure and Regulation of Sale of Liquor by the Drink—Qualifications for License; Limited Liability Companies. Corporations—Limited Liability Companies—Nature of Business Permitted; Ability to Obtain License to Sell Liquor by the Drink. Robert Longino, Director, Division of Alcoholic Beverage Control, Kansas Department of Revenue, Topeka, April 23, 2001.

A limited liability company that otherwise qualifies is not precluded from holding a club or drinking establishment license. Elections—Advance Voting—Advance Voting; Unlawful Acts and Penalties; Applications; Ballots; Person or Group Engaged in Distribution; Delivery to County Election Officer; Constitutionality. Representative Gwen Welshimer, 88th District, Wichita, April 23, 2001.

Pursuant to K.S.A. 25-1122 and 25-1128, signed advance voting applications are to be mailed, faxed or otherwise delivered to the county election officer by any person or group engaged in the distribution of such applications within 48 hours after the application is signed by the voter. The provisions serve important regulatory interests of the state, the burden of which falls equally on all persons or groups engaged in distributing advance voting applications. Further, neither the United States nor the Kansas Constitution confers upon the voters the right to select how and by whom voting materials may be delivered to proper election officers. The ability of Kansas voters to select a person or group to deliver advance voting applications to the county election officer remains subject to statutory provisions enacted by the Kansas Legislature. The provisions adopted during the 2000 legislative session resulting in amendments to K.S.A. 25-1122 and 25-1128 do not violate the associational rights of Kansas voters. Based upon the information provided to this office, K.S.A. 14-1302 does not prohibit the Abilene city manager from appointing a former commissioner to the office of city attorney prior to the expiration of two years from the date the former commissioner left office. Prison Health Services, a private entity that contracts with the Kansas Department of Corrections to provide medical and mental health services for inmates, is not a public agency. Personal and Real Property—Public Buildings; Accessibility Standards for Public Buildings—Accessibility Standards for Public Buildings or Facilities; Enforcement of Act; County Attorney's Office. Representative Richard Alldritt, 105th District, Harper, May 7, 2001.

A county attorney's office is required by Kansas and federal law to comply with the accessibility standards established under the Americans with Disabilities Act (ADA). The ADA does not necessarily require that the office itself be physically accessible to individuals with disabilities. In determining whether the office is in compliance with Title II of the ADA, its services, programs and activities must be viewed in their entirety. The office will not be required to make modifications in its services, programs and activities if the modifications would fundamentally alter the services, programs and activities or would result in undue financial and administrative burdens upon the office. In addition, alterations of the physical aspects of the office may not be required if the office is located in an historic site. The ADA is enforced by appropriate federal agencies. In determining compliance with the Kansas Architectural Accessibility Standards Act, primary enforcement authority with regard to any local government facility where funds of a county are utilized is placed upon the county or an agency designated by the county. A board of county commissioners may exercise its home rule power to abolish its county planning commission created pursuant to K.S.A. 12-741 et seq. A board of county commissioners should follow the same procedure to repeal its comprehensive plan as is required to adopt and amend a comprehensive plan. However, if a board of county commissioners has abolished its planning commission and no longer intends to use the provisions of K.S.A. 12-741 et seq., it is no longer bound by those statutory requirements and, therefore, may use its power of home rule to repeal its county's comprehensive plan. Constitution of the State of Kansas—Corporations—Cities; Powers of Home Rule; Charter Ordinance; Municipal Housing Authority. Linda P. Jeffrey, Topeka City Attorney, Topeka, May 21, 2001.

The Topeka Housing Authority is the agent of the City of Topeka pursuant to the Municipal Housing Law. However, because the city has no control or right to control the actions of the Topeka Housing Authority, the city should not be held liable on a theory of *respondeat superior* for tortious conduct committed by the Topeka Housing Authority. Pursuant to the Kansas Tort Claims Act, the Topeka Housing Authority is liable for the negligence of its employees while acting within the scope of their employment under circumstances where the Topeka Housing Authority, if a private person, would be liable under state law. Finally, the Municipal Housing Law is not an enactment uniformly applicable to all cities and, therefore, a city may exempt itself from the Municipal Housing Law's provisions in accordance with Article 12, Section 5 of the Kansas Constitution. A person who was serving in one of the member positions on the Board of Directors of the Rawlins County Health Center subject to election in November of 2000 will continue to serve in that member position until a successor is appointed or elected and qualified. If there was no person to hold over in the member position, a vacancy occurs. There is no authority for holding a special election to elect persons to fill vacancies in positions on the board of directors for the Rawlins County Health Center. Rather than leave the member positions on the board of directors vacant, the Rawlins County Commission is authorized to appoint persons to serve in the member positions that should have been filled through election in November, 2000.
