**Behavioral Sciences Regulatory Board****Notice of Hearing on Proposed  
Administrative Regulations**

The Behavioral Sciences Regulatory Board will conduct a public hearing from 9 to 11 a.m. Wednesday, February 6, in the board conference room at 712 S. Kansas Ave., Topeka, to consider adopting proposed amendments to permanent rules and regulations for licensed social workers.

This 60-day notice of the public hearing constitutes a public comment period for purposes of receiving written public comments on the proposed amendments. All interested parties may submit written comments prior to the hearing to Phyllis Gilmore, Executive Director, Behavioral Sciences Regulatory Board, 712 S. Kansas Ave., Topeka, 66603-3817. All interested parties will be given a reasonable opportunity to present their views orally during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Phyllis Gilmore at (785) 296-3240 or the Kansas Relay Center at 1-800-766-3777. There is designated accessible parking on Kansas Avenue, and the front entrance of the board office also is accessible.

A copy of the full text of each regulation and the economic impact statement may be reviewed or obtained at

the board office. The regulations and economic impact statements also are available on the board's Web site at [www.ink.org/public/bsrb](http://www.ink.org/public/bsrb). The following is a summary of the proposed amendments and economic statement. The board does not have a less costly or less intrusive method for achieving the stated purpose of each regulation.

**K.A.R. 102-2-3** is the fee section of the social work regulations. The amendment creates the fee schedule for the implementation of the optional pre-approval process for providers and programs for continuing education units.

**Economic Impact:** If there were initially 25 companies or institutions requesting pre-approval as a provider at a rate of \$100 per applicant, the fiscal impact would be positive to this agency with an increase in revenues of \$2,500. There will be staff time in producing forms, reviewing each application, ongoing evaluation of the providers, and oversight by the executive director of the program. There would be no economic impact to licensees or other governmental agencies, except those who apply to be providers. The single-program provider fee of \$50 would cover the same activities as above.

**K.A.R. 102-2-4b** is the regulation for approval of continuing education providers and single programs for social work. The amendment is the implementation of the request made from the social work community regarding returning to an optional pre-approval process for continuing education units.

**Economic Impact:** There is no impact to the Behavioral Sciences Regulatory Board, licensees, the public or any other governmental agency except as stated above in the accompanying fee regulation.

Proposals will be issued upon request to all prospective bidders who have been prequalified by the Kansas Department of Transportation on the basis of financial condition, available construction equipment and experience. Also, a statement of unearned contracts (Form No. 284) must be filed. There will be no discrimination against anyone because of race, age, religion, color, sex, handicap or national origin in the award of contracts.

Each bidder shall file a sworn statement executed by or on behalf of the person, firm, association or corporation submitting the bid, certifying that such person, firm, association or corporation has not, either directly or indirectly, entered into any agreement, participated in any collusion, or otherwise taken any action in restraint of free competitive bidding in connection with the submitted bid. This sworn statement shall be in the form of an affidavit executed and sworn to by the bidder before a person who is authorized by the laws of the state to administer oaths. The required form of affidavit will be provided by the state to each prospective bidder. Failure to submit the sworn statement as part of the bid approval package will make the bid nonresponsive and not eligible for award consideration.

Plans and specifications for the projects may be examined at the office of the respective county clerk or at the KDOT district office responsible for the work.

#### Notice of Commencement of Negotiations for Architectural Services

Notice is hereby given of the commencement of negotiations for architectural services for the \$18,720,000/60,900 gsf Food Safety and Security Research Facility (FSS) to be located immediately north of the Veterinary Medicine Complex, on an undeveloped property, of the main campus of Kansas State University. The FSS project has been submitted to the Legislature for approval in the upcoming session. Selection of the A/E team will be made in advance of the final action by the Legislature. Approval of the project is not guaranteed, and an element of risk does exist. Concurrence of the Joint Committee on State Building Construction to begin the selection process has been secured. Requests for proposals for land surveys and subsurface investigations are being prepared for issuance through the normal State of Kansas procedures.

Research components included in the FSS complex include, but are not limited to, pre- and post-harvest food safety, animal disease (including diagnostics, detection and treatment), crop plant resistance to disease and pests, and countermeasures for biological and chemical agents. The major design concept for the facility is the need for biosecurity, which will enable investigation of infectious diseases and provide for safe handling of biotechnology products. The Kansas Department of Health and Environment is announcing its intent to issue an air quality construction permit to Great Plains Power for installation of a proposed electrical generation facility. The proposed facility is to be located 1.5 miles northeast of the City of Edgerton. The proposed construction permit authorizes Great Plains Power to install and operate four simple cycle-combustion turbine generators, four gas preheaters, four evaporative coolers, one 675,000 gallon fuel oil storage tank, one 675,000 gallon water storage tank, a carbon dioxide fire protection system and necessary ancillary equipment. The proposed plant is to have a nominal electric generating capacity of 320 megawatts.

The proposed permit is to be issued in accordance with the provisions of K.A.R. 28-19-17, Prevention of Significant Deterioration (PSD), which adopt the federal standards, procedures and requirements of 40 CFR 52.21 by reference. These air quality regulations apply to major stationary emission sources located in areas designated as "attainment" under the federal Clean Air Act (CAA). Attainment areas are areas where the air quality meets or

is better than the national ambient air quality standards (NAAQS).

The PSD regulations require evaluation of emission reduction techniques to identify the best available control technology (BACT) for each pollutant for which the emission rate exceeds the PSD significant level. The purpose of BACT is to effect the maximum degree of reduction achievable, taking into account energy, environmental and economic impacts for each pollutant under review. Evaluation of the estimated emissions for the proposed Great Plains Power facility indicates that the emission rate of oxides of nitrogen, sulfur dioxide, carbon monoxide, particulate matter and sulfuric acid mist all exceed the significance levels. Great Plains Power conducted the required BACT analyses. The department has reviewed Great Plains Power's BACT analyses and concurs with its findings that dry low NOx burners, good combustion practices, use of natural gas and low (0.05% by weight) sulfur No. 2 fuel oil is the BACT for these turbines as pollution control.

The PSD regulations also require an evaluation of the impacts, if any, that emissions from the proposed modifications may have on the ambient air quality, visibility, vegetation and soils. Great Plains Power has conducted the required analyses in accordance with methods approved by the United States Environmental Protection Agency. The results of the analyses conclude that there should be no significant impacts on the ambient air quality, visibility, local vegetation or soils.

A public comment period has been established until December 31 to allow citizens the opportunity to express any concerns or comments they may have about this permitting action. The Kansas Department of Agriculture will conduct a public hearing at 9:30 a.m. Monday, February 11, on the fourth floor of the Kansas Department of Agriculture, 901 S.W. 9th, Topeka, to consider the permanent adoption of K.A.R. 4-25-2 through K.A.R. 4-25-18 governing public grain warehouses licensed by the State of Kansas. In addition, the hearing will cover the proposed revocation of the following regulations: 25-1-3; 25-1-4; 25-1-5; 25-1-6; 25-1-12; 25-1-15; 25-1-19; 25-1-20; 25-1-21; 25-1-22; 25-1-23; 25-1-24; 25-1-25; 25-1-26; 25-1-27; 25-1-28; 25-2-4; 25-3-2; 25-3-3; 25-3-4; 25-3-5; 25-3-6; 25-3-8; 25-3-10; 25-3-11; 25-3-12; 25-3-13; 25-3-15; 25-3-16; 25-3-17; 25-4-4; and 25-5-1. Essentially, the content of these regulations is being re-located in Department of Agriculture regulations.

The majority of the proposals conform the language of the regulations to a style consistent with other state agencies as required by the Kansas Department of Administration. Substantive changes to the regulations include:

(1) K.A.R. 4-25-2 to clarify what records should be kept for six years by a public warehouseman;

(2) K.A.R. 4-25-12 to require the composition of financial statements and to prohibit deferred income taxes or residential property from being designated a liquid asset.

(3) K.A.R. 4-25-13 to allow the use of an appraisal under certain constraints to qualify for the net worth requirements.

(4) K.A.R. 4-25-14 to identify the information required by the secretary when a successor warehouse or business is involved;

(5) K.A.R. 4-25-15 to calculate the beginning and end of the 12 month period for the statutory "annual" audit requirement; and

(6) K.A.R. 4-25-16 to clarify the nature of fees for department audits when conditional space is licensed, or storage space is added to the licensed capacity of a public warehouse.

All changes to the regulations are identified in greater detail in the economic impact statement. To summarize the economic impact statement, the agency does not anticipate an economic impact other than the cost to a public warehouseman to familiarize himself with the changes. Depositors of grain in a public warehouse should benefit from the changes because the changes clarify the requirements and provide additional safeguards for the storage of grain in state licensed warehouses.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the Secretary of Agriculture, attention Derenda J. Mitchell, 109 S.W. 9th, 4th Floor, Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and

may request the proposed regulations and economic impact statement in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Leslie Garner at (785) 296-4623 or fax (785) 368-6668. RegulationsArticle 1.—EXAMINATION AND  
REGISTRATION

86-1-10. **Approval of courses of instruction; procedure.** (a) Definitions. (1) "School" means an entity that is eligible under subsection (g) of K.S.A. 58-3046a, and amendments thereto, to offer courses approved by the commission.

(2) "Cosponsor" means an entity that is not eligible under subsection (g) of K.S.A. 58-3046a, and amendments thereto, to offer courses approved by the commission.

(b) Request for course approval. To obtain commission approval of a course of education required by K.S.A. 58-3046a, and amendments thereto, each school shall meet the following conditions:

(1) Notify the commission of the name, address, and telephone number of the coordinator who will supervise the course; and

(2) submit all information required by the commission for course and instructor approval at least 45 days before the first scheduled class session. The information shall include the following:

(A) A completed application for course registration on a form that has been obtained from the commission;

(B) an application for real estate instructor, completed in accordance with subsection (g) of this regulation;

(C) the procedure for maintenance of attendance records;

(D) the proposed dates, times, and locations of the course offering;

(E) the total amount of the attendance fee for the course;

(F) the total number of class sessions;

(G) the time spent per session;

(H) the total number of hours in the course; and

(I) the course objectives and a detailed course outline.

(c) Preliminary notification of approval or disapproval. Within 15 working days after the commission receives the request for approval, the school shall be notified by the commission, in writing, of the commission's decision to approve or disapprove the course.

(1) In each notice of approval, the number of hours of credit to be given for attending the course shall be stipulated by the commission.

(2) If the commission requires additional time to reach a decision, the school shall be notified by the commission, in writing, of the following:

(A) The fact that the course is under review; and

(B) the date by which the commission expects to complete its review.

(d) The school shall remit the course fee prescribed by K.A.R. 86-1-5 if the commission notifies the school of tentative approval of the course. The course shall not receive final approval from the commission until the commission receives the course fee.

(e) Changes. Each school shall notify the commission, in writing, at least 15 days before a significant change in a course approved by the commission.

(1) A significant change shall include a change in any of the following:

(A) The coordinator;

(B) the instructor;

(C) the name or location of the school;

(D) the course outline;

(E) the dates and times the course is offered;

(F) the location where the course is offered; or

(G) the fees charged to students.

(2) Nothing in this regulation shall preclude the commission from approving substitution of an instructor to teach an approved course, if the instructor meets the qualifications specified in subsection (g) of this regulation.

(f) Correspondence and home study program courses.

(1) Each school requesting approval of a correspondence or home study program course shall submit the following information:

(A) A copy of all course materials, including textbooks, student workbooks, and examinations with answers;

(B) the time frame for completion of the course; and

(C) the time allotted for examinations and the method by which examinations will be proctored.

(2) A school may issue a certificate of completion of a correspondence or home study program course approved by the commission to meet any requirement of K.S.A. 58-3046a, and amendments thereto, if the student has met either of the following conditions:

(A) Received a score of at least 70 percent on a proctored closed-book examination, in which case the proctor shall complete and provide to the school a certification form approved by the commission for each examination administered by the proctor; or

(B) received a score of at least 90 percent on an open-book examination.

(g) Request for instructor approval; notification of approval or disapproval. Each person desiring to teach a course approved by the commission shall submit an application for instructor approval on a form obtained from the commission. Each instructor shall show evidence of knowledge of the subject matter and ability to effectively instruct or evidence that the instructor has received a commission-approved designation.

(1) Knowledge of the subject matter shall be shown by meeting at least one of the following requirements:

(A) Holding a college degree in real estate or a college degree in law, business, or another academic area directly related to the course that the applicant intends to instruct; or

(B) having at least three years of experience in the professional area of real estate directly related to the course that the applicant intends to instruct.

(2) The ability to effectively instruct shall be shown by meeting at least one of the following requirements:

(A) Having completed, within the preceding two years, a commission-approved course of study for instructors designed to develop the ability to communicate;

(B) holding a current teaching certificate issued by a state department of education or an equivalent agency in another jurisdiction;

(C) holding a four-year college or university degree in the field of education; or

(continued)

(D) having successfully demonstrated the ability to teach in schools, seminars, or an equivalent setting.

(3)(A) Within 15 working days of receipt of an application for instructor approval, the school coordinator shall be notified by the commission, in writing, of its decision to approve or disapprove the instructor.

(B) If the commission requires additional time to reach a decision, the school coordinator shall be notified by the commission, in writing, of the fact that the application is under review and of the date by which the commission expects to complete its review.

(h) Registration of approved courses; application for renewal.

(1) Registration of courses approved by the commission shall expire at the end of each calendar year.

(2) Applications to renew approval of courses and instructors shall be sent to each school by the commission by November 1.

(i) Sponsoring courses. A school may request approval of a course that is developed and presented by a cosponsor.

(1) The school shall submit an application that has been obtained from the commission for approval of a sponsored course.

(2) The school shall maintain responsibility for each course presented by a cosponsor, including issuance of a certificate of satisfactory completion to each student who successfully completes the course. The school shall submit a roster to the commission, in a format approved by the commission, that specifies which student satisfactorily completed the course.
