Request for Comments

The Kansas Department of Health and Environment is soliciting comments regarding a proposed air quality construction permit. Butler County Sanitary Landfill has applied for an air quality construction permit in accordance with the provisions of K.A.R. 28-19-300 to install a landfill gas flare. Emissions of nitrogen oxides, particulate matter and carbon monoxide were evaluated during the permit review process.

Butler County Sanitary Landfill, El Dorado, owns and operates the stationary source located at 2963 S.W. 40th, El Dorado, at which the landfill gas flare is to be installed.

A copy of the proposed permit, permit application, all supporting documentation and all information relied upon during review of the permit application is available for public inspection for a period of 30 days from the date of publication during normal business hours at the KDHE, Bureau of Air and Radiation, 1000 S.W. Jackson, Suite 310, Topeka, and at the KDHE South Central Dis-

trict Office, 130 S. Market, Suite 6050, Wichita. To obtain or review the proposed permit and supporting documentation, contact John S. Ramsey, (785) 296-1992, at the KDHE central office, or David Butler, (316) 337-6020, at the KDHE South Central District Office. The standard departmental cost will be assessed for any copies requested.

Direct written comments or questions regarding the proposed permit to John S. Ramsey, KDHE, Bureau of Air and Radiation, 1000 S.W. Jackson, Suite 310, Topeka, 66612-1366. In order to be considered in formulating a final permit decision, written comments must be received by the close of business February 11.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Connie Carreno, Bureau of Air and Radiation, not later than the close of business February 11 in order for the Secretary of Health and Environment to consider the request.

Annual Program Report for the Voluntary Cleanup and Property Redevelopment Program

Activities from December 31, 2000 to December 31, 2001

Background

The Voluntary Cleanup and Property Redevelopment Act was enacted by the Kansas Legislature on July 1, 1997 (Kansas Statutes Annotated 65-34,161 through 65-34,174). The purpose of the act is to allow voluntary cleanup of contaminated properties with oversight by the Kansas Department of Health and Environment to promote the transfer, redevelopment and reuse of contaminated properties and to protect public health and the environment. Article 71 of the Kansas Administrative Regulations, specifically K.A.R. 28-71-1 through 28-71-12, were promulgated June 26, 1998, officially establishing the Voluntary Cleanup and Property Redevelopment Program (VCPRP). The law and program are administered by the Kansas Department of Health and Environment.

Under the VCPRP, stakeholders performing cleanup of contaminated properties that meet the criteria in the law (low to medium priority sites with minimal risk) can receive a "no further action" determination from the department to provide some protection from potential liabilities. Adjacent property owners who did not contribute to the contamination also may receive protection from the department through such determinations. A streamlined process is utilized to address these sites in an expeditious manner to encourage the redevelopment or enhancement of such properties. Clearly defined cleanup standards that identify the extent of cleanup have been developed and are provided to the voluntary party early in the program so the time and costs involved in cleanup can be determined. The VCPRP is truly voluntary and is designed for industry and businesses to properly address contamination on their property through a private/state partnership. There are no additional burdens or requirements placed on voluntary parties that participate in the program.

Report Summary

In accordance with K.S.A. 65-34,173, the Department of Health and Environment shall publish annually in the Kansas Register a summary of the number of applicants, the general categories of those applicants and the number of cleanups completed pursuant to this act. This annual report describes the activities accomplished by the department in the VCPRP for the period of December 31, 2000 to December 31, 2001.

The previous annual reports to the Legislature contained descriptions of VCPRP activities that reflected significant program building and implementation. VCPRP activities conducted during 2001 continued to involve program building and implementation while increased attention was provided to VCPRP program refinement. In September 2001, the program released the second version of the Risk-based Standards for Kansas (RSK) manual, which provides a risk-based approach to voluntary cleanups across Kansas. The RSK manual allows voluntary parties to take a tiered, risk-based approach to address contamination at their properties. The approaches and contaminant concentrations described in the RSK manual follow the regulations as developed by the regulation committee, which consisted of 12 major stakeholders. Program refinement will be an on-going objective for the VCPRP during the upcoming year.

A significant development was achieved in the VCPRP program during this reporting period. The department has been in negotiation with Region VII of the United States Environmental Protection Agency for more than two years to obtain a Memorandum of Agreement (MOA) relative to the VCPRP. The MOA was executed effective March 2, 2001. The MOA provides the EPA's acknowledgment of the adequacy of Kansas' VCPRP program. The MOA also provides assurances to voluntary parties that there will be no federal involvement at properties properly addressed in the VCPRP. The additional assurance from the EPA enhances the department's actions in issuing a "no further action" determination in terms of appeasement of environmental liability.

As reported in last year's annual report, the 2000 Kansas Legislature passed the Agriculture and Specialty Chemical Remediation Act (SB 501), which was signed into law by Governor Graves. This law establishes an industry-supported remediation fund to provide financial aid to property owners faced with costs associated with soil or groundwater contamination caused by agricultural and specialty chemicals such as fertilizers and pesticides. The VCPRP has been identified as one of two programs through which agriculture-related properties with contamination problems will be addressed. The VCPRP still maintains a rather significant percentage of agriculture-related projects; the numbers of agriculture-related applications to the VCPRP is expected to increase with the new funding mechanism for property owners with these types of problems. The VCPRP will coordinate ef-

forts with the Kansas Agricultural Remediation Board (KARB) to ensure that contaminated agricultural sites are handled in an efficient manner. The VCPRP provided names of participating voluntary parties to the KARB so an informational mailing could be sent out to agri-businesses.

As of December 21, 2001, the Department of Health and Environment has received a total of 227 completed application packages, of which 219 properties have been determined eligible to participate in the program. A total of 206 voluntary agreements have been signed. Voluntary cleanup investigations have been initiated or completed at 156 properties. Currently, 39 properties have entered the cleanup phase in either the preliminary cleanup proposal process, cleanup planning stage, or in the active cleanup phase; cleanups have now been completed at 11 properties. To date, the department has issued 39 "no further action" determination letters.

The rate at which applications have been received by the VCPRP program has remained fairly constant; the average number of applications received for 1999 was 3.9 applications per month, 5.9 applications per month in 2000 and 4.3 applications per month in 2001. An average of 53 new voluntary cleanup properties enter the program each year. One of the primary performance indicators for the VCPRP would be the number of "no further action" letters (NFA) issued. The number of NFAs issued per year has increased and will be expected to continue on this trend as properties finish their investigations and proceed through the cleanup phase. This can be demonstrated by reviewing the number of NFAs issued each year: for 1998 only 3 NFAs were issued, 4 NFAs were issued in 1999, 9 NFAs were issued in 2000 and 23 NFAs were issued in 2001, as properties finish the investigation and/or cleanup phase. Cleanup and issuance of a NFA can be fairly quick if only soil contamination is involved. Longer periods of time are required to clean up contaminated groundwater at properties. In Kansas, approximately 80 percent of all the VCPRP properties involve groundwater contamination.

Notice of Hearing

A public hearing will be conducted by the Kansas Department of Health and Environment at 7 p.m. Tuesday, February 12, in the Finney County Commission Room, second floor, Finney County Administrative Center, 311 N. 9th, Garden City, to receive comments prior to final action on the proposed issuance of an air quality construction permit. KDHE is proposing to issue the permit, in accordance with the provisions of K.A.R. 28-19-17, Prevention of Significant Deterioration (PSD), which adopts by reference the standards, procedures or requirements of 40 CFR 52.21. The permit authorizes Sand Sage, LLC to install and operate a 660 MW pulverized coal-fired

boiler, one natural gas auxiliary boiler and a new cooling tower, and authorizes changes to the coal, lime and ash handling equipment at the Sunflower Electric Corporation's Station in Holcomb. The facility is owned and operated by Sand Sage, LLC, 301 W. 13th St., Hays.

The Holcomb area is designated as an attainment area under the Clean Air Act, which means that the air quality meets or is better than the national ambient air quality standards (NAAQS). Any major source or a major modification to a major source has to undergo a pre-construction review as required by the PSD regulations.

The PSD regulations require evaluation of emission reduction techniques to identify the best available control technology (BACT) for each pollutant for which the emission rate exceeds the PSD significant level. The purpose of BACT is to effect the maximum degree of reduction achievable, taking into account energy, environmental and economic impacts for each pollutant under review. Evaluation of the estimated emissions for the proposed Sand Sage, LLC facility indicates that the emission rate of nitrogen oxides (NOx), sulfur dioxide (SO₂), carbon monoxide (CO), volatile organic compounds (VOCs), particulate matter (PM) and particulate matter less than 10 microns (PM₁₀) all exceed the significance levels. Sand Sage, LLC conducted the required BACT analyses. The department has reviewed Sand Sage, LLC's BACT analyses for the coal-fired boiler and concurs with its findings that low NOx burners and overfire air with selective catalytic reduction is BACT for NOx, dry flue gas desulfurization (dry FGD) is BACT for SO₂, and fabric filters is BACT for PM and PM₁₀.

The PSD regulations also require an evaluation of the impacts, if any, that emissions from the proposed modifications may have on the ambient air quality, visibility, vegetation and soils. Sand Sage, LLC has conducted the required analyses in accordance with methods approved by the United States Environmental Protection Agency. The results of the analyses conclude that, except for the short-term (3 hour and 24 hour) SO₂, there should be no significant impacts on the ambient air quality, visibility, local vegetation or soils. Since the baseline SO₂ date had previously been triggered for Finney County by a previous permit, both an increment and national ambient air quality analysis were required for short-term SO₂ emissions. Further review of the short-term SO₂ showed no values in excess of increment or ambient air standards applicable to the area.

Notice of Hearing of Proposed Administrative Regulations

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Thursday, March 14, at Prairie Land Electric, West Highway 36, Norton, to consider the approval and adoption of proposed regulations of the Kansas Department of Wildlife and Parks.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 1:30 p.m. March 14 at the location listed above. The meeting will recess at 5 p.m., then resume at 7 p.m. at the same location for the regulatory hearing. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. March 15 at the same location.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Sheila Kemmis, commission secretary, at (620) 672-5911. Persons with a hearing impairment may call the TDD service at 1-800-766-3777 to request special accommodations.

This 60-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on proposed administrative regulations.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, Suite 502, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The administrative regulations that will be heard during the regulatory hearing portion of the meeting are as follows:

K.A.R. 115-2-6. This regulation establishes fees for certain permits and other issues, including the annual lease fee for private cabins on state park controlled lands. Future changes in that fee are to be based on changes in the Consumer Price Index (CPI). The only proposed amendment is technical in nature, and would simply correct the reference to the CPI to specify the CPI using a baseline of 1982-1984=100, rather than 1993-1995=100, which is no longer used by the U.S. Department of Labor.

Economic Impact Summary: Because the CPI percentage change since 1998 will be the same using either baseline, the resulting fee will be the same in either case. Consequently, the amendment would have no economic impact on the department, other state agencies or members of the public.

K.A.R. 115-4-4. This regulation establishes legal equipment and taking methods for big game species. The proposed amendments would make three changes. First, they would refer to the use of locking draws as authorized by K.A.R. 115-18-7. Second, they would allow "open or peep sights" during muzzleloader-only seasons, which would have the effect of allowing fiber optic sights. Third, they would allow the use of dogs during fall turkey seasons.

Economic Impact Summary: The proposed amendments may benefit sales of modern muzzleloader rifles, but otherwise are not anticipated to have substantial economic impact on the department, other state agencies or members of the public.

K.A.R. 115-18-7. This regulation provides for the issuance of a crossbow permit to any person with a qualifying disability. The proposed amendment would allow persons who qualify to use a crossbow the additional option of using a "locking draw," which is a bow equipped with a mechanical device that locks the bow at full or partial draw

Economic Impact Summary: Other than some potential benefit to businesses that sell locking draw devices, the proposed amendment is not anticipated to have an economic impact on the department, other state agencies or members of the public.

A petition seeking to bring before the electorate a question regarding the dissolution of a city of the third class pursuant to K.S.A. 15-111 must comply with the provisions of K.S.A. 25-3601 et seq., except to the extent that K.S.A. 15-111 imposes specific requirements that conflict with those requirements set forth in K.S.A. 25-3601 et seq. Such a petition is to be filed with the county election officer of the county in which the city is located and must include signatures equal in number to not less than a majority of the latest voter registration certified by the county election officer to the Secretary of State. The election at which a question regarding the status of a city of the third class is submitted to the electorate pursuant to K.S.A. 15-111 and 25-3601 et seq. is to be held at the next succeeding primary or general election, as defined by K.S.A. 25-2502, in which the city is participating. The Sixth Amendment right to counsel does not attach at the point when a juvenile is taken into custody and subjected to the juvenile intake and assessment process established pursuant to K.S.A. 2000 Supp. 75-7023.

Whether a juvenile's Fifth Amendment rights are violated will depend upon whether a juvenile is in fact compelled to respond to a POSIT questionnaire and whether there is an attempt to use such responses against the juvenile in a criminal proceeding. There would likely be Fifth Amendment implications if POSIT responses to criminal behavior queries lead to either the filing of criminal charges or the court's imposition of a harsher sentence based on such responses.

Given the state's parens patriae interest and the fact that POSIT questionnaire responses are confidential, it is unlikely under the present state of the law that a claim based upon the constitutional right of privacy would be successful. Although the fact that the information obtained during the intake and assessment process is allegedly retained indefinitely, it is only one of many factors that a court would consider in determining whether the intake and assessment process evidences a proper regard for privacy.

Whether or not a parent's familial association rights are violated based on a juvenile's responses to a POSIT questionnaire will depend upon the facts of the case.

While a juvenile who has been arrested for disorderly conduct may consider it intrusive to answer a question regarding sexual practices, in light of the government's interest in identifying at-risk behavior in juveniles, this limited intrusion is justified and does not run afoul of the Fourth Amendment.

Finally, the fact that responses to a POSIT questionnaire may be taken into account by a prosecutor in determining whether to grant diversion does not implicate the Equal Protection Clause. A person has a "personal interest" if credentialing will benefit a blood relative or a close friend in a nonfinancial way, but in a matter of great importance, or if that person's judgment may be affected because of membership in some organization and a desire to help that organization further its policies. The secretary must determine facts and circumstances concerning the apparent support of credentialing expressed by persons appointed to a technical committee and then, using his discretion, determine for himself whether a "personal interest" exists. Permanent Administrative Regulations

Article 3.—PRODUCTION AND CONSERVATION OF OIL AND GAS

82-3-111. **Temporarily abandoned wells; penalty; plugging.** (a) Temporary abandonment approval or plugging required. Within 90 days after operations cease on any well drilled for the purpose of exploration, discovery, service, or production of oil, gas, or other minerals, the operator of that well shall perform either of the following:

(1) Plug the well; or

(2) file an application with the conservation division requesting temporary abandonment authority, on a form

prescribed by the conservation division.

- (b) Approval of temporary abandonment. No well shall be temporarily abandoned as described above unless first approved by the conservation division. If the operations on any temporarily abandoned well or other inactive well are not resumed within a period of one year after the application has been approved, the well shall be deemed a permanently abandoned well, and the operator of the well shall comply with rules and regulations of the commission relating to the plugging of wells. Upon application to the conservation division before the expiration of the one-year period, and for good cause shown, the period may be extended by the conservation division for one year. Additional one-year extensions may be granted by the conservation division. The failure to file a notice of temporary abandonment shall be punishable by a \$100 penalty.
- (c) Right of denial. After an application for temporary abandonment has been filed, the well shall be subject to inspection by the conservation division to determine whether its temporary abandonment could cause pollution of fresh and usable water resources. If necessary to prevent the pollution of fresh and usable water, temporary abandonment may be denied by the conservation division, and the well may be required to be plugged or

repaired according to the direction of the conservation division and in accordance with its rules and regulations.

- (d) Plugging of temporarily abandoned wells. At the expiration of the maximum temporary abandonment period, each well temporarily abandoned shall be plugged, repaired, or returned to operation in accordance with applicable rules and regulations.
- (e) Certain wells exempted. The requirements of this regulation shall not apply to any well that meets all of the following criteria:
- (1) The well is fully equipped for production of oil or gas, or injection.
- (2) The well is capable of immediately resuming production of oil or gas, or injection.
- (3) The well is subject to a valid, continuing oil and gas lease.
- (4) The cessation period for the well is less than 365 consecutive days.
- (5) The well is otherwise in full compliance with all of the commission's regulations.
- (f) Post-exemption requirements. The date on which a well ceases to qualify for the exemption specified in subsection (e) shall be deemed to be the date operations ceased on the well, for purposes of subsection (a). (Authorized by and implementing K.S.A. 55-152, K.S.A. 2000 Supp. 55-164, as amended by L. 2001, ch. 5, sec. 191; effective, T-83-44, Dec. 8, 1982; effective May 1, 1983; amended May 1, 1984; amended May 1, 1985; amended April 23, 1990; amended Jan. 25, 2002.)
- 82-3-120. Operator or contractor licenses: application; financial responsibility; denial of application; penalty. (a) No operator or contractor shall undertake the activities of drilling, completing, servicing, plugging, or operating any well for the purposes of exploring for or recovering oil or gas without first obtaining or renewing a current license. Each operator in physical control of any well, whether or not the well is in operating condition, shall maintain a current license. Each licensee shall annually submit a completed license renewal form on or before the expiration date of the current license.
- (b) To qualify for a license or license renewal, the applicant shall be in compliance with applicable laws, as required in subsection (h), and shall submit the following items to the conservation division:
- (1) An application meeting the requirements of subsection (c);
- (2) a \$100 license fee, except that an applicant for a license who is operating one gas well used strictly for the purpose of heating a residential dwelling shall pay an annual license fee of \$25;
- (3) for each rig as defined in subsection (d), a \$25 fee and copies of property tax receipts on all rigs; and
- (4) financial assurance in accordance with subsection (e).
- (c) Application. The application for a license or a license renewal shall be verified and filed with the commission showing the following information:
- (1) The applicant's full legal name and any other name or names under which the applicant transacts or intends to transact business under the license and the applicant's correct mailing address. If the applicant is a partnership or association, the application shall include the name and

address of each partner or member of the partnership or association. If the applicant is a corporation, the application shall contain the names and addresses of the principal officers;

(2) the number of rigs sought to be licensed; and

(3) any other information that the forms provided

Each application for a license shall be signed and verified by the applicant if the applicant is a natural person, by a partner or a member if the applicant is a partnership or association, or by an executive officer if the applicant is a corporation.

- is a corporation.

 (d) "Rig" means any crane machine used for drilling or plugging wells. An identification tag shall be issued by the commission for each rig licensed according to this regulation. The operator shall display a current identification tag on each rig at all times.
- (e) (1) Financial assurance shall be provided in accordance with the requirement specified in paragraph (e)(2), if applicable, or in accordance with subsection (g).
- (2) The applicant shall pay an annual \$50 nonrefundable fee if the applicant has an acceptable record of compliance, as demonstrated during the preceding 36 months.
- (f) For purposes of this regulation, "an acceptable record of compliance" shall mean both of the following:
- (1) The operator has neither been assessed by final order of the commission with \$3,000 or more in penalties nor has been cited by final commission order for five or more violations in the preceding 36 months.
- (2) The operator has no outstanding undisputed orders or unpaid fines, penalties, or costs assessed by the commission and has no officer or director that has been or is associated substantially with another operator that has any such outstanding orders or unpaid fines, penalties, or costs.
- (g) (1) If the applicant does not meet the provisions of paragraph (e)(2) or has not been licensed for at least the preceding 36 months, the applicant shall furnish one of the following, up to \$30,000, on an annual basis:
- (A) An individual performance bond or letter of credit on a form prescribed by the commission, in an amount equal to \$.75 times the total aggregate depth, in feet, of all wells for which the operator is responsible;
- (B) a blanket performance bond or letter of credit on a form prescribed by the commission, in an amount equal to the following, as applicable:
- (i) Wells fewer than 2,000 feet in depth: 1-5 wells, \$5,000; 6-25 wells, \$10,000; over 25 wells, \$20,000; and
- (ii) wells 2,000 or more feet in depth: 1-5 wells, \$10,000; 6-25 wells, \$20,000; over 25 wells, \$30,000;
- (C) a nonrefundable fee equal to 3% of the amount of the bond or letter of credit required by paragraph (g)(1)(A) or (B); or
- (D) a first lien in favor of the state of Kansas on tangible personal property associated with the operator's oil and gas production, having a salvage value equal to not less than the amount of the bond or letter of credit required by paragraph (g)(1)(A) or (B); or
- (E) any other financial assurance approved by the commission.
- (2) Well inventory. Each operator furnishing financial assurance under paragraph (g)(1)(A) of this regulation

shall also furnish a complete inventory of wells and the depth of each well for which the operator is responsible. Each operator furnishing financial assurance under paragraphs (g)(1)(B) through (E) either shall furnish a well inventory or shall be required to furnish the \$30,000 bond, letter of credit, fee, or other financial assurance based on that amount. Falsification of the well inventory shall be punishable by a penalty of up to \$5,000 and possible suspension of the operator's license.

(h) Compliance with applicable laws.

- (1) If the applicant is registered with the federal securities and exchange commission, the applicant shall demonstrate to the commission that the applicant complies with all requirements of chapter 55 of the Kansas statutes annotated, all regulations adopted thereunder, and all commission orders and enforcement agreements.
- (2) If the applicant is not registered with the federal securities and exchange commission, the applicant shall demonstrate to the commission that the following individuals comply with all requirements of chapter 55 of the Kansas statutes annotated, all regulations adopted thereunder, and all commission orders and enforcement agreements:
 - (A) The applicant;
- (B) any officer, director, partner, or member of the applicant;
- (C) any stockholder owning in the aggregate more than 5% of the stock of the applicant; and
- (D) any spouse, parent, brother, sister, child, parent-in-law, brother-in-law, or sister-in-law of any of the individuals specified in paragraphs (h)(2)(A) through (C).
- (i) Upon approval of the application by the conservation division, a license shall be issued to the applicant. Each license shall be in effect for one year unless suspended or revoked by the commission.
- (j) Denial of application. An application or renewal application shall be denied if the applicant has not satisfied the requirements of this regulation. Denial of a license application shall constitute a summary proceeding under K.S.A. 77-537 and amendments thereto. A denial pursuant to K.S.A. 55-155(c)(3) or (4), and amendments thereto, shall be considered a license revocation.
- (k) Upon revocation of a license, no new license shall be issued to that operator or contractor until after the expiration of one year from the date of the revocation.
- (l) The failure to obtain or renew an operator or contractor license before operating shall be punishable by a \$500 penalty.
- (m) Notification of changes. Each operator shall immediately notify the conservation division in writing of any change in information supplied in conjunction with the license application. If the change involves an increase in the number or depth of the wells listed on the operator's well inventory, the operator's notification shall be accompanied by additional financial assurances to cover the additional number or depth of wells. - 82-3-120a. (Authorized by and implementing K.S.A. 1996 Supp. 55-155 and 55-164; effective Aug. 29, 1997; revoked Jan. 25, 2002.)
- 82-3-123. **Well bore**; **commingling of production**. (a) Applicability. Commingling of production from more than one source of supply shall be permitted if the total production potential is less than the allowable for a single common source of supply for the immediate area and after application and approval by the commission. Commingling shall be prohibited if the commission finds that waste or a violation of correlative rights is likely to result.
- (b) Allowable. The maximum well allowable for a well in which commingled production is approved shall be the following:
- (1) For oil wells, the allowable for the deepest source of supply demonstrating productivity as specified in K.A.R. 82-3-203 or special order; and
- (2) for gas wells, the allowable specified in K.A.R. 82-3-312 based on the combined actual open-flow potential from all producing zones or as provided by special order.
- (c) Notice. Notice of the application shall be provided as required in K.A.R. 82-3-135a(b).
- (d) Application. Each original application for commingling and one copy shall be filed with the conservation division. The application shall be submitted to the commission on the form provided by the commission and shall be accompanied by the following information:
- (1) A description of the well with a plat attached showing the location of the subject well, the location of other wells on the lease, the location of offset wells within a ½-mile radius of the subject well, and for each of these wells, the name of the lessee of record or the operator;
- (2) the names of the upper and lower limits of the sources of supply to be commingled, with proposed perforations or open holes noted;
 - (3) a wireline log of the subject well;
- (4) the production potential of oil, water, gas, or a combination for each source of supply;
- (5) the total anticipated production for the formations sought to be commingled; and
 - (6) the applicant's license number.
- (e) Application for additional sources of supply. A new commingling application shall be required if the operator desires to open an additional source of supply that was not included in the initial application. (Authorized by and implementing K.S.A. 2000 Supp. 55-604, K.S.A. 55-605, K.S.A. 55-704; effective, T-83-44, Dec. 8, 1982; effective May 1, 1983; amended May 1, 1985; amended May 1, 1987; amended May 1, 1988; amended May 8, 1989; amended April 23, 1990; amended Aug. 29, 1997; amended Jan. 25, 2002.)
- 82-3-304. **Tests of gas wells; penalty.** (a) (1) Initial certified tests run on gas wells to determine the standard daily allowable as a percentage of the well's actual openflow potential shall be conducted in conformance with K.A.R. 82-3-303 or special orders. These tests shall be completed and filed by the well operator with the commission within 60 days of the first gas sales. The well operator shall conduct the tests under the supervision of

the conservation division, and a representative of the commission may be present to witness these tests.

- (2) The operator of any gas wells producing a minimum allowable of 250 mcf or less of gas per day in non-prorated fields shall not be required to perform an initial certified test in conformance with K.A.R. 82-3-303. Each operator of a minimum allowable gas well shall perform an initial test consisting of a 24-hour shut-in pressure test within 30 days of the first gas sales. The operator of the well shall report the results of the shut-in pressure test to the commission on a prescribed form within 30 days of the test date.
- (3) In prorated fields, all gas produced into a pipeline shall be counted against the allowable.
- (b) Tests may be witnessed by a representative of any producer, purchaser, or transporter in the field. Any producer, purchaser, or transporter may request notification of the time the tests will commence from the operator of the well on which a test is to be run.
- (c) An annual test shall be run on all gas wells not covered by a proration order or special order, in accordance with these regulations, except for the following:
- (1) Gas wells used for domestic purposes where gas is not sold:
- (2) gas wells that produce 250 mcf of gas or less per day;
 - (3) coalbed methane gas wells;
 - (4) water-prone gas wells equipped with a plunger lift;
- (5) gas wells used exclusively for secondary oil recovery; and
- (6) gas wells employing a vacuum to recover gas. The test shall be effective during the next succeeding year. Tests may be required by the commission at any time. The test shall become effective the first day of the month following receipt of test results by the conservation division.
- (d) Gas wells that produce gas with more than 30 grains per 100 cubic feet of H_2S shall not qualify for an exemption from annual testing under paragraphs (c)(1) through (6).
- (e) Each operator shall request the exemption from annual testing each year on forms prescribed by the commission, shall perform a shut-in pressure test during each year, and shall furnish it to the commission with the request for exemption.
- (f) Each operator of a gas well shall be responsible for conducting all tests required to obtain an allowable for the well. Each operator shall submit one copy of the test required under subsection (c) to the conservation division and one copy to the purchaser to confirm the allowable as determined by these regulations or by special orders.
- (g) All gas produced and sold without the required test shall be considered illegal production.
- (h) The failure to submit an annual gas well test shall be punishable by a \$500.00 penalty. (Authorized by K.S.A. 55-704; implementing K.S.A. 2000 Supp. 55-164, as amended by L. 2001, ch. 5, sec. 191 and K.S.A. 55-703; effective, T-83-44, Dec. 8, 1982; effective May 1, 1983; amended May 1, 1986; amended May 1, 1987; amended May 1, 1988; amended April 23, 1990; amended Aug. 29, 1997; amended Jan. 25, 2002.)
- 82-3-312. **Gas allowables and drilling unit.** In the absence of basic proration orders issued by the commis-

- sion, the following provisions shall apply to all gas wells. (a) Standard daily allowable. The standard daily allowable for a gas well is limited to 25 percent of the well's actual open-flow potential. The actual open-flow potential used to determine the standard daily allowable shall be measured by the testing procedures specified in K.A.R. 82-3-303. All gas wells that are in compliance with the provisions of K.A.R. 82-3-304 shall be entitled to a minimum allowable of 250 mcf per day.
- (b) Standard drilling unit. A standard drilling unit shall be 10 acres. Except as otherwise specified in K.A.R. 82-3-108(c), the well for that unit shall be located at least 330 feet from any lease or unit boundary.
- (c) Acreage-attribution unit. Unless a well location exception is granted, each gas well located nearer than 330 feet to any lease or unit boundary line shall have acreage attributed to it by the establishment of an acreage-attribution unit. The width of each unit shall be defined as being twice the distance from the well to the nearest lease or unit boundary line. The length of the unit shall be defined to be the same as the width.
- (d) Acreage attributable. When any gas well is located nearer than 330 feet to any lease or unit boundary line, the standard daily allowable or minimum allowable shall be reduced in the same proportion that the acreage attribution to the well bears to 10 acres.
- (e) Exceptions may be granted, and adjustments to the allowables may be made by the commission to protect correlative rights, prevent waste, and give the full allowable where any of these conditions exists:
- (1) Location exceptions have been granted for manmade structures or topographic features.
- (2) No interference with drainage of adjacent wells can be shown by competent evidence.
- (3) Actual interference is less than the reduced allowable. (Authorized by K.S.A. 55-704; implementing K.S.A. 55-703; effective May 1, 1985; amended May 1, 1986; amended May 1, 1988; amended April 23, 1990; amended Aug. 29, 1997; amended June 1, 2001; amended Jan. 25, 2002.)
