Notice of Nomination Deadline for Governor's Arts Awards

The Kansas Arts Commission is accepting nominations for the 2002 Governor's Arts Awards until 5 p.m. Wednesday, May 1.

Any Kansas citizen or organization may submit a documented nomination in one of six categories: Individual Artist, Arts Organization, Art Educator, Arts Advocate, Individual Patron or Patron Organization. Individual artists may be in the visual, performing, literary, folk or media arts.

Nominees must be Kansas citizens or Kansas-based organizations with records of outstanding contributions to the excellence, growth and support or availability of the arts in Kansas. Prior honorees, current members of the commission or its staff, and art projects or programs are not eligible.

Award recipients will be selected from the eligible nominees by a panel including members of the Kansas Arts Commission, a representative of the Governor and representatives from various arts disciplines and organizations.

All original nominations must be submitted on the official form. Handwritten nominations will not be considered. If more than one nomination is received for the

same person or organization, only the first one received will be accepted.

All support materials, including but not limited to photographs, slides, video tapes, audio tapes, letters, clippings, manuscripts or publications, become the property of the commission and will not be returned.

Nominations must either be received in the Kansas Arts Commission office by 5 p.m. May 1 or bear a U.S. Postal Service postmark that is not later than the deadline date. Metered mail is not acceptable as a postmark. Nominations that are delivered by express mail, overnight delivery or by hand will not be accepted after the deadline time.

Notice of Grant Opportunities and Deadlines

Kansas organizations may apply to the Kansas Arts Commission for grants to support arts programming, projects, activities and events during fiscal year 2003 (July 1, 2002 through June 30, 2003). The grant programs and application deadlines are as follows:

- Arts In Education (AIE) Projects—March 27, 2002. Categories are for Community AIE Programs and AIE Programs for At-Risk Youth.
- Arts Project Support—March 27, 2002. This program is open to non-arts organizations, such as local governmental entities, libraries, recreation commissions, community colleges, historical societies or museums, and chambers of commerce. This program is not open to elementary and secondary schools, educational centers, and arts and cultural organizations.

Advisory panels for these two programs will meet respectively in April and May, and the recommendations for funding will be considered by the commission during its quarterly business meeting in June.

The following programs are not evaluated by panels:

- Operational Support for Arts and Cultural Organizations—March 13, 2002, deadline. This program is not open to schools or non-arts organizations.
- Technical Assistance and Grassroots. Applications should be submitted at least six weeks prior to the beginning of the project and will be considered for grants until reserved funds have been exhausted. Non-arts organizations, schools and social service agencies must qualify as rural, emerging, multicultural or culturally specific.
- The Kansas Touring Program. Presenters may apply for 40 percent of the artists' fees. Applications should be submitted at least six weeks prior to the event and will be considered for grants until reserved funds have been exhausted. (Presenters seeking support for a season of performances must apply for Operational Support grants.)

The booklet includes the roster of more than 60 performing artists, ensembles and companies offered through the Kansas Touring Program. Categories are dance and movement theatre, storytellers and theatre, solo and ensemble classical music, jazz, traditional acoustic music, music and technology, and vocal performance by singers and songwriters.

The Kansas Department of Health and Environment is soliciting comments regarding a proposed air quality operating permit. Oneok Field Services - Glick Compressor Station has applied for a Class I operating permit in accordance with the provisions of K.A.R. 28-19-510 et seq. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards and requirements applicable to each source; and the monitoring, record keeping and reporting requirements applicable to each source as of the effective date of permit issuance.

Oneok Field Services - Glick Compressor Station, Oneok Field Services Company, Tulsa, Oklahoma, owns and operates a natural gas compressor station located at Section 20, Township 30 South, Range 15 West, Barber County, Kansas.

A copy of the proposed permit, permit application, all supporting documentation and all information relied upon during the permit application review process is available for a 30-day public review during normal business hours at the KDHE, Bureau of Air and Radiation, 1000 S.W. Jackson, Suite 310, Topeka, and at the KDHE South Central District Office, 130 S. Market, Suite 6050, Wichita. The standard departmental cost will be assessed for any copies requested.

In order to be considered in formulating a final permit decision, written comments must be received by the close of business March 25.

The U.S. Environmental Protection Agency has a 45-day review period, which will start concurrently with the 30-day public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA 45-day review period. If the EPA waives its 45-day review period, the 60-day public petition period will start directly after the 30-day public comment period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. Notice of Available Grant Funding

Applications for the Edward Byrne Memorial State and Local Law Enforcement Assistance Grant Program are available. This grant program was established by the Anti-Drug Abuse Act of 1988 and the Crime Control Act of 1990.

The State of Kansas will be awarded funding by the U.S. Department of Justice, Bureau of Justice Assistance, which will be subgranted to Kansas criminal justice agencies to assist their efforts in combating illicit drug use, violent crime and system improvement needs.

Cities, counties, state agencies and native Indian tribes are eligible to receive grant funding. Program areas for which applicants can apply include prevention, enforcement, treatment, criminal interdiction, adjudication and criminal justice information systems improvement.

Applicants are required to provide at least 25 percent of the total amount requested (local matching funds). The percent of the local matching funds is contingent on the number of years a grant has been funded.

The Byrne grant allows for the possibility of four years of funding in a program area. Program areas are described in the grant application.

Grants operate on a reimbursement basis. Subrecipients will be reimbursed the federal portion for authorized expenditures. Reimbursements are processed monthly.

The grant award period will be from July 1, 2002 to June 30, 2003.

Applications must be postmarked not later than April 26 to the address listed below. Grant awards will be announced before June 30, 2002.

Request for Comments

The Kansas Department of Health and Environment has prepared a Kansas Water Pollution Control General Wastewater Control Permit for operating wastewater treatment/retention facilities for ready-mix concrete products plants, concrete product plants and their associated facilities. The draft permit covers both total retention facilities and facilities that discharge treated wastewater to surface waters of the state. A stormwater pollution plan is required within one year of the issuance of the permit.

A general wastewater permit is provided for those entities engaged in similar activities and discharging the same types of wastewater. The wastewater from these types of activities has a low public health and environmental risk. A general permit is placed on public notice once during the life of the permit and then is made available, without further public notice, to all persons for ready-mix concrete products plants, concrete product plants and their associated facilities that meet the requirements of the permit. The permittees also are required to meet all other federal, state and local requirements, including local zoning ordinances.

The draft permit covers discharges of process wastewater from ready-mix concrete products plants, concrete product plants and their associated facilities. For facilities that discharge wastewater to surface waters of the state, the draft permit contains limits for oil and grease, total suspended solids, pH and monitoring for effluent flow, sulfate and chlorides. The permittee also is required to record usage of concrete and water treated additives and conduct inspections of the stormwater runoff control system. Sources of process wastewater discharge are equipment washoff, including delivery trucks, conveyor belts, transport buckets, and central mixers and forms and other incidental sources of wastewater. The draft permit does not cover facilities on Indian lands, discharge facilities in close proximity of certain high priority waters of the state or facilities that would result in discharges that violate the Kansas Surface Water Quality Standards. To be covered under the draft permit, the permittee is required to complete and submit the Notice of Intent along with the first year's permit fee of \$60 and receive a signed and dated permit from KDHE. To maintain the permit, the permittee is required to achieve and maintain compliance with the permit requirements and pay the annual \$60 permit fee.

Request for Comments

The Kansas Department of Health and Environment has received and reviewed an application to amend the permit for the municipal solid waste landfill known as Johnson County Landfill, owned and operated by Defenbaugh Industries, Inc. The proposed permit modification is to add a municipal solid waste disposal area known as Phase V. The landfill is located in the East ½ of Section 1 and the Northeast ¼ of Section 12, Township 12 South, Range 23 East; and the West ½ of Section 6 and the Northwest ¼ of Section 7, Township 12 South, Range 24 East in Johnson County, at 18181 W. 53rd St., Shawnee. Phase V is located on the southeast corner of the landfill property, northwest of the intersection of I-435 and Johnson Drive. The property containing Phase V is owned by the applicant and is included in the overall acreage of the permitted landfill facility. Phase V will consist of approximately 65 acres with an estimated landfill volume of 11,400,000 cubic yards, or approximately 5.5 years of additional landfill capacity at projected disposal rates.

KDHE is providing public notice of its intent to issue a permit modification for the requested amendment. Notice of the decision will be given to the applicant, to anyone who submitted written comments during the comment period and to those who requested notice of the final permit decision.

Request for Comments

The Kansas Department of Health and Environment is requesting comments on the Draft Section 401 of the Clean Water Act Water Quality Certification to address all of the Nation Wide Permits under Section 404 of the Clean Water Act, issued by the United States Army Corps of Engineers (USACE). Section 404 Nation Wide Permits authorize projects that discharge dredged or fill materials into the waters of the United States determined by the USACE through public review and comment to have minimal impacts as described in the January 15, 2002, Part II of the Federal Register (67FR 2020-2095), U.S. Army Corps of Engineers. These permits are applicable to activities including, but not limited to, linear transportation crossings, utility corridors, stream and wetland restoration, moist soil management for wildlife, stormwater outfalls, recreation and stormwater management facilities, and others. Detailed description and notification to the public of the Federal Register notice and complete listing of the Nation Wide Permits can be found at www.nwk.usace.army.mil/regulatory/regulatory.htm.

The USACE has coordinated with state agencies and EPA Region VII to issue Kansas Regional Conditions that will help assure minimal impacts to water resources and aquatic habitats. Kansas Regional Conditions can be found on the Web at www.nwk.usace.army.mil/regulatory/nwp_information/ks_nwp_regional_conditions.pdf. This Web site includes a table and attached map illustrating Outstanding National Resource Waters, Exceptional State Waters and Special Aquatic Life Use Waters.

The purpose of the Section 401 Water Quality Certification is to inform the USACE and the applicant that the project: (1) has the potential to violate water quality standards, (2) expected water quality conditions resulting from the activity avoid violation of water quality standards, and (3) recommended measures to abate or minimize pollutants and water quality degradation. Conditions of the Section 401 Water Quality Certification become conditions of the Section 404 Nation Wide Permits. Notice of Hearing on Proposed Administrative Regulations

A public hearing will be conducted at 9 a.m. Thursday, April 25, in the State Conservation Commission's conference room, 109 S.W. 9th, Suite 500, Topeka, to consider the adoption of proposed permanent regulations of the State Conservation Commission Water Resources Cost-Share Program, Non-Point Source Pollution Control Program, Water Rights Purchase Program and Buffer Initiative Program. The State Conservation Commission also will hear comments relating to the revocation of the Cost-Sharing for Land Treatment Above Multi-Purpose Small Lakes Projects and the High Priority Cost-Share Program.

This 60-day notice constitutes a public comment period for the purpose of receiving written public comments on the proposed regulations. Comments may be sent to the State Conservation Commission, 109 S.W. 9th, Suite 500, Topeka, 66612-1299, prior to the hearing date. All interested parties will be given an opportunity to address their views during the hearing. The State Conservation Commission, as a basis for approving, amending and approving or rejecting a proposed regulation, will consider all written and oral comments submitted by interested parties.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Scott Carlson at (785) 296-3600.

The proposed regulations for adoption address the expenditure and accountability of State Water Plan Special Revenue Funds. These funds are allocated to conservation districts by the State Conservation Commission for the implementation of soil and water conservation and water pollution control practices to protect and restore Kansas' natural resources. These incentive-based financial assistance funds are awarded to landowners on a cost-sharing basis. The proposed regulations considered for adoption consist of the following:

K.A.R. 11-1-6 through 11-1-14, Water Resources Cost-Share Program; and 11-7-6, 11-7-7, 11-7-12, 11-7-13, 11-7-14, 11-7-15 and 11-7-16, Non-Point Source Pollution Control Program. These new and modified proposed regulations address the financial and practice maintenance contracting, eligibility requirements and allocation procedures between the State Conservation Commission, conservation districts and landowners involving soil and

water conservation and pollution control practices. The economic impact on other governmental agencies may require increased costs associated with local implementation and administration of the program. The general public would be impacted positively if receiving financial assistance for implementation of a conservation or pollution control practice.

K.A.R. 11-9-2, 11-9-5 and 11-9-10, Kansas Water Quality Buffer Initiative. These are amended regulations addressing the enhancement of the federal Conservation Reserve Program by providing state financial incentives to supplement federal payments for filter strips and riparian forest buffers. The proposed expansion would increase the workload upon the United States Department of Agriculture, Natural Resources Conservation Service, which is responsible for the administration of the Conservation Reserve Program. A lower valuation of property would negatively impact the property tax revenue for a county. The supplemental payments made available to landowners would allow increased income from enrolled acres.

K.A.R. 11-10-1 through 11-10-6, Water Rights Purchase Program. These are new regulations utilized to implement the Water Rights Purchase Program, which provides cost-share assistance to local entities for the purchase of water rights from willing sellers. The objective of the program is to reduce aquifer depletion and recover stream flows. The Water Rights Purchase Program will have a negative impact on local property tax collection by converting property from irrigated to dry land. The purchase of water rights could affect various sectors of agri-business by changing the land use and thus the inputs required to produce an annual crop.

K.A.R. 11-2-1 through 11-2-6, High Priority Cost-Share Program. This program is proposed for revocation as it was merged into the Water Resources Cost-Share Program in 1993. The program involved cost-sharing on soil and water conservation practices. No economic impact is anticipated upon governmental agencies with revocation of the High Priority Cost-Share Program. All benefits accrued by landowners and construction contractors and local taxing authorities will be maintained by the Water Resources Cost-Share Program.

K.A.R. 11-5-1 through 11-5-4, Cost-Sharing for Land Treatment Above Multi-Purpose Small Lakes Projects. This program is proposed for revocation as the statute governing this portion of the Multi-Purpose Small Lakes Program has been revised. These land treatment practices are now provided under the Water Resources Cost-Share and Non-Point Source Pollution Control Programs. No economic impact is anticipated upon governmental agencies with revocation of the Cost-Sharing for Land Treatment Above Multi-Purpose Small Lakes Program. All benefits accrued by landowners and construction contractors and local taxing authorities will be maintained by the Water Resources Cost-Share Program.

The equalized assessed tangible valuation for computation of bonded debt limitations is \$344,260,686. The total general obligation indebtedness of the city as of the date of the notes, including the notes being sold, is \$40,733,007.

The notes will be sold subject to the approving legal opinion of Gilmore & Bell, P.C., Kansas City, Missouri, bond counsel, which opinion will be furnished and paid for by the city, will accompany the notes and will be delivered to the successful bidder when the notes are delivered.

Regulations****Article 25.—GRAIN WAREHOUSE**

4-25-2. Record retention. (a) Each public warehouseman shall retain the following documents for at least six years after the public warehouseman is no longer liable for the grain specified in the document:

- (1) Scale tickets;
- (2) evidence of cancelled checks;
- (3) customer ledgers;
- (4) records of daily grain position;
- (5) insurance records;
- (6) warehouse receipts; and
- (7) any other document stored electronically or by any other means that identifies, in any way, grain stored in the warehouse.

(b) Upon request of the secretary or the secretary's designee, a public warehouseman shall produce for inspection or review any of the documents required to be maintained in subsection (a) of this regulation. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102, 34-228, 34-236, 34-246, 34-249a, 34-295a, 34-295b, and 34-2,104; effective March 8, 2002.)

4-25-3. Return of documents. Each public warehouseman shall return to the secretary all unused warehouse receipts and all Kansas public warehouseman licenses when either of the following occurs:

- (a) The public warehouseman is no longer engaged in business as a public warehouseman.
- (b) The name of the public warehouseman changes. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-299; effective March 8, 2002.)

4-25-4. Storage space; exception. No portion of the total bulk grain capacity shall be deleted from the licensed capacity of a public warehouse if this portion is an integral part of any one unit under license and is equipped for grain handling and warehousing. However,

any part of the licensed capacity may be reserved and designated "not for public use," if the public warehouseman submits an application to the secretary and receives the secretary's approval. A seal, a lock, or other method of segregating an area designated "not for public use" from the public warehouse may be required by the secretary. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102, 34-228 and 34-237; effective March 8, 2002.)

4-25-5. Storage liability reports. (a) The "examiner's copy" of all executed warehouse receipts for the previous month shall be postmarked by the fifth of each month and mailed to the secretary.

(b) Each local public warehouseman shall maintain current and complete records at all times with respect to all grain, including grain owned by the public warehouseman, that is stored in or handled through the warehouse. These records shall include a daily summarized position record showing the following:

(1) The total quantity of each kind of grain received and shipped, and the quantity of each kind of grain remaining in the warehouse at the close of each business day; and

(2) the public warehouseman's total storage obligation for each kind of grain at the close of each business day.

(c) The public warehouseman shall forward to the secretary, not later than the fifth day of each month, a monthly statement of stocks of grain in each elevator through the last day of the preceding month, for each licensed warehouse location. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-295a; effective March 8, 2002.)

4-25-6. Secretary's right to seal bins and weigh grain. Any grain on hand for which there are outstanding warehouse receipts may be weighed and required to be stored in sealed bins or tanks by the secretary. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-239; effective March 8, 2002.)

4-25-7. Public warehouse receipts; form. The form used for warehouse receipts shall conform to the provisions of K.S.A. 34-239 and all other applicable sections of chapter 34 of the Kansas statutes annotated, and amendments thereto, and shall include, as a part of the form, the following statement:

"The undersigned warehouseman is not the owner of the grain covered by this receipt, either solely, jointly, or in common with others, unless otherwise stated hereon. It is hereby agreed that the grain herein described has been graded as provided by law and may be stored with other grain of the same grade; that this grain is stored under all the rights, powers, privileges, and duties provided by chapter 34 of the Kansas Statutes Annotated. This grain is fully covered by fire, lightning, tornado, and internal explosion insurance. The storage, insurance, elevation, and other charges on said grain shall be governed by the published schedule of charges, which includes any legal change, in effect during the period from date of receipt of the grain until sold or delivered to the above named depositor or the depositor's order." (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102, 34-238, and 34-239; effective March 8, 2002.)

4-25-8. Scale tickets; inbound form. (a) When a depositor leaves grain in any warehouse licensed under the

provisions of chapter 34 of the Kansas statutes annotated, and amendments thereto, the grain shall be weighed and graded as provided by the laws and regulations of the state of Kansas.

(b) Each scale ticket shall be plainly marked "inbound," shall be serially numbered, and shall contain at some convenient, conspicuous point the phrase "approved by the Kansas Department of Agriculture." Each ticket shall also include lines designated for the following:

(1) The name of the licensee;

(2) the date;

(3) the name of the depositor;

(4) the gross weight;

(5) the tare weight;

(6) the net weight, and a designation of whether the driver is on or off the truck;

(7) the test weight;

(8) the price;

(9) the kind of grain; and

(10) the signature of the licensee or duly authorized agent.

Each scale ticket may contain additional information if the additional information has received the prior approval of the secretary, but scale tickets shall be used only for grain received by the public warehouseman.

(c) Each public warehouseman shall keep a copy of the scale tickets, including voided tickets, in numerical order. The public warehouseman shall furnish a copy of these tickets to an authorized examiner of the Kansas department of agriculture upon demand. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-233; effective March 8, 2002.)

4-25-9. Scale tickets; outbound form. (a) When, by any means of transportation except by rail or water, a public warehouseman licensed under the provisions of chapter 34 of the Kansas statutes annotated, and amendments thereto, ships or transfers grain, grain shall be weighed as provided by the laws and regulations of the state of Kansas.

(b) Each scale ticket shall be plainly marked "outbound," shall be serially numbered, and shall contain at some convenient, conspicuous point the phrase "approved by the Kansas Department of Agriculture." Each ticket shall include lines designated for the following:

(1) The name of the licensee;

(2) the date;

(3) the name of the customer;

(4) the gross weight;

(5) the tare weight;

(6) the net weight, and a designation of whether the driver is on or off the truck;

(7) the test weight;

(8) the price;

(9) the kind of grain; and

(10) the signature of the licensee or duly authorized agent.

Scale tickets may contain additional information if the additional information has received the prior approval of the secretary.

(c) The approved scale tickets shall not be used for custom weighing or for any other purpose or use that is not

pursuant to chapter 34 of the Kansas statutes annotated, and amendments thereto, and the regulations of the Kansas department of agriculture, but shall be used only for grain shipped or transferred by the warehouseman.

(d) Each public warehouseman shall keep a copy of the scale tickets, including voided tickets, in numerical order. The public warehouseman shall furnish a copy of these tickets to an authorized examiner of the Kansas department of agriculture upon demand. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-233; effective March 8, 2002.)

4-25-10. Grain bank grain. (a) Grain bank grain shall be considered to be the same as storage grain and shall be subject to the same regulations as those for storage grain. For grain that is processed by each public warehouseman in whose warehouse the grain was originally deposited for processing, the minimum load out and receiving charges may be zero.

(b) Grain bank grain shall be entered into the records of the public warehouseman as a liability in the same manner as that for other storage grain for which the public warehouseman is liable. Grain bank grain shall be accounted for on an individual depositor basis and shall not be shown as a part of the total grain bank grain obligation. The records for grain bank grain shall be kept on a pound, bushel, or hundredweight basis for the grain deposited. (Authorized by K.S.A. 34-102 and 34-227b; implementing K.S.A. 34-227b; effective March 8, 2002.)

4-25-11. Allowance to licensed warehouses for the purpose of handling and storage of dry edible beans. For the purpose of allowing public licensed warehouses to handle and store dry edible beans, the definition of the word "grain" in K.S.A. 34-223, and amendments thereto, shall include dry edible beans. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-223; effective March 8, 2002.)

4-25-12. Financial statements. (a) The financial statement of an applicant for a license or the financial statement of an existing grain warehouse shall show that current liquid assets equal or exceed current liabilities. If liabilities exceed liquid assets, the bond required by K.S.A. 34-229, and amendments thereto, may be amended to cover the deficiency, or an unused line of credit available to pay the depositor may offset the deficiency.

(b) If current liabilities exceed current liquid assets, the public warehouseman shall comply with subsection (a) of this regulation within 60 days from the date the secretary receives the financial statement that shows any deficiency.

(c) For the purposes of this regulation, liquid assets shall not include deferred income taxes or residential property. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102, 34-228, and 34-229; effective March 8, 2002.)

4-25-13. Appraisals. (a) If the financial statement of a public warehouseman does not reflect assets sufficient to comply with the net worth requirements of K.S.A. 34-228, and amendments thereto, the public warehouseman may acquire an appraisal. Each appraisal prepared pursuant to this regulation shall be performed by an independent appraiser certified by a generally recognized ap-

praisal society. Each public warehouseman shall submit credentials for the appraiser upon request of the secretary.

(b) Surplus designated under an appraisal shall be discounted by 30 percent to account for estimated unrealized capital gains at the time of the disposition of any grain for which the public warehouseman is liable.

(c) An appraisal prepared according to this regulation may be relied upon by the secretary for up to four years from the date of completion of the appraisal. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-228; effective March 8, 2002.)

4-25-14. Successor agreement. (a) In each successor's agreement, grain in open storage, grain bank grain, or warehouse receipts shall be identified separately. The public warehouseman whose liability is being assumed shall report within five days of closing, or within a reasonable time approved by the secretary, the amount of each commodity stored in the warehouse and shall identify the grain as grain in open storage, grain bank grain, or grain subject to a warehouse receipt. The report shall be submitted in writing on a form prescribed by the secretary.

(b) The report specified in subsection (a) of this regulation shall not be required if the change in the ownership is a change only in the name of the grain warehouse. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-228; effective March 8, 2002.)

4-25-15. Definition of 12-month period. The inspection required by K.S.A. 34-228, and amendments thereto, shall be conducted at least once in the 12-month period commencing July 1 of each year. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-228; effective March 8, 2002.)

4-25-16. Fees and charges. (a) The annual fee for a public warehouse license shall be computed as follows, based on the capacity of the public warehouse:

(b) The charge for amending a warehouse license shall be \$100.00.

(c) The charges for each special or requested examination of a warehouse shall consist of the following:

(1) \$30.00 per hour for each examiner, with a required minimum charge of four hours;

(2) subsistence expenses for each examiner; and

(3) mileage expenses for each examiner, which shall be charged, per mile driven, at the rate per mile determined by the secretary of administration pursuant to K.S.A. 75-4607, and amendments thereto.

(d) The license fee shall be the applicable amount specified in the fee schedule in subsection (a) plus \$350 for each functional unit. Each public warehouseman shall pay the hourly rate, subsistence, and mileage expenses identified in subsection (c) of this regulation for examinations necessitated by changes in storage capacity, including conditional storage space of a licensed warehouse, or by the need to confirm that a warehouse is empty. Any other charge or requirement identified in statute or regulation shall apply to the conditional or empty storage space of a public warehouse.

(e) Each public warehouseman shall pay the hourly rate, subsistence, and mileage expenses identified in subsection (c) of this regulation for examinations necessitated by changes in storage capacity, including the addition of conditional storage space in a licensed warehouse, or by the need to confirm that a warehouse is empty. Any other charge or requirement identified in statute or regulation shall apply to the conditional or empty storage space of a public warehouse. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-228; effective March 8, 2002.)

4-25-17. Transfer of grain between public warehouses. (a) A public warehouseman, as defined by K.S.A. 34-223, and amendments thereto, who lacks sufficient space and desires to transfer grain for which valid receipts have been issued may transfer this grain either by physical movement of the grain or by other methods approved by the secretary as standard industry practice, subject to the following requirements:

(1) The shipping public warehouseman shall immediately notify the secretary before the transfer of receipted grain. This notice to the secretary shall include the location where the grain will be transferred for storage. The shipping public warehouseman shall also provide written notice to all depositors who hold receipts for grain that the shipping public warehouseman may forward grain deposited on a commingled basis.

(2) For purposes of this regulation, a licensed public warehouse shall mean a warehouse operated by a public warehouseman who holds a valid license under the U.S. warehouse act for grain, or a public warehouse operated by a public warehouseman who holds a valid warehouse license for the public storage of grain or rice, issued by a state that has financial, bonding, and examination requirements for the benefit of all depositors.

(3) The shipping public warehouseman shall promptly obtain nonnegotiable warehouse receipts from the receiv-

ing public warehouseman for all transferred grain. The receipts shall be kept on forms furnished by the secretary pursuant to K.S.A. 34-238 and amendments thereto. Receipts shall not be used in any other manner except as provided by Kansas statute. The receipts shall be retained by the shipping public warehouseman to be presented to and used by department examiners in lieu of an on-site inventory. The grain covered by these receipts shall not be the property of either the receiving or shipping public warehouseman but shall be held in trust by both parties solely for the benefit of the depositors whose bailed grain was transferred individually or collectively, and the depositor or the depositor's transferee shall retain title to it.

(4) The shipping public warehouseman's bond shall be increased to consider the addition of the transferred grain to the licensed capacity of the public warehouse with the net worth requirements based on the total of the licensed capacity and the forwarded grain. The bond amount shall not be required to be more than \$500,000 unless necessary to cover a deficiency in net worth to meet the requirements of K.S.A. 34-228, and amendments thereto.

(5) The shipping public warehouseman shall continue to retain that individual's obligations to the owners for all grain deposited in the public warehouse for storage, whether forwarded or retained, and shall redeliver the grain upon demand to the depositor or the depositor's transferee at the public warehouse where the grain was first deposited for storage.

(6) Nothing in this regulation shall diminish either the right of the owner of the grain to receive on delivery or the obligation of the public warehouseman of a licensed public warehouse from which the product is transferred to deliver, to the owner, grain in the amount and of the kind, quality, and grade specified by the warehouse receipts or other evidence of storage.

(7) If it is the shipping public warehouseman's obligation by terms of the warehouse receipt or by any other agreement to insure the grain subject to the transfer, that individual shall in accordance with K.S.A. 34-236, and amendments thereto, keep this grain insured in that individual's own name or transfer the grain only to a public warehouse where the grain is fully insured.

(b) A shipping public warehouseman may transfer stored grain, as defined by K.S.A. 34-223, and amendments thereto, by complying with the provisions of paragraphs (a)(2), (a)(5), (a)(6), and (a)(7) of this regulation. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-241; effective March 8, 2002.)

4-25-18. Credit for unexpired portion of license on new or amended license. A successor to a current license holder may prorate the unused portion of the license fee to reduce the amount of a new license fee if the change in the successor is solely a change in the name of the license holder. (Authorized by K.S.A. 34-102; implementing K.S.A. 34-102 and 34-228; effective March 8, 2002.)

Article 2.—LICENSING OF SOCIAL WORKERS

102-2-3. Fees. (a) Each applicant for a new social work license shall pay the appropriate application fee as set forth below:

- (1) Licensed baccalaureate social worker (LBSW): \$100.00;
(2) licensed master social worker (LMSW): \$100.00;
(3) licensed specialist clinical social worker (LSCSW): \$100.00; and
(4) temporary license fee: \$50.00.

(b) Each applicant for license renewal shall pay the applicable fee as set forth below:

- (1) Licensed associate social worker (LASW): \$100.00;
(2) licensed baccalaureate social worker (LBSW): \$100.00;
(3) licensed master social worker (LMSW): \$100.00; and
(4) licensed specialist clinical social worker (LSCSW): \$100.00.

(c) Each applicant for license renewal after the date of its expiration shall pay, in addition to the renewal fee, the applicable penalty fee as set forth below:

- (1) Licensed associate social worker (LASW): \$100.00;
(2) licensed baccalaureate social worker (LBSW): \$100.00;
(3) licensed master social worker (LMSW): \$100.00; and
(4) licensed specialist clinical social worker (LSCSW): \$100.00.

(d) The fee for a duplicate license shall be \$20.00, and the fee for a duplicate wallet card shall be \$2.00.

(e) Each provider of continuing education programs shall pay the applicable fee as set forth below:

- (1) One-year provisional approved provider application fee: \$100.00;
(2) three-year approved provider renewal fee: \$250.00; and
(3) single-program provider fee: \$50.00.

(f) Fees to the board shall not be refundable. 102-2-4b. Continuing education approval for providers. (a) Each application to become an approved provider, as defined in K.A.R. 102-2-1a(a), or a single-program provider, as defined in K.A.R. 102-2-1a(x) shall be submitted on forms provided by the board and shall include the nonrefundable fee prescribed in K.A.R. 102-2-3.

(b) Approved providers.

(1) Each applicant for approved-provider status shall submit the application form and application fee for approved-provider status at least three months before the first scheduled program.

(2) Each applicant for approved-provider status shall submit an organizational plan that includes a written statement of purpose documenting that social work practice, values, skills, and knowledge are the bases for the provider's educational goals and objectives and administrative procedures.

(3) Each approved provider shall designate a person who meets the educational requirements for licensure to be responsible for the development of the program.

(4) Each approved provider shall develop these systems:

(A) A system for maintaining records for a period of at least three years; and

(B) a system for selection and evaluation of instructors, participant performance requirements, and provision of accessible and adequate space.

(5) Each approved provider shall maintain for at least three years a summary of each individual program offered that documents the following information:

(A) The relationship of the program to the enhancement of social work practice, values, skills, or knowledge;

(B) the learning objectives for the program and the relationship between the program content and the objectives;

(C) the licensing levels for which the program is designed and any program prerequisites;

(D) the relationship of the format and presentation methods to the learning objectives and the content, and the size and composition of the participant group;

(E) the qualifications of the instructor in the subject matter;

(F) the means of program evaluation;

(G) the program agenda. The agenda shall clearly indicate all coffee and lunch breaks; and

(H) the dates the program was given.

(6) Upon board approval of the application and payment of the initial application fee, a provider shall be provisionally approved for one year.

(7) At least 60 days before the end of the year of provisional approved-provider status and at least 60 days before the end of each succeeding three-year period of approved-provider status, each approved provider seeking renewal shall submit an application to the board. Each application for renewal of approved-provider status shall include the documentation required in paragraph (b)(5) for each program offered during that period of approved-provider status. Upon a determination by the board that

the approved provider has provided sufficient documentation as specified in paragraph (b)(5) and upon payment of the approved-provider renewal fee established in K.A.R. 102-2-3, approved-provider status shall be granted for a new three-year period.

(8) Any approved provider may be evaluated and monitored by the board by random contact of social work participants attending programs sponsored by the approved provider.

(9) Approved-provider status may be withdrawn by the board if the provider violates this regulation or if quality programs are not maintained to the board's satisfaction.

(c) Single-program providers.

(1) Each applicant for single-program provider status shall submit a separate single-program provider application form and fee for each continuing education activity or each continuing education activity date for which single-program provider status is requested.

(2) The applicant shall submit each application for single-program provider status on a board-approved form that includes a description of the following items:

(A) The relationship of the program to the enhancement of social work practice, values, skills, or knowledge;

(B) the learning objectives for the program and the relationship between the program content and the objectives;

(C) the licensing levels for which the program is designed and any program prerequisites;

(D) the relationship of the format and presentation methods to the learning objectives and the content, and the size and composition of the participant group;

(E) the qualifications of the instructor in the subject matter;

(F) the means of program evaluation;

(G) the program agenda. The agenda shall clearly indicate all coffee and lunch breaks; and

(H) the date or dates the program is to be given.

(3) Each applicant shall submit the required application fee with the completed single-program provider application. If the completed single-program provider application form is not received in the board office at least 30 days before the scheduled continuing education activity, the application may not be processed or approved by the board.

(4) Single-program provider status may be withdrawn by the board if the provider violates this regulation or if the quality of the program is not satisfactory to the board.

(d) Each single-program provider and approved provider shall maintain a record of each social worker's attendance for a period of at least three years.

(e) Each single-program provider and approved provider shall provide each social work participant with verification of the participant's attendance. This verification shall be on forms approved by the board.
