Notice of Available Grant Funding

Grant funds are available from the Federal Victims of Crime Act (VOCA) for the federal year of October 1, 2002 through September 30, 2004, to eligible applicants. The purpose of this grant program is to fund public and private not-for-profit agencies that provide direct assistance to crime victims. For the purposes of this grant program, a crime victim is a person who has suffered physical, sexual and emotional harm as a result of the commission of a crime. Direct services are defined as those efforts that (1) respond to the emotional and physical needs of crime victims; (2) assist primary and secondary victims of crime to stabilize their lives after a victimization; (3) assist victims to understand and participate in the criminal justice system; and (4) provide victims of crime with a measure of safety, such as boarding up windows and replacing or repairing locks, etc.

Priority shall be given to victims of sexual assault, domestic abuse and child abuse. Thus, a minimum of 10 percent of each federal fiscal year grant (30 percent total) will be allocated to each of these categories of crime victims. An additional 10 percent of each VOCA grant will be allocated to victims of violent crime (other than "pri-

ority" category victims) who were "previously underserved." VOCA crime victim assistance grant funds can be used to enhance or expand services and cannot be used to supplant state and local funds that would otherwise be available for crime victim services.

There is a match requirement of a minimum of 20 percent cash or in-kind match of the total VOCA grant project (VOCA grant award plus match). The exception is the subgrantees that are Native American tribes/organizations located on reservations. Whether new or existing, their match requirement is 5 percent cash or in-kind match, of the total VOCA grant project, (VOCA) grant award plus match.

Notice of Deadlines for Individual Artist Program

The Kansas Arts Commission has announced opportunities for Kansas artists available through the Individual Artist Program for 2002-2003, including the Kansas Touring Program Roster and the Kansas Artist Fellowships and Mini-Fellowships.

The commission is accepting applications from individual performing artists who live in Kansas and from Kansas-based performing groups, companies and ensembles for three-year appointments to the roster of the Kansas Touring Program. Roster artists whose three-year terms are expiring also must reapply and be reevaluated to be considered for another appointment.

This roster of solo and ensemble artists generally includes—but is not limited to—storytelling, mime, dance, theater for adults and children, and classical, folk, ethnic, blues, jazz and gospel music.

Each eligible application and its support materials will be reviewed by advisory panels of professionals and experts, and artists will be notified in September 2002 if they have been accepted for the roster.

The application deadline for the Kansas Touring Program Roster is Friday, July 12. The application deadline for both the Kansas Artist Fellowships and the Mini-Fellowships is Friday, October 18.

Completed applications with required support materials must bear an official U.S. Postal Service postmark not later than the deadline date. Applications hand-carried or sent by express mail or overnight delivery must be received in the commission office not later than 5 p.m. on the deadline date or they will not be accepted.

The commission may award a Kansas Artist Fellowship of \$5,000 to a qualified artist in each of the following disciplines: Music composition, choreography, interdisciplinary/performance art, film/video and playwriting.

Up to 12 Mini-Fellowships of \$500 each also are offered. An eligible artist may apply for a Mini-Fellowship in any one of the following disciplines: Fiction, poetry, two-dimensional visual art, three-dimensional visual art, crafts, music composition, choreography, film/video, interdisciplinary/performance art and playwriting.

Fellowship applications will be evaluated by advisory panels of professionals and experts, and the applicants will be notified of the outcome by February 2003.

Notice of Hearing on Proposed Administrative Regulations

A public hearing will be conducted at 10 a.m. Wednesday, July 24, at the office of the Kansas State Board of Healing Arts, 235 S. Topeka Blvd., Topeka, to consider a proposed new regulation, K.A.R. 100-22-4, dealing with each licensee who represents to the public that they are credentialed by a specialty organization or board to identify the specialty board that has granted the credential to the licensee.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the above referenced rule and regulation. All interested parties may submit comments prior to the hearing to the Board of Healing Arts at the address above. All interested parties will be given a reasonable opportunity to present their views, orally or in writing, concerning the adoption of the regulation during the hearing. In order to give all persons an opportunity to present their views, it may be necessary to request each participant to limit any oral presentations to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the regulation being considered and the economic impact statement in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Melissa Kipp at (785) 368-6425. Handicapped parking is located at the west end of the Hutton Building, and the northwest entrance to the building is accessible.

The proposed new rule and regulation to be considered at the hearing and its respective economic impact is as follows:

K.A.R. 100-22-4. Description of specialty board affiliation. This regulation states that each licensee who represents to the public that the licensee is credentialed by a specialty organization or board other than a state licensing agency, including through the use of the description "board-certified" in connection with the licensee's name, shall, in the same medium as that in which the representation appears, identify the specialty board that has granted the credential to the licensee. Any departure from this regulation shall constitute prima facie evidence of dishonorable conduct.

The regulation is not mandated by any federal law, and there is no foreseen cost to either the board or the public to implement this new regulation.

Permanent Administrative Regulations

Article 4.—ACCIDENT AND HEALTH INSURANCE

40-4-37. **Long-term care insurance; application; definitions.** (a) These regulations shall apply to individual or group long-term care insurance policies, subscriber contracts, endorsements, and riders delivered or issued for delivery in this state by the following:

- (1) Insurance companies;
- (2) fraternal benefit societies;
- (3) nonprofit hospital and medical service corporations; and
- (4) health maintenance organizations.

(b) A policy, rider, or endorsement shall not be advertised, described, solicited, or issued for delivery in this state as long-term care insurance unless it conforms to the requirements of these regulations.

(c) As used in these regulations, these terms shall have the following meanings:

- (1) "Long-term care insurance," "group long-term care insurance," "commissioner," "applicant," "certifi-

(continued)

cate," and "policy" shall have the meanings set forth in K.S.A. 40-2227, and amendments thereto.

(2) "Medicare" means programs established by the "health insurance for the aged act," Title XVIII of the social security amendments of 1965, as then constituted or later amended.

(3) "Nursing facility" means a home, residence, or institution, other than a hospital, that is primarily engaged in providing nursing care and related services on an inpatient basis under a license issued by the appropriate licensing agency. A nursing facility may be a freestanding facility, including the following:

- (A) Nursing facility;
- (B) skilled nursing home;
- (C) intermediate nursing care home;
- (D) assisted living facility; and
- (E) residential health care facility.

Each definition of a nursing facility shall adhere to the above definition unless otherwise approved by the commissioner of insurance.

(4) No insurance carrier shall define "mental or nervous disorder" more restrictively than any of the following:

- (A) Neurosis;
- (B) psychoneurosis;
- (C) psychopathy;
- (D) psychosis; or

(E) any mental or emotional disease or disorder. However, no policy, contract, or rider shall exclude or limit benefits on the basis of organic brain disease, including Alzheimer's disease or senile dementia.

(5) The insurer may define "nurse" so that the description is restricted to a certain type of nurse, whether a registered graduate professional nurse, a licensed practical nurse, or a licensed vocational nurse. If the words "nurse," "trained nurse," or "registered nurse" are used without specific instruction, then the insurer shall recognize the services of any individual who qualified under this terminology in accordance with the applicable statutes or administrative regulations of the licensing or registry board of the state.

(6) The insurer may include the words "duly qualified physician" or "duly licensed physician" in its definition of "physician." An insurer using these terms shall recognize and accept, to the extent of its obligation under the contract, all providers of medical care and treatment when these services are within the scope of the provider's licensed authority and are provided pursuant to applicable laws.

(7) "Sickness" shall include an illness or disease of an insured person that first manifests itself after the effective date of insurance and while the insurance is in force. A definition of sickness may provide for a waiting period which shall not exceed 30 days after the effective date of the coverage of the insured person. The definition may be further modified to exclude illnesses or diseases for which benefits are provided under any workers' compensation, occupational disease, employer's liability, or similar law.

(8) "Guaranteed renewable" means both of the following:

(A) The insured may continue the long-term care insurance in force by the timely payment of premiums; and
(B) the insurer shall not unilaterally make any change in any provision of the policy or rider while the insurance is in force and shall not decline to renew the policy. However, the insurer may revise the rates on a class basis.

(9) "Noncancellable" means that the insured may continue the long-term care insurance in force by timely paying premiums during which period the insurer shall not unilaterally make any change in any provision of the insurance or in the premium rate.

(10) "Lapse" means termination of a policy due to the policyholder's failure to pay the premium within the time required.

(11)(A) "Exceptional increase" means only an increase filed by an insurer as exceptional for which the commissioner determines that the need for the premium rate increase is justified due to changes in laws or regulations applicable to long-term care coverage in this state, or due to increased and unexpected utilization that affects the majority of insurers of similar products.

(B) Exceptional increases shall be subject to the following:

(i) Except as provided in K.A.R. 40-4-37t, exceptional increases shall be subject to the same requirements as those for other premium rate schedule increases.

(ii) A review by an independent actuary or a professional actuarial body of the basis for a request than an increase be considered an exceptional increase may be requested by the commissioner.

(iii) Potential offsets to higher claim costs shall also be determined by the commissioner in determining that the necessary basis for an exceptional increase exists.

(12) "Incidental," as used in K.A.R. 40-4-37t(j), means that the value of the long-term care benefits provided is less than 10 percent of the total value of the benefits provided over the life of the policy. These values shall be measured from the date of issue.

(13) "Qualified actuary" means a member in good standing of the American academy of actuaries.

(14) "Similar policy forms" means all of the long-term care insurance policies and certificates issued by an insurer in the same long-term care benefit classification as the policy form being considered. Certificates of groups that meet the definition in K.S.A. 40-2227(e), and amendments thereto, shall not be considered similar to certificates or policies otherwise issued as long-term care insurance, but shall be considered similar to other comparable certificates with the same long-term care benefits classifications. For purposes of determining similar policy forms, long-term care benefit classifications shall be defined as follows:

- (A) Institutional long-term care benefits only;
- (B) noninstitutional long-term care benefits only; or
- (C) comprehensive long-term care benefits.

(d) K.A.R. 40-4-37a, 40-4-37f, and 40-4-37i shall not apply to group long-term care insurance policies issued to an employer-employee group. (Authorized by K.S.A. 40-103, K.S.A. 40-2228; implementing K.S.A. 40-2228; effective, T-89-9, March 18, 1988; effective Sept. 12, 1988; amended Jan. 6, 1992; amended Jan. 4, 1993; amended Feb. 9, 1996; amended May 31, 2002.)

40-4-37s. **Long-term care insurance; required disclosure of rating practices to consumers.** (a) Except as provided in subsection (b) of this regulation, this regulation shall apply to any long-term care policy or certificate issued in this state six or more months after the adoption of this regulation.

(b) For certificates issued on and after the effective date of this regulation under a group long-term care insurance policy as defined in K.S.A. 40-2227(e) and amendments thereto, which policy was in force at the time this regulation became effective, the provisions of this regulation shall apply on the policy anniversary following the date that is 12 months after the adoption of this regulation.

(c) Other than for policies for which no applicable premium rate or rate schedule increases can be made or for which the method of application does not allow for delivery at the time of application or enrollment, each insurer shall provide all the following information to the applicant at the time of application or enrollment.

(1) A statement that the policy may be subject to rate increases in the future;

(2) an explanation of potential future premium rate revisions, and the policyholder's or certificate holder's option in the event of a premium rate revision;

(3) the premium rate or rate schedules applicable to the applicant that will be in effect until a request is made for an increase;

(4) a general explanation for applying premium rate or rate schedule adjustments that shall include the following:

(A) A description of when premium rate or rate schedule adjustments will be effective including the next anniversary date, next billing date; and

(B) the right to a revised premium rate or rate schedule as specified in paragraph (c)(2) of this regulation if the premium rate or rate schedule is changed;

(5) information regarding each premium rate increase on this policy form or similar policy forms over the past 10 years for this state or any other state that, at a minimum, identifies the following:

(A) The policy forms for which premium rates have been increased;

(B) the calendar years when the form was available for purchase; and

(C) the amount or percent of each increase. The percentage may be expressed as a percentage of the premium rate before the increase, and may also be expressed as minimum and maximum percentages if the rate increase is variable by rating characteristics.

(d)(1) The insurer may, in a fair manner, provide additional explanatory information related to rate increases.

(2) Each insurer shall have the right to exclude from the disclosure premium rate increases that apply only to blocks of business acquired from other nonaffiliated insurers or the long-term care policies acquired from other nonaffiliated insurers if those increases occurred before the acquisition.

(3) If an acquiring insurer files for a rate increase on a long-term care policy form acquired from nonaffiliated insurers or a block of policy forms acquired from nonaffiliated insurers on or before the later of the effective date of this regulation, or the end of a 24-month period follow-

ing the acquisition of the block or policies, the acquiring insurer may exclude that rate increase from the disclosure. However, the nonaffiliated selling company shall include the disclosure of that rate increase in accordance with paragraph (c)(5) of this regulation.

(4) If the acquiring insurer described in paragraph (d)(3) of this regulation files for a subsequent rate increase, even within the 24-month period, on the same policy form acquired from nonaffiliated insurers or block of policy forms acquired from nonaffiliated insurers referenced in paragraph (d)(3) of this regulation, the acquiring insurer shall make all disclosures required by paragraph (c)(5) of this regulation, including disclosure of the earlier rate increase referenced in paragraph (d)(3) of this regulation.

(e) Each applicant shall sign an acknowledgement at the time of application, unless the method of application does not allow for signature at that time, that the insurer made the disclosures required under paragraphs (c)(1) and (5) of this regulation. If due to the method of application the applicant cannot sign an acknowledgement at the time of application, the applicant shall sign no later than at the time of delivery of the policy or certificate.

(f) Each insurer shall provide notice of an upcoming premium rate schedule increase to all policyholders or certificate holders, if applicable, at least 45 days before the implementation of the premium rate increase by the insurer. The notice shall include the information required by subsection (c) of this regulation when the rate increase is implemented.

(g) Each insurer shall use the forms found in appendices B and F of the national association of insurance commissioners' "long-term care insurance model regulation," June 13, 2000 edition, which are hereby adopted by reference, to comply with the requirements of subsections (a), (b), and (c) of this regulation. (Authorized by K.S.A. 40-103 and K.S.A. 40-2228; implementing K.S.A. 40-2228; effective May 31, 2002.)

Permanent Administrative Regulations

Article 1.—GENERAL PROVISIONS

26-1-1. **Definitions.** (a) "Area agency" and "area agency on aging" mean the agency or organization within a planning and service area that has been designated by the secretary to develop, implement, and administer a plan for the delivery of a comprehensive and coordinated system of services to older persons in the planning and service area.

(b) "Area plan" means the document developed by an area agency that describes the comprehensive and coordinated system of services to be provided to older persons in a planning and service area.

(c) "Comprehensive and coordinated system of services" means a program of interrelated supportive and nutrition services designed to meet the needs of older persons in a planning and service area.

(d) "Contract" means a procurement agreement.

(e) "Contractee" means the party or parties who are under contract with the department or an area agency to provide services to older persons in a planning and service area.

(f) "Contribution" means a donation of money or vision card units that is given by a customer to pay to the provider a portion or the total cost of services received.

(g) "Cost sharing or matching" means the value of third-party in-kind or cash contributions and the portion of the costs of a federally assisted or state-assisted project or program not borne by the federal or state government.

(h) "Department" means the Kansas department on aging, created by K.S.A. 75-5903, and amendments thereto.

(i) "Federal act" means the older Americans act of 1965, as amended in 2000.

(j) "Final financial report" means a contractee-prepared or grantee-prepared document that contains an accurate and complete disclosure of the financial results of the contract, grant, subcontract, or subgrant.

(k) "Grant" means an award of financial assistance in the form of money, or property in lieu of money, by the department.

(l) "Grantee" means any legal entity to which a grant is awarded and that is accountable to the department for the use of the grant. The grantee is the entire legal entity even if only a particular component of the entity is designated in the grant.

(m) "Granting agency" means the Kansas department on aging.

(n) "Greatest economic need" means the need for services resulting from an annual income level at or below the poverty threshold established annually by the federal office of health and human services.

(o) "Greatest social need" means the need for services caused by noneconomic factors that restricts an individual's ability to perform normal daily tasks or that threaten the capacity to live independently. Noneconomic factors shall include physical and mental disabilities, language barriers, and cultural or social isolation including that caused by racial or ethnic status.

(p) "Indian tribal organization" means the recognized governing body of any Indian tribe, or any legally established organization of Indians that is controlled, sanctioned, or chartered by the governing body of an Indian tribe.

(q) "In-home meal provider" means any legal entity to which funds are paid for the purpose of providing home-delivered meals under the in-home nutrition programs.

(r) "In-home service" means the provision of health, medical, or social services to a private individual in the individual's noninstitutional place of residence.

(s) "Kansan" means any person who currently resides within the state of Kansas.

(t) "Metropolitan area" means a standard metropolitan statistical area as defined by the census bureau.

(u) "Modification of a grant or contract" means a change in an area plan or other grants or contracts that would result in any of the following:

(1) Alteration of the program scope, planned objectives, or manner in which services are delivered;

(2) provision of financial assistance or payments to any entity not authorized by the original grant or contract;

(3) alteration of the approved budget of the original grant or contract.

(v) "Monthly gross income" means the monthly sum of income received by an individual or couple from the following sources:

(1) Wages or salary;

(2) income from self-employment;

(3) social security;

(4) dividends, interest, income from estate or trusts, rental income, or royalties;

(5) public assistance or welfare payment;

(6) pensions and annuities;

(7) unemployment compensation;

(8) workers compensation;

(9) alimony;

(10) veteran's pensions; and

(11) adjusted net farm income.

(w) "Notification of grant award" and "NGA" mean the document, issued by the department, awarding financial assistance for the provision of services to older persons and specifying the terms of the grant.

(x) "Obligation" means the number of orders placed, contracts and subgrants awarded, services received, and similar transactions during the grant period that will require payment within 75 days following the last day in which the grant is active.

(y) "Older person" means any person 60 years of age or older.

(z) "Planning and service area" and "PSA" mean a geographic area of the state designated by the department for the purpose of planning, development, delivery, and overall administration of services under an area plan.

(aa) "Program income" and "project income" mean gross income received by the grantee or subgrantee and directly generated by a grant-supported activity, or earned only as a result of the grant agreement during the period.

(bb) "Purchase of service contract or grant" means an award of financial assistance in which the payment is made on a reimbursement basis at a unit rate of cost of service with an upper limit on the total cost of the grant. Payment shall be made in the form of money, or property in lieu of money.

(cc) "Redesignation" means a change in the geographic boundaries of a planning and service area or selection of an area agency that is different from the area agency previously designated for a particular planning and service area.

(dd) "Request for Proposal" and "RFP" mean the document containing criteria that is used to solicit applications for a contract or subgrant from potential service providers.

(ee) "Secretary" means the secretary of the Kansas department on aging.

(ff) "Self-employment" means work for income performed by a person engaged on that person's own account in a business, farm, or other enterprise.

(gg) "Service provider" means any legal entity that is obligated to provide services to older persons in any planning and service area.

(hh) "State act" means the Kansas act on aging, K.S.A. 75-5901 through K.S.A. 75-5925, and amendments thereto.

(ii) "State advisory council" means the advisory council on aging created by K.S.A. 75-5911, and amendments thereto.

(jj) "State plan" means the document submitted by the department in order to receive its allotment of funds under the older Americans act.

(kk) "Subgrant" means an award of financial assistance in the form of money, or property in lieu of money, made under a grant by a grantee to a subgrantee.

(ll) "Subgrantee" means any legal entity to which a subgrant is awarded and that is accountable to the grantee for the use of the grant funds.

(mm) "Unit of local government" means either of the following:

(1) Any county, city, township, school district, or other similar political subdivision of the state, or any agency, bureau, office, or department thereof; or

(2) any Indian tribal organization.

(nn) "Unused supplies" means supplies that still have a useful life and that have not been put to use in the project or program for which they were acquired when the grant, contract, or subgrant under which they were acquired expires or is terminated. (b) Each area plan shall be submitted on forms prescribed by the secretary and shall contain all of the assurances required in section 306 of the older Americans act of 1965, as amended in 2000, and all information requested on the forms.

(c) Each area agency shall ensure that units of local government, local advisory councils, potential service providers, and older persons have an opportunity for involvement in the development of the area plan.

(d) Each area agency, as part of the area plan, shall describe the rationale for the proposed allocation of funds for services in the planning and service area. The rationale shall identify the manner in which the proposed distribution of funds will meet identified, priority nutrition, and supportive service needs.

(e) The area plan developed by the area agency shall provide assurances that the area agency will spend in each fiscal year, for services to older individuals residing in rural areas in the area agency's planning and service area, an amount not less than the amount expended for these services in the previous federal fiscal year, which shall include amounts expended under Title V and Title VII of the older Americans act of 1965. Permanent Administrative Regulations

Article 1.—REGISTRATION AND EXAMINATION OF PHARMACISTS

68-1-1a. Application for registrations or permits; withdrawal of application. After an application for a registration or permit has been accepted, the failure of the applicant or authorized representative to respond to official correspondence regarding the application, when sent by registered or certified mail, return receipt requested, shall be deemed to be a withdrawal of the application. (Authorized by and implementing K.S.A. 65-1630 and K.S.A. 2000 Supp. 65-1631; effective, E-76-31, Aug. 11, 1975; effective May 1, 1976; amended May 1, 1978; amended May 1, 1983; amended June 6, 1994; amended March 20, 1995; amended May 31, 2002.)

68-1-2a. Pharmacist-in-charge examination; acknowledgment. (a) Each prospective pharmacist-in-charge shall take a pharmacy law examination administered by the board, with a passing score of at least 85%.

The examination shall include the statutes and rules and regulations, both state and federal, governing the practice of pharmacy.

(b) Each pharmacy or registrant required to have a pharmacist-in-charge that operates for more than 30 days without a designated pharmacist-in-charge who meets the requirements of this regulation shall be deemed to be in violation of K.S.A. 65-1627(e) and amendments thereto.

(c) A pharmacist who has already passed the pharmacist-in-charge examination required by the board shall not be required to retake the examination upon assuming the duties of a pharmacist-in-charge but shall, at the time of assuming these duties, sign an acknowledgment that states both of the following:

(1) The pharmacist is not currently prevented from performing the duties of a pharmacist-in-charge by an order of the board.

(2) The pharmacist has reviewed the pharmacy act and the board's regulations and is aware of the responsibilities of a pharmacist-in-charge.

The pharmacist-in-charge shall immediately provide this acknowledgment to the board. A copy of the acknowledgment shall be maintained at the premises where the pharmacist is functioning as a pharmacist-in-charge. 68-1-3a. Qualifying pharmaceutical experience.

(a) Pharmaceutical experience that qualifies as one year of experience shall consist of 1,500 clock hours as a registered intern while being supervised by a preceptor. All hours worked when the intern is in regular attendance at an approved school of pharmacy and during vacation times and other times when the intern is enrolled but not in regular attendance at an approved school of pharmacy may be counted as qualified hours. However, not more than 60 hours shall be acquired in any one week.

(b) No time may accrue to a student before acceptance in an approved school of pharmacy or before being registered as an intern with the board. However, any foreign pharmacy graduate who has successfully passed an equivalent examination as specified in K.A.R. 68-1-1f (b) may apply for registration as an intern.

(c) Once registered as an intern, all required hours shall be completed within six years.

(d) Reciprocity shall not be denied to any applicant who is otherwise qualified and who meets both of the following conditions:

(1) Has met the internship requirements of the state from which the applicant is reciprocating; or

(2) has at least one year of experience as a registered pharmacist. (Authorized by K.S.A. 65-1630; implementing K.S.A. 2000 Supp. 65-1631; effective, E-76-31, Aug. 11, 1975; effective May 1, 1976; amended May 1, 1983; amended May 1, 1985; amended May 31, 2002.)

Article 2.—LOTTERY RETAILERS

111-2-139. **R&C Petroleum winner awareness “Starburst” promotion.** (a) In addition to compensation specified in K.A.R. 111-2-4 and 111-2-6, the Kansas lottery shall also conduct a “Starburst” promotion to enhance winner awareness at all R&C Petroleum corporate locations.

(b) The winner awareness sales promotion will commence at 5:00 a.m. on Wednesday, May 1, 2002, and end at the end of the business day as defined at K.A.R. 111-6-1 on Friday, May 31, 2002.

(c) Beginning May 1, 2002, and concluding May 31, 2002, the lottery will conduct a “Starburst” promotion at all the R&C Petroleum corporate stores located in Kansas. The stores must place a starburst decal on a visible wall or counter for every winning instant or on-line ticket that is redeemed at that retailer which wins \$10 or more. Each starburst placed should contain, where possible, the amount won, the ticket itself, and the name of the winner if written permission is obtained from the winner.

(d) For every 10 winning starbursts placed in a visible location at the retail establishment, the retailer will receive the lottery’s choice of a promotional item, with a maximum of 10 items per store. For every 25 winning starbursts placed in a visible location at the retail establishment, that retailer will be entered into a drawing for a prize from the lottery. The grand prize is a \$300 credit on the retailer’s lottery account. Second prize is a \$50 credit on the retailer’s lottery account, and third prize is a \$25 credit on the retailer’s lottery account. Each retail location is eligible to win only one of the three credit prizes.

(e) During the week preceding the start of the promotion, an information sheet will be provided for all participating retailers so that they may all start on the same day. Starbursts will be provided by the lottery. The drawings for the grand prize, second prize, and third prize will be conducted at the lottery’s Great Bend regional office on June 7, 2002. Lottery security will approve drawing procedures to be used for the drawing. (Authorized by and implementing K.S.A. 2001 Supp. 74-8710; effective, T-111-5-7-02, April 17, 2002.)

Article 4.—INSTANT GAMES AND DRAWINGS

111-4-1910. **Prize.** (a) The winner of the grand prize at the “Kansas Thunder Drawing,” which will be conducted on September 15, 2002, shall receive a 2002 Ford Thunderbird automobile.

(b) There will be three additional winners selected at the drawing and they shall each receive a \$5,000, \$3,000, or a \$2,000 cash prize.

(c) All prizes are subject to lottery validation, set-offs and deductions authorized by law.

(d) The winner of the grand prize 2002 Ford Thunderbird automobile shall return to the lottery a completed

claim form as provided by the lottery no later than 5:00 p.m. on the tenth day following the day the claim form is mailed to the person whose name was drawn or the person named on the ticket drawn will no longer be eligible for the prize. In such an event, the first eligible alternate entry drawn for that prize pursuant to subsection (e) of K.A.R. 111-4-1913 shall be declared the winner.

(e) The three additional winners of the \$5,000, \$3,000, or \$2,000 cash prizes shall return to the lottery a completed claim form as provided by the lottery no later than 5:00 p.m. on the tenth day following the day the claim form is mailed to the person whose name was drawn or the person named on the ticket drawn will no longer be eligible for the prize. In such an event, the first eligible alternate entry drawn for that prize pursuant to subsection (e) of K.A.R. 111-4-1913 shall be declared the winner. (Authorized by and implementing K.S.A. 2001 Supp. 74-8710; effective, T-111-4-17-02, March 13, 2002; amended, T-111-5-7-02, April 17, 2002.)

111-4-1911. **Method of entry.** (a) Entry into the “Kansas Thunder Drawing” to be conducted on September 15, 2002, shall be accomplished as follows:

(1) Obtain a valid “Kansas Thunder” Kansas instant lottery ticket.

(2) Determine if the ticket is a winning ticket in accordance with “Kansas Thunder” game rules. If the ticket is a winning ticket, it is not eligible for the “Kansas Thunder Drawing” and shall be redeemed in accordance with the instant game rules, except that any ticket winning a free admission to the 2002 Kansas state fair may instead be used to enter the drawing, and if so utilized, shall be considered a “non-winning ticket” for purposes of entry into the drawing.

(3) If the ticket is a valid non-winning ticket, the ticket is eligible for the drawing and the holder of the ticket may use it to enter the “Kansas Thunder Drawing.”

(4) The holder of the non-winning ticket must complete the information form on the back of the ticket in a legible manner. Only one name shall appear on a non-winning ticket entered.

(5) A receptacle or drum shall be available and entries may be made at the Kansas lottery building at the Kansas state fair between September 6, 2002, and 6:00 p.m. September 15, 2002.

(6) Players may also deposit entries for the “Kansas Thunder Drawing” at the Kansas lottery location at the Kansas Speedway, Kansas City, Kansas, during selling hours on May 31, June 1, July 5, 6, and 7, 2002.

(7) Entries other than those entered at the Kansas state fair or Kansas Speedway shall be mailed with proper postage to “Kansas Thunder Drawing,” c/o Kansas lottery, P. O. Box 7777, Lawrence, Kansas 66044-7777. Mailed entries must be received by morning mail pickup on Tuesday, September 10, 2002. More than one entry may be mailed in one envelope.

(8) The holder of the ticket is not required to personally attend the “Kansas Thunder Drawing” or be present at the time of the drawing to be determined a winner.

(9) The drawing will be conducted soon after 6:00 p.m. on Sunday, September 15, 2002.

(continued)

(b) There is no limit on the number of entries a person may make, but a person may only win one time in the drawing.

(c) Only valid non-winning "Kansas Thunder" tickets which are mailed to the "Kansas Thunder Drawing," c/o Kansas lottery, P. O. Box 7777, Lawrence, Kansas 66044-7777 with proper postage and received by the morning mail pickup in Topeka, Kansas, on Tuesday, September 10, 2002, and non-winning "Kansas Thunder" tickets entered at the Kansas Speedway or the Kansas state fair lottery building as provided in the rules herein shall be eligible for the drawing. All tickets so mailed or deposited shall be secured by the lottery until the drawing is conducted.

(d) Eligible entrants in the "Kansas Thunder Drawing" must be 18 years of age or older.

(e) Completing the information form on the non-winning ticket and entering the ticket into the drawing constitutes authorization to publicly identify the person whose entry is drawn. (Authorized by and implementing K.S.A. 2001 Supp. 74-8710; effective, T-111-4-17-02, March 13, 2002; amended, T-111-5-7-02, April 17, 2002.)

111-4-1913. **Selection of winners.** The following process shall be used for the selection of winners in the "Kansas Thunder Drawing:"

(a) Kansas lottery personnel shall pick up all mail containing "Kansas Thunder Drawing" tickets at the United States Post Office in Lawrence, Kansas, with the final pick up at the Topeka post office in the morning mail pickup on Tuesday, September 10, 2002. Following the morning mail pickup on Tuesday, September 10, 2002, the envelopes containing mailed entries will be transported to lottery headquarters and opened by lottery personnel. All mailed entries shall then be placed in a secure receptacle, transported to the state fair, and placed in the drawing receptacle or drum with all entries deposited at the state fair and the Kansas Speedway.

(b) The drawing shall be held at the Kansas state fair lottery building and shall be open to the public with lottery security personnel present. The drawing shall be audio and video taped.

(c) At the final drawing on Sunday, September 15, 2002, lottery security personnel will be present with the person designated by the executive director to perform the drawing. Prior to the drawing, if a drum is used, the drum shall be sealed and the contents mixed by rotating the drum at least 10 times. If a receptacle other than a drum is used, the contents shall be mixed with a shovel or by other means for at least three minutes prior to the drawing.

(d) The designated individual shall then unseal the drum, if a drum is used, and using the bare-arm technique, while looking away, remove a single entry from the receptacle or drum. The person whose name appears on the entry shall be the winner of the grand prize identified in K.A.R. 111-4-1910, subject to validation by the lottery as set forth in these rules.

(e) After a single entry has been drawn on September 15, 2002, and the entry has been verified as valid, nine more valid entries will be drawn, one at a time. The first three valid entries of these nine entries drawn will be

awarded in the order drawn a secondary prize of \$5,000, \$3,000, or \$2,000, respectively. The last six entries drawn will serve as alternate entries for the grand prize and secondary prizes. The alternate entries will be marked in order drawn, 1A, 2A, 3A, 4A, 5A and 6A. Each winner shall have until 5:00 p.m. on the tenth day following mailing of a claim form to the winner to present the fully-executed claim form to lottery headquarters. If the grand prize winner cannot be located or is declared ineligible, or fails to timely present a fully-executed claim form to lottery headquarters, the grand prize will be awarded to the entry drawn for the \$5,000 prize, the \$3,000 prize winner shall be awarded the \$5,000 prize, the \$2,000 prize winner shall be awarded the \$3,000 prize, and the first alternate entry shall be awarded the \$2,000 prize. The alternates will be used, if necessary, in the order drawn. If a winner or an alternate winner for the grand prize or a secondary prize cannot be located, is declared ineligible, or fails to present a fully-executed claim form to lottery headquarters as required herein, the alternate winner process shall be repeated until all prizes are properly claimed or until such time as no alternate winners remain, whichever occurs first.

(f) The Kansas lottery security official present shall review each ticket drawn to determine the validity of the entry into the "Kansas Thunder Drawing" in accordance with these regulations. If it is a valid entry and the name is legible, the event manager and the security person present shall record the name of the winner and the prize won. The prize winners shall be given or sent a prize claim form to be completed and returned as set forth in subsection (e) herein.

(g) If any entry drawn is determined to be ineligible, it shall be discarded by the security person present and another entry drawn. This procedure will be repeated until the required number of apparently eligible selections is obtained.

(h) Only non-winning "Kansas Thunder" instant tickets are eligible for the drawing.

(i) All "Kansas Thunder" tickets remaining in the drum or receptacle on September 15, 2002, after the winners and alternatives have been selected, and all entries not received in compliance with these rules, shall be destroyed pursuant to K.A.R. 111-3-34. (Authorized by and implementing K.S.A. 2001 Supp. 74-8710; effective, T-111-4-17-02, March 13, 2002; amended, T-111-5-7-02, April 17, 2002.)
