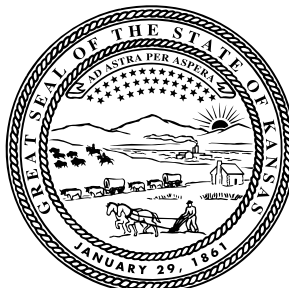

Administrative Regulations

A public hearing will be conducted at 9 a.m. Thursday, December 19, in Room 401 of the Kansas Department of Agriculture, 109 S.W. 9th, Topeka, to consider the adoption of a proposed change in an existing rule and regulation of the Meat and Poultry Program. A summary of proposed regulation and its economic impact follows.

K.A.R. 4-16-7a is proposed to increase the overtime fee from \$18 to \$25 to partially defray the agency's cost of providing inspection services in excess of set hours of operation.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rule and regulation. All interested parties may submit written comments prior to the hearing to the Secretary of Agriculture, 109 S.W. 9th, 4th Floor, Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulation during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulation and economic impact statement in an accessible format. Description: Acquisition of 150 acres of agricultural land and related improvements and equipment to be used by the owner/operator for farming purposes. The project is located at Section 15, Highland Township, Morris County, Kansas, approximately 10.25 miles east of Herington on Highway 56.

Each bond, when issued, will be a limited obligation of the Kansas Development Finance Authority and will not constitute a general obligation or indebtedness of the State of Kansas or any political subdivision thereof, including the Authority, nor will it be an indebtedness for which the faith and credit and taxing powers of the State of Kansas are pledged. The bond will be payable solely from amounts received from the respective borrower, the obligation of which will be sufficient to pay the principal of, interest and redemption premium, if any, on the bond when it becomes due.

All individuals who appear at the hearing will be given an opportunity to express their views, and all written comments previously filed with the Authority at its offices at 555 S. Kansas Ave., Suite 202, Topeka, 66603, will be considered. Additional information regarding the project may be obtained by contacting the Authority.

Any individual affected by the above-described projects may, at or prior to the hearing, file a written request with the Authority that a local hearing be held on the proposal to issue a bond to finance said project. A local hearing, if requested, would be conducted in the county where the project in question is located.

The Kansas Department of Health and Environment is soliciting comments regarding a proposed air quality operating permit. Enbridge, Inc. - KPC has applied for a Class I operating permit in accordance with the provisions of K.A.R. 28-19-510 et seq. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards and requirements applicable to each source; and the monitoring, record keeping and reporting requirements applicable to each source as of the effective date of permit issuance.

Enbridge, Inc. - KPC, Houston, Texas, owns and operates a natural gas compressor station located at Section 21, Township 27 South, Range 9 East, Greenwood County, Kansas.

A copy of the proposed permit, permit application, all supporting documentation and all information relied upon during the permit application review process is available for a 30-day public review during normal business hours at the KDHE, Bureau of Air and Radiation, 1000 S.W. Jackson, Suite 310, Topeka; and at the KDHE Southeast District Office, 1500 W. 7th, Chanute. To obtain or review the proposed permit and supporting documentation, contact Michael J. Parhomek, (785) 296-1580, at the KDHE central office; or Lynelle Stranghoner, (620) 431-2390, at the KDHE Southeast District Office. The standard departmental cost will be assessed for any copies requested.

Direct written comments or questions regarding the proposed permit to Michael J. Parhomek, KDHE, Bureau of Air and Radiation, 1000 S.W. Jackson, Suite 310, Topeka, 66612-1366. In order to be considered in formulating a final permit decision, written comments must be received by the close of business November 18.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. Article 8.—EXAMINATIONS

66-8-4. Land surveyor examinations. (a) The examinations required of an applicant for land surveying licensure shall be the following:

(1) The national council of examiners for engineering and surveying (NCEES) examinations covering the following:

- (A) The fundamentals of land surveying; and
- (B) the principles and practices of land surveying; and
- (2) an examination covering Kansas land surveying laws and practices.

(b) The examinations shall be graded by the NCEES, subject to approval by the board.

(c) Each applicant who has passed one or more sections of previous registration examinations may be granted transfer credits if approved by the board.

(d) Each applicant for a professional license as a land surveyor shall take and pass the section on the fundamentals of land surveying and shall meet the professional land surveying experience requirements under K.S.A. 74-7022, and amendments thereto, before the applicant may take the section on professional practice. (Authorized by K.S.A. 2001 Supp. 74-7013; implementing K.S.A. 74-7017; effective May 1, 1984; amended May 4, 1992; amended Feb. 22, 1993; amended Feb. 14, 1994; amended Feb. 13, 1995; amended Nov. 1, 2002.)

Article 9.—EDUCATION

66-9-5. Surveying curriculum approved by the board. Any applicant seeking licensure as a land surveyor may fulfill the education requirements by any of the following:

(a) Graduation from an approved engineering curriculum as defined in K.A.R. 66-9-4;

(b) graduation from a four-year land surveying baccalaureate curriculum accredited by the accreditation board for engineering and technology (ABET);

(c) graduation from an approved land surveying curriculum of two years from a school or college approved by the board; or

(d) graduation from an approved four-year related science curriculum, which may include geology, mathematics, chemistry, or physics. (Authorized by K.S.A. 2001 Supp. 74-7013; implementing K.S.A. 74-7022; effective Feb. 22, 1993; amended Feb. 14, 1994; amended Nov. 1, 2002.)

Article 10.—EXPERIENCE

66-10-1. Architectural experience of a character satisfactory to the board. Each applicant shall complete the intern development program (IDP) as defined in the "intern development program guidelines, 2001-2002," which is published by the national council of architectural registration boards (NCARB) and hereby adopted by reference. Each applicant shall provide a completed and

bound record of architectural experience in the form transmitted by the NCARB. (Authorized by K.S.A. 2001 Supp. 74-7013; implementing K.S.A. 74-7019; effective May 1, 1984; amended May 4, 1992; amended Feb. 22, 1993; amended Feb. 14, 1994; amended Feb. 13, 1995; amended March 1, 1996; amended Feb. 6, 1998; amended Feb. 9, 2001; amended Nov. 1, 2002.)

66-10-9. Engineering experience of a character that is satisfactory to the board. (a) The work experience required of each applicant shall expose the applicant to all phases of work integral to the discipline of engineering in which the applicant claims qualification to practice and shall be verified as set forth in paragraph (b)(2) of this regulation.

(b) Engineering work experience shall meet the following requirements:

(1) Fall within the definition of "the practice of engineering" pursuant to K.S.A. 74-7003, and amendments thereto; and

(2) be directly supervised and verified by a licensed, professional engineer for work performed after May 1, 1988, except that direct supervision of a licensed, professional engineer shall not be required of the employees of any person, firm, or corporation not offering services in the technical professions to the public, although verification by the applicant's supervisor shall still be required.

(c) The following guidelines shall be used to assign credit for work experience.

(1) The education and experience evaluations by previous boards or other state boards may be accepted for work experience before the fundamentals of engineering examination. The applicant shall demonstrate four years of acceptable experience.

(2) One year of credit toward the experience requirement may be given for a master's degree in engineering.

(3) Teaching engineering in a college or university that offers an approved engineering curriculum of four years or more may be considered engineering experience.

(4) Experience credit shall not be allowed for work performed before graduation.

(d) Each applicant shall supply at least three references from licensed professional engineers who are familiar with the applicant's engineering experience. (Authorized by K.S.A. 2001 Supp. 74-7013; implementing K.S.A. 74-7021; effective May 1, 1984; amended April 9, 1990; amended May 4, 1992; amended Feb. 14, 1994; amended Feb. 13, 1995; amended Nov. 1, 2002.)

66-10-10b. Surveying experience required of a graduate in a four-year related science curriculum other than land surveying and engineering. Each graduate of a four-year curriculum considered by the board to be related to land surveying, which may include geology, mathematics, chemistry, or physics, shall provide a verified record of six years of surveying experience as specified by K.S.A. 74-7022(a), and amendments thereto. At least four years of this experience shall have been in progressive land surveying, as defined in K.A.R. 66-10-12(b)(1). (Authorized by K.S.A. 2001 Supp. 74-7013; implementing K.S.A. 74-7022; effective Nov. 1, 2002.)

66-10-13. Geology experience of a character that is satisfactory to the board. (a) The work experience required of each applicant shall expose the applicant to all phases of work integral to the discipline of geology in which the applicant claims qualification to practice and shall be verified as set forth in paragraph (b)(2) of this regulation.

(b) Geology experience shall meet these criteria:

(1) Fall within the definition of "the practice of geology" in K.S.A. 74-7003, and amendments thereto; and

(2) be directly supervised and verified by a licensed geologist for work performed after July 1, 2000. However, direct supervision of a licensed geologist shall not be required of the employees of any person, firm, or corporation that does not offer services in the technical professions to the public, although verification by the applicant's supervisor shall still be required.

(c) The following shall be used to assess credit for work experience:

(1) Experience credit shall not be allowed for work performed before graduation.

(2) One year of credit toward the experience requirement may be given for a master's degree in geology or in a closely related specialty area acceptable to the board.

(3) Teaching geology in a college or university that offers an approved geology curriculum of four years or more may be considered geology experience.

(d) Each applicant shall supply at least three references who are familiar with the applicant's geology experience. At least two of these references shall be licensed geologists. One of the three references may be a professional engineer. (Authorized by K.S.A. 2001 Supp. 74-7013; implementing K.S.A. 2001 Supp. 74-7041; effective Feb. 4, 2000; amended Feb. 9, 2001; amended Nov. 2, 2001; amended Nov. 1, 2002.)

Article 11.—INTERN CERTIFICATION AND ADMISSION TO THE FUNDAMENTALS EXAMINATION

66-11-1a. Intern geologist defined. "Intern geologist" means an individual who meets both of the following requirements: (a) Has taken and passed the written examination in the fundamentals of geology as administered by the national association of state boards of geologists (ASBOG); and

(b) has been issued an intern geologist certificate. This certification shall be granted only after satisfactory proof of graduation has been provided to the board. (Authorized by K.S.A. 2001 Supp. 74-7013; implementing K.S.A. 2001 Supp. 74-7041 and K.S.A. 2001 Supp. 74-7035; effective Nov. 1, 2002.)

66-11-1b. Intern land surveyor defined. "Intern land surveyor" means an individual who meets both of the following requirements: (a) Has taken and passed the written examination in the fundamentals of land surveying as administered by the national council of examiners for engineering and surveying (NCEES); and

(b) has been issued an intern land surveyor certificate. (Authorized by K.S.A. 2001 Supp. 74-7013 and K.S.A. 2001 Supp. 74-7035; implementing K.S.A. 74-7022; effective Nov. 1, 2002.)

66-11-5. Admission requirements for fundamentals of land surveying examination. (a) Each application shall be reviewed by the board to determine whether the requirements for admission to take the examination have been met. Once the board establishes that these requirements have been met, the applicant shall be allowed to sit for the examination.

(b) Each applicant shall meet one of the following requirements for admission before taking the examination:

(1) Graduation from an accredited land surveying curriculum, as defined in K.A.R. 66-9-5(b) and (c);

(2) verification of a combination of education and experience of a character satisfactory to the board. In evaluating an applicant's record, a determination shall be made by the board of whether, based on the applicant's educational background, the applicant requires no more than four years of additional progressive land surveying experience to qualify for admission to the practice of land surveying examination; or

(3) through June 30, 2005, verification of four years of experience of a character satisfactory to the board, of which two years shall be in progressive land surveying as defined in K.A.R. 66-10-12. (Authorized by K.S.A. 2001 Supp. 74-7013; implementing K.S.A. 74-7022; effective Nov. 1, 2002.)

Article 14.—CONTINUING EDUCATION REQUIREMENTS

66-14-6. Exemptions. A licensee may be exempt, upon board review and approval, from continuing education requirements in any of the following situations:

(a) The licensee is renewing for the first time.

(b) The licensee is called to active duty in the armed forces of the United States for a period of time exceeding 120 consecutive days in a calendar year. This individual may be exempt from obtaining the 15 professional development hours (PDH) required only during that year.

(c) The licensee experiences physical disability, illness, or other extenuating circumstances and certifies that the licensee is not currently practicing a technical profession. The licensee shall provide supporting documentation for the board's review and approval. If the licensee elects to return to practice, the licensee shall earn 30 professional development hours for the last renewal period or shall meet the requirement specified in K.A.R. 66-14-10 or K.A.R. 66-14-11.

(d) The licensee lists the licensee's occupation as retired on the board-approved renewal form and certifies that the licensee is not currently practicing a technical profession. If the licensee elects to return to practice, the licensee shall earn 30 professional development hours for the last renewal period or shall meet the requirement specified in K.A.R. 66-14-10 or K.A.R. 66-14-11. (Authorized by K.S.A. 2001 Supp. 74-7013; implementing K.S.A. 2001 Supp. 74-7013 and 74-7025; effective March 1, 1996; amended Feb. 4, 2000; amended Nov. 1, 2002.)

28-14-1. Fees for analysis of samples from public water supply systems. All laboratory analyses conducted in the division of health and environmental laboratories of the Kansas department of health and environment shall require payment as specified in K.A.R. 28-14-2, except for analyses requested by departmental staff. The fee for any analysis not specified in K.A.R. 28-14-2 shall be based on the cost of the analysis as determined by the secretary. (Authorized by and implementing K.S.A 65-156 and K.S.A. 2001 Supp. 65-166a; effective Jan. 1, 1966; amended, E-79-13, June 15, 1978; amended May 1, 1979; amended Nov. 1, 2002.)

28-14-2. Schedule of fees. All public water supply systems submitting samples for analysis to the division of health and environmental laboratories of the Kansas department of health and environment as specified in K.A.R. 28-15-14 shall receive a quarterly statement reflecting the cost of services rendered during the previous calendar quarter. Fees shall be paid to the Kansas department of health and environment within 30 days of receipt of statement. Failure to pay fees shall result in denial of future analytical services.

Unmarked Burial Sites Preservation Board

Permanent Administrative
Regulations

Article 1.—UNMARKED BURIAL SITES

126-1-1. Unmarked burial site registry. (a) “Registry” means the unmarked burial site registry established by the board pursuant to K.S.A. 75-2745, and amendments thereto.

(b) The types of evidence submitted to the board for its consideration in determining whether or not to list a site on the registry may include any of the following:

- (1) The absence of obvious grave markers;
- (2) documentation, oral or written, which may include any of the following:

(A) A statement from any landowner of record of the site;

(B) a statement from any potential descendant; or

(C) a statement from any member of an American Indian tribe potentially having a continuing cultural affiliation with the decedent; or

(3) physical evidence at the site. (Authorized by and implementing K.S.A. 75-2745 and 75-2746; effective Nov. 1, 2002.)

126-1-2. Permits for excavation, study, display, and reinterment. (a) Except as provided in subsection (b), a permit shall be required for each of the following actions:

(1) The excavation of any unmarked burial site, registered or unregistered;

(2) the study of human skeletal remains from any unmarked burial site, including any goods interred with those remains;

(3) the reinterment of human skeletal remains from any unmarked burial site, including any goods originally excavated with those remains; and

(4) the public display of human skeletal remains from any unmarked burial site, including any goods excavated with those remains.

(b) A permit shall not be required for any of the following actions:

(1) The disinterment, possession, display, transfer, reinterment, or disposition of human skeletal remains, or goods interred with those remains, when undertaken by a criminal justice or law enforcement agency, coroner, or medical examiner in conjunction with a criminal investigation or pursuant to K.S.A. 22a-231 and amendments thereto;

(2) any limited test excavation of a suspected unmarked burial site under the supervision of the chairperson of the board to determine whether a property contains a burial site; or

(3) the inadvertent discovery of an unmarked burial site if, immediately upon the discovery of human remains, all excavation ceases until a permit is obtained from the board.

(c) Each permit request shall include the following information:

(1) The name, address, and telephone number of the applicant and, if the applicant is an organization, the name of the contact person;

(2) a statement detailing the reason for the permit request; and

(3) a detailed work plan, which shall include the following information:

(A) The name of the archeologist who will supervise any excavation or disinterment. The supervising archeologist shall meet the qualifications specified in subsection (d);

(B) the name and credentials of the physical anthropologist who will supervise any study of remains;

(C) the legal description of the site of excavation or reinterment, and either photographs or digital images of the site;

(D) a detailed description of any proposed studies of the remains;

(E) a detailed description of any proposed plan to display the remains; and

(F)(i) A proposed date and location of reinterment; or

(ii) a proposed date and description of any type of disposition other than reinterment of the disinterred remains or goods, or both, from the site.

(d) Each supervising archeologist shall meet the following minimum professional qualifications:

(1) A graduate degree in archeology, anthropology, or a closely related field;

(2) at least one year of full-time professional experience or equivalent specialized training in archeological research, administration, or management;

(3) at least four months of supervised field and analytic experience in general North American archeology;

(4) the demonstrated ability to carry research to completion; and

(5) at least one year of full-time professional experience at a supervisory level in the study of archeological resources of the prehistoric period.

(e) A nonrefundable \$50.00 application fee shall accompany each permit request, except an emergency request

for a permit or a permit for which the board waives this fee.

(f) The following factors shall be considered by the board:

(1)(A) The medical, educational, or scientific reasons for the permit;

(B) the manner in which any work is to be conducted; and

(C) the qualifications of the participants in the project; and

(2) the concerns of any potential descendants, including members of American Indian tribes potentially having a continuing cultural affiliation with the human remains or burial goods, or both.

(g) A permit to excavate may be granted if both of the following conditions are met:

(1) It is necessary to relocate an unmarked burial site for public health, safety, and welfare or for substantial economic reasons.

(2) The board finds that adequate plans for reinterment have been made.

(h) An excavation, study, display, or reinterment carried out pursuant to a permit shall not exceed the work plan authorized by the permit.

(i) One or more permits may be issued on an emergency basis by the chairperson of the board, with the concurrence of any board member. The reason for issuing any permit on an emergency basis shall consist of one of the following:

(1) To prevent imminent danger to life, significant harm to property, or significant economic loss;

(2) to prevent imminent destruction or desecration of an unmarked burial site; or

(3) to prevent an injustice or undue hardship.

(j) Each permittee shall maintain a copy of the permit at the location of any work carried out under that permit. (Authorized by and implementing K.S.A. 75-2745 and 75-2747; effective Nov. 1, 2002.)
