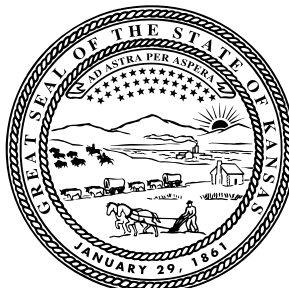

**Invitation to Pre-Qualify for Construction Project**

The Kansas State University Foundation seeks to construct a new building for the Department of Grain Science at Kansas State University, Manhattan. This building is the International Grains Program building (known as the IGP building). It is a privately-funded, 19,732 square foot masonry structure, and the estimated construction cost is \$3,381,000. The IGP building contains a large conference room, classrooms, offices and a dining facility. Construction documents have been prepared by HTK Architects of Topeka.

Prospective bidders are invited by the Foundation to submit the AIA form *Contractor's Qualification Statement* for evaluation by the Foundation and the university. Upon review of the submitted forms, a list of pre-qualified contractors will be developed, and these contractors will be invited to bid the project. Award of the contract shall be based on the low bidder. The schedule for this process is as follows:

- October 31** Contractors to submit Contractor's Qualification Statement
- November 4** Foundation to notify pre-qualified bidders
- November 11** Construction documents delivered to qualified bidders
- December 6** Bids submitted to Foundation

**Governmental Ethics Commission**

**Opinion No. 2002-23**

Written September 19, 2002, to Tom Sawyer, State Chair, Kansas Democratic Party, Topeka.

This opinion is in response to your letter of September 9, 2002, in which you request an opinion from the Kansas Governmental Ethics Commission concerning the Campaign Finance Act (K.S.A. 25-4142 *et seq.*). We note at the outset that the Commission's jurisdiction concerning your question is limited to the application of K.S.A. 25-4142 *et seq.* Thus, whether some other statutory system, common law theory or agency rule or regulation applies to your inquiry is not covered by this opinion.

**Factual Statement**

We understand that you request this opinion in your capacity as the State Chair of the Kansas Democratic Party (Party). You question whether certain out-of-state organizations which only make contributions to the Party and not directly to candidates, meet the definition of a political committee (PAC) as defined in K.S.A. 25-4143(k). In addition, you question what the contribution limit to state parties is for these out-of-state organizations. Finally, you inquire about the definition of the phrase "a major purpose" in the definition of a political committee.

**Questions**

- I. Are out-of-state organizations which only make contributions to the state party and not directly to candidates, a political committee as defined in K.S.A. 25-4143(k)?
- II. What are the contribution limits for these out-of-state organizations?
- III. What is the definition of the phrase "a major purpose" in the definition of a political committee?

**Opinion**

With regard to your first question, K.S.A. 25-4143(k) applies. That statute states in pertinent part:

"Political committee" means any combination of two or more individuals or any person other than an individual, a major purpose of which is to expressly advocate the nomination, election or defeat of a clearly identified candidate for state or local office or make contributions to or expenditures for the nomination, election or defeat of a clearly identified candidate for state or local office.

You have questioned whether an out-of-state organization becomes a PAC when it makes a contribution to the Party. Based upon the language of the statute, the Commission now determines that an organization which does nothing more than make a contribution to a State Party does not meet the definition of a PAC as defined in K.S.A. 25-4143(k).

With regard to your second question, K.S.A. 25-4153 delineates the contribution limits for different organizations and individuals. It states in pertinent part:

- (d) The aggregate amount contributed to a state party committee by a person other than a national party committee or a political committee shall not exceed \$15,000 in each calendar year; and the aggregate amount contributed to any other party committee by a person other than a

national party committee or a political committee shall not exceed \$5,000 in each calendar year.

Based upon the language of this statute, the contribution limit for an organization which does not meet the definition of a PAC pursuant to K.S.A. 25-4143(k) is \$15,000.00 per calendar year.

Finally, with regard to your third question, K.A.R. 19-21-3 applies. It states in pertinent part:

(a) General. The following factors shall be considered in determining whether a combination of two or more persons, or a person other than an individual, constitutes a political committee:

- (1) The intent of the person or persons;
- (2) the amount of time devoted to the support or opposition of one or more candidates for state office;
- (3) the amount of time devoted to the support or opposition of any other political committee or party committee;
- (4) the amount of contributions, as defined by the act, made to any candidate, candidate committee, party committee or political committee;
- (5) the amount of expenditures, as defined by the act, made on behalf of any candidate, candidate committee, party committee or political committee; and
- (6) the importance to any candidate, candidate committee, party committee or political committee of the activities in which the person or persons engage.

This regulation was codified from an opinion first issued by the Commission in 1974. It stated in pertinent part:

When the Act was initially introduced in the Senate, the purpose-test was phrased as "a primary or incidental purpose." The Senate dropped the "or incidental purpose" aspect of the test. In the House the language was further modified to "a major purpose" which in turn became the final form. The Commission understands that the intent of the final modification was to lessen the requisite degree of purpose required to be considered a political committee. Specifically, the intent was to decrease the required purpose from one of first in importance among all other purposes to one of a considerable purpose regardless of whether other purposes were greater in degree. Thus, the applicable test for whether a major purpose of any [organization] is to [expressly advocate the nomination, election or defeat of a clearly identified candidate for state or local office] is whether any one of its purposes, or by cumulative effect more than one of its purposes, are considerable in degree and are directed at attaining the described goal.

The outcome of the application of this test to a particular [organization] or person will depend on the specific factual situation involved. Commission Opinion 1974-22.

For a review of other cases in which the Commission has applied the test outlined in K.A.R. 19-21-3, see Commission Opinions 1974-22, 1974-39, and 1974-54.

#### Opinion No. 2002-24

Written September 19, 2002, to C.E. Russell, Wellington City Attorney, Wellington.

This opinion is in response to your letter of September 3, 2002, in which you request an opinion from the Kansas Governmental Ethics Commission concerning the local conflict of interest law (K.S.A. 75-4301 *et seq.*). We note at the outset that the Commission's jurisdiction concerning

your question is limited to the application of K.S.A. 75-4301 *et seq.* Thus, whether some other statutory system, common law theory or agency rule or regulation applies to your inquiry is not covered by this opinion.

#### Factual Statement

We understand that you are requesting this opinion in your capacity as City Attorney for the City of Wellington, Kansas (the City). You have explained that the City recently annexed a certain tract of land owned by the Unified School District No. 353 (U.S.D. 353). Prior to the annexation, Sumner-Cowley Electric Cooperative Association, Inc. (Co-op) supplied the electricity to this tract of land. Pursuant to K.S.A. 66-1,167 the City gave the Co-op notice that it intended to begin providing the electricity to this tract of land. The City and the Co-op must now agree upon the amount of compensation due the Co-op pursuant to statute. There may be an option for the City and Co-op to swap territory as compensation. Pursuant to statute, however, if the City and the Co-op cannot agree as to the appropriate amount of compensation, the district court will determine the amount. You have informed us that three members of the City Council are employees of the Co-op.

#### Question

Does an agreement between the City and the Co-op regarding the compensation due the Co-op constitute a contract within the definition of the local level conflict of interest laws?

#### Opinion

The City Council members are governed by the local level conflict of interest laws (K.S.A. 75-4301 *et seq.*). K.S.A. 75-4304 prohibits a local employee from participating, in his official capacity, in the making of a contract with an entity by which that employee is employed. This statute states in pertinent part:

(a) No local governmental officer or employee shall, in the capacity of such an officer or employee, make or participate in the making of a contract with any person or business by which the officer or employee is employed or in whose business the officer or employee has a substantial interest.

...

(c) A local governmental officer or employee does not make or participate in the making of a contract if the officer or employee abstains from any action in regard to the contract.

K.S.A. 75-4301a(g) provides the definition of contracts:

"Contracts" means agreements including but not limited to sales and conveyances of real and personal property and agreements for the performance of services.

In the scenario you have described, the agreement between the City and the Co-op for the determination of compensation or for a trade of territory would constitute a contract. Therefore, the three members of the City Council would be prohibited from participating in the making of that contract. Pursuant to K.S.A. 75-4303(c), if the three Council members in question abstained from any discussion and do not vote on the decision, they will not violate the local level conflict of interest laws.

Notice of Hearing on Proposed  
Administrative Regulations

The State Board of Education will conduct a public hearing at 1:30 p.m. Tuesday, January 14, in the board room of the State Education Building, 120 S.E. 10th Ave., Topeka, to consider proposed amendments to school bus transportation regulations, K.A.R. 91-38-1, 91-38-2, 91-38-3, 91-38-5, 91-38-6 and 91-38-7.

All interested persons will be given a reasonable opportunity at the hearing to present their views or arguments, either orally or in writing, in regard to the proposed amended regulations. In addition, the period of public notice hereby provided constitutes a public comment period for the purpose of receiving written public comments on the proposed regulations. Such written comments may be submitted to the secretary of the State Board of Education at the address above. The hearing shall be conducted in compliance with the public hearing procedures of the State Board of Education.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Lanny Gaston at (785) 296-3906 or TDD (785) 296-8172.

A copy of each of the proposed regulations and its economic impact statement may be obtained by contacting the secretary of the State Board of Education at the address above prior to the date of the hearing.

The following is a summary of each regulation and the economic impact statement:

**K.A.R. 91-38-1.** This regulation provides definitions for terms used in the substantive regulations. It is being amended to clarify that activity buses can be used only for transportation to and from activities, to correct a statutory cite and to conform the definition of "bus" with a change in state law.

No economic impact is anticipated for the State Board of Education or school districts, individuals, other governmental agencies or private businesses.

**K.A.R. 91-38-2.** This regulation provides general limitations and requirements for buses and other vehicles used to provide transportation to students. The amendments are necessary to help assure the safe transportation of school children and to clarify the mandate for a body fluid cleanup kit and seat belt usage.

No economic impact is anticipated for the State Board of Education or school districts, individuals, other governmental agencies or private businesses.

**K.A.R. 91-38-3.** This regulation requires the appointment of a transportation supervisor and sets forth the duties of that supervisor. The amendments are intended to clarify the responsibilities of the supervisor.

No economic impact is anticipated for the State Board of Education or school districts, individuals, other governmental agencies or private businesses.

**K.A.R. 91-38-5.** This regulation provides for an annual inspection of school buses. It is being amended at the re-

quest of the Kansas Highway Patrol (KHP). As amended, the KHP would continue to do a safety equipment check of each bus but a mechanical inspection would be performed by a mechanic.

There should be no economic impact upon the State Board of Education, other governmental agencies, private businesses or individuals. Several schools were contacted across Kansas. They indicated that this change would have no impact on their current operation, since a mechanic was already available to do the mechanical inspection.

**K.A.R. 91-38-6.** This regulation sets forth the qualifications and training requirements for drivers transporting Kansas school children. This regulation is being amended to make its provisions consistent with each other.

No economic impact is anticipated for the State Board of Education or school districts, individuals, other governmental agencies or private businesses.

**K.A.R. 91-38-7.** This regulation concerns a driver's responsibilities when providing transportation to school children. This regulation is being amended to ensure that each driver utilizes the seat belt whenever the vehicle is in motion.

No economic impact is anticipated for the State Board of Education or school districts, individuals, other governmental agencies or private businesses.

The Kansas Department of Health and Environment has received and reviewed a permit application from Vilela C&D Landfill, L.L.C. to construct and operate a construction and demolition landfill in Crawford County. KDHE is providing public notice of its intent to issue a construction and demolition landfill permit to Vilela C&D Landfill, L.L.C. The landfill would be located 1/4 mile north of South 250th St. on E. 540th Ave. in the Northeast Quarter of the Southeast Quarter of Section 27 of Township 30 South, Range 25 East, east of Pittsburg. Only construction and demolition waste materials, as defined by Kansas statutes, would be allowed for disposal at this site. The total area of the disposal site would be about 22 acres, with an estimated capacity of 468,000 cubic yards. With this capacity, the landfill would be expected to operate more than 25 years.

## Request for Comments

The Kansas Department of Health and Environment has reviewed an application from Holland Corporation, Inc. to establish and operate a new construction and demolition (C&D) landfill. The proposed landfill site is located in the West Half of Section 16, Township 14 South, Range 23 East in Johnson County, at 23775 W. 159th St., Olathe. The proposed landfill will cover approximately 192 acres on the 260-acre property, which is currently used for quarrying and crushing rock, and operating an asphalt plant. The landfill is proposed to be developed in five phases to reclaim (fill) land subsequent to quarrying. The proposed landfill is estimated to have capacity for approximately 30 million cubic yards of C&D waste, with the period of active landfill operation estimated at 134 years. The bottom of the landfill is proposed to be at elevations ranging from 900 to 950 feet (about 100 feet below the natural ground surface elevations prior to quarrying), and final landfill elevations will be at elevations ranging from 1,000 to 1,050 feet (approximately matching the natural ground surface elevations prior to quarrying).

The City of Olathe has issued a Special Use Permit to Holland Corp. for this land use, and the City of Olathe and Johnson County have certified that the application described herein is consistent with local zoning requirements. Johnson County also has certified that the application is consistent with the county's solid waste management plan. KDHE has reviewed the application and found it to be in conformance with the state solid waste regulations.

KDHE is providing public notice of its intent to issue a permit to Holland Corp. for the proposed landfill described herein. A copy of the administrative record, which includes the permit application, engineering drawings, draft permit and other information regarding this permit action, is available for public review through November 25 during normal business hours at the following locations:

The permit process in the Stream Obstructions Act is intended to determine if the proposed plan or change creates an unreasonable threat to the public safety or property, generally, but because the Act does not place a statutory duty on the Division of Water Resources to protect a downstream landowner affected by the permittee's (the upper landowner) structure or displacement of water, the Division of Water Resources does not incur liability from the permit process statute it administers. #### Opinion 2002-45

**Constitution of the State of Kansas—Legislative—Legislative Power; Authority of Legislature to Transfer Money from Special Revenue Funds into the State General Fund. Representative Laura McClure, 119th District, Osborne; Representative Carl Holmes, 125th District, Liberal, September 18, 2002.**

If an assessment so exceeds the cost of regulation that it is apparent the Legislature is using it as a general revenue raising measure, the overage cannot stand on police power authority. If the assessment is in fact a revenue raising measure, it must be analyzed as such, which may include a determination as to whether it meets Commerce Clause and Equal Protection requirements, as well as any state constitutional requirements applicable to the type of tax it is. If an assessment cannot stand on either police power or taxing authority, it would have to be reimbursed. Whether the general fund contribution of a fund administered by an agency performing police power functions so far exceeds the direct and indirect costs incurred by the state on behalf of such agency as to be improper can be determined only as a factual matter on a case-by-case basis. While we do not have sufficient factual information to make this determination for the four scenarios discussed herein, we seriously question whether the agencies involved cost the state in indirect and administrative expenses as much as was taken from their funds during the 2002 session. If, based on facts presented, a court determined that too much money was taken, and that the individuals and entities who pay fees and assessments to these agencies therefore are paying more than their fair share for the state's general operating expenses, it is likely the court would order those assessments reduced and payments into the general fund reversed. Persons appointed to the board of directors for the Information Network of Kansas (INK) by the governor pur-

suant to subsections (b)(4), (b)(5) and (b)(6) of K.S.A. 74-9303 as representatives of designated associations may not appoint others to serve in their absence from meetings of the board of directors for INK. Service on the board by the secretary of state is a duty of the office of secretary of state. Pursuant to authority conferred under K.S.A. 75-412, the secretary of state may appoint an assistant secretary of state or deputy assistant secretary of state who may serve on the board in the absence of the secretary. The assistant secretary of state or deputy assistant secretary of state so appointed may discuss issues and cast votes on issues coming before the board of directors for INK, subject only to any restrictions placed by the secretary of state upon the exercise of that authority. ## Article 1.—EXAMINATION AND REGISTRATION

**86-1-19. Submission of supporting documentation with application.** In addition to submitting the application for original licensure or renewal of a real estate broker's or salesperson's license, each applicant shall provide documentation concerning the following, if applicable: (a) Any litigation filed by or against the applicant or any real estate company owned in whole or in part by the applicant relating to the business of buying, selling, exchanging, or leasing real estate or to any activity listed in the definition of "broker" in K.S.A. 58-3035 and amendments thereto. The applicant shall provide a copy of the petition or complaint setting out the allegations. If the litigation has been resolved, the applicant shall provide a copy of the settlement agreement or order that sets forth the outcome. If a judgment was obtained against the applicant or any real estate company owned in whole or in part by the applicant, the applicant shall indicate whether the judgment has been satisfied. If the judgment has not been satisfied, the applicant shall provide an explanation;

(b) any pending charges or conviction of a criminal offense other than minor traffic violations, including final discharge from probation, parole, or conditional release, and a written explanation of the circumstances that resulted in the charge or conviction; and

(c) the denial, revocation, or suspension of, or any other disciplinary action taken by the state of Kansas or another jurisdiction against any professional or occupational license or certificate held by the applicant. ## Article 3.—PERSONS HOLDING LICENSES; DUTIES

**86-3-15. Reporting of information.** (a) Each licensee shall report any of the following circumstances to the commission, in writing and within 10 days of the date of occurrence:

(1) Any litigation filed by or against the licensee or any real estate company owned in whole or in part by the licensee relating to the business of buying, selling, exchanging, or leasing real estate or to any activity listed in the definition of "broker" in K.S.A. 58-3035 and amendments thereto. The licensee shall provide a copy of the petition or complaint setting forth the allegations;

(2) disposition of any litigation reported pursuant to paragraph (a)(1);

(3) any court judgment filed against the licensee or any real estate company owned in whole or in part by the licensee;

(4) any charge of, arrest or indictment for, plea of guilty or nolo contendere to, or conviction of any of the following:

(A) Forgery, embezzlement, obtaining money under false pretenses, larceny, extortion, conspiracy to defraud, or any similar offense;

(B) a crime involving moral turpitude; or

(C) any felony;

(5) any change in the licensee's name;

(6) any change in the licensee's residence address;

(7) any change relative to a trust account maintained by the licensee pursuant to K.S.A. 58-3061 and amendments thereto;

(8) any denial by another jurisdiction of an application made by the licensee for a broker or salesperson license;

(9) any suspension or revocation of, or any other disciplinary action taken by another jurisdiction against a broker or salesperson license held by the licensee; or

(10) any denial, suspension, or revocation of, or any other disciplinary action taken by the state of Kansas or another jurisdiction against any professional or occupational license or certificate held by the licensee.

(b) Each supervising broker for a partnership, association, or corporation whose members or officers are licensed pursuant to subsection K.S.A. 58-3042, and amendments thereto, shall be responsible for reporting the information required by this regulation as it relates to the partnership, association, or corporation.

(c) Each supervising broker and branch broker shall report to the commission any information pursuant to paragraph (a)(4) of this regulation that is applicable to any associated or employed salesperson or associate broker. This report shall be submitted in writing within 10 days of the date that knowledge of the information comes to the attention of the broker.

(d) Each supervising broker for a partnership or corporation whose members or officers are licensed pursuant to K.S.A. 58-3042, and amendments thereto, shall notify the commission of the name and office of each officer of the corporation or the name of each partner, by completing and submitting a partnership or corporation report form obtained from the commission. The supervising broker shall notify the commission within 10 days of any change in the information, by completing and submitting a revised report. This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written comments from the public on the proposed regulations. All interested parties may submit written public comments on the proposed regulations prior to the hearing to Kathleen Smith, Tax Specialist, Office of Policy and Research, Room 230, Docking State Office Building, 915 S.W. Harrison, Topeka, 66625.

All interested parties will be given a reasonable opportunity to present their views, either orally or in writing or both, concerning the adoption of the proposed regulations. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. The regulations are proposed for adoption on a permanent basis. A summary of the proposed regulations and their economic impact follows:

**Article 15.—BEER AND CEREAL MALT BEVERAGE  
KEG REGISTRATION**

**Adoption of K.A.R. 14-15-1.** This is a new regulation providing definitions of terms used in the keg registration act.

Economic Impact: No economic impact on the public, the department or other agencies is anticipated.

**Adoption of K.A.R. 14-15-2.** This new regulation describes the requirement to affix tags to kegs sold by retailers; the process of ordering tags; the records required to be kept by the retailer, including purchaser information and disposal of the records; and that untagged kegs in the possession of anyone other than a retail licensee, club, drinking establishment, hotel drinking establishment or caterer shall be presumed to be contraband and subject to seizure.

Economic Impact: The keg tags are to be provided by the Kansas Department of Revenue, Alcoholic Beverage Control to retail licensees free of charge. This will cost approximately \$4,500 per year.

There is a possibility that some people not wanting to fill out the paperwork will discontinue purchasing kegs

and instead make purchases in case lots. This could have a small favorable economic impact on licensees (private business), as the same amount of product bought in case lots in lieu of kegs would cost the purchaser more, therefore making additional money for the licensee.
