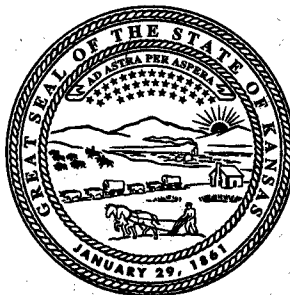

**Notice of Hearing on Proposed
Administrative Regulations**

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Thursday, April 17, at the El Dorado Civic Center, 201 E. Central, El Dorado, to consider the approval and adoption of proposed regulations of the Kansas Department of Wildlife and Parks.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 1:30 p.m. April 17 at the location listed above. The meeting will recess at 5 p.m., then resume at 7 p.m. at the same location for the regulatory hearing. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. April 18 at the same location.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Sheila Kemmis, commission secretary, at (620) 672-5911. Persons with a hearing impairment may call the TDD service at 1-800-766-3777 to request special accommodations.

This 30-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on proposed administrative regulations.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, 1020 S. Kansas Ave., Suite 200, Topeka, 66612. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The administrative regulations that will be heard during the regulatory hearing portion of the meeting are as follows:

K.A.R. 115-25-5. This exempt regulation establishes the 2003 fall turkey hunting season, bag limits and permits.

The proposed changes further clarify the units where a permit is valid.

Economic Impact Summary: It is anticipated that 10,500 turkey permits and game tags will be issued generating \$176,700. The department anticipates that over 20,000 days of hunting activity would occur, thus providing economic benefit to businesses providing goods and services.

K.A.R. 115-25-7. This exempt regulation establishes the 2003 antelope hunting season, bag limits and permits. Proposed changes would reduce the number of antelope permits available in 2003. Unlimited archery permits are proposed, and a total of 115 firearms permits and 30 muzzleloader permits are proposed.

Economic Impact Summary: It is anticipated that 270 antelope permits may be authorized, which would generate \$8,300 in revenue. Approximately 750 days of hunting activity may occur, thus providing economic benefit to businesses providing goods and services.

K.A.R. 115-25-8. This exempt regulation establishes the 2003-2004 elk season, bag limits and permits. Proposed changes would establish two new hunt units, Unit 6 and Unit 14, and would increase the number of any-elk permits available from eight to ten permits. This regulation would allow permits to be used during muzzleloader, archery, or rifle season. However, only eight antlerless-only elk permits would be valid for use at a single time on Fort Riley. In addition, unlimited hunt-on-your-own-land antlerless-only elk permits would be authorized off Fort Riley.

Economic Impact Summary: It is estimated that a total of 50 elk permits may be authorized. Estimated revenue if these permits are issued would be approximately \$5,500. Approximately 500 days of hunting activity may occur, thus providing economic benefit to businesses providing goods and services.

K.A.R. 115-25-9. This regulation establishes the 2003-2004 deer season, bag limits and permits. Proposed changes include shortening the January extended firearms season to four days, reducing the number of antlerless game tags valid in certain units, reducing the number of units open for the January extended firearms season, establishing an October firearms season for units designated as urban deer management units, and establishing a January antlerless-only white-tailed deer season for units designated as urban deer management units.

Economic Impact Summary: Estimated revenue based on 2002-2003 permit and game tags sales would be approximately \$4,000,000. Approximately 415,000 days of hunting activity may occur, thus providing economic benefit to businesses providing goods and services.

Applications for the Edward Byrne Memorial State and Local Law Enforcement Assistance Grant Program are available. This grant program was established by the Anti-Drug Abuse Act of 1988 and the Crime Control Act of 1990.

The State of Kansas will be awarded funding by the U.S. Department of Justice, Bureau of Justice Assistance, which will be subgranted to Kansas criminal justice agencies to assist their efforts in combating illicit drug use, violent crime and system improvement needs.

Cities, counties, state agencies and native Indian tribes are eligible to receive grant funding. Program areas for which applicants can apply include prevention, enforcement, treatment, criminal interdiction, adjudication and criminal justice information systems improvement.

Applicants are required to provide at least 25 percent of the total amount requested (local matching funds). The percent of the local matching funds is contingent on the number of years a grant has been funded.

The Byrne grant allows for the possibility of four years of funding in a program area. Program areas are described in the grant application.

Grants operate on a reimbursement basis. Sub-recipients will be reimbursed the federal portion for authorized expenditures. Reimbursements are processed monthly.

The grant award period will be from July 1, 2003 to June 30, 2004. Applications must be postmarked not later than April 25 to the address listed below. Grant awards will be announced before June 30.

Article 5.—PROVIDER PARTICIPATION, SCOPE OF SERVICES, AND REIMBURSEMENT FOR THE MEDICAID (MEDICAL ASSISTANCE) PROGRAM

30-5-64. Prior authorization. The following changes will be made to K.A.R. 30-5-64 regarding prior authorization of pharmaceutical products:

Due to the implementation of the Kansas Medicaid Preferred Drug List, several drugs in the following therapeutic drug classes will require prior authorization: beta-blockers, calcium channel blockers, ace inhibitors and angiotensin II receptor antagonists (ARBs).

Federal Mandate: This regulation change is not federally mandated.

Economic Impact: SRS included the expected savings from this change in the economic impact statement when this same regulation was proposed to be amended in the Kansas Register dated December 19, 2002 (Vol. 21, No. 51). When SRS published that notice, SRS intended to phase in several pharmaceutical products at different dates, so SRS reported the entire amount of savings in that statement.

Bearer of Cost: The cost of reviewing prior authorization (PA) will be borne by SRS. If a Medicaid consumer wishes to have a drug despite a PA denial, the cost will be borne by the consumer.

Affected Parties: Medicaid consumers, pharmacists and the Medicaid agency.

Other Methods: There were no other appropriate methods for the desired outcome.

Article 5.—PROVIDER PARTICIPATION, SCOPE OF SERVICES, AND REIMBURSEMENTS FOR THE MEDICAID (MEDICAL ASSISTANCE) PROGRAM

30-5-107. Scope of non-emergency medical transportation services. This regulation changes the word "ambulance" to "emergency" and is for clarification purposes only.

Federal Mandate: This regulation change is not federally mandated.

Economic Impact: No impact.

Bearer of Cost: None.
Affected Parties: None.

Other Methods: There were no other appropriate methods for the desired outcome.

30-5-107a. Reimbursement for non-emergency medical transportation services. The proposed change to this regulation clarifies and establishes reimbursement as it relates to Medicaid transportation.

Federal Mandate: This regulation change is not federally mandated.

Economic Impact: It is expected that this change would save about \$16,000.

Bearer of Cost: Medicaid consumers.

Affected Parties: Medicaid consumers.

Other Methods: There were no other appropriate methods for the desired outcome.

Article 6.—MEDICAL ASSISTANCE PROGRAM— CLIENTS' ELIGIBILITY FOR PARTICIPATION

30-6-65. Automatic eligibles. This regulation is being amended to require that transitional medical assistance be provided for an initial six-month period if the individual provides ongoing status reports. Assistance shall be provided for an additional six months if the individual ongoing status reports and the gross earned income, less the cost of child care, do not exceed 185 percent of the federal poverty income guideline.

Federal Mandate: This change is required by Section 1925 of the Social Security Act.

Economic Impact: It is expected that the change will result in savings of \$2,814,070 (\$1,120,000 state general funds) on an annual basis.

Bearer of Cost: None

Affected Parties:

1. This change will have a substantive impact on both SRS staff and systems related to development of status reports, tracking receipt of status reports necessary to continue coverage, and determination of income eligibility.
2. This change will negatively impact approximately 2,200 individuals who will either fail to return reports or exceed income limits and thus lose coverage.

Other Methods: Other methods of achieving the same budget savings that this change entails were considered. This method was chosen to prevent more substantive eligibility and service cuts that may have otherwise been taken in fiscal year 2004.

30-6-108. Real property. This regulation is being amended in regards to income-producing property. For non-SSI, income-producing other real property shall continue to be exempt if the income produced is consistent with its fair market value. For SSI, income-producing other real property that is used in an individual's trade or business shall be exempt, but nonbusiness income-producing property shall only be exempt if the equity value of both nonbusiness income-producing other real property plus the equity value of any nonbusiness income-producing personal property do not exceed \$6,000 and produces a net annual return of at least 6 percent of the total equity.

Federal Mandate: The new resource limit (after the amendment) is mandated as a minimum the state must follow based on Sections 1613 and 1902(a)(10)(c) of the Social Security Act.

Economic Impact: It is expected that this change will result in annual savings of \$326,880 (\$130,261 state general fund).

Bearer of Cost: None.

Affected Parties:

1. This change will have a moderate impact on SRS staff who will be required to evaluate property that is not subject to exemption.

2. This change will have a negative impact on approximately 12 individuals each year who will fail to qualify for assistance because of property value.

Other Methods: Other methods were evaluated, but this method was chosen as it aligns more closely with SSI eligibility policy.

30-6-109. Personal property. This regulation is being amended in regards to exempted income-producing personal property. For SSI, the equity value of income-producing personal property, other than cash assets, that is used in an individual's trade or business shall be exempt. The equity value of nonbusiness income-producing personal property, other than cash assets, shall be exempt if the equity value of the personal property plus the equity value of nonbusiness income-producing real property do not exceed \$6,000 and produces a net annual return of at least 6 percent of the total equity.

Federal Mandate: The new resource limit (after the amendment) is mandated as a minimum the state must follow based on Sections 1613 and 1902(a)(10)(c) of the Social Security Act.

Economic Impact: See the economic impact statement for K.A.R. 30-6-108.

Article 44.—SUPPORT ENFORCEMENT

30-44-5. Scope of services; judgment interest. Pursuant to the provisions of K.S.A. 39-753, the Secretary of Social and Rehabilitation Services submits the following description of the economic impact of the above-referenced regulation:

The proposed regulation defines the scope of services provided by the SRS Child Support Enforcement Program (CSE) with respect to judgment interest that may accrue upon unpaid installments of child support and maintenance. CSE services are limited to enforcement of the amount of accrued judgment interest previously determined by a tribunal of competent jurisdiction.

Federal Mandate: The SRS Child Support Enforcement Program (CSE) is required to meet federal requirements under Title IV-D of the Social Security Act. The federal law does not mandate any activities related to judgment interest, although activities related to judgment interest generally are allowable expenses for federal financial participation.

Currently, two sets of rules concerning the application of payments to principal and interest may apply to calculation of accrued judgment interest in CSE cases with Kansas orders. The so-called "American rule" (approved

(continued)

in *Dallas v. Dallas*, 236 Kan. 92, 698 P2d 1184, 1984) generally is applied in non-CSE cases or in cases before they become part of the CSE caseload. Under the Dallas rule, receipts in excess of the amount due for the current month are applied first to accrued judgment interest, then to unpaid principal (arrearages) on a "first in, first out" basis. To meet Title IV-D requirements, CSE must follow IV-D distribution rules for the application of receipts to debts. Although the federal law does not specifically address application of receipts to accrued judgment interest, Title IV-D is detailed and unambiguous about the application of receipts until all principal has been paid in full. It does not authorize the application of receipts to judgment interest debts before the principal has been paid.

The inconsistencies between the Dallas rule and IV-D distribution cause different results when judgment interest is calculated. The law in Kansas is presently unclear on several points concerning judgment interest, including which creditor among multiple judgment creditors has the authority to determine the application of receipts for calculation of judgment interest, some of which may be owed to the other creditor(s).

The complexities of current federal distribution rules, combined with federal system requirements and the legal uncertainties noted above, have made it impractical for the CSE automated system to be programmed to calculate accrued and accruing judgment interest on Kansas orders. If accrued and accruing interest were calculated manually, CSE would be unable to assure accuracy and uniformity of such services statewide. In some locations, the diversion of efforts from federally-mandated tasks to manual calculation of accrued judgment interest would put the state at risk of federal sanctions.

This regulation is intended to ensure uniformity of CSE services statewide, reduce risks concerning federal performance requirements, and reduce risks related to the legal uncertainties noted above.

Economic Impact: Adoption of this regulation is not expected to materially affect state revenues. First, because CSE collections are applied to judgment interest after all principal has been paid in full, payments on judgment interest represent an extremely low percentage of annual CSE receipts. Second, average child support collections are far more strongly affected by fluctuations in debtors' ability to pay than by the total amount debtors owe. Finally, if accrued interest has been reduced to a sum-certain by a tribunal, CSE will continue to provide enforcement services on the judgment interest debt, mitigating the impact of the regulation on revenues.

In general, families receiving services from CSE are not expected to be materially affected by this regulation. Nothing in this regulation terminates custodial parents' rights to receive judgment interest; the regulation only defines the scope of services CSE will provide to them concerning judgment interest. CSE distribution rules already postpone collection of judgment interest until all principal has been paid in full, and the individual debtor's ability to pay is the greatest factor determining amounts that will be collected and distributed to individual families. As noted above, if accrued interest has been reduced to a sum-certain by a tribunal, CSE will continue to provide enforcement services on the judgment interest

debt, mitigating the effect of the regulation on families. Custodial parents who choose to obtain such determinations may incur the cost of private legal counsel for such services.

CSE will incur one-time costs for mailing information about the new regulation to CSE customers, as follows:

Another avenue of limiting CSE services with respect to allowable but unmandated activities would be enactment of state legislation. A regulation, however, provides more flexibility, should conditions change and enhancement of judgment interest services to CSE customers become feasible.

The proposed regulation is not expected to affect the revenues of cities, counties or school districts, nor does it impose functions or responsibilities on cities, counties or school districts that will increase their expenditures or fiscal liability.

The Kansas Department of Health and Environment has reviewed an application from Norton County to expand its construction and demolition (C&D) landfill. The landfill is located in the Southwest Quarter of Section 25, Township 2 South, Range 23 West, approximately 1 mile northeast from the City of Norton. The proposed landfill expansion will cover approximately 2.5 acres on the existing 60-acre landfill property. The proposed landfill expansion is designed with approximately 40,000 cubic yards of capacity for C&D waste and intermediate cover material. Based on an estimated daily average disposal rate of four cubic yards, the proposed landfill expansion is projected to extend the period of active landfill operation by approximately 35 years.

The bottom of the landfill expansion is proposed at elevations ranging from approximately 2,310 feet to 2,318 feet, resulting in excavation depths up to 15 feet below the existing ground surface. The completed surface of the landfill expansion (including the final cover) is proposed at elevations ranging from approximately 2,310 feet to 2,332 feet, representing fill depths up to 20 feet above the existing ground surface. The final cover on the landfill expansion is proposed to consist of at least 30 inches of soil with native grasses established on the surface.

Norton County has certified that the application described herein is consistent with the local solid waste management plan and compatible with the surrounding land use. KDHE has reviewed the application and found it to be in conformance with the state solid waste statutes and regulations.

KDHE is providing public notice of its intent to issue an amended permit to Norton County for the proposed C&D landfill expansion described herein. A copy of the administrative record, which includes the permit application, engineering drawings, draft permit and other information with respect to this permit action, will be available for public review March 17-April 18, during normal business hours, at the following locations:

The U.S. Environmental Protection Agency has a 45-day review period, which will start concurrently with the 30-day public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA 45-day review period. If the EPA waives its 45-day review period, the 60-day public petition period will start directly after the 30-day public comment period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this

notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. Grandview Products Company, Inc. has applied for a Class I operating permit in accordance with the provisions of K.A.R. 28-19-510 et seq. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards and requirements applicable to each source; and the monitoring, record keeping and reporting requirements applicable to each source as of the effective date of permit issuance.

Grandview Products Company, Inc. owns and operates a wood cabinet manufacturing facility located at 1601 Superior Drive, Parsons.

A copy of the proposed permit, permit application, all supporting documentation and all information relied upon during the permit application review process is available for a 30-day public review during normal business hours at the KDHE, Bureau of Air and Radiation, 1000 S.W. Jackson, Suite 310, Topeka; and at the KDHE Southeast District Office, 1500 W. 7th, Chanute. To obtain or review the proposed permit and supporting documentation, contact Rasha Allen, (785) 296-1693, at the KDHE central office; or Lynelle Stranghoner, (620) 431-2390, at the KDHE Southeast District Office. The standard departmental cost will be assessed for any copies requested.

Direct written comments or questions regarding the proposed permit to Rasha Allen, KDHE, Bureau of Air and Radiation, 1000 S.W. Jackson, Suite 310, Topeka, 66612-1366. In order to be considered in formulating a final permit decision, written comments must be received by the close of business April 14.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Connie Carreno, Bureau of Air and Radiation, not later than the close of business April 14 in order for the Secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency has a 45-day review period, which will start concurrently with the 30-day public comment period, within which to object to

the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA 45-day review period. If the EPA waives its 45-day review period, the 60-day public petition period will start directly after the 30-day public comment period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. Permanent Administrative Regulations

Article 38.—SCHOOL BUS TRANSPORTATION

91-38-1. Definitions. (a) "Activity bus" means any over-the-road, commercial-type bus utilized by a governing body only to transport students to and from school activities as authorized by K.S.A. 72-8301 (c)(3), and amendments thereto. An activity bus may be a color other than school bus yellow.

(b) "Bus" means any motor vehicle, as defined in K.S.A. 8-1406 and amendments thereto, that is designed for transporting more than 10 passengers in addition to the driver.

(c) "Driver-trainer" means any person who is assigned by a transportation supervisor to provide instruction and training to other school transportation providers, including knowledge of vehicles used to provide student transportation, safe driving practices, emergency procedures, and passenger control. The driver-trainer shall maintain current licensure to operate the largest vehicle about which the driver-trainer is to provide instruction and shall have experience as a school bus driver.

(d) "Governing body" means the local board of education or other entity having authority over a school district.

(e) "Multipurpose passenger vehicle" means a motor vehicle, as defined in K.S.A. 8-126 and amendments thereto, that is designed to transport 10 or fewer persons, including the driver, and that is constructed on a truck chassis.

(f) "School bus" means any bus designed primarily for the transportation of students or school personnel either to or from school or to or from school-related functions or activities. A school bus may be owned by a school district or a private company. The term shall include any van or other vehicle rated by the manufacturer, or having a door label, as a bus.

(g) "School bus driver" means any person employed by a school district or school bus contractor to drive a school bus or activity bus.

(h) "School district" means any unified school district or private school.

(i) "School passenger vehicle" means any passenger car or multipurpose passenger vehicle that is owned or leased by a school district or private individual and is used regularly to provide student transportation on behalf of a school district.

(j) "School passenger vehicle driver" means any person employed by a school district primarily to provide transportation for students in a school passenger vehicle.

(k) "School transportation provider" means either a school bus driver or a school passenger vehicle driver.

(l) "School vehicle" means any activity bus, school bus, or school passenger vehicle.

(m) "Short-term leased vehicles" means any school vehicle that is leased by a school district for a period of 30 or fewer days.

(n) "Substitute driver" means any person who is not assigned to a regular route but is employed to serve as a school transportation provider when necessary due to driver absences or emergencies.

(o) "Transportation supervisor" means a person designated by a governing body to be responsible for transportation activities within a school district. (Authorized by and implementing K.S.A. 8-2009; effective July 1, 2000; amended March 28, 2003.)

91-38-2. General limitations and requirements. (a) No governing body shall have a school bus in service after July 1, 1992, unless the school bus was manufactured after April 1, 1977 and either is no more than 20 years old or has been modified to meet current standards. Each school bus shall meet the standards specified by law and this article.

(b) The owner's name shall be displayed on each side of any school bus.

(c) Activity buses shall not be utilized to provide student transportation to and from school.

(d) Each school bus, activity bus, and school passenger vehicle shall be equipped with a two-way communication system.

(e) (1) Each bus shall contain the following emergency supplies:

(A) At least one 2A-10BC fire extinguisher;

(B) at least one readily identifiable first-aid kit in a removable, waterproof, and dustproof container;

(C) at least one readily identifiable body fluid clean-up kit in a removable, waterproof, and dustproof container; and

(D) a minimum of three reflectorized triangle warning devices, securely stored but in an accessible location.

(2) The first-aid kit, body fluid clean-up kit, and fire extinguisher shall be mounted in full view of, and readily accessible to, the driver.

(f) Each governing body shall ensure that occupant restraint systems are provided for, and utilized by, all occupants of school passenger vehicles. When providing transportation for infants and preschool children in school passenger vehicles, age- and size-appropriate child safety restraining systems shall be utilized, in accordance with the provisions of K.S.A. 8-1344, and amendments thereto. (Authorized by K.S.A. 8-2009; implementing K.S.A. 8-2009, 8-2009a; effective July 1, 2000; amended March 28, 2003.)

91-38-3. School transportation supervisor; duties and responsibilities. (a)(1) Appointment. Each governing body shall designate an employee to be the transportation supervisor.

(2) General responsibilities.

(A) The transportation supervisor shall be responsible for supervision and maintenance of the school district's transportation system.

(B) The transportation supervisor shall act as liaison between the school district and any contracted bus transportation service.

(b) School transportation routes and stops.

(1) The transportation supervisor shall be responsible for establishing all regular transportation routes and stops for the loading and unloading of students along those routes. The supervisor shall keep a current map on file for each regular transportation route, with all stops noted and a current map of the school district showing each attendance center.

(2) The transportation supervisor shall not establish stops on any interstate highway, state toll road, or other limited-access highway.

(3) The transportation supervisor shall give special consideration to road conditions and safety concerns when planning the regular transportation routes. If a safety hazard is encountered, the appropriate authorities shall be contacted about eliminating or correcting the hazard, if possible.

(4) Each driver shall report to the transportation supervisor any condition encountered by the driver on a transportation route that appears to pose a safety hazard.

(5) If visibility is less than 500 feet when approaching an established school bus stop from any direction, the transportation supervisor shall contact state, county, or township road authorities and request that warning signs be posted for the school bus stop. Whenever practicable, stops shall be established only at points where visibility is at least 500 feet for all motorists.

(c) Driver training meetings.

(1) Each transportation supervisor shall conduct at least 10 safety meetings per year for all school transportation providers employed by the school district.

(2) Attendance at each meeting shall be documented with a sign-in sheet or similar document. The record of attendance and the agenda shall be retained by the supervisor for at least two years.

(3) Safety meeting topics shall include school transportation safety concerns from drivers regarding route safety, changes in laws or regulations, and other safety issues as determined appropriate by the transportation supervisor.

(4) Safety meetings may be electronically recorded so that drivers who are unable to attend a particular meeting may view the program at another time.

(5) Newly hired drivers shall be required to attend only those meetings held following their employment.

(d) Records retention.

(1) The transportation supervisor shall be responsible for maintenance and repair records for all school buses, activity buses, and school passenger vehicles used for student transportation, except short-term leased vehicles, that are either owned or leased and are operated by the school district. These records shall include information on scheduled maintenance, lubrication records, repair orders, and other maintenance.

(2) The maintenance record for each vehicle shall be kept as long as the school owns or leases the vehicle, and for at least two years following disposition of the vehicle.

(3) Maintenance records shall be available for inspection by the Kansas highway patrol, other law enforcement agencies, and Kansas state department of education officials.

(e) Each school district that contracts for bus transportation services shall ensure that each contract for those services includes a provision requiring the contractor to meet the requirements of subsections (c) and (d) of this regulation.

(f) Students with special needs. Each board shall notify the transportation supervisor of any student with special health care concerns or special needs for transportation. The supervisor shall ensure that drivers, substitute drivers, and attendants are informed of these needs and receive any training that is necessary to safely transport the student or to accommodate the student's special needs. (Authorized by and implementing K.S.A. 8-2009; effective July 1, 2000; amended March 28, 2003.)

91-38-5. Annual inspection of school vehicles.

(a)(1) Each governing body that either owns or leases and that operates any school bus or activity bus shall have each of those buses inspected annually in accordance with this regulation.

(2) Each person or entity that contracts with any governing body to provide bus transportation services to students shall have each school bus or activity bus used to transport students inspected annually in accordance with this regulation.

(3) Except for new buses, which shall be inspected upon delivery and before being used to transport students, the inspection process shall be conducted between June 1 and September 30. No school bus or activity bus shall be used to transport students until the inspection process has been completed and the bus is in proper working order.

(b)(1) Each governing body and each bus transportation contractor shall have each school bus and each activity bus that is operated by the governing body or the contractor inspected by a mechanic who is knowledgeable about the mechanical systems of school buses. In addition, each governing body shall have each school passenger vehicle that is used to transport students inspected annually by a mechanic. The mechanic shall inspect each bus and each school passenger vehicle to determine

(continued)

whether the mechanical system is in proper working order.

(2) Each mechanic shall indicate the results of the inspection on the form provided by the state department of education and shall return the form to the governing body or bus transportation contractor.

(c)(1) After the inspection prescribed in subsection (b) is completed, each school vehicle shall be inspected by the Kansas highway patrol to determine whether the school vehicle is equipped with the appropriate safety devices and those devices are in proper working order.

(2) The results of the inspection shall be indicated by the highway patrol officer on the form provided by the state department of education. Following completion of this form, it shall be returned to the governing body or bus transportation contractor.

(d) Upon successful completion of the inspection process specified in subsections (b) and (c), a school vehicle inspection sticker issued by the Kansas highway patrol shall be placed on the school vehicle's windshield in a location that will not impair the driver's vision.

(e) (1) If any school vehicle fails either the mechanical or safety inspection specified in this regulation, that school vehicle shall not be used for student transportation until all defects have been corrected and school vehicle has been approved.

(2) If repairs or other corrections are required for a school vehicle to pass the inspection and these repairs or corrections are completed within 10 days after the initial inspection, then only the defective items shall be reexamined. If the repairs or corrections are not made within 10 days following the initial inspection, the school vehicle shall be completely reinspected.

(f) At any time, spot inspections of any school vehicle used for student transportation may be conducted by the Kansas highway patrol.

(g) Each school bus, activity bus, and school passenger vehicle that is purchased at any time following the required annual inspection for school vehicles shall pass the inspections required by this regulation before being used to transport students. (Authorized by and implementing K.S.A. 8-2009; effective July 1, 2000; amended March 28, 2003.)

91-38-6. School transportation driver qualifications. (a) Driver's licensing and age requirements. Each person employed by a school district or by a school bus contractor who, at any time, will provide student transportation shall be licensed in accordance with K.S.A. 8-234b and amendments thereto, or the appropriate licensing statutes of the person's state of residence. Each person also shall meet the requirements listed below:

(1) Each driver of a school bus or activity bus with a gross weight of over 26,000 pounds shall maintain a commercial class A or B driver's license, with passenger endorsement.

(2) Each driver of a school bus or activity bus that has a gross weight of 26,000 pounds or less and is designed for transporting 16 passengers or more shall maintain a commercial class A, B, or C driver's license, with passenger endorsement.

(3) Each driver of a school passenger vehicle or a school bus or activity bus that has a gross weight of 26,000

pounds or less and is designed to transport fewer than 16 passengers shall maintain an appropriate noncommercial operator's license.

(4) Each driver's license shall be valid within the driver's state of residence.

(5) Each driver of an activity bus shall be 21 years of age or older.

(b) Criminal and driving records.

(1) Each prospective school transportation provider or other school employee who may transport students shall be required to sign a statement indicating whether that individual has been convicted within the past 10 years in any state or federal court of any felony involving another person or any crime involving a child. A person who has been convicted of such a crime within the past 10 years shall not be employed, re-employed, or retained as an employee to provide student transportation.

(2) Each prospective driver shall be required to sign a statement indicating whether, within the past 10 years, that individual has been convicted in any state of any major traffic violations indicated in subsection (c) of this regulation.

(3) For purposes of this regulation, a conviction means entering a plea of guilty or nolo contendere, a finding of guilty by a court or jury, or forfeiture of bond.

(4) Each prospective school transportation provider shall give written authorization to the prospective employer to obtain the applicant's driving record through a local law enforcement agency or the Kansas department of revenue, division of vehicles, in accordance with K.S.A. 74-2012 and amendments thereto. The authorization also shall allow the prospective employer to obtain the applicant's driving record in states other than Kansas through a local law enforcement agency or the appropriate agency of the other state.

(c) Disqualification from employment.

(1) Except as otherwise provided in paragraph (2) of this subsection, a governing body shall not employ or retain to transport students any person who discloses or whose driving record indicates that, within the past 10 years, the person has been convicted of any of the following major traffic violations:

(A) Hit-and-run driving;

(B) driving while under the influence of alcohol or drugs;

(C) vehicular homicide;

(D) reckless driving; or

(E) any offense for which the driver's license was suspended or revoked pursuant to K.S.A. 8-254 and 8-255 and amendments thereto.

(2) A governing body may waive the disqualification for employment by a unanimous vote of the full membership of the governing body.

(d) Driver experience and training requirements.

(1) Each driver who operates a school vehicle to transport students shall have at least one year's experience in operating a motor vehicle.

(2) (A) School bus drivers shall be provided a minimum of 12 hours of bus driver training. The first six hours of training shall be completed without student passengers, but the remaining hours may be completed with student passengers, if the driver-trainer is on the bus. All driver

training shall be supervised by the assigned driver-trainer.

(B) Except as otherwise provided in paragraph (2) (C) of this subsection, each school transportation provider shall complete a first aid and cardiopulmonary resuscitation (CPR) course, approved by the state department of education, before the first day the driver is allowed to transport students. Each driver completing any training session shall obtain a wallet card or other certificate attesting to that individual's completion of the training program.

(C) A school transportation provider who is certified as an emergency medical service provider shall not be required to complete first aid and CPR training, if the emergency medical certification is maintained in valid status. As used in this paragraph, "emergency medical service provider" means first responder, emergency medical technician-basic, emergency medical technician-intermediate, emergency medical technician-paramedic, or mobile intensive care technician.

(e) (1) Each school transportation provider shall successfully complete a vehicle accident prevention course approved by the state department of education, before the first day the driver transports students. The driver shall obtain a completion certificate or wallet card as evidence that the course requirements have been met.

(2) After completion of the initial accident prevention course, each driver shall be required to maintain certification by either of the following:

(A) Completion of an accident prevention course at least every three years; or

(B) annual attendance at a workshop provided for school transportation personnel by the state department of education.

(3) The transportation supervisor shall maintain documentation of driver training for school transportation providers for the duration of the driver's employment, and a minimum of two years thereafter.

(f) Substitute and emergency school transportation providers.

(1) Substitute school transportation providers shall meet the requirements in this regulation, but they may be allowed up to 30 days following employment to complete the first aid, CPR, and accident prevention course training requirements.

(2) Any person who holds a valid commercial driver's license may operate a school bus in an emergency situation. For purposes of this paragraph, an "emergency situation" means a situation in which no qualified driver or substitute driver is available. A specific driver shall not drive as an emergency driver for more than five days during a school year.

(g) Physical examination and health requirements.

(1) The physical qualification requirements for school transportation providers in Kansas shall be those in 49 C.F.R. 391.41, as in effect on October 1, 2001, which is adopted by reference. The physical examination form that is prescribed by the federal highway administration, office of motor carriers, and that is available from the state department of education shall be utilized to document the results of each examination.

(2) The physical examination shall be certified by a person licensed to practice medicine and surgery, and shall be required according to the following schedule:

(A) Before beginning employment as a school transportation provider;

(B) at least every two years after the date of the initial physical examination; and

(C) at any time requested by the driver's employer, the school transportation supervisor, or the state department of education.

(3) A properly certified physical examination report required under this subsection shall constitute the certification of health required by K.S.A. 72-5213 and amendments thereto.

(4) Each governing body shall keep on file a current physical examination report for each school transportation provider. If a provider leaves employment for any reason, the person's last physical examination report shall be kept for two years after the person leaves.

(h) Waiver of physical requirements.

(1) (A) Any person failing to meet the requirements of subsection (g) may be permitted to be a school transportation provider for a particular school district, if a waiver is granted by the governing board of that school district under this subsection. Each waiver shall meet the following requirements:

(i) The person seeking the waiver, the transportation supervisor for the school district, and the contract manager, if applicable, shall submit a joint application for a waiver to the local board of education.

(ii) Each application shall be accompanied by reports from two physicians licensed to practice medicine and surgery, indicating their opinions regarding the person's ability to safely operate a school bus.

(iii) The application shall contain a description of the type and size of the vehicle to be driven and any special equipment required to accommodate the driver to safely operate the vehicle, the general area and type of roads to be traveled, distances and time period contemplated, and the experience of the person in driving vehicles of the type to be driven.

(B) An application for a waiver shall be granted only by unanimous approval of the governing board.

(2) Restrictions of the waiver as approved by the governing body.

(A) A waiver as described in paragraph (1) of this subsection shall not be granted for a period longer than two years, but may be renewed by following the procedures in paragraph (1) of this subsection.

(B) While on duty, the driver shall keep in the driver's possession the original document granting the waiver or a legible copy of it.

(C) Each governing body shall retain the original document granting the waiver or a legible copy of the waiver in the driver's personnel file for as long as the driver is employed and for a period of at least two years following termination of the driver's employment.

(D) A waiver may be revoked, for cause, by the governing body. Before revocation, the governing body shall perform the following:

(i) Suspend the driver from service;

(continued)

(ii) provide notice of the proposed revocation to the driver, including the reason or reasons for the proposed revocation; and

(iii) allow the driver a reasonable opportunity to show cause, if any, why the revocation should not occur.

(i) Alcohol and drug testing requirements. Each governing body may develop a policy to include all drivers of any school motor vehicles in the alcohol and drug testing program required for drivers holding commercial driver's licenses. (Authorized by and implementing K.S.A. 8-2009; effective July 1, 2000; amended March 28, 2003.)

91-38-7. Driver's duties and responsibilities. (a) Each school transportation provider shall inspect a school vehicle before its use to ascertain that the vehicle is in a safe condition and equipped as required by law, and that all required equipment is in working order. The school transportation provider shall document each inspection.

(b) If any defect is discovered, students shall not be transported in the vehicle until the defect is corrected.

(c) Documentation of the inspections of each school vehicle shall be kept on file for a minimum of one year following the vehicle inspection.

(d) A school transportation provider shall not drive a school vehicle for more than 10 consecutive hours or for more than a total of 10 hours in any 15-hour period.

(e) Each school transportation provider shall ensure that all doors are closed before the vehicle is put into motion and remain closed while the vehicle is moving.

(f) Each school transportation provider shall ensure that openings for the service door, emergency exits, and aisles are kept clear of any obstructions.

(g) Each school transportation provider shall utilize the driver's safety belt at all times while the vehicle is in motion.

(h) If the school transportation provider leaves the driver's seat, the parking brake shall be set, the motor turned off, and the keys removed. However, drivers of specially equipped buses may leave the motor running to operate a power lift after setting the parking brake.

(i) If a school vehicle is refueled during any trip when passengers are being transported, the school transportation provider shall unload all passengers from the vehicle and turn off the vehicle's motor before beginning refueling procedures. Fuel shall not be transported in any manner, except in the vehicle's fuel tank.

(j) Following the completion of any trip, each school transportation provider shall perform a walk-through inspection of the school bus or activity bus, or a visual check of the school passenger vehicle, that the provider was driving, to ensure that all passengers have disembarked.

(k) A driver of a school bus or activity bus shall not tow any trailer or other vehicle with the bus, while any passenger is on the bus. (Authorized by and implementing K.S.A. 8-2009 and 8-2009a; effective July 1, 2000; amended March 28, 2003.)

Article 1.—ELIGIBILITY REQUIREMENTS

108-1-4. Local unit of government employee health care benefits plan. (a) Definitions.

(1) "Commission" means the Kansas state employees health care commission.

(2) "Qualified local unit" means a county, township, or city that meets the terms, conditions, limitations, exclusions, and other provisions established by the commission for participation in the local unit employee health care benefits component of the health care benefits program and that has entered into a written agreement with the commission to participate in the program.

(3) "Local unit employee" means any individual who is employed by a qualified local unit and who meets one of the following criteria:

(A) The employee meets the definition of employee under K.S.A. 74-4902 or K.S.A. 74-4952, and amendments thereto.

(B) The employee would otherwise meet the definition of employee under K.S.A. 74-4902 or K.S.A. 74-4952, and amendments thereto, if the qualified local unit was a participating employer.

(4) "Local unit plan" means the local unit employee health care benefits component of the health care benefits program.

(b) Active participants. Subject to the provisions of subsection (c), each local unit employee shall be eligible to participate as an active participant in the local unit plan. Eligibility and participation shall be subject to terms, conditions, limitations, exclusions, and other provisions established by the commission, including the amount and method of payment for employee and employer contributions.

(c) Waiting periods.

(1) Each local unit employee whose first day of work for a qualified local unit is on or after the first day on which the employee's qualified local unit participates in the local unit plan shall become eligible for coverage following completion of a 60-day waiting period beginning with the first day of work for the qualified local unit. Each

local unit employee shall have 31 days after becoming eligible to elect health insurance coverage.

(2) The waiting period established in paragraph (c)(1) shall not apply if all of the following conditions are met:

(A) The person is returning to work for the qualified local unit, is transferring from another qualified local unit, or is transferring from a position that is eligible for coverage under K.A.R. 108-1-1 or K.A.R. 108-1-3.

(B) Immediately before leaving the prior position, the person was enrolled in the local unit plan, the school district plan under K.A.R. 108-1-3, or the health care benefits program under K.A.R. 108-1-1 or was enrolled in the health care insurance plan provided by the employee's qualified local unit.

(C) The break in service between the prior position and the new position does not exceed the following time periods:

- (i) 30 or fewer calendar days; or
- (ii) 365 or fewer days, if the person was laid off in accordance with the practices of the prior employer.

(3) The waiting period established in paragraph (c)(1) shall not apply to any person who, on that person's first day of work for the qualified local unit, is enrolled in the local unit plan, the school district plan under K.A.R. 108-1-3, or the health care benefits plan under K.A.R. 108-1-1 on any of the following bases:

- (A) As a direct bill participant;
- (B) under the continuation of benefits coverage provided under public law 99-272, as amended; or
- (C) as a spouse or dependent of an active participant in any of those plans.

(4) The waiting period established in paragraph (c)(1) may be waived if the chief administrative officer of the qualified local unit, or the chief administrative officer's designee, meets the following requirements:

(A) The chief administrative officer or the chief administrative officer's designee shall provide both of the following certifications to the commission, or its designee, in writing:

(i) A potential new local unit employee is not entitled to continuation of health benefits available from prior insurance coverage.

(ii) The waiting period poses, or will pose, an obstacle to recruitment.

(B) The chief administrative officer or the chief administrative officer's designee shall submit the request for a waiver before the employee's acceptance of the position.

(5) Each local unit employee who is employed by the employee's qualified local unit immediately before the first day on which the employee's qualified local unit participates in the local unit plan shall be subject to transitional provisions established by the commission regarding waiting periods and the date on which the employee becomes eligible to participate in the local unit plan.

(6) The waiting period described in this subsection may be waived by the commission if the commission determines that failure to grant a waiver would create a manifest injustice or undue hardship on the local unit employee.

(d) Categories of direct bill participants. Subject to the provisions of subsection (e), the classes of persons eligible

to participate as members of the local unit plan on a direct bill basis shall be the following:

(1) Any retired local unit employee who meets one of the following conditions:

(A) The employee is receiving state warrants for retirement benefits under the Kansas public employees retirement system or the Kansas police and firemen's retirement system.

(B) If the qualified local unit is not a participating employer under either the Kansas public employees retirement system or the Kansas police and firemen's retirement system, the employee is receiving retirement benefits under the retirement plan provided by the qualified local unit;

(2) any totally disabled former local unit employee who meets one of the following conditions:

(A) The employee is receiving benefits under the Kansas public employees retirement system or the Kansas police and firemen's retirement system.

(B) If the qualified local unit is not a participating employer under either the Kansas public employees retirement system or the Kansas police and firemen's retirement system, the employee is receiving disability benefits under the retirement or disability plan provided by the qualified local unit;

(3) any surviving spouse or dependent of a qualifying participant in the local unit plan;

(4) any person who is a local unit employee and who is on approved leave without pay in accordance with the practices of the qualified local unit; and

(5) any individual who was covered by the health care plan offered by the qualified local unit on the day immediately before the first day on which the qualified local unit participates in the local unit plan, except that no individual who is an employee of the qualified local unit and who does not meet the definition of local unit employee in subsection (a) shall be qualified as a direct bill participant under this paragraph.

(e) Conditions for direct bill participants. Each person who is within a class listed in subsection (d) shall be eligible to participate on a direct bill basis only if the person meets both of the following requirements:

(1) The person was covered by the local unit plan or the health care insurance plan offered by the qualified local unit on one of the following bases:

(A) Immediately before the date the person ceased to be eligible for coverage or, for any person identified in paragraph (d)(5), immediately before the first day on which the qualified local unit participates in the local unit plan, the person either was covered as an active participant under subsection (b) or was covered by the health care insurance plan offered by the employee's qualified local unit.

(B) The person is a surviving spouse or dependent of a person who was enrolled as a plan participant under subsection (b) or (d) at the time the plan participant died, and the person was enrolled in spouse or dependent coverage under subsection (g) at the time the plan participant died.

(C) The person is a surviving spouse or dependent of a person who was enrolled as a plan participant under

the health care insurance plan offered by the participant's qualified local unit at the time the participant died, and the person was covered under the same plan at the time the participant died.

(2) The person files a statement of election with the commission's health benefits administrator to continue coverage under the plan. The election to continue coverage shall be submitted on a form prescribed by the commission's health benefits administrator. The form shall be submitted no more than 30 days after the person ceased to be eligible for coverage or, in the case of any individual identified in paragraph (d)(5), no more than 30 days after the first day on which the qualified local unit participates in the local unit plan.

(f) Continuation of benefits (COBRA) coverage. Any individual with rights to extend coverage under provisions of public law 99-272, as amended, may participate in the local unit plan, subject to the provisions of that federal law.

(g) Coverage of spouses and dependents. Any person who is enrolled in the local unit plan under subsection (b), (d), or (f) as a primary participant may enroll the following dependents, subject to the same conditions and limitations that apply to the primary participant:

(1) The primary participant's lawful wife or husband; and

(2) any of the primary participant's eligible dependent children. An eligible dependent child who is enrolled in the local unit plan by one primary participant shall not be eligible to be enrolled by another primary participant in the local unit plan, the school district plan under K.A.R. 108-1-3, or the health care benefits program under K.A.R. 108-1-1.

(h) Eligible dependent participants; definitions. For purposes of subsection (g), "primary participant," "child," and "eligible dependent child" shall be defined as those terms are defined in K.A.R. 108-1-1.

(i) Direct bill participants; continuous coverage provisions.

(1) Except as otherwise provided in this subsection, each direct bill participant enrolled in the local unit plan shall maintain continuous coverage in the program or shall lose eligibility to be in the local unit plan as a direct bill participant under subsection (d).

(2) Any person who discontinues direct bill coverage in the local unit plan and maintains continuous coverage in a medicare risk plan may return to the local unit plan according to the open enrollment procedures.

(j) An individual who is eligible to enroll as an active participant under subsection (b) and whose spouse is eligible for coverage as an active participant under K.A.R. 108-1-1 shall not be eligible for coverage as a dependent under K.A.R. 108-1-1. Any other dependents of the individual and the individual's spouse may be enrolled under the provisions of either K.A.R. 108-1-1 or K.A.R. 108-1-4. SENATE BILL No. 52

AN ACT concerning the emergency medical services board; relating to financial support therefor; amending K.S.A. 2002 Supp. 75-1508 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 2002 Supp. 75-1508 is hereby amended to read as follows: 75-1508. (a) For the purpose of maintaining the department of the state fire marshal and the payment of the expenses incident thereto, each fire insurance company doing business in this state shall pay to the commissioner of insurance, on or before March 15 each year, beginning with the year 1984, and each year thereafter, in addition to the taxes, fees and charges now required by law to be paid by it, such levy as may be made by the state fire marshal. The levy shall not be more than 1.0% for calendar years 2003 2002 and 2004 2003, and 1.25% for calendar year 2005 2004 and ensuing years, of a sum equal to the gross cash receipts as premiums of such company on all fire business transacted by it in the state of Kansas during the calendar year next preceding, as shown by its annual statement under oath to the state insurance department.

(b) For the purposes of maintaining the emergency medical services board and the payment of the expenses incident thereto, each fire insurance company doing business in this state shall pay to the commissioner of insurance, on or before March 15 each year, beginning with the calendar year 2003, 2002 and each year thereafter ending with calendar year 2003, in addition to the taxes, fees and charges now required by law to be paid by it, such levy as may be made by the emergency medical services board. The levy shall not be more than .25% of a sum equal to the gross cash receipts as premiums of such company on all fire business transacted by it in the state of Kansas during the calendar year next preceding, as shown by its annual statement under oath to the state insurance department. The provisions of this subsection (b) shall expire on December 31 July 1, 2004.

Sec. 2. K.S.A. 2002 Supp. 75-1508 is hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the Kansas register.

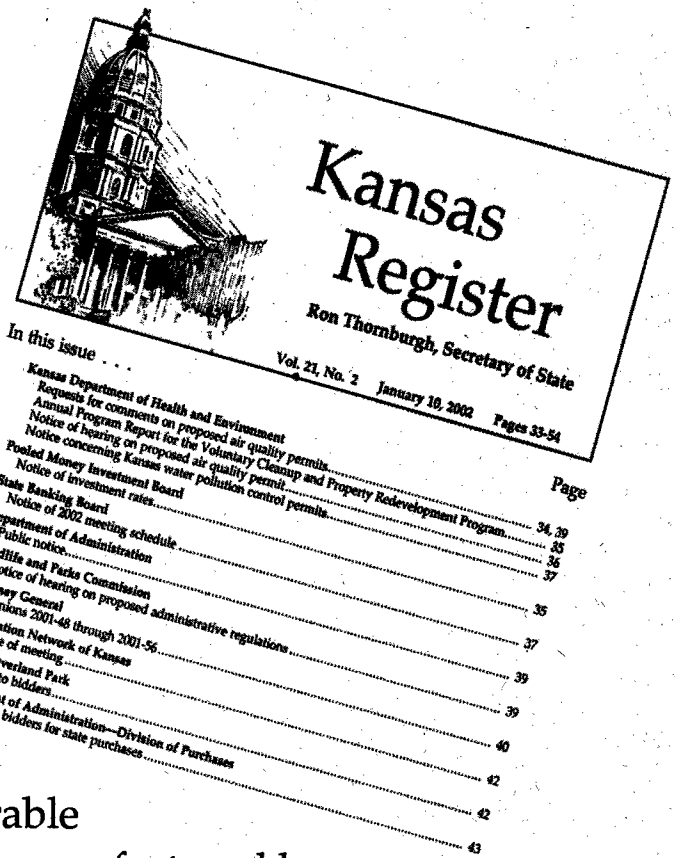


