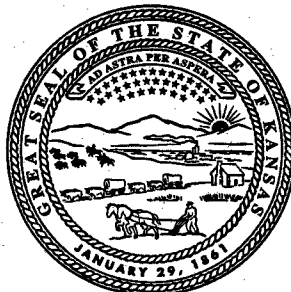

Executive Order 03-07

Establishing a Kansas Employee Preference Program for the State of Kansas

WHEREAS, the current fiscal situation facing the State of Kansas has necessitated spending and funding cuts and some state agencies have been forced to downsize in order to accommodate those cuts; and

WHEREAS, the employees of the State of Kansas are essential to maintain its service capacity and continue to provide quality services to its citizens; and

WHEREAS, the State of Kansas has made a substantial investment in its workforce; and

WHEREAS, the State of Kansas should make every effort to retain these employees because of this investment and to recognize their service and contributions to the State of Kansas.

NOW, THEREFORE, pursuant to the authority vested in me as Governor and chief executive of the State of Kansas, I hereby direct that the Secretary of Administration prepare necessary personnel regulations, policies, or procedures to establish a Kansas Employee Preference Program whereby the State of Kansas can demonstrate its commitment to these employees and maintain its investment. Pursuant to this program, classified state employees who are affected by layoffs shall receive preference for any announced vacant position for which they apply that is at the same pay grade or lower than the pay grade of the positions from which the employees were laid off or scheduled to be laid off. Such regulations, policies or procedures developed by the Department of Administration shall include provisions for eligibility; duration of this preference; procedures for filling positions under the program; and any other criteria deemed necessary to implement this program.

This document shall be filed with the Secretary of State as Executive Order 03-07 and shall be effective immediately.

Executive Order No. 03-08
Establishing Cellular Phone Policies

WHEREAS, the use of cellular phones while operating vehicles presents potentially unsafe driving conditions; and

WHEREAS, the use of cellular phones while operating state vehicles is strongly discouraged as it is inconsistent with the responsibility of state employees to operate state vehicles in a safe and prudent manner; and

WHEREAS, the use of state cellular phones for personal, non-state business purposes can constitute an improper use of state property; and

WHEREAS, the Department of Administration is to exercise administrative functions in developing plans for improvements and economies in the operation of the several state agencies; and

WHEREAS, the adoption of the attached cellular phone policies will provide such improvements and economies in the operation of state agencies.

NOW THEREFORE, pursuant to K.S.A. 75-3707 and 75-3711 and the authority vested in me as Governor of the State of Kansas, and having applied the guidelines and limitations of K.S.A. 75-3711c, I hereby direct the Secretary of Administration to provide the executive branch agencies under the jurisdiction of the Governor copies of the two attached cellular phone policies. Such policies are to be utilized in the operations of such state agencies. Each such state agency shall utilize such policies and make them known and available to their employees.

State of Kansas
Cellular Phone Policy

Cellular Phones Provided by State of Kansas

General

1. Cellular phones are provided to improve customer service and to enhance business efficiencies. Cellular phones are not a personal benefit and shall not be a primary mode of communication, unless they are the most cost-effective means to conduct state business.

2. Employees are responsible for operating state-owned vehicles and potentially hazardous equipment in a safe and prudent manner, and therefore, employees should refrain from using cellular phones while operating such vehicles and equipment.

3. Possessing a cellular phone is a privilege and all employees are expected to use them responsibly. The state will seek reimbursement for any additional charges resulting from personal calls. Misuse of a state cellular phone may result in its revocation and possible disciplinary action against the employee pursuant to K.S.A. 75-2949.

4. If the cellular phone contract is based on minutes used, a minimal plan shall be utilized. In other words, the smallest plan available to accommodate the particular business need shall be utilized. No employee may approve his/her own cellular service plan.

Billing Statements and Reconciliation

1. Each state cellular phone will receive a monthly activity statement for all charges.

2. The user must review the monthly statement for billing accuracy.

3. Monthly activity statements must be attached to the voucher and retained for a period of time consistent with record retention policies.

Personal Use

More than de minimis personal use of a state-provided cellular phone without written authorization by the employees' agency head is not allowed. When personal calls/minutes cause the monthly plan minutes to be exceeded, reimbursement for those minutes must be made to the state. Additionally, all long distance and roaming charges incurred for personal calls (even if under the plan limit) must be reimbursed to the state. All reimbursements are to be made within 15 days of receipt and reconciliation of the monthly statement.

Violation

Employees violating this policy may be subject to disciplinary action in accordance with the provisions of K.S.A. 75-2949, including but not limited to, K.S.A. 75-2949e(a)(3) "careless, negligent or improper use of state property," or K.S.A. 75-2949f(1) "refusal to accept a reasonable and proper assignment from an authorized supervisor. Personal Cellular Phone Policy

The following policy shall be in effect for the use of employee personal cellular phones in order to promote a safe working environment and to limit the liability of the State due to the use of personal cellular phones in non-work related situations. State employees may carry personal cellular phones with them while on state time or while operating state equipment, but are subject to the following restrictions:

1. Excessive use of a personal cellular phone for personal business during duty hours is considered outside the employees' scope of employment.

2. Employees are responsible for operating state-owned vehicles and potentially hazardous equipment in a safe and prudent manner, and therefore, employees should refrain from using personal cellular phones while operating such vehicles and equipment.

3. The State assumes no liability for loss or damage to employees' personal cellular phones carried in state vehicles or left on state property. Employees assume the risk of loss or damage to personal cellular phones carried by employees during working hours.

4. When authorized in writing by the agency head or designee, the cost of using a personal cellular phone for official business may be reimbursed to the employee. Having a personal cellular phone is a choice the employee makes, and if the cellular phone is used for business purposes, any reimbursement will be for reasonable costs in excess of the base plan plus any additional fees such as roaming fees or other fees and taxes incurred as a direct result of the business use. In no instance will the employee be reimbursed more than the monthly cost to the employee.

5. Employees are not permitted to receive a monthly allowance from a state agency for the use of a cellular phone.

6. The violation of any provision of this policy may result in possible disciplinary action pursuant to K.S.A. 75-2949, including but not limited to, K.S.A. 75-2949f(i) "willful endangerment of the lives or property of others, or both," or K.S.A. 75-2949f(1) "refusal to accept a reasonable and proper assignment from an authorized supervisor."

This document shall be filed with the Secretary of State as Executive Order No. 03-08 and shall become effective on and after March 31, 2003.

68-2-15. Nametags. (a) The following individuals shall wear a visible nametag under the following conditions:

Article 19.—KANSAS RETAILERS' SALES TAX

92-19-200. Refund of sales tax paid upon food; definitions of "member of a household." (a) "Member of a household" shall mean any of the following:

(1) If the claimant files an individual income tax return, a person, other than the claimant, for whom a personal exemption is or may be claimed by the claimant for income tax purposes on the income tax return filed by the claimant for the year in which the food sales tax refund claim is made and who occupies a residence with the claimant for all or any part of the year;

(2) if the claimant does not file an individual income tax return, a person, other than the claimant, for whom a personal exemption could have been claimed by the claimant for income tax purposes for the year in which the food sales tax refund claim is made if an individual income tax return had been filed and who occupies a residence with the claimant for all or any part of the year; or

(3) a deceased spouse of a claimant for whom a personal exemption may be claimed by the claimant for income tax purposes for the year in which the food sales tax refund claim is made.

(b) "Member of a household" shall not include a person for whom a personal exemption is not allowed to be claimed by the claimant for income tax purposes for the year in which the food sales tax refund claim is made, regardless of how long the person occupies a residence with the claimant. (Authorized by K.S.A. 79-3636; implementing K.S.A. 2001 Supp. 79-3633; effective April 18, 2003.)

92-19-201. Refund of sales tax paid upon food; definition of domicile; residency requirement; temporary absence. (a) "Domicile" shall mean that place where a person resides, where the person has an intention to remain, and to which that person intends to return following any absence.

(b) Each claimant shall have maintained a domicile within the state of Kansas and resided within the state of Kansas during the entire year preceding the year in which the claim is filed to be eligible for a food sales tax refund.

(c) For purposes of the food sales tax refund program, a claimant shall be domiciled in this state if the claimant

resides in this state and maintains the principal home within this state.

(d) A temporary absence from the domicile shall not disqualify a claimant for a refund. A seasonal absence or absence of a reasonable duration shall constitute a temporary absence. (Authorized by K.S.A. 79-3636; implementing K.S.A. 2001 Supp. 79-3633; effective April 18, 2003.)

92-19-202. Refund of sales tax paid upon food; right of representative to make a claim on behalf of claimant. (a) Each individual filing a refund claim as a legal guardian or conservator of a claimant shall include with the claim an attested copy of the court order granting the power to act as a legal guardian or conservator for the claimant. A refund claim filed pursuant to the authority of a legal guardian or conservator shall be denied unless a copy of the court order granting the power to act as a legal guardian or conservator for the claimant is included with the refund claim.

(b) Each individual filing a refund claim as an attorney-in-fact for a claimant shall include with the claim a written document stating that an attorney-client relationship with the claimant exists. A refund claim filed pursuant to an authority of a power of attorney shall be denied unless a copy of the duly executed power of attorney for the claimant is included with the refund claim.

(c) An individual may file a refund claim on behalf of the claimant if the individual completes and includes with the claim an affidavit in support of the demand for a food sales tax refund on a form prescribed by the director of taxation. 92-19-203. Refund of sales tax paid upon food; death of claimant subsequent to filing claim; disbursement of refund. (a) If a claimant dies after timely filing a refund claim and a member of the household survives, the surviving member shall submit an affidavit of membership in the claimant's household and either a copy of the claimant's death certificate or other proof of the claimant's death to the director before receiving a disbursement.

(b) If a claimant dies after timely filing a refund claim and was the only member of the household, the individual appointed as executor or administrator of the claimant's estate shall submit an attested copy of the court order appointing that individual as executor or administrator and either a copy of the claimant's death certificate or other proof of the claimant's death to the director of taxation before receiving a disbursement. If an executor or administrator has not been appointed and qualified, an heir at law shall submit an affidavit of heirship and either a copy of the claimant's death certificate or other proof of the claimant's death to the director of taxation before receiving a disbursement. Article 8.—NOXIOUS WEEDS

4-8-43. Noxious weeds; declaration of county as a sericea lespedeza disaster area. The board of county commissioners of any county may petition the Kansas secretary of agriculture to declare that county to be a sericea lespedeza disaster area. (a) The petition form, which shall be provided by the secretary, shall include the following information:

(1) The number of acres of sericea lespedeza identified on private land;

(2) the number of acres of sericea lespedeza identified on public land;

(3) the approximate amount of expenditures by private and public land managers to control the infestation;

(4) the county mil levy for noxious weeds and the extent to which the acres infested by sericea lespedeza are being treated; and

(5) a specific, practical action plan detailing the county's approach to contain and manage the acres infested with sericea lespedeza in the county.

(b) Following approval of the petition by the board of county commissioners, the petition shall be submitted to the secretary for approval or denial.

(c) A county may be designated as a sericea lespedeza disaster area by the secretary based upon the following criteria:

(1) The percent of land area in the county estimated to be infested with sericea lespedeza;

(2) the percent of acres known to have been treated for sericea lespedeza;

(3) a designation of whether or not the county is an exporter of native hay or mulch;

(4) the percent of mil levy for weed control that is dedicated to sericea lespedeza control; and

(5) a specification of whether the acreage of sericea lespedeza is equal to or greater than two percent of any of the following:

(A) The total land area of the county;

(B) the amount of private land in the county; or

(C) the amount of public land in the county.

(d) Random spot checks of counties designated as sericea lespedeza disaster areas may be conducted by the secretary to ensure consistent implementation as approved in the action plan. Article 5.—PROVIDER PARTICIPATION, SCOPE OF SERVICES, AND REIMBURSEMENTS FOR THE MEDICAID (MEDICAL ASSISTANCE) PROGRAM

30-5-81u. General hospital groups under the diagnosis-related group (DRG) reimbursement system. (a) General hospitals participating in the Kansas medicaid/medikan program shall be assigned by the Kansas department of social and rehabilitation services to one of three groups. Each general hospital shall be annually notified by the department in writing of the hospital's group assignment.

(1) Each general hospital assigned to group one shall meet either of the following criteria:

(A) Be located within a metropolitan statistical area within the state of Kansas and have at least 200 general hospital inpatient beds; or

(B) be located within the state of Kansas and within 10 miles of a general hospital meeting the criteria set forth in paragraph (a)(1)(A).

(2) Each general hospital assigned to group two shall meet one of the following criteria:

(A) Be located within a metropolitan statistical area in the state of Kansas and have fewer than 200 general hospital inpatient beds;

(B) be located outside of a metropolitan statistical area in the state of Kansas or its border cities and have at least 100 general hospital inpatient beds;

(C) be located within the state of Kansas and within 10 miles of a general hospital meeting the criteria set forth in paragraph (a)(2)(A) or (B); or

(D) be located outside of the state of Kansas.

(3) A general hospital shall be assigned to group three if it does not meet the criteria specified in either paragraph (a)(1) or (a)(2) above.

(4) A general hospital shall be assigned to group one if it meets the criteria for assignment to both group one and group two.

(b) General hospital group assignments shall be redetermined annually by the department based upon the criteria in subsection (a). (Authorized by and implementing K.S.A. 39-708c; effective July 1, 1989; amended Dec. 29, 1995; amended, T-30-1-2-03, Jan. 2, 2003; amended April 18, 2003.)

30-5-102. Scope of optometric and optical services. Optometric and optical services shall be covered for Kan Be Healthy participants only. (a) These services shall include the following:

(1) Optometric examinations;

(2) medical treatment pursuant to K.S.A. 65-1501, and amendments thereto;

(3) grinding and edging lenses, and assembling and dispensing eyeglasses; and

(4) providing optical materials. Optical materials shall include the following:

(A) Frames. The materials covered shall be only frames showing the manufacturer's name on either the front or temple; and

(B) lenses. Only lenses meeting designated standards shall be acceptable. For single lens replacement, the replacement lens shall be made of quality similar to that of the remaining usable lens.

(b) Limitations.

(1) Prior authorization shall be required for designated services.

(2) The second and subsequent sets of eyeglasses shall meet the standards specified by the secretary. 30-5-105. Scope of hearing services. Hearing services shall be covered for Kan Be Healthy participants only. (a) Medical diagnosis, audiological testing, and the fitting and dispensing of hearing aids and appropriate accessories shall be covered.

(b) A medical diagnosis shall be made by an ear specialist or by a general practitioner if an ear specialist is not easily available.

(c) Audiological testing shall be performed by a physician or an audiologist.

(d) Fitting, dispensing, and follow-up shall be performed by a hearing aid dealer.

(e) A hearing aid shall not be covered if the physician indicates that a medical condition contraindicates the effectiveness of an aid. Article 6.—MEDICAL ASSISTANCE PROGRAM—CLIENTS' ELIGIBILITY FOR PARTICIPATION

30-6-103. Determined eligibles; protected income levels. (a) Independent living and home- and community-based services arrangements.

(1) The protected income level for any person in an independent living arrangement or in the home- and community-based services program shall be based on the total number of persons in the assistance plan and any other persons in the family group whose income is being considered.

(2) The protected income levels for independent living may also be used when an applicant or recipient meets either of these conditions:

(A) Enters a medicaid-approved facility, except that this provision shall not apply in situations in which only one spouse of a married couple enters an institutional living arrangement; or

(B) is absent from the home for medical care for a period not to exceed two months to allow for maintaining the applicant's or recipient's independent living arrangements.

(3) Except as specified in paragraphs (4), (5), (6), (7), and (8) below, the following table shall be used to deter-

mine the protected income level for persons in independent living.

The protected income level for additional persons shall be the sum of the basic standard for a like public assistance family plus the maximum state shelter standard.

(4) In determining eligibility for pregnant women and for infants under the provisions of K.A.R. 30-6-77(a) and (b), 150 percent of the official federal poverty income guidelines shall serve as the protected income level.

(5) In determining eligibility for other young children under the provisions of K.A.R. 30-6-77(c), 133 percent of the official federal poverty income guidelines shall serve as the protected income level.

(6) In determining eligibility for older children under the provisions of K.A.R. 30-6-77(d), 100 percent of the official federal poverty income guidelines shall serve as the protected income level.

(7) In determining eligibility for poverty-level medicare beneficiaries under the provisions of K.A.R. 30-6-86, 100 percent of the official federal poverty income guidelines shall serve as the protected income level.

(8) In determining eligibility for working disabled individuals under the provisions of K.A.R. 30-6-87, 200 percent of the official federal poverty income guidelines shall serve as the protected income level.

(9) In determining eligibility for low-income medicare beneficiaries under the provisions of K.A.R. 30-6-86, 120 percent of the official federal poverty income guidelines shall serve as the protected income level.

(10) In determining eligibility for low-income medicare beneficiaries under the provisions of K.A.R. 30-6-86, 120 to 135 percent of the official federal poverty income guidelines shall serve as the protected income level subject to available federal funding.

(11) In determining eligibility for disabled individuals with earned income under the provisions of K.A.R. 30-6-88, 300 percent of the official federal poverty income guidelines shall serve as the protected income level.

(b) Institutional living arrangements. For persons residing in institutional settings, the protected income level shall be \$30.00, except as specified in paragraph (a)(2).

(c) Home- and community-based services arrangements. For persons in the home- and community-based services program, the monthly protected income level shall be \$645.00. Each person hunting in this subunit during the firearm deer season shall be in possession of any permits and licenses required by the air national guard.

(e) Pawnee; unit 5: that part of Kansas bounded by a line from the state highway K-4 and state highway K-14 junction, then south on state highway K-14 to its junction with federal highway US-50, then west on federal highway US-50 to its junction with federal highway US-183, then northeast and north on federal highway US-183 to its junction with federal highway US-156, then west on federal highway US-156 to its junction with federal highway US-283, then north on federal highway US-283 to its junction with state highway K-4, then east on state highway K-4 to its junction with state highway K-14, except federal and state sanctuaries.

(o) Ninnescah; unit 15: that part of Kansas bounded by a line from the Oklahoma-Kansas state line north on state highway K-179 to its junction with state highway K-14, then continuing north on state highway K-14 to its junction with state highway K-42, then west on state highway K-42 to its junction with federal highway US-281, then north on federal highway US-281 to its junction with federal highway US-50, then east on federal highway US-50 to its junction with federal highway US-77, then south on federal highway US-77 to its junction with state highway K-15, then west and northwest on state highway K-15 to its junction with state highway K-53, then west on state highway K-53 to its junction with federal highway US-81, then south on federal highway US-81 to the Oklahoma-Kansas state line, then west along the Oklahoma-Kansas state line to its junction with state highway K-179, except federal and state sanctuaries.

(p) Red Hills; unit 16: that part of Kansas bounded by a line from the Oklahoma-Kansas state line north on federal highway US-283 to its junction with federal highway US-54, then east on federal highway US-54 to its junction with federal highway US-183, then north on federal highway US-183 to its junction with federal highway US-50, then east on federal highway US-50 to its junction with federal highway US-281, then south on federal highway US-281 to its junction with state highway K-42, then east on state highway K-42 to its junction with state highway K-14, then south on state highway K-14 to its junction with state highway K-179, then south on state highway K-179 to the Oklahoma-Kansas state line, then west along the Oklahoma-Kansas state line to its junction with federal highway US-283, except federal and state sanctuaries.

(q) West Arkansas; unit 17: that part of Kansas bounded by a line from the Colorado-Kansas state line east on state highway K-96 to its junction with federal highway US-83, then north on federal highway US-83 to its junction with state highway K-4, then east on state highway K-4 to its junction with federal highway US-283, then south on federal highway US-283 to its junction with federal highway US-156, then east on federal highway US-156 to its junction with federal highway US-183, then south on federal highway US-183 to its junction with federal highway US-54, then southwest on federal highway US-54 to its junction with federal highway US-283, then north on federal highway US-283 to its junction with federal highway US-56, then southwest on federal highway US-56 to its junction with state highway K-144, then west on state highway K-144 to its junction with federal highway US-160, then continuing west on federal highway US-160 to the Colorado-Kansas state line, then north along the Colorado-Kansas state line to its junction with state highway K-96, except federal and state sanctuaries.

(r) Cimarron; unit 18: that part of Kansas bounded by a line from the Colorado-Kansas state line east on federal

highway US-160 to its junction with state highway K-144, then east on state highway K-144 to its junction with federal highway US-56, then east on federal highway US-56 to its junction with federal highway US-283, then south on federal highway US-283 to its junction with the Oklahoma-Kansas state line, then west along the Oklahoma-Kansas state line to its junction with the Colorado-Kansas state line, then north along the Colorado-Kansas state line to its junction with federal highway US-160, except federal and state sanctuaries.

(s) Kansas City urban; unit 19: that part of Kansas bounded by a line from the Missouri-Kansas state line west on Johnson County 199 Street to its junction with federal highway US-56, then west on federal highway US-56 to its junction with South Topeka Boulevard, then north on South Topeka Boulevard to its junction with Shawnee County SW 93 Road, then west on Shawnee County SW 93 Road to its junction with Shawnee County SW Auburn Road, then north on Shawnee County SW Auburn Road to its junction with interstate highway I-70, then west on interstate highway I-70 to its junction with Carlson-Rossville Road, then north on Carlson-Rossville Road to its junction with federal highway US-24, then southeast on federal highway US-24 to its junction with Shawnee County NW Humphrey Road, then north on Shawnee County NW Humphrey Road to its junction with Shawnee County NW 62 Street, then east on Shawnee County NW 62 Street to its junction with Jefferson County Clark Road, then south on Jefferson County Clark Road to its junction with Jefferson County 50 Road, then east on Jefferson County 50 Road to state highway K-237, then south on state highway K-237 to its junction with federal highway US-24, then east on federal highway US-24 to its junction with Tonganoxie Drive, then northeast on Tonganoxie Drive to its junction with Leavenworth County 187 Street, then north on Leavenworth County 187 Street to its junction with state highway K-92, then northeast on state highway K-92 to the Missouri-Kansas state line, then south on the Missouri-Kansas state line to Johnson County 199 Street, except federal and state sanctuaries. (Authorized by K.S.A. 32-807; implementing K.S.A. 32-807 and K.S.A. 2002 Supp. 32-937; effective April 30, 1990; amended June 8, 1992; amended June 1, 1993; amended June 13, 1994; amended May 30, 1995; amended June 6, 1997; amended July 21, 2000; amended April 18, 2003.)

115-4-11. Big game permit applications. (a) General application provisions.

(1) Unless otherwise authorized by law or regulation, an individual shall not apply for or obtain more than one big game permit for each big game species.

(2) Unless otherwise authorized by law or regulation, each big game permit application shall be signed by the individual applying for the permit.

(3) Subject to any priority draw system established by this regulation, if the number of permit applications of a specific species and type received by the designated application deadline exceeds the number of available permits of that species and type, a random drawing to issue permits of that species and type shall be conducted by the secretary.

(4) A hunt-on-your-own-land permit shall not be tabulated in a priority draw system if the permit would otherwise reduce the applicant's odds of receiving a big game permit through that draw system.

(b) Deer permit applications.

(1) Subject to any priority draw system established by this subsection, in awarding deer permits in units having a limited number of permits, the first priority shall be given to those applicants who did not receive, in the previous year, a deer permit that allowed the taking of an antlered deer. All other deer permit applicants shall be given equal priority.

(2) In awarding a limited number of deer permits by a priority draw system, the first priority shall be given to those individuals who have earned the highest number of preference points. Preference points shall be awarded as follows:

(A) One point shall be awarded to an individual for each year the individual is unsuccessful in obtaining, by a priority draw system, a deer permit that allows the taking of an antlered deer.

(B) If the individual fails to make at least one application within a period of five consecutive years, all earned points shall be lost.

(C) If an applicant obtains, by a priority draw system, a deer permit that allows the taking of an antlered deer, all earned points shall be lost.

(D) If the number of applicants with the most preference points exceeds the number of permits for specified units or permit types, then a drawing shall be held to determine the successful applicants.

(c) Antelope permit applications. In awarding firearm antelope permits, the first priority shall be given to those individuals who have earned the highest number of preference points. Preference points shall be awarded as follows:

(1) One point shall be awarded to an individual for each year the individual is unsuccessful in obtaining an antelope permit.

(2) If the individual fails to make at least one application within a period of five consecutive years, all earned points shall be lost.

(3) If an applicant obtains either a firearm or archery permit, all earned points shall be lost.

(4) If the number of applicants with the most preference points exceeds the number of permits for specified units or permit types, then a drawing shall be held to determine the successful applicants.

(d) Elk permit applications. An individual receiving a limited-quota elk permit shall not be eligible to apply for or receive an elk permit in subsequent seasons, with the following exceptions:

(1) An individual receiving an any-elk or a bull-only elk permit may apply for and receive an antlerless-only elk permit in subsequent seasons.

(2) An individual receiving a limited-quota, antlerless-only elk hunting permit shall not be eligible to apply for or receive a limited-quota, antlerless-only elk permit for a five-year period thereafter. Subject to subsection (d), however, this individual may apply for and receive an any-elk or bull-only elk permit without a waiting period.

(e) Turkey permit applications. When awarding turkey permits in units having a limited number of permits, the first priority shall be given to those individuals who did not receive a permit in a limited turkey unit during the previous year. All other applicants shall be given equal priority. (Authorized by K.S.A. 32-807 and K.S.A. 32-937, as amended by L. 2002, ch. 96, sec. 4; implementing K.S.A. 32-937, as amended by L. 2002, Chapter 96, sec. 4; effective Sept. 10, 1990; amended May 27, 1991; amended June 1, 2001; amended April 18, 2003.)

Article 17.—WILDLIFE, COMMERCIAL USES AUTHORIZED

115-17-6. Commercial mussel fishing license; mussel salvage permits; license or permit application and requirements, authority, reports, general provisions, and license or permit revocation. (a) A commercial mussel fishing license shall be required for commercial mussel fishing purposes. If a mussel salvage order has been issued by the secretary through public notice or posting the area open to mussel salvage, a mussel salvage permit shall be required for mussel salvage purposes.

(b) Any person may apply to the secretary for a commercial mussel fishing license or a mussel salvage permit. The application shall be submitted on forms provided by the department, and each applicant shall provide the following information, except that no commercial license shall be issued on and after January 1, 2003 through December 31, 2012:

- (1) The name of the applicant;
- (2) the address and telephone number of the applicant;
- (3) the business locations and telephone numbers of the applicant;
- (4) the location for mussel storage and processing; and
- (5) other information as required by the secretary.

(c) Each mussel fishing licensee shall maintain a current record of activity and shall submit quarterly reports to the department on forms provided by the department. The reports shall be submitted not later than 15 days following the end of the quarter for which the reports are prepared. A license shall not be renewed until all reports due have been received by the department. Each mussel salvage permittee shall maintain a current record of activity for the duration of the permit and shall submit a report to the department on forms provided by the department. The report shall be submitted not later than 15 days following the expiration of the permit.

(d) The records and reports shall include the following information:

- (1) The name of the licensee or permittee;
- (2) the address and telephone number of the licensee or permittee;
- (3) the license or permit number of the licensee or permittee;
- (4) the total weight or total shell weight of each mussel species harvested;
- (5) the total weight or total shell weight of each mussel species sold, including the following information:

(A) A separate entry for each sale stating the total weight or total shell weight of each mussel species sold;

(continued)

- (B) the date of each sale;
 - (C) the name, address, and license number of the person to whom the mussels were sold; and
 - (D) the name of the state where harvested; and
 - (6) other information as required by the secretary.
- (e) Each commercial mussel fishing licensee or mussel salvage permittee shall sell mussels only to a person legally authorized to purchase mussels under subsection (f) of this regulation, or pursuant to K.A.R. 115-17-14.
- (f) Any person may purchase mussels from a commercial mussel fishing licensee or mussel salvage permittee if the mussels are not purchased for use as fish bait, are not purchased for resale, are not purchased for other commercial use, and are not sold.

(g) In addition to other penalties prescribed by law, a commercial mussel fishing or mussel salvage application, license, or permit may be revoked or denied issuance by the secretary if any of the following conditions is met:

- (1) The application is incomplete or contains false information.
- (2) The licensee or permittee fails to meet license or permit requirements or violates license or permit conditions.
- (3) The licensee or permittee violates any provision of law, rules, or regulations related to the commercial use of mussels.

(h) Each commercial mussel fishing license shall expire on December 31 of the year for which the license was issued. Each mussel salvage permit shall expire on the date written on the salvage permit.

(i) Each commercial mussel fishing license shall permit the possession of mussels harvested for commercial purposes by that licensee for no more than 48 hours after the close of the mussel season. A mussel salvage permit shall permit the possession of mussels harvested for commercial purposes by that permittee for no more than 48 hours after the expiration date written on the salvage permit.

(j) A licensee or permittee may submit a written request to the secretary to possess mussels for commercial purposes beyond the possession period specified above in subsection (i). Each request shall specify the number of each species of mussels possessed and the applicant's name, address, and commercial mussel fishing license or mussel salvage permit number. Authorization of possession beyond the possession period shall be issued in writing and shall include a date on which the authorization expires. Receipt of this authorization by the licensee or permittee shall allow the licensee's or permittee's sale of shells pursuant to subsection (e) of this regulation. Any mussel sale during the authorized time period shall be reported to the department within 48 hours of the sale by both the licensee or permittee and the purchaser. (Authorized by K.S.A. 32-807 and K.S.A. 32-941; implementing K.S.A. 32-807, K.S.A. 32-941, and K.S.A. 32-1002; effective Jan. 1, 1991; amended June 8, 1992; amended Nov. 30, 1998; amended Nov. 22, 2002; amended April 18, 2003.)

115-17-7. Commercial harvest of mussels; legal species, seasons, size restrictions, daily limits, and possession limits. (a) The following listed mussel species may be taken for commercial purposes, except that no

mussels may be commercially harvested on and after January 1, 2003 through December 31, 2012, unless a mussel salvage order has been issued by the secretary through public notice or posting the area open to mussel salvage:

- (1) Threeridge, *Amblyma plicata*;
- (2) monkeyface, *Quadrula metanevra*;
- (3) mapleleaf, *Quadrula quadrula*;
- (4) bleufer (purple shell), *Potamilus purpuratus*; and
- (5) Asian clam, *Corbicula fluminea*.

(b) The season for the commercial harvest of mussels shall be on and after April 1 through September 30. However, mussels shall not be commercially harvested on and after January 1, 2003 through December 31, 2012, except when a mussel salvage order has been issued by the secretary through public notice or posting the area open to mussel salvage.

(c) Harvesting requirements shall include the following:

(1) The minimum size of mussels shall be measured by passing the mussel shell through a circular measuring device with the appropriate inside diameter.

(2) Measurement shall occur immediately upon removal of the mussel from the water.

(3) If the mussel passes through the appropriate circular measuring device from any angle or direction, the mussel shall not be deemed to meet the minimum size requirement and shall be immediately returned to the water.

(4) The minimum shell size for mussel species shall be the following:

- (A) Threeridge: 3-inch diameter;
- (B) monkeyface: 2¾ inch diameter;
- (C) mapleleaf and bleufer: 3-inch diameter; and
- (D) Asian clam: no minimum size.

(d) There shall be no maximum daily or possession limits for mussels. (Authorized by K.S.A. 32-807 and K.S.A. 32-941; implementing K.S.A. 32-807, K.S.A. 32-941, and K.S.A. 32-1002; effective Jan. 1, 1991; amended June 8, 1992; amended Nov. 22, 2002; amended April 18, 2003.)

115-17-8. Commercial harvest of mussels; legal equipment, taking methods, and general provisions. (a) Legal equipment and taking methods permitted for commercial harvest of mussels shall be the following:

- (1) By hand; and
 - (2) by other methods as approved by the department.
- (b) (1) Boats with or without mechanical propulsion methods may be used.
- (2) Depth-recording or fish-locating devices may be used.

(3) Underwater breathing equipment may be used while taking mussels, if a diver's flag is prominently displayed while using the underwater breathing equipment.

(4) Holding bags, holding baskets, and holding cages may be used if the name and permit number of the permittee is attached to each such bag, basket, and cage.

(c) No mussels may be commercially harvested on and after January 1, 2003 through December 31, 2012, except when a mussel salvage order has been issued by the secretary through public notice or posting the area open to mussel salvage. (Authorized by K.S.A. 32-807 and K.S.A. 32-941; implementing K.S.A. 32-807, K.S.A. 32-941, and

K.S.A. 32-1002; effective Jan. 1, 1991; amended Nov. 22, 2002; amended April 18, 2003.)

115-17-9. Commercial mussel fishing; open areas. Waters of the state open for commercial mussel fishing shall be the following, except that all waters of the state shall be closed on and after January 1, 2003 through December 31, 2012, unless a mussel salvage order has been issued by the secretary through public notice or posting the area open to mussel salvage:

- (a) Federal reservoirs;
- (b) impoundments operated by other governmental entities, if authorized by the governmental entity;
- (c) Fall River from below Fall River Dam to its junction with the Verdigris River, except for the stretch of the Fall River from the county road ford located 1.2 miles east of state highway K-96, 3.2 miles south of Fredonia, Kansas, downstream to the Dun Dam located 2.5 miles west and 2.25 miles north of Neodesha, Kansas, which is a total of 9.89 stream miles including 3.27 impounded miles;
- (d) Verdigris River from below Toronto Dam to the state line, except for the stretch of the Verdigris River from the Whitehair bridge located 2.5 miles east of federal highway US-75 on the Wilson-Montgomery county line road, downstream to the Montgomery county road bridge located 1.47 miles east of Sycamore, Kansas, which is a total of 6.66 stream miles; and
- (e) Neosho River from below John Redmond Dam to the state line, except for the stretch of the Neosho River from the Neosho Falls dam, at Neosho Falls, Kansas, downstream to the mouth of Rock Creek in the NW 1/4, NW 1/4, Section 11, T24S, R17E, Allen County, Kansas, which is a total of 3.35 stream miles; and
- (f) Elk River. (Authorized by K.S.A. 32-807 and K.S.A. 32-941; implementing K.S.A. 32-807, K.S.A. 32-941 and K.S.A. 32-1002; effective Jan. 1, 1991; amended June 8, 1992; amended Nov. 22, 2002; amended April 18, 2003.)

Article 18.—SPECIAL PERMITS

115-18-10. Importation and possession of certain wildlife; prohibition, permit requirement, and restrictions. (a) The importation, possession, or release in the state of Kansas of the following live wildlife species shall be prohibited, except as authorized by terms of a wildlife importation permit issued by the secretary:

- (1) Walking catfish (*Clarias batrachus*);
- (2) silver carp (*Hypophthalmichthys molitrix*);
- (3) bighead carp (*Aristichthys nobilis*);
- (4) black carp (*Mylopharyngodon piceus*);
- (5) snakehead fish (All members of the family Channidae);
- (6) monk parakeet (*Myiopsitta monachus*); and
- (7) Asian raccoon dog (*Nyctereutes procyonoides*).

(b) Any live member of a wildlife species listed in subsection (a) and possessed before the following dates may be retained in possession, in closed confinement, by making application to the secretary that provides information detailing the circumstances, including the location, by which the animal came into the applicant's possession:

- (1) February 1, 1978, for fish and bird species other than black carp and snakehead fish;
- (2) February 1, 1986, for mammal species;

- (3) October 1, 2000, for black carp; and
- (4) May 1, 2003 for snakehead fish.

The manner in which the animal is to be used shall be identified in the application.

(c) Wildlife importation permits for the importation or possession of live members of the wildlife species listed in subsection (a) may be issued by the secretary for experimental, scientific, display, or other purposes subject to any conditions and restrictions contained or referenced in a wildlife importation permit.

(d) Each individual desiring to import or possess live members of the wildlife species listed in subsection (a) shall apply to the secretary for a wildlife importation permit. The application shall be submitted on forms provided by the department and shall contain the following information:

- (1) The name, address, and telephone number of applicant;
- (2) the wildlife species to be imported or possessed and the number of wildlife involved;
- (3) the purpose or purposes for importation or possession;
- (4) a description of facilities for holding and using the wildlife species;
- (5) a description of plans to prevent release of the wildlife species; and
- (6) other information as requested by the secretary.

(e) Each wildlife importation permit, once issued, shall be valid during the time period specified on the permit.

(f) In addition to other penalties prescribed by law, any wildlife importation permit may be refused issuance or revoked by the secretary if any of the following conditions is met:

- (1) The application is incomplete or contains false information.
- (2) Issuance of a permit would not be in the best interest of the public or of the natural resources of Kansas.
- (3) The permittee fails to meet permit requirements or violates permit conditions. (Authorized by K.S.A. 32-807 and K.S.A. 32-956; implementing K.S.A. 32-956; effective Dec. 27, 1993; amended Sept. 22, 2000; amended April 18, 2003.)

111-4-1953. "Bonus Crossword" instant ticket lottery game number 249. (a) The Kansas lottery shall conduct an instant winner lottery game entitled "Bonus Crossword" commencing on or after December 16, 2002.

The rules for this game are contained in K.A.R. 111-3-1 et seq. and 111-4-1953.

(b) The "play symbols" for this game are as follows: A - B - C - D - E - F - G - H - I - J - K - L - M - N - O - P - Q - R - S - T - U - V - W - X - Y - Z. There are no "play symbol captions" in this game.

(c) For this game, a play symbol shall appear in each of 18 play spots within the "YOUR NUMBERS" play area, in each of two play spots within the "BONUS" play area, and a variable number of times within the crossword puzzle grid.

(d) The ticket numbers in each book of tickets in this game shall start with 000 and end with 149.

(e) The three letters comprising the retailer validation codes used in this game shall appear in three of eight varying locations among the play symbols. The retailer validation codes for this game and their meanings are as follows:

(f) The price of instant tickets sold by a retailer for this game shall be \$2.00 each.

(g) "Bonus Crossword" consists of three play areas. In the upper part of the ticket there is a crossword puzzle grid that contains 11 spaces (height) by 11 spaces (width) covered by transparent latex. In the "YOUR LETTERS" play area, located in the lower part of the ticket, there are 18 letters located under opaque latex. To the right of the "YOUR LETTERS" play area is the "BONUS" play area in which there are two letters covered by opaque latex. Imaged around each of the 18 "YOUR LETTERS" and two "BONUS" letters there will be a four-sided box composed of solid lines. A player will remove the latex from the "YOUR LETTERS" and "BONUS" play areas one letter at a time, and then for each matching letter in the crossword puzzle grid scratch off the transparent latex. Each letter revealed in the "YOUR LETTERS" and "BONUS" play areas may be used an unlimited number of times in the crossword puzzle grid. If a player reveals at least three complete words in the crossword puzzle grid, the player wins the corresponding prize in the prize legend. The prize legend on the front of the ticket indicates prizes won for number of words revealed.

(h) To qualify as a complete word to win a prize in this game, the words revealed must meet the following requirements:

- (1) must contain at least three letters;
- (2) cannot be formed diagonally, run right to left or from bottom to top;
- (3) must appear in an unbroken horizontal or vertical string of letters in the "crossword" puzzle;
- (4) an unbroken string of letters cannot be interrupted by a black space and must contain every single letter square between two black spaces;
- (5) every single letter in the unbroken string must be revealed in "YOUR LETTERS," or "BONUS" areas and be included to form a word; and

(6) the three small letters outside the squares in the "YOUR LETTERS" area are for validation purposes and cannot be used to play "Bonus Crossword."

(i) Each ticket in this game may win up to one time. Only the highest prize won on each ticket will be awarded.

SENATE BILL No. 175

AN ACT concerning the state general fund; relating to estimates of revenues; amending K.S.A. 75-6701 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 75-6701 is hereby amended to read as follows: 75-6701. (a) Except as provided in subsection (d), on or before each December 4 and on or before each April 4, the director of the budget and the director of the legislative research department shall prepare a joint estimate of revenue to the state general fund for the current fiscal year and the ensuing fiscal year.

(b) If prior to final adjournment of any regular session of the legislature any law is enacted providing for additional or less revenues to be deposited in the state treasury to the credit of the state general fund, the director of the budget and the director of the legislative research department shall prepare a joint estimate of such revenues.

(c) In the event of a disagreement or failure to agree upon a joint estimate of revenue pursuant to subsection (a) or (b), the legislature shall utilize the estimates of the director of the legislative research department and the governor shall utilize the estimates of the director of the budget.

(d) During fiscal year 2003, the director of the budget and the director of the legislative research department shall prepare the joint estimate

of revenue to the state general fund for the current fiscal year and the ensuing fiscal year on or before April 22 in lieu of on or before April 4.

Sec. 2. K.S.A. 75-6701 is hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the Kansas register.

SENATE BILL No. 130

AN ACT relating to apportioned registration of fleet vehicles; amending K.S.A. 8-1,100 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

New Section 1. A converter gear may be registered under the provisions of K.S.A. 8-1,100 through 8-1,123, and amendments thereto, provided that the data required for registration is submitted electronically. The division shall assign a unique number to each converter gear and such number shall be durably marked on the converter gear as prescribed by the division. An annual fee of \$1 shall be paid for each registration.

Sec. 2. K.S.A. 8-1,100 is hereby amended to read as follows: 8-1,100. As used in this act, the following words and phrases shall have the meanings respectively ascribed to them herein: (a) The words "vehicle," "motor vehicle," "truck," "truck tractor," "trailer," "semitrailer," "pole trailer," "specially constructed vehicle" and "passenger vehicle" shall have the meanings respectively ascribed to them by K.S.A. 8-126, and amendments thereto;

(b) "division" means the division of vehicles of the department of revenue;

(c) "director" means the director of vehicles of the division of vehicles within the department of revenue;

(d) "commercial vehicle" means any motor vehicle, other than a passenger vehicle, and any trailer, semitrailer or pole trailer drawn by such motor vehicle, which vehicle is designed, used and maintained for the transportation of persons or property for hire, compensation, profit, or in the furtherance of a commercial enterprise;

(e) "fleet" means one or more commercial vehicles, at least one of which is a motor vehicle;

(f) "jurisdiction" means the states and territories of the United States, the District of Columbia, the provinces of Canada, the states and territories of the Federal District of Mexico, and the states, provinces and territories of any foreign country;

(g) "person" means an individual, firm, partnership, association, corporation, estate or trust;

(h) "owner" means:

(1) Any person who is lawfully entitled to possession of a commercial vehicle and who has the right to control the operation of such vehicle; and in the event more than one person has the right to possession or control, the person in whose behalf such vehicle is being operated at a particular time shall be deemed the owner at that time;

(2) in the event a commercial vehicle is the subject of a lease without a driver, the lessor shall be deemed the owner;

(3) in the event a commercial vehicle is the subject of a lease with a driver, the lessee and operator of such vehicle, and not the holder of the legal title or the lessor shall be deemed the owner;

(i) "preceding year" means a period of 12 consecutive months authorized by any bilateral or multijurisdictional agreement lawfully entered into by the director of vehicles, which 12 consecutive months shall end on a date of the year immediately preceding the commencement of the registration or license year for which apportioned registration is sought. In the absence of an agreement, such 12 consecutive months shall coincide with the definition for preceding year as provided by any multijurisdictional agreement to which this state is a member jurisdiction and such multijurisdictional agreement has the greater number of member jurisdictions;

(j) "based, base point and base jurisdiction" means the jurisdiction where an owner has an established place of business where operational records of the owner's fleet are maintained or can be made available, and where mileage is accrued by such fleet, and the vehicles of such fleet are most frequently dispatched, garaged, serviced, maintained, operated or otherwise controlled;

(k) "place of business" means the place or location where an owner has a terminal, warehouse, office, garage or some permanent bona fide

address at which one or more employees report and perform regular and continuing service for the owner;

(l) "base plate" means a registration or license plate issued by this state to a commercial vehicle based in and registered on an apportioned basis in this state;

(m) "total fleet miles" means the total number of miles operated during the preceding year in this state and in each and all other jurisdictions by the motor vehicles of a fleet, which motor vehicles were registered on an apportioned basis in this state during such preceding year by the owner operating such motor vehicles such total number of miles. Total fleet miles shall include miles operated upon a toll road;

(n) "in-state miles" means the total number of miles operated in this state during the preceding year by motor vehicles of a fleet which were registered on an apportioned basis in this state during such preceding year by the owner operating such total number of miles in this state. In the case of a fleet based in this state, in-state miles operated in jurisdictions other than Kansas shall be considered as Kansas in-state miles when such jurisdictions, by virtue of law or an agreement made with this state extends interstate reciprocity to the vehicles of such fleet; and

(o) "utility trailer" means any trailer of a rental fleet of 250 or more trailers, each having an empty weight of 2,000 pounds or less and a gross weight of not more than 8,000 pounds; and

(p) "converter gear" means an auxiliary axle assembly having a fifth wheel used for the purpose of converting a semi-trailer to a full trailer. The axle assembly can be used to haul multiple trailers behind a single power unit, also referred to as dollies or bogie.

Sec. 3. K.S.A. 8-1,100 is hereby repealed.

Sec. 4. This act shall take effect and be in force from and after its publication in the Kansas register.

SENATE BILL No. 17

AN ACT concerning district courts; relating to clerks and nonjudicial personnel; amending K.S.A. 2002 Supp. 20-343 and 20-345 and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 2002 Supp. 20-343 is hereby amended to read as follows: 20-343. The chief judge, with the approval of a majority of the other district judges of the each judicial district, shall appoint a clerk of the district court in each county within such judicial district. The chief judge, with the approval of a majority of the other district judges of the judicial district, shall designate one of such clerks as the chief clerk of the district court of such judicial district, except that a chief clerk is not required to be designated in a judicial district which is authorized to have a court administrator pursuant to the personnel plan of the supreme court. The clerks of the district court and deputies, assistants and other clerical personnel shall have such qualifications as are prescribed for the offices by statute, rule of the district court and rule of the supreme court. Such clerks, deputies, assistants and other personnel shall have such powers, duties and functions as are prescribed by law, prescribed by rules of the supreme court or assigned by the chief judge.

Sec. 2. K.S.A. 2002 Supp. 20-345 is hereby amended to read as follows: 20-345. Within staffing limits prescribed by the supreme court and appropriations therefor, the chief judge of each judicial district, with the approval of a majority of the other district judges of such judicial district, shall appoint such bailiffs, court reporters, secretaries, court services officers and other clerical and nonjudicial personnel as necessary to perform the judicial and administrative functions of the district court. Persons appointed pursuant to this section shall have qualifications prescribed by law or rule of the supreme court. Except as otherwise provided by law, such persons shall receive compensation prescribed by the judicial personnel classification system. Such persons shall perform the duties and functions prescribed by law, designated in the personnel classification system or assigned by the chief judge, subject to rule of the supreme court. Personnel whose salary is payable by counties shall receive compensation in the amounts provided in the district court budget approved by the board of county commissioners. Whenever any person is employed or assigned to work under direct supervision of any judge or in a division of court in which a judge presides, the employment or assignment of the person shall be subject to the approval of that judge.

Sec. 3. K.S.A. 2002 Supp. 20-343 and 20-345 are hereby repealed.

Sec. 4. This act shall take effect and be in force from and after and its publication in the Kansas register.


