Grant funds are available from the Federal State Access and Visitation Program pursuant to P.L. 104-193 for fiscal year 2005. The purpose of this grant program is to increase, enhance, expand or initiate grant projects that provide services and assistance to children and families in need of supervised exchange or visitation. It is the intention of this grant program to provide as wide a range of coverage as possible to the citizens of the state. Assistance may encompass a wide range of support services. Specific services to be provided and the specific target group should reflect local needs and priorities. Activities may include: on-site supervision, exchange monitoring, therapeutic supervision, recording observations of visits, referrals to other services and educational parenting classes. Such indicators as number of staff assigned, the type of services provided, number of children and families served, and the number of personnel and others trained may be used to evaluate the efficiency and impact of the grant project.

**Economic Impact Summary:** Due to laws currently in place there is no significant economic impact to state agencies, private citizens or consumers.

**K.A.R. 63-5-1. Definition of unprofessional or dishonorable conduct.** This regulation is being amended to expand current definitions.

**Economic Impact Summary:** There is no significant economic impact to state agencies, private citizens or consumers.

**K.A.R. 63-6-1. Continuing education requirements.** This regulation is being amended for purposes of clarification.

Economic Impact Summary: There is no significant economic impact to state agencies, private citizens or consumers.

A public hearing will be conducted at 1:30 p.m. Friday, October 8, in the main conference room, Kansas Department of Commerce, first floor, Suite 100, Curtis State Office Building, 1000 S.W. Jackson, Topeka, to consider the revocation of existing rules and regulations of the department regulating certified capital formation companies.

This 60-day notice of the public hearing shall constitute a public comment period for receiving written public comments on the revocation of these regulations. All interested parties may submit written comments before the hearing to John Moore, Secretary of Commerce, Suite 100, Curtis State Office Building, 1000 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the revocation of the existing regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the existing regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Bob North at (785) 296-3004. Handicapped parking is not available around the Curtis Office Building; however, all persons in a vehicle with a handicapped license plate may park in any metered space around the building, and there is no charge for parking. The curbs and all the entrances on Jackson, 10th Street and Kansas Avenue to the Curtis Office Building are accessible to individuals with disabilities.

Copies of the regulations and their economic impact statements may be obtained from the general counsel, Department of Commerce, at the address and phone number above. A summary of the existing regulations and their economic impact follows:

**K.A.R. 110-8-1. Eligibility.** This regulation defines which entities may desire to become authorized capital formation companies, and that such persons apply to the Secretary of Commerce. Such entities must invest at least half of their cash in qualified Kansas businesses for the investors to realize a tax credit. Investors in such companies with a Kansas tax liability can receive credits equal to 50 percent of their investment.

**K.A.R. 110-8-2. Application for authorization.** The application for authorization requires submission of certain documents and information about the company. Those documents and the required information are listed in this regulation. An application fee is required pursuant to statute. The secretary has 60 days to authorize or deny the application, and the regulation describes what happens if the application is denied. By law, companies have 365 days following notification that the applicant is an authorized company to raise its venture capital.

**K.A.R. 110-8-3. Presentations to certified capital investors.** Each authorized capital formation company must prepare written offerings for potential investors. This regulation describes what minimum information must be in the offering. Investors in the authorized CFC also must provide certain information for the company to determine if the investor is eligible for tax credits, and the company must retain such information. The term "primary residence" is defined.

**K.A.R. 110-8-4. Certification of capital formation companies.** No certified CFC can take investments exceeding the aggregate tax credit limit by law. CFCs investing in nonmetropolitan areas must meet certain maximum certified capital investment amounts negotiated between the CFC and the Secretary of Commerce. Alternative means of authorizing CFCs is set forth if the CFCs fail to reach their maximum certified capital investments. "Other capital contribution" is defined.

**K.A.R. 110-8-5. Investment by certified CFCs in qualified Kansas businesses.** CFCs may invest proceeds from prior investments in qualified Kansas businesses, and such proceeds are credited toward an individual investor's accrual of tax credits.

**K.A.R. 110-8-6. Accrual and payment of tax credits.** Certified CFCs that make a capital commitment to a qualified Kansas business allow each certified investor in the CFC to accrue a tax credit proportional to the investor's share of the cumulative certified capital raised by the CFC. Certified investors, as defined, apply for tax credits according to this regulation.

**K.A.R. 110-8-8. Annual report and recertification.** On or before March 1 of each year, certified CFCs must submit annual reports to the secretary covering statutorily required information and activities during the previous year's operation ending December 31.

**K.A.R. 110-8-9. Reporting material changes in operation.** Certified CFCs must report material changes in operation of their company within 30 days of the change. The phrase "material change of operation" is defined. False information provided in such reports may result in revocation of certification.

**K.A.R. 110-8-10. Decertification.** Certified CFCs may be decertified pursuant to K.S.A. 74-8226. Companies desiring to be eligible for recertification must continue to provide annual reports and make certain payments to the state treasurer, as required by law, but need not pay annual renewal or recertification fees.

**K.A.R. 110-8-11. Public records and confidentiality.** The Act makes certain documents of the companies submitted to the secretary a trade secret and exempt from disclosure under state open records laws. This regulation utilizes Kansas case law on what constitutes a trade secret and describes how the secretary will determine whether information qualifies as a trade secret.

These regulations help establish the tax credit program under the Capital Formation Company Act. There are no anticipated costs to state agencies or employees because of this revocation.
