The Kansas Water Authority will meet at 9 a.m. Thursday, January 27, at the Ramada Inn, 420 S.E. 6th St., Topeka. The Kansas Water Authority, a 24-member group representing the state's diverse water interests, provides advice to the Governor and Kansas Legislature on water resource issues.

The Authority will consider whether to direct the Kansas Water Office to initiate studies on the role of conservation in managing Kansas' water resources and the causes and effects of streambed degradation on the Kansas River.

Updates will be provided on two background papers developed by the Kansas Water Office. One of them deals with economic development opportunities at the state's reservoirs. The other deals with public involvement in the development and implementation of the state's water resource plans.

Operational business includes a review and decision on the criteria to be used in selecting a small public water supply/recreational lake to demonstrate the methods and benefits of restoration. Additional information, if available, will be provided on the Attorney General's opinion on Cedar Bluff Operations, the proposed state purchase of the Circle K Ranch in Edwards County, and the Water Plan Projects Initiative.

Other topics of discussion will include a proposed study on the water conservation effects of improvements in irrigation efficiency, the Irrigation Transition Assistance Program, and a pending application for a nation-wide EPA competitive grant to implement wetland protection and restoration programs. Legislative interim committee recommendations on Cedar Bluff Reservoir and the Irrigation Transition Assistance Program also will be presented.

#### Notice of Hearing on Proposed Administrative Regulations

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Thursday, March 24, at the Beloit Municipal Building, 119 Hersey, Beloit, to consider the approval and adoption of proposed administrative regulations of the Kansas Department of Wildlife and Parks.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 1:30 p.m. March 24 at the location listed above. The meeting will recess at 5:30 p.m., then resume at 7 p.m. at the same location for the regulatory hearing. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. March 25 at the same location.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Sheila Kemmis, commission secretary, at (620) 672-5911. Persons with a hearing impairment may call the Kansas Commission for the Deaf and Hard Hearing at 1-800-432-0698 to request special accommodations.

This 60-day notice period prior to the hearing constitutes a public comment period for the purpose of receiving written public comments on the proposed administrative regulations. All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, 1020 S. Kansas Ave., Suite 200, Topeka, 66612, or by e-mail to sheilak@wp.state.ks.us. All interested parties

will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The regulations that will be heard during the regulatory hearing portion of the meeting are as follows:

**K.A.R. 115-4-2.** This permanent regulation sets general requirements for wild turkey and big game permits. The proposed amendments include removing wild turkey from big game language and requiring the beard of a wild turkey to remain attached in transport unless taken with an either-sex permit.

Economic Impact Summary: The proposed amendments are not anticipated to have any appreciable economic impact on the department, other agencies or the public.

**K.A.R. 115-4-4.** This permanent regulation provides for legal equipment and taking methods for big game. Proposed amendments include removing provisions dealing with wild turkeys from the regulation.

Economic Impact Summary: The proposed amendments are not anticipated to have any appreciable economic impact on the department, other agencies or the public.

**K.A.R.** 115-4-4a. This new permanent regulation sets the legal equipment and taking methods for wild turkeys.

Economic Impact Summary: The proposed regulation is not anticipated to have any appreciable economic impact on the department, other agencies or the public.

**K.A.R. 115-4-13.** This permanent regulation designates the types of deer permits available. The proposed amendments would add one class of permit, the archery white-tailed deer permit, to conform with current practices.

Economic Impact Summary: The proposed regulation is not anticipated to have any appreciable economic impact on the department, other agencies or the public.

**K.A.R.** 115-25-5. This exempt regulation sets the fall wild turkey season, bag limits and permits available. Changes from previous seasons include lengthening the fall season by one month and having the season run concurrently with the firearms deer season.

Economic Impact Summary: The proposed regulation is not anticipated to have any appreciable economic impact on the department, other agencies or the public.

A summary of the proposed regulations, their environmental benefit and the estimated economic impact follows:

1500 W. 7th St., Chanute

K.A.R. 28-16-56c and 56d. Sewage permit fees; definitions and schedules. The proposed amendments alphabetize the currently defined terms; replace animal unit and confined feeding facility definitions with statutory definitions; modify the terms "industrial wastewater treatment facility," and "storm water discharge"; and define the new term, "private truck-washing facility for animal wastes." The amendments also revise the permit fee schedule by adding specific types of facilities and associated fees defined by statute. Within the context of the regulatory impact statement the proposed amendments will not have a direct impact on public health or the environment as they are primarily administrative in nature. The proposed amendments do not subject the affected parties, the general public or any unit of government to additional direct costs.

K.A.R. 28-18-1 and 28-18a-1. Definitions. The proposed amendments update references to other existing regulations and define new terms that have been introduced as part of the proposed regulations and amendments. The revisions include definitions for the following terms: "closure plan," "equus beds," "groundwater," "impermeable synthetic membrane liner," "public livestock market," "sensitive groundwater areas" and "whole pond seepage test." Within the context of the regulatory impact statement the proposed amendments will not have a direct impact on public health or the environment as they are primarily administrative in nature. The proposed amendments do not subject the affected parties, the general public or any unit of government to additional direct costs.

K.A.R. 28-18-2 and 28-18a-2. Registration and application requirements. The proposed amendments will clarify which public livestock markets are required to apply for a permit. The proposed amendments are a result of recent statutory changes (L. 2003, ch.18, sec. 2). Within the context of the regulatory impact statement the proposed amendments will not have a direct impact on public health or the environment as they are primarily administrative in nature. The proposed amendments do not subject the affected parties, the general public or any unit of government to additional direct costs.

K.A.R. 28-18-4 and 28-18a-4. Filing of applications and payment of fees. The proposed amendments reflect proposed modifications to other regulations addressing closure of waste lagoons located over the Equus Beds for facilities with 1,000 or more animal units. Additionally, the contents of permit applications for confined feeding facilities have been modified to address current program requirements. Within the context of the regulatory impact statement the proposed amendments will not have a direct impact on public health or the environment as they are primarily administrative in nature. The proposed amendments do not subject the affected parties, the general public or any unit of government to additional direct costs.

K.A.R. 28-18-8 and 28-18a-8. Permit; terms and conditions. The proposed amendments remove requirements having the same purpose or effect as requirements found in other sections of the existing regulations. Subsection (e) is eliminated since reporting of changes or modifications to individual farming plans is unnecessary. Agronomic use of wastes is required by other current regulations. Within the context of the regulatory impact statement the proposed amendments will not have a direct impact on public health or the environment as they are primarily administrative in nature. The proposed amendments do not subject the affected parties, the general public or any unit of government to additional direct costs. The affected parties may realize some cost savings due to the elimination of the reporting requirement. The estimated cost savings are less than \$1 per facility.

K.A.R. 28-18-9 and 29-18a-9. Certification; terms and conditions. The proposed amendments address the terms and conditions to be included in each certification or permit. Modification has been made to clarify that the issuance of a permit is of itself not an enforcement action. Within the context of the regulatory impact statement the proposed amendments will not have a direct impact on public health or the environment as they are primarily administrative in nature. The proposed amendments do not subject the affected parties, the general public or any unit of government to additional direct costs.

K.A.R. 28-18-11 and 28-18a-11. Confined feeding facilities; federal requirements. The proposed amendments adopt, by reference, the recently revised Environmental Protection Agency concentrated animal feeding operation requirements that became effective nationwide April 12, 2003. The final EPA regulations, proposed to be adopted by KDHE, are revisions and updates to the previous 1974 EPA requirements that KDHE had adopted and are currently implemented. The incorporation of the

(continued)

revised EPA rules will enable the state to continue to manage the federal water pollution control permitting program in Kansas rather than the federal government. The primary revision to the 1974 EPA requirements address management and utilization of the manure from concentrated animal feeding operations. The new measures will provide an environmental benefit by requiring the facility operator to plan, in advance, for the agronomic use of animal wastes. Along with requiring the operator to implement, the planned management practices are designed to (1) minimize pollutant discharges from confined animal feeding facilities and (2) minimize contaminated runoff into Kansas surface waters from fields where the animal waste is utilized.

The proposed amendments will increase capital and annual operating costs for the affected parties. When revising the 1974 regulations, the EPA worked closely and with the support of the United States Department of Agriculture. The Environmental Quality Incentives Program (EQIP) of the 2002 Farm Bill substantially increased the availability of funds to all confined animal feeding facilities, regardless of size, to assist in them in complying with the revised EPA regulations. Capital and annual costs will vary considerably depending upon the size of confined feeding facility, local climate, current waste management capabilities, and availability of suitable crop, pasture and range land upon which to manage the collected wastes. Swine facilities are not expected to be impacted due to Kansas legislation created in 1998 requiring swine facilities to conduct nutrient utilization planning. KDHE estimates of the capital costs for nonswine facilities (beef, dairy, poultry, etc.) to **develop** sitespecific, detailed plans to manage and utilize the facility wastes will range from less than \$1,000 to more than \$40,000 depending on the range of variables previously described. Estimates of capital costs to make any necessary improvements to the land application system to distribute the wastes range from \$500 or less to several hundred thousand dollars or more, again depending on site-specific variables previously described. Estimates of the annual costs for nonswine facilities (beef, dairy, poultry, etc.) to **implement** their nutrient management plan range from \$325 to \$20,000 or more, with the cost highly dependent upon the site-specific variables previously described. The proposed amendments do not subject the general public or any unit of government to additional direct costs.

K.A.R. 28-18-12 and 28-18a-12. Design and construction of animal waste and swine waste management and swine pollution control systems. The proposed amendments will: (1) correct references to other existing regulations; (2) clarify that only those changes made after KDHE approval that affect the scope, boundaries, collection, handling, treatment, utilization or disposal of the animal waste require the facility to amend the construction plans and seek approval of the changes by the department prior to implementing the change; (3) incorporate by reference minimum design standards that have been rewritten to distinguish between requirements and guidance; and (4) allow KDHE to focus its review of post construction information to those facilities with site-specific concerns or risks. Within the context of the regula-

tory impact statement the proposed amendments will not have a direct impact on public health or the environment. The proposed amendments do not subject the affected parties, the general public or any unit of government to additional direct costs, although the amendments are expected to create some efficiencies for the affected parties and KDHE by clarifying when KDHE approval is needed and providing flexibility in evaluating construction activities.

K.A.R. 28-18-13 and 28-18a-19. Operation of animal waste and swine waste management and swine pollution control systems. The proposed amendments address protection of groundwater resources in sensitive groundwater areas. The amendments affect facilities with less than 1,000 animal units. Similar requirements for facilities with more than 1,000 animal units are contained in the revised EPA regulations proposed for adoption in K.A.R. 28-18-11 and 28-18a-11. It is proposed the facilities with less than 1,000 animal units, with land application areas in sensitive groundwater areas, sample and test the soil of those areas, which have been utilized for waste management, at least once every five years. These fields, in sensitive groundwater areas, present an increased probability of affecting groundwater if animal wastes are applied at rates that exceed the ability of the crop to utilize the nutrients. The proposed modifications will provide an environmental benefit. Information on soil nutrient status can be monitored to determine if sub-soil nitrogen levels are increasing. If an upward trend is noted, then it will be apparent nitrates are being leached into the deeper soil layers and possibly into the groundwater, thereby contaminating a source of drinking water. The information also can be monitored for elevated levels of phosphorus that can be eroded or carried into streams and lakes creating eutrophication of the water bodies and leading to fish kills and taste and odor problems for public water supplies. There are no projected capital costs to the affected parties for them to be able to conduct the soil sampling. The projected annualized cost for the affected facilities, those with fewer than 1,000 animal units that have applied manure to a field in a sensitive groundwater area, to collect the samples, have the samples analyzed, and to send KDHE a copy of the test results are projected to be \$5 to \$10 per year. The proposed amendments do not subject the general public or any unit of government to additional direct costs.

K.A.R. 28-18-14 and 28-18a-21. Inspections. The current regulations address the compliance of KDHE inspectors with the bio-security plans of those confined feeding facilities and swine facilities that implement a bio-security plan at their facility. The section has been amended to remove references to dates and deadlines that have passed. Within the context of the regulatory impact statement the proposed amendments will not have a direct impact on public health or the environment as they are primarily administrative in nature. The proposed amendments do not subject the affected parties, the general public or any unit of government to additional direct costs.

K.A.R. 28-18-16 and 28-18a-22. Animal waste-retention lagoon and swine facility closure requirements. K.A.R. 28-18-16 is newly proposed and is similar to the

currently effective K.A.R. 28-18a-22 that is specific to swine. K.A.R. 28-18a-22 requires the development and implementation of a closure plan for those swine facilities with 3,725 or more animal units. The proposed new regulation and the proposed amended regulation are similar to the current regulation for large swine facilities, but the requirement to develop a closure plan, to be implemented at such time the facility ceases operation, is proposed to be extended to Equus Bed confined animal feeding facilities with 1,000 or more animal units. Bringing the closure planning requirement to the forefront for these facilities will ensure the owner is aware of requirements to manage the wastes until they have all been removed and that the contents of the closure plan have been accepted by KDHE. The requirement for facilities located in this significant groundwater resource area to plan in advance for closure and then follow through when the facility ceases operation will reduce the risk of any remaining waste to be left unmanaged and concentrated in one small area and to subsequently cause nitrate contamination of the groundwater. Capital costs to develop a closure plan for Equus Bed confined animal feeding facilities with 1,000 or more animal units are estimated to range from \$480 to \$3,600 per facility and no projected annual costs. The proposed amendments do not subject the general public or any unit of government to additional direct costs.

K.A.R. 28-18-17 and 28-18a-33. Groundwater protection requirements for animal waste and swine wasteretention lagoons. The proposed new regulations will establish a siting requirement related to distance to groundwater and will establish a three-tiered approach to requirements for lining waste-retention lagoons. The tiers are based on the most commonly used terms to define groundwater systems in Kansas and the relative degree of vulnerability and use of each groundwater system.

The proposed regulations will require the finished floor of each new or expanded portion of waste-retention lagoons and swine waste-retention lagoons to be a minimum of 10 feet above groundwater. Additionally, the proposed regulations require the liner of new or expanded portion of waste-retention lagoons and swine waste-retention lagoons to be designed to minimize seepage to the greatest extent practicable and established site-specific seepage rates, based upon the specific groundwater system, which are not to be exceeded.

The proposed rules will have an environmental benefit by establishing requirements to reduce the level of seepage in proportion to the vulnerability and degree of use of the groundwater resource at the location of the wasteretention lagoons or swine waste-retention lagoons. The reduced levels of seepage will reduce the quantity of ammonium (in the environment, ammonium is readily converted to nitrate) moving into the soils surrounding the waste-retention lagoons. The reduced ammonium movement will limit the potential for its conversion into nitrate and thus reduce the risk of nitrate contamination of groundwater. Nitrate at relatively low levels is toxic to unborn children and infants and at slightly higher levels can cause toxicity problems for adults. The proposed amendments could create additional direct costs for the affected parties, but government units and the general

public should not incur additional direct costs. The additional direct costs to affected parties, if any, will be primarily dependent upon the availability of alternative locations (those that would meet requirements) for the facility and the willingness of the facility owner to consider alternative locations. Capital costs could range from \$0 to several hundred thousand dollars depending on the site selected by the owner and availability of alternative sites. Annual costs to the affected parties, if any, are estimated to range from \$0 to \$120,000. Again, the cost is highly dependent on the owner's site selection and the availability of alternative sites.

K.A.R. 28-18-18 and 28-18a-34. Groundwater monitoring for confined feeding facilities and swine facilities. The proposed new regulations address required components of a groundwater monitoring plan when site conditions or statutes require the confined feeding facility or swine facility to develop and implement a groundwater monitoring plan. The requirement for the plan to address certain issues does not in and of itself provide any environmental benefit. However, implementation of a groundwater monitoring plan, when required, will create an environmental benefit by reducing groundwater pollution since a monitoring system will allow for earlier detection and correction of groundwater pollution should it occur. The affected parties will incur additional capital and annual costs if required to develop and implement a groundwater monitoring plan; however, as previously noted, the facility owner can eliminate or largely control these costs through careful selection of a site for the facility. If a facility is required to develop and install groundwater monitoring, then the capital costs are projected to range from \$710 to \$12,910, depending upon the number of wells and their depth. Annual costs for implementing the groundwater monitoring plan (sampling and reporting) are estimated to range from \$100 to \$600. The proposed regulations do not subject the general public or any unit of government to additional direct costs.

K.A.R. 28-18a-26. Requirements for swine facility operator certification. This regulation currently implements the statutory requirement for swine facilities with 1,000 or more animal units to be operated by a certified swine facility operator. The proposed amendment removes references to dates and deadlines that have passed. Within the context of the regulatory impact statement the proposed amendments will not have a direct impact on public health or the environment as they are primarily administrative in nature. The proposed amendments do not subject the affected parties, the general public or any unit of government to additional direct costs.

K.A.R. 28-18a-32. Swine waste-retention lagoons in sensitive groundwater areas. This existing regulation addresses swine waste-retention lagoon liner requirements. This regulation is proposed to be revoked. The terms defined in this existing regulation have been incorporated into K.A.R. 28-18a-1, definitions. Swine waste-retention lagoon liner requirements have been more clearly delineated in K.A.R. 28-18a-33. Within the context of the regulatory impact statement this revocation will not have a direct impact on public health or the environment. The proposed revocation does not subject the affected particular.

All interested parties intending to provide oral comments will be given a reasonable opportunity to present their views of the proposed amended, new and revoked regulations during each hearing. In order to give each individual or entity an opportunity to present their views, it may be necessary for the hearing officer to request that each presenter limit any of their presentation to an appropriate time frame.

Because of the expected level of public participation at the hearings, KDHE recommends that individuals intending to present oral testimony at the hearings provide the hearing officer with a written copy of their comments and recommendations during the hearing. This will ensure KDHE receives each presenter's comments and recommendations in the event presentation times are limited.

All interested parties will be given a reasonable opportunity to present their views orally on these regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. A summary of the proposed regulations and their economic impact follows:

**K.A.R. 110-11-1. Definitions.** This regulation defines key terms in the regulations.

K.A.R. 110-11-2. Application process. This regulation provides the application process for cities and counties to apply to the Kansas Department of Commerce to designate downtown redevelopment areas, wherein rebate of real property tax increments collected from real property may apply to properties that have undergone approved improvements.

**K.A.R. 110-11-3. Progress reports.** This regulation provides for annual progress reports to be filed by cities and counties with the Kansas Department of Commerce.

**Economic Impact:** It is anticipated that at least one employee of the Department of Commerce will be required to review applications for compliance with applicable rules and capture annual statistics on downtown redevelopment so that the Legislature can review the impact of this act. The costs to the department are estimated to be between \$10,000 and \$20,000. The department does not anticipate the need to hire additional employees.

The new regulations will have a negligible impact upon local governments, as property tax rebates will be processed by local taxing authorities based upon incrementally assessed value on property improvements made by individuals and businesses, not total assessed value. Long-term economic impacts would be positive to the local government and businesses in the community, due to an anticipated increase in property tax revenue, after the 10-year rebate is expired, as well as an anticipated increase in sales tax revenue, as new or expanded businesses are in operation in formerly vacant properties. Local governments and businesses participating in this program will have normal recordkeeping costs and expenses, as well as salaries involved in the maintenance of records. The department cannot reliably estimate the costs required of each local government or business since that involves decisions made at their level.

There would be no negative impact on other entities or persons. To the extent the program allows local governments to make decisions on establishing redevelopment areas to utilize this program, it enhances the state's downtown economic development activities and attractiveness. This would have a positive impact on state and local tax revenues.

## Permanent Administrative Regulations

#### Article 6.—CONTINUING EDUCATION

- **117-6-3.** Education; obtaining course approval. (a) To request board approval of a course to meet any education requirement of the act or portion of it, for each course the sponsor shall perform the following:
- (1) Appoint a coordinator, who shall monitor the course and ensure compliance with the appropriate statutes and regulations;
- (2) submit all information, materials, and fees required by the board for course approval at least 30 days before the first scheduled class session, including the following:
- (A) A completed application for course registration on a form prescribed by the board;
  - (B) the procedure for maintaining attendance records;
- (C) the proposed dates and times of the course offering;
  - (D) the total amount of the attendance fee;
- (E) the total number of class sessions and the length of time per session;

- (F) the total number of hours in the course and the number of credit hours requested;
- (G) if approval of the course is requested according to K.A.R. 117-2-1, 117-3-1, or 117-4-1, the amount of time allotted for the required examination;
- (H) a course syllabus, including a detailed course outline and course objectives;
- (I) an instructor resume, demonstrating that the instructor meets the qualifications in relation to knowledge of the subject matter and ability to teach;
- (J) the methods of instruction or teaching techniques to be used in the course;
  - (K) a copy of any textbook or manual that will be used;
- (L) a copy of all handout materials that will be used;
- (M) the course approval fee prescribed by K.A.R. 117-7-1.
- (b) For continuing education purposes, each instructor shall demonstrate knowledge of the subject matter as indicated by either of the following:
- (1) A college degree in an academic area related to the course; or
- (2) at least three years of experience in a subject area directly related to the course.
- (c) For prelicensing education or qualifying education purposes, according to K.A.R. 117-2-1, 117-3-1, and 117-4-1, each instructor shall demonstrate knowledge of the subject matter as indicated by any of the following:
- (1) A current appraiser's license or certification pursuant to K.S.A. 58-4109(a)(1), (2), or (3), and amendments thereto;
- (2) a current appraiser's license or certification issued by another state;
- (3) a college degree in an academic area related to the course; or
- (4)(A) Evidence of completion of all the required courses specified in K.A.R. 117-2-1, 117-3-1, or 117-4-1 within the past five years; and
- (B) an appraisal log sheet that shows the equivalent of two years of appraisal experience within the past five calendar years in the subject area related to the course. One thousand hours shall constitute one year of appraisal experience.
- (d) For purposes of continuing education or prelicensing education on the "uniform standards of professional appraisal practice," the only courses that will be accepted by the board for either prelicensing or continuing education shall be the "national uniform standards of professional appraisal practice" and "national uniform standards of professional appraisal practice update" courses that meet any of the following conditions:
  - (1) Have been developed by the appraisal foundation;
- (2) have been approved by the board as being equivalent to these courses; or
- (3) have been approved by the appraisal foundation as being equivalent to these courses, if the requirements of subsections (a), (b), and (c) have been met.

Each instructor shall be certified by the appraiser qualifications board.

(e) For prelicensing education or qualifying education purposes, according to K.A.R. 117-2-1, 117-3-1, and 117-

- 4-1, the ability to teach effectively shall be demonstrated by one of the following:
- (1) Within the preceding two years, completing a board-approved program for instructors that is designed to develop the ability to communicate;
- (2) holding a current teaching certificate issued by any state department of education or an equivalent agency;
- (3) holding a four-year undergraduate degree in education; or
- (4) having experience teaching in schools, seminars, or in an equivalent setting.
  - (f) Each instructor shall perform the following:
- (1) Comply with all laws and regulations pertaining to appraiser continuing education;
- (2) provide students with the most current and accurate information;
- (3) maintain an atmosphere conducive to learning in a classroom; and
- (4) provide assistance to the students and respond to questions relating to course material.
- (g) Course approvals shall expire on December 31 of each year. By November 1 a notification that includes the necessary forms shall be sent by the board informing each sponsor that an application for renewal is necessary. The course renewal applications and necessary forms shall be received by the board before April 1, or the course approvals shall not be renewed. After notice and opportunity for a hearing, course approval or renewal of a course approval may be denied or revoked by the board under either of the following conditions:
- (1) The course sponsor procured or attempted to procure course approval by knowingly making a false statement, submitting false information, or refusing to provide complete information in response to a question in an application for course approval or renewal of course approval.
- (2) The course sponsor engages in any form of fraud or misrepresentation.
- (h) The sponsor shall not advertise a course as approved unless written approval has been granted by the board.
- (i) The sponsor shall conduct each course in a class-room or other facility that is adequate to comfortably accommodate the number of students enrolled.
- (j) Each sponsor shall maintain, for at least five years, accurate records relating to course offerings, instructors, and student attendance. If a sponsor ceases operations, the coordinator appointed under paragraph (a)(1) shall be responsible for maintaining the records or providing a custodian acceptable to the board.
- (k) Each sponsor shall provide each student with a certificate of completion within seven days of the date on which the student completes the course. The sponsor may require payment of course tuition as a condition for completing the course. #### Article 7.—FEES

- **117-7-1. Fees.** The following fees shall be submitted to the board. (a) For application for certification or licensure, the fee shall be \$50.
- (b) For original certification or licensure, the fee shall be \$250.
- (c) For renewal of a certificate or license, the fee shall be \$225.
- (d) For late renewal of a certificate or license, the fee shall be the amount specified in subsection (c) and an additional \$50.
- (e) Except as provided in subsection (h) of this regulation, for approval of a course of instruction to meet any portion of the education requirements of K.A.R. 117-2-1, 117-3-1, or 117-4-1, the fee shall be \$100.
- (f) Except as provided in subsection (h) of this regulation, for approval of a course of instruction to meet the continuing education requirements of K.A.R. 117-6-1, the fee shall be \$50.
- (g) Except as provided in subsection (h) of this regulation, for renewal of any course of instruction, the fee shall be \$25.
- (h) For approval or renewal of any course of instruction that is endorsed by the appraiser qualifications board, the fee shall be \$10. ## Article 8.—UNIFORM STANDARDS OF PROFESSIONAL APPRAISAL PRACTICE

- **117-8-1.** Uniform standards of professional appraisal practice. The 2005 edition of the "uniform standards of professional appraisal practice and advisory opinions," as promulgated by the appraisal standards board of the appraisal foundation, effective January 1, 2005, is hereby adopted by reference, with the following exceptions:
  - (a) Standards 6, 7, 8, 9, and 10; and
- (b) the advisory opinions, which are on pages 123 through 228. #### **Board of Technical Professions**

## Permanent Administrative Regulations

#### Article 6.—PROFESSIONAL PRACTICE

- **66-6-4. Professional conduct.** (a) For the purposes of this regulation, "licensee" shall mean an architect, a geologist, a landscape architect, a land surveyor, or a professional engineer licensed by the Kansas state board of technical professions.
- (b) If any licensee's judgment is overruled under circumstances in which the safety, health, or welfare of the public is endangered, the licensee shall inform the employer or client of the possible consequences, and the licensee shall notify the authority who issued the building permit or otherwise has jurisdiction.
- (c) The licensee shall not advertise to perform or undertake to perform any assignment involving a specific technical profession unless licensed and qualified by education and experience in that technical profession, as defined in K.S.A. 74-7003, and amendments thereto.
- (d) A licensee in any technical profession shall not affix a personal signature, seal, or both to any plan or document dealing with subject matter that is outside of the licensee's field of practice as defined by K.S.A. 74-7003, and amendments thereto. Additionally, as provided in K.S.A. 74-7023, and amendments thereto, a licensee in any technical profession shall not affix a personal signature, seal, or both to any plan or document of any individual licensed in a technical profession in another state, unless the licensee has completed a detailed review and evaluation of the documents and both individuals are licensed in the same field of practice.
- (e) If the competence of any licensee to perform an assignment in a specific technical field is at issue, the licensee may be required by the board to pass an appropriate examination.
- (f) In all professional reports, statements, and testimony, each licensee shall meet the following criteria:
  - (1) Be completely objective and truthful; and
  - (2) include all relevant and pertinent information.
- (g) When serving as an expert or technical witness before any court, commission, or other tribunal, each licensee shall express only opinions founded on the following:
  - (1) An adequate knowledge of the facts at issue;
- (2) a background of technical competence in the subject matter; and
- (3) an actual, good-faith belief in the accuracy and propriety of the licensee's testimony.
- (h) If a licensee issues any statements, criticisms, or arguments on public policy matters that are inspired or paid for by any interested party or parties, those comments shall be prefaced by and include disclosure of the following:
- (1) The identities of the party or parties on whose behalf the licensee is speaking; and
- (2) the existence of any pecuniary interest of the licensee.

- (i) Each licensee shall disclose all known or potential conflicts of interest to employers or clients by promptly informing them of any business association, interest, or any other circumstances that could influence that licensee's judgment or the quality of the licensee's services.
- (j) A licensee shall not accept compensation, financial or otherwise, from more than one party for services on the same project or for services pertaining to the same project, unless the circumstances are fully disclosed and agreed to by all interested parties.
- (k) A licensee shall not solicit or accept financial or other valuable consideration, directly or indirectly, from either of the following:
- (1) Material or equipment suppliers for specifying their products; or
- (2) contractors, their agents, or other parties in connection with work for employers or clients for which the licensee is responsible.
- (l) A licensee shall not solicit a contract from a governmental body on which a principal or officer of the licensee's organization serves as a member, except upon public disclosure of all pertinent facts and circumstances and consent of the appropriate public authority.
- (m) A licensee shall not offer, directly or indirectly, to pay a commission or other consideration or to make a political contribution or other gift in order to secure work, except for payment made to an employment agency for its services.
- (n) In all contacts with prospective or existing clients or employers, each licensee shall accurately represent the licensee's qualifications and the scope of the licensee's responsibility in connection with work for which the licensee is claiming credit.
- (o) A licensee shall not be associated with, or permit the use of the licensee's personal name or firm name in, a business venture being performed by any person or firm that the licensee knows, or has reason to believe, is engaging in either of the following:
- (1) Business or professional practice of a fraudulent or dishonest nature; or
- (2) a violation of K.S.A. 74-7001 *et seq.*, and amendments thereto, or the rules and regulations promulgated and adopted by the board, or both.
- (p) Each licensee with knowledge of any alleged violation of K.S.A. 74-7001 *et seq.*, and amendments thereto, or the regulations promulgated and adopted by the board, or both, shall report the alleged violation to the board.
- (q) Each licensee shall cooperate with the board in its investigation of complaints or possible violations of K.S.A. 74-7001 *et seq.*, and amendments thereto, and the regulations of the board. This cooperation shall include responding timely to written communications from the board, providing any information or documents requested within 30 days of the date on which the communication was mailed, and appearing before the board or its designee upon request.
- (r) A licensee shall not assist any person in applying for registration if the licensee knows that person to be unqualified with respect to education, training, experience, or character.

(s) Conviction of a felony or the revocation or suspension of a professional license by another jurisdiction, if for a cause that in the state of Kansas would constitute a violation of Kansas law or of these regulations, or both, shall be grounds for a charge of violation of these regulations. #### **Article 8.—EXAMINATIONS**

- **66-8-8.** Examination standards acceptable to the board for reciprocity applicants. (a) The reexamination of an applicant from another jurisdiction shall not be required for a license by reciprocity if that jurisdiction's examination requirements would have met the Kansas requirements in effect on the date when the applicant's original license was issued.
- (b) Another jurisdiction's written examination may be accepted by the board if that jurisdiction did not require the national examination when the applicant originally took and passed the jurisdiction's examination.
- (c) In order to meet the standard acceptable to the board, each applicant for a license by reciprocity as a land surveyor shall be required to demonstrate proficiency in Kansas land surveying laws and practices. This proficiency shall be presumed by the board upon the applicant's successful completion of the examination as specified in K.A.R. 66-8-4(a)(2). (Authorized by K.S.A. 74-7013; implementing K.S.A. 74-7024; effective Feb. 4, 2005.)

#### **Article 9.—EDUCATION**

- **66-9-6.** Geology curriculum approved by the board. Graduation from a course of study in geology shall mean successful completion of a baccalaureate or a master's degree in geology that meets the requirements of K.S.A. 74-7041, and amendments thereto. (Authorized by K.S.A. 74-7013; implementing K.S.A. 74-7041; effective Feb. 4, 2000; amended Feb. 4, 2005.)
- **66-9-7.** Educational standard acceptable to the board for reciprocity applicants. For purposes of K.S.A. 74-7024 and amendments thereto, each applicant for a license by reciprocity shall be deemed to have met the educational standard acceptable to the board if the applicant's educational qualifications when the original license was issued would have met the Kansas requirements in effect on that date. (Authorized by K.S.A. 74-7013; implementing K.S.A. 74-7024; effective Feb. 4, 2005.)

#### **Article 10.—EXPERIENCE**

**66-10-14.** Professional engineering, land surveying, and geology experience standards acceptable to the board for reciprocity applicants. (a) Each applicant for an engineering license by reciprocity shall meet the following requirements:

- (1) Provide verification from the employer of at least four years of engineering experience, as defined in K.S.A. 74-7003 and amendments thereto. One year of credit toward the experience requirement may be given for a master's degree in engineering; and
- (2) supply at least three references from licensed professional engineers who are familiar with the applicant's engineering experience.
- (b) Each applicant for a land surveying license by reciprocity shall meet the following requirements:
- (1) Provide verification from the employer of at least eight years of land surveying experience or education, or a combination of these, pursuant to K.S.A. 74-7022 and amendments thereto; and
- (2) supply at least three references from licensed land surveyors or licensed professional engineers who are familiar with the applicant's land surveying experience. At least one reference shall be from a licensed land surveyor.
- (c) Each applicant for a geology license by reciprocity shall meet the following requirements:
- (1) Provide verification from the employer of at least four years of geology experience, as defined in K.S.A. 74-7003 and amendments thereto. One year of credit toward the experience requirement may be given for a master's degree in geology; and
- (2) supply at least three references from individuals who are familiar with the applicant's geology experience. At least two of these references shall be from licensed geologists. One of the three references may be from a professional engineer. (Authorized by K.S.A. 74-7013, 74-7021, 74-7022, and 74-7041; implementing K.S.A. 74-7018, 74-7021, 74-7022, 74-7024, and 74-7041; effective Feb. 4, 2005.)

## Article 14.—CONTINUING EDUCATION REQUIREMENTS

- **66-14-3.** Activities. (a) Continuing education activities that satisfy the continuing education requirement shall include the following:
- (1) Attending professional or technical presentations at meetings, conventions, or conferences;
- (2) attending in-house programs sponsored by corporations or other organizations;
- (3) successfully completing seminars, tutorials, short courses, correspondence courses, televised courses, or videotaped courses;
- (4) making professional or technical presentations at meetings, conventions, or conferences;
- (5) teaching or instructing, as described in K.A.R. 66-14-5(a)(2);
  - (6) authoring published papers, articles, or books;
- (7) actively participating in a technical profession society or organization, as described in K.A.R. 66-14-5(a)(4);
- (8) successfully completing courses sponsored by a college or university;
- (9) successfully completing courses that are awarded continuing educational units; and
- (10) actively mentoring individuals who are preparing for licensure, as described in K.A.R. 66-14-5(a)(8).
- (b) All of the activities described in subsection (a) shall be required to be relevant to the practice of a tech-

nical profession and may include technical, ethical, or managerial content. (Authorized by and implementing K.S.A. 74-7013 and 74-7025; effective March 1, 1996; amended Feb. 4, 2005.)

- **66-14-5.** Computation of credit. (a) Continuing education credits shall be measured in professional development hours (PDH) and shall be computed as follows:
- (1) Successfully completing one hour of professional development education in coursework or seminars, or making professional or technical presentations at meetings, conventions, or conferences shall be the equivalent of one PDH.
- (2) Teaching or instructing, as specified in K.A.R. 66-14-3(a)(5), shall constitute two PDH for each contact hour spent in the classroom. Teaching credit shall be valid for teaching a course or seminar in its initial presentation only. Full-time faculty at a college, university, or other educational institution shall not receive teaching credit for teaching their regularly assigned courses.
- (3) Authoring a published paper, article, or book shall be the equivalent of 10 PDH.
- (4) Actively participating in a technical profession society or organization shall be the equivalent of two PDH. An individual shall serve as an officer or actively partic-

ipate in a committee of the organization, or both, in order to receive credit under this subsection. Professional development hours shall be limited to two PDH per organization and shall not be earned until the completion of each year of service.

- (5) Successfully completing one university semester hour of credit shall be the equivalent of 45 PDH.
- (6) Successfully completing one university quarter hour of credit shall be the equivalent of 30 PDH.
- (7) Successfully completing one continuing education unit shall be the equivalent of 10 PDH.
- (8) Actively mentoring one or more individuals who are preparing for licensure shall be limited to five PDH each year. Mentoring shall mean guiding or tutoring in the areas of professionalism, licensure, ethics, and technical knowledge.
- (b) Final authority shall rest with the board, with respect to the approval of courses, credits, and professional development hours for courses and other methods of earning credit. (Authorized by and implementing K.S.A. 74-7013 and 74-7025; effective March 1, 1996; amended Nov. 2, 2001; amended Feb. 4, 2005.)
