**K.A.R. 115-11-1.** This regulation relates to controlled shooting areas with regard to license application, issuance priority and reporting. The proposed change would not require daily reporting from controlled shooting areas.

**K.A.R. 115-18-10.** This regulation covers importation and possession of certain wildlife with provisions for prohibition, permit requirements and restrictions. The proposed amendment would add the New Zealand mudsnail to the list of prohibited species.

Economic Impact Summary: The proposed amendment is not anticipated to have any appreciable economic impact on the department, other agencies or the public.

The previous version of the regulation public comment is hereby rescinded.

Economic Impact Summary: The proposed regulation is not anticipated to have any appreciable economic impact on the department, other agencies or the public.

**K.A.R. 115-25-6.** This exempt regulation sets the spring wild turkey season, bag limits and permits available. Changes from the current regulation include the age of the supervising adult from 21 to 18 for the youth season.

Economic Impact Summary: The proposed regulation is not anticipated to have any economic impact on the department, other agencies or the public.

**K.A.R. 115-25-7.** This exempt regulation sets the antelope season, bag limits and permits available. Changes from the previous season include a slight increase in the number of permits available.

Economic Impact Summary: The proposed regulation is not anticipated to have any economic impact on the department, other agencies or the public.

**K.A.R. 115-25-8.** This exempt regulation sets the elk season, bag limits and permits available. Changes from the previous season include a slight increase in the number of any-elk permits available.

Designated uses of surface waters are listed in the Kansas Surface Water Register, which is adopted by reference in K.A.R. 28-16-28g (the register formerly adopted by reference in K.A.R. 28-16-28d). The register identifies major classified streams, lakes and wetlands, and the uses that are existing or attainable. In the period of April 1 through October 31, 2003, 427 stream segments and 45 lakes were evaluated by a UAA to determine the appropriate recreational use designation. This revision also includes one stream UAA conducted in 2000. Thirteen stream segments are proposed to be removed from classification, 282 stream segments are proposed as secondary contact recreation, and 132 stream segments are proposed as primary contact recreation. Five lakes are proposed to be removed from classification, one lake is proposed as secondary contact recreation, and 39 lakes are proposed as primary contact recreation and food procurement.

There are no additional costs of compliance resulting from these changes in recreational use designations. The department estimates an annual cost to perform 500 recreational UAAs as required by K.S.A. 82a-2004 and amendments thereto to be \$200,000 per year. Currently this cost is funded by the State Water Plan and state general fund.

The time period between the publication of this notice and the scheduled hearing constitutes a 60-day public comment period for the purpose of receiving written public comments on the proposed regulatory action. In the upper part of the ticket there is a crossword puzzle grid that contains 11 spaces (height) by 11 spaces (width) covered by transparent latex. In the "YOUR LETTERS" play area, located in the lower part of the ticket, there are 18 letters located under opaque latex. To the right of the "YOUR LETTERS" play area is the "BONUS" play area in which there are two letters covered by opaque latex. Name of drawing.** The Kansas lottery shall conduct two drawings entitled "Atlantis Second Chance Drawings" and will accept entries on and after the day Kansas lottery "Atlantis" instant tickets are first offered for sale to the general public and ending on Tuesday, March 8, 2005, for the first drawing and May 31, 2005, for the second drawing as specified in K.A.R. 111-4-2225. The drawings will be held on Friday, March 11, 2005, and June 3, 2005, at Kansas lottery headquarters in Topeka, Kansas. Rules applicable to the "Atlantis Second Chance Drawings" are contained in K.A.R. 111-4-2222 through 111-4-2227 and K.A.R. 111-3-1, *et seq.* (Authorized by and implementing K.S.A. 74-8710; effective, T-111-1-25-05, Dec. 16, 2004.)

**111-4-2223. Definitions.** (a) All definitions contained in the Kansas lottery act (K.S.A. 74-8701 *et seq.*) and lottery regulations are hereby incorporated by reference and govern unless otherwise indicated.

(b) "Atlantis Second Chance Drawings" means the act of drawing prizes conducted by the Kansas lottery at lottery headquarters in Topeka, Kansas, at the times described in K.A.R. 111-4-2225, in which participants are selected to win prizes as described in K.A.R. 111-4-2224.

(c) "Non-winning ticket" means any valid Kansas lottery "Atlantis" instant game lottery ticket not eligible to win a prize under the rules of that instant game.

(d) "Receptacle" or "drum" means a container in which non-winning Kansas instant game lottery tickets are placed and from which the "Atlantis Second Chance Drawing" entries are drawn. Receptacles or drums may be sealable and shall be capable of being mixed or rotated for the purpose of ensuring random distribution.

(e) "Bare arm technique" means a type of drawing where the person drawing the winning ticket from the receptacle or drum wears a long-sleeved shirt with sleeve rolled up above the elbow, a short-sleeved shirt (sleeve not extending past the elbow) or a no-sleeve shirt which exposes the drawer's bare arm and looks away from the drawing drum or receptacle while drawing. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-1-25-05, Dec. 16, 2004.)

**111-4-2224. Prizes.** (a) A total of seven prize packages shall be awarded at each of the two "Atlantis Second Chance Drawings." The winner of a prize at either of the drawings shall receive a prize package consisting of the following: round-trip coach airfare for two from Kansas City, Missouri, or Wichita, Kansas, to Nassau, Bahamas; double occupancy hotel room for four days and three nights at the Atlantis Paradise Island hotel; round trip ground transfers; \$3,000 cash; and mandatory state and federal withholding taxes.

(b) The following restrictions shall apply to each prize awarded in this drawing:

(1) The Kansas lottery is not responsible for any losses caused by delay or cancellation of any flights.

(2) The trip package is transferable one time but cannot be redeemed for cash.

(3) The lottery shall choose and reserve all hotel rooms.

(4) The lottery shall choose and provide transportation as described above. All other transportation is the responsibility of the prize winners.

(5) The trip must be taken no later than 18 months following the first date of sale of the "Atlantis" instant ticket.

(6) Any meals, drinks, gratuities, taxes, and other expenses that are not specifically mentioned are not included.

(c) All prizes are subject to lottery validation, set-offs and deductions authorized by law.

(d) The winner of a prize shall return to the lottery a completed claim form as provided by the lottery within 30 calendar days in which his or her ticket was drawn or the person named on the ticket drawn will no longer be eligible for the prize. In such an event, the first eligible alternate entry drawn for that prize pursuant to subsection (e) of K.A.R. 111-4-2227 shall be declared the winner. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-1-25-05, Dec. 16, 2004.)

**111-4-2225. Method of entry.** (a) Entry into the "Atlantis Second Chance Drawings" to be conducted on March 11, 2005, and June 3, 2005, shall be accomplished as follows:

(1) Obtain a valid "Atlantis" Kansas lottery instant lottery ticket.

(2) Determine if the ticket is a winning ticket in accordance with "Atlantis" game rules. If the ticket is a winning

ticket, it is not eligible for the drawing and shall be re-deemed in accordance with the instant game rules.

(3) If the ticket is a valid non-winning ticket, the ticket is eligible for the drawing and the holder of the ticket may use it to enter the drawing.

(4) The holder of the non-winning ticket must complete the information form on the back of the ticket in a legible manner. Only one name shall appear on a non-winning ticket entered.

(5) A receptacle or drum may be available for deposit of entries at locations as may be specifically designated by the lottery. All entries so deposited shall be transported to lottery headquarters and secured until the time of the drawing.

(6) Entries may also be mailed with proper postage to "Atlantis Drawing, c/o Kansas Lottery, P. O. Box 8099, Topeka, Kansas 66608-0099." Mailed entries must be received by morning mail pickup on Tuesday, March 8, 2005, for the first drawing, and Tuesday, May 31, 2005, for the second drawing. More than one entry may be mailed in one envelope.

(7) The holder of the ticket is not required to personally attend the drawing or be present at the time of the drawing to be determined a winner.

(8) The drawings will be conducted on Friday, March 11, 2005, and Friday, June 3, 2005.

(b) There is no limit on the number of entries a person may make, but a person may only win one time in each drawing. Entries remaining in the draw receptacle after the first drawing is complete are not eligible for the second drawing.

(c) Only valid non-winning "Atlantis" tickets which are mailed to the address set forth above with proper postage and received by the morning mail pickup in Topeka, Kansas, on the dates indicated above and non-winning "Atlantis" tickets entered at locations as may be specifically designated by the lottery, shall be eligible for the drawing.

(d) Eligible entrants in the "Atlantis Second Chance Drawings" must be 18 years of age or older.

(e) Completing the information form on the non-winning ticket and entering the ticket into the drawing constitutes authorization to publicly identify the person whose entry is drawn. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-1-25-05, Dec. 16, 2004.)

**111-4-2226. Certification of drawing.** (a) The "Atlantis Second Chance Drawings" shall be personally observed by a member of the Kansas lottery security department and a member of the Kansas lottery marketing department or other person or persons designated by the executive director of the lottery (hereinafter "event manager").

(b) Upon completion of each drawing, the security official and the event manager shall issue a report to the executive director, certifying that the name of each prize winner is correct, and that to the best of their knowledge the procedures required by these rules were followed in selecting the prize winners. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-1-25-05, Dec. 16, 2004.)

**111-4-2227. Selection of winners.** The following process shall be used for the selection of winners in the "Atlantis Second Chance Drawings:"

(a) Kansas lottery personnel shall pick up all mail containing "Atlantis Second Chance Drawing" tickets at the United States Post Office in Topeka, Kansas, with the final pickup at the Topeka post office in the morning mail pickup on Tuesday, March 8, 2005, and Tuesday, May 31, 2005. Following the morning mail pickup on each of said dates, the envelopes containing mailed entries will be transported to lottery headquarters and opened by lottery personnel. All mailed entries and entries retained from any other locations as specifically designated by the lottery shall also be placed in the drawing receptacle or drum.

(b) The drawing shall be held at Kansas lottery headquarters and shall be open to the public with lottery security personnel present. The drawing shall be audio and video taped.

(c) At each drawing, lottery security personnel will be present with the person designated by the executive director to perform the drawing. Prior to the drawing, if a drum is used, the drum shall be sealed and the contents mixed by rotating the drum at least 10 times. If a receptacle other than a drum is used, the contents shall be thoroughly mixed with a shovel or by other means prior to the drawing.

(d) The designated individual shall then unseal the drum, if a drum is used, and using the bare-arm technique, while looking away, remove seven entries, one at a time, from the receptacle or drum and mark them in order drawn: 1, 2, 3, 4, 5, 6, and 7. The person whose name appears on each entry shall be the winner of a prize package identified in K.A.R. 111-4-2224, subject to validation by the lottery as set forth in these rules.

(e) After the seven prize entries have been drawn at each drawing, and the entries have been verified as valid, four more entries will be drawn, one at a time. The last four entries drawn will serve as alternate entries for the prize packages. The alternate entries will be marked in order drawn: 1A, 2A, 3A, and 4A. The alternate entries will be used only if one or more of the original prize winners cannot be located or is declared ineligible, or fails to present a fully-executed claim form to lottery headquarters by 5:00 p.m. of the thirtieth calendar day following the drawing. The alternates will be used, if necessary, in the order drawn. If an alternate winner cannot be located, is declared ineligible, or fails to present a fully-executed claim form to lottery headquarters by 5:00 p.m. of the thirtieth calendar day following the claim form being given or sent to the alternate winner, the alternate winner process shall be repeated until the prize is properly claimed or until such time as no alternate winners remain, whichever occurs first.

(f) The Kansas lottery security official present shall review each ticket drawn to determine the validity of the entry into the "Atlantis Second Chance Drawings" in accordance with these regulations. If it is a valid entry and the name is legible, the event manager and the security person present shall record the name of the winner and the prize won. Each winner shall be given or sent a prize

claim form to be completed and returned to the lottery within 30 calendar days of the drawing.

(g) If the entry is determined to be ineligible, it shall be discarded by the security person present and another entry drawn. This procedure will be repeated until valid selections are obtained.

(h) Only non-winning "Atlantis" instant tickets as defined by these rules are eligible for the drawing.

(i) All "Atlantis" tickets remaining in the drum or receptacle after the winners and alternates have been selected in each drawing, and all entries not received in compliance with these rules, shall be destroyed pursuant to K.A.R. 111-3-34. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-1-25-05, Dec. 16, 2004.)

## Article 5.—MULTI-STATE ON-LINE GAMES

### POWERBALL POWER PLAY TRUCK GIVEAWAY

**111-5-116. Name of drawing.** The Kansas lottery shall conduct a drawing entitled "Powerball Power Play Truck Giveaway," and will accept entries starting January 9, 2005, for the drawing to be conducted at approximately 4:00 p.m. on April 30, 2005. Rules applicable to this drawing are contained in K.A.R. 111-5-116 through 111-5-120 and K.A.R. 111-6-1 *et seq.* (Authorized by and implementing K.S.A. 74-8710; effective, T-111-1-25-05, Dec. 16, 2004.)

**111-5-117. Prize.** (a) One prize winner selected in the "Powerball Power Play Truck Giveaway" on the date specified in K.A.R. 111-5-116 shall receive a 2005 GMC Sierra Denali pickup truck chosen by the Kansas lottery, all applicable sales and property taxes, registration fees, license tag fees, cash, and mandatory state and federal income withholding taxes.

(b) All prizes are subject to lottery validation, set-offs and deductions authorized by law.

(c) The winner of a prize as the result of the said drawing shall return to the lottery a completed claim form as provided by the lottery within 30 days of the date his or her entry was drawn or the person named on the entry drawn will no longer be eligible for the prize. In such an event, the first eligible alternate entry drawn pursuant to subsection (e) of K.A.R. 111-5-119 shall be declared the winner. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-1-25-05, Dec. 16, 2004.)

**111-5-118. Method of entry.** (a) Entry into the "Powerball Power Play Truck Giveaway" shall be accomplished as follows:

(1) Beginning at 5:00 a.m. on January 9, 2005, and ending at the close of business as defined in subsection (p) of K.A.R. 111-6-1, on April 23, 2005, for every single Kansas Powerball ticket purchase that includes purchase of the Power Play option, the purchaser shall receive free of charge an entry blank for the drawing, which entry blank shall be automatically dispensed from the terminal upon qualifying purchase. In addition, from the time the Kansas lottery begins selling Powerball tickets using lottery terminal(s) at the 3i Show in Great Bend, Kansas, on April 28, 2005, through and including 3:00 p.m. on April 30, 2005, for every single Kansas Powerball ticket purchased from said terminal(s) that includes the Power Play option, the

purchaser shall receive free of charge an entry blank for the drawing, which entry blank shall be automatically dispensed from the terminal(s) upon the qualifying purchase.

(2) The executive director may suspend or terminate this promotion at any time or modify the qualifying purchase necessary to receive an entry, whether during periods of high sales of Powerball tickets, thereby rendering the generation of entries impractical, or otherwise.

(3) The holder of an entry blank must fill in the entry blank in a legible manner. Only one name shall appear on an entry blank.

(4) Place one or more completed entry blank(s) for said drawing into an envelope with proper postage and mail it to: "Denali Truck Giveaway, c/o Kansas lottery, P. O. Box 1494, Great Bend, Kansas 67530-1494, or deposit completed entry blank(s) into the lottery receptacle designated at the 3i Show from April 28, 2005, until 3:00 p.m. on April 30, 2005. Mailed entries must be received by morning mail pickup on Tuesday, April 26, 2005. A receptacle or drum may also be available for deposit of entries at locations specifically designated by the lottery. All entries so deposited shall be transported to the lottery office in Great Bend, Kansas, and secured until the time of the drawing.

(5) The holder of the entry is not required to personally attend said drawing or be present at the time of the drawing to be determined a winner.

(6) The drawing will be conducted at the approximate time listed in K.A.R. 111-5-116.

(b) There is no limit on the number of entries a person may make, but a person may only win one time.

(c) All eligible entries which are mailed and received by the morning mail pickup in Great Bend, Kansas, on Tuesday, April 26, 2005, those deposited at the 3i Show, and those deposited at locations specifically designated by the lottery pursuant to subsection (a) herein, shall be entered into said drawing.

(d) Eligible entrants in the drawing must be 18 years of age or older.

(e) Completing the information form on the entry blank and entering it into the drawing constitutes authorization to publicly identify the person whose entry is drawn.

(f) The executive director of the Kansas lottery may, in his sole discretion, cancel this promotion at any time. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-1-25-05, Dec. 16, 2004.)

**111-5-119. Selection of winners.** The following process shall be used for the selection of winners in the "Powerball Power Play Truck Giveaway":

(a) Kansas lottery personnel shall pick up all mail containing entries mailed to P. O. Box 1494 for the drawing at the United States Post Office in Great Bend, Kansas, with final pick up on Tuesday, April 26, 2005.

(b) Lottery personnel shall transport the mail to the Great Bend regional office where the envelopes will be opened and the entries contained therein stored in a secure location until immediately prior to the drawing, at which time all entries will be placed into the drawing receptacle or drum, along with all entries deposited at the 3i Show pursuant to the rules herein, and all entries retained from any other locations as specifically designated by the lottery.

(c) The drawing shall be held at the 3i Show in Great Bend, Kansas, in a place accessible to the public and open for public attendance with lottery security personnel present. The drawing shall be audio and video taped.

(d) At the start of the drawing, lottery security personnel shall present the receptacle or drum to the person designated by the executive director to perform the drawing. The receptacle or drum for the said drawing shall contain all eligible entries. The entries shall be thoroughly mixed prior to the entries actually being drawn. The designated individual shall then unseal the receptacle or drum, and using the bare-arm technique, while looking away, remove one entry from the receptacle or drum and mark it in such a way as to identify it as the winning entry. The person whose name appears on the entry shall be the winner of the prize identified in K.A.R. 111-5-117, subject to validation by the lottery as set forth in these rules.

(e) After one entry has been drawn and verified as valid by lottery security, two more entries will be drawn, one at a time, to serve as alternate entries. The alternate entries will be marked in order drawn, 1A and 2A. The alternate entries will be used only if the original winner cannot be located or is declared ineligible, or fails to present a fully-executed claim form to lottery headquarters by 5:00 p.m. of the thirtieth day following the drawing. The alternates will be used, if necessary, in the order drawn.

(f) The Kansas lottery security official present shall review each entry drawn to determine the validity of the entry into the said drawing in accordance with these regulations. If it is a valid entry and the information is legible, the event manager and the security person present shall record the name of the winner and each alternate. Each winner shall be given or sent a prize claim form to be completed and received by the lottery within 30 days of the drawing.

(g) If any entry is determined to be ineligible, it shall be discarded by the security person present and another entry drawn. This procedure will be repeated until valid selections are obtained.

(h) Entries remaining in the drum or receptacle after the drawing has been completed and all entries not received in compliance with these rules shall be destroyed pursuant to K.A.R. 111-3-34. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-1-25-05, Dec. 16, 2004.)

**111-5-120. Certification of drawing.** (a) The "Powerball Power Play Truck Giveaway" shall be personally observed by a member of the Kansas lottery security department and a member of the Kansas lottery marketing department or other person or persons designated by the executive director of the lottery ("event manager").

(b) Upon completion of the drawing, the security official and the event manager shall issue a report to the executive director, certifying that the name of each prize winner is correct, and that to the best of their knowledge the procedures required by these rules were followed in selecting the prize winner. #### HOUSE BILL No. 2007

AN ACT concerning the horsethief reservoir benefit district; relating to district sales tax; election therefor; amending K.S.A. 2004 Supp. 82a-2205 and repealing the existing section.

*Be it enacted by the Legislature of the State of Kansas:*

Section 1. K.S.A. 2004 Supp. 82a-2205 is hereby amended to read as follows: 82a-2205. (a) In addition to and notwithstanding any limitations on the aggregate amount of the retailers' sales tax contained in K.S.A. 12-187 through 12-197, and amendments thereto, the district may impose a horsethief reservoir benefit district sales tax on the selling of tangible personal property at retail or rendering or furnishing services taxable pursuant to the provisions of the Kansas retailers' sales tax act, and amendments thereto, within the district for purposes of financing the project in increments of .05% and in an aggregate amount not to exceed .25% and pledge the revenue received therefrom to pay the costs of the project, the costs to manage and operate the project and to make debt service payments on any bonds issued to finance the project. Any horsethief reservoir benefit district sales tax imposed pursuant to this section shall expire no later than the

maturity date of the bonds issued to finance such project or refunding bonds issued therefor.

(b) Prior to the imposition of the horsethief reservoir benefit district sales tax, the governing board shall adopt a resolution stating its intention to levy a horsethief reservoir benefit district sales tax for the purpose of financing the project and continued management and operational expenses thereof as proposed by this act. The governing board shall give notice of the public hearing on the imposition of such horsethief reservoir benefit district sales tax. Such notice shall be published at least once a week for two consecutive weeks in the official county newspaper of each county whose boundaries are located within the district. The second notice shall be published at least seven days prior to the date of hearing. The notice shall contain the following information:

- (1) The time and place of the hearing;
- (2) the nature of the project;
- (3) the estimated cost of the project;
- (4) the proposed method of financing the project; and
- (5) the proposed amount of the horsethief reservoir benefit district sales tax to be imposed and the termination date of such horsethief reservoir benefit district sales tax.

(c) The hearing may be adjourned from time to time. Following the hearing, the governing board may authorize the project, approve the estimated cost of the project and the method of financing of the project by adoption of the appropriate resolution. Such resolution shall be effective upon publication once in the official county newspaper of each county whose boundaries are located within the district.

(d) If at the conclusion of the public hearing, the governing board of the district proposes to impose a horsethief reservoir benefit district sales tax, the governing board shall submit a proposition to impose such tax to the qualified electors within the district. Notice of such election shall be provided in accordance with the provisions of K.S.A. 10-120, and amendments thereto published at least once a week for two consecutive weeks in the official county newspaper of each county whose boundaries are located within the district. The second notice shall be published at least seven days prior to the date of such election. Any such election shall be called and

held at any general election, as defined in K.S.A. 25-2502, and amendments thereto, or at a special election called for that purpose. In lieu thereof, such election may be called and held in the manner provided by K.S.A. 25-431 et seq., and amendments thereto. If an election is held and the proposition is approved by a majority of the voters of the district voting at such election, the governing board, by resolution, may levy such tax. If such a resolution is adopted pursuant to this act, the horsethief reservoir benefit district sales tax shall be imposed in the district. Except as provided in this act, the tax authorized by this section shall be administered, collected and subject to provisions of K.S.A. 12-187 to 12-197, inclusive, and amendments thereto.

(e) Upon receipt of a certified copy of the resolution authorizing the levy of the horsethief reservoir benefit district sales tax pursuant to this section, the state director of taxation shall cause such tax to be collected in the district at the same time and in the same manner provided for the collection of the state retailers' sales tax. All taxes collected under the provisions of this act shall be remitted by the secretary of revenue to the state treasurer in accordance with the provisions of K.S.A 75-4215, and amendments thereto. Upon receipt of each such remittance, the state treasurer shall deposit the entire amount of all taxes collected under the provisions of this act in the state treasury to the credit of the horsethief reservoir benefit district sales tax fund, which fund is hereby established in the state treasury. All moneys in the horsethief reservoir benefit district sales tax fund shall be remitted at least quarterly by the state treasurer, on instruction from the secretary of revenue, to the district. Any refund due on any horsethief reservoir benefit district sales tax collected pursuant to this section shall be paid out of the horsethief reservoir benefit district sales tax refund fund which is hereby established in the state treasury and reimbursed by the director of taxation from collections of the horsethief reservoir benefit district sales tax authorized by this section and applied by the district in the manner provided pursuant to this act.

Sec. 2. K.S.A. 2004 Supp. 82a-2205 is hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the Kansas register.
