Notice of Hearing on Proposed  
Administrative Regulations

The State Board of Education will conduct a public hearing at 1:30 p.m. Tuesday, June 14, in the board room of the State Education Building, 120 S.E. 10th Ave., Topeka, to consider proposed amendments to a teacher licensure regulation, 91-1-203, and new regulations 91-1-220 and 91-1-221, which replace 91-1-213 that is being revoked. A summary of the proposed regulations and their economic impact follows:

**K.A.R. 91-1-203. Licensure requirements.** The changes to 91-1-203 appear only in subsection (b) of the regulation, which concerns professional licenses. The added language will allow conditionally-licensed persons to complete the required performance assessment while employed in either a state board-accredited school or in a school that is accredited by a national or regional accrediting agency recognized by the state board. If this revision is not adopted, conditionally-licensed persons who are employed in schools that are not state board-accredited, although nationally or regionally accredited, will not be able to complete the performance assessment and will never qualify for a professional license. There will be no financial impact upon the State Board of Education, other governmental entities, private businesses or individuals.

New regulations **91-1-220** and **91-1-221** will replace current regulation **91-1-213**. These regulations concern issuance of technical education certificates. These certificates are issued to persons who have knowledge, skills and experience in a technical or vocational area, but who do not have college degrees as teachers. Regulation 91-1-213, which was adopted along with the other licensure redesign regulations, provided the requirements for this certificate.

It has become apparent that different qualifications for this certificate are needed depending upon whether the certificate holder will be providing instruction primarily to regular education children or to children with disabilities. In the latter case, the certificate holder must possess additional knowledge and skills to work appropriately with special needs children.

Therefore, 91-1-220 is proposed to specify the requirements for a "standard" technical education certificate, and 91-1-221 sets forth the requirements for a technical education special certificate. Regulation 91-1-213 will be revoked. There will be no financial impact upon the State Board of Education, other governmental entities, private businesses or individuals.

All interested persons will be given a reasonable opportunity at the hearing to present their views, either orally or in writing, in regard to the proposed regulations. In addition, the period of public notice hereby provided constitutes a public comment period for the purpose of receiving written public comments on the proposed regulations. Such written comments may be submitted to the secretary of the State Board of Education at the address above. The hearing shall be conducted in compliance with the public hearing procedures of the State Board of Education.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. **Article 1.—LICENSING AND QUALIFICATIONS OF COSMETOLOGISTS**

**69-1-4. Grades necessary to pass licensure examinations; development and administration of licensure examinations.** (a) Each applicant taking the state board of cosmetology examinations shall be granted a license authorizing the practice of cosmetology, nail technology, esthetics, or electrology if the applicant attains the following examination scores:

(1) An average of at least 75 percent on the practical examination sections. However, each applicant shall be required to attain a score of at least 75 percent on the client protection section of the practical examination; and

(2) at least 75 percent on the written examination.

(b) Each applicant for licensure as an instructor shall be required to attain a score of at least 75 percent on the written examination for instructors, in addition to meeting the applicable requirements specified in K.S.A. 65-1903, and amendments thereto.

(c) The licensure examinations shall be developed and administered by the board or by a board-approved examination provider. (Authorized by and implementing K.S.A. 65-1905; effective Jan. 1, 1966; amended May 1, 1981; amended Feb. 21, 1994; amended March 22, 1996; amended, T-69-12-29-04, Dec. 29, 2004; amended April 15, 2005.)

**30-5-64. Prior authorization.** The following changes will be made to K.A.R. 30-5-64 regarding prior authorization of pharmaceutical products: To ensure the most clinically appropriate utilization of these drugs in the most cost-effective manner, the following drugs will require prior authorization. These therapeutic classes of drugs have been evaluated by the Preferred Drug List Advisory Board and found to be clinically equivalent:

- anticholinergic urinary incontinence drugs: trospium chloride
- intranasal corticosteroids: Bausch & Lomb's flunisolide
- inhaled corticosteroids: flunisolide/menthol; beclomethasone; (QVAR®); triamcinolone; budesonide inhalation powder; budesonide inhaled suspension

Federal Mandate: This regulation change is not federally mandated.

Economic Impact: It is expected that this change will reduce Medicaid expenditures by \$272,000 SGF and \$408,000 FFP, annually.

Bearer of Cost: The cost of reviewing prior authorization (PA) will be borne by SRS. If a Medicaid consumer wishes to have a drug despite a PA denial, the cost will be borne by the consumer.

Affected Parties: Medicaid consumers, pharmacists and the Medicaid agency.

Other Methods: There were no other appropriate methods for the desired outcome.

No changes to the expiration date of an application were made with this proposed regulation change. Expiration dates of licenses is deleted in this regulation and moved to K.A.R. 60-3-108.

**K.A.R. 60-3-108. License expiration and renewal.** The proposed language clarifies the expiration date of a license and when the renewal date is. No changes to the expiration date or renewal dates were made with this proposed regulation change.

**K.A.R. 60-3-112. Exempt license.** The proposed language changes jurisdiction to state or territory and deletes reference to K.A.R. 60-3-107 and replaces it with K.A.R. 60-3-108.

**K.A.R. 60-11-113. Certification renewal.** The proposed language clarifies that the advanced practice nurse practitioner certifications are renewed as the registered professional nurse licensure. No change to the actual time of renewal was made.

**K.A.R. 60-11-120. Expiration dates of certificates, applications.** The proposed language adds reference to K.A.R. 60-3-108.

**K.A.R. 60-11-121. Exempt certificate.** The proposed language deletes reference to K.A.R. 60-3-107 and replaces it with K.A.R. 60-3-108.

**K.A.R. 60-13-112. Authorization renewal.** The proposed language deletes reference to K.A.R. 60-3-107 and replaces it with K.A.R. 60-3-108.

**K.A.R. 60-17-111. Requirements for advanced registered nurse practitioner refresher course.** The proposed change adds language that would allow a registered nurse who completed the education required to be certified as an advanced registered nurse practitioner and was never certified to be eligible to take a refresher course.

**K.A.R. 60-15-101. Definitions and functions.** The proposed language change adds staff to the list of those a nurse can teach or counsel. It also adds a qualifier that an "investigational drug" means a drug under study by the United States Food and Drug Administration.

**K.A.R. 60-15-104. Medication administration in a school setting.** The proposed language states that a registered nurse may delegate the procedure of medication administration in a school setting in accordance with this regulation. Current language stated that a registered nurse may delegate the procedure of medication administration in a school setting to unlicensed persons if the initial dose of a medication has been previously administered to the student unless the medication is ordered for an anticipated health crisis.

**K.A.R. 60-16-103. Course approval procedure.** The proposed language will add the requirement that a copy of the final written competency examination and the final clinical competency examination for an intravenous (IV) fluid therapy course to be submitted with their proposal to the board. The number of hours of continuing education that must be awarded for this course was decreased from 42 to at least 32 for the LPN that complete the

course. Other changes made in the regulation are clarifying language only.

**K.A.R. 60-16-104. Standards for course; competency examination; recordkeeping.** Proposed changes to this regulation for intravenous fluid therapy course will decrease the classroom hours from 40 to 30 hours and require a minimum of eight hours of supervised clinical practice that shall include at least one successful peripheral venous access procedure and the initiation of an intravenous infusion treatment modality on an individual. Proposed changes also name the only board-approved intravenous fluid therapy curriculum shall be the "venous access and intravenous infusion treatment modalities," 2003 revision, published by the Instructional Materials Laboratory, University of Missouri-Columbia, which is hereby adopted by reference with several modifications. The final competency examination shall be constructed from the board-approved pool of test questions that consist of a minimum of 50 questions.

There is no economic impact for the State Board of Nursing, other governmental entities, private business or individuals.

#### HOUSE BILL No. 2187

AN ACT relating to the taxation of motor vehicles; concerning exemptions for certain military individuals; amending K.S.A. 2004 Supp. 79-5107 and repealing the existing section.

*Be it enacted by the Legislature of the State of Kansas:*

Section 1. K.S.A. 2004 Supp. 79-5107 is hereby amended to read as follows: 79-5107. (a) Except as provided in subsection (e), the tax imposed by this act upon any motor vehicle, other than a motor vehicle which replaces a motor vehicle previously registered and taxed in this state and to which registration plates are transferred, which has been acquired, or brought into the state, or for any other reason becomes subject to registration after the owner's regular annual motor vehicle registration date, shall become due and payable at the time such motor vehicle becomes subject to registration under the laws of this state and the amount of tax to be paid by the owner for the remainder of the tax year shall be an amount which is equal to  $\frac{1}{12}$  of the tax which would have been due upon such motor vehicle for the full registration year, multiplied by the number of full calendar months remaining in the registration year of the owner of such vehicle. Such tax shall be paid at the time of the registration of such motor vehicle.

(b) Except as provided in subsection (e), the tax upon a motor vehicle, which replaces a motor vehicle previously registered and taxed in this state and to which registration plates are transferred, which is registered at any time other than the annual registration date prescribed by law for the registration of such motor vehicle, shall be in an amount equal to the amount by which: (1) One-twelfth of the tax which would have been due upon such replacement motor vehicle for the full registration year multiplied by the number of full calendar months remaining in the registration year for such motor vehicle, exceeds (2) one-twelfth of the tax which would have been due for the full registration year upon the motor vehicle replaced multiplied by the number of full calendar months remaining in such registration year. Such tax shall be paid at the time of registration of such replacement vehicle.

(c) Whenever the tax imposed under this act has been paid upon any motor vehicle and title to such vehicle is transferred and no replacement vehicle is substituted therefor such taxpayer shall be entitled to a refund in an amount equal to  $\frac{1}{12}$  of the tax due upon such motor vehicle for the full registration year, multiplied by the number of full calendar months remaining in such registration year. Whenever the tax imposed under this act upon any replacement motor vehicle for the remainder of the registration year is less than the tax paid on the motor vehicle replaced for the remainder of such registration year, the taxpayer shall be entitled to a refund in the amount by which the tax paid upon the vehicle replaced exceeds the tax due upon the replacement vehicle. All refunds shall be paid by the county treasurer from the moneys received from taxes upon motor vehicles imposed by this act which have not been distributed. No



refund shall be made under the authority of this subsection for a sum less than \$5.

(d) Whenever the tax imposed under this act has been paid upon any motor vehicle and the owner thereof has established residence in another state during such vehicle's registration year, such owner shall be entitled to a refund of such taxes in an amount equal to 1/12 of the tax paid upon such motor vehicle for the full registration year, multiplied by the number of full calendar months remaining in such registration year after the month of establishing residence in another state. No such refund shall be allowed unless and until the owner submits to the county treasurer evidence of a valid driver's license and motor vehicle registration in another state, and surrenders the Kansas license plate. All refunds shall be paid by the county treasurer from the moneys received from taxes upon motor vehicles which have not been distributed. No refund shall be made for a sum less than \$5.

(e) No tax shall be levied under the provisions of this act upon not more than two motor vehicles which are owned by a resident individual:

(1) Who is in the full-time regular military service of the United States and is absent from this state solely by reason of military orders on the date of such individual's application for registration and such motor vehicles are maintained by such individual outside of this state; or

(2) who is a member of the military service of the United States and is mobilized and or deployed on the date of such individual's application for registration.

The provisions of this subsection shall be applicable on and after December 31, 2004.

Sec. 2. K.S.A. 2004 Supp. 79-5107 is hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the Kansas register.
