This facility washes the exterior of semi-tractors and trailers associated with the transportation business. This facility is not a commercial vehicle wash. The wash water and domestic wastewater from a mobile home are directed to an earthen waste stabilization lagoon. The wash water is directed through a mud trap before entering the lagoon. An average of five trucks are washed per week. A commercial vehicle wash is utilized when cleaning chemicals are used. Cattle trailers also are cleaned off-site. Article 2.—FEES

51-2-5. Special local administrative law judge fees and expenses. (a) The fees for the services of each special local administrative law judge shall be as follows:

(1) A fee of \$50.00 shall be assessed for each settlement hearing that is heard as part of a regular settlement docket.

(2) A fee of \$50.00 shall be assessed for each settlement hearing that is heard at an individual setting.

(3) A fee of \$100.00 shall be assessed for each preliminary hearing, including a preliminary award, and for each full hearing.

(4) A fee of \$100.00 shall be assessed for each prehearing settlement conference.

(5) A fee of \$85.00 per hour shall be assessed for preparing and rendering a final award. The total fee shall not exceed \$500.00.

(b) If a special local administrative law judge incurs expenses conducting one or more settlement hearings in a location other than the judge's home community, the expenses shall be assessed, as costs, proportionately among the cases generating the expenses.
