Opinion No. 2006-01

Written January 19, 2006, to Jim Skelton, Wichita City Council Member, Wichita.

This opinion is in response to your letter dated December 15, 2005, in which you request an opinion from the Kansas Governmental Ethics Commission concerning the Campaign Finance Act (K.S.A. 25-4142 et seq.). We note at the outset that the Commission's jurisdiction concerning your question is limited to the application of K.S.A. 25-4142 et seq., and whether some other statutory system, common law theory or agency rule or regulation applies to your inquiry is not covered by this opinion.

Factual Statement

We understand that you are asking for this opinion in your capacity as a member of the Wichita City Council. Your question concerns paying for the mailing of newsletters to your constituents. You state that the newsletters do not pertain in any way to your campaign.

Question

Is it permissible under the Campaign Finance Act for you to use campaign funds for the mailing of newsletters to your constituents?

Opinion

K.S.A. 25-4157a, which addresses the use of campaign contributions, specifically allows a candidate to use campaign contributions for "expenses of holding political office." Costs associated with mailing newsletters to constituents are an expense of holding political office. Therefore, it is permissible for you to use campaign funds for the mailing of newsletters to your constituents.

Opinion No. 2006-02

Written January 19, 2006, to Sandy Perkins, Topeka.

This opinion is in response to your letter dated December 27, 2005, requesting an opinion from the Kansas Governmental Ethics Commission concerning state level conflict of interest laws, K.S.A. 46-215 et seq. We note at the outset that the Commission's jurisdiction concerning your question is limited to the application of K.S.A. 46-215 et seq., and whether some other statutory system, common law theory or agency rule or regulation applies to your inquiry is not covered by this opinion.

Factual Statement

You request this opinion in your capacity as the Maternal and Children Nutrition Consultant in the Bureau for Children, Youth and Families of the Kansas Department of Health and Environment (KDHE). You indicate that KDHE contracts with Starling Systems of Olympia, Washington for the design, implementation and management of the Kansas WIC Program's management information system (KWIC). Your duties included assisting in the design and implementation of KWIC, primarily in 2002. You are still involved with KWIC, however you state that you were not involved in the negotiation of the contract between Starling Systems and KDHE.

(continued)

Starling Systems is making a proposal to design a WIC management information system for the Mountain Plans State Consortium (MPSC) and has offered you a part-time position with Starling Systems as a WIC policy specialist if their proposal results in being awarded a contract with the MPSC. Kansas is not part of the MPSC. You state that your employment with Starling Systems would involve "assessing the degree to which the Starling WIC system meets current and anticipated federal policies and state requirements regarding client eligibility, nutrition, and check issuance and recommend changes to the Starling WIC System and/or MPSC member states eligibility, nutrition and check policies and procedures." You would perform these duties outside of your work time for KDHE and would not be paid by Starling Systems for any of your KDHE job duties.

Questions

1. Do the conflict of interest laws allow you to accept a position with Starling Systems if Starling Systems is awarded a contract with the MPSC?

2. Do the conflict of interest laws prohibit Starling Systems from identifying you as their potential WIC Policy Specialist in their Proposal for the Mountain Plans State Consortium?

Opinion

K.S.A. 2004 Supp. 46-233 places restrictions on a state employee's ability to accept outside employment while they are employed by the State. That statute states in pertinent part:

(a)(1) No state officer or employee shall in the capacity as such officer or employee be substantially involved in the preparation of or participate in the making of a contract with any person or business by which such officer or employee is employed

(2) Except as otherwise provided in this subsection, whenever any individual has participated as a state officer or employee in the making of any contract with any person or business, such individual shall not accept employment with such person or business as an employee, independent contractor or subcontractor until two years after performance of the contract is completed or until two years after the individual terminates employment as a state officer or employee, whichever is sooner. . . .

. . . .

(d) Subsections (a) and (b) shall not apply to the following: (1) Contracts let after competitive bidding has been advertised for by published notice; and (2) Contracts for property or services for which the price or rate is fixed by law.

(e) . . . (2) "Substantially involved in the preparation or participate in the making of a contract" means having approved or disapproved a contract or having provided significant factual or specific information or advice or recommendations in relation to the negotiated terms of the contract.

You stated that you "played no part in the negotiation of the contract between Starling Systems and KDHE." However, the prohibitions stated in K.S.A. 2004 Supp. 46-233 apply to more than being involved in the review or selection of a contractor, or in negotiating the terms of a contract. In Opinion No. 2000-50 the Commission determined that if a state employee has the ability to influence

the selection of a contractor or provides significant information, advice or recommendations in relation to the selection of a contractor, they are substantially involved in the preparation of or are participating in the making of the contract. Additionally, Opinion No. 1999-33 determined that if there are material changes made to a renewal contract, the renewal contract will be considered to be a negotiated contract. The particular facts of each situation must be reviewed to determine if an employee's involvement constitutes participation in the making of a contract under K.S.A. 2004 Supp. 46-233.

In response to your first question, if you have not participated on behalf of KDHE in making a negotiated contract with Starling Systems as contemplated by K.S.A. 2004 Supp. 46-233, you may accept employment with Starling Systems immediately while continuing to work for KDHE. However, if you participated in making a negotiated contract between KDHE and Starling Systems, you may not accept employment with Starling Systems until two years after the performance of that contract is completed. This statute also prohibits you from being involved in the making of any new or renewal contract on behalf of KDHE with Starling Systems as long as you are employed by Starling Systems.

In response to your second question, the state conflict of interest statutes do not prohibit Starling Systems from identifying you as their potential WIC Policy Specialist in their proposal.

Opinion No. 2006-03

Written January 19, 2006, to Joann E. Corpstein, Chief Counsel, Kansas Department on Aging, Topeka.

This opinion is in response to your letter dated December 8, 2005, in which you request an opinion from the Kansas Governmental Ethics Commission concerning the state level conflict of interest laws, K.S.A. 46-215 et seq. We note at the outset that the Commission's jurisdiction concerning your request is limited to the application of K.S.A. 46-215 et seq., and whether some other statutory system, common law theory or agency rule or regulation applies to your inquiry is not covered by this opinion.

Factual Statement

We understand that you are asking for this opinion in your capacity as Chief Counsel for the Department on Aging (KDOA). You state that as the sponsor of the Governor's Conference on Aging in May 2006, KDOA would like to solicit trade organizations to sponsor a reception, luncheons, breakfasts, breaks and concurrent sessions. KDOA would also like to solicit a wide variety of entities to be exhibitors at the conference, some which are entities that KDOA licenses, inspects or regulates. All exhibitors will be charged the same fee based on the size of their exhibit booth. You have stated that you understand from this Commission's Opinion No. 1999-52 that KDOA employees may solicit and accept sponsorship money in excess of \$40 from sponsors who do not have a special interest in KDOA and who are not licensed, inspected or regulated by KDOA. You also understand that pursuant to Opinion No. 1999-52, KDOA may solicit and accept money for exhibit booths from exhibitors that are licensed, inspected and regulated by KDOA or that have a

special interest in KDOA. You seek further guidance in determining what constitutes a "special interest" under the conflict of interest statutes.

You explain that KDOA performs administrative responsibilities for the payment and enforcement of certain Medicaid long-term care programs on behalf of the Division of Health Policy and Finance. KDOA's responsibilities include calculating and paying reimbursement rates and imposing certain federal enforcement remedies such as civil money penalties against hospital-based long-term care units. Hospital-based long-term care units are licensed and inspected by the Kansas Department of Health and Environment, not by KDOA. You question whether KDOA's Medicaid responsibilities constitute regulation of the hospital-based long-term care units.

Questions

1. For purposes of soliciting sponsorships, are trade associations whose members are licensed, inspected or regulated by KDOA considered to have a special interest in KDOA if the associations lobby the Legislature and discuss matters of interest to their members with KDOA staff?

2. Does KDOA's administrative authority to calculate payment and impose enforcement remedies on behalf of another agency constitute "regulating" for purposes of K.S.A. 46-237(c)?

3. May KDOA continue to rely on the statements and conclusions of Opinion No. 1999-52?

Opinion

In response to your first question, K.S.A. 46-236 limits certain solicitations by state employees when the entity solicited has a special interest in the employee. K.S.A. 46-236 states in pertinent part:

No state officer or employee . . . shall solicit any economic opportunity, gift, loan, gratuity, special discount, favor, hospitality, or service from any person known to have a special interest, under circumstances where such officer [or] employee . . . knows or should know that a major purpose of the donor in granting the same could be to influence the performance of the official duties or prospective official duties of such officer [or] employee . . .

K.S.A. 46-228 defines "special interest" in pertinent part as follows:

"Special interest" means an interest of any person as herein defined . . . (2) in the action or non-action of any state agency or state officer or employee upon any matter affecting such person as distinct from affect upon the people of the state as a whole.

We have previously considered a person to have a special interest in a state agency or employee if the person contracts with the agency, or if the agency has regulatory or inspection authority over the person, or if the person has a matter before the agency that does not affect the general public as a whole. *See* Opinions No. 1997-48 and 1997-28. Although a trade association falls within the definition of "person" under the state conflict of interest statutes, we do not believe that a trade association would have a special interest in your agency merely because it discusses legislation or other matters of interest to its members with employees of your agency. While your agency may have matters before it concerning individual

members of a trade association, unless the association has a matter pending that would affect the actual trade association, the association would not have a special interest in your agency under K.S.A. 46-236. KDOA employees may solicit sponsorships from any association that does not have a special interest as defined in K.S.A. 46-236.

Your second question is whether KDOA's administrative and enforcement responsibilities with respect to certain Medicaid long-term care programs constitutes "regulating" for purposes of K.S.A. 46-237(c). We have directed our staff to obtain further information from you and conduct further research on this question. We will respond to this question in a separate opinion.

Finally, the conclusions stated in Opinion No. 1999-52 are still valid, and you may continue to rely on that opinion in determining issues concerning solicitations by KDOA.

Opinion No. 2006-04

Written January 19, 2006, to the Honorable Kay O'Connor, State Senator, Topeka.

This opinion is in response to your letter dated December 15, 2005, in which you request an opinion from the Kansas Governmental Ethics Commission concerning the Campaign Finance Act (K.S.A. 25-4142 et seq.). We note at the outset that the Commission's jurisdiction concerning your questions is limited to the application of K.S.A. 25-4142 et seq., and whether some other statutory system, common law theory or agency rule or regulation applies to your inquiry is not covered by this opinion.

Factual Statement

We understand that you are asking for this opinion in your capacity as State Senator and candidate for Secretary of State. Your questions involve maintaining two separate campaign accounts.

Question

1. Can the same entity contribute to a current office holder's campaign account and to a campaign account for a different office for which that same office holder is a candidate?

2. What accounting techniques are necessary and recommended to separate joint expenses from two different campaign accounts for the same office holder/candidate? Examples of possible joint expenses are mileage to an event involving both the current office holder and that office holder's newly sought office, paying office help to answer phones and schedule events for both campaigns, and using the same copy machine for both campaigns.

Opinion

In response to your first question, we find nothing in the Campaign Finance Act to prohibit the same entity from contributing to two campaign accounts for the same person who is a current office holder and a candidate for a different office.

K.S.A. 25-4157a(c) provides:

No candidate or candidate committee shall accept from any other candidate or candidate committee for any candidate for local, state or national office, any moneys received by such candidate or candidate committee as a campaign contribution. The provisions of this subsection

shall not be construed to prohibit a candidate or candidate committee from accepting moneys from another candidate or candidate committee if such moneys constitute a reimbursement for one candidate's proportional share of the cost of any campaign activity participated in by both candidates involved. Such reimbursement shall not exceed an amount equal to the proportional share of the cost directly benefitting and attributable to the personal campaign of the candidate making such reimbursement.

Therefore, because your current office and the new one which you seek are separate candidacies, you may not transfer money from your current office campaign account to the campaign account for the new office you are seeking, and vice versa, unless the transfer is to reimburse one account for the proportional share of the cost of a campaign activity that you participate in for both candidacies. Further, contributions should be solicited specifically for the campaign account into which they are deposited.

In response to your second question, you should determine the percentage of joint expenses which directly benefit and are attributable to each campaign. The amount of the expenditure attributable to each campaign should be included on the appropriate Receipts and Expenditures Report for each campaign account. Documentation of joint expenditures and the amounts attributable to each campaign account should be maintained in accordance with K.S.A. 25-4147 and K.A.R. 19-27-3. Pursuant to Opinion No. 2000-51, when claiming reimbursement for mileage expenditures, you must keep detailed records showing the dates of travel, the necessity for and specific purpose of the travel, and the actual mileage traveled.

Opinion No. 2006-05

Written January 19, 2006, to the Honorable Derek Schmidt, State Senator, Topeka.

This opinion is in response to your letter dated January 17, 2006, in which you request an opinion from the Kansas Governmental Ethics Commission concerning the State level governmental ethics laws, K.S.A. 46-215 et seq. We note at the outset that the Commission's jurisdiction is limited to the application of K.S.A. 46-215 et seq., and whether some other statutory system, common law theory or agency rule or regulation applies to your inquiry is not covered by this opinion.

Factual Statement

We understand that you request this opinion in your capacity as Majority Leader of the Kansas Senate. You have informed us that you have applied for The Simons Public Humanities Fellowship awarded through the Hall Center for the Humanities at the University of Kansas. The fellowship is funded by a gift from the Simons Family of Lawrence, Kansas, together with matching funds from the national Endowment for the Humanities. The fellowship is intended to give individuals the opportunity to re-engage with humanities-based learning while enhancing their career goals; and simultaneously, to invigorate the Hall Center and the University through the presence of an accomplished leader from beyond the academy. Any U.S. citizen with at least five years of professional experience

in their chosen field is eligible to apply for the fellowship. The fellowship includes a stipend of up to \$20,000 to help cover housing and other expenses for a period ranging from one month to one academic semester. You have informed us that if you are awarded this fellowship, you intend to suspend your private practice of law during the Fall 2006 academic semester to pursue your fellowship studies relating to certain aspects of the history and culture of Russia, China and India.

Question

May you accept the Simons Public Humanities Fellowship without violating State governmental ethics laws?

Opinion

K.S.A. 46-236, which limits solicitations by state legislators, states in pertinent part as follows:

No state officer . . . shall solicit any economic opportunity, gift, loan, gratuity, special discount, favor, hospitality, or service from any person known to have a special interest, under circumstances where such officer . . . knows or should know that a major purpose of the donor in granting the same could be to influence the performance of the official duties or prospective official duties of such officer . . .

K.S.A. 46-237 addresses gifts to legislators. It states in pertinent part:

(a) Except as provided by this section, no state officer . . . shall accept, or agree to accept any (1) economic opportunity, gift, loan, gratuity, special discount, favor, hospitality or service having an aggregate value of \$40 or more in any calendar year . . . from any one person known to have a special interest, under circumstances where such person knows or should know that a major purpose of the donor is to influence such person in the performance of their official duties or prospective official duties.

(b) Except as provided by this section, no person with a special interest shall offer, pay, give or make any (1) economic opportunity, gift, loan, gratuity, special discount, favor, hospitality or service having an aggregate value of \$40 or more in any calendar year . . . to any state officer . . . with a major purpose of influencing such officer . . . in the performance of official duties or prospective official duties.

K.S.A. 46-228 defines "special interest" as follows:

"Special interest" means an interest of any person as herein defined (1) concerning action or non-action by the legislature on any legislative matter affecting such person as distinct from affect upon the people of the state as a whole, or (2) in the action or non-action of any state agency or state officer or employee upon any matter affecting such person as distinct from affect upon the people of the state as a whole.

Three elements must be shown before the prohibitions in these sections apply. First, the value of the gift must be \$40.00 or greater. Second, the person giving the gift must have a special interest in the person accepting the gift. Finally, the person accepting the gift must know or should know that a major purpose of the donor is to influence such person in the performance of their official duties or prospective official duties. If any element is not met, the restrictions in the statute do not apply.

Based on the information you have provided, The Simons Public Humanities Fellowship does not have a spe-

cial interest in you. In addition, it is clear that the Fellowship is intended to provide an educational opportunity for its recipients, and there has been no evidence presented to the Commission to suggest that a major purpose in granting the Fellowship is to influence you in the performance of your official duties as a legislator. Therefore,

the Commission determines that you may accept the Fellowship without violating State governmental ethics laws.
