Notice of Hearing on Proposed Administrative Regulations

A public hearing will be conducted by the Wildlife and Parks Commission at 7 p.m. Thursday, March 13, at Memorial Hall, 120 S.W. 10th Ave., Topeka, to consider the approval and adoption of proposed administrative regulations of the Kansas Department of Wildlife and Parks.

A workshop meeting on business of the Wildlife and Parks Commission will begin at 2:30 p.m. March 13 at the location listed above. The meeting will recess at 5:30 p.m., then resume at 7 p.m. at the same location for the regulatory hearing. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business also may be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9 a.m. March 14 at the same location.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Sheila Kemmis, commission secretary, at (620) 672-5911. Persons with a hearing impairment may call the Kansas Commission for the Deaf and Hard of Hearing at (800) 432-0698 to request special accommodations.

This 30-day notice period prior to the hearing constitutes a public comment period for the purpose of receiv-

ing written public comments on the proposed administrative regulations.

All interested parties may submit written comments prior to the hearing to the chairman of the commission, Kansas Department of Wildlife and Parks, 1020 S. Kansas Ave., Suite 200, Topeka, 66612, or to sheilak@wp.state. ks.us if electronically. All interested parties will be given a reasonable opportunity at the hearing to express their views orally in regard to the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

In addition to any previously published notice, the regulation that will be heard during the regulatory hearing portion of the meeting follows:

K.A.R. 115-25-8. This exempt regulation establishes the open season, bag limit and permits for elk. The changes from the previous season include the addition of six total permits for the taking of elk.

Economic Impact Summary: The proposed amendments are not anticipated to have any appreciable negative economic impact on the department, other agencies or the public.

Notice of Proposed Change in Medicaid Reimbursement Methodology

In order to direct resources equitably towards providers that traditionally provide a high level of services to Medicaid beneficiaries and uninsured patients, to ensure access to important services that are traditionally unprofitable and to ensure adequate funding for the clinical educational programs that train future Kansas physicians, the Kansas Health Policy Authority is proposing to provide the following supplemental reimbursement:

The Kansas Health Policy Authority is proposing to change the reimbursement methodology for Medicaid-covered outpatient services provided by Large Public Teaching Hospitals. Effective February 8, 2008, Medicaid-covered outpatient claims will be paid using a hospital-specific cost-based settlement process. The KHPA anticipates a fiscal impact for federal fiscal year 2008 of approximately \$2.0 million.

The Kansas Health Policy Authority is proposing to change the reimbursement methodology for Medicaid-covered outpatient professional services provided by licensed professionals employed by Medical groups associated with the state's residency programs at Kansas public universities. Effective February 8, 2008, Medicaid-covered outpatient professional claims will be paid using an average commercial rate methodology. The KHPA anticipates a fiscal impact of \$5.0 million.

A public hearing will be conducted at 9 a.m. Monday, March 10, in Room 900-N, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612-1220, to consider the adoption of amendments to an existing rule and regulation on a permanent basis effective 15 days after publication in the Kansas Register. Telephone conference is not available.

Chapter 187, 2005 Session Laws of Kansas transferred specific powers, duties and regulatory authority from the Department of Social and Rehabilitation Services to the Division of Health Policy and Finance (DHPF) within the Department of Administration, and then transferred those powers, duties and regulatory authority to the Kansas Health Policy Authority (KHPA), effective July 1, 2006. The statutes provide that KHPA will be the single

state agency for Medicaid, Medikan and HealthWave in Kansas.

This 30-day notice of the public hearing shall constitute a public comment period for the proposed regulation as stated in K.S.A. 2007 Supp. 77-421(a)(3). Article 5.—PROVIDER PARTICIPATION, SCOPE OF SERVICES, AND REIMBURSEMENTS FOR THE MEDICAID (MEDICAL ASSISTANCE) PROGRAM

129-5-1. Prior authorization. The following changes will be made to K.A.R. 129-5-1 regarding prior authorization of pharmaceutical products: To ensure the most clinically appropriate utilization of these drugs in the most cost-effective manner, the following drugs will require prior authorization. The clinical prior authorization criteria for these drugs have been reviewed by the Drug Utilization Review Board:

Antiretroviral drugs: Selzentry®

Federal Mandate: This regulation change is not federally mandated.

Économic Impact: The reimbursement for this drug is \$15.77 per tablet and the cost for the drug at the maximum daily dose is \$63.08 per day. This drug is new to the market and it is hard to quantify a fiscal note at this time. By placing the drug on prior authorization and ensuring appropriate use, it is expected to limit the fiscal impact of this drug.

Bearer of Cost: The cost of reviewing prior authorization will be borne by KHPA. If a Medicaid consumer wishes to have a drug despite a PA denial, the cost will be borne by the consumer.

Affected Parties: Medicaid consumers, pharmacists and the Medicaid agency.

Other Methods: There were no other appropriate methods for the desired outcome.

KDHE announces two public hearings as listed below on the 2008 Kansas 303d List of Impaired Waters. Section 303d of the Clean Water Act requires states to biennially prepare a list of waters failing to meet state water quality standards. The previously developed 2006 Kansas 303d list will be incorporated into the 2008 list at the request of EPA Region VII. Additionally, such waters are required to have total maximum daily loads (TMDLs) prepared by the state to restore their water quality. A total maximum daily load is the maximum amount of the impairing pollutant that can enter the water without causing a violation of its water quality standards.

Kansas has developed TMDLs for impaired surface waters in each of the state's 12 river basins. KDHE will be addressing a second round of TMDL development in the Smoky Hill-Saline, Solomon and Upper Republican basins in state fiscal year 2009 and the third round of TMDLs in the Kansas-Lower Republican Basin in fiscal year 2010. The draft 2008 Kansas 303d list will emphasize waters in those four basins, including an initial designation of TMDLs to be developed over the next two years. The list and its methodology are available for review on the Internet at http://www.kdhe.state.ks.us/tmdl/.

Additionally, the Clean Water Act requires the states to assemble and evaluate "all existing and readily available water quality related data and information" in developing the 303(d) list. Such data include information from local, state and federal agencies, members of the public and academic institutions conducting research. This notice requests any data or information on the water quality condition of waters of the state covering the period of 2000-2007. Submitted data may include chemical, physical or biological measurements and should be accompanied by information to identify the waterbody with as much geographic specificity as possible. In order to be considered for evaluation, submissions also should ensure quality control and quality assurance of the data provided to KDHE.

The hearings will open with a brief summary of the list and its methodology as it pertains to the waters of the applicable river basin. Public testimony will then be taken after the presentation. KDHE will prepare a response to all public comments and revise the draft list as necessary and will submit the list, the methodology, the public comments and the KDHE response to Region
