**HB 2981**, An act concerning elections; concerning presentation of photographic identification at time of voting; amending K.S.A. 2007 Supp. 25-1122, 25-1123, 25-2908 and 25-3002 and repealing the existing sections, by Committee on Appropriations.

**HB 2982**, An act concerning drainage and levees; relating to excavation by drainage districts; amending K.S.A. 24-132 and repealing the existing section, by Committee on Appropriations.

A public hearing will be conducted at 9 a.m. Thursday, April 17, in the offices of the Kansas Development Finance Authority, 555 S. Kansas Ave., Suite 202, Topeka, pursuant to Section 147(f) of the Internal Revenue Code of 1986, as amended (the code), at which time any person may be heard regarding a plan to issue not to exceed \$60,000,000 aggregate principal amount of KDFA revenue bonds, in one or more series. The proceeds of the bonds will be loaned to Nexsun Ethanol, LLC, a Kansas limited liability company (the borrower), for the purpose of financing a portion of the costs of certain sewage and solid waste disposal facilities constituting industrial enterprises to be acquired, constructed and equipped (the project), in connection with the construction of the borrower's approximately 40,000,000 gallon-per-year ethanol plant located 3303 W. Oklahoma Ave., Ulysses, Kansas 67880, within an unincorporated area of Grant County, Kansas, near the city of Ulysses. The facilities being so financed, refinanced or reimbursed from proceeds of the bonds are or will be owned by the borrower.

Each bond, when issued, will be a limited obligation of the KDFA and will not constitute a general obligation or indebtedness of the state of Kansas or any political subdivision thereof, including the KDFA, nor will it be an indebtedness for which the faith and credit and taxing powers of the state of Kansas are pledged. Each bond will be payable solely from amounts received from the borrower, the obligation of which will be sufficient to pay the principal of, interest and redemption premium, if any, on each bond when it becomes due.

The above notice of public hearing is required by the code. All individuals who appear at the hearing will be given an opportunity to express their views, and all written comments previously filed with the KDFA at its offices at Suite 202, 555 S. Kansas Ave., Topeka, 66603, will be considered. Additional information regarding the project may be obtained by contacting the KDFA.

Notice of Hearing on Proposed  
Administrative Regulations

A public hearing will be conducted at 9 a.m. Monday, June 9, in the Secretary of State's Office, Garden Level Conference Room, Memorial Hall, 120 S.W. 10th Ave., Topeka, to consider proposed Kansas Administrative Regulations 7-21-1, 7-21-2, 7-21-4, 7-45-1 and 7-45-2, which pertain to elections. Also for consideration are revocations of K.A.R. 7-21-3, 7-23-13, 7-37-2 and 7-38-2, which also pertain to elections. These regulations are proposed for adoption on a permanent basis.

**K.A.R. 7-21-1.** The regulation on storage of voting machines is updated to address storage of electronic and optical scan voting equipment.

**K.A.R. 7-21-2.** The regulation removes references to on-site preparation of voting machines and instead addresses voting equipment security. The regulation requires county election officers to adopt security measures and outlines the requirements for those security measures.

**K.A.R. 7-21-4.** The regulation specifies how damaged or defective paper ballots that cannot be counted by voting equipment are to be manually counted by the county election officer.

**K.A.R. 7-45-1.** The regulation allows a county election officer to modify shifts of election board workers so as not to require all-day shifts for all board workers.

**K.A.R. 7-45-2.** The regulation authorizes and outlines requirements for oversight of poll agents by election board workers.

These regulations are expected to cause little economic impact on county election officials. Costs associated with K.A.R. 7-21-1 and K.A.R. 7-21-2 have been absorbed by county election officials who complied with their association's policy for voting equipment storage and security prior to these regulations. The cost for counties to comply with K.A.R. 7-21-1 is expected to be an average of \$1066 per county. The cost for counties to comply with K.A.R. 7-21-2 is expected to be an average of \$978 per county. The cost for counties to comply with K.A.R. 7-21-4 is expected to be an average of \$10. The cost for counties to create modified poll worker shifts pursuant to K.A.R. 7-45-1, which is optional, is expected to be an average of \$273 per county. No costs are expected to result from K.A.R. 7-45-2.

This 60-day notice of public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed regulations. Comments may be submitted prior to the hearing to Melissa A. All interested parties will be given a reasonable opportunity at the hearing to present their views. It may be necessary to request each participant to limit any oral presentation to five minutes. Any person requiring visual, hearing or other communication aid or assistance, building access assistance or other similar accommodation should contact the Secretary of State's Office so appropriate arrangements can be made.

In order to be considered in formulating a final permit decision, written comments must be received before the close of business May 5.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Christy Thurman, Bureau of Air and Radiation, not later than the close of business May 5 in order for the Secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency has a 45-day review period, which will start concurrently with the 30-day public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was im-

#### Permanent Administrative Regulations

#### Article 7.—MISCELLANEOUS PROVISIONS

**68-7-20. Shared services.** (a) (1) "Order" means either of the following:

(A) A prescription order as defined in K.S.A. 65-1626 and amendments thereto; or

(B) a medication order as defined in K.A.R. 68-5-1.

(2) "Shared order filling" means the following:

(A) Preparing, packaging, compounding, or labeling an order, or any combination of these functions, by a person authorized by the pharmacy act to do so and located at a pharmacy on behalf of and at the request of another pharmacy; and

(B) returning the filled order to the requesting pharmacy for delivery to the patient or patient's agent or, at the request of the requesting pharmacy, directly delivering the filled order to the patient.

(3) "Shared order processing" means the following order processing functions that are performed by a person authorized by the pharmacy act and located at a pharmacy, on behalf of and at the request of another pharmacy:

(A) Interpreting and entering the order; and

(B) performing drug utilization reviews, claims adjudication, refill authorizations, or therapeutic interventions, or any combination of these functions.

(4) "Shared services" means shared order filling or shared order processing, or both.

(b) Each pharmacy participating in shared services shall be registered by the board as either a resident or a non-resident pharmacy.

(c) Pharmacies may provide or utilize shared services functions only if the pharmacies involved meet the following requirements:

(1) Share a common electronic file or appropriate technology to allow access to sufficient information necessary to fill, refill, or perform shared services in conformance with the pharmacy act and the board's regulations; and

(2) (A) Have the same owner; or

(B) have a written contract outlining the services provided and the shared responsibilities of each party in complying with the pharmacy act and the board's regulations.

(d) Pharmacies engaged in shared services shall meet the following requirements:

(1) Maintain records identifying, individually for each order processed, the name of each pharmacist, technician, pharmacy student, and intern who took part in the drug utilization review, refill authorization, or therapeutic intervention functions performed at that pharmacy;

(2) maintain records identifying, individually for each order filled or dispensed, the name of each pharmacist, technician, pharmacy student, and intern who took part in the filling, dispensing, and counseling functions performed at that pharmacy;

(3) report to the board as soon as practical the results of any disciplinary action taken by another state's pharmacy board involving shared services;

(4) maintain a mechanism for tracking the order during each step of the processing and filling procedures performed at the pharmacy;

(5) maintain a mechanism to identify on the prescription label all pharmacies involved in filling the order;

(6) provide for adequate security to protect the confidentiality and integrity of patient information; and

(7) be able to obtain for inspection any required record or information within 72 hours of any request by a board representative.

(e) Each pharmacy providing or utilizing shared services shall adopt and maintain a joint policies and procedures manual that meets both of the following criteria:

(1) The manual describes how compliance with the pharmacy act and the board's regulations will be accomplished while engaging in shared services.

(2) A copy of the manual is maintained in each pharmacy.

(f) Nothing in this regulation shall prohibit an individual pharmacist licensed in Kansas who is an employee of or under contract with the pharmacy from accessing the pharmacy's electronic database from inside or outside the pharmacy and performing the order processing functions permitted by the pharmacy act, if both of the following conditions are met:

(1) The pharmacy establishes controls to protect the privacy and security of confidential records.

(2) None of the database is duplicated, downloaded, or removed from the pharmacy's electronic database. The drawing will be held soon after 6:00 p.m. on Saturday, May 17, 2008, at the Kansas lottery selling location at the Wichita River Festival in Wichita, Kansas. Rules applicable to this drawing are contained in K.A.R. 111-4-2651 through 111-4-2656 and K.A.R. 111-3-1, *et seq.* (Authorized by and implementing K.S.A. 74-8710; effective, T-111-3-14-08, Dec. 13, 2007.)

**111-4-2652. Definitions.** (a) All definitions contained in the Kansas lottery act (K.S.A. 74-8701 *et seq.*) and lottery regulations are hereby incorporated by reference and govern unless otherwise indicated.

(b) "Cougar and Cash Drawing" means the act of drawing prizes conducted by the Kansas Lottery at the 2008 Wichita River Festival in Wichita, Kansas, at the time described in K.A.R. 111-4-2654, in which one participant is selected to win various prizes as described in K.A.R. 111-4-2653.

(c) "Non-winning ticket" means any valid Kansas "Cougar and Cash" instant game lottery ticket not eligible to win a prize under the rules of the "Cougar and Cash" instant game, and for purposes of this drawing only, tickets entitled to a free admission button prize for the 2008 Wichita River Festival shall also be considered "non-winning tickets."

(d) "Receptacle" or "drum" means a container in which non-winning Kansas instant game lottery tickets are placed and from which the "Cougar and Cash Drawing" entries are drawn. Receptacles or drums may be sealable and shall be capable of being mixed or rotated for the purpose of ensuring random distribution.

**111-4-2654. Method of entry.** (a) Entry into the "Cougar and Cash Drawing" to be conducted on May 17, 2008, shall be accomplished as follows:

(1) Obtain a valid "Cougar and Cash" Kansas instant lottery ticket;

(2) Determine if the ticket is a winning ticket in accordance with "Cougar and Cash" game rules. If the ticket is a winning ticket, it is not eligible for the "Cougar and Cash Drawing" and shall be redeemed in accordance with the instant game rules, except that any ticket winning a free admission button for the 2008 Wichita River Festival may instead be used to enter the drawing, and if so utilized, shall be considered a "non-winning ticket" for purposes of entry into the drawing.

(3) If the ticket is a valid non-winning ticket, the ticket is eligible for the drawing and the holder of the ticket may use it to enter the "Cougar and Cash Drawing."

(5) A receptacle or drum shall be available and entries may be made at the Kansas lottery selling location at the Wichita River Festival between May 9, 2008, and 6:00 p.m. May 17, 2008.

(6) Players may also deposit entries for the "Cougar and Cash Drawing" at any Kansas lottery event at which the lottery has specifically designated a receptacle for deposit of said entries.

(7) Entries other than those entered at the Wichita River Festival shall be mailed with proper postage to "Cougar and Cash Drawing," P. O. Box 3561, Topeka, Kansas 66601-3561. Mailed entries must be received by morning mail pickup on Tuesday, May 13, 2008. More than one entry may be mailed in one envelope.

(8) The holder of the ticket is not required to personally attend the "Cougar and Cash Drawing" or be present at the time of the drawing to be determined a winner;

(9) The drawing will be conducted soon after 6:00 p.m. on Saturday, May 17, 2008.

(b) There is no limit on the number of entries a person may make, but a person may only win one time in the drawing.

(c) Only valid non-winning "Cougar and Cash" tickets which are mailed to the "Cougar and Cash Drawing," at the above-stated address with proper postage and received by the morning mail pickup in Topeka, Kansas,

on Tuesday, May 13, 2008, and non-winning "Cougar and Cash" tickets entered into any other receptacle designated by the lottery or at the Wichita River Festival as provided in the rules herein shall be eligible for the drawing. All tickets so mailed or deposited shall be secured by the lottery until the drawing is conducted.

(d) Eligible entrants in the "Cougar and Cash Drawing" must be 18 years of age or older.

(e) Completing the information form on the non-winning ticket and entering the ticket into the drawing constitutes authorization to publicly identify the person whose entry is drawn. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-3-14-08, Dec. 13, 2007.)

**111-4-2655. Selection of winners.** The following process shall be used for the selection of the winners in the "Cougar and Cash Drawing:"

(a) Kansas lottery personnel shall pick up all mail containing "Cougar and Cash Drawing" tickets at the United States Post Office in Topeka, Kansas, with the final pick up at the Topeka post office in the morning mail pickup on Tuesday, May 13, 2008. Following the morning mail pickup on Tuesday, May 13, 2008, the envelopes containing mailed entries will be transported to lottery headquarters and opened by lottery personnel. All mailed entries shall then be placed in a secure receptacle, transported to the Wichita River Festival, and placed in the drawing receptacle or drum with all entries deposited at the festival and into any other receptacle designated by the lottery.

(b) The drawing shall be held at the Kansas lottery selling location at the Wichita River Festival and shall be open to the public with lottery security personnel present. The drawing shall be audio and video taped.

(c) At the final drawing on Saturday, May 17, 2008, lottery security personnel will be present with the person designated by the executive director to perform the drawing. Prior to the drawing, if a drum is used, the drum shall be sealed and the contents mixed by rotating the drum at least 10 times. If a receptacle other than a drum is used, the contents shall be thoroughly mixed with a shovel or by other means.

(d) The designated individual shall then unseal the drum, if a drum is used, and using the bare-arm technique, while looking away, remove two entries, one at a time, from the receptacle or drum. The persons whose names appear on each of the two entries drawn shall be the winners of the grand prizes identified in K.A.R. 111-4-2653, subject to validation by the lottery as set forth in these rules.

(e) After two entries have been drawn on May 17, 2008, and the entries have been verified as valid, six more valid entries will be drawn, one at a time, which entries drawn will serve as alternate entries for the grand prizes. The alternate entries will be marked in order drawn, 1A, 2A, 3A, 4A, 5A, and 6A. The winners shall have until 5:00 p.m. on the thirtieth day following mailing of a claim form to the winners to present the fully-executed claim form to lottery headquarters. If either of the grand prize winners cannot be located or is declared ineligible, or fails to timely present a fully-executed claim form to lottery

*(continued)*

headquarters, the grand prize will be awarded to the first alternate entry drawn. The alternates will be used, if necessary, in the order drawn. If a winner or an alternate winner for the grand prize cannot be located, is declared ineligible, or fails to present a fully-executed claim form to lottery headquarters as required herein, the alternate winner process shall be repeated until the prize is properly claimed or until such time as no alternate winners remain, whichever occurs first.

(f) The Kansas lottery security official present shall review each ticket drawn to determine the validity of the entry into the "Cougar and Cash Drawing" in accordance with these regulations. If it is a valid entry and the name is legible, the event manager and the security person present shall record the name of the winner and the prize won. The prize winner shall be given or sent a prize claim form to be completed and returned as set forth in subsection (e) herein.

(g) If any entry drawn is determined to be ineligible, it shall be discarded by the security person present and another entry drawn. This procedure will be repeated until the required number of apparently eligible selections is obtained.

(h) Only non-winning "Cougar and Cash" instant tickets are eligible for the drawing.

(i) All "Cougar and Cash" tickets remaining in the drum or receptacle on May 17, 2008, after the winners and alternatives have been selected, and all entries not received in compliance with these rules, shall be destroyed pursuant to K.A.R. 111-3-34. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-3-14-08, Dec. 13, 2007.)

**111-4-2656. Certification of drawing.** (a) The "Cougar and Cash Drawing" shall be personally observed by a member of the Kansas lottery security department and a member of the Kansas lottery marketing department or other person or persons designated by the executive director of the lottery.

(b) Upon completion of the drawing, the security official and the event manager shall issue a report to the executive director, certifying that the name of each prize winner is correct, and that to the best of their knowledge the procedures required by these rules were followed in selecting the prize winners. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-3-14-08, Dec. 13, 2007.)

#### Article 5.—MULTI-STATE ON-LINE GAMES

**111-5-127. Definitions.** The following definitions shall apply to the "Hot Lotto" game:

(a) "Computer pick" means the random selection of two-digit numbers by the computer system, which appear on a ticket and are played by a player in the game.

(b) "Drawing" means the formal process of selecting winning numbers which determine the number of winners for each prize level of the game.

(c) "Game board" or "boards" means that area of the play slip which contains two sets of numbered squares to be marked by the player, the first set containing 39 squares, number one through 39, and the second set containing 19 squares, number one through 19.

(d) "Game ticket" or "ticket" means a computer generated ticket issued by a terminal to a person as a receipt for the combination a person has selected.

(e) "MUSL" means the Multi-State Lottery Association, a government-benefit association wholly owned and operated by the party lotteries.

(f) "MUSL Board" means the governing body of the MUSL which is comprised of the chief executive officer of each party lottery.

(g) "Multi-draw" means the optional ability for a player to purchase the same play(s) in one or more future drawings.

(h) "On-line lottery game" means a lottery game connected by telephone lines, satellite, radio, or other similar communication methodology, owned or controlled by the lottery, to a central computer in which each player selects numbers out of a larger predetermined set or sets of numbers.

(i) "Party Lottery" means a state lottery or lottery of a political subdivision or entity which has joined the MUSL and, in the context of these Powerball product group rules, which has joined in selling the Powerball game.

(j) "Product group" means the group of lotteries which has joined together to offer a product pursuant to the terms of the multi-state lottery agreement and the group's own rules.

(k) "Play" means the six numbers, the first five from a field of 39 numbers and the last one from a field of 19 numbers, that appear on a ticket as a single lettered selection and are to be played by a player in the game.

(l) "Play slip" means a card used in marking a player's game plays and containing one or more boards and if the multi-draw option is available for play, the play slip shall include a box to mark the number of draws chosen.

(m) "Retailer" or "agent" means a person or entity authorized by the Kansas lottery to sell lottery tickets.

(n) "Set Prize" means all other prizes except the grand prize that are advertised to be paid by a single cash payment and, except in rare instances, outlined in these rules, will be equal to the prize amount established by the MUSL Board for the prize level.

(o) "Terminal" means a device authorized by a party lottery to function in an on-line, interactive mode with the lottery's computer system for the purpose of issuing lottery tickets and entering, receiving and processing lottery transactions, including purchases, validating tickets and transmitting reports.

(p) "Validation" or "validate" means the process of determining whether a ticket presented for a prize is a winning ticket.

(q) "Winning numbers" means the six numbers, the first five from a field of 39 numbers and the last one from a field of 19 numbers, randomly selected at each drawing which shall be used to determine winning plays contained on a game ticket.

(r) "Sizzler" or "multiplier option" means that the "Hot Lotto" game option, whereby a player may elect to pay an additional \$1 per play at the time of ticket purchase which will have the effect of multiplying any prize won on the play, except the grand prize, by a factor of 3.

(s) These amendments shall take effect January 3, 2008. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-3-14-08, Dec. 13, 2007.)

**111-5-128. Game description; retail sale of tickets.**

(a) "Hot Lotto" is a five out of 39 plus one out of 19 online lottery game which pays the grand prize, at the election of the player made in accordance with the rules or by a default election made in accordance with these rules at the time of play purchase, either on an annuitized parimutuel basis, or as a cash lump sum payment of the total cash held for this prize on a parimutuel basis. Except as provided in these rules, all other prizes are paid on a set cash basis. To play "Hot Lotto," a player shall select five different numbers from one to 39 and one additional number from one to 19 for input into a terminal. The additional number may be the same as one of the first five numbers selected by the player.

(b) A "Hot Lotto" game ticket shall sell for one dollar.

(c) Tickets shall not be sold to any person under the age of 18 years. Each retailer may require a person purchasing tickets to produce proof of age.

(d) Each ticket shall be purchased from a terminal operated by a retailer. The player may select a set of five numbers and one additional number by:

- (1) communicating the six numbers to the retailer;
- (2) marking six numbered squares in any one or more game boards on a play slip and submitting the play slip to the retailer; or
- (3) requesting a "computer pick" or "quick pick" from the retailer.

If available at the time, a player may choose the multi-draw option by marking the appropriate box on the play slip or by communicating that desire to the retailer. If the multi-draw option is chosen, it shall apply to all boards played on that play slip. For each play upon which the multi-draw option is chosen, the player shall pay one additional dollar. The retailer shall then issue a ticket from the terminal containing the selected set or sets of numbers, each of which constitutes a game play, and if applicable, whether or not the multi-draw option has been chosen for all plays on that play slip.

(e) If available at the time, a player may choose the multiplier option by marking the appropriate box on the play slip or by communicating to the retailer the desire to play the multiplier option. If the multiplier option is chosen, it shall apply to all boards played on that play slip. For each play upon which the multiplier option is chosen, the player shall pay one additional dollar. The retailer shall then issue a ticket from the terminal containing the selected set or sets of number, each of which constitutes a game play, and if applicable, whether or not the multiplier option has been chosen for all plays on that play slip.

(f) A validated ticket shall be the only proof of a game play or plays. The only method of claiming a prize or prizes shall be the submission of the winning ticket to and receipt of the ticket by the lottery or its authorized agent. A play slip shall have no pecuniary or prize value and shall not be used as evidence of a ticket purchase or of numbers selected.

(g) A ticket shall not be voided or cancelled by returning the ticket to the selling retailer, including tickets that are printed in error.

(h) Ticket sales will end at approximately 8:59 p.m. central time on Wednesdays and Saturdays and will resume at approximately 9:05 p.m.

(i) Drawings will be conducted twice weekly, on Wednesdays and Saturdays at approximately 9:58 p.m. central time (CT), after the game is closed at approximately 8:59 p.m. central time (CT) and the external auditor has verified that the game is closed, under conditions and procedures promulgated by the executive director of the lottery.

(j) Each player shall be responsible for verifying the accuracy of the game play or plays and other data printed on the ticket. The placing of plays is done at the player's own risk through the on-line retailer who is deemed to be acting on behalf of the player in entering the play or plays.

(k) These amendments shall take effect January 3, 2008. (Authorized by K.S.A. 74-8710; implementing K.S.A. 74-8710 and 74-8718; effective, T-111-3-15-06, Feb. 15, 2006; amended, T-111-3-14-08, Dec. 13, 2007.)

**111-5-132. Prize payments; annuitized and cash prizes.**

(a) Grand prizes shall be paid, at the election of the player made no later than 60 days after the player becomes entitled to a prize with either a per winner annuity or cash payment. If the payment election is not made at the time of purchase and is not made by the player within 60 days after the player becomes entitled to the prize, then the prize shall be paid as an annuity prize. An election for an annuity payment made by a player before ticket purchase or by system default or design may be changed to a cash payment at the election of the player until the expiration of 60 days after the player becomes entitled to the prize. The election to take the cash payment may be made at the time of the prize claim or within 60 days after the player becomes entitled to the prize. An election made after the winner becomes entitled to the prize is final and cannot be revoked, withdrawn or otherwise changed. Shares of the grand prize shall be determined by dividing the cash available in the grand prize pool equally among all winners of the grand prize. Winner(s) who elected a cash payment shall be paid their share(s) in a single cash payment. The annuitized option prize shall be determined by multiplying a winner's share of the grand prize pool by the MUSL annuity factor. The MUSL annuity factor is determined by the best total securities price obtained through a competitive bid of qualified, pre-approved brokers made after it is determined that the prize is to be paid as an annuity prize or after the expiration of 60 days after the winner becomes entitled to the prize. Neither MUSL nor the party lotteries shall be responsible or liable for changes in the advertised or estimated annuity prize amount and the actual amount purchased after the prize payment method is actually known to MUSL. In certain instances announced by the product group, the grand prize shall be a guaranteed amount and shall be determined pursuant to subsection (f) of K.A.R. 111-5-28. If individual shares of the cash held to fund an annuity are less than \$250,000, the product group, in its sole discretion, may elect to pay the winners their share of the cash held in the grand prize pool of the

*(continued)*

annuity. All annuitized prizes shall be paid annually in 25 equal payments with the initial payment being made in cash, to be followed by 24 payments funded by the annuity. Annual payments after the initial payment shall be made by the lottery on the anniversary date, or if such date falls on a non-business day, then on the first business day following the anniversary date of the selection of the jackpot winning numbers. Funds for the initial payment of an annuitized prize shall be made available by MUSL for payment by a party lottery by the fifteenth calendar day following the drawing or the next banking day if the fifteenth day is a holiday. A state may elect to make the initial payment from its own funds after validation, with notice to MUSL.

(b) In the event of the death of a lottery winner during the annuity payment period, the product group, in its sole discretion, upon the petition of the estate of the lottery winner to the Kansas lottery, may accelerate the payment of all of the remaining lottery proceeds to the estate. If the product group makes such a determination, then securities and/or cash held to fund the deceased lottery winner's annuitized prize, may be distributed to the estate. The identification of the securities to fund the annuitized prize shall be at the sole discretion of the product group.

(c) All low tier cash prizes, which are all prizes except the grand prize, shall be paid in cash through the party lottery which sold the winning ticket(s). If the multiplier option is played, the prize won on that play, except for the grand prize, shall be multiplied by a factor of three. A party lottery may begin paying low-tier cash prizes after receiving authorization to pay from the MUSL central office.

(d) Annuitized payments of the grand prize or a share of the grand prize may be rounded to facilitate the purchase of an appropriate funding mechanism. Breakage on an annuitized grand prize win shall be added to the first cash payment to the winner or winners. Prizes other than the grand prize, which, under these rules, may become single-payment, pari-mutuel prizes, may be rounded down so that prizes can be paid in multiples of whole dollars. Breakage resulting from rounding these prizes shall be carried forward to the prize pool for the next drawing.

(e) If the grand prize is not won in a drawing, the prize money allocated for the grand prize shall roll over and be added to the grand prize pool for the following drawing.

(f) The product group may offer guaranteed minimum grand prize amounts or minimum increases in the grand prize amount between drawings or make other changes in the allocation of prize money where the product group finds that it would be in the best interest of the game. If a minimum grand prize amount or a minimum increase in the grand prize amount between drawings is offered by the product group, then the grand prize shares shall be determined as follows. If there are multiple grand prize winners during a single drawing, each selecting the annuitized option prize, then a winner's share of the guaranteed annuitized grand prize shall be determined by dividing the guaranteed annuitized grand prize by the number of winners. If there are multiple grand prize winners during a single drawing and at least one of the grand prize winners has elected the annuitized option prize, then the best bid submitted by MUSL's pre-approved qualified brokers shall determine the cash pool needed to fund the guaranteed annuitized grand prize. If no winner of the grand prize during a single drawing has elected the annuitized option prize, then the amount of cash in the grand prize pool shall be an amount equal to the guaranteed annuitized amount divided by the average annuity factor of the most recent three best quotes provided by MUSL's pre-approved qualified brokers submitting quotes. In no case, shall quotes be used which are more than two weeks old and if less than three quotes are submitted, then MUSL shall use the average of all quotes submitted. Changes in the allocation of prize money shall be designed to retain approximately the same prize allocation percentages, over a year's time, set out in these rules. Minimum guaranteed prizes or increases may be waived if the alternate funding mechanism set out in K.A.R. 111-5-130 becomes necessary.

(g) The holder of a winning ticket may win only one prize per board in connection with the winning numbers drawn, and shall be entitled only to the prize won by those numbers in the highest matching prize category.

(h) All prizes must be claimed within 365 days of the day of the drawing in which the prize was won.

(i) These amendments shall take effect January 3, 2008. (Authorized by K.S.A. 74-8710; implementing K.S.A. 74-8710 and K.S.A. 74-8731; effective, T-111-3-15-06, Feb. 15, 2006; amended, T-111-3-14-08, Dec. 13, 2007.)
