A public hearing will be conducted at 9 a.m. Friday, July 24, in Room 108 of the Landon State Office Building, 900 S.W. Jackson, Topeka, to consider K.A.R. 71-11-1 of the Kansas Dental Board.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed adoption of K.A.R. 71-11-1. All parties may submit written comments prior to the hearing to Betty Wright, Executive Secretary, Kansas Dental Board, Room 564-S, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612-1231, or to info@dental.state.ks.us. All interested parties will be given a reasonable opportunity to present their views orally on the proposed regulation during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the regulation and economic impact statement in an accessible format. Negotiations for Engineering Services

Notice is hereby given of the commencement of negotiations for civil engineering services for the design and reconstruction of Jayhawk Boulevard and Oread Avenue on the Lawrence campus of the University of Kansas, Lawrence. The program description calls for reconstruction of approximately 3,830 l.f. each of streets and sidewalks, replacement of utility and data lines, installation of stormwater improvements, installation of landscape and streetscape improvements, and construction of transit stops. Schematic design-level documents will be completed for the entire corridor and construction documents will be completed for Phase 1 construction.

Upon successful completion of this phase, the contract may be extended for completion of construction documents for further phases. Recognition of the historic significance of this corridor is crucial, and the consultant or consulting team will be required to demonstrate expertise in the disciplines of landscape architecture, civil engineering, landscape architectural preservation (or architectural preservation with experience in sites/landscapes) and experience in district nominations to the National Register. It is critical that all improvements within this project comply with the requirements for potential future nomination to the National Register. The total estimated cost of the project is \$7.4 million, to be constructed in phases over several years as funding becomes available.

House Bills

HB 2354, An act concerning certain claims against the state, making appropriations, authorizing certain transfers, imposing certain restrictions and limitations, and directing or authorizing certain disbursements, procedures and acts incidental to the foregoing, by Committee on Appropriations.

HB 2355, An act imposing a limitation on the issuance of certain bonds issued by the Kansas development finance authority; establishing a maximum on state general fund bonded debt; prescribing certain powers, duties and functions with respect thereto, by Committee on Appropriations.

HB 2356, An act concerning child care facilities; amending K.S.A. 65-504 and 65-512 and repealing the existing sections, by Committee on Appropriations.

HB 2360, An act concerning the state budget; relating to preparation and submission of budget estimates and recommendations by the governor to the legislature; amending K.S.A. 75-3720 and K.S.A. 2008 Supp. 75-3717, 75-3717b, 75-3718 and 75-3721 and repealing the existing sections, by Committee on Appropriations.

HB 2361, An act concerning state finance; establishing a process to evaluate and implement federal funding available for state agencies under the federal American economic recovery and reinvestment act of 2009, by Committee on Appropriations.

During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The regulations that will be heard during the regulatory hearing portion of the meeting follow:

K.A.R. 115-15-1. This permanent regulation designates the endangered and threatened species within the boundaries of the state. The proposed amendments would remove one endangered species, the Peregrine falcon; remove one threatened species, the Bald eagle; and add

three threatened species, the Delta hydrobe, the Plains minnow and the Shoal chub, from the list of species designated.

Economic impact summary: The economic impact of the proposed amendments is expected to be minimal due to a number of factors, including the current existence of other species in the same habitat that are already listed as threatened or endangered (concerning the Shoal chub and Plains minnow) and the limited geographic area (concerning the Delta hydrobe). To the extent the proposed amendments would lead to additional review of projects that would impact one of this species or its habitat, the economic impact would be anticipated to be small. State law requires a permit of such a project only if publicly funded or if a state or federal permit is already required. Of approximately 1000 to 1500 projects reviewed annually, only 20-30 require a permit, and less than 5 percent are required to perform additional mitigation. The proposed amendments would impose some cost on the department for the development and implementation of a recovery plan for the species being listed. However, the plan would be developed based on a priority list of all listed species. No other economic impact on the public or other state agencies is anticipated.

K.A.R. 115-15-2. This permanent regulation designates species in need of conservation (SINC species) within the boundaries of the state. SINC species do not receive the same level of protection as threatened or endangered species. The proposed amendments would add the Bigeye shiner, Redfin darter, Lake sturgeon, Striped shiner, Common shiner, Southern redbelly dace, Cardinal shiner and Johnny darter, and remove the Delta hydrobe and the Plains minnow from the list of SINC species.

Economic impact summary: Listing a species as a SINC species provides no special protection or permit requirements other than a prohibition on the intentional taking of such species. Therefore, the proposed amendments would not be anticipated to have an economic impact on the public or other state agencies. Adding a new SINC species would create some cost to the department for the development of a recovery plan for that species.

K.A.R. 115-25-9a. This exempt regulation establishes open season, bag limit and permits for deer. The proposed version would add an extended season in all of units 7 and 8, whereas the previous season only included a portion of units 7 and 8.

Economic impact summary: The proposed amendments are not anticipated to have any appreciable negative economic impact on the department, other agencies, small businesses or the public.

A summary of the proposed regulation and its economic impact follows:

K.A.R. 40-4-35. Medicare supplement policies; minimum standards, requirements. This regulation is being amended to update the existing regulation on Medicare supplement insurance. K.S.A. 40-2221 requires the Commissioner of Insurance to adopt standards equal to or exceeding the minimum standards and requirements permitted by Section 1395ss (b) of the federal Social Security Act (42 U.S.C. § 1395 et seq.). Section 1395ss (b) provides, in part, that the Secretary of Health and Human Services ("secretary") must approve a state's standards if they meet or exceed the standards and requirements promulgated by the National Association of Insurance Commissioners ("NAIC"). The consequence of failure to obtain approval of the standards adopted by Kansas is the transfer of regulatory power over Medicare supplement insurance to the federal government. K.A.R. 40-4-35 currently adopts by reference the NAIC Model Regulation promulgated in 2004. This proposed amendment to 40-4-35 would update the Kansas regulation by adopting by reference the 2008 "Policy and Procedure to Implement Medicare Supplement Insurance Minimum Standards" ("2008 Model Regulation") of the NAIC.

The proposed regulation is mandated by federal law.

The proposed amendment will have no economic impact on insurance companies because they are already complying with the requirements set forth in the 2008 Model Regulation. Likewise, it will have no economic impact on government agencies, regulated entities, large or small businesses or the general public.

The proposed amendment to K.A.R. 40-4-35 achieves the stated purpose of complying with the mandate of K.S.A. 40-2221 by adopting the current standards and requirements of the NAIC 2008 Model Regulation. The only alternative would be to draft standards equal to or exceeding those set forth in the 2008 NAIC Model Regulation and obtain a waiver from the secretary of adoption of the 2008 NAIC Model Regulation. That process was not considered because Kansas had adopted the 2004 NAIC Model Regulation and companies were already complying with it. The alternative would have resulted in a more costly process of amendment and supervision of compliance. The standards and requirements of the 2008 NAIC Model Regulation meet the needs of Kansas.

A public hearing will be conducted at 9 a.m. Wednesday, May 13, in the third floor hearing room at 1500 S.W. Arrowhead Road, Topeka, to consider the adoption of proposed regulations 82-11-4 and 82-11-10.

This 60-day notice of public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed regulations. All interested parties may submit written comments prior to the hearing to Colleen R. Harrell, Litigation Counsel, State Corporation Commission, 1500 S.W. Arrowhead Road, Topeka, 66604. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statement in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Colleen Harrell at (785) 271-3138 or TTY (Kansas Relay Center) at (800) 766-3777. Copies of the regulations may be obtained by contacting Colleen Harrell. A summary of the proposed regulations follows:

82-11-4. Transportation of natural and other gas by pipeline; minimum safety standards. This regulation adopts by reference the federal rules and regulations found at 49 C.F.R. Part 192, with the enumerated exceptions. The modifications to this regulation are minor and nonsubstantive in nature.

82-11-10. Drug and alcohol testing. This regulation adopts 49 C.F.R. Part 199 concerning drug and alcohol testing, with the enumerated modifications and exceptions.

Economic impact statement summary: The proposed regulations are mandated by federal law as a requirement for participating in a federally subsidized or assisted program. The commission receives approximately 45 percent of the Pipeline Safety operating budget as a grant from the U.S. Department of Transportation. Under 49 USC §60105(a), Kansas submits an annual certification to the USDOT that allows Kansas law to supersede the jurisdiction of the USDOT for intrastate pipeline safety standards. The adoption of these regulations is not expected to increase costs to the commission, other governmental agencies, private entities including natural gas companies, any private citizen or consumer of natural gas. The update of the Kansas additions to the federal regulations is expected to lessen the burden on the regulated community by focusing the cost of compliance on areas considered to have a higher safety risk.

Article 72.—NATUROPATHY

100-72-7. Registration renewals; continuing education. (a) Each registration initially issued or renewed by the board on or after January 1, 2009 and through December 31, 2009 shall expire on December 31, 2010.

(b) Each registration initially issued or renewed by the board on or after January 1, 2010 shall expire on December 31 of the year of issuance.

(c) Each registered naturopath who wishes to renew the registration shall meet the following requirements:

(1) Submit an application for renewal of registration and the registration renewal fee; and

(2) for the second and each subsequent renewal and for each renewal after reinstatement, submit evidence of satisfactory completion of at least 50 hours of continuing education since the registration was last renewed or was reinstated, whichever is more recent. At least 20 of these hours shall be taken in a professionally supervised setting, and not more than 30 of these hours may be taken in a non-supervised setting.

(d) Continuing education activities shall be designed to maintain, develop, or increase the knowledge, skills, and professional performance of persons registered to practice as a naturopathic doctor. All continuing education shall deal primarily with the practice of naturopathy. Each continuing education activity that occurs in a professionally supervised setting shall be presented by a provider.

(e) One hour shall mean 60 minutes of instruction or the equivalent.

(f) The content of each continuing education activity shall have a direct bearing on patient care.

(g) An activity occurring in a "professionally supervised setting" shall mean any of the following:

(1) Lecture, which means a discourse given before an audience for instruction;

(2) panel discussion, which means the presentation of a number of views by several professional individuals on a given subject;

(3) workshop, which means a series of meetings designed for intensive study, work, or discussion in a specific field of interest;

(4) seminar, which means directed, advanced study or discussion in a specific field of interest;

(5) symposium, which means a conference that consists of more than a single session and is organized for the purpose of discussing a specific subject from various viewpoints and by various speakers; or

(6) other structured, interactive, and formal learning methods approved by the board on a case-by-case basis.

(h) An activity occurring in a "non-supervised setting" shall mean any of the following:

(1) Teaching health-related courses to practicing naturopathic doctors or other health professionals;

(2) presenting a scientific paper to an audience of health professionals, or publishing a scientific paper in a medical or naturopathic journal;

(3) engaging in self-instruction, including journal reading and the use of television and other audiovisual materials;

(4) receiving instruction from a medical or naturopathic consultant;

(5) participating in programs concerned with review and evaluation of patient care;

(6) spending time in a self-assessment examination, not including examinations and quizzes published in journals; or

(7) engaging in meritorious learning experiences that provide a unique educational benefit to the registrant.

(i) To provide evidence of satisfactory completion of continuing education, each registrant shall submit the following to the board, as applicable:

(1) Documented evidence of attendance at each activity occurring in a professionally supervised setting; and

(2) proof of participation in each activity occurring in a non-supervised setting, which shall include a copy of any professional publication, the certification of a teaching activity, or the personal verification of any other activity occurring in a non-supervised setting. (Authorized by K.S.A. 65-7203; implementing K.S.A. 2007 Supp. 65-7209; effective, T-100-1-2-03, Jan. 2, 2003; effective Nov. 14, 2003; amended March 27, 2009.)

111-7-239. Prize. (a) Each of the four grand prize winners selected in the "Keno Madness Drawing" on the date specified in K.A.R. 111-7-238 shall receive two tickets for each game of the men's national college basketball championship games on or about April 4 and 6, 2009, in Detroit, Michigan, one double occupancy hotel room and room taxes for the nights on or about April 3, 4, 5, and 6, 2009, round trip airline transportation from Kansas City, Missouri, to Detroit, Michigan, \$5,000 cash, and mandatory state and federal income withholding taxes.

(b) Four secondary prize winners shall each receive two tickets for each game of the first and second round of the men's regional basketball tournament on or about March 19, 20, and 21, 2009, in Kansas City, Missouri, one double occupancy hotel room and room taxes for the nights on or about March 18, 19, 20, and 21, 2009, \$2,000 cash, and mandatory state and federal income withholding taxes. The following restrictions shall apply to the "Keno Madness Drawing" prize packages:

(c) The Kansas lottery is not responsible for any losses caused by delay or cancellation of any of said basketball games.

(k) No later than 5:00 p.m. on the fourteenth calendar day following the drawing, each winner of a prize as the result of the "Keno Madness Drawing" shall return to the lottery a completed claim form as provided by the lottery or the person named on the entry drawn will no longer be eligible for the prize. In such an event, the first eligible alternate entry drawn pursuant to K.A.R. 111-7-241(f) and (g) shall be declared the winner. All alternate winners

shall then be subject to the same rules of eligibility as original winners.

(l) A total of four grand prize packages and four secondary prize packages shall be awarded. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-2-20-09, Nov. 12, 2008.)

111-7-240. Method of entry. (a) Entry into the "Keno Madness Drawing" shall be accomplished as follows:

(3) Place one or more entry form(s) into an envelope with proper postage and mail it to: "Keno Madness Drawing" c/o Kansas lottery, P. O. Box 3561, Topeka, Kansas 66601-3561. Mailed entries must be received by morning mail pickup on Tuesday, February 10, 2009.

(4) No later than 5:00 p.m. CDT on Tuesday, February 10, 2009, players may also enter this drawing in any manner the Kansas lottery has specifically designated for deposit of said entries.

(5) The holder of the ticket is not required to personally attend the drawing or be present at the time of the drawing to be determined a winner.

(6) Eight entries and five alternate entries will be drawn.

(7) Entry forms obtained during the stated period of time may be entered in the drawing.

(b) There is no limit on the number of entries a person may make, but a person may only win one prize package.

(c) All eligible entry forms which are mailed and received by the morning mail pickup in Topeka, Kansas, on Tuesday, February 10, 2009, shall be entered into the drawing to be conducted on Friday, February 13, 2009.

(d) Eligible entrants in the "Keno Madness Drawing" must be 18 years of age or older.

(e) Completing the information form on the entry form and entering the ticket into any drawing constitutes authorization to publicly identify the person whose entry is drawn. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-2-20-09, Nov. 12, 2008.)

111-7-241. Selection of winners. The following process shall be used for the selection of winners in the "Keno Madness Drawing":

(a) Kansas lottery personnel shall pick up all mail containing "Keno Madness Drawing" entries at the United States Post Office in Topeka, Kansas, with final pickup for the drawing after the morning mail delivery on Tuesday, February 10, 2009, prior to the drawing on Friday, February 13, 2009.

(b) Only valid entry forms which are mailed and received by the lottery as provided by these rules and entry forms entered into any other receptacle or manner designated by the lottery as provided in the rules herein shall be eligible for the drawing. All entries so mailed or de-

posited shall be secured by the lottery until the drawing is conducted.

(c) Lottery personnel shall transport the mail to the Kansas lottery mail room where the envelopes will be opened, emptied, and all entries will be placed into the drawing receptacle or drum.

(d) The drawing shall be held at a place designated by the executive director of the Kansas lottery which is reasonably accessible to the public and open for public attendance with lottery security personnel present. The drawing shall be audio and video taped.

(e) At the start of the drawing, lottery security personnel shall present the receptacle or drum to the person designated by the executive director to perform the drawing. The receptacle or drum for the drawing shall contain all entries eligible for the drawing. The drum shall be rotated 10 times or receptacle mixed thoroughly as may be applicable. The designated individual shall then unseal the receptacle or drum, and using the bare-arm technique, while looking away, remove four valid entries, one at a time, from the receptacle or drum, and mark them in the order drawn, 1, 2, 3, and 4. The person whose name appears on each entry marked 1, 2, 3, and 4, will be the winner of one of the grand prize packages identified in K.A.R. 111-7-239(a), subject to validation by the lottery as set forth in these rules. These entries shall be marked as the grand prize winners.

(f) After the said grand prize entries have been drawn, and the entries have been verified as valid, four more entries will be drawn, one at a time. The person whose name appears on each entry shall be the winner of one of the second prize packages identified in K.A.R. 111-7-239(b), subject to validation by the lottery as set forth in these rules. Entries will be marked in the order drawn, 1, 2, 3, and 4 and otherwise identified as having been selected for the applicable drawing. If any of the grand prize winners cannot be located, are declared ineligible, or fail to timely present a fully-executed claim form to lottery headquarters, the next selected second prize winner for this drawing shall be declared a grand prize winner, subject to the claim procedure as set forth in these rules. If a second prize winner cannot be located, is declared ineligible, or fails to timely present a fully-executed claim form to lottery headquarters, or is elevated to be the grand prize winner, the next selected second prize winner shall be declared the winner, subject to the claim procedure as set forth in these rules. The second prize winners will be used, if necessary, in the order drawn. If a second prize winner cannot be located, is declared ineligible, or fails to timely present a fully-executed claim

form to lottery headquarters, the process shall be repeated until the prize is properly claimed or until such time as no winners remain, whichever occurs first.

(g) After the grand prize entries and second prize entries have been drawn, and the entries have been verified as valid, five more entries will be drawn, one at a time, to serve as alternate entries. The alternate entries will be marked in the order drawn, 1A, 2A, 3A, 4A, and 5A. The alternate ticket entries will be used only if one or more of the original winners cannot be located or are declared ineligible, or fail to present a fully-executed claim form to lottery headquarters as required by K.A.R. 111-7-239(k). The alternates will be used, if necessary, in the order drawn.

(h) The Kansas lottery security official present shall review each entry drawn to determine the validity of the entry into the "Keno Madness Drawing" in accordance with these regulations. If it is a valid entry and the name is legible, the event manager and the security person present shall record the name of the winner. Each winner shall be given or sent a prize claim form to be completed and returned to the lottery within 14 calendar days of the drawing.

(i) If the entry is determined to be ineligible, it shall be discarded by the security person present and another entry drawn. This procedure will be repeated until valid selections are obtained.

(j) All "Keno Madness Drawing" entries remaining in the drum or receptacle after the winners have been selected and certified and all entries not received in compliance with these rules shall be destroyed pursuant to K.A.R. 111-3-34. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-2-20-09, Nov. 12, 2008.)

111-7-242. Certification of drawing. (a) The "Keno Madness Drawing" shall all be personally observed by a member of the Kansas lottery security department and a member of the Kansas lottery marketing department or other person or persons designated by the executive director of the lottery (hereinafter "event manager").

(b) Upon completion of the drawing, the security official and the event manager shall issue a report to the executive director, certifying that the name of each prize winner is correct, and that to the best of their knowledge the procedures required by these rules were followed in selecting each prize winner. (Authorized by and implementing K.S.A. 74-8710; effective, T-111-2-20-09, Nov. 12, 2008.)
