**Notice of 2014 WTAP Enrollment**

The Kansas Department of Agriculture, Division of Conservation, will accept applications under the Water Right Transition Assistance Program (WTAP) during the 2014 enrollment period of October 1-November 15.

WTAP is a voluntary, incentive-based program that permanently retires privately held irrigation water rights in exchange for payment by the state of Kansas. It is intended to help restore aquifers and recover stream flows in critically depleted target areas. The 2012 Kansas Legislature extended WTAP until June 30, 2022, based on past results of the initial pilot project. The target areas currently designated include Rattlesnake Creek Sub-basin, Prairie Dog Creek Basin, and six "high priority areas" of Northwest Kansas Groundwater Management District No. 4. The WTAP rules and regulations, target area maps, application forms and other details are posted on the Division of Conservation website at <http://agriculture.ks.gov/divisions-programs/division-of-conservation/water-conservation-programs>.

WTAP bids cannot be approved by the Division of Conservation for more than \$2,000 per acre-foot of the Historic Consumptive Water Use as calculated over the last 10 years of actual annual water use of the water

right(s) proposed for acceptance. WTAP grants can be combined with other federal or local water conservation programs that offer financial incentives. Applications to accept partial water rights also can be considered. The award of WTAP grants for water right retirements is based on a competitive bidding process. Applications that propose a financial contribution from a local entity may increase the priority of an application.

Eligible applicants are community mental health centers (CMHC) and regional recovery centers (RRC).

Congress increased FY 2014 funds to the Mental Health Block Grant (MHBG) state programs by 5 percent, and required the new funds be applied to early SMI interventions. The funding is to be dedicated to provide supports and services for those with "early serious mental illness" and not for primary prevention or preventive interventions for those at risk of serious mental illness. Funding will be used to build a Coordinated Specialty Care (CSC) Early Intervention Team (EIT) to support early detection and intervention. The EIT will support meeting the needs of persons with early psychotic disorders, specifically first episode psychosis between the ages of 15 to 25. Early intervention programs are designed to bridge existing services for these groups and eliminate gaps between child, adolescent and adult mental health programs.

Funds shall be used solely for the development of a community or regional EIT that will support prevention of psychotic disorders by early detection and intervention. The EIT design should include early intervention, coordinated specialty care and a team-based approach. Component interventions should include intensive case management, individual or group psychotherapy, supported employment, education services, family education and support, and low doses of select antipsychotic agents. EIT will support meeting the needs of persons with early psychotic disorders, specifically first episode psychosis, for individuals between the ages of 15 to 25. The proposal should describe how funds will be utilized to meet the needs specific to the above-mentioned targeted population.

These regulations will set in place the 2015 criteria changes as established by the Appraisal Standards Board, an independent board of The Appraisal Foundation, which, under the provisions of Title XI of the Financial Institutions Reform, Recovery and Enforcement Act of 1989 (FIRREA), establishes the minimum education, experience and examination requirements for real property appraisers to obtain a state license/certification.

**117-2-1. Licensed classification; education requirements.** There will be an economic impact as follows: Public-applicants seeking to secure a state license classification will be required to meet a minimum 30 hours of college-level education. Area colleges vary greatly in their costs per credit hour, but an average of \$250 per hour would increase the cost to a new applicant by \$7,500. Real Estate Appraisal Board: It is anticipated that there will be a decrease in the number of applications received annually (\$50 per application); however, no statistics are available on which to estimate a total loss. There will be no economic impact to appraisers, other governmental agencies or units.

**117-2-2. State licensed real property appraiser classification; appraisal experience requirement.** There will be an economic impact to the public in that the addition of a required supervisor/trainee course will increase the cost of pre-license education. At approximately \$20 per hour

and the average course running seven hours in length, the cost is estimated to be \$140 per trainee. There will be no economic impact to appraisers, this agency, or other governmental agencies or units.

**117-2-2a. Licensed classification; experience supervision requirements.** Although supervisors will be required to complete the supervisor/trainee course, it is a one-time cost and each supervisor completing the course may use it to meet a portion of their biennial continuing education requirement. There is no economic impact to the public, appraisers, this agency, or other governmental agencies or units.

**117-2-3. Licensed classification; examination requirement.** There will be no economic impact to the public, appraisers, this agency, or other governmental agencies or units.

**117-3-2a. There will be no economic impact to the public, appraisers, this agency, or other governmental agencies or units.

**117-4-1. Residential classification; education requirements.** The increase from an associate's degree to a bachelor's degree will increase the cost of the college-level education requirement. ### Agricultural Remediation Board

#### Notice of Hearing on Proposed Administrative Regulation

The Kansas Agricultural Remediation Board will conduct a public hearing at 10 a.m. Thursday, December 4, in the conference room of the Tom R. Tunnell Building, 816 S.W. Tyler, Topeka, to consider the adoption of a proposed amended regulation.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rule and regulation. All interested parties may submit written comments prior to the hearing to the chairman of the board, 816 S.W. Tyler, Topeka, 66612, or by email at [randy@kansasag.org](mailto:randy@kansasag.org). During the hearing, all interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulation. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Copies of the regulation and the economic impact statement may be obtained by contacting Randy Stookey at 785-234-0461. The regulation is proposed for adoption on a permanent basis.

#### Summary of the proposed regulation:

**K.A.R. 125-1-7. Eligible corrective action costs; exclusions.** In order for the board to satisfy the purpose of the remediation reimbursement program of reimbursing eligible parties for agricultural remediation expenses, the proposed amendment limits the total amount of reimbursement from the agricultural remediation fund for any one site to \$200,000, except that if the property has been sold or leased and both the buyer and seller (or lessee and lessor) are responsible for the site remediation costs, then the total amount of reimbursement shall be limited to \$400,000. Grammatical amendments were requested by

the Department of Administration and the attorney general's office to bring the regulation in line with current customs and usage.

**Economic impact upon the Kansas Agricultural Remediation Board:**

The proposed changes will likely increase administrative costs required to reimburse additional applicants from the agricultural remediation fund.

**Economic impact upon other governmental agencies, private business or individuals:**

The proposed changes will have no fiscal impact upon other governmental agencies. The proposed changes to K.A.R. 125-1-7 will have a positive impact on all applicants to the fund that would not have otherwise received reimbursement for costs associated with ag-chemical environmental remediation efforts, as the limited amount of money in the fund will be paid out to a greater number of applicants. This will provide additional applicants with the necessary funds to continue their environmental remediation efforts, furthering the purpose of the agricultural and specialty chemical remediation act. The proposed changes to K.A.R. 125-1-7 may have a negative impact on any applicant who has already received \$200,000 from the fund and will not be eligible for further reimbursement.

Individuals with a disability may request accommodation in order to participate in the public hearing. Such requests should be made at least five working days before the hearing by contacting Randy Stookey.

(f) "Bonus Cash Crossword" consists of two separate games. The "Crossword" game appears in the upper part of the ticket where there is a crossword puzzle grid that contains 11 spaces (height) by 11 spaces (width) covered by transparent latex. In the "YOUR LETTERS" play area, located in the lower part of the ticket, there are 18 letters located under opaque latex. Imaged around each of the 18 "YOUR LETTERS" there will be a four-sided box composed of solid lines. A player will remove the latex from the "YOUR LETTERS" play area one letter at a time, and then for each matching letter in the crossword puzzle grid scratch off the transparent latex. Each letter revealed in the "YOUR LETTERS" play area may be used an unlimited number of times in the crossword puzzle grid. If a player reveals at least two complete words in the crossword puzzle grid, the player wins the corresponding prize in the prize legend shown on the front of the ticket. The prize legend on the front of the ticket indicates prizes won for number of words revealed.

In the "BONUS" game at the bottom of the ticket, the player will scratch the play area to reveal three symbols. If the player reveals three identical symbols, the player wins \$25 instantly.

(g) To qualify as a complete word to win a prize in this game, the words revealed must meet the following requirements:

- (1) must contain at least three letters;

**Article 15.—RAFFLE GAMES**

**111-15-1. Name of the game; rules and regulations.** The Kansas lottery may conduct a lotto game entitled "Holiday Millionaire Raffle" beginning at 5:00 a.m. September 5, 2014, for a drawing to be conducted on December 31, 2014.

The rules and regulations for the "Holiday Millionaire Raffle" game are contained in K.A.R. 111-15-1 through 111-15-11 and K.A.R. 111-15-21, and applicable generic rules are contained in K.A.R. 111-6-1 *et seq.* (Authorized by and implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-10-8-09, Sept. 9, 2009; amended, T-111-12-7-10, Sept. 8, 2010; amended, T-111-10-12-11, Sept. 14, 2011; amended, T-111-10-18-12, Sept. 12, 2012; amended, T-111-11-6-13, Sept. 11, 2013; amended, T-111-9-4-14, Aug. 13, 2014.)

**111-15-2. Definitions.** The following definitions shall apply to the "Holiday Millionaire Raffle" game:

(a) "Available ticket(s)" or "ticket(s) available for sale" means one or any number of tickets from one through 175,000 that is available to sell during the "Holiday Millionaire Raffle" game.

(b) "Check-A-Ticket Machine" means an electronic machine operated by the Kansas lottery for the purpose of determining whether or not an online ticket is a winning ticket.

(c) "Computer pick" or "quick pick" means the selection of a six-digit number by the computer system, which appears on a ticket and is played by a player in the game. This is the only type of ticket sold by a retailer for the game.

(d) "Drawing" means the formal process of selecting winning numbers which determine the number of winners for each prize level of the game.

(e) "Early Bird Drawings" means a series of drawings for prizes to be held on October 12, 19, and 26, 2014, and November 2 and 9, 2014, before final raffle drawings on December 31, 2014.

(f) "Electronic drawing machine" or "random number generator" means the electronic device approved by the executive director of the Kansas lottery to electronically select the winning numbers for this drawing.

(g) "Game ticket" or "ticket" means a computer generated ticket issued by a terminal to a person as a receipt for the ticket a person has purchased.

(h) "Online lottery game" means a lottery game connected by telephone lines, satellite, radio, or other similar communication methodology, owned or controlled by the lottery, to a central computer in which each player selects numbers out of a larger predetermined set or sets of numbers.

(i) "Order drawn" means the sequential order in which a "WINNING" ticket or tickets are selected during the drawing process.

(j) "Pari-mutuel prize" means all prizes that are advertised to be paid by a single cash payment as outlined in these rules, shall be paid on a pari-mutuel basis as a cash



lump sum payment of the total cash held for all tickets sold in this game.

(k) "Retailer" or "agent" means a person or entity authorized by the Kansas lottery to sell lottery tickets.

(l) "Serial number" means the identifying number printed on the top line of the ticket.

(m) "Set Prize" means all prizes that are advertised to be paid by a single cash payment as outlined in these rules, and which will be equal to the prize amount established by these rules for the prize level.

(n) "Terminal" means a device authorized by a party lottery to function in an online, interactive mode with the lottery's computer system for the purpose of issuing lottery tickets and entering, receiving and processing lottery transactions, including purchases, validating tickets and transmitting reports.

(o) "Ticket Number" means the six-digit number that was selected by the computer, which appears on the face of the ticket and is identified on the ticket as such.

(p) "Validation" or "validate" means the process of determining whether a ticket presented for a prize is a winning ticket.

(q) "Winning number" or "winning numbers" means a six-digit number which is selected by an electronic drawing machine to be a winner of a prize in this drawing.

(r) "Winning ticket" or "winning tickets" means a raffle ticket which was available for sale for this game where the ticket number matches a winning number drawn for the raffle, in exact order, reading from left to right. (Authorized by and implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-10-8-09, Sept. 9, 2009; amended, T-111-10-12-11, Sept. 14, 2011; amended, T-111-10-18-12, Sept. 12, 2012; amended, T-111-11-6-13, Sept. 11, 2013; amended, T-111-9-4-14, Aug. 13, 2014.)

**111-15-3. Game description; retail sale of tickets.**

(a) "Holiday Millionaire Raffle" is a raffle drawing which offers a total of 175,000 online tickets available for sale. Each ticket shall bear a "TICKET NUMBER" on the face of the ticket. The Kansas lottery will conduct five "Holiday Millionaire Raffle Early Bird Drawings" according to the following schedule, unless otherwise determined by the executive director:

For each early bird drawing, two ticket numbers will be drawn to determine the winners of each individual \$10,000 early bird drawing prize. A ticket must be purchased before 8:59 p.m. the day of the early bird drawing to be eligible for that drawing. In the event a ticket wins a prize in an early bird drawing, the ticket will remain eligible for any remaining drawings, including the final drawing held on December 31, 2014. For the final drawing, an electronic drawing machine, which has been approved by the executive director of the Kansas lottery, shall randomly select a total of 2,551 "WINNING NUM-

BERS." Each "WINNING NUMBER" consists of a six-digit number as it appears in exact order reading from left to right. A player wins by exactly matching his or her "TICKET NUMBER" to a "WINNING NUMBER" that was selected in the drawing. The first "WINNING NUMBER" selected during the drawing process shall be the grand prize winner. The second (2<sup>nd</sup>) through twenty-sixth (26<sup>th</sup>) "WINNING NUMBERS" selected during the drawing process shall be the second prize winners. The next 25 "WINNING NUMBERS" selected during the drawing process, which shall be drawn in the order of the twenty-seventh (27<sup>th</sup>) "WINNING NUMBER" through the fifty-first (51<sup>st</sup>) "WINNING NUMBER," shall be the third prize winners. The next 2,500 "WINNING NUMBERS" selected during the drawing process, which shall be drawn in the order of the fifty-second (52<sup>nd</sup>) "WINNING NUMBER" through the two thousand five hundred fifty-first (2,551<sup>st</sup>) "WINNING NUMBER," shall be the fourth prize winners. If 169,000 of the 175,000 tickets that are available for sale are sold, all prizes shall be paid as a cash lump sum payment. If less than 169,000 tickets available for sale are sold, all prizes may be paid on a pari-mutuel basis as a cash lump sum payment of the total cash held for all tickets sold in this game. To play the "Holiday Millionaire Raffle," a player shall purchase a "Holiday Millionaire Raffle" ticket which bears a ticket number on the face of the ticket.

(b) A "Holiday Millionaire Raffle" ticket shall sell for \$20 (twenty) dollars.

(c) Tickets shall not be sold to any person under the age of 18 years. Each retailer may require a person purchasing tickets to produce proof of age.

(d) Each ticket shall be purchased from a terminal operated by a retailer.

(e) All tickets sold by a retailer shall be a "computer pick" or "quick pick" ticket.

(f) A validated ticket shall be the only proof of a game play. The only method of claiming a prize or prizes shall be the submission of the original winning ticket to and receipt of said ticket by the lottery or its authorized agent.

(g) The only guaranteed methods of win checking a ticket to determine whether the ticket bears a winning number shall be through the Kansas lottery check-a-ticket machines, or submission of a ticket to the Kansas lottery or an authorized retail agent.

(h) A ticket shall not be voided or cancelled by returning the ticket to the selling retailer, including tickets that are printed in error. Exchange tickets may be printed by the lottery for early bird drawing winners at the discretion of the executive director.

(i) There shall be a total of 175,000 available tickets for sale.

(j) Ticket sales will begin at 5:00 a.m. central time on September 5, 2014.

(k) Ticket sales will end at 2:00 a.m. central time on December 31, 2014, or whenever all 175,000 tickets that are available for sale are sold, whichever comes first.

(l) The game will officially close at 4:30 a.m. on December 31, 2014.

(m) The drawing shall be conducted by December 31, 2014, before noon central time, at a secure location as de-

terminated by the executive director, after the game is closed and the drawing official has verified that the game is closed, under conditions and procedures promulgated by the executive director of the lottery.

(n) Each player shall have the sole responsibility for verifying the accuracy and condition of the data printed on the ticket. The purchase of a ticket is done at the player's own risk through the online retailer who is deemed to be acting on behalf of the player in entering the play or plays.

(o) For any reason or under any circumstance, the liability of the Kansas lottery or its agents shall be strictly limited to a refund of the amount of the ticket purchase price.

(p) Winning ticket numbers shall be made available to the public on or about noon, December 31, 2014. (Authorized by K.S.A. 2013 Supp. 74-8710; implementing K.S.A. 2013 Supp. 74-8710 and 74-8718; effective, T-111-10-8-09, Sept. 9, 2009; amended, T-111-12-7-10, Sept. 8, 2010; amended, T-111-12-29-10, Dec. 9, 2010; amended, T-111-10-12-11, Sept. 14, 2011; amended, T-111-10-18-12, Sept. 12, 2012; amended, T-111-11-6-13, Sept. 11, 2013; amended, T-111-4-4-14, Dec. 11, 2013; amended, T-111-9-4-14, Aug. 13, 2014.)

**111-15-5. Expected prize payout.** (a) In the event 169,000 or more of the tickets available for sale in this raffle game are sold, all prizes awarded shall be paid as set lump-sum prizes, with the following expected approximate prize payout amounts:

(b) In the event less than 169,000 tickets available for sale in this raffle game are sold, all prizes awarded as described in subsection (a) above may be paid as pari-mutuel prizes, as a lump-sum payment of the total cash held for all tickets sold in this game. In that instance, the money available from the funding sources for this game shall be divided among the winning tickets/plays in proportion to their respective prize percentages. Any pari-mutuel prizes awarded shall be calculated rounding down to the nearest dollar. Monies left over after prizes have been rounded down shall be applied to the general prize reserve pool for subsequent lottery games. **111-15-8. Claiming prizes; procedure and time period.** (a) Prior to the payment of any prize, each ticket shall be validated by the retailer or lottery office pursuant to this act.

(b) The procedures for payment of a "Holiday Millionaire Raffle" prize on any single game ticket of \$599 or less are as follows:

(1) The claimant of a ticket purchased in Kansas may present the ticket to any Kansas lottery online retailer. Upon validation of the ticket, the retailer shall immediately make payment for the prize to the claimant. If the retailer cannot validate the ticket, the claimant shall fill out a claim form provided by the retailer and personally present or mail the completed form, together with the ticket, to any office of the Kansas lottery. If the ticket is validated, then payment shall be made to the claimant by mail.

(2) The claimant may bring the ticket to any office of the Kansas lottery during the hours that the office is open to the public for business. Upon validation of the ticket, and completion of a claim form, payment shall be processed for the claimant.

(3) The claimant may mail the ticket with a completed claim form in any envelope to any office of the Kansas lottery. Claim forms may be obtained from any lottery retailer, any office of the Kansas lottery, or the Internet. Upon receipt of the ticket and completed claim form and validation of the ticket, payment shall be processed for the claimant.

If any evidence of alteration, mutilation, tear, or other ambiguity appears on the ticket, the retailer shall not make direct payment of a prize. The claimant shall submit a claim form with the ticket to the lottery.

(c) The procedure for the payment of a "Holiday Millionaire Raffle" prize on any single game ticket which totals \$600.00 or more shall be as follows:

(1) The claimant may bring the signed ticket to any office of the Kansas lottery during the hours that the office is open to the public for business. Upon validation of the ticket and completion of a claim form, payment shall be processed for the claimant.

(2) The claimant may mail the ticket with a completed claim form to any office of the Kansas lottery. Claim forms may be obtained from any lottery retailer, any office of the Kansas lottery, or via the Internet. Upon receipt of the ticket and completed claim form and validation of the ticket, payment shall be processed for the claimant.

(d) Although tickets and claim forms may be presented or mailed to any Kansas lottery office, such prizes may only be paid by lottery headquarters.

(e) All prizes shall be claimed within 365 days of the drawing in which the prize was won. Any prize or prizes not claimed within the time specified shall be forfeited. If a prize is claimed by mail, the ticket and claim form must actually be received by the lottery within the claim period. (Authorized by K.S.A. 2013 Supp. 74-8710; implementing K.S.A. 2013 Supp. 74-8710 and 74-8720; effective, T-111-10-8-09, Sept. 9, 2009; amended, T-111-9-4-14, Aug. 13, 2014.)

**111-15-21. Instant win cash prizes.** The Kansas lottery shall offer all Kansas lottery players purchasing a Holiday Millionaire raffle ticket the chance to win a \$50 cash prize (up to 5,000 winners based on sell out) instantly. Beginning with the sale of "Holiday Millionaire" raffle tickets at 5:00 a.m. central time on September 5, 2014, through the close of sales at 2:00 a.m. on December 31, 2014, every thirty-fifth (35<sup>th</sup>) Holiday Millionaire raffle ticket sold amongst all selling Kansas lottery locations throughout the state of Kansas will include a message that the player is entitled to a \$50 instant win prize. Every thirty-fifth (35<sup>th</sup>) ticket which wins a \$50 instant prize will have the following "winner" message imprinted on the ticket front: "You have won a \$50 bonus cash prize. Redeem with store clerk at any Kansas lottery retailer." Directly below the message, a winning icon consisting of a pig encircled by the words, "Kansas Lottery \$50 Winner," shall be printed.

The \$50 instant win ticket can be redeemed at any Kansas lottery selling location or at the Kansas lottery headquarters, or the ticket can be mailed to the Kansas lottery in accordance with established procedures for ticket redemption for the Holiday Millionaire raffle game. An exchange ticket without "winner" message shall be issued when a \$50 instant win ticket is redeemed at a retailer location by the retailer who redeems the ticket. An exchange ticket without "winner" message shall be issued when a \$50 instant win ticket is redeemed in person at Kansas lottery headquarters by Kansas lottery personnel. If a \$50 instant ticket is redeemed by mailing the ticket to Kansas lottery headquarters, the \$50 prize shall be mailed to the winner pursuant to instant ticket redemption procedures along with written notification from the Kansas lottery that the instant win ticket will be held by Kansas lottery security until completion of the Holiday Millionaire Raffle on December 31, 2014. Following completion of the Holiday Millionaire Raffle Drawing on December 31, 2014, Kansas lottery personnel shall notify, in writing, the owner of any \$50 instant win ticket being held by Kansas security lottery, if the owner has won any additional prize in any drawing of the "Holiday Millionaire Raffle" conducted during 2014. (Authorized by and implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-11-6-13, Sept. 11, 2013; amended, T-111-9-4-14, Aug. 13, 2014.)

#### Article 17.—SPECIFIC ONLINE DRAWING RULES

**111-17-16. Frogger second-chance drawing.** (a) The Kansas lottery shall conduct a second-chance online event drawing entitled "Frogger Second-Chance Drawing." The rules for this drawing are contained in K.A.R. 111-16-1 *et seq.* and 111-17-16. The Kansas lottery will accept online entries into the drawing beginning at midnight September 4, 2014, and ending at noon on March 10, 2015. The drawing will be announced with at least 24 hours advanced notice via the lottery's website, and other social media forums such as Facebook and Twitter. The drawing will be conducted sometime after entry into the drawing has closed, but before noon on March 13, 2015.

(b) The specific non-winning ticket eligible for entry into this second-chance online event drawing shall be the \$5 Frogger, game number 594.

(c) The Kansas lottery shall award one grand prize and three secondary prizes to players who entered the "Frogger Second-Chance Drawing" using the \$5 Kansas lottery instant ticket named Frogger, game number 594. The grand prize shall consist of a \$500 gift card. Three secondary prizes shall consist of a \$250 gift card.

(d) There will be one drawing held to select winners of the grand prize and secondary prizes. The drawing shall select 15 entrants. The first entrant drawn in this drawing shall be awarded the grand prize identified in subsection (c). The next three entrants drawn in this drawing (identified as numbers 2 through 4) will be awarded one of the three secondary prizes identified in subsection (c). The next 11 entrants drawn in this drawing (identified as numbers 5 through 15) will be used as alternate winners, if necessary, in the order drawn.

(e) A winner of any prize shall be notified via email that he or she has won a prize. The winner shall be instructed how to verify his or her personal identification.

(f) A winner shall be sent a claim form via U. S. mail at the time the winner is notified he or she has won a prize.

(g) A player who is the first winner selected in this drawing to receive the grand prize must return his or her completed claim form and must be received by the Kansas lottery within 14 days following the date of the online event drawing. A player who is the second, third, and fourth winner selected in this drawing to receive a secondary prize must return his or her completed claim form and must be received by the Kansas lottery within 14 days following the date of the online event drawing. Alternatively, a player who is among the entrants selected as alternate winners in all drawings and identified in subsection (d) must return his or her completed claim form within 14 days following the date the alternate winner was sent a claim form via U. S. mail.

(h) Completed claim forms can be mailed by the winners via U.S. Mail to: Kansas lottery, 128 North Kansas Avenue, Topeka, Kansas 66603, or the winners can deliver the completed claim form by hand to the Kansas lottery claims center in Topeka, Kansas during the claim center's normal business hours.

(i) If a player fails to answer any email, respond to any request for information, or fill out any forms required by the Kansas lottery within the time allotted in the winner's notification of winning a grand prize, said win shall be forfeited and the prize awarded to another alternate winner.

(j) Any player entering the Frogger Second-Chance Drawing agrees to public disclosure.

(k) The Kansas lottery reserves the right to substitute prizes at its sole and total discretion of approximate equal value.

(l) Rules applicable to this online event drawing are contained in K.A.R. 111-17-16 and K.A.R. 111-16-1 *et seq.* (Authorized by K.S.A. 2013 Supp. 74-8710 and K.S.A. 74-8748; implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-9-4-14, Aug. 13, 2014.)

#### Article 401.—NORTHEAST GAMING ZONE

**111-401-129. Wagers and payout odds.** (a) Minimum and maximum wagers will be posted on a sign at each table.

(continued)

(b) Maximum table payouts, if any, will be posted at each table and will not be less than the maximum bet times the maximum odds.

(c) If a player has been permitted to wager less than the table minimum, the dealer will take or pay the amount actually wagered. If a player has been permitted to wager more than the table maximum, the excess will be returned to the player and the player will be paid the correct odds on the correct wager. The player will be informed of the table minimum and maximum for subsequent wagers.

(d) A player may play two hands at double the table minimum or greater per hand not to exceed the table maximum. A player may play three hands at the table maximum per hand. Multiple hands must be on empty positions with no other players located between multiple hands. Exceptions will be made only at the discretion of the table games pit manager, the table games shift manager, or higher ranking casino official.

(e) The following describes a list of the permissible wagers, payout odds, and what constitutes a win, loss, or tie:

(1) Initial Pai Gow wager:

(A) All wagers must be placed prior to dealing of hands. The initial Pai Gow wager is a wager placed by a player on either his own hand or the hand of another player.

(i) Initial Pai Gow wagers may be placed on a position by more than one player, however, the total initial Pai Gow wagers per position cannot exceed the table maximum.

(ii) Only the seated player for a position will handle the cards and set the hand. A seated player may refuse additional wagers.

(iii) An additional initial Pai Gow wager may be made as a tip for the dealer.

(iv) No commission is charged on Pai Gow wagers.

(B) Payout odds on all winning wagers will be 1 to 1.

(C) Initial Pai Gow wagers will win if:

(i) The player's low hand beats the dealer's low hand, and

(ii) The player's high hand beats the dealer's high hand.

(D) Initial Pai Gow wagers will lose if:

(i) The player's low hand does not beat the dealer's low hand, and

(ii) The player's high hand does not beat the dealer's high hand.

(iii) The player forfeited the hand.

(iv) The low hand of the player is set to rank higher than the high hand of the player (fouled hand).

(v) The low hand contains more or less than two cards, or the high hand contains more or less than five cards (fouled hand).

(E) Initial Pai Gow wagers will tie or push if:

(i) The player's low hand beats the dealer's low hand and the player's high hand does not beat the dealer's high hand; or

(ii) The player's high hand beats the dealer's high hand and the player's low hand does not beat the dealer's low hand.

(2) Fortune Pai Gow bonus (also referred to as "fortune bonus") wagers:

(A) The Fortune Pai Gow bonus wager is a player's optional side bet that the outcome of his or her high hand will be of a certain qualifying poker rank. Players who wager a minimum of \$5 on the Fortune Pai Gow bonus wager also qualify for the envy bonus. The Fortune Pai Gow bonus wager must be placed at the same time as the initial Pai Gow wager and may be larger than the initial Pai Gow wager.

(i) Only the seated player for a position is allowed to place a Fortune Pai Gow bonus wager.

(ii) An additional Fortune Pai Gow bonus wager may be made as a tip for the dealer.

(B) Payout odds on winning Fortune Pai Gow bonus wagers will be independent of the outcome of the dealer's hand and the bonus will be paid at the following odds when the player's high hand or high hand and low hand combined consist of a:

(i) 3 pair - push

(ii) straight - 2 to 1

(iii) three-of-a-kind - 3 to 1

(iv) flush - 4 to 1

(v) full house - 5 to 1

(vi) four-of-a-kind - 20 to 1

(vii) straight flush - 50 to 1

(viii) royal flush - 100 to 1

(ix) five aces - 250 to 1

(x) seven card straight flush with joker - 750 to 1

(xi) royal flush plus a royal match (suited king and queen) - 1,000 to 1

(xii) seven card straight flush without a joker - 5,000 to 1

1

(C) A Fortune Pai Gow bonus wager will win if:

(i) The player makes an initial Pai Gow wager

(ii) The player makes a Fortune Pai Gow bonus wager of \$1 up to the table maximum in \$5 increments per hand once the bet reaches \$5; and,

(iii) The hand on which the bets were placed consists of a combination of cards containing at least three pair.

(D) A Fortune Pai Gow bonus wager will lose if:

(i) The hand on which the bet was placed does not consist of a combination of cards containing at least three pair, or

(ii) The seated player forfeited the hand.

(3) Envy bonus wager:

(A) Players who wager a minimum of \$5 on the Fortune Pai Gow bonus wager qualify for the envy bonus, subject to the following:

(i) Only the seated player for a position qualifies for the envy bonus.

(ii) Before dealing the cards, the dealer will place an envy bonus lammer for each player who has a \$5 bonus wager.

(iii) If two players have an envy bonus jackpot, the players will be paid on both hands.

(iv) The dealer's hand never qualifies for the envy bonus.

(v) The position which contains the qualifying envy bonus hand (at least a four-of-a-kind) cannot win the envy bonus.

(B) Payout odds on winning envy bonus wagers will be independent of the outcome of the dealer's hand and the following bonuses will be paid when a player wagers

a minimum of \$5 on the Fortune Pai Gow bonus wager and another player's hand at the table contains a:

- (i) four-of-a-kind - \$5
- (ii) straight flush - \$10
- (iii) royal flush - \$25
- (iv) five aces - \$50
- (v) Seven card straight flush with a joker - \$100
- (vi) royal flush plus royal match - \$250
- (vii) seven card straight flush without a joker - \$1,000

(C) A Fortune Pai Gow envy bonus wager will win if:

(i) The player makes an initial Pai Gow wager  
(ii) The player makes a fortune bonus wager of a minimum of \$5, and

(iii) Another player's hand consists of at least a four-of-a-kind.

(D) A Fortune Pai Gow envy bonus wager will lose if no players have a hand consisting of at least a four-of-a-kind.

(4) Progressive:

(A) Players may participate in the optional progressive jackpot by placing a \$1 chip in the designated area. The progressive bet is considered a side wager and the dealer's hand has no bearing on the progressive bet's outcome. The player must have an original Pai Gow wager to make a progressive bet.

(B) The progressive jackpot will be comprised of a beginning base amount of \$2,000.

(C) The amount of the progressive jackpot will be displayed in a manner visible to players.

(D) Winning progressive bets will be paid at the rate of:

- (i) If the player's hand consists of a full house, 4 to 1.
- (ii) If the player's hand consists of a four-of-a-kind, 75 to 1.
- (iii) If the player's hand consists of a straight flush, 100 to 1.
- (iv) If the player's hand consists of a royal flush, 500 to 1.
- (v) If the player's hand consists of five aces, 10 percent of the progressive jackpot.
- (vi) If the player's hand consists of a seven card straight flush (with or without the joker), 100% of the progressive jackpot.

(E) A progressive bet will win if the player's hand consists of a seven card straight flush (with or without the joker), five aces, royal flush, straight flush, four-of-a-kind, or a full house.

(5) Winning progressive bets will be paid in the following manner:

(A) If the winning hand consists of a full house, four-of-a-kind, or straight flush, the table games supervisor

will verify the winning hand and will verify the progressive bet was made, and direct the dealer to make the appropriate payout.

(B) If the winning hand consists of a royal flush, five aces, or a seven card straight flush (with or without the joker), the table games supervisor or higher ranking casino official will verify the winning hand and will verify the progressive bet was made. The table games supervisor or higher ranking casino official will notify the table games pit manager or higher ranking casino official. Surveillance will also be notified to verify the winning hand.

(i) The dealer will verify the deck of cards by counting down and sorting the remaining cards by suit.

(ii) Once the jackpot has been deducted from the progressive jackpot for the five aces or seven card straight flush (with or without the joker), new cards will be placed on the table and play will resume.

(iii) In the case of the seven card straight flush (with or without the joker), the meter will reset to an amount equal to the sum of \$2,000.

(iv) In the event of multiple winning progressive hands consisting of five aces or seven card straight flush (with or without joker), the jackpot will be determined by whoever receives their hand first according to the time stated on surveillance video at the lottery gaming facility.

(C) A progressive bet will lose if the player's hand consists of any combination of cards other than a seven card straight flush (with or without the joker), five aces, royal flush, straight flush, four-of-a-kind, or a full house.

(6) Tiger 9 bonus:

(A) Only the seated player for a table position may place a tiger 9 bonus wager.

(B) Any seated player who has made a Pai Gow wager may, at the same time, make a tiger 9 bonus wager by placing gaming chips in the area designed for that bonus wager at his or her betting position.

(C) A tiger 9 bonus wager shall be no less than \$1.00 and may be larger than the original Pai Gow wager.

(D) An additional tiger 9 bonus wager may be made as a toke (gratuity) for the dealer.

(E) A tiger 9 bonus wager shall win if the dealer's hand contains a nine (9) high low hand and will lose if the dealer's hand does not contain a nine (9) high low hand.

(F) All winning tiger 9 bonus wagers are paid at the rate of 30 to one. (Authorized by K.S.A. 2013 Supp. 74-8710 and 74-8748; implementing K.S.A. 2013 Supp. 74-8710; effective, T-111-2-9-12, Dec. 14, 2011; amended, T-111-9-4-14, Aug. 13, 2014.)
