Summaries of the proposed regulations and their economic impact follow. (Note: Statements indicating that a regulation is “not anticipated to have any economic impact” are intended to indicate that no economic impact on the Kansas State Board of Pharmacy, other state agencies, state employees, or the general public has been identified.)

**K.A.R. 68-13-2, 68-13-3, and 68-13-4. Compounding.** These regulations are proposed to create minimum standards for sterile and non-sterile pharmaceutical compounding in Kansas consistent with the U.S. Pharmacopeia (USP) requirements.

**K.A.R. 68-5-17. Pharmacy technicians; certification examination; request for extension.** This regulation is proposed to identify requirements for successful completion of the pharmacy technician certification exam. For all pharmacy technicians registered after July 1, 2017, the Board will require passing scores from the Pharmacy Technician Certification Board (PTCB) or the National Healthcareer Association (ExCPT) exams prior to the first renewal (24-26 months) of the pharmacy technician’s registration.

**K.A.R. 68-21-7. Drugs of concern.** This regulation is amended to classify any product, compound, mixture, or preparation containing gabapentin as a drug of concern. K.A.R. 68-21-7 identifies the drugs of concern that are reported to, tracked by, and monitored through the Kansas Prescription Monitoring Program (K-TRACS) that are not controlled substances identified in Schedules II-IV of the Kansas Controlled Substances Act.

#### Summary of Economic Impact

It is the mission of the Board to ensure that all persons practicing pharmacy are properly licensed and registered, and to ensure compliance with Kansas statutes regarding proper compounding and dispensing of prescription drugs, maintenance of professional practice standards, and proper manufacture, distribution, and sale of prescription and nonprescription drugs, including controlled substances and poisons. In order to attain these goals, the Board is proposing these regulatory changes to comply with professional, healthcare, and safety norms.

The Board anticipates minimal economic impact to the Board, its licensees and registrants, or Kansas-registered

pharmacies. In all instances, the Board does not anticipate any financial impact upon other governmental agencies, and the Board is unaware of any less costly or less intrusive methods to achieve the stated purposes and thus none were considered. For a more detailed summary of the economic impact each specific regulation may have, see the Economic Impact Statement, provided at the website above.

#### Article 19. — AMBIENT AIR QUALITY STANDARDS AND AIR POLLUTION CONTROL

**28-19-202.** (Authorized by K.S.A. 2009 Supp. 65-3005 and 65-3024; implementing K.S.A. 65-3024; effective Nov. 22, 1993; amended Jan. 23, 1995; amended March 15, 1996; amended Feb. 21, 1997; amended Feb. 13, 1998; amended March 23, 2001; amended Jan. 30, 2004; amended Nov. 5, 2010; revoked Jan. 5, 2018.)

**28-19-516. Class I operating permits; application fees.** (a) Each of the following class I operating permit applications shall be accompanied by the fee specified in this subsection:

- (1) For an initial application submitted under K.A.R. 28-19-510, \$3,000.00;
- (2) for a renewal application submitted under K.A.R. 28-19-514, \$3,000.00;
- (3) for an application for a significant permit modification submitted under K.A.R. 28-19-513, \$1,500.00;
- (4) for a general permit petition submitted under K.A.R. 28-19-401, \$2,250.00; and
- (5) for a general permit application submitted under K.A.R. 28-19-403, \$750.00.

(b) Each application fee shall be remitted in the form of a check, bank draft, credit card payment, or money order made payable to the Kansas department of health and environment. All application fees shall be nonrefundable. (Authorized by K.S.A. 2017 Supp. 65-3005; implementing K.S.A. 2017 Supp. 65-3008; effective Jan. 23, 1995; amended Jan. 5, 2018.)

**28-19-517. Class I operating permits; annual emissions inventory and fees.** The owner or operator of each stationary source that is required to apply for a class I operating permit shall comply with this regulation.

(a) Annual emissions inventory.

(1) Each owner or operator shall submit to the department an annual emissions inventory for each stationary source for the year preceding the calendar year in which the source is required to apply for an operating permit and each year thereafter.

(2) Each annual emissions inventory shall be submitted for any regulated pollutant deemed necessary by the secretary from each emission unit, as defined in K.A.R. 28-19-200, and shall include the following:

(A) All operating information;

(B) actual emissions, including fugitive emissions, calculated pursuant to K.A.R. 28-19-210;

(C) any quantity of emissions regardless of operating hours, including sources that did not operate; and

(D) emissions from each source only while operating in Kansas, if the source operates both in Kansas and out of state.

(b) Annual emissions fee.

(1) Each owner or operator shall submit to the department an annual emissions fee based on the annual emissions inventory determined under subsection (a). Annual emissions fees shall be the greater of the following:

(A) \$1,000.00; or

(B) \$53.00 per ton of emissions multiplied by the total number of tons of emissions, with a maximum of 4,000 tons of each of the following pollutants rounded to the nearest ton:

(i) Sulfur dioxide;

(ii) nitrogen oxides;

(iii) PM10;

(iv) volatile organic compounds (VOCs); and

(v) hazardous air pollutants (HAPs), excluding HAPs already accounted for as VOCs or PM10.

(2) Each owner or operator shall make annual emissions fee payments by check, bank draft, credit card, or money order payable to the Kansas department of health and environment.

(c) Submittal.

(1) Each annual emissions inventory determined under subsection (a) and each annual emissions fee determined under subsection (b) shall be submitted on forms provided by the department, using either of the following:

(A) An electronic inventory submission; or

(B) A paper inventory submission, including a fee of \$250.00 for each paper inventory submittal and \$10.00 for each single-sided page.

(2) Each submission shall be signed by a responsible official, as defined in K.A.R. 28-19-200, and shall be due on or before April 1 of each year or, if April 1 is a Saturday or Sunday, on or before the next business day following April 1.

(3) If there is a change in the owner or operator of the stationary source, the owner or operator at the time the submission is due shall be responsible for submitting the annual emissions inventory and fee payment. For purposes of determining the annual emissions inventory required by subsection (a) for any period in which there was any other owner or operator of the stationary source, the owner or operator may assume current operating and emission information if the owner or operator is unable to obtain actual information from any previous owner or operator.

(d) Late fee and refund.

(1) Each owner or operator who fails to submit the annual emissions inventory and pay the annual emissions fee by the due date specified in subsection (c) shall pay a late fee. The late fee shall be \$200.00 per day or 0.10 percent of the annual emissions fee per day, whichever is greater.

(2) Any overpayment of \$100.00 or more made by the owner or operator of a stationary source may be refunded. Overpayments in any amount less than \$100.00

#### Article 12.—INCOME TAX

**92-12-146. Definitions.** (a) "Contribution," as defined in K.S.A. 2016 Supp. 72-99a02 and amendments thereto, shall include any donation of cash, stocks and bonds, personal property, or real property.

(1) Stocks and bonds shall be valued at the stock market price on the date of the transfer.

(2) Personal property shall be valued at the lesser of its fair market value or the cost to the donor. The value may include costs incurred in making the donation but shall not include sales tax. If the donor received the personal property as a gift or inheritance and the item is considered a rare and valuable antique or work of art, an independent appraisal may be necessary in determining the fair market value.

(3) The donation of real property shall be allowable for tax credit if title to the real property is in fee simple absolute and is clear of any encumbrances. The amount of tax credit allowable for donations of real property shall be based upon the lesser of two current, independent appraisals conducted by state-licensed appraisers.

(b) "Contributor" shall mean any of the following entities making a contribution:

(1) A taxpayer filing an income tax return pursuant to the Kansas income tax act, and amendments thereto;

(2) a taxpayer filing a privilege tax return pursuant to K.S.A. 79-1105c et seq., and amendments thereto; or

(3) a taxpayer filing an insurance premium tax return pursuant to K.S.A. 40-252, and amendments thereto. (Authorized by and implementing K.S.A. 2016 Supp. 72-99a07, as amended by L. 2017, ch. 95, sec. 97; effective Dec. 5, 2014; amended Jan. 5, 2018.)

**92-12-148. Tax credit application.** (a) Each contributor making a contribution to a scholarship-granting organization shall complete a tax credit application with the scholarship-granting organization on a form furnished by the secretary. Each application shall include the following information:

(1) The name, address, and either the social security number or the employer identification number of the contributor;

(2) the name of the scholarship-granting organization to which the contribution is being made;

(3) the amount and type of the contribution;

(4) the date of the contribution; and

(continued)

(5) any other supporting documentation that the secretary requires to review the tax credit application.

(b) Each scholarship-granting organization shall submit the completed tax credit application and supporting documentation to the secretary for review. The application, including the supporting documentation, may be filed by electronic means in a manner approved by the secretary. The scholarship-granting organization shall receive written notification from the secretary when the application is approved or denied. The scholarship-granting organization shall provide a copy of this approval or denial to the contributor that has made the contribution. **92-12-149. Quarterly reports.** Each scholarship-granting organization shall submit a quarterly report indicating the amount of contributions qualifying for tax credits. This report shall be submitted to the secretary on a form furnished by the secretary. Any quarterly report may be filed by electronic means in a manner approved by the secretary. A quarterly report shall be submitted on or before the tenth day following the end of each calendar quarter even if no qualifying contributions are received in that quarter. Each quarterly report shall include the following information:

(a) The name and either the social security number or the employer identification number of each contributor in that quarter;

(b) the amount and type of each contribution received in that quarter;

(c) the total amount of qualified tax credits based on the contributions received in that quarter;

(d) the total amount of tax credits that remain from the scholarship-granting organization's annual allocation; and

(e) any documentation that the secretary requires to support the quarterly report. #### Temporary Administrative Regulations

##### Article 2.—LOTTERY RETAILERS

**111-2-30. Retailer bonus.** (a) On all Powerball, Mega Millions, Hot Lotto, Lotto America, and Super Kansas Cash drawings in which the prize claimed and awarded is the "jackpot prize" offered in the game it represents, the Kansas lottery retailer(s) selling the ticket(s) shall receive \$10,000 for Powerball, \$10,000 for Mega Millions, \$2,500 for Hot Lotto, \$2,500 for Lotto America, and \$1,000 for

Super Kansas Cash, or share equally in a bonus if there are multiple winners and the prize is paid on a parimutuel basis. The bonus shall be in addition to compensation specified in K.A.R. 111-2-4.

(b) A "jackpot prize" is the highest prize awarded in the prize structure of the Powerball, Mega Millions, Hot Lotto, Lotto America, or Super Kansas Cash game it represents.

(c) On all Powerball drawings where the prize claimed and awarded is less than the jackpot prize and is not less than \$200,000, the Kansas lottery retailer selling the ticket shall receive \$1,000.

(d) On all Keno drawings where the prize claimed and awarded is not less than \$100,000, the Kansas lottery retailer selling the ticket shall receive \$1,000.

(e) On all raffle game drawings where the prize claimed and awarded is not less than \$1,000,000, the Kansas lottery retailer selling the ticket shall receive \$1,000.

(f) On all Mega Millions drawings where the prize claimed and awarded is less than the jackpot prize and is not less than \$250,000, the Kansas lottery retailer selling the ticket shall receive \$1,000.

(g) On all Lucky for Life drawings where the top prize claimed and awarded is not less than \$1,000 a day for life or the cash option equivalent, the Kansas lottery retailer selling the ticket shall receive \$2,500. On all Lucky for Life drawings where the prize claimed and awarded is not less than \$25,000 a year for life or the cash option equivalent, the Kansas lottery retailer selling the ticket shall receive \$1,000.

(h) In addition to other commissions and bonuses received, each retailer shall receive a sales bonus of one percent (1%) of each instant and online tickets sold by the retailer where the prize claimed and awarded is over \$599, with a minimum bonus of \$10 and a maximum bonus of \$100. A retailer receiving a bonus pursuant to subsections (a), (b), (c), (d), (e) or (f) above shall not be entitled to this bonus.

(i) A bonus as provided in subsections (a), (b), (c), (d), (e), (f), (g) or (h) above shall only be paid to a Kansas lottery retailer that, at the time the qualifying prize is claimed and awarded, is not delinquent in any payments due the lottery, is a certified lottery retailer, is not suspended or on "hold" status, and is otherwise in compliance with retailer's contract with the lottery. In the event a bonus is earned but the retailer is not at that time eligible to receive the bonus, the lottery will withhold payment or credit for up to 90 days to allow the retailer to cure any such delinquency or other deficiency. If after 90 days the retailer fails to cure said delinquency or deficiency, the retailer shall forfeit said bonus. Under extenuating circumstances, as determined by the executive director, the time for curing said delinquency or deficiency may be extended. **Article 5.—MULTI-STATE ONLINE GAMES AND DRAWINGS**

**111-5-180. Name of the game; rules and regulations.** The Kansas lottery may conduct a lotto game entitled “Mega Millions” (“MM”) conducted twice weekly on Tuesdays and Fridays, beginning at the start of the business day on January 31, 2010.

The rules and regulations for “Mega Millions” game are contained in K.A.R. 111-5-180 through 111-5-194, K.A.R. 111-5-242, and applicable generic rules are contained in K.A.R. 111-6-1 *et seq.* (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-1-29-10, Jan. 20, 2010; amended, T-111-12-05-17, Oct. 11, 2017.)

**111-5-181. Definitions.** The following definitions shall apply to the Kansas lottery’s “Mega Millions” game unless the context requires a different meaning or is otherwise inconsistent with the intention of other rules adopted by the Kansas lottery.

(a) “Advertised Grand Prize” shall mean the estimated annuitized grand prize amount as determined by the Mega Millions Finance Committee and communicated through the selling lotteries prior to the grand prize drawing. The advertised grand prize is not a guaranteed prize amount and the actual grand prize amount may vary from the advertised amount, except in circumstances where there is a guaranteed grand prize amount as described in these rules.

(b) “Agent” or “retailer” means a person or entity authorized by the Kansas lottery to sell Kansas lottery tickets.

(c) “Drawing” or “Draw” means the formal process of selecting winning numbers which determine the number of winners for each prize level of the game.

(d) “Computer pick” or “quick pick” means the ran-

dom selection of two-digit numbers by the computer system, which appear on a ticket and are played by a player in the game.

(e) “Finance and Audit Committee” shall mean the committee established by the Multi-State Lottery Association Agreement (MUSL).

(f) “Game board” or “boards” means that area of the play slip, also known as a “panel,” which contains two sets of numbered squares to be marked by the player, the first set containing seventy (70) squares, number one (1) through seventy (70) and the second set containing twenty-five (25) squares, number one (1) through twenty-five (25).

(g) “Game ticket” or “ticket” means an acceptable evidence of play, which is a ticket produced by a terminal which meets the specifications defined in these rules and is a physical representation of the play or plays sold to a player.

(h) “Jackpot” or “Grand Prize” means the top prize of the Mega Millions game.

(i) “Just the Jackpot Plays” or “JJ Plays” means a purchased wager which includes two (2) JJ Plays as part of the Just the Jackpot game play as described in these rules.

(j) “Mega Millions Finance Committee” means a committee of the Mega Millions lotteries which determines the grand prize jackpot amount (cash and annuity).

(k) “Mega Millions Lottery or Lotteries” means those lotteries which have joined under the Mega Millions lottery agreement; the group of lotteries that has reached a cross-selling agreement with the MUSL product group for the selling of the Mega Millions game.

(l) “Megaplier Plays” means plays purchased as part of the Megaplier Promotion described in these rules.

(m) “MUSL” means the Multi-State Lottery Association, a government-benefit association wholly owned and operated by the party lotteries.

(n) “MUSL Board” means the governing body of the MUSL which is comprised of the chief executive officer of each party lottery.

(continued)

(o) "On-Line Lottery Game" means a lottery game connected with the lottery's computer gaming system wherein a player selects numbers out of a larger predetermined set or sets of numbers.

(p) "Participating Lottery" or "Selling Lottery" means a state lottery or lottery of a political subdivision or entity which is participating in selling the Mega Millions game and that may be a member of either MUSL or the Mega Millions lotteries.

(q) "Party lottery" means a state lottery which has joined the MUSL and, in the context of the product group rules, which has joined in selling the games offered by the MUSL Mega Millions product group.

(r) "Play" or "bet" means the six (6) numbers, the first five (5) from a field of seventy (70) numbers and the last one (1) from a field of twenty-five (25) numbers, that appear on a ticket as a single-lettered selection and are to be played by a player in the game. Each play is played separately in determining matches to winning numbers and prize amounts. As used in these rules, unless otherwise specifically indicated, "Play" or "Bet" includes both "MM Plays" and "JJ Plays." "Megaplier Plays" are separately described in these rules.

(s) "Play Slip" or "Bet Slip" means a card used in marking a player's game plays and containing one or more boards.

(t) "Product Group" means the group of lotteries which has joined together to offer the Mega Millions lottery game product pursuant to the terms of its cross-selling agreement with the Mega Millions lotteries, the Multi-State Lottery Agreement, and the group's own rules.

(u) "Set Prize" or "single payment prize" means all other prizes except the grand prize and, except in instances outlined in these rules, will be equal to the prize amount established by the MUSL board for the prize level.

(v) "Terminal" means a device authorized by the Kansas lottery to function in an on-line interactive mode with the lottery's computer system for the purpose of issuing lottery tickets and entering, receiving, and processing lottery transactions, including purchases, validating tickets, and transmitting reports.

(w) "Ticketless transaction" shall include plays sold through non-standard terminals.

(x) "Winning numbers" means the six (6) numbers, the first five (5) from a field of seventy (70) numbers and the last one (1) from a field of twenty-five (25) numbers, randomly selected at each drawing, which shall be used to determine winning plays contained on a game ticket.

**111-5-182. Game description; retail sale of tickets.**

(a) "Mega Millions" is a five (5) out of seventy (70) plus one (1) out of twenty-five (25) on-line lottery game, drawn on the day(s), time(s), and location(s) as determined by the Mega Millions lotteries, and which pays the grand prize, at the election of the player, made in accordance with these rules or by a default election made in accordance with these rules, either on a graduated annuitized annual pari-mutuel basis or as a cash value option using

a rate determined by the Mega Millions finance committee on a pari-mutuel basis. Except as provided in these rules, all other prizes are paid on a single payment basis.

(b) To play Mega Millions, a player shall select five (5) different numbers, from one (1) through seventy (70) and one (1) additional number from one (1) through twenty-five (25), for input into a terminal. The additional number may be the same as one of the first five numbers selected by the player.

(c) A "Mega Millions" game ticket shall sell for two dollars (\$2.00).

(d) Tickets shall not be sold to any person under the age of 18 years. Each retailer may require a person purchasing tickets to produce proof of age.

(e) Each ticket shall be purchased from a terminal operated by a retailer. The player may select a set of five numbers and one additional number by:

(1) communicating the six numbers to the retailer;

(2) marking six numbered circles in any one game board on a play slip and submitting the play slip to the retailer; or

(3) requesting a "computer pick" or "quick pick" from the retailer.

(f) A validated ticket shall be the only proof of a game play or plays. The only method of claiming a prize or prizes shall be the submission of the winning ticket to and receipt of the ticket by the lottery or its authorized agent. A play slip shall have no pecuniary nor prize value and shall not be used as evidence of a ticket purchase or of numbers selected. A terminal produced paper receipt has no pecuniary nor prize value and shall not constitute evidence of ticket purchase or of numbers selected.

(g) A ticket shall not be voided or cancelled by returning the ticket to the selling retailer, including tickets that are printed in error. No ticket which can be used to claim a prize shall be returned to the Kansas lottery for credit. Tickets accepted by retailers as returned tickets and which cannot be re-sold shall be deemed owned by the bearer thereof.

(h) Ticket sales will end at approximately 8:59 p.m. central time on Tuesdays and Fridays and will resume at approximately 9:05 p.m. on those same days.

(i) Drawings will be conducted twice weekly, on Tuesdays and Fridays at approximately 10:00 p.m. central time (CT), after the game is closed at approximately 8:59 p.m. central time (CT) and the draw official has verified that the game is closed, under conditions and procedures promulgated by the executive director of the lottery.

(j) It shall be the sole responsibility of each player to verify the accuracy of the game play or plays and other data printed on the ticket. The placing of plays is done at the player's own risk through the lottery retailer who is deemed to be acting on behalf of the player in entering the play or plays. (Authorized by K.S.A. 2017 Supp. 74-8710; implementing K.S.A. 2017 Supp. 74-8710 and 74-8718; effective, T-111-1-29-10, Jan. 20, 2010; amended, T-111-10-11-13, Aug. 14, 2013; amended, T-111-12-05-17, Oct. 11, 2017.)

**111-5-183. Prize pool; reserve account.** (a) The prize pool for all prize categories shall consist of up to 55.0% of each drawing period's sales, including any specific statutorily-mandated tax to be included in the price of

a lottery MM ticket, after the prize reserve accounts are funded to the amounts set by the product group, but may be higher or lower based upon the number of winners at each prize level, as well as the funding required to meet a guaranteed annuity grand prize.

(b) An amount up to five percent (5%) of the Kansas lottery's Mega Million sales shall be added to the Kansas lottery's grand prize pool contribution and placed in trust in one or more prize pool accounts and prize reserve accounts held by the product group at any time that the prize pool accounts and Kansas lottery's share of the prize reserve account(s) is below the amounts designated by the product group. The product group may determine to expend all or a portion of the funds in prize pool accounts (except the grand prize pool account) and the prize reserve accounts for the purpose of indemnifying the Kansas lottery in the payment of prizes, subject to the approval of the board, and for the payment of prizes or special prizes in the game, limited to prize pool and prize reserve contributions from the Kansas Lottery when participating in special prize game play, subject to the approval of the finance and audit committee or that committee's failure to object after given two weeks' notice of the planned action, which actions may be appealed to the full board by the product group. The prize reserve shares of the Kansas lottery may be adjusted with refunds to the Kansas lottery from the prize reserve account as may be needed to maintain the approved maximum balance and sales percentage shares of the party lotteries. The Kansas lottery may contribute to its sales percentage share of prize reserve accounts over time, but in the event of a draw down from a reserve account, the Kansas lottery is responsible for its full sales percentage share of the prize reserve account, whether or not it has been paid in full. Any amount remaining in the prize pool accounts or prize reserve account at the end of this game shall be returned to the lotteries participating in the prize pool and prize reserve accounts after the end of all claim periods of all selling lotteries, carried forward to a replacement game or expended in a manner as directed by the members of the product group in accordance with Kansas law. **111-5-184. Expected prize payout pari-mutuel prizes.** (a) The grand prize shall be determined on a pari-mutuel basis. Except as provided in these rules, all other prizes awarded shall be paid as single payment prizes with the following expected approximate prize payout percentages, which does not include an additional amount contributed to or held in prize reserves, although the prize payout percentages per draw may vary:

\*The grand prize shall include the MM prize pool percentage allocated to the grand prize combined with JJ prize pool percentage allocated to the grand prize.

(b) The prize money allocated to the grand prize category shall be divided equally by the number of MM plays winning the grand prize.

(c) The single payment prizes (for payment of single payment prizes of \$1,000,000 or less) shall be carried forward to subsequent draws if all or a portion of it is not needed to pay the set prizes awarded in the current draw.

(d) Except as otherwise provided in these rules, if the total of the MM set prizes (as multiplied by the respective Megaplier multiplier, if applicable) awarded in a drawing exceeds the percentage of the prize pool allocated to the MM set prizes, then the amount needed to fund the MM set prizes, including Megaplier prizes, awarded shall be drawn from the following sources in the following order:

(1) the amount available from the single set prizes and the megaplier prize pool, if any;

(2) an amount from the prize reserve account, if available, not to exceed forty million dollars (\$40,000,000) per drawing;

(3) If, after these sources are depleted, there are not sufficient funds to pay the set prizes awarded, including Megaplier prizes, then the highest set prize shall become a pari-mutuel prize. If the amount of the highest set prize, including megaplier prizes, when paid on a pari-mutuel basis, drops to or below the next highest set prize and there are still not sufficient funds to pay the remaining set prizes awarded, then the next highest set prize shall become a pari-mutuel prize. This procedure shall continue down through all set prize levels, if necessary, until all set prize levels become pari-mutuel prize levels. In that instance, the money available from the funding sources shall be divided among the winning MM plays in proportion to their respective prize percentages. Mega Millions and megaplier prizes will be reduced by the same percentage; and

(4) By agreement with the Mega Millions lotteries, the Mega Millions lotteries shall independently calculate their set pari-mutuel prize amounts. The party lotteries and the Mega Millions lotteries shall then agree to set the pari-mutuel prize amount for all lotteries selling the game at the lesser of the independently-calculated prize amounts.

(continued)

(e) Except as may be required by these rules, the official advertised grand prize annuity amount is subject to change based on sales forecasts and/or actual sales.

(f) Subject to the laws and rules governing each participating lottery, the number of prize categories and the allocation of the prize fund among the prize categories may be changed at the discretion of the Mega Millions lotteries, for promotional purposes. Such change shall be announced by Mega Millions lotteries.

**111-5-185. Probability of winning.** (a) The following table sets forth the approximate probability of winning and the probable distribution of winners in and among each prize category based upon the total number of possible combinations in Mega Millions.

**111-5-186. Prize payments; annuitized and cash prizes.** (a) The prize money allocated from the current Mega Millions prize pool for the grand prize, plus any previous portions of prize money allocated to the grand prize category in which no matching MM Plays or JJ Plays were sold, will be divided equally among all MM Plays and JJ Plays in all participating lotteries. The annuity grand prize amount will be paid in thirty (30) graduated annual installments paid out over 29 years.

Grand prizes won shall be funded by the selling lotteries in accordance with the formula set by the Mega Millions lotteries. The Mega Millions lotteries may set a minimum guaranteed annuity grand prize amount that shall be advertised by the selling lotteries as the starting guaranteed annuity grand prize amount. The Mega Millions lotteries may set a minimum guaranteed annuity grand prize amount, which shall be advertised by the Kansas lottery as the starting guaranteed annuity grand prize amount.

(b) If in any Mega Millions drawing there are no MM Plays or JJ Plays which qualify for the grand prize category, the portion of the prize fund allocated to such grand prize category shall remain in the grand prize category and be added to the amount allocated for the grand prize category in the next consecutive Mega Millions drawing.

(c) Grand prizes shall be paid, at the election of the player made no later than 60 days after the player becomes entitled to a prize, with either a per winner annuity or cash payment. If the payment election is not made by the player within 60 days after the player becomes entitled to the prize, then the prize shall be paid as an annuity prize. The election to take the cash payment may be made within 60 days after the player becomes entitled to the prize. An election made after the winner becomes entitled to the prize is final and cannot be revoked, withdrawn, or otherwise changed.

(d) In the event of a prize winner who selects the cash value option, the prize winner's share will be paid in a single payment upon completion of internal validation procedures. The cash option amount shall be determined by the Mega Millions lotteries.

(e) Graduated annual payment option grand prizes shall be paid in thirty (30) graduated annual installments upon completion of internal validation procedures. The initial payment shall be paid upon completion of internal validation procedures. The subsequent twenty-nine (29) payments shall be paid and graduated annually to coincide with the month of the Federal auction date at which the bonds were purchased to fund the annuity, with graduated annual installments defined in the Mega Millions lotteries' finance and operations procedures. Payments shall escalate by a factor of five percent (5%) annually, and annual payments shall be rounded down to the nearest rounded one thousand dollar (\$1,000) increment. All such payments shall be made within seven days of the anniversary of the annual auction date.

(f) If individual shares of the grand prize pool funds held to fund an annuity are less than \$250,000, the product group, in its sole discretion, may elect to pay the winners their share of the cash held in the grand prize pool.

(g) Funds for the initial payment of an annuitized prize or the cash option value prize shall be made available by MUSL for payment by the party lottery on a schedule approved by the product group. If necessary, when the due date for the payment of a prize occurs before the receipt of funds in the prize pool trust is sufficient to pay the prize, the transfer of funds for the payment of the full cash value option amount may be delayed pending receipt of funds from the party lotteries or other lotteries participating in the Mega Millions game. A party lottery may elect to make the initial payment from its own funds after validation, with notice to MUSL.

(h) In the event of the death of a lottery winner during the annuity payment period, the MUSL finance and audit committee, in its sole discretion excepting a discretionary review by the product group, upon the petition of the estate of the lottery winner (the "estate") to the Kansas lottery, and subject to federal, state, district, or territorial applicable laws, may accelerate the payment of all of the remaining lottery proceeds to the estate. If such a determination is made, then securities and/or cash held to fund the deceased lottery winner's annuitized prize may be distributed to the estate. The identification of the securities to fund the annuitized prize shall be at the sole discretion of the finance and audit committee or the product group.

(i) If the Kansas lottery purchases or holds the prize payment annuity for a prize won in Kansas, the prize winner shall have no recourse on the MUSL or any other party lottery for payment of that prize.

(j) All low-tier cash prizes (all prizes except the grand prize) shall be paid in cash or the equivalent. The Kansas lottery may begin paying low-tier cash prizes after receiving authorization to pay from the MUSL central office.

(k) Annuitized payments of the grand prize or a share of the grand prize may be rounded to facilitate the purchase of an appropriate funding mechanism. Breakage on an annuitized grand prize win shall be added to the first cash payment to the winner or winners. Prizes other than the grand prize, which, under these rules, may become single-payment, pari-mutuel prizes, may be rounded down so that prizes can be paid in multiples of whole dollars. Breakage resulting from rounding these prizes shall be carried forward to the prize pool for the next drawing.

(l) The holder of a winning MM Play may win only one prize per play in connection with the winning numbers drawn, and shall be entitled only to the prize won by those numbers in the highest matching prize category. A JJ Play is not eligible to win non-grand prizes/non-jackpot prizes. All liability for a Mega Millions prize is discharged upon payment of a prize claim.

(m) Prize claims must be claimed within 365 days of the day of the drawing in which the prize was won pursuant to K.A.R. 111-6-5(e).

**111-5-187. Ticket validation requirements.** (a) To be a valid ticket or play and eligible to receive a prize, a ticket shall satisfy all the requirements established by the Kansas lottery for validation of winning tickets sold through its on-line system and any other validation requirements adopted by the product group, the MUSL board and published as the confidential MUSL minimum game security standards. The MUSL and the Kansas lottery shall not be responsible for tickets which are altered in any manner.

(b) Under no circumstances will a claim be paid without an official Mega Millions ticket matching all game play, serial number, and other validation data residing

in the Kansas lottery's computer gaming system and such ticket shall be the only valid proof of the wager placed and the only valid receipt for claiming or redeeming such prize.

(c) In order to be deemed a valid, winning Mega Millions ticket, all of the following conditions must be met:

(1) The validation data must be present in its entirety and must correspond, using the computer validation file, to the number selections printed on the ticket for the drawing date(s) printed on the ticket;

(2) The ticket must be intact;

(3) The ticket must not be mutilated, altered, reconstituted, or tampered with in any manner;

(4) The ticket must not be counterfeit or an exact duplicate of another winning ticket;

(5) The ticket must have been issued by an authorized Kansas lottery retailer on official paper stock of the Kansas lottery;

(6) The ticket must not have been stolen, to the knowledge of the Kansas lottery;

(7) The ticket must be submitted for payment in accordance with procedures for claiming and payment of prizes;

(8) The ticket data must have been recorded on the central computer system prior to the drawing and the ticket data must match this computer record in every respect. In the event of a contradiction between information as printed on the ticket and as accepted by the Kansas lottery computer, the wager accepted by the Kansas lottery's computer gaming system shall be the valid wager;

(9) The player or computer number selections, validation data, and the drawing date(s) of an apparent winning ticket must appear on the official file of winning tickets, and a ticket with that exact data must not have been previously paid;

(10) The ticket must not be misregistered, defectively printed, or printed or produced in error to an extent that it cannot be processed by the Kansas lottery;

(11) The ticket must pass validation tests using a minimum of three (3) of five (5) validation. In addition, the ticket must pass all other confidential security checks of the Kansas lottery;

(12) In submitting a Mega Millions ticket for validation, the claimant agrees to abide by applicable laws, all rules and regulations, instructions, conditions, and final decisions of the executive director of the Kansas lottery;

(13) There must not be any other breach of Mega Millions or Kansas lottery rules in relation to the ticket, which in the opinion of the executive director of the Kansas lottery, justifies invalidation; and

(14) The ticket must be submitted to the party lottery that issued the ticket.

(d) An official Mega Millions ticket submitted for validation, which fails any of the preceding validation conditions, shall be considered void, subject to the following determinations:

(1) In all cases of doubt, the determination of the party lottery which sold the Mega Millions ticket shall be final and binding. The party lottery may, at its option, replace an invalid ticket with a Mega Millions ticket of equivalent sales price;

*(continued)*

(2) In the event a defective ticket is purchased or in the event the party lottery determines to adjust an error, the claimant’s sole and exclusive remedy shall be the replacement of such defective or erroneous ticket(s) with a Mega Millions ticket of equivalent sales price; and

(3) In the event a Mega Millions ticket is not paid by a party lottery and a dispute occurs as to whether the ticket is a winning ticket, the party lottery may, at its option, replace the ticket as provided in this rule. This shall be the sole and exclusive remedy of the claimant unless the laws or regulations of the party lottery provide for further administrative review. (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-1-29-10, Jan. 20, 2010; amended, T-111-12-05-17, Oct. 11, 2017.)

**111-5-191. Multi-Draw.** (a) In addition to a single play for each \$2.00, a player may also have his or her selections entered in multiple drawings. Multi-draw tickets must be purchased for consecutive drawings beginning with the next drawing. This is done by marking one of the multi-draw boxes designated by 2, 3, 4, 5, 10, or 15 on the play slip. The additional draw period(s) for which the ticket is valid will then appear on the computer generated ticket given to the player by the retailer.

(b) A player must pay an additional \$2.00 per play for each additional drawing in which he or she wishes to play.

(c) Unless one of the multi-draw boxes is marked and the additional amount paid, the play will only be eligible for the current drawing up to 8:59 p.m. the day of the drawing.

(d) A player may purchase only the same numbers on the same boards for multiple drawings.

(e) Multi-draw tickets for Mega Millions drawings conducted after the October 27, 2017, business day shall not be available for purchase prior to the business day beginning October 28, 2017.

(f) A business day for the purposes of this game shall be defined at subsection (p) of K.A.R. 111-6-1. (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-1-29-10, Jan. 20, 2010; amended, T-111-12-05-17, Oct. 11, 2017.)

**111-5-194. Mega Millions Megaplier promotion.**

(a) The Mega Millions Megaplier promotion is a limited extension of the Mega Millions game and is conducted in accordance with the Mega Millions game rules and other lottery rules applicable to the Mega Millions game except as may be amended herein. The promotion will begin on January 31, 2010, which is the day Mega Millions tickets are first offered for sale by the Kansas lottery. The promotion will continue until it is discontinued by the Kansas lottery. The promotion will offer to the owners of a qualifying Megaplier play a chance to multiply or increase the amount of any of set prizes (the prizes normally paying \$2 to \$1,000,000) won in a drawing held during the promotion. The grand prize is not a set prize and will not be multiplied or increased by means of the Megaplier promotion or the Just the Jackpot promotion.

(b) A qualifying Megaplier play is any single Mega Millions play for which the player pays an extra one dollar (\$1.00) for the Megaplier option and which is recorded on the Kansas Lottery’s computer gaming system as a qualifying Megaplier play. The purchase of Just the Jackpot plays do not qualify to purchase a Megaplier play.

(c) Except as provided in these rules, a qualifying Megaplier play which wins one of the set prizes will be multiplied by the number drawn, either two, three, four, or five (2, 3, 4, or 5), in a separate random Megaplier drawing announced in a manner approved by the product group.

(d) MUSL will either itself conduct, or authorize a United States lottery to conduct on its behalf, a separate random megaplier drawing. Before each Mega Millions drawing, a single number (2, 3, 4, or 5) shall be drawn. The product group may change one or more of these multiplier numbers for special promotions from time to time. In the event the multiplier drawing does not occur prior to the Mega Millions drawing, the multiplier number will be a five (5), which shall solely be determined by the lottery authorized to conduct the “Megaplier” drawing.

(e) The Megaplier prize pool is hereby created, and shall be used to fund Megaplier prizes. The Megaplier prize pool shall hold the temporary balances that may result from having fewer than expected winning Megaplier plays. The source of the Megaplier prize pool is the Kansas lottery’s weekly prize contributions less actual Megaplier prize liability.

(f) Up to fifty-five percent (55%) of each drawing period’s sales, including any specific statutorily-mandated tax of a party lottery to be included in the price of a lottery ticket, shall be collected for the payment of Megaplier prizes.

(g) Prize payout percentages per draw may vary. The Megaplier prize pool shall be carried forward to subsequent draws if all or a portion is not needed to pay the Megaplier prizes awarded in the current draw and held in the Megaplier prize pool.

(h) Any amount remaining in the Megaplier prize pool account at the end of this game shall be returned to the lotteries participating in the account after the end of all claim periods of all selling lotteries, carried forward to a replacement game or expended in a manner at the election of the members of the product group in accordance with Kansas law.

(i) Except as provided in these rules, all prizes awarded shall be paid as single payment set prizes. Instead of the Mega Millions set prize amounts, qualifying Megaplier plays will pay the amounts shown below when matched with the Megaplier number drawn:

Note: The Megaplier promotion and multiplier numbers do not apply to the Mega Millions or Just the Jackpot (JJ) grand prizes.

In certain rare instances, the Mega Millions set prize amount may be less than the amount shown. In such case, the Megaplier prizes will be a multiple of the changed Mega Millions prize amount announced after the draw.



For example, if the match 4+1 Mega Millions set prize amount of \$10,000 becomes \$2,000 under the rules of the Mega Millions game, then a Megaplier player winning that prize amount with a 4X multiplier would win \$8,000 (\$2,000 × 4).

(h) The following table sets forth the probability of the various Megaplier numbers being drawn during a single Mega Millions drawing. The group may elect to run limited promotions that may modify the multiplier features.

Megaplier	Probability of Prize Increase
5X—Prize won times 5	1 in 15
4X—Prize won times 4	3 in 15
3X—Prize won times 3	6 in 15
2X—Prize won times 2	5 in 15

Note: The Megaplier promotion and multiplier numbers do not apply to the Mega Millions or Just the Jackpot (JJ) grand prizes.

(i) The prize pool percentage allocated to the Megaplier set prizes shall be carried forward to subsequent draws if all or a portion of it is not needed to pay the set prizes awarded in the current draw or may be held in a prize reserve account.

(j) Pari-mutuel prizes for all prize amounts shall be paid, except as otherwise provided for in subsection (j) (3), as follows:

(1) If the total of the original Mega Millions set prizes and the Megaplier prize amounts awarded in a drawing exceeds the percentage of the prize pools allocated to the set prizes, then the amount needed to fund the set prizes (including the Megaplier prize amounts) awarded shall be drawn from the following sources, in the following order:

(A) the amount available in the set prize pool and the Megaplier prize pool, if any;

(B) an amount from the Mega Millions prize reserve account, if available in the account, not to exceed forty million dollars (\$40,000,000) per drawing.

(2) If, after these sources are depleted, there are not sufficient funds to pay the set prizes awarded (including Megaplier prize amounts), then the highest set prize (including the Megaplier prize amounts) shall become a pari-mutuel prize. If the amount of the highest set prize, when paid on a pari-mutuel basis, drops to or below the next highest set prize and there are still not sufficient funds to pay the remaining set prizes awarded, then the next highest set prize, including the Megaplier prize amount, shall become a pari-mutuel prize. This procedure shall continue down through all set prize levels, if necessary, until all set prize levels become pari-mutuel prize levels. In that instance, the money available from the funding sources listed in this rule shall be divided among the MM winning plays in proportion to their respective prize percentages. Mega Millions and Megaplier prizes will be reduced by the same percentage.

(3) By agreement with the Mega Millions lotteries, the Mega Millions lotteries shall independently calculate their set pari-mutuel prize amounts, including the Megaplier prize amounts. The party lotteries and the Mega Millions lotteries shall then agree to set the pari-mutuel

prize amounts for all lotteries selling the game at the lesser of the independently-calculated prize amounts.

(k) These amendments shall take effect with the drawing conducted on October 31, 2017. (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-1-29-10, Jan. 20, 2010; T-111-9-1-10, Aug. 18, 2010; amended, T-111-2-9-12, Dec. 14, 2011; amended, T-111-10-11-13, Aug. 14, 2013; amended, T-111-12-05-17, Oct. 11, 2017.)

**111-5-228. Name of the game; rules and regulations.** The Kansas lottery may conduct a lotto game entitled “Lotto America” beginning November 12, 2017, at 5:00 a.m., with draws conducted twice weekly on Wednesdays and Saturdays.

The rules and regulations for “Lotto America” game are contained in K.A.R. 111-5-228 through 111-5-241, and applicable generic rules are contained in K.A.R. 111-6-1 *et seq.* (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-5-229. Definitions.** The following definitions shall apply to the “Lotto America” game:

(a) “Advertised grand prize” shall mean the estimated annuitized grand prize amount as determined by the MUSL central office by use of the MUSL annuity factor and communicated through the selling lotteries prior to the grand prize draw. The “advertised grand prize” is not a guaranteed prize amount and the actual grand prize amount may vary from the advertised amount, except in circumstances where there is a guaranteed grand prize amount as described in these rules.

(b) “All Star Bonus” means the All Star Bonus Multiplier Promotion described in these rules.

(c) “Computer gaming system” or “lottery’s computer gaming system” means the Kansas Lottery’s central computer system which provides online games including, but not limited to the Lotto America game.

(d) “Drawing” or “Draw” means the formal draw event for randomly selecting the winning numbers that determine the number of winners for each prize level of the Lotto America game.

(e) “Computer pick” or “quick pick” means the random selection of numbers by the computer that appear on a ticket and are played by a player in the game.

(f) “Game ticket” or “ticket” means an acceptable evidence of play, which is a ticket produced in a manner that meets the specifications of the Kansas lottery and is a physical representation of the play or plays sold to the player.

(g) “Grand prize” means the top prize in the Lotto America game.

(h) “Lotto America Play” means the plays purchased as part of the Lotto America game, but shall not include the All Star Bonus Multiplier plays.

(i) “MUSL” means the Multi-State Lottery Association, a government-benefit association wholly owned and operated by the party lotteries.

(j) “MUSL annuity factor” means the annuity factor as determined by the MUSL central office through a method approved by the MUSL finance and audit committee and which is used as described in these rules.

(continued)

(k) "MUSL board" means the governing body of the MUSL, which is comprised of the chief executive officer of each party lottery.

(l) "MUSL finance and audit committee" means the committee of that name established by the MUSL board.

(m) "Participating lottery" or "selling lottery" means a state lottery or lottery of a political subdivision or entity that is authorized by the product group to participate in selling the Lotto America game.

(n) "Party lottery" or "member lottery" means a state lottery or lottery of a political subdivision or entity that has joined the MUSL and, in the context of these rules, that is authorized to sell the Lotto America game.

(o) "Play" or "bet" means a set of six (6) numbers, the first five (5) from a field of fifty-two (52) numbers and the last one (1) from a field of ten (10) numbers, that appear on a ticket or communicated in a ticketless transaction as a single lettered selection and are to be played by a player in the Lotto America game. Each play is played separately in determining matches to winning numbers and prize amounts. As used in these rules, unless otherwise specifically indicated, "play" or "bet" includes Lotto America plays. "All Star Bonus Multiplier Plays" are separately described in these rules.

(p) "Play slip or "bet slip" means a physical means by which a player communicates his or her intended play selection to the retailer as approved by the Kansas lottery.

(q) "Product group" or "the group" means a group of lotteries that has joined together to offer a product pursuant to the terms of the Multi-State Lottery agreement and the product group's own rules.

(r) "Retailer" or "agent" means a person or entity authorized by the Kansas lottery to sell lottery plays.

(s) "Set Prize," also referred to as "low-tier" prize (single payment prize), means all other prizes except the grand prize and, except in instances outlined in these rules, will be equal to the prize amount established by the product group for the prize level.

(t) "Terminal" means a device authorized by a selling lottery to function in an online, interactive mode with the computer gaming system for the purpose of issuing lottery tickets and entering, receiving, and processing lottery transactions, including making purchases, validating tickets, and transmitting reports.

(u) "Winning numbers" means the indicia randomly selected during a draw event which shall be used to determine winning plays for the Lotto America game contained on a game ticket. (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

### **111-5-230. Game description; retail sale of tickets.**

(a) "Lotto America" is a five (5) out of fifty-two (52) plus one (1) out of ten (10) numbers lottery game drawn every Wednesday and Saturday as part of the Lotto America draw event, which pays the grand prize, at the election of the player made in accordance with these rules or by a default election made in accordance with these rules, either on an annuitized pari-mutuel basis or as a single lump sum payment of the total funding held in the grand prize pool (GPP) for the winning draw on a pari-mutuel basis. Except as provided in these rules, all other prizes are paid on a single payment basis.

(b) Lotto America winning numbers applicable to determine Lotto America prizes will be determined in the Lotto America draw event. During the draw event, five (5) numbers shall be drawn from the first set of fifty-two (52) numbers, and one (1) number shall be drawn from the second set of ten (10) numbers, which shall constitute the winning numbers.

(c) To play Lotto America, a player shall select (or computer pick) five (5) different numbers, from one (1) through fifty-two (52) and one (1) additional number from one (1) through ten (10). The additional number may be the same as one of the first five numbers selected by the player.

(d) Plays can be purchased for one dollar (\$1.00).

(e) Plays may be purchased from a terminal operated by a Kansas lottery retailer. The player may select a set of five numbers and one additional number by:

(1) communicating the six numbers to the retailer;

(2) marking six numbered circles in any one game board on a play slip and submitting the play slip to the retailer; or

(3) requesting a "computer pick" or "quick pick" from the retailer.

A player may choose the All Star Bonus multiplier option by marking the appropriate box on the play slip or by communicating to the retailer the desire to play the All Star Bonus multiplier option. If the All Star Bonus multiplier option is chosen, it shall apply to all boards played on that play slip. For each board upon which the All Star Bonus multiplier option is chosen, the player shall pay one additional dollar.

The retailer shall then issue a ticket from the terminal containing the selected set or sets of numbers, each of which constitutes a game play, and if applicable, whether or not the All Star Bonus multiplier option has been chosen for all plays on that play slip.

Plays may only be entered manually using the lottery terminal keypad or touch screen or by means of a play slip as approved by the Kansas lottery. Retailers shall not permit the use of play slips that are not approved by the Kansas lottery. Retailers shall not permit any device to be physically or wirelessly connected to a lottery terminal to enter plays, except as approved by the Kansas lottery.

(f) The maximum number of consecutive drawings on a single play purchase is fifteen (15).

(g) A validated ticket shall be the only proof of a game play or plays. The only method of claiming a prize or prizes shall be the submission of the winning ticket to and receipt of the ticket by the lottery or its authorized agent. A play slip shall have no pecuniary or prize value and shall not be used as evidence of a play purchase or of numbers selected.

(h) A play may not be voided or cancelled by returning the ticket to the selling retailer, including tickets that are printed in error. The Kansas lottery has an approved method (defined in K.A.R. 111-2-4) of compensating retailers for plays that are not transferred to a player for reasons acceptable to the Kansas lottery. No play that is eligible for a prize can be returned to the Kansas lottery for credit. Plays accepted by retailers as returned plays and that cannot be re-sold shall be deemed owned by the bearer thereof unless the ticket has been signed.

(i) Ticket sales will end at approximately 8:59 p.m. central time (CT) on Wednesdays and Saturdays and will resume at approximately 9:04 p.m. central time (CT).

(j) Draws will be conducted by MUSL twice weekly, on Wednesdays and Saturdays after the game is closed at approximately 8:59 p.m. central time (CT) and the draw official has verified that the game is closed, under conditions and procedures promulgated by MUSL and the Kansas lottery.

(k) Each player shall be responsible for verifying the accuracy of the game play or plays and other data printed on the ticket. The placing of plays is done at the player's own risk through the online retailer who is deemed to be acting on behalf of the player in entering the play or plays. (Authorized by K.S.A. 2017 Supp. 74-8710; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-5-231. Prize pool; prize pool account, and prize reserve account.** (a) The prize pool for all prize categories shall consist of 50.0% of each draw period's sales, inclusive of tax, and including contributions to the prize pool accounts and prize reserve accounts but may be higher or lower based upon the number of winners at each prize level.

(b) The following prize reserve accounts for the Lotto America game are hereby established:

(1) The prize reserve account (PRA) which is used to guarantee the payment of valid, but unanticipated, grand prize claims that may result from a system error or other reason; to fund deficiencies in low-tier Lotto America game prize payments (subject to the limitations of these rules); deficiencies in guaranteed grand prize funding if approved by the group; and for other purposes as established in these rules.

(c) The following prize pools for the Lotto America game are hereby established:

(1) The grand prize pool (GPP) which is used to fund the current grand prize;

(2) The set prize pool (SPP) which is used to fund the set prizes. The set prize pool shall hold the temporary balances that may result from having fewer than expected winners in the set prize (low-tier prize) categories. The source of the set prize pool is the party lottery's weekly prize contributions less actual set prize liability;

(3) The set-aside pool (SAP) which is used to fund the payment of the awarded minimum starting annuity grand prizes and the minimum annuity grand prize increase, if necessary (subject to the limitations in these rules), as may be set by the product group; and

(4) The grand prize carry forward pool (GPCFP), which is used to fund the starting minimum annuity grand prize, as may be set by the product group, if such funds are available, and if sales do not fund the grand prize.

(d) The grand prize carry forward pool and the set-aside pool may have maximum balance amounts or balance limiter triggers that are set by the product group.

The maximum balance amounts and balance limit triggers are subject to review by the MUSL board finance and audit committee. The finance and audit committee shall have two weeks to state objections, if any, to the approved maximum balance amounts or balance limiter triggers. Approved maximum balance amounts or

balance limiter triggers shall become effective no sooner than two weeks after notice is given to the finance and audit committee and no objection is stated or sooner if the committee affirmatively approves the maximum balance amounts and balance limiter triggers. The product group may appeal the finance and audit committee's objections to the full MUSL board. Product group approved changes in the maximum balance amounts or balance limiter triggers set by the product group shall be effective only after the next grand prize win.

(e) The maximum contribution rate to the grand prize pool shall be 46.1982 percent of the prize pool (23.0991 percent of sales).

An amount of a party lottery's sales shall be deducted from a party lottery's grand prize pool contribution and placed in trust in one or more prize pools and prize reserve accounts held by the product group (hereinafter the "Prize pool and reserve deduction") at any time that the set-aside pool and the party lottery's share of the prize reserve accounts is below the amounts designated by the product group.

An additional amount up to twenty percent (20%) of a party lottery's sales shall be deducted from a party lottery's grand prize pool contribution and placed in trust in the grand prize carry forward pool to be held by the product group at a time determined by the product group.

(f) The product group may determine to expend all or a portion of the funds in the Lotto America game prize pools and the prize reserve accounts except the grand prize pool and the grand prize carry forward pool for the purpose of indemnifying the party lotteries in the payment of prizes to be made by the selling lotteries, and for the payment of prizes or special prizes in the game, limited to prize pool and prize reserve contributions from lotteries participating in the special prize promotion, subject to the approval of the board's finance and audit committee or that committee's failure to object after given two weeks' notice of the planned action, which actions may be appealed to the full board by the product group. The grand prize carry forward pool may only be expended to fund the starting minimum annuity grand prize.

(g) The prize reserve shares of a party lottery may be adjusted with refunds to the party lottery from the prize reserve accounts as may be needed to maintain the approved maximum balance and sales percentage shares of the party lotteries.

(h) A party lottery may contribute to its sales percentage share of prize reserve accounts over time, but in the event of a draw down from the reserve account, a party lottery is responsible for its full sales percentage share of the account, whether or not it has been paid in full.

(i) Any amount remaining in the Lotto America game prize pools or prize reserve accounts when the product group declares the end of the game shall be returned to the lotteries participating in the prize pools and prize reserve accounts after the end of all claim periods of all selling lotteries, carried forward to a replacement game, or otherwise expended in a manner at the election of the individual members of the product group in accordance with jurisdiction statute. (Authorized by K.S.A. 2017 Supp. 74-8710; implementing K.S.A. 2017 Supp.

**111-5-232. Expected prize payout pari-mutuel prizes.** (a) The grand prize payout shall be determined on a pari-mutuel basis. Except as provided in these rules, all other prizes awarded shall be paid as single payment prizes. All prize payouts are made with the following expected approximate prize payout percentages, which does not include any amount contributed to or held in prize reserves, although the prize payout percentages per draw may vary:

(b) The prize money allocated to the grand prize category shall be divided equally by the number of Lotto America plays winning the grand prize.

(c) The set prize pool for single payment prizes of twenty thousand dollars (\$20,000) or less shall be carried forward to subsequent draws if all or a portion of it is not needed to pay the set prizes awarded in the current draw.

(d) If the total of the Lotto America game set prizes (as multiplied by the All Star Bonus multiplier, if applicable) awarded in a draw exceeds the percentage of the prize pool allocated to the Lotto America game set prizes, then the amount needed to fund the Lotto America game set prizes, including All Star Bonus multiplier prizes, awarded shall be drawn from the following sources, in the following order:

(1) the amount available in the set prize pool and the All Star Bonus multiplier prize pool;

(2) an amount from the prize reserve account, if available, not to exceed the balance of the prize reserve account; and

(3) an amount from the set aside pool, if available, not to exceed the balance of that pool.

(e) If, after these sources are depleted, there are not sufficient funds to pay the set prizes, including the All Star Bonus multiplier prizes, then the highest set prize shall become a pari-mutuel prize. If the amount of the highest set prize, including All Star Bonus multiplier prizes, when paid on a pari-mutuel basis, drops to or below the next highest set prize and there are still not sufficient funds to pay the remaining set prizes awarded, including All Star Bonus multiplier prizes, then the next highest set prize shall become a pari-mutuel prize. This procedure shall continue down through all set prize levels, if necessary, until all set prize levels become pari-mutuel prize levels. In that instance, the money available from the funding sources listed in this rule shall be divided among the winning plays in proportion to their respective prize percentages. Lotto America game prizes and All Star Bonus multiplier prizes will be reduced by the same percentage. (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-5-233. Probability of winning.** (a) The following table sets forth the probability of winning and the probability of winning and the probable distribution of winners in and among each prize category based upon the total number of possible combinations in Lotto America:

**111-5-234. Prize payments; annuitized and cash prizes.** (a) Grand prizes shall be paid, at the election of the player made no later than 60 days after the player becomes entitled to a prize, with either a per-winner annuity or single lump sum payment. If the payment election is not made by the player within 60 days after the player becomes entitled to the prize, then the prize shall be paid as an annuity prize. The election to take the cash option payment may be made at the time of the prize claim or within 60 days after the player becomes entitled to the prize. An election made after the winner becomes entitled to the prize is final and cannot be revoked, withdrawn or otherwise changed.

(b) Shares of the grand prize shall be determined by dividing the cash available in the grand prize pool equally among all winning plays of the grand prize. Winner(s) who elected a cash payment shall be paid their share(s) in a single cash payment. The annuitized option prize shall be determined by multiplying a winner's share of the grand prize pool by a process as approved by the MUSL board. Neither MUSL nor the selling lotteries shall be responsible or liable for changes in the advertised or estimated annuity prize amount and the actual amount purchased after the prize payment method is actually known to MUSL.

(c) In certain instances announced by the product group, the grand prize shall be a guaranteed amount and shall be determined pursuant to MUSL rules.

(d) If individual shares of the grand prize pool funds held to fund an annuity is less than \$250,000, the product group, in its sole discretion, may elect to pay the winners their share of the funds held in the grand prize pool.

(e) All annuitized prizes shall be paid annually in thirty (30) payments with the initial payment being made in a single payment, to be followed by twenty-nine (29) payments funded by the annuity. All annuitized prizes shall be paid annually in thirty (30) graduated payments (increasing each year) by a rate as determined by the product group. Prize payments may be rounded down to the nearest one thousand dollars (\$1,000). Annual payments after the initial payment shall be made by the lottery on the anniversary date or if such date falls on a non-business day, then the first business day following the anniversary date of the selection of the grand prize winning numbers.

(f) Funds for the initial payment of an annuitized prize or the lump sum cash option prize payment shall be made available by MUSL for payment by the selling lottery no earlier than the fifteenth calendar day (or the next banking day if the fifteenth day is a holiday) following the drawing. If necessary, when the due date for the payment of a prize occurs before the receipt of funds in the prize pool trust sufficient to pay the prize, the transfer of funds for the payment of the full lump sum cash option amount may be delayed pending receipt of funds from the selling lotteries. A paying lottery may elect to make the initial payment from its own funds after validation, with notice to MUSL.

(g) If a party lottery purchases or holds the prize payment annuity for a prize won in that jurisdiction, that

party lottery's game rules, and any prize payment agreement with the prize winner, shall indicate that the prize winner has no recourse on the MUSL or any other party lottery for payment of that prize.

(h) In the event of the death of a lottery winner during the annuity payment period, the MUSL finance and audit committee, in its sole discretion excepting a discretionary review by the product group, upon the petition of the estate of the lottery winner (the "estate") to the lottery and subject to federal, state, or applicable laws, may accelerate the payment of all of the remaining lottery proceeds to the estate. If such a determination is made, then securities and/or cash held to fund the deceased lottery winner's annuitized prize may be distributed to the estate. The identification of the securities to fund the annuitized prize shall be at the sole discretion of the finance and audit committee or the product group.

(i) If a party lottery purchases or holds the prize payment annuity for a prize won in that jurisdiction, that party lottery's game rules, and any prize payment agreement with the prize winner, shall indicate that the prize winner has no recourse on the MUSL or any other party lottery for payment of that prize.

(j) All prizes (whether described as "cash" payment prizes or otherwise) shall be paid through the selling lottery which sold the winning play(s) and at the discretion of the selling lottery that sold the winning play(s) may be paid by cash, check, warrant, or electronic transfer. A selling lottery may begin paying low-tier cash prizes after receiving authorization to pay from the MUSL central office.

(k) Annuitized payments of the grand prize or a share of the grand prize may be rounded to facilitate the purchase of an appropriate funding mechanism. Breakage on an annuitized grand prize win shall be added to the first cash payment to the winner or winners. Prizes other than the grand prize, which, under these rules, may become single-payment, pari-mutuel prizes, may be rounded down so that prizes can be paid in multiples of whole dollars. Breakage resulting from rounding these prizes shall be carried forward to the prize pool for the next draw.

(l) If the grand prize is not won in a draw, the prize money allocated for the grand prize shall roll over and be added to the grand prize pool for the following draw.

(m) The product group may offer guaranteed minimum grand prize amounts or minimum increases in the grand prize amount between draws or make other changes in the allocation of prize money where the product group finds that it would be in the best interest of the game. If a minimum grand prize amount or a minimum increase in the grand prize amount between draws is offered by the product group, then the grand prize shares shall be determined as follows:

(1) If there are multiple grand prize winners during a single draw, each selecting the annuitized option prize, then a winner's share of the guaranteed annuitized grand prize shall be determined by dividing the guaranteed annuitized grand prize by the number of winning plays;

(2) If there are multiple grand prize winners during a single draw and at least one of the grand prize winners

*(continued)*

has elected the annuitized option prize, then the MUSL annuity factor shall be utilized to determine the cash pool. The cost of the annuitized prize(s) will be determined at the time the annuity is purchased through a process as approved by the MUSL board; or

(3) If no winner of the grand prize during a single draw has elected the annuitized option prize, then the amount of cash in the grand prize pool shall be an amount equal to the guaranteed annuitized amount divided by the MUSL annuity factor.

(n) Minimum guaranteed prizes or increases may be waived by the product group if the alternate funding mechanism set out in these rules becomes necessary. Approval of the group is required to change the guaranteed minimum grand prize amounts or minimum increases in the grand prize amount. Any reduction in the guaranteed minimum grand prize amount or reduction in the minimum increases to the grand prize amount shall not become effective until after a grand prize win following the action taken by the group.

(o) The holder of a winning play may win only one prize per play in connection with the winning numbers drawn and shall be entitled only to the prize won by those numbers in the highest matching prize category. All liabilities for a Lotto America prize are discharged upon payment of a prize claim.

(p) All prizes must be claimed within 365 calendar days of the day of the draw in which the prize was won pursuant to K.A.R. 111-6-5(e) and 111-5-236(d). (Authorized by K.S.A. 2017 Supp. 74-8710; implementing 2017 Supp. K.S.A. 74-8710 and K.S.A. 74-8731; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-5-235. Ticket validation requirements.** To be a valid play and eligible to receive a prize, a ticket shall satisfy all the requirements established by the Kansas lottery pursuant to K.A.R. 111-6-7 for validation of winning plays sold through its computer gaming system and any other validation requirements adopted by the product group, the MUSL board, and published as the confidential MUSL minimum game security standards. The MUSL and the Kansas lottery shall not be responsible for tickets which are altered in any manner. (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-5-236. Claiming prizes; procedure and time period.** (a) Under no circumstances will a claim be paid for any prize without an official Lotto America ticket matching all game play, serial number, and other validation data residing in the Kansas lottery's computer gaming system and shall be the only valid proof of the wager placed and the only valid receipt for claiming or redeeming the prize.

(b) In order to be deemed a valid, winning play, all of the following conditions must be met:

(1) The validation data must be present in its entirety and must correspond, using the computer validation file, to the number selections printed on the ticket for the draw date(s) printed on the ticket;

(2) The ticket must be intact;

(3) The ticket must not be mutilated, altered, reconstituted, or tampered with in any manner;

(4) The ticket must not be counterfeit or an exact duplicate of another winning ticket;

(5) The ticket must not have been stolen, to the knowledge of the Kansas lottery;

(6) The play data must have been recorded on the computer gaming system prior to the draw and the play data must match this computer record in every respect. In the event of a contradiction between information as printed on the ticket and as accepted by the Kansas lottery's computer gaming system, the wager accepted by the Kansas lottery's computer gaming system shall be the valid wager;

(7) The player or computer pick number selections, validation data, and the draw date(s) of an apparent winning play must appear on the official file of winning plays, and a play with that exact data must not have been previously paid;

(8) The play must not be misregistered, and the play's ticket must not be defectively printed or produced in error to an extent that it cannot be processed by the Kansas lottery;

(9) The play must pass all confidential security checks of the Kansas lottery;

(10) In submitting a play for validation, the claimant agrees to abide by applicable laws, all rules and regulations, instructions, conditions and final decisions of the executive director of the Kansas lottery;

(11) There must not be any other breach of these rules in relation to the play that, in the opinion of the executive director of the Kansas lottery, justifies invalidation; and,

(12) The play must be submitted to the party lottery that issued it;

(13) The ticket must have been issued by an authorized Kansas lottery retailer on official paper stock of the Kansas lottery.

(b) A play submitted for validation that fails any of the validation conditions shall be considered void, subject to the following determinations:

(1) In all cases of doubt, the determination of the Kansas lottery shall be final and binding; however, the Kansas lottery may, at its option, replace an invalid play with a play of equivalent sales price;

(2) In the event a defective ticket is purchased or in the event the Kansas lottery determines to adjust an error, the claimant's sole and exclusive remedy shall be the replacement of such defective or erroneous ticket(s) with a play of equivalent sales price; and,

(3) In the event a play is not paid by the Kansas lottery and a dispute occurs as to whether the play is a winning play, the Kansas lottery may, at its option, replace the play as provided in these rules. This shall be the sole and exclusive remedy of the claimant unless laws or regulations governing the Kansas lottery provide further administrative review.

(c) The procedures for payment of a "Lotto America" prize on any single game ticket of \$599 or less, are as follows:

(1) The claimant of a ticket purchased in Kansas may present the ticket to any Kansas lottery retailer. Upon validation of the ticket, the retailer shall immediately make payment for the prize to the claimant. If the retailer cannot validate the ticket, the claimant shall fill out a claim form provided by the retailer and personally pres-

ent or mail the completed form together with the ticket to any office of the Kansas lottery. If the ticket is validated, then payment shall be made to the claimant by mail;

(2) The claimant may bring the ticket to any office of the Kansas lottery during the hours that the office is open to the public for business. Upon validation of the ticket, and completion of a claim form, payment shall be processed for the claimant; or

(3) The claimant may mail the ticket with a completed claim form in any envelope to the office of the Kansas lottery. Claim forms may be obtained from any Kansas lottery retailer, the Internet, or the office of Kansas lottery headquarters. Upon receipt of the ticket and completed claim form and validation of the ticket, payment shall be processed for the claimant.

If any evidence of alteration, mutilation, tear, or other ambiguity appears on the ticket, the retailer shall not make direct payment of a prize. The claimant shall submit a claim form with the ticket to the lottery.

(c) The procedure for the payment of a Lotto America prize on any single game ticket which totals six hundred dollars (\$600) or more shall be as follows:

(1) The claimant may bring the signed ticket to any office of the Kansas lottery during the hours that the office is open to the public for business. Upon validation of the ticket and completion of a claim form, payment shall be processed for the claimant; or

(2) The claimant may mail the ticket with a completed claim form to the office of the Kansas lottery. Claim forms may be obtained from any Kansas lottery retailer, the Internet, or the office of Kansas lottery headquarters. Upon receipt of the ticket and completed claim form and validation of the ticket, payment shall be processed for the claimant.

(d) All prizes shall be claimed within 365 calendar days of the draw in which the prize was won. Any prize or prizes not claimed within the time specified shall be forfeited. If a prize is claimed by mail, the ticket and claim form must actually be received by the lottery within the claim period. (Authorized by K.S.A. 2017 Supp. 74-8710; implementing K.S.A. 2017 Supp. 74-8710 and 74-8720; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-5-237. Ticket responsibility.** (a) Prize claim procedures shall be governed by the rules of the Kansas lottery. The MUSL and the Kansas lottery shall not be responsible for prizes that are not claimed following the proper procedures as determined by the Kansas lottery.

(b) The product group, the MUSL, and the party lotteries shall not be responsible for lost or stolen plays.

(c) The Kansas lottery shall not be responsible to a prize claimant for plays redeemed in error by a selling agent or retailer.

(d) Winners are determined by the numbers drawn and certified by the MUSL independent auditor responsible for auditing the draw. MUSL and the party lotteries are not responsible for winning numbers reported in error.

(e) If the signature of more than one person appears on the back of the ticket in the designated place, upon execution of a proper affidavit the lottery shall make payment to the person presenting the ticket whose signature appears on both the ticket and the winner claim form. If all persons whose signatures appear in the appropriate space cannot

identify one person to whom payment should be made, the lottery shall keep the prize until a determination of entitlement is made by the parties. In no event shall more than one person be entitled to a particular prize.

(f) It shall be the sole responsibility of the player to verify the accuracy of the game play or plays and other data printed on the ticket. (Authorized by K.S.A. 2017 Supp. 74-8710; implementing K.S.A. 2017 Supp. 74-8710 and K.S.A. 74-8720; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-5-238. Ineligible players.** (a) All provisions of K.S.A. 74-8718 and K.S.A. 74-8719, and amendments thereto, apply to the "Lotto America" game.

(b) A play or share issued by the MUSL or any of its party lotteries shall not be purchased by, and a prize won by any such play or share shall not be paid to:

(1) a MUSL employee, officer or director;

(2) a contractor or consultant under agreement with the MUSL to review the MUSL audit and security procedures;

(3) an employee of an independent accounting firm under contract with MUSL to observe drawings or site operations and actually assigned to the MUSL account and all partners, shareholders, or owners in the local office of the firm; or

(4) an immediate family member (parent, stepparent, child, stepchild, spouse, or sibling) of an individual described in subsections (b)(1), (b)(2) and (b)(3) and residing in the same household. (Authorized by K.S.A. 2017 Supp. 74-8710; implementing K.S.A. 2017 Supp. 74-8718 and K.S.A. 74-8719; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-5-239. Applicable law.** (a) In purchasing a play, or attempting to claim a prize, purchasers and prize claimants agree to comply with and abide by all applicable laws, rules, regulations, procedures, and decisions of the Kansas lottery and by directives and determinations of the executive director of the Kansas lottery.

(b) A prize claimant agrees, as its sole and exclusive remedy that claims arising out of a Lotto America play can only be pursued against the selling lottery which issued the play. Litigation, if any, shall only be maintained within the jurisdiction in which the Lotto America play was purchased and only against the selling lottery that issued the play. No claim shall be made against any other participating lottery or against the MUSL.

(c) Nothing in these rules shall be construed as a waiver of any defense or claim the selling lottery which issued the play, any other participating lottery or MUSL may have in any litigation, including in the event a player or prize claimant pursues litigation against the selling lottery, any other participating lottery or MUSL, or their respective officers, directors, or employees.

(d) All decisions made by a selling lottery, including the declaration of prizes and the payment thereof and the interpretation of Lotto America rules, shall be final and binding on all play purchasers and on every person making a prize claim in respect thereof, but only in the jurisdiction where the Lotto America play was issued.

(e) Unless the laws, rules, regulations, procedures, and decisions of the lottery which issued the play provide otherwise, no prize shall be paid upon a play purchased, claimed, or sold in violation of these rules or the laws,

(continued)

rules, regulations, procedures, and decisions of that selling lottery; any such prize claimed but unpaid shall constitute an unclaimed prize under these rules and the laws, rules and regulations, procedures, and decisions of that selling lottery. (Authorized by K.S.A. 2017 Supp. 74-8710; implementing K.S.A. 74-8719; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-5-240. Multi-Draw.** (a) In addition to a single play for each \$1.00, a player may also have his or her selections entered in multiple Lotto America draws. Multi-draw tickets must be purchased for consecutive draws beginning with the next draw. This is done by marking one of the multi-draw boxes designated by 2, 3, 4, 5, 10, or 15 on the play slip. The additional draw period(s) for which the ticket is valid will then appear on the computer generated ticket given to the player by the retailer.

(b) A player must pay an additional \$1.00 per play for each additional draw in which he or she wishes to play.

(c) Unless one of the multi-draw boxes is marked and the additional amount paid, the play will only be eligible for the current draw up to 8:59 p.m. the day of the draw.

(d) A player may purchase only the same numbers on the same boards for multiple draws. (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-5-241. Lotto America All Star Bonus promotion.** (a) The Kansas lottery shall offer players the opportunity to participate in the Lotto America All Star Bonus multiplier option, which is a limited extension of the Lotto America game and is conducted in accordance with the Lotto America Game rules and other lottery rules applicable to the Lotto America game except as may be amended herein. The promotion will begin on November 12, 2017, and will continue until discontinued by the Kansas lottery. The promotion will offer to the owners of a qualifying Lotto America play a chance to multiply the amount of any of the eight lump sum set prizes (the lump sum prizes normally paying \$2 to \$20,000) won in a draw held during the promotion. The grand prize is not a set prize and will not be multiplied.

(b) A qualifying play is any single Lotto America game play for which the player pays an extra dollar (\$1) for the All Star Bonus multiplier option and that is recorded at the Kansas lottery’s computer gaming system as a qualifying All Star Bonus multiplier play.

(c) Except as provided in these rules, a qualifying play which wins one of the set prizes will be multiplied by the number selected, either two, three, four, or five (2, 3, 4, or 5) in a separate random All Star Bonus multiplier drawing announced by the product group.

(d) MUSL will conduct a separate random “All Star Bonus” draw and announce the results. During each 2-5X multiplier draw, a single number (2, 3, 4, or 5) shall be drawn. The Lotto America game group may modify the multiplier features for special promotions from time to time.

(e) The All Star Bonus multiplier prize pool (MPP) is hereby created and which is used to fund All Star Bonus multiplier prizes. The multiplier prize pool shall hold the temporary balances that may result from having fewer than expected winners in the All Star Bonus multiplier. The source of the multiplier prize pool is the party lot-

tery’s prize contributions less actual All Star Bonus multiplier prize liability.

(f) In total, fifty percent (50%) of each draw’s sales shall be collected for the payment of prizes. The expected payout for all prize categories shall consist of up to forty-nine and five hundred ninety-eight thousandths percent (49.598%) of each draw period’s sales to be included in the price of a lottery ticket. An additional four hundred two thousandths percent (0.402%) of each drawing period’s sales may be collected and placed in trust in the multiplier prize pool for the purpose of paying All Star Bonus multiplier prizes.

(g) The prize payout percentage per draw may vary. The multiplier prize pool shall be carried forward to subsequent draws if all or a portion of it is not needed to pay the set prizes awarded in the current draw and held in the multiplier prize pool.

(h) Any amounts remaining in the multiplier prize pool when the product game declares the end of this game shall be returned to the lotteries participating in the pool after the end of all claim periods of all party lotteries, carried forward to a replacement game, or otherwise expended in a manner as directed by the individual members of the product group in accordance with jurisdiction law.

(i) Except as provided in these rules, all prizes awarded shall be paid as lump sum set prizes. Instead of the Lotto America game set prize amounts, qualifying All Star Bonus multiplier plays will pay the following amounts:

In certain instances the Lotto America game set prize amount may be less than the amount shown. In such case, the eight (8) lowest Lotto America prizes will be changed to an amount announced after the draw.

(j) The following table sets for the probability of the various All Star Bonus multiplier numbers being drawn during a single 5X multiplier draw. The Lotto America group may elect to run limited promotions that may modify the multiplier features:

All Star Bonus multiplier does not apply to the grand prize.

(k) If the total of the original Lotto America game set prizes and the multiplied All Star Bonus multiplier set prizes awarded in a draw exceeds the percentage of the prize pools allocated to the set prizes and All Star Bonus multiplier prizes, then the amount needed to fund the



set prizes (including the All Star Bonus multiplier prize amounts) awarded shall be drawn from the following sources, in the following order:

(1) the amount available in the set prize pool allocated to the set prizes and the multiplier pool prize, if any;

(2) an amount from the prize reserve account, if available, not to exceed the balance of the prize reserve account; and

(3) an amount from the set aside pool, if available, not to exceed the balance of that pool.

If, after these sources are depleted, there are not sufficient funds to pay the set prizes awarded (including All Star Bonus multiplier prizes), then the highest set prize (including the All Star Bonus multiplier prizes) shall become a pari-mutuel prize. If the amount of the highest set prize (including the All Star Bonus multiplier prizes) when paid on a pari-mutuel basis, drops to or below the next highest set prize (including the All Star Bonus multiplier prizes) and there are still not sufficient funds to pay the remaining set prizes awarded, then the next highest set prize (including the All Star Bonus multiplier prize) shall become a pari-mutuel prize. This procedure shall continue down through all set prize levels, if necessary, until all set prize levels become pari-mutuel prize levels. In that instance, the money available from the funding sources listed in this rule shall be divided among the winning plays in proportion to their respective prize percentages. Lotto America game and All Star Bonus multiplier prizes will be reduced by the same percentage.

(l) All Star Bonus multiplier prizes shall be paid in one lump sum through the Kansas lottery. The Kansas lottery may begin paying All Star Bonus multiplier prizes after receiving authorization to pay from the MUSL central office.

(m) Prizes that, unless under these rules, may become pari-mutuel prizes, may be rounded down so that prizes can be paid in multiples of whole dollars. Breakage resulting from rounding these prizes shall be carried forward to the multiplier prize pool for the next draw. (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-5-242. Just the Jackpot promotion.** (a) The Mega Millions Just the Jackpot promotion is a limited extension of the Mega Millions game and is conducted in accordance with the Mega Millions game rules and other lottery rules applicable to the Mega Millions game except as may be amended herein. The promotion will begin on October 28, 2017, at 5:00 a.m. The promotion will continue until it is discontinued by the Kansas lottery.

(b) The promotion will offer to players a chance to purchase two (2) Just the Jackpot plays (JJ Plays) for three dollars (\$3.00). Each Just the Jackpot play purchased will qualify the player for a chance to win the grand prize, but no other prize levels.

(c) A Just the Jackpot play must match exactly all of the Mega Millions grand prize winning numbers in order to win the Mega Millions grand prize. A Just the Jackpot play is not eligible to win non-grand prizes/non-jackpot prizes in the Just the Jackpot promotion.

(d) Just the Jackpot winning plays will be paid the Mega Millions grand prize, at the election of the player or by a default election made in accordance with these rules, either on a graduated annuitized annual pari-mutuel basis

or as a cash value option using a rate determined by the Mega Millions finance committee on a pari-mutuel basis. All provisions in these rules regarding payment of the Mega Millions grand prize are applicable to Just the Jackpot winning plays.

(e) The winning numbers for Just the Jackpot promotion shall be the winning numbers for the grand prize drawn in the Mega Millions drawing. Mega Millions winning numbers applicable to determine Just the Jackpot prizes will be drawn on the days, times, and locations as determined by the Mega Millions lotteries.

(f) To play Just the Jackpot, a player shall select (or quick pick) two (2) sets of five (5) different numbers, from one (1) through seventy (70) and one (1) additional number from (1) through twenty-five (25). The additional number may be a same number as one of the first five numbers selected by the player. Each set of numbers shall constitute a single lettered selection, or single play. The two (2) sets of numbers selected in each three dollar (\$3.00) Just the Jackpot purchase may be the same. The two (2) plays for each three dollar (\$3.00) Just the Jackpot plays purchase shall be for the same drawing, although a lottery may sell multi-draw Just the Jackpot plays as well in the same increments as Mega Millions multi-draw tickets.

(g) The purchase price of Just the Jackpot plays shall be three dollars (\$3.00) for two (2) single lettered selections of Just the Jackpot plays. Just the Jackpot plays may be purchased from any Kansas lottery retailer. Just the Jackpot plays must be printed on separate tickets from Mega Millions plays and must clearly indicate the plays are for the Just the Jackpot promotion. Each Just the Jackpot play is played separately in determining matches to winning numbers and prize amounts.

(h) The grand prize will not be multiplied or increased by means of the Megaplier promotion.

(i) The prize pool for Just the Jackpot plays shall consist of up to fifty-five percent (55%) of each drawing period's sales, inclusive of any specific statutorily-mandated tax of a party lottery to be included in the price of a lottery's Just the Jackpot play, and inclusive of contributions to the prize pool accounts and prize reserve accounts, but may be higher or lower based on the funding required to meet a guaranteed annuity grand prize as may be required by these rules.

(j) The product group shall set the contribution rates to the Just the Jackpot prize pool and prize reserve accounts established by these rules. The contribution rate for Just the Jackpot plays to the grand prize pool shall be 50.2012% of sales.

An amount up to five percent (5%) of the Kansas lottery's Just the Jackpot play sales shall be added to the Kansas lottery's Just the Jackpot prize pool contribution and placed in trust in one (1) or more prize pool and prize reserve accounts held by the product group at any time the Kansas lottery's share of the prize reserve account is below the amounts designated by the product group. All provisions regarding the grand prize pool and prize reserve account as described in these rules are applicable to Just the Jackpot play contributions to the grand prize pool and prize reserve account.

*(continued)*

(k) The Mega Millions JJ grand prize payout shall be determined on a pari-mutuel basis. All prize payouts are made with the following expected prize payout percentages, which does not include any additional amount contributed to or held in prize reserves:

\*Just the Jackpot prize pool percentage allocated to the grand prize shall be combined with Mega Millions prize pool percentage allocated to the grand prize.

(l) The grand prize amount shall be divided equally by the number of Mega Millions plays and Just the Jackpot plays winning the Mega Millions grand prize. (Authorized by and implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**Article 19. — SPECIFIC PLAYER LOYALTY CLUB RULES**

**111-19-24. Bass Pro \$500 gift card drawing.** (a) The Kansas lottery may conduct a “Bass Pro \$500 Gift Card” drawing awarding one \$500 Bass Pro gift card to a player selected as the winner. Entries into the drawing will be accepted beginning at 5:00 a.m. on December 1, 2017. Entry deadline is 12:00 p.m. on January 16, 2018. The drawing will be conducted sometime after the entry into the drawing has closed but before 12:00 p.m. on January 22, 2018, after which time the winner will be announced.

(b) A player shall enter the drawing through the Kansas lottery PlayOn program available at [www.kslottery.com](http://www.kslottery.com). The player shall follow the hyperlink specifically designated for the purpose of accessing the “Bass Pro \$500 Gift Card” drawing and shall redeem 150 PlayOn points to enter the drawing.

(c) One entrant shall win a Bass Pro \$500 gift card. Four entrants shall be drawn, and recorded in the order drawn. The first entry drawn shall be the winner of the Bass Pro gift card. The next three entrants selected, numbers 2 through 4, shall be used as alternate winners in the order drawn, if needed.

(d) A player may enter the drawing an unlimited number of times.

(e) A player who is selected as the prize winner in the drawing will be sent a claim form via U.S. mail. The winner must return his or her completed claim form, and the claim form must be received by the Kansas lottery within 14 days calendar following the date of the drawing. In the event an alternate winner is awarded a prize, that alternate winner must return his or her completed claim form and the claim form must be received by the Kansas lottery within 14 calendar days following the date the alternate winner was sent a claim form via U. S. mail or another alternate will be selected until all alternates are exhausted.

(f) The Kansas lottery reserves the right to substitute an alternate prize of approximate equal value.

(g) Only registered PlayOn members may enter the “Bass Pro \$500 Gift Card Drawing.” PlayOn members must enter themselves into the drawing according to the terms and conditions of PlayOn. Entries shall not be accepted which are submitted by any method other than through PlayOn.

(h) By entering the promotion, entrant agrees to PlayOn terms and conditions.

(i) Maximum liability of the Kansas lottery shall be one \$500 Bass Pro gift card per all entrants.

(j) Rules applicable to this promotion are contained in K.A.R. 111-19-24 and K.A.R. 111-18-1 *et seq.* (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-19-25. X Games Bonus Cash promotion.** (a) The Kansas lottery may conduct six drawings entitled “X Games Bonus Cash Promotion” awarding cash prizes to players selected as winners. Entries into the drawings will be accepted beginning at 5:00 a.m. on January 11, 2018. Entry deadline into the drawings is noon on October 8, 2018. The drawings will be conducted sometime after the entry into the drawings has closed but before 12:00 p.m. on October 11, 2018, after which time the winners will be announced.

(b) The specific tickets eligible for entry into these drawings shall be non-winning tickets for the following games: \$1 “5X The Cash,” game number 752; \$2 “10X The Cash,” game number 753; \$5 “20X The Cash,” game number 730; \$10 “50X The Cash,” game number 726, \$20 “\$100X The Cash,” game number 727 and \$30 “Multiplier Super Ticket,” game number 728.

(c) There shall be one drawing conducted for each of the six instant ticket games listed in subsection (b).

(d) A PlayOn member may shall enter a drawing by submitting a non-winning X Game ticket described in subsection (b) into PlayOn. Upon successful submission of an eligible ticket, the interactive game will automatically load into the PlayOn program. A player shall access the interactive game through the Kansas lottery PlayOn program available on mobile devices and at [www.kslottery.com](http://www.kslottery.com). The player shall follow the hyperlink specifically developed for the purpose of accessing the “X Games Bonus Cash Promotion.” The player may enter the required data from the instant ticket manually for entry into the drawing. If the player does not enter the ticket data manually, the player may scan, if available, the ticket to enter data to be used for entry into the drawing using a mobile device and a downloaded Kansas lottery PlayOn app. After the ticket data is successfully entered either manually or scanned using an app, the player will be given the option to play the interactive game now or later. Once the interactive game is played, the player will receive a random number of entries into the drawing based on ticket price and the probability matrix developed for the interactive game. Players are only able to enter the drawing associated with the specific ticket they are using to enter said drawing.

(e) Each drawing shall select six entrants. The first entrant selected in each drawing shall be the winner of a cash

prize. The next five entrants selected, numbers 2 through 6, shall serve as alternates in the order drawn, if needed.

(f) The first drawing conducted shall be from among the entrants in the \$1 "5X The Cash," game number 752, second-chance drawing. The cash prize awarded to the first entrant selected in the first drawing shall be \$1,000. The second drawing conducted shall be from among the entrants in the \$2 "10X The Cash," game number 753, second-chance drawing. The cash prize awarded to the first entrant selected in the second drawing shall be \$2,000. The third drawing conducted shall be from among the entrants in the \$5 "20X The Cash," game number 730, second-chance drawing. The cash prize awarded to the first entrant selected in the third drawing shall be \$5,000. The fourth drawing conducted shall be from among the entrants in the \$10 "50X The Cash," game number 726, second-chance drawing. The cash prize awarded to the first entrant selected in the fourth drawing shall be \$10,000. The fifth drawing conducted shall be from among the entrants in the \$20 "100X The Cash," game number 727, second-chance drawing. The cash prize awarded to the first entrant selected in the fifth drawing shall be \$20,000. The sixth drawing conducted shall be from among the entrants in the \$30 "Multiplier Super Ticket," game number 728, second-chance drawing. The cash prize awarded to the first entrant selected in the sixth drawing shall be \$30,000.

(g) A player may enter each specified ticket drawing an unlimited number of times. A player may win a prize in each promotional drawing.

(h) Each prize winner in each drawing will be notified via email and address information will be verified. A winner shall be sent a claim form via U.S. mail. The winner must return his or her completed claim form, and the claim form must be received by the Kansas lottery within 20 calendar days following the date of the online event drawing. In the event an alternate winner is awarded a prize, the winner must return his or her completed claim form and the claim form must be received by the Kansas lottery within 20 calendar days following the date the alternate winner was sent a claim form via U. S. mail or another alternate will be selected until all alternates are exhausted.

(i) Only registered PlayOn members may enter the "X Games Bonus Cash Promotion." PlayOn members must enter themselves into the drawings according to the terms and conditions of PlayOn. Entries shall not be accepted which are submitted by any method other than through PlayOn.

(j) By entering the promotion, entrant agrees to PlayOn terms and conditions.

(k) Liability is limited to ticket purchase price.

(l) Rules applicable to this promotion are contained in K.A.R. 111-19-25 and K.A.R. 111-18-1 *et seq.* (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

#### Article 401.—NORTHEAST GAMING ZONE

**111-401-50. Method of play.** In Seven Card Stud (Razz), the best five cards of the seven cards dealt determine the ranking of each player's hand.

(a) Starting with the first player to the left of the dealer and continuing in a clockwise rotation around the table, the dealer will deal two rounds of cards face down and one round of cards face up to each player.

(b) Once each player has received three cards, the first betting round will commence by comparing the up card of each player. For the purpose of this subsection only, in the event that two or more up cards are of the same rank, the up cards will then be ranked by suit, with the highest to lowest ranked suits in order as follows: spades, hearts, diamonds, and clubs. Betting begins with the player having the highest ranked card making a wager.

(c) Following the placement of the forced bet (the first bet made), each subsequent player may, proceeding in a clockwise rotation from the player who placed the forced bet, fold, call, or raise the bet. After the last player has responded to the most recent bet, the betting round will be considered complete.

(d) Upon completion of the first betting round, the dealer will burn the top card of the deck and then, starting with the first remaining player clockwise from the dealer, deal a fourth card face up to each player who has not folded. The next betting round will commence as follows:

(1) The player with the lowest hand showing is the first to act, and must bet or check (place no bet); or

(2) if the lowest ranking poker hand showing is held by two or more players, the player with the lowest ranking hand by suit will be required to bet or check.

(e) Following the initial bet or check required above, each subsequent player, proceeding in a clockwise rotation, may fold, call, raise, or check, but a player may check only if one or more of the preceding players have not made a bet. Each player may check until a bet is made. Players may check around the table with no wager for that round. Once a bet has been made, the next player in a clockwise rotation may fold, call, or raise. After the last player has responded to the most recent bet, the betting round will be considered complete.

(f) The dealer will then deal two additional rounds of cards face up and one round of cards face down to each player who has not folded, with each such round followed by a betting round conducted in accordance with the provisions in paragraph (e) herein. Prior to each round of cards being dealt, the dealer will burn the top card of the deck. Every effort should be made to deal each player his own hole card (the seventh card dealt to each player). This may require up to two additional cards than the number of remaining players. If insufficient cards remain in the deck to give each player a seventh and final card, the top card of the deck will be burned and a common card will be dealt face up in the center of the table. If there is one or no cards remaining in the deck, the dealer will shuffle the burn cards, burn a card, and then deal the common card.

(g) If more than one player remains in the round of play after the final betting round has been completed, a "showdown" will be used to determine the winner of the pot. "Showdown" means a situation when, if more than one player remains after the last betting round, remaining players expose and compare their hand rankings to determine the winner or winners, as follows:

(continued)

(1) Each player remaining in the game will form the lowest possible five card poker hand from the seven cards which were dealt;

(2) This five-card hand will constitute the poker hand of that player at showdown;

(3) The winner of the pot will be the player with the highest ranking low hand;

(4) The best possible hand in Razz is five, four, three, two and ace;

(5) Straights and flushes do not count against a player; and,

(6) If a tie exists between two or more players for the lowest ranking hand, the pot will be divided equally among the tied players. Whenever a pot cannot be split evenly, any odd chip will go to the player with the lowest card in the player's hand by suit.

(h) In Razz games, the Razzdugi option may also be offered. If the Razzdugi option is offered at the table, the following additional rules shall also apply:

(1) Razzdugi is a game variant where half of the pot shall be awarded to the highest ranking Razz hand and the other half of the pot shall be awarded to the player with the highest ranking Badugi hand. For the "Badugi" hand, a player uses up to four of their seven cards to construct their lowest possible hand but may only utilize one card of each suit and rank to do so. It is possible when making a Badugi hand for the hand value to contain less than four cards due to the unique rank and suit requirement of this game; however any hand made up of four unique cards of different suits automatically beats any hand made up of three cards, any hand made up of three unique cards automatically beats any hand made up of two cards and any hand made up of two unique cards of different suits automatically beats any hand made up of one card. If Badugi hands between two or more players contain the same number of cards, then they will be compared on their ranking. For purposes of Razzdugi, an ace is always low and the highest ranking Badugi hand is a four, three, two, and ace with all four cards being a different suit from the others.

(2) One player may win both pots;

(3) If the pot cannot be split evenly between the Razz pot and the Badugi pot, the odd chip will go to the highest ranking Razz hand; and,

(4) Whenever there is a tie for the Razz pot or the Badugi pot and either pot cannot be split evenly, any odd chip will go to player with the lowest card in the player's hand by suit. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-2-9-12, Dec. 14, 2011; amended, T-111-12-05-17, Oct. 11, 2017.)

**111-401-229. Name of the game; rules and regulations.** The Kansas lottery shall conduct a lottery facility game at the Hollywood Casino at Kansas Speedway in Kansas City, Kansas, entitled "Five-Card Draw Poker" beginning on or after November 1, 2017.

The rules and regulations for the game of "Five-Card Draw Poker" are contained in K.A.R. 111-401-229 through 111-401-234, and applicable generic rules are contained in K.A.R. 111-201-1 *et seq.* (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-401-230. Object of game.** Five-Card Draw Poker is played at a large table with a maximum number of 10 players using one standard deck of playing cards. The object of the game is for a player to either:

(a) create a five-card poker hand of a higher rank than the poker hand of all other players, or

(b) remain the only player in the hand after all other players have folded (quit the hand). (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-401-231. Definitions.** The following words and terms, when pertaining to the game of Five-Card Draw Poker, shall have the following meanings unless the context clearly indicates otherwise:

(a) "All in" means when a player who has no funds remaining on the poker table to continue betting in a round of play still retains the right to contend for that portion of the pot in which the player has already placed a bet.

(b) "Ante" means a predetermined wager, which a player may be required to make prior to any cards being dealt in order to participate in the round of play.

(c) "Bet" or "wager" means an action by which a player places gaming chips into the pot on any betting round.

(d) "Betting round" means a complete wagering cycle in a hand of poker.

(e) "Blind bet" means a forced bet that only players sitting in specific betting positions at the poker table shall be required to place prior to looking at any cards.

(f) "Burn a card" means to remove a card from the top of a deck, which is discarded face down, which card is not in play and the identity of which remains unknown.

(g) "Button" or "dealer button" means an object, which is moved clockwise around the table after each hand is complete to denote an imaginary dealer and thereby determine the betting and dealing sequence.

(h) "Call" means a wager made in an amount equal to the immediately preceding wager.

(i) "Check" means when a player waives the right to initiate the betting in a betting round but retains the right to act if another player initiates the betting.

(j) "Collection" means another name for the rake collected by the house, which may be a specified amount charged to each player or as a percentage of the pot for each hand.

(k) "Cut" means to divide a deck of playing cards into two parts in order to change the order of the cards without revealing the identity of any cards in the deck.

(l) "Deck" means a standard collection of 52 playing cards with the following 13 cards in each of four suits: 2, 3, 4, 5, 6, 7, 8, 9, 10, jack, queen, king, and ace.

(m) "Face card" means a king, queen, or jack.

(n) "Fold" means the withdrawal of a player from a round of play by discarding the player's hand of cards during a betting round and refusing to equal a wager.

(o) "Forced bet" means a wager, which is required to start the wagering on the first betting round.

(p) "Half-kill" means in the game of Five-Card Draw Poker when one player wins an entire qualifying pot, the betting limits are increased by one-half the posted table wagering limits for the next hand and remain in effect until a pot is split between one player winning the high hand and another player winning the low hand.

(q) "Hand" means one of two things, depending upon the context in which the term is used:

- (1) the cards available to a player to use; or
- (2) a complete round of play from the first ante or blind bet until the pot is awarded to a player.

(r) "Hole cards" means any cards dealt to a player face down, which are also "pocket cards," "in the hole," or "in the pocket."

(s) "Kill" means when one player wins an entire qualifying pot, the betting limits are twice the posted table wagering limits for the next hand and remain in effect until a pot is split between one player winning the high hand and another player winning the low hand.

(t) "Muck pile" means the stack of cards no longer available for use during a round of play.

(u) "Opening bet" means the first bet by each player in a round of play.

(v) "Pot" or "kitty" means the amount that is awarded to the winning player or players at the conclusion of a round of play and is equal to the total amount wagered by the players during the round of play minus any rake.

(w) "Raise" means a bet in an amount greater than the immediately preceding bet in that betting round.

(x) "Rake" means the amount of gaming chips collected on each hand by the dealer representing the predetermined amount to be included in net gaming revenue.

(y) "Round of plays" means the process by which cards are dealt, bets are placed and the winner of the pot is determined and paid in accordance with the rules of this game.

(z) "Showdown" means a situation when, if more than one player remains after the last betting round, remaining players expose and compare their hand rankings to determine the winner or winners.

(aa) "Stub" means all cards remaining in the deck that have not been dealt to the players.

(bb) "Suit" means one of the following four categories of cards: diamonds, spades, clubs, or hearts.

(cc) "Table stakes" means the gaming chips on the table, which are in play. A player may not add or subtract from his or her gaming chips at any time during a betting round of play.

(dd) "Up cards" means any card dealt face up to a player. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-401-232. Five-Card Draw Poker hand rankings.** (a) The rank of the cards used in Five-Card Draw Poker for the determination of winning hands, in order of highest to lowest rank, shall be: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3, and 2. All suits shall be considered equal in rank. Notwithstanding the foregoing, an ace may be used to complete a "straight flush" or a "straight" formed with a 2, 3, 4, and 5.

(b) The permissible poker hands in order of highest to lowest rank, shall be:

(1) "Royal flush" is a hand consisting of (an ace, king, queen, jack, and 10 of the same suit;

(2) "Straight flush" is a hand consisting of five cards of the same suit in consecutive ranking, with king, queen, jack, 10, and 9 being the highest ranking straight flush and ace, 2, 3, 4, and 5 being the lowest ranking straight flush;

(3) "Four-of-a-kind" is a hand consisting of four cards of the same rank regardless of suit, with four aces being the highest ranking four-of-a-kind and four 2s being the lowest ranking four of a kind;

(4) "Full house" is a hand consisting of a "three-of-a-kind" and a "pair," with the three aces and two kings being the highest ranking full house and three 2s and two 3s being the lowest ranking full house;

(5) "Flush" is a hand consisting of five cards on the same suit;

(6) "Straight" is a hand consisting of five cards of consecutive rank, regardless of suit with an ace, king, queen, jack, and 10 being the highest ranking straight and an ace, 2, 3, 4, and 5 being the lowest ranking straight, provided that an ace may not be combined with any other sequence of cards for purposes of determining a winning hand, (for example queen, king, ace, 2, 3);

(7) "Three-of-a-kind" is a hand consisting of three cards of the same rank regardless of suit, with three aces being the highest ranking three-of-a-kind and three 2s being the lowest ranking three-of-a-kind;

(8) "Two pairs" is a hand consisting of two "pairs," with two aces and two kings being the highest ranking two pair and two 3s and two 2s being the lowest ranking two pair; and

(9) "One pair" is a hand consisting of two cards of the same rank, regardless of suit with two aces being the highest ranking pair and two 2s being the lowest ranking pair;

(10) "High hand" is, when comparing two hands that are of otherwise identical poker rank, the hand with the highest-ranking card.

(c) When comparing two hands, if none of the above poker rankings are contained in a ranking hand, the hand with the highest-ranking card shall be considered the higher hand.

(d) If, after all five cards are compared and the hands are identical, they shall be considered a tie and the pot split equally among those players that are tied. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-401-233. Wagers.** (a) Only players who are seated at the poker table shall be permitted to receive cards and participate in each betting round.

(b) Depending upon the predetermined option for the poker game being dealt, a player may be required to:

(1) Place a predetermined ante prior to receiving any cards; or

(2) Place a predetermined blind bet prior to receiving any cards.

(c) A player may only participate in the wagering during a round of play with the table stakes gaming chips, which were already placed on the poker table in front of that player when the round of play commenced.

(d) A player may only add to his gaming chips between rounds of play and may not remove any of that player's gaming chips from the poker table at any time during ongoing play.

(e) A player who depletes his funds on the poker table prior to the completion of a round of play shall be deemed to be "all-in."

(continued)

(f) An “all-in” player shall retain financial interest in the outcome of the round of play, but shall only be eligible to win the amount of the pot to which that player contributed.

(g) An “all-in” player shall continue to receive any cards to which that player would normally be entitled.

(h) Betting shall continue unimpeded among the other players by generating a separate secondary pot that only those active players shall be eligible to win.

(i) A verbal statement of “fold,” “check,” “call,” “raise,” or an announcement of a specific size wager by a player, assuming it is within the rules herein and the minimum and maximum wager limits for the poker table, shall be binding on the player if it is that player’s turn to act.

(j) A player who announces a bet or raise of a certain amount but places a different amount of gaming chips in the pot shall be required to correct his or her bet or raise to the announced amount in accordance with the instructions of the dealer.

(k) A player shall be considered to have placed a wager if the player:

(1) Pushes gaming chips forward to indicate the intent of placing a wager;

(2) Releases gaming chips into the pot; or

(3) Releases gaming chips at a sufficient distance from the player and towards the pot to make it obvious that it is intended as a wager.

(l) A player shall not be permitted to make a wager and thereafter attempt to increase the amount of that wager.

(m) If the player wishes to add additional gaming chips to a wager, the player must indicate at the time the wager is being made that the wager is not yet complete.

(n) A player who puts the proper amount of gaming chips into the pot to call a wager, without indicating his or her intention to raise, may not thereafter raise the previous wager.

(o) No player may touch any of the gaming chips once placed into the pot until a decision on the hand has been made.

(p) Unless a raise has been verbally announced by that player, a player who puts into the pot a single gaming chip that is larger than required is assumed to have only called the preceding wager and to be awaiting change from the dealer.

(q) Unless specifically posted at the gaming table to the contrary, a player shall be permitted to raise after that player has previously checked in a betting round. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-401-234. Play.** (a) In Five-Card Draw Poker, the ranking of the five (5) cards dealt determine the ranking of each player hand. Each player has their own unique five (5) card hand and no community cards are used or shared between players. Five-Card Draw Poker may be played with High hand winning the pot (known as “Five-Card Draw High”) or with Low Hand winning the pot (known as “Lowball”). There are two variations of Lowball: “Five-Card Draw A-5 Lowball” and “Five-Card Draw 2-7 Lowball”. As play continues, players may, if they so choose, discard some or all of their cards and have them replaced by new unique cards. This is known

as the “draw.” There are two variants that determine the number of instances a player may draw cards. These two variants are known as “Single Draw” (where players have the option to draw new cards one time) or “Triple Draw” (where players have the option to draw new cards three times). In addition, certain Lowball games may offer the “Badacey” or “Badeucey” options. The name of the Five-Card Draw Poker game being played at a gaming table and variations thereof shall be posted at the gaming table.

(b) The order in which the cards will be dealt and the order in which players will be required or have the option to bet will be determined as follows:

(1) The “button” will be used to indicate an imaginary dealer;

(2) At the commencement of play, the dealer will shuffle, either manually or through the use of a shuffling machine, cut the cards and deliver one card to each player, starting with the player in the first position to the left of the dealer and continuing in a clockwise rotation around the table. The highest ranking card will receive the button and become the imaginary dealer; and,

(3) Thereafter, after each round of play the button will rotate around the table to each player in a clockwise manner.

(c) The first player to the left of the button (in a clockwise rotation) will be required to initiate the first betting round by placing a “blind” bet (Small Blind). Additional “blind” bets may also be required to be made immediately subsequent to the initial blind bet (Big Blind). The Small blind will be equal to or less than half of the table minimum wager. The Big Blind will be equal to or less than the table minimum wager. The amount of all blinds, if any, will be posted on a sign at the gaming table.

(d) Starting with the first player to the left of the dealer and continuing in a clockwise rotation around the table, the dealer will deal five rounds of cards face down to each player.

(e) In Five-Card Draw High, any card that is exposed by the dealer during the initial deal of cards must be kept by the player.

(f) In Five-Card Draw A-5 Lowball, if an ace, two, three, four or five card is exposed by the dealer during the initial deal of cards, it must be kept by the player and any other card must be replaced by the next card on the stub after the remainder of the deal is first completed. Exposed cards that are replaced are placed in the muck pile.

(g) In Five-Card Draw 2-7 Lowball, if a two, three, four, five, or seven is exposed by the dealer during the initial deal of cards, it must be kept by the player and any other card must be replaced by the next card on the stub after the remainder of the deal is first completed. Exposed cards that are replaced are placed in the muck pile.

(h) Following the placement of the “blind” bet(s) and delivery of the first five cards to each player, each player will in turn, in a clockwise rotation around the table, either fold, call or raise the bet. The option to raise will apply to the player who made the “blind” bet(s). After the last player has responded to the most recent bet, the betting round will be considered complete.

(i) Players who remain in the hand will now, in a clockwise manner starting at the dealer button, indicate how

many cards they wish to draw by placing those cards from their hand face down on the table in front of them for the dealer to collect.

(j) Players may discard any number of cards between zero (0) and five (5).

(k) The dealer will burn a card and deal to each player, starting clockwise of the button, a number of cards equal to the number of cards each player discarded for the draw.

(l) Any card exposed by the dealer during the draw may not be kept. Exposed cards will be placed in the muck pile and replaced by the next card on the stub after all remaining draw cards are dealt as normal.

(m) If the dealer runs out of cards, the dealer will deal all cards until the last card on the stub remains, at which time the last card on the stub will not be exposed and will then be combined and shuffled with all cards which were placed into the muck pile prior to the current draw phase in order to form a new stub, after which the draw will continue from where it left off.

(n) Each subsequent player may now, in clockwise rotation, fold, call, raise the bet or, if preceding players have not made a bet, make an opening bet or check. The betting round will be considered complete when each player has either folded or called the most recent bet.

(o) If all other players have folded and only one player remains, this player is declared the winner of the pot and the hand is complete. If more than one player remains, then:

(1) If the game type is designated as "Single Draw," continue to subsection (p); or,

(2) If the game type is designated as "Triple Draw," the dealer shall repeat the draw and betting rounds as set forth in subsections (i) through (o) above an additional two times as necessary (for a total of three draw phases and four betting rounds), and then continue to subsection (p).

(p) If more than one player remains in the round of play after the final betting round has been completed, a show-down will be used to determine the winner of the pot.

(q) Each player remaining in the game will show or discard their hand.

(r) Players remaining in the game will utilize all five of their cards to form their five-card poker hand.

(s) In Five-Card Draw High, the player with the highest ranking five-card poker hand will win the pot, as follows:

(1) If there is a tie for highest ranking hand the pot will be split as evenly as possible; and,

(2) Whenever a pot cannot be split evenly, any odd chip will go to the first player in action clockwise from the button.

(t) In Five-Card Draw A-5 Lowball, the player with the highest ranking five-card low hand will win the pot, as follows:

(1) The ranking of a five-card low hand shall be the inverse of the rankings for a five-card high hand;

(2) There is no minimum qualifying low hand;

(3) The highest ranking low hand is five, four, three, two, and ace;

(4) A straight or flush does not negatively impact hand value;

(5) An ace is always considered low;

(6) If there is a tie for highest ranking low hand the pot will be split as evenly as possible; and,

(7) Whenever a pot cannot be split evenly, any odd chip will go to the first player in action clockwise from the button.

(u) In Five-Card Draw A-5 Lowball games the Badacey option may also be offered. If the Badacey option is offered at the table, the following additional rules shall also apply:

(1) Badacey is a game variant where half of the pot shall be awarded to the highest ranking Five-Card Draw A-5 Lowball Poker Hand and the other half of the pot shall be awarded to the player with the highest ranking Badugi hand. For the "Badugi" hand, a player uses up to four of their five cards to construct their lowest possible hand but may only utilize one card of each suit and rank to do so. It is possible when making a Badugi hand for the hand value to contain less than four cards due to the unique rank and suit requirement of this game; however any hand made up of four unique cards of different suits automatically beats any hand made up of three cards, any hand made up of three unique cards automatically beats any hand made up of two cards and any hand made up of two unique cards of different suits automatically beats any hand made up of one card. If Badugi hands between two or more players contain the same number of cards, then they will be compared on their ranking. For purposes of Badacey, an ace is always low and the highest ranking Badugi hand is a four, three, two, and ace with all four cards being a different suit from the others;

(2) One player may win both pots;

(3) If the pot cannot be split evenly between the Five-Card Draw A-5 pot and the Badugi pot, the odd chip will go to the highest ranking Five-Card Draw A-5 Lowball Poker hand; and,

(4) Whenever there is a tie for the Five-Card Draw A-5 pot or the Badugi pot and either pot cannot be split evenly, any odd chip in that pot will go to the first player in action clockwise from the button.

(v) In Five-Card Draw 2-7 Lowball, the player with the highest ranking five-card low hand will win the pot, and the following additional rules shall apply:

(1) The ranking of a five-card low hand shall be the inverse of the rankings for a five-card high hand;

(2) There is no minimum qualifying low hand;

(3) The highest ranking low hand is seven, five, four, three, and two;

(4) A straight or flush negatively impacts hand value; and,

(5) An ace is always considered high.

(w) In Five-Card Draw 2-7 Lowball games the Bادهucey option may also be offered. If the Bادهucey option is offered at the table, the following additional rules shall apply:

(1) Bادهucey is a game variant where half of the pot shall be awarded to the highest ranking Five-Card Draw 2-7 Lowball hand and the other half of the pot shall be awarded to the player with the highest ranking Badugi hand. For the "Badugi" hand, a player uses up to four of their five cards to construct their lowest possible hand but may only utilize one card of each suit and rank to do so. It is possible when making a Badugi hand for the hand value to contain less than four cards due to the

unique rank and suit requirement of this game; however any hand made up of four unique cards of different suits automatically beats any hand made up of three cards, any hand made up of three unique cards automatically beats any hand made up of two cards and any hand made up of two unique cards of different suits automatically beats any hand that uses one card. If Badugi hands between two or more players contain the same number of cards, then they will be compared on their ranking. For purposes of Badeucey, an ace is always high and the highest ranking Badugi hand is a five, four, three, and two with all four cards being a different suit from the others;

(2) One player may win both pots;

(3) If the pot cannot be split evenly between the Five-Card Draw 2-7 pot and the Badugi pot, the odd chip will go to the highest ranking Five Card Draw 2-7 Lowball Poker Hand; and,

(4) Whenever there is a tie for the Five-Card Draw 2-7 pot or the Badugi pot and either pot cannot be split evenly, any odd chip will go to the first player in action clockwise from the button. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-401-235. Name of the game; rules and regulations.** The Kansas lottery shall conduct a lottery facility game at the Hollywood Casino at Kansas Speedway in Kansas City, Kansas, entitled "Badugi" beginning on or after November 1, 2017.

The rules and regulations for the game of "Badugi" are contained in K.A.R. 111-401-235 through 111-401-239, and applicable generic rules are contained in K.A.R. 111-201-1 *et seq.* (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-401-236. Object of game.** Badugi is played at a large table with a maximum number of 10 players using one deck of playing cards. The object of the game is for a player to either:

(a) create a four-card poker hand of a higher rank than the poker hand of all other players, or

(b) remain the only player in the hand after all other players have folded (quit the hand). (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-401-237. Definitions.** The following words and terms, when pertaining to the game of Badugi, shall have the following meanings unless the context clearly indicates otherwise:

(a) "All in" means when a player who has no funds remaining on the poker table to continue betting in a round of play still retains the right to contend for that portion of the pot in which the player has already placed a bet.

(b) "Ante" means a predetermined wager, which a player may be required to make prior to any cards being dealt in order to participate in the round of play.

(c) "Bet" or "wager" means an action by which a player places gaming chips into the pot on any betting round.

(d) "Betting round" means a complete wagering cycle in a hand of poker.

(e) "Blind bet" means a forced bet that only players sit-

ting in specific betting positions at the poker table shall be required to place prior to looking at any cards.

(f) "Burn a card" means to remove a card from the top of a deck, which is discarded face down, which card is not in play and the identity of which remains unknown.

(g) "Button" or "dealer button" means an object, which is moved clockwise around the table after each hand is complete to denote an imaginary dealer and thereby determine the betting and dealing sequence.

(h) "Call" means a wager made in an amount equal to the immediately preceding wager.

(i) "Check" means when a player waives the right to initiate the betting in a betting round but retains the right to act if another player initiates the betting.

(j) "Collection" means another name for the rake collected by the house, which may be a specified amount charged to each player or as a percentage of the pot for each hand.

(k) "Cut" means to divide a deck of playing cards into two parts in order to change the order of the cards without revealing the identity of any cards in the deck.

(l) "Deck" means a standard collection of 52 playing cards with the following 13 cards in each of four suits: 2, 3, 4, 5, 6, 7, 8, 9, 10, jack, queen, king, and ace.

(m) "Face card" means a king, queen, or jack.

(n) "Fold" means the withdrawal of a player from a round of play by discarding the player's hand of cards during a betting round and refusing to equal a wager.

(o) "Forced bet" means a wager, which is required to start the wagering on the first betting round.

(p) "Hand" means one of two things, depending upon the context in which the term is used:

(1) the cards available to a player to use; or

(2) a complete round of play from the first ante or blind bet until the pot is awarded to a player.

(q) "Hole cards" means any cards dealt to a player face down, which are also "pocket cards," "in the hole," or "in the pocket."

(r) "Kill" means when one player wins an entire qualifying pot, the betting limits are twice the posted table wagering limits for the next hand and remain in effect until a pot is split between one player winning the high hand and another player winning the low hand.

(s) "Opening bet" means the first bet by each player in a round of play.

(t) "Muck pile" means the stack of cards no longer available for use during a round of play.

(u) "Pot" or "kitty" means the amount that is awarded to the winning player or players at the conclusion of a round of play and is equal to the total amount wagered by the players during the round of play minus any rake.

(v) "Raise" means a bet in an amount greater than the immediately preceding bet in that betting round.

(w) "Rake" means the amount of gaming chips collected on each hand by the dealer representing the predetermined amount to be included in net gaming revenue.

(x) "Round of plays" means the process by which cards are dealt, bets are placed and the winner of the pot is determined and paid in accordance with the rules of this game.

(y) "Showdown" means a situation when, if more than one player remains after the last betting round, remain-



ing players expose and compare their hand rankings to determine the winner or winners.

(z) "Stub" means all cards remaining in the deck that have not been dealt to the players.

(aa) "Suit" means one of the following four categories of cards: diamonds, spades, clubs, or hearts.

(bb) "Table stakes" means the gaming chips on the table, which are in play. A player may not add or subtract from his or her gaming chips at any time during a betting round of play.

(cc) "Up cards" means any card dealt face up to a player. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-401-238. Wagers.** (a) Only players who are seated at the poker table shall be permitted to receive cards and participate in each betting round.

(b) Depending upon the predetermined option for the poker game being dealt, a player may be required to:

(1) Place a predetermined ante prior to receiving any cards; or

(2) Place a predetermined blind bet prior to receiving any cards.

(c) A player may only participate in the wagering during a round of play with the table stakes gaming chips, which were already placed on the poker table in front of that player when the round of play commenced.

(d) A player may only add to his gaming chips between rounds of play and may not remove any of that player's gaming chips from the poker table at any time during ongoing play.

(e) A player who depletes his funds on the poker table prior to the completion of a round of play shall be deemed to be "all-in."

(f) An "all-in" player shall retain financial interest in the outcome of the round of play, but shall only be eligible to win the amount of the pot to which that player contributed.

(g) An "all-in" player shall continue to receive any cards to which that player would normally be entitled.

(h) Betting shall continue unimpeded among the other players by generating a separate secondary pot that only those active players shall be eligible to win.

**111-401-239. Play.** (a) In Badugi, the lowest four (4) cards dealt determine the ranking of each player's hand. Each player has their own unique four (4) card hand and no community cards are used or shared between players. As play continues, players may, if they so choose, discard some or all of their cards and have them replaced by new unique cards; this is known as the "draw." Unlike in other poker games, players' hands may or may not contain the same number of usable (eligible) cards at the show-down. There are two variants that determine the number of instances a player may draw cards; these two variants are known as "Single Draw" (where players draw new cards one time) or "Triple Draw" (where players draw new cards three times). Disclosure of the variation being used will be posted at the Badugi gaming table.

(b) The order in which the cards will be dealt and the order in which players will be required or have the option to bet will be determined as follows:

(1) The "button" will be used to indicate an imaginary Dealer;

(2) At the commencement of play, the Dealer will shuffle the cards, either manually or through the use of a shuffling machine, cut the cards and deliver one card to each player, starting with the player in the first position to the left of the Dealer and continuing in a clockwise rotation around the table. The highest ranking card will receive the button and become the imaginary Dealer; and,

(3) Thereafter, the button will rotate around the table in a clockwise manner after each round of play.

(c) The first player to the left of the button (in a clockwise rotation) will be required to initiate the first betting round by placing a "blind" bet (Small Blind). Additional "blind" bets may be required to be made immediately subsequent to the initial blind bet (Big Blind). The Small blind will be equal to or less than half of the table minimum wager. The Big Blind will be equal to or less than the table minimum wager. The amount of all blinds, if any, will be posted on a sign at the table.

(d) Starting with the first player to the left of the Dealer and continuing in a clockwise rotation around the table,

the Dealer will deal four rounds of cards face down to each player.

(e) If an ace, two, three, or four is exposed by the dealer during the deal, it must be kept by the player; any other card must be replaced by the next card on the stub after the remainder of the deal is first completed. Exposed cards that are replaced are placed in the muck pile.

(f) Following the placement of the "blind" bet(s) and delivery of the first four cards, each player will in turn, in a clockwise rotation around the table, either fold, call or raise the bet. The option to raise will apply to the player who made the "blind" bet(s). After the last player has responded to the most recent bet, the betting round will be considered complete.

(g) Players who remain in the hand will now, in a clockwise manner from the dealer button, indicate how many cards they wish to draw by placing those cards from their hand face down on the table in front of them for the dealer to collect.

(h) Players may discard any number of cards between zero (0) and four (4).

(i) The dealer will burn a card and deal to each player, starting clockwise of the button, a number of cards equal to the number of cards each player discarded for the draw.

(j) Any card exposed by the dealer during the draw may not be kept. Exposed cards will be placed in the muck pile and replaced by the next card on the stub after all remaining draw cards are dealt as normal.

(k) If the dealer runs out of cards, the dealer will deal all cards until the last card on the stub remains, at which time the last card on the stub will not be exposed and will be combined and shuffled with all cards which were previously placed in the muck pile prior to the current draw phase in order to form a new stub and the draw will continue from where it left off.

(l) Each subsequent player may now, in clockwise rotation, fold, call, raise the bet or, if preceding players have not made a bet, make an opening bet or check. The betting round will be considered complete when each player has either folded or called the most recent bet.

(m) If all other players have folded and only one player remains, this player is declared the winner of the pot and the hand is complete. If more than one player remains, then:

(1) If the game type is designated as "Single Draw," continue to subsection (o); or,

(2) If the game type is designated as "Triple Draw," repeat the procedure set forth in subsections (g) through (m) an additional two times as necessary (for a total of three Draw phases and four betting rounds), and then continue to subsection (n).

(n) If more than one player remains in the round of play after the final betting round has been completed, a showdown will be used to determine the winner of the pot.

(o) In Badugi, the player with the highest ranking low-hand, containing between one and four eligible cards will win the pot, as follows:

(1) Each player's final hand may only consist of a maximum of one card from each suit and rank. Any card(s) of the same rank or suit as the card(s) the player chooses to use for the player's final hand are irrelevant to the player's final poker hand;

(2) The lowest possible hand consists of a four, three, two, ace so long as all four cards are of different suits;

(3) Only when hands contain the same number of cards (after discounting cards of same rank or suit) will they be compared. If one player's hand contains more eligible cards than the other player, this player will always win;

(4) Any 4-card hand beats any hand comprised of three eligible cards or fewer;

(5) Any 3-card hand beats any hand comprised of two eligible cards or fewer;

(6) Any 2-card hand beats any hand comprised of one eligible card;

(7) When players' hands contain the same number of cards, they will be compared beginning with the highest card in the hand and working down until one player's hand is lower;

(8) If there is a tie for highest ranking Badugi low hand the pot will be split as evenly as possible; and,

(9) Whenever a pot cannot be split evenly, any odd chip will go to the first player in action clockwise from the button. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

#### Article 501. — SOUTH CENTRAL GAMING ZONE

**111-501-139. Name of game; rules and regulations.** The Kansas lottery shall conduct a lottery facility game at the Kansas Star Casino in Mulvane, Kansas, entitled "High Card Flush" beginning on or after November 1, 2017. High Card Flush is a game that each player may play against the dealer and/or play against posted paytables.

The rules and regulations for the game of High Card Flush are contained in K.A.R. 111-501-139 through 111-501-143, and applicable generic rules are contained in K.A.R. 111-201-1 *et seq.* (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-501-140. Definitions.** The following definitions shall have the following meanings unless the context clearly indicates otherwise.

(a) "Ante wager" means the wager that a player is required to make prior to any cards being dealt in order to participate in a round of play. This is a required wager to play the game.

(b) "Flush bonus wager" means the wager that a player is required to make prior to any cards being dealt in order to compete against a posted payable, regardless of the outcome of the player's hand against the dealer. This is not a required wager to play the game.

(c) "Hand" means the seven cards poker that are held by each player and the dealer after all cards have been dealt.

(d) "Raise wager" means an additional wager that a player must make if the player chooses to remain in competition against the dealer after the player reviews his or her hand.

(e) "Round of play" means one complete cycle of play during which all wagers have been placed, all cards have been dealt and all remaining wagers have been paid off or collected in accordance with the rules of the game.

(f) "Straight flush bonus wager" means the wager that a player is required to make prior to any cards being dealt in order to compete against a posted payable, regardless of the outcome of the player's hand against the dealer. This is not a required wager to play the game.

(g) "Suit" means one of the four categories of cards: club, diamond, heart or spade. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-501-141. Card and hand rankings.** (a) The rank of the cards used in "High Card Flush," in order of highest to lowest rank, shall be: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3, and 2. All suits shall be considered equal in rank. Notwithstanding the foregoing, an ace may also be used to complete a "straight flush" in combination with a 2 card and 3 card. The only permissible hands in the game of High Card Flush are certain straight flushes and flushes.

(b) The permissible straight flushes in order of highest to lowest rank, shall be as follows:

(1) "Seven card straight flush" is a hand consisting of seven cards of the same suit in consecutive ranking, with ace, king, queen, jack, 10, 9, and 8 being the highest ranking seven card straight flush and 7, 6, 5, 4, 3, 2 and ace being the lowest ranking seven card straight flush.

(2) "Six card straight flush" is a hand consisting of six cards of the same suit in consecutive ranking, with ace, king, queen, jack, 10 and 9 being the highest ranking six card straight flush and 6, 5, 4, 3, 2 and ace being the lowest ranking six card straight flush.

(3) "Five card straight flush" is a hand consisting of five cards of the same suit in consecutive ranking, with ace, king, queen, jack and 10 being the highest ranking five card straight flush and 5, 4, 3, 2 and ace being the lowest ranking five card straight flush.

(4) "Four card straight flush" is a hand consisting of four cards of the same suit in consecutive ranking, with ace, king, queen and jack being the highest ranking four card straight flush and 4, 3, 2 and ace being the lowest ranking four card straight flush.

(5) "Three card straight flush" is a hand consisting of three cards of the same suit in consecutive ranking, with ace, king and queen being the highest ranking three card straight flush and 3, 2 and ace being the lowest ranking three card straight flush.

(c) The permissible flushes in order of highest to lowest rank, shall be as follows:

(1) "Seven card flush" is a hand consisting of seven cards of the same suit not in consecutive ranking, with ace, king, queen, jack, 10, 9, and 7 being the highest ranking seven card flush and 8, 6, 5, 4, 3, 2 and ace being the lowest ranking seven card flush.

(2) "Six card flush" is a hand consisting of six cards of the same suit not in consecutive ranking, with ace, king, queen, jack, 10 and 8 being the highest ranking six card flush and 7, 5, 4, 3, 2 and ace being the lowest ranking six card flush.

(3) "Five card flush" is a hand consisting of five cards of the same suit not in consecutive ranking, with ace, king, queen, jack and 9 being the highest ranking five card flush and 6, 4, 3, 2 and ace being the lowest ranking five card flush.

(4) "Four card flush" is a hand consisting of four cards of the same suit not in consecutive ranking, with ace, king, queen and 10 being the highest ranking four card flush and 5, 3, 2 and ace being the lowest ranking four card flush.

(d) When comparing two hands that are of identical rank, the hand that contains the highest ranking card that is not contained in the other hand shall be considered the higher ranking hand. If the hands are of identical rank after the application of this comparison, the hands shall be considered a tie or draw and any ante wager and play wager are returned to the player. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective, T-111-12-05-17, Oct. 11, 2017.)

**111-501-142. Wagers.** (a) The following wagers may be placed in the game of High Card Flush:

(1) In order to participate in a round of play, before any cards are dealt a player must place an ante wager that is in any amount within the minimum and maximum wagers posted at the table.

(2) After examination of his or her cards, each player who has placed an ante wager shall have the option to either forfeit the ante wager and end his or her participation against the dealer's hand or compete against the dealer. If a player chooses to compete against the dealer, the player must place one of the following raise wagers:

(A) if the player's hand contains fewer than five (5) cards of the same suit, the raise wager must be in the same amount as the player's ante wager;

(B) if the player's hand contains five (5) or more cards of the same suit, the raise wager may be in any amount up to two times the player's ante wager; or,

(C) if the player's hand contains six (6) or seven (7) cards of the same suit, the raise wager may be in any amount up to three times the player's ante wager.

(3) A player placing an ante wager may also compete against a payable by placing a flush bonus wager and/or straight flush bonus wager in any amount within the minimum and maximum wagers posted at the table; or,

(4) A player may compete against both the dealer and the payable by placing wagers in accordance with the requirements of (a)(1), (a)(2) and (a)(3) above.

(b) All wagers at High Card Flush shall be made by placing gaming chips or authorized coupons on the appropriate betting areas of the game table layout.

(c) Only players who have placed wagers at a gaming position at a High Card Flush game table are eligible to receive cards.

(d) No wager shall be made, increased, or withdrawn after the first card has been dealt in that round of play. (Authorized by K.S.A. 2017 Supp. 74-8710 and 74-8748; implementing K.S.A. 2017 Supp. 74-8710; effective T-111-12-05-17, Oct. 11, 2017.)

**111-501-143. Play.** (a) All ante wagers, flush bonus wagers and straight flush bonus wagers shall be placed prior to the first card being dealt in a round of play.

(b) Beginning with the first player to the left of the dealer and continuing clockwise in order around the table, the dealer shall deal each player and the dealer seven (7) cards one card at a time face down.

(continued)

(c) After all cards have been dealt, each player may examine his or her cards. Each player who places a wager shall be responsible for his or her own hand and no person other than the dealer and the player to whom the cards were dealt may touch the cards of that player.

(d) After examination of his or her cards, each player who has placed an ante wager shall have the option to either forfeit the ante wager and end his or her participation against the dealer's hand or make a raise wager. A raise wager must be equal to the amount of the player's ante wager unless the player's hand consists of five (5) or more cards of the same suit. If the player's hand consists of five (5) or more cards of the same suit, the player may make a raise wager up to two (2) times the amount of the player's ante wager. If the player's hand consists of six (6) or seven (7) cards of the same suit, the player may make a raise wager up to three (3) times the amount of the player's ante wager. If a player has placed an ante wager along with a flush bonus wager and/or straight flush bonus wager but does not make a raise wager, the player shall forfeit the ante wager.

(e) After each player has either placed a raise wager on the designated area of the table or forfeited his or her wager and hand, the dealer shall collect all forfeited wagers and associated cards, placing them in the discard rack or automatic shuffling machine. The dealer shall then reveal the dealer's cards and place the cards so as to form the highest possible ranking hand available for the dealer's cards.

(f) The dealer shall then settle the wagers remaining on the table by performing the procedure in subsection (g) below. All cards collected during the procedure shall be placed in the discard rack or automatic shuffling machine.

(g) Starting with the player farthest to the dealer's right and continuing counterclockwise around the table the dealer shall:

- (1) Reveal the cards of each remaining player, one player at a time;
- (2) Determine the highest ranking hand of each remaining player;
- (3) Collect all losing wagers;

(4) Pay each winning wager in accordance with the payout odds listed below; and,

(5) Collect all player cards and place them in the discard rack or automatic shuffling machine.

(h) All cards collected by the dealer shall be picked up in order and placed in the discard rack or automatic shuffling machine in such a way that they can be readily arranged to reconstruct each hand in the event of a question or dispute.

(i) There are three winning payout types, as follows:

(1) A player in competition against the dealer shall be paid at odds of one to one on both the ante wager and the raise wager if the player's hand is ranked higher than the dealer's hand, except that to win both wagers the dealer's hand must contain a flush containing a 9 or higher ranking card and the player's hand must be ranked higher than the dealer's hand. If the dealer does not hold a hand with a flush containing a 9 or higher ranking card, the player's ante wager shall automatically be paid at odds of one to one and the player's raise wager shall be returned to the player as a draw (tie).

(2) A player placing a flush bonus wager shall be paid at the following odds:

Four card flush	1 to 1
Five card flush	10 to 1
Six card flush	100 to 1
Seven card flush	300 to 1

(3) A player placing a straight flush bonus wager shall be paid at the following odds:

Three card straight flush	7 to 1
Four card straight flush	60 to 1
Five card straight flush	100 to 1
Six card straight flush	1000 to 1
Seven card straight flush	8000 to 1
