**Notice of Available Grant Funding from the Federal John R. Justice Student Loan Repayment Program**

Grant funds are available from the Federal John R. Justice Student Loan Repayment Program for calendar year 2019. The purpose of this grant program is to provide student loan repayment assistance for full-time local, state, and federal government public defenders and full-time local and state government prosecutors who commit to serving as public defenders and prosecutors for at least three (3) years. Kansas has \$32,616 available for awards and will be available to prosecutors (maximum of \$16,308) and public defenders (maximum of \$16,308). Federal John R. Justice Grant funds awarded under this program are a supplement to, not a substitute

for, personal student loan obligations. To be eligible to receive funding, an attorney must not be in default on re-payment of any federal student loans. **Proposed Action:** The Kansas Department of Health and Environment (KDHE) issued authorizations for stormwater discharges under of the Construction Stormwater General Permit for the above named projects. The regulation provides for an advisory opinion prior to application for licensure for an amount of \$50 to state if there is a disqualifying civil or criminal record that would disqualify such applicant from licensure.

**Economic Impact.** The Board anticipates that there should be little, if any, economic impact to State and local governments due to this regulation.

##### Article 401.—NORTHEAST GAMING ZONE

**111-401-208. Card and hand rankings.** (a) The rank of the cards used in “High Card Flush,” in order of highest to lowest rank, shall be: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3, and 2. All suits shall be considered equal in rank. Notwithstanding the foregoing, an ace may also be used as the equivalent of a “1” card to complete a “straight flush.” An ace may only be used as the highest ranking card in a “flush”. The only permissible hands in the game of High Card Flush are certain straight flushes and flushes.

(b) The permissible straight flushes in order of highest to lowest rank, shall be as follows:

(1) “Seven card straight flush” is a hand consisting of seven cards of the same suit in consecutive ranking, with ace, king, queen, jack, 10, 9, and 8 being the highest ranking seven card straight flush and 7, 6, 5, 4, 3, 2 and ace being the lowest ranking seven card straight flush.

(2) “Six card straight flush” is a hand consisting of six cards of the same suit in consecutive ranking, with ace, king, queen, jack, 10 and 9 being the highest ranking six card straight flush and 6, 5, 4, 3, 2 and ace being the lowest ranking six card straight flush.

(3) “Five card straight flush” is a hand consisting of five cards of the same suit in consecutive ranking, with ace, king, queen, jack and 10 being the highest ranking five card straight flush and 5, 4, 3, 2 and ace being the lowest ranking five card straight flush.

(4) “Four card straight flush” is a hand consisting of four cards of the same suit in consecutive ranking, with ace, king, queen and jack being the highest ranking four card straight flush and 4, 3, 2 and ace being the lowest ranking four card straight flush.

(5) “Three card straight flush” is a hand consisting of three cards of the same suit in consecutive ranking, with ace, king and queen being the highest ranking three card straight flush and 3, 2 and ace being the lowest ranking three card straight flush.

(c) The permissible flushes in order of highest to lowest rank, shall be as follows:

(1) “Seven card flush” is a hand consisting of seven cards of the same suit.

(2) “Six card flush” is a hand consisting of six cards of the same suit.

(3) “Five card flush” is a hand consisting of five cards of the same suit.

(4) “Four card flush” is a hand consisting of four cards of the same suit.

(5) “Three card flush” is a hand consisting of three cards of the same suit.

(6) “Two card flush” is a hand consisting of two cards of the same suit.

(d) Ranking of hands containing a flush is based upon the number of cards of the same suit in the player’s and dealer’s hands. Straight flushes are only relevant to the optional straight flush bonus wager. **111-501-141. Card and hand rankings.** (a) The rank of the cards used in “High Card Flush,” in order of highest to lowest rank, shall be: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3, and 2. All suits shall be considered equal in rank. Notwithstanding the foregoing, an ace may also be used as the equivalent of a “1” card to complete a “straight flush”. An ace may only be used as the highest ranking card in a “flush”. The only permissible hands in the game of High Card Flush are certain straight flushes and flushes.

(b) The permissible straight flushes in order of highest to lowest rank, shall be as follows:

(1) "Seven card straight flush" is a hand consisting of seven cards of the same suit in consecutive ranking, with ace, king, queen, jack, 10, 9, and 8 being the highest ranking seven card straight flush and 7, 6, 5, 4, 3, 2 and ace being the lowest ranking seven card straight flush.
