Programs (TIPs) administered by each of the Metropolitan Planning Organizations (MPO) for the six urbanized areas of Kansas. The six state MPOs are: the Mid-America Regional Council (MARC) for the Kansas City area; the Wichita Area Metropolitan Planning Organization (WAMPO) that serves Sedgwick County and the cities of Andover and Mulvane; the Metropolitan Topeka Planning Organization; the Lawrence-Douglas County Metropolitan Planning Office; the Flint Hills Metropolitan Planning Organization that serves the cities of Manhattan, Ogden, Junction City, and Wamego; and the St. Joseph Area Transportation Study Organization that serves Doniphan County in the cities of Wathena and Ellwood.

p.m. November 17, 2022, at the location listed above. The meeting will recess at approximately 5:00 p.m. and then resume at 6:30 p.m. at the same location for the regulatory hearing and more business. There will be public comment periods at the beginning of the afternoon and evening meetings for any issues not on the agenda, and additional comment periods will be available during the meeting on agenda items. Old and new business may also be discussed at this time. If necessary to complete the hearing or other business matters, the commission will reconvene at 9:00 a.m. November 18, 2022, at the location listed above.

Any individual with a disability may request an accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation to participate in the hearing should be made at least five working days in advance of the hearing by contacting Sheila Kemmis, Commission secretary, at 620-672-5911. All interested parties will be given a reasonable opportunity at the hearing to express their views orally regarding the adoption of the proposed regulations. During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The regulations that will be heard during the regulatory hearing portion of the meeting are as follows:

**K.A.R. 115-5-1.** This permanent regulation amendment adds laser sights to the illuminating devices which may be used for the taking of furbearers treed with the aid of dogs when paired with a .22 or .17 caliber rimfire handgun or rifle.

**Economic Impact Summary:** This amendment is not expected to have any significant economic impact on the department, other agencies, or the public.

**K.A.R. 115-25-11.** This exempt regulation establishes open seasons for hunting, running and trapping furbearers and also establishes bag limits.

**Economic Impact Summary:** The economic impact will be directly proportionate to any increase in furbearer harvest resulting from an additional 15 days of general furbearer open season and increases in the otter bag limits.

**K.A.R. 115-17-6.** This permanent regulation revocation will eliminate all licensing provisions for commercial mussel harvest.

**Economic Impact Summary:** There is no anticipated economic impact to this revocation since commercial mussel harvest has been suspended since 2003.



**K.A.R. 115-17-7.** This permanent regulation revocation clarifies that commercial mussel harvesting is prohibited at all locations in Kansas.

**Economic Impact Summary:** There is no anticipated economic impact to this revocation since commercial mussel harvest has been suspended since 2003.

**K.A.R. 115-17-8.** This permanent regulation revocation eliminates all authorized equipment and methods of taking mussels commercially.

**Economic Impact Summary:** There is no anticipated economic impact to this revocation since commercial mussel harvest has been suspended since 2003.

**K.A.R. 115-17-9.** This permanent regulation revocation eliminates the prior designation of areas open to commercial mussel harvest.

**Economic Impact Summary:** There is no anticipated economic impact to this revocation since commercial mussel harvest has been suspended since 2003.

**K.A.R. 115-17-14.** This permanent regulation revocation eliminates the procedure for the issuance, reporting and revocation of commercial mussel harvesting permits.

**Economic Impact Summary:** There is no anticipated economic impact to this revocation since commercial mussel harvest has been suspended since 2003.

The Kansas Department of Health and Environment (KDHE), Division of Public Health, Bureau of Family Health, will conduct a public hearing at 10:00 a.m. Friday, October 28, 2022, in Room 530, Curtis State Office Building, 1000 SW Jackson, Topeka, Kansas, to consider the adoption of proposed amended maternal and child health regulation K.A.R. 28-4-114, regarding the application process and licensee requirements for day care homes and group day care homes for children.

A summary of the proposed regulation and estimated economic impact follows:

#### Summary of Regulation:

**K.A.R. 28-4-114. Applicant; licensee.** Updates infant age in day care homes and group day care homes from under 18 months to under 12 months of age. Revises licensing capacities for one and two providers. Updates the age for maximum number of children in care from under 11 years to under 16 years of age.

#### Economic Impact:

Cost to the agency: The proposed amended regulation will require staff time to update the agency handbook,

"Kansas Laws and Regulations for Licensing Day Care Homes and Group Day Care Homes for Children." The costs for the update of the handbook and printing will be absorbed in the ongoing KDHE budget.

Cost to licensees: The proposed amended regulation has no implementation or compliance costs to child care licensees.

Costs to other governmental agencies or units: The proposed amended regulation applies to local units of government, including cities and counties, that operate a day care home or group day care home. For those licensees, there are no implementation or compliance costs.

A detailed economic impact is provided in the economic impact statement that is available from the designated KDHE contact staff person or at the KDHE Child Care Licensing website, as listed below.

The time period between the publication of this notice and the scheduled hearing constitutes a 60-day public comment period for the purpose of receiving written public comments on the proposed regulation. Article 4.—INSTANT GAMES AND DRAWINGS

111-4-3547. 2022 Kansas State Fair second-chance drawing. (a) The Kansas lottery may conduct a second-chance drawing in conjunction with the Kansas State Fair event giving away five \$500 cash prizes. The drawing will be on September 22, 2022, and the winners will be announced on September 23, 2022.

(b) To enter the drawing, a player shall purchase \$20 of any Kansas lottery ticket(s) in a single purchase at the Kansas lottery’s selling location at the Kansas State Fair. A player may purchase lottery products during the hours the Kansas lottery selling location at the Kansas State Fair is open each day to the public beginning September 9, 2022, through September 18, 2022. For each qualifying purchase, the player will be given an official entry form by the representative selling the ticket(s). A player shall complete the entry form in a legible manner and deposit the entry form into a receptacle(s) designated for the purpose of this drawing no later than 2:00 p.m. on September 18, 2022. Only one name shall appear on an eligible entry.

(c) After the close of entries, the entry forms shall be transported by Kansas lottery security officials, or security designee as appointed by the security person on duty, in a sealed container from the selling location at the Kansas State Fair to Kansas lottery headquarters and secured until the drawing occurs.

(d) On the designated date, the drawing shall be conducted by a drawing official designated by the executive director of the Kansas lottery in accordance with the Kansas lottery’s established drawing procedures.

Five entries shall be drawn. The person whose name appears on each valid entry drawn shall be the winner of a prize described in these rules. After five entries have been drawn and verified as valid, five more valid entries will be drawn, one at a time, which entries drawn will serve as alternate entries. The alternate entries will be marked in the order drawn, 1A, 2A, 3A, 4A, and 5A.

Each person who is selected as a prize winner in the drawing described above, will be sent an email with an electronic claim form attached, followed by the same documentation sent by U.S. mail. That winner must return his or her completed claim form, electronically, by U.S. mail, or hand-delivered to the Kansas lottery claims center, and the claim form must be received by the Kansas lottery within 14 days following the date the winners are announced. If the prize winner cannot be located, is declared ineligible, or fails to return the completed claim form in the allotted time, the prize will be awarded to an alternate winner. In the event an alternate winner is awarded a prize, that alternate winner must return his or her completed claim form, electronically, by U.S. mail, or hand-delivered, and the claim form must be received by the Kansas lottery within 14 calendar days following the date the alternate winner was sent a claim form electronically or by U. **111-15-3. Game description; retail sale of tickets.**

A ticket must be purchased by 6:59 p.m. the day of the Early Bird drawing to be eligible for that drawing. In the event a ticket wins a prize in an Early Bird drawing, the ticket will remain eligible for any remaining drawings, including the final drawing held on January 3, 2023. For the final drawing an electronic drawing machine shall randomly select a total of 5,645 winning numbers. A player wins by exactly matching his or her ticket number to a winning number that was selected in the drawing. ## Article 501.—SOUTH CENTRAL GAMING ZONE

**111-501-154. Mini-baccarat 5 treasures baccarat bonus bet.** (a) The 5 treasures baccarat bonus may be offered for play in the game of mini-baccarat. The 5 treasures baccarat bonus offers several optional side bets with separate pay tables. The pay tables shall be posted on the mini-baccarat table.

(b) Rules for the 5 treasures baccarat bonus bet are as follows:

(1) Players must make a standard mini-baccarat wager in order to make a 5 treasures baccarat bonus bet;

(2) 5 treasures baccarat bonus bet limits will be posted at the table and must be made in \$5 increments; and

(3) 5 treasures baccarat bonus bets must be placed within the designated betting area on the game table.

(c) There are five optional wagers on the 5 treasures baccarat bonus, as follows:

(1) Fortune 7 wins if the banker’s outcome is a three-card total of seven and pays odds of 40 to 1.

(2) Golden 8 wins if the player’s outcome is a three-card total of eight and pays odds of 25 to 1.

(3) Heavenly 9 wins if either the banker’s outcome or the player’s outcome is a three-card total of nine and pays odds of 10 to 1. Heavenly 9 wins if both the banker’s



outcome and the player's outcome are three-card totals of nine and pays odds of 75 to 1.

(4) Blazing 7 wins if both the banker's outcome and the player's outcome are two-card totals of seven and pays odds of 50 to 1. Blazing 7 wins if both the banker's outcome and the player's outcome are three-card totals of seven and pays odds of 200 to 1.

(5) The cover all bonus wins if any one or more of the separate bonus wagers in sections (c)(1), (c)(2), (c)(3) or (c)(4) win. The cover all bonus wager pays odds of 6 to 1. The cover all bonus may be played alone. Players are not required to place a separate bonus wager in order to win the cover all bonus wager.

(d) Dealing procedures for the 5 treasures baccarat bonus shall be as follows:

(1) Players must make the standard mini-baccarat wager and, if desired, the optional 5 treasures baccarat bonus bet before the dealer reveals any of the cards.

The 5 treasures baccarat bonus offers several optional side bets with separate pay tables. The pay tables shall be posted on the midi-baccarat table.

(b) Rules for the 5 treasures baccarat bonus bet are as follows:

(1) Players must make a standard midi-baccarat wager in order to make a 5 treasures baccarat bonus bet;

(2) 5 treasures baccarat bonus bet limits will be posted at the table and must be made in \$5 increments; and

(3) 5 treasures baccarat bonus bets must be placed within the designated betting area on the game table.

(c) There are five optional wagers on the 5 treasures baccarat bonus, as follows:

(1) Fortune 7 wins if the banker's outcome is a three-card total of seven and pays odds of 40 to 1.

(2) Golden 8 wins if the player's outcome is a three-card total of eight and pays odds of 25 to 1.

(3) Heavenly 9 wins if either the banker's outcome or the player's outcome is a three-card total of nine and pays odds of 10 to 1. Heavenly 9 wins if both the banker's outcome and the player's outcome are three-card totals of nine and pays odds of 75 to 1.

(4) Blazing 7 wins if both the banker's outcome and the player's outcome are two-card totals of seven and pays odds of 50 to 1. Blazing 7 wins if both the banker's outcome and the player's outcome are three-card totals of seven and pays odds of 200 to 1.

(5) The cover all bonus wins if any one or more of the separate bonus wagers in sections (c)(1), (c)(2), (c)(3) or (c)(4) win. The cover all bonus wager pays odds of 6 to 1. The cover all bonus may be played alone. Players are not required to place a separate bonus wager in order to win the cover all bonus wager.

(d) Dealing procedures for the 5 treasures baccarat bonus shall be as follows:

(1) Players must make the standard midi-baccarat wager and, if desired, the optional 5 treasures baccarat bonus bet before the dealer reveals any of the cards.

(2) The dealer will collect and pay standard wagers first, and then the optional 5 treasures baccarat bonus bet of each player before moving to the next player position.

(e) A commission shall not be charged on winning 5 treasures baccarat bonus bets. (Authorized by K.S.A. 74-8710 and 74-8748; implementing K.S.A. 74-8710; effective, T-111-6-1-22, May 11, 2022; amended, T-111-7-27-22, July 13, 2022.)
