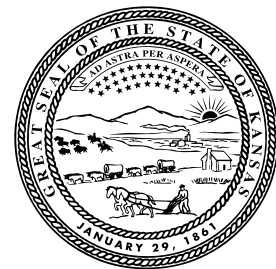

The website will allow the contractor to request approval from KDOT to bid as a prime contractor and be included on the "Bid Holders List," or to be included on the "Non-Bid Holders List" as a subcontractor/supplier. KDOT's approval is required to bid as a prime contractor. To bid as a prime contractor, KDOT needs to be notified of the intent to bid no later than the close of business on the Monday preceding the scheduled letting date. Failure to obtain prior approval to bid as a prime contractor on any projects listed below will be reason to reject your bid. The Secretary reserves the right to reject bids that do not comply with all requirements for preparing a bidding proposal as specified in the 2015 edition of the Kansas Department of Transportation *Standard Specifications for State Road and Bridge Construction*.

Each bidder shall certify that such person, firm, association, or corporation has not, either directly or indirectly, entered into any agreement, participated in any collusion, or otherwise taken any action in restraint of free competitive bidding in connection with the submitted bid. This certification shall be in the form of a required contract provision provided by the state to each prospective bidder. Failure to complete the required contract provision and certify the completeness of the preceding statement when electronically signing the proposal will make the bid nonresponsive and not eligible for award consideration.

Notice is hereby given of the commencement of the selection process for engineering services for the Kansas State University Data Center 1121 renovation project. This project will expand the existing data center capacity to add more servers and data equipment. This project will also add redundant cooling and backup generating capacity to ensure the data center never loses power nor cooling. This will require a redundant direct expansion (DX) cooling AHU to be added that is fed with generator power. Ductwork will need to be added to connect the new AHU to the data room. The existing AHU will need to be reconfigured to provide adequate ventilation and economizer cooling to the space. Reheat will be added to ductwork where it feeds the existing data room so that

humidity can be controlled. Fan coil units that cool the UPS will be replaced with new fan coils that have both chilled water and DX cooling. The existing 250KW generator will be replaced with three new 250KW natural gas generators that will feed power to UPS and HVAC for the data center. The project construction budget is \$2,505,680.

Conditional and Temporary Relief from  
Certain Motor Carrier Rules and Regulations**

**WHEREAS**, severe winter cold, in the mid-west and upper mid-west, is likely to cause an interruption to the delivery of essential home heating fuels;

**WHEREAS**, these conditions require the operation of motor carriers and drivers of commercial motor vehicles for the purposes of providing direct assistance to supplement State and local efforts in the restoration of services and relief in the affected area(s) of the State of Kansas;

**WHEREAS**, in accordance with K.S.A. 48-945, the Kansas Division of Emergency Management declares this disaster has caused or threatens to cause an emergency as defined in 49 C.F.R. 390.5, as adopted by K.A.R. 82-4-3f, and which has or threatens to interrupt the delivery of essential services or essential supplies or otherwise immediately threatens physical harm or injury to persons, the public welfare and/or substantial damage to property;

**NOW, THEREFORE**, pursuant to the authority vested in me as Governor of the State of Kansas and in accordance with 49 C.F.R. 23(a)(1), I hereby acknowledge and concur in the Kansas Division of Emergency Management's declaration of a state of emergency in Kansas in accordance with K.S.A. 48-945(a) and declare it necessary to assist and expedite all disaster recovery efforts, including the following:

1. This declaration applies to motor carriers directly participating in relief efforts; and
2. In accordance with Title 49 C.F.R. § 390.23(a)(1) allowing for the suspension of motor carrier regulations in the event of a regional emergency, the requirements contained in the Federal Motor Carrier Safety Regulations, Title 49 C.F.R. Parts 390-399 are hereby suspended through the duration of the motor carrier's assistance in the disaster relief effort not to exceed a period of thirty (30) days from the date of the initial declaration unless the order is rescinded or expanded by executive order or concurrent resolution of the legislature; and
3. All other applicable state and federal regulations shall apply to include but not limited to: Title 49

C.F.R. Part 382, Controlled Substances and Alcohol Use and Testing; the Kansas Motor Vehicle Driver's License Act, K.S.A. 8-234 et. seq. and Title 49 C.F.R. Part 383 Commercial Driver's License Standards as adopted by the Kansas Uniform Commercial Drivers' License Act, K.S.A. 8-2,125 et. seq., the federal Minimum Levels of Financial Responsibility (insurance requirements) Title 49 C.F.R. Part 387 as adopted by K.A.R. 82-4-3n and state insurance requirements as provided in K.A.R. 82-4-23, and the regulations governing transportation of hazardous materials in Kansas in 49 C.F.R. A summary of the proposed regulation and the economic impact follows:

**K.A.R. 100-54-13. Professional Liability Insurance.**

The purpose of this proposed new regulation is to implement the regulation mandate of 2022 Senate Bill 440, establishing the minimum level of coverage of professional liability insurance each licensed occupational therapist actively practicing in this state must have as a condition of rendering professional services.

Although the agency does not employ an economist, the lay opinion of agency staff is that the economic effect on the affected businesses and business sector would not be significant. The only costs anticipated will be those incurred by an individual occupational therapist purchasing liability insurance prior to licensure and annual renewal of their license or an employer who covers an occupational therapist under an additional insured policy. It is difficult to ascertain a fixed price for an individual OT policy as each insurance carrier will vary. The agency does not anticipate any significant implementation or compliance costs associated with these changes.

The agency has had extensive discussions with members of the Occupational Therapy Advisory council, which is made up of 5 members, including 3 members who are licensed occupational therapists, a licensed physician, and a member of the Board of Healing Arts. The OT Council has reviewed and approves of this proposed regulation. Additionally, the agency has worked collaboratively with the Kansas Occupational Therapy Association ("KOTA"), the professional association for OT/OTAs, on the language of the proposed regulation and KOTA agrees. The agency has also met with an insurance carrier to ensure the proposed regulation accurately reflects how coverage for occupational therapists work. After these vital discussions with key stakeholders and those of the public who may be affected, the proposed regulation was discussed at the June 10, 2022, open Board meeting of which members of the public, business, and stakeholders could attend. Further it should be noted that the Board of Healing Arts is comprised of medical practitioners, business owners, and members of the public. The Board of Healing Arts intends to continue to comply with all public hearing requirements involved in the regulation promulgation process.
